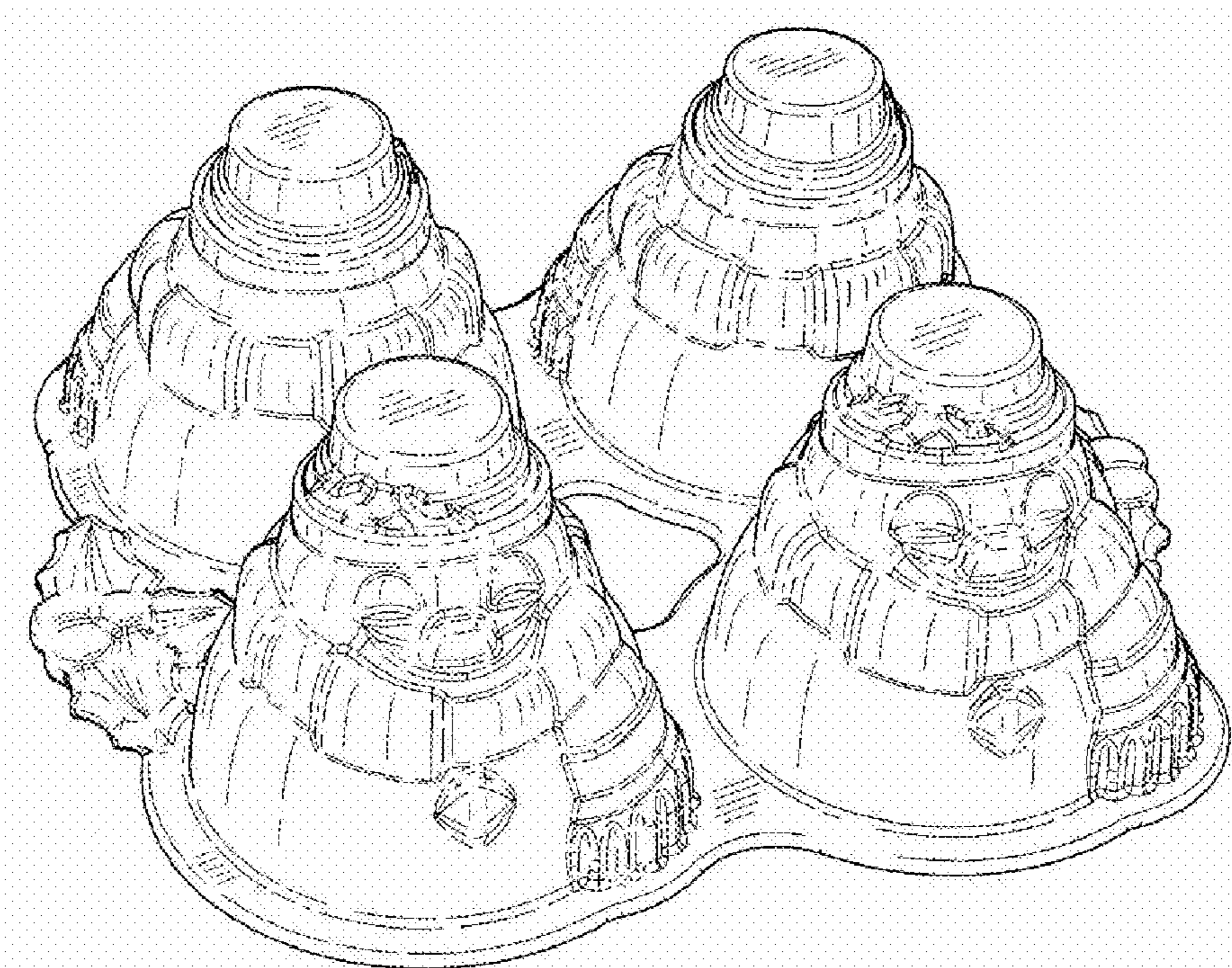
(57) **CLAIM**

The ornamental design for the cake pan, as shown.

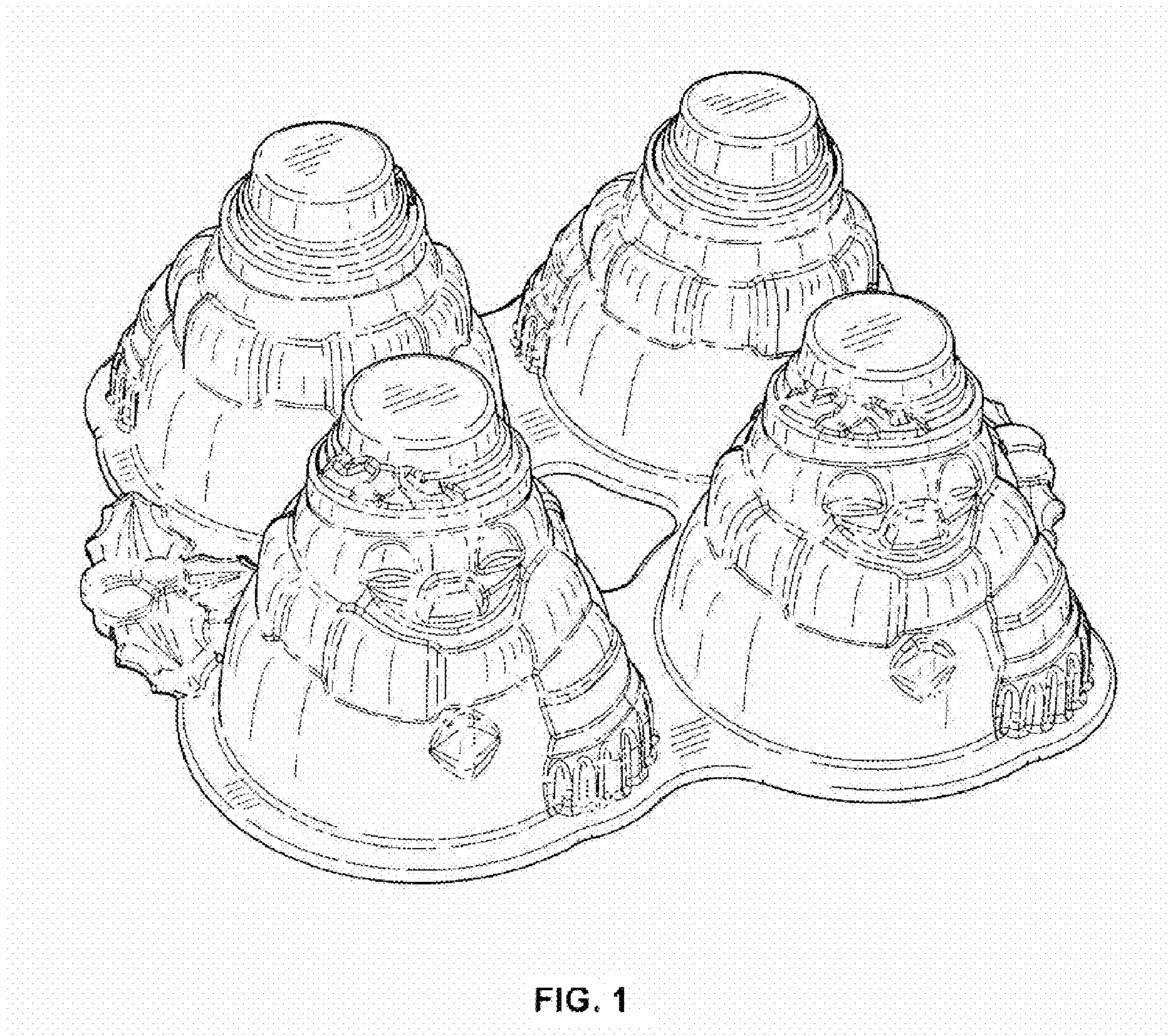
**DESCRIPTION**

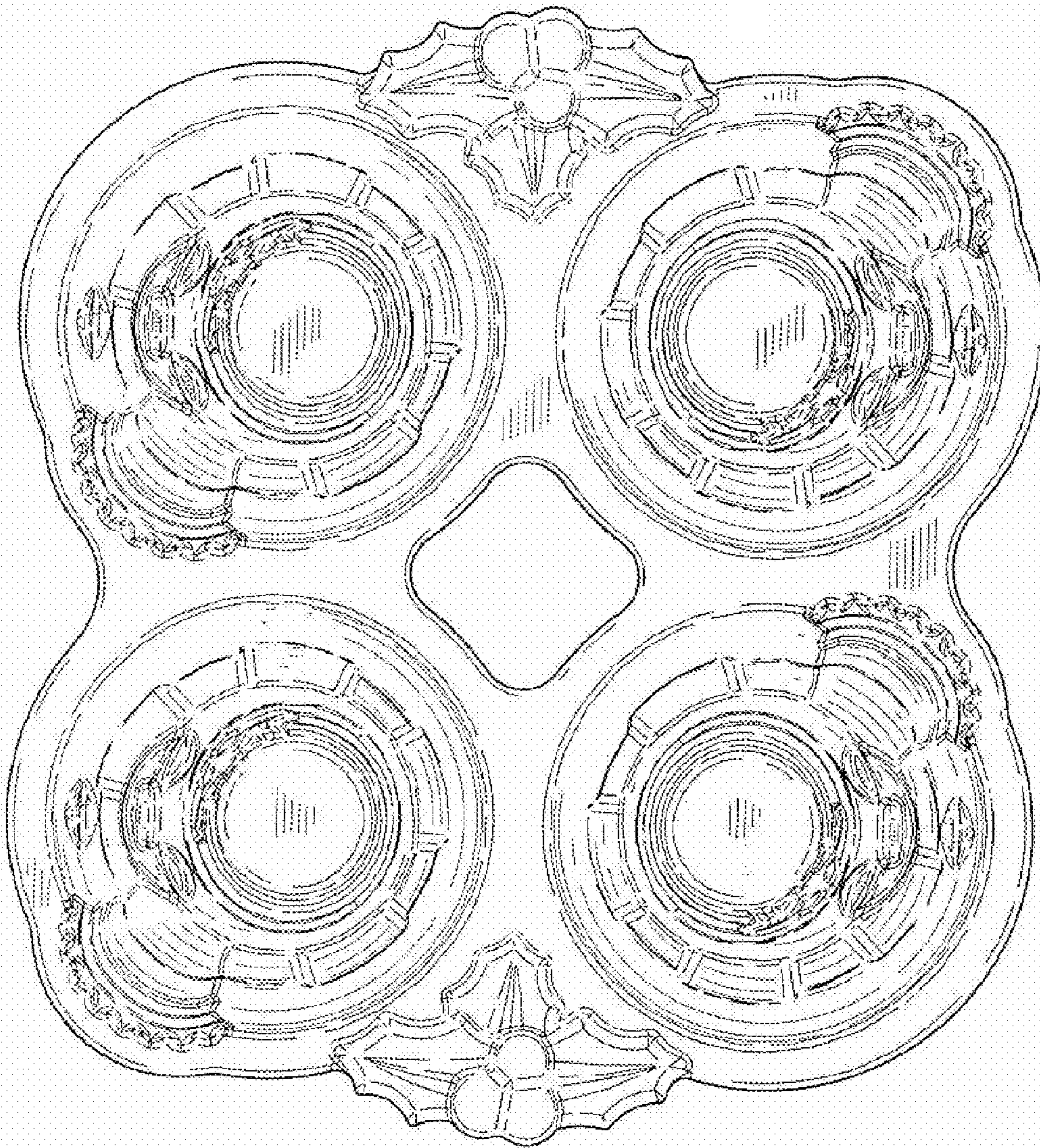

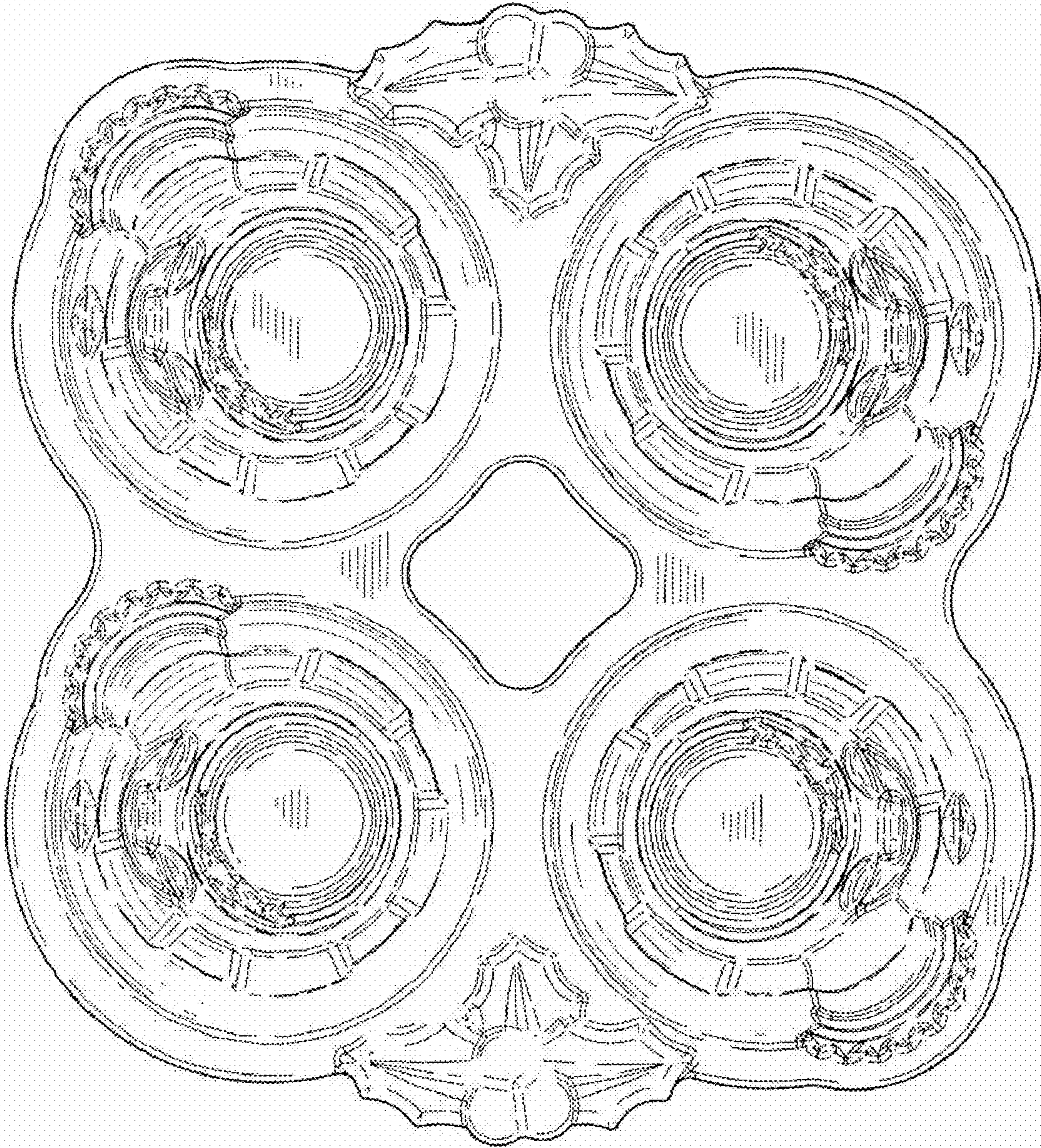
