(57) **CLAIM**

The ornamental design for a cooking appliance door, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of the cooking appliance door showing our ornamental design;

FIG. 2 is a front plan view of the one embodiment of a cooking appliance door shown in FIG. 1;

FIG. 3 is a right plan view of the one embodiment of a cooking appliance door shown in FIG. 1;

FIG. 4 is a left plan view of the one embodiment of a cooking appliance door shown in FIG. 1;

FIG. 8 is a front plan view of the another embodiment of the cooking appliance door shown in FIG. 7;

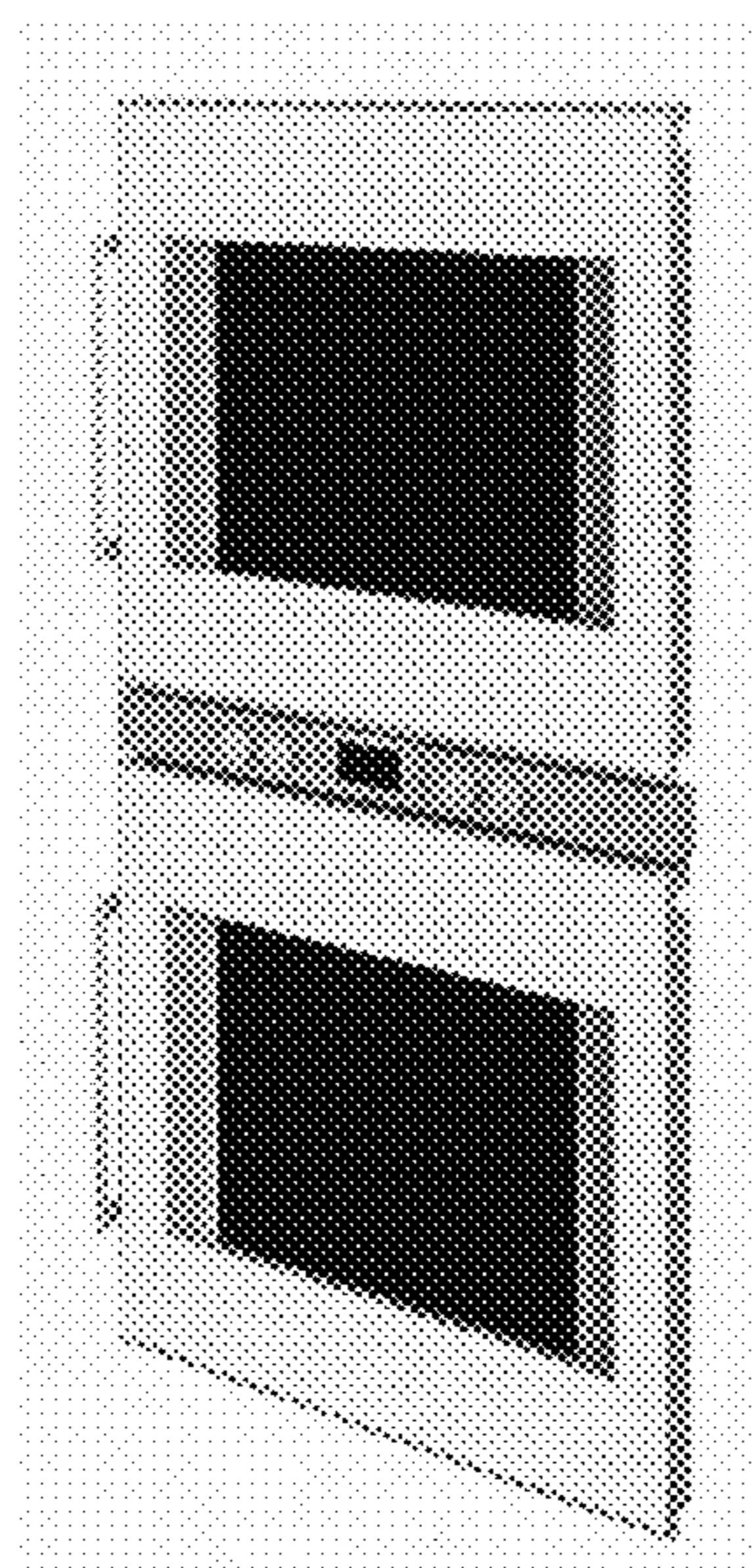
FIG. 9 is a right plan view of the another embodiment of the cooking appliance door shown in FIG. 7;

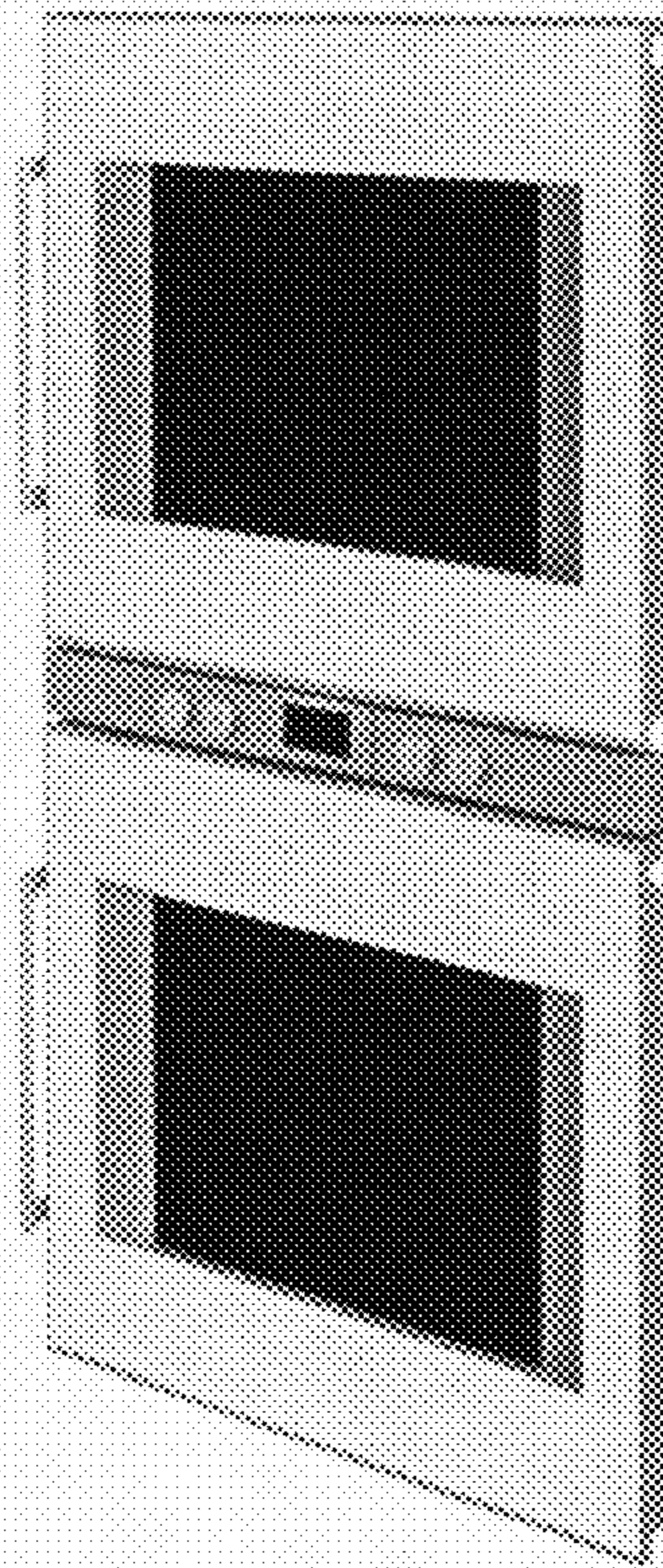

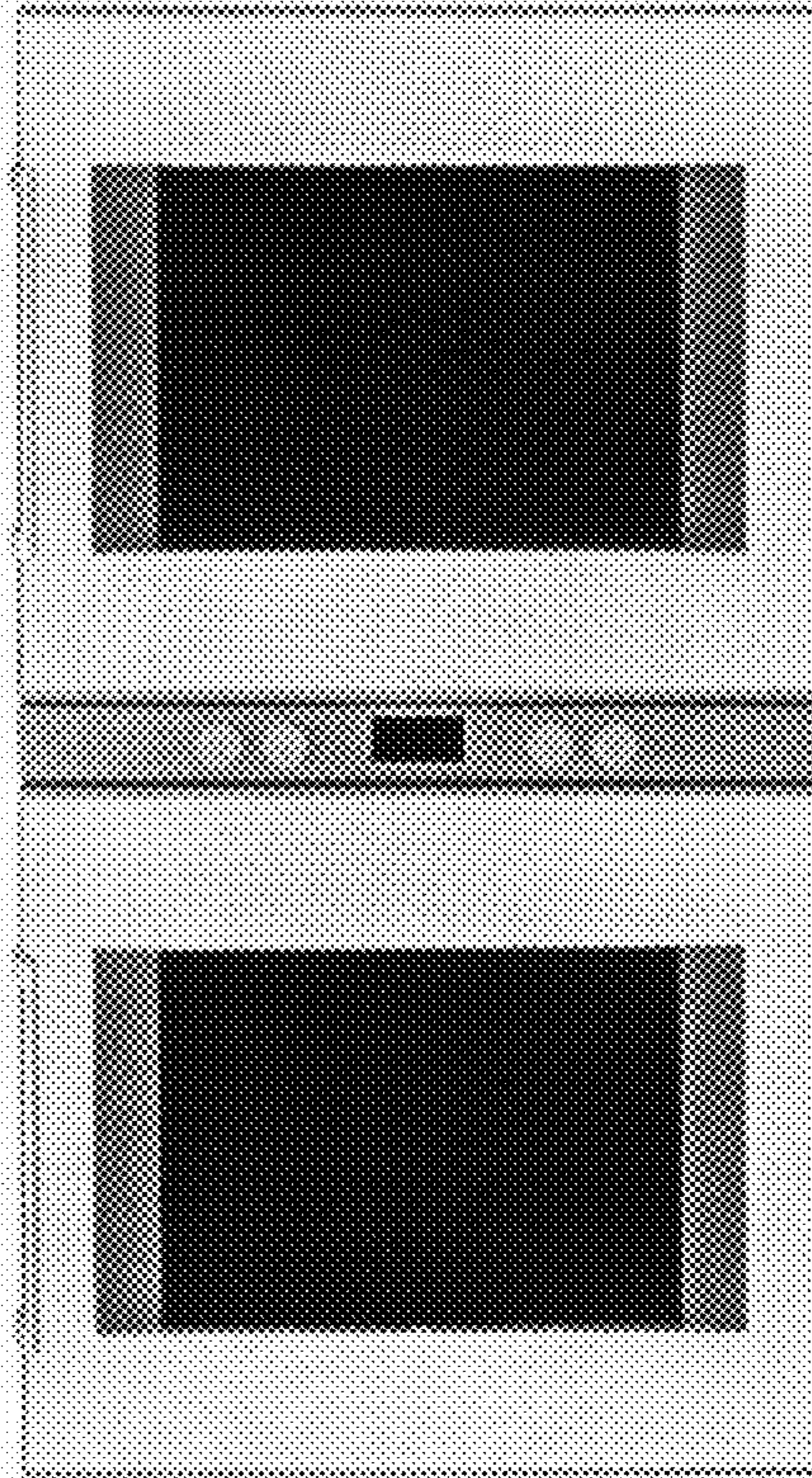

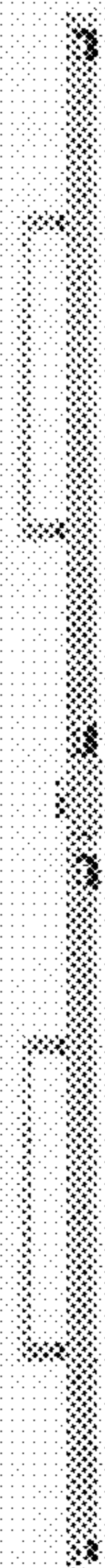

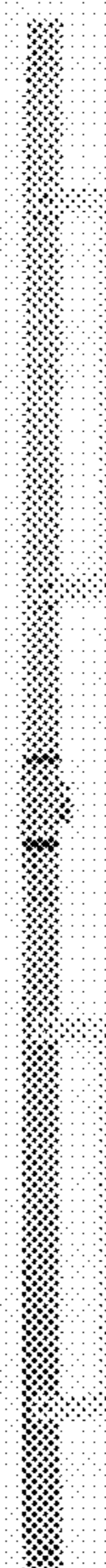

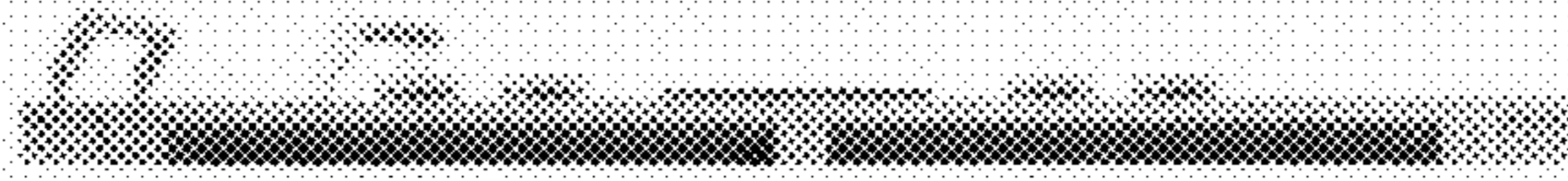

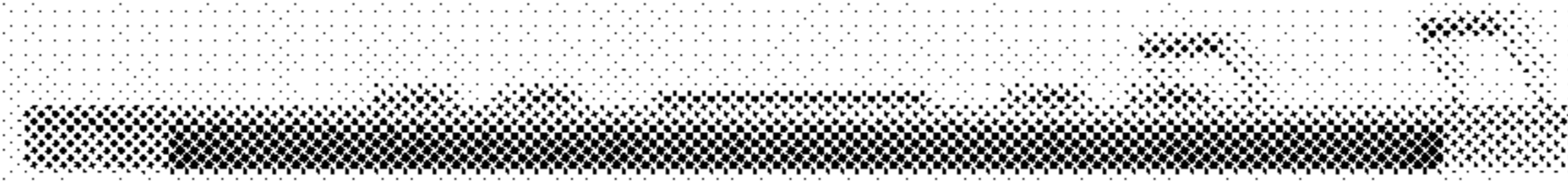

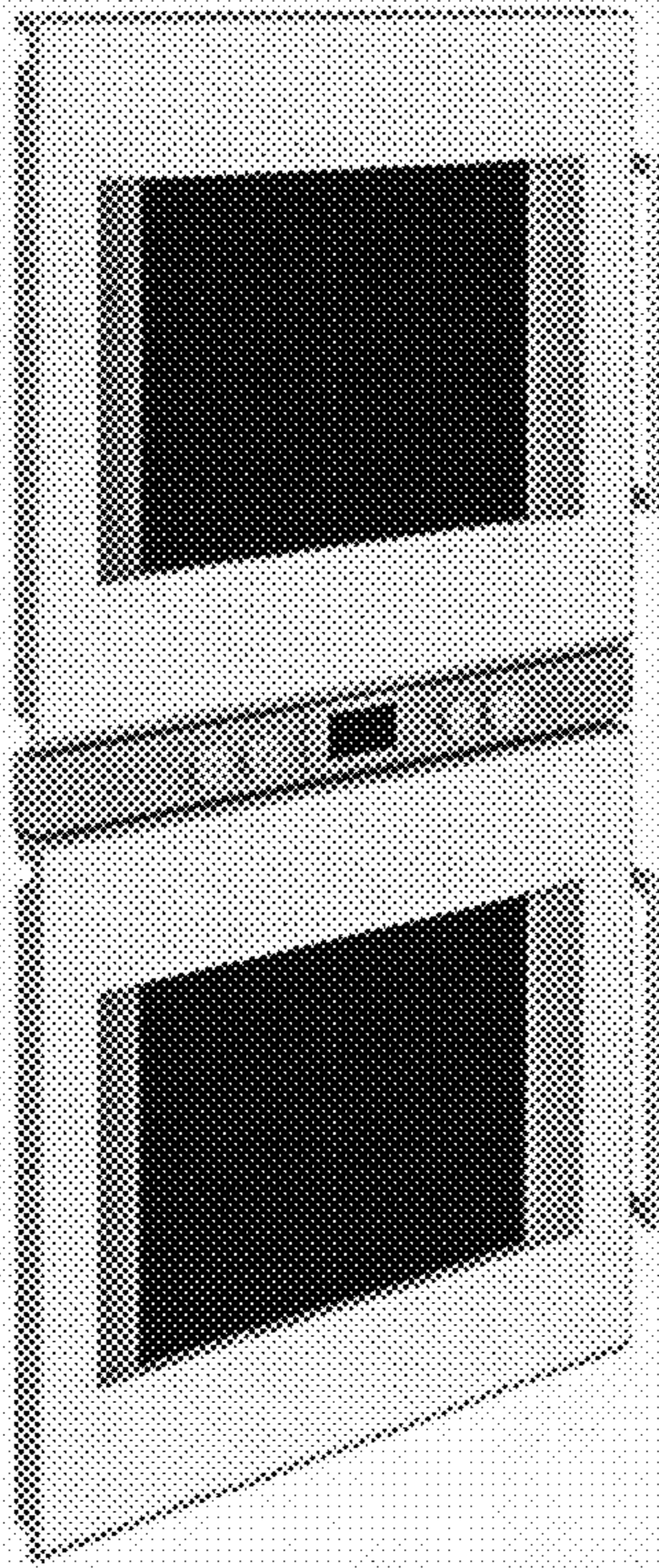

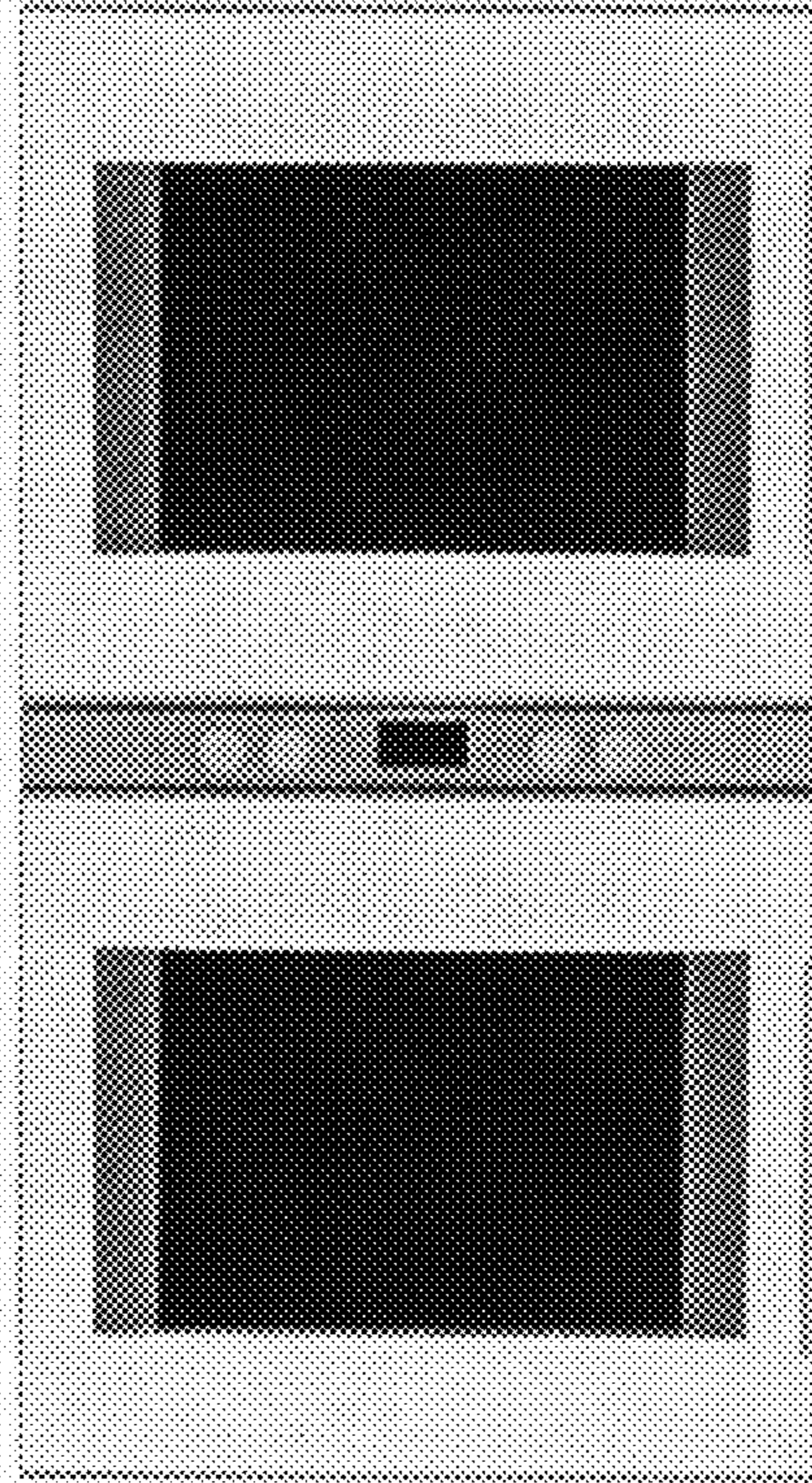

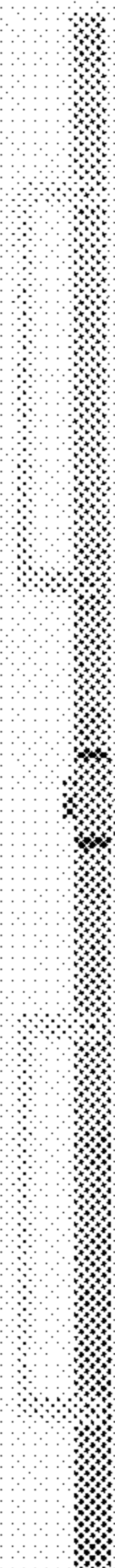

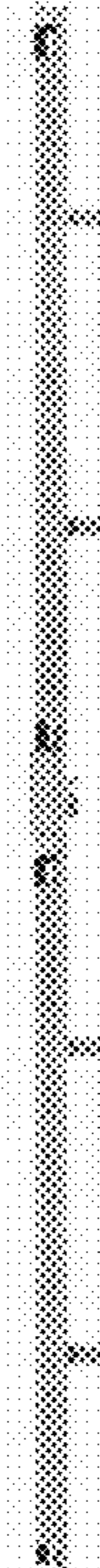

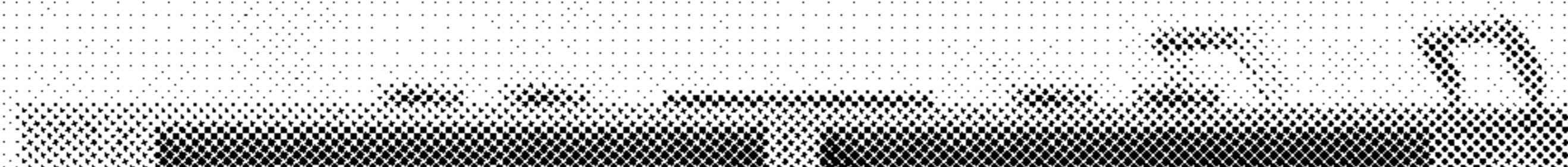

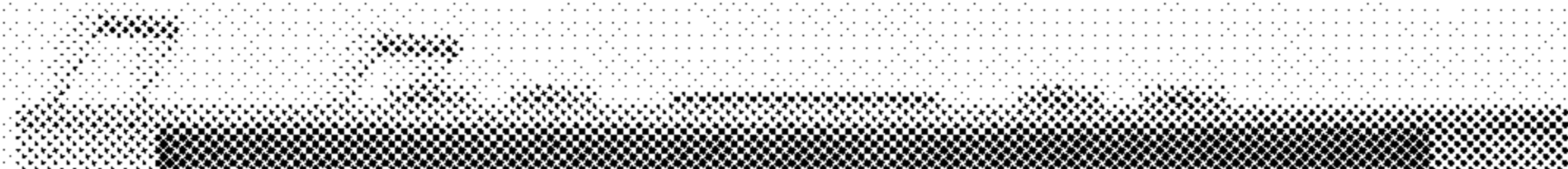
