The ornamental design for a furniture knob, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a furniture knob showing my new design.

FIG. 2 is a left side elevational view thereof.

FIG. 3 is front elevational view thereof.

FIG. 4 is a section view taken along line 4—4 of FIG. 3.

FIG. 5 is a rear view thereof.

FIG. 6 is a perspective view of a second embodiment of a furniture knob showing my new design.

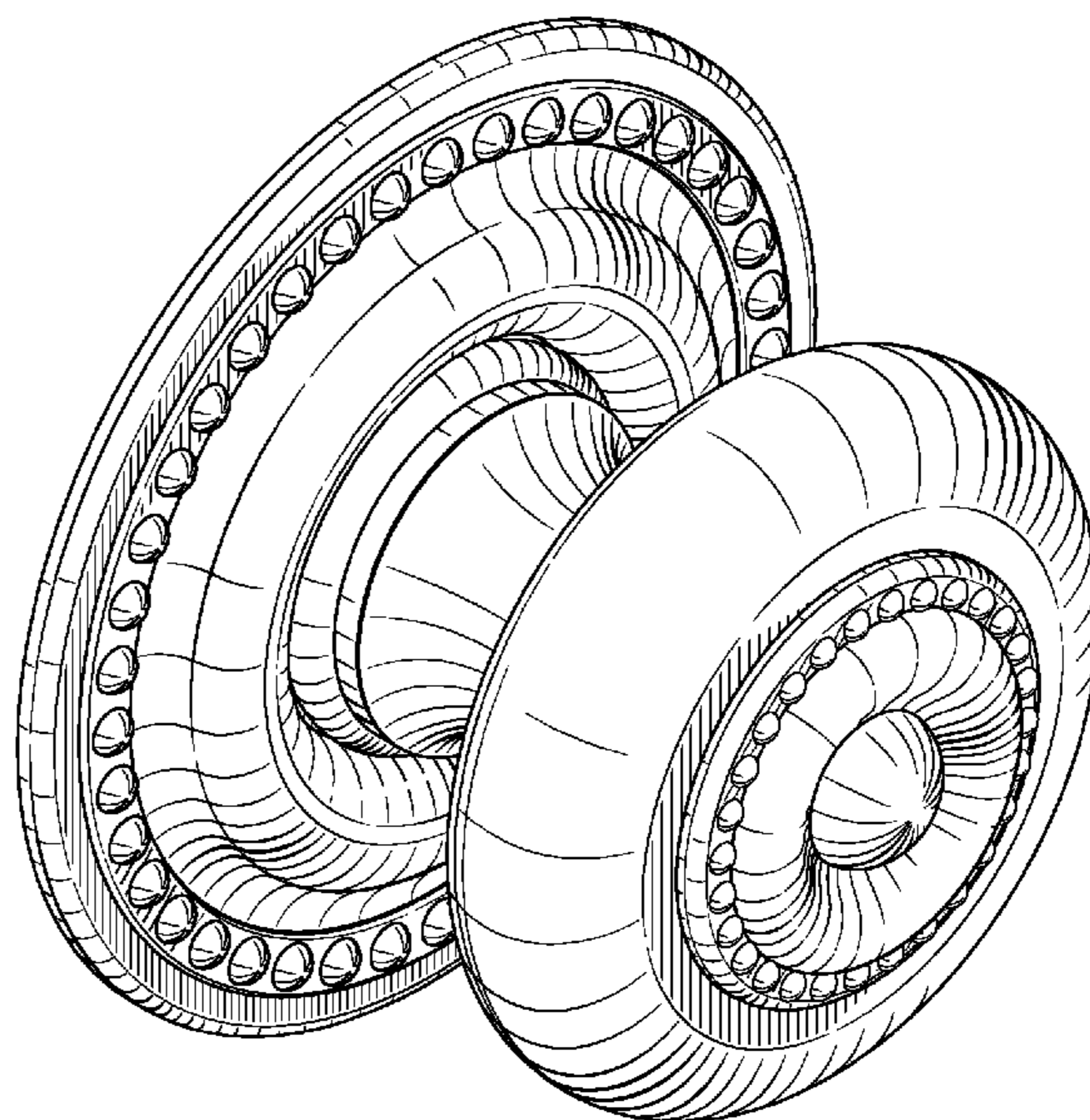
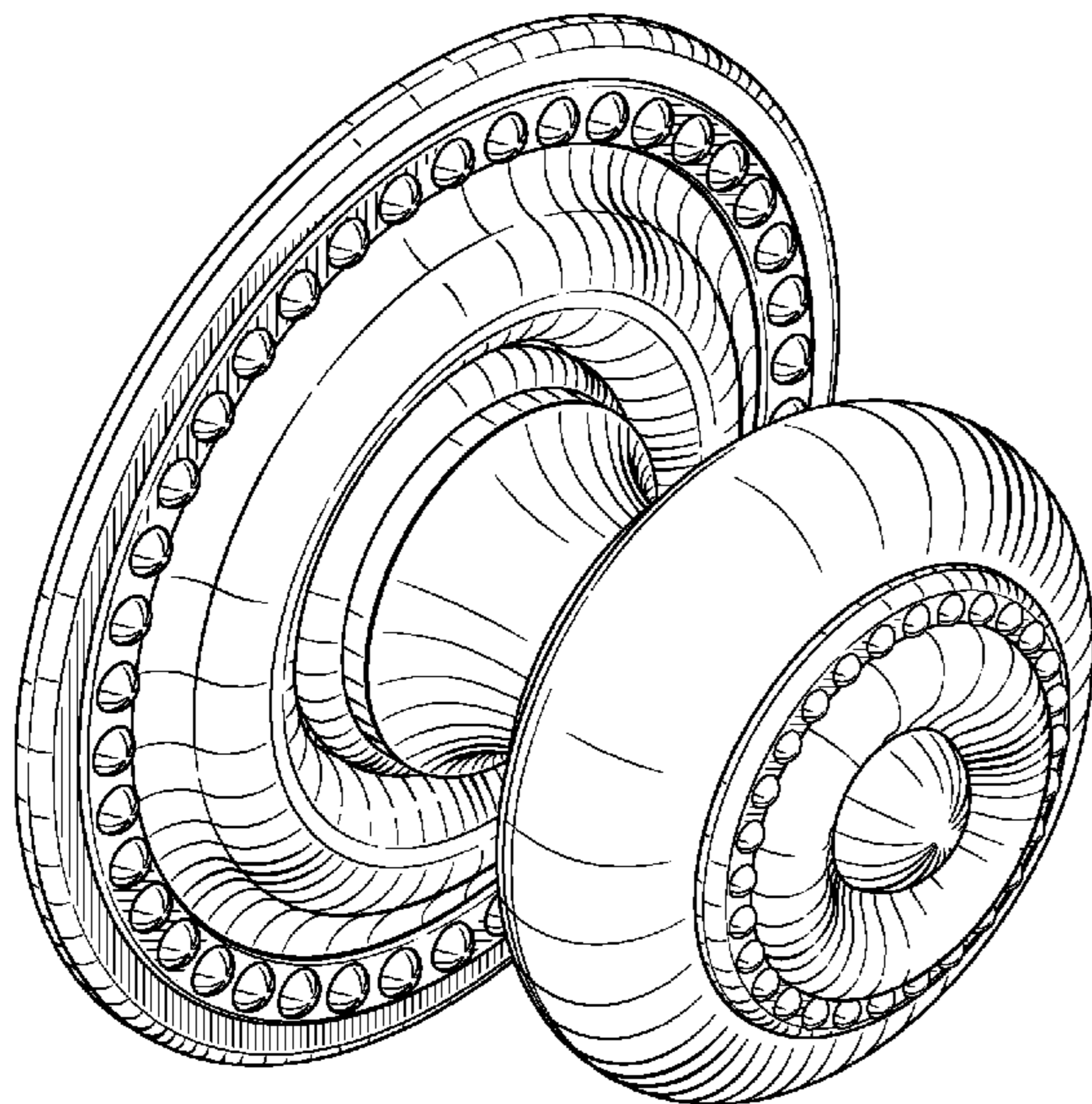
FIG. 7 is a left side elevational view of FIG. 6.

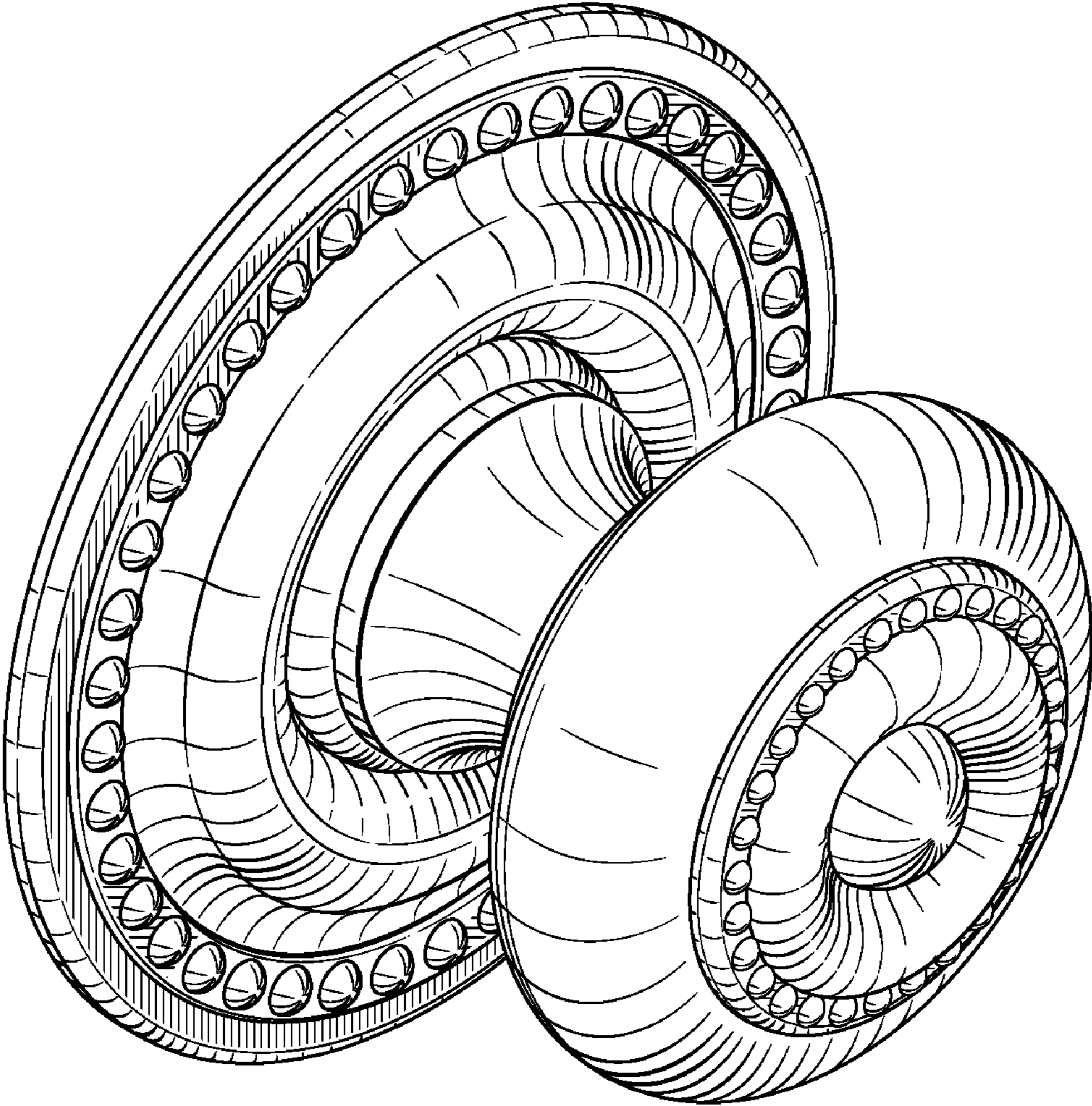

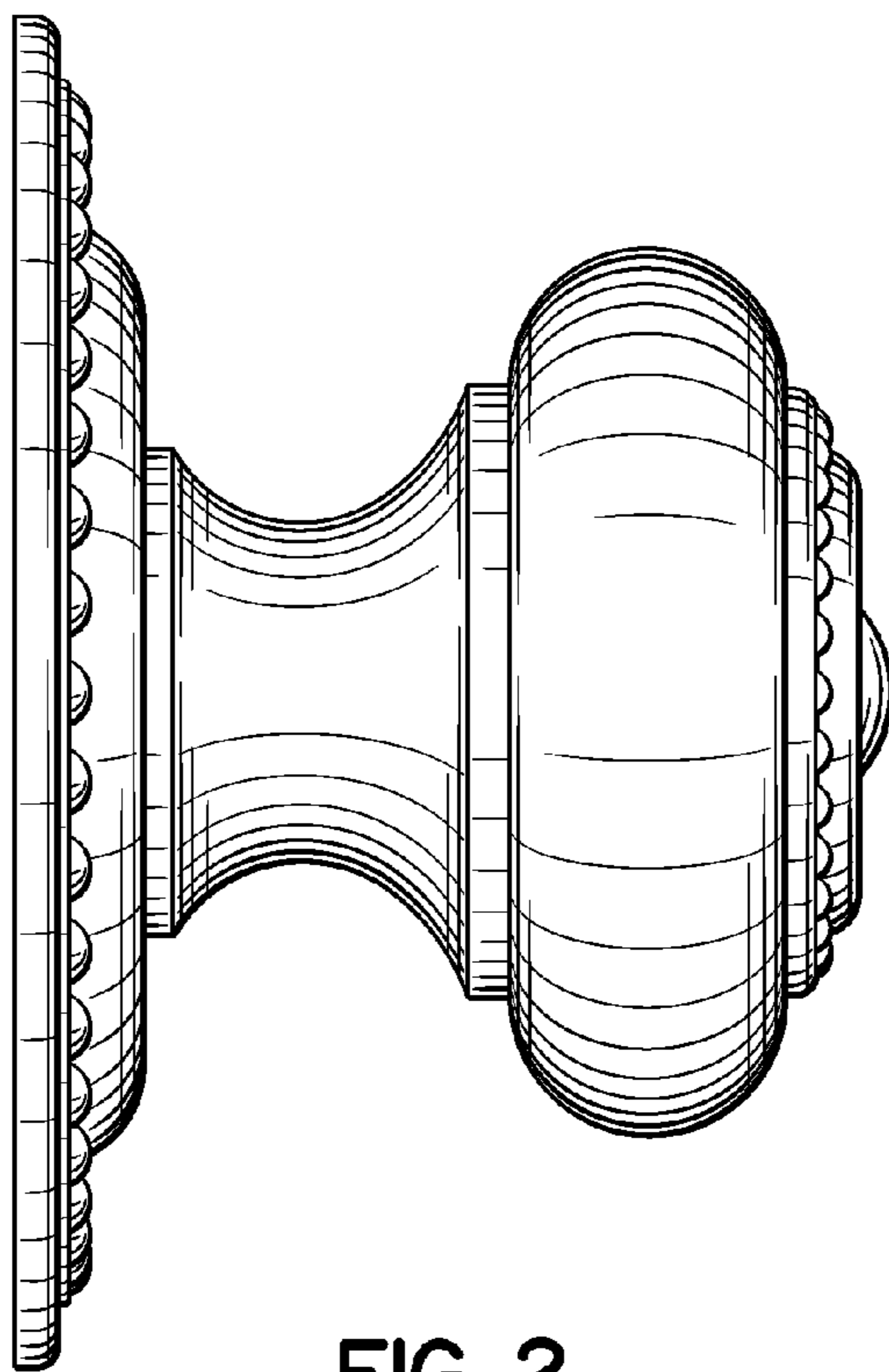

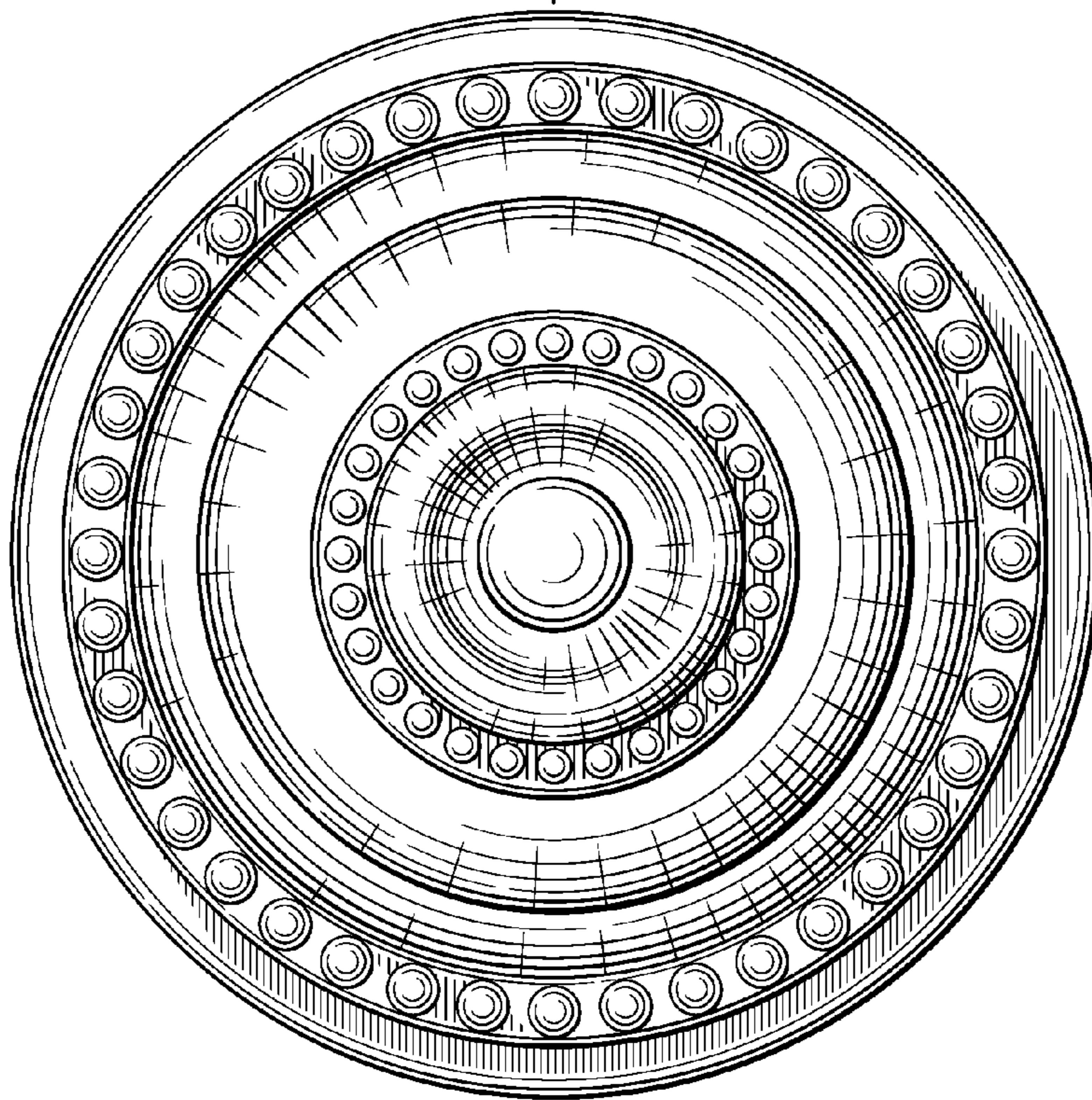
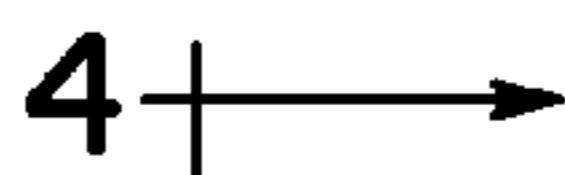

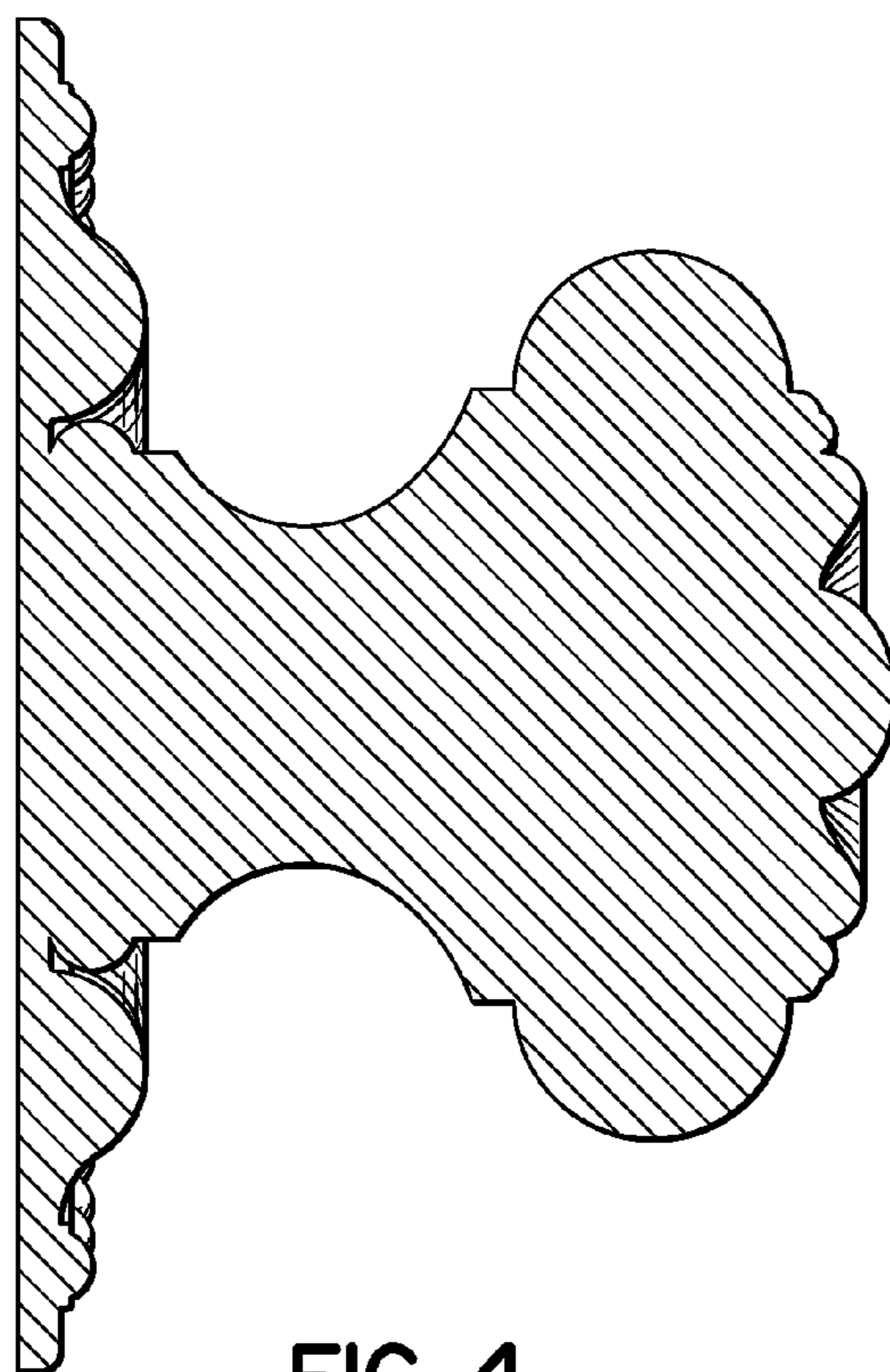

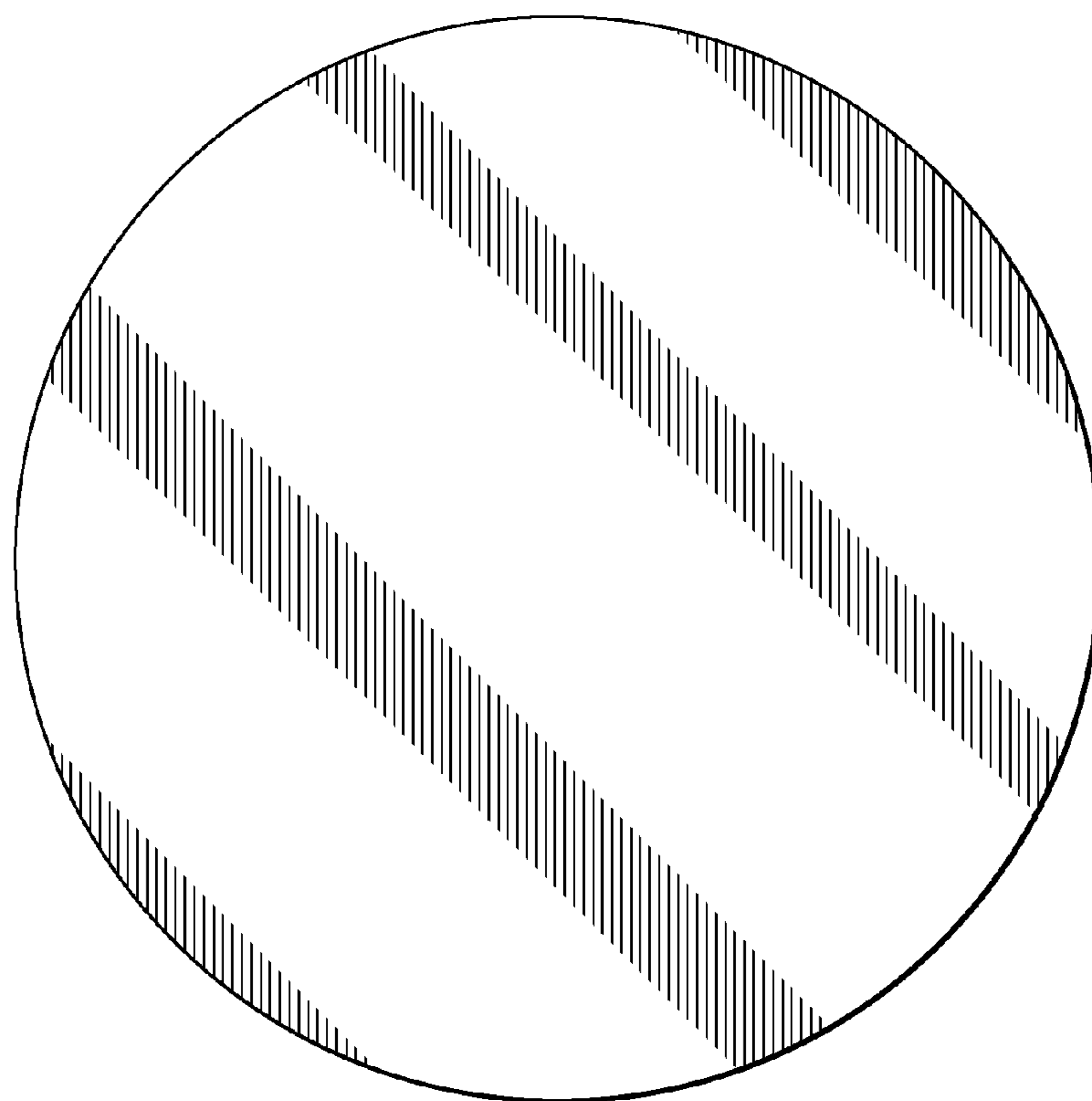

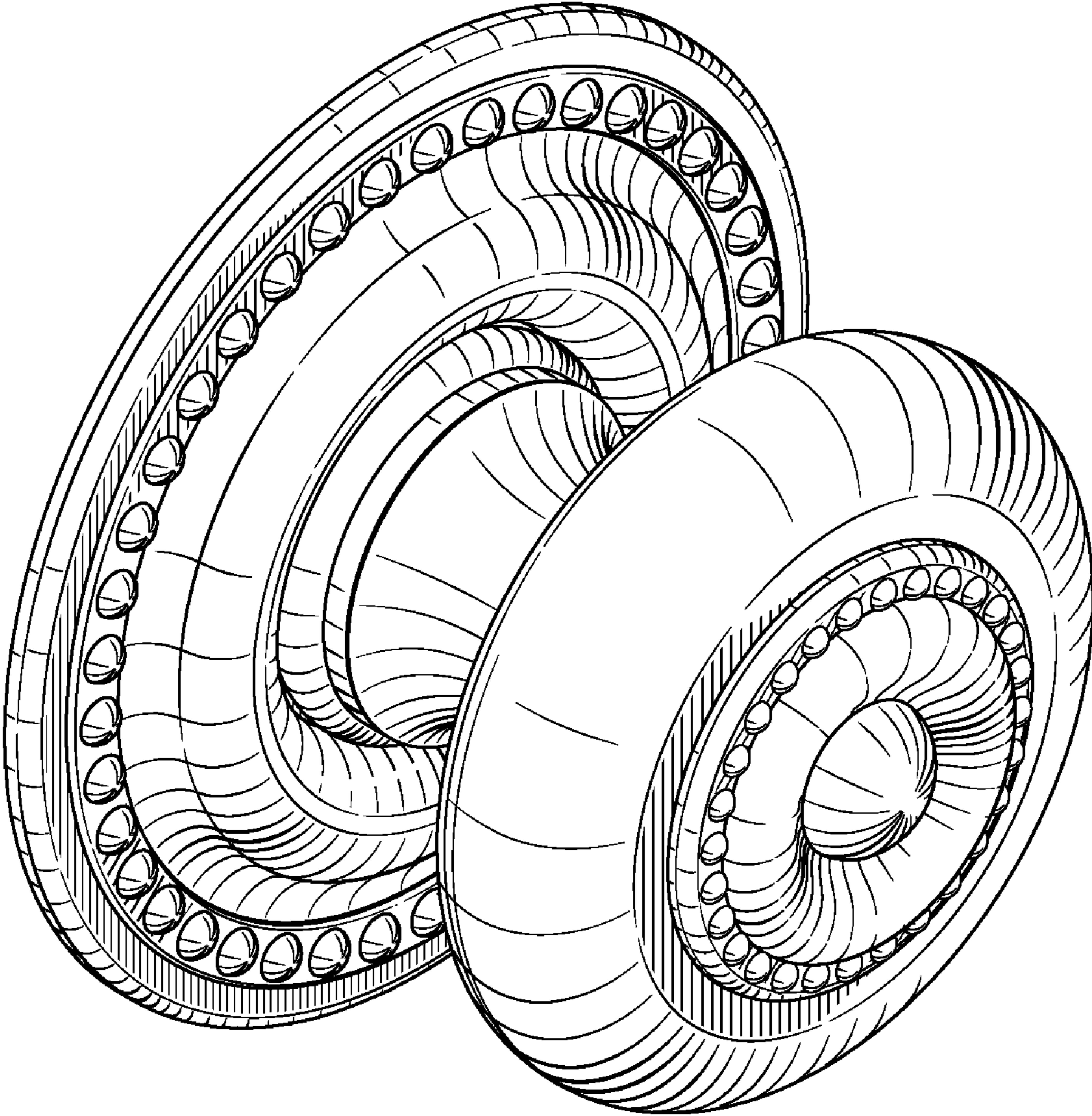

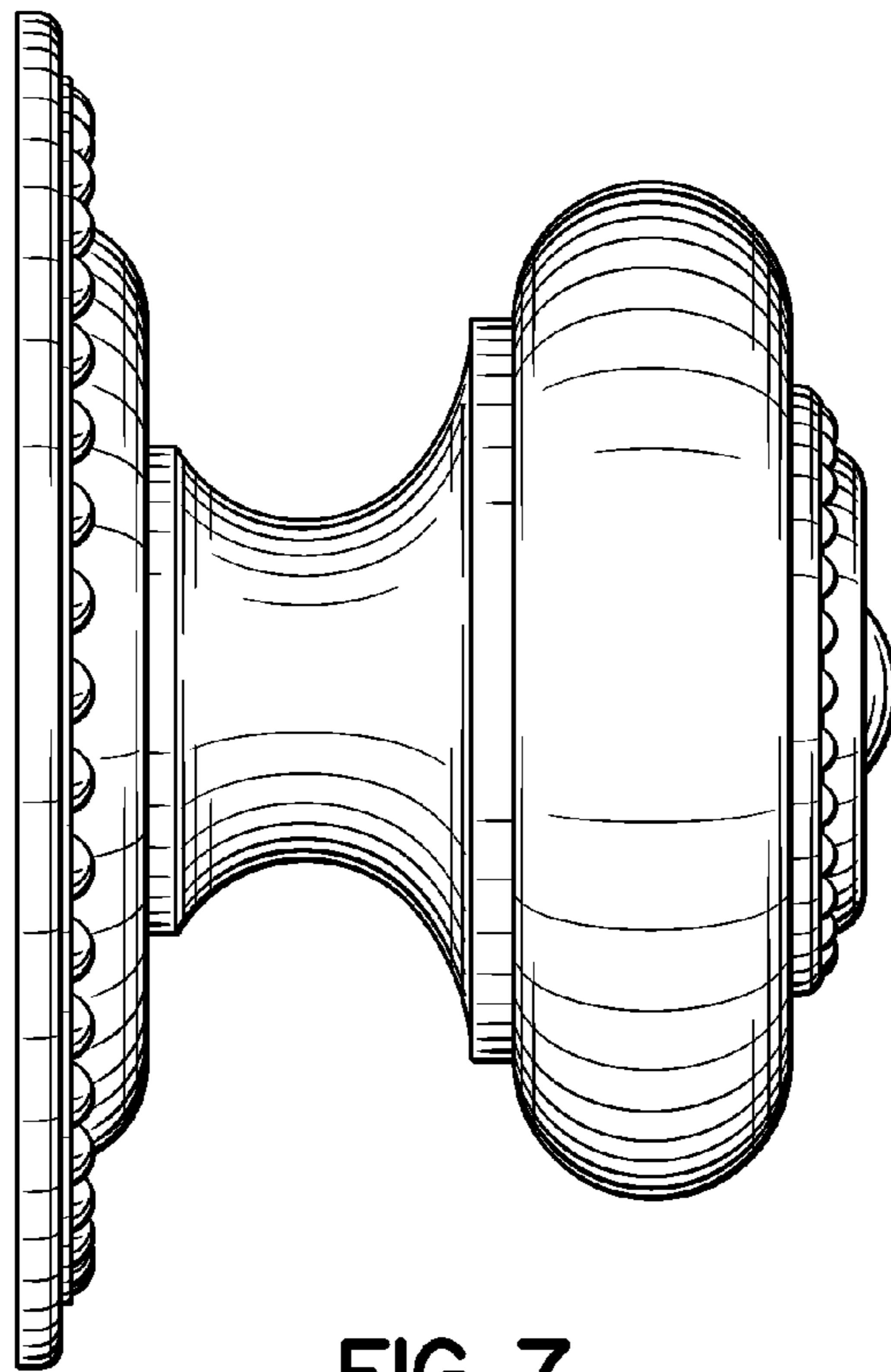

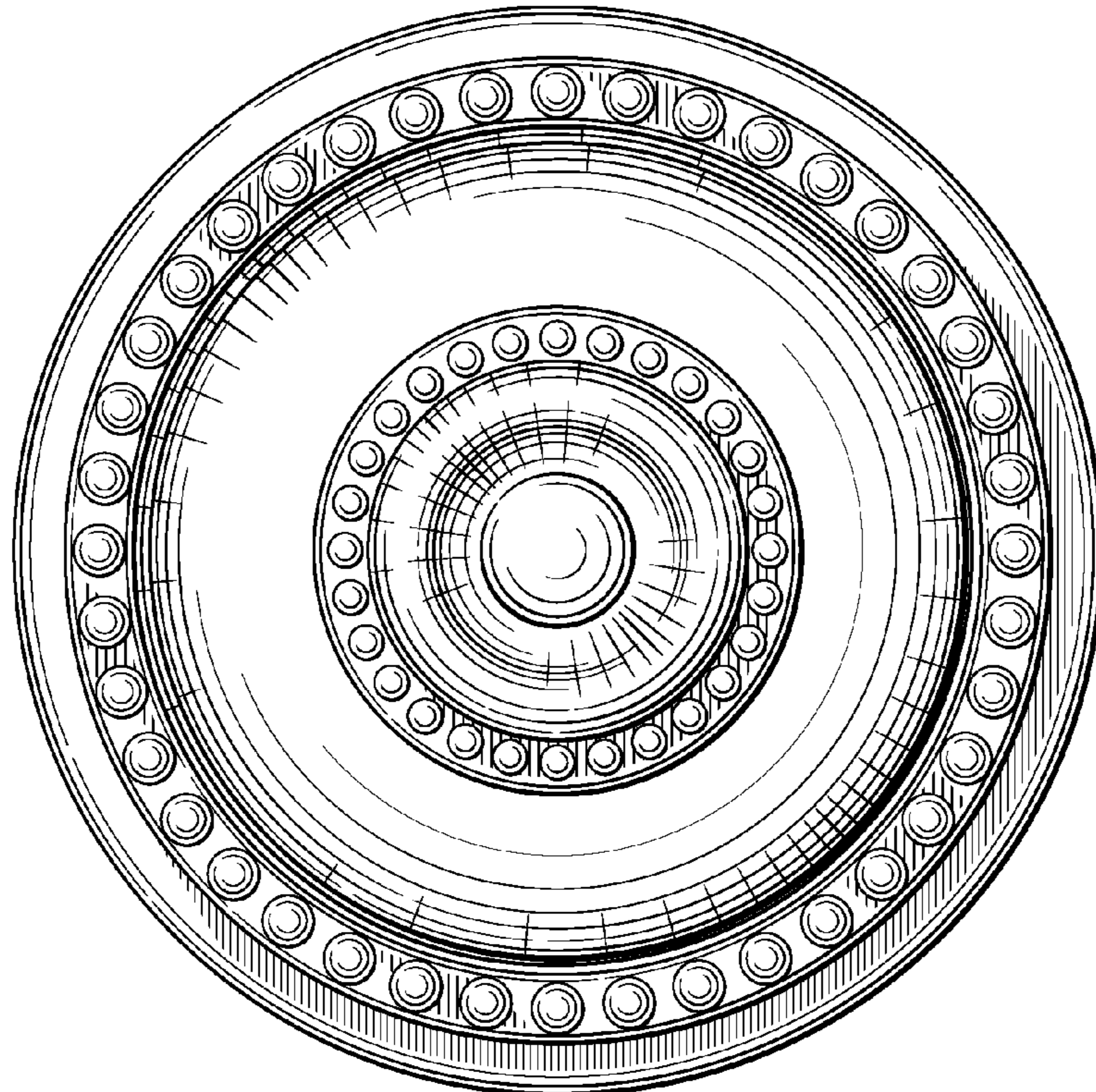
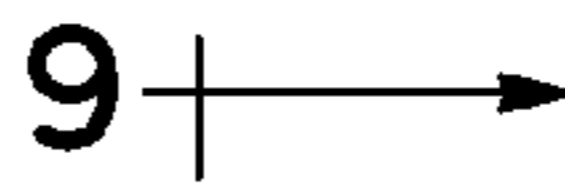

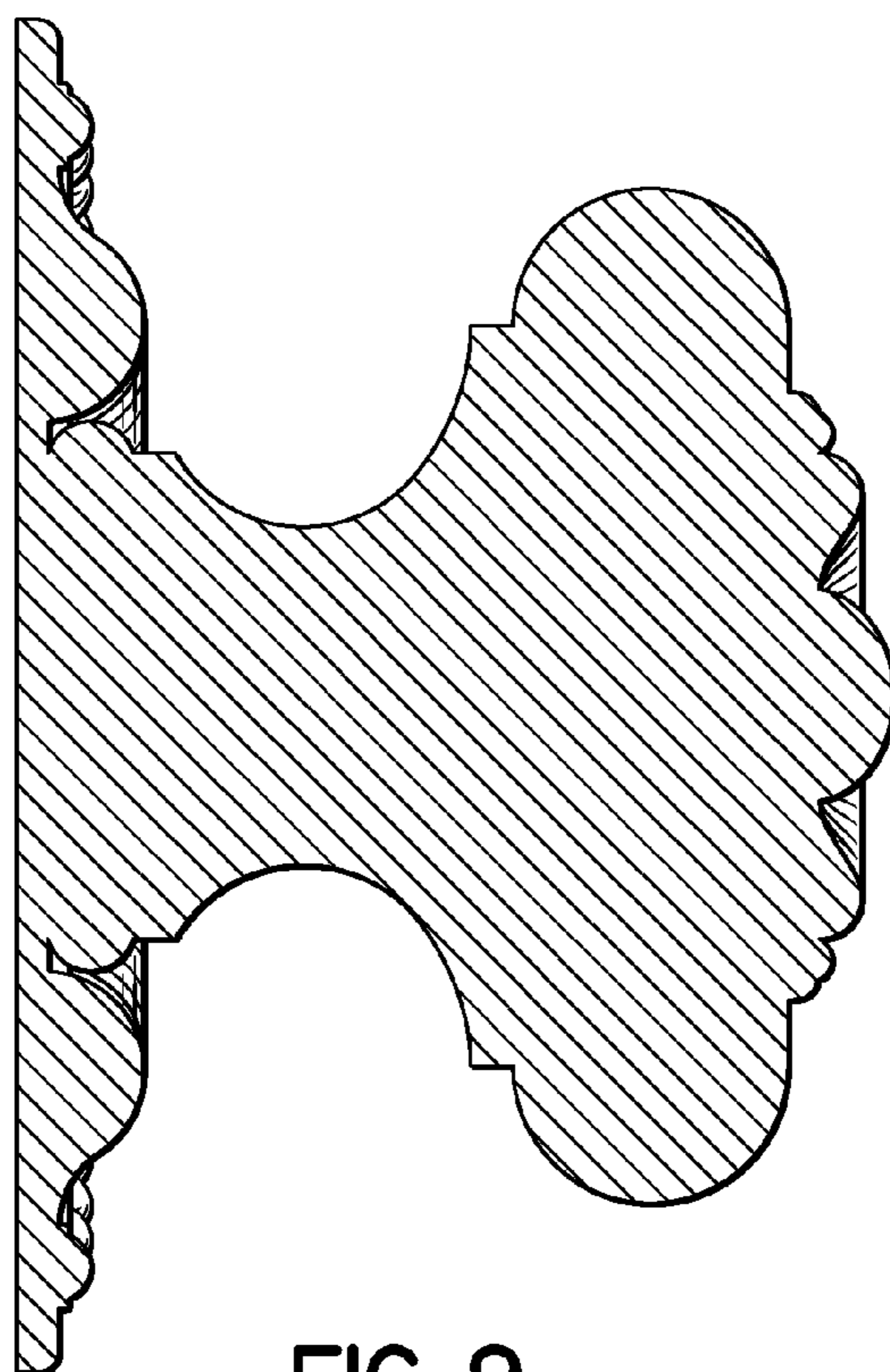

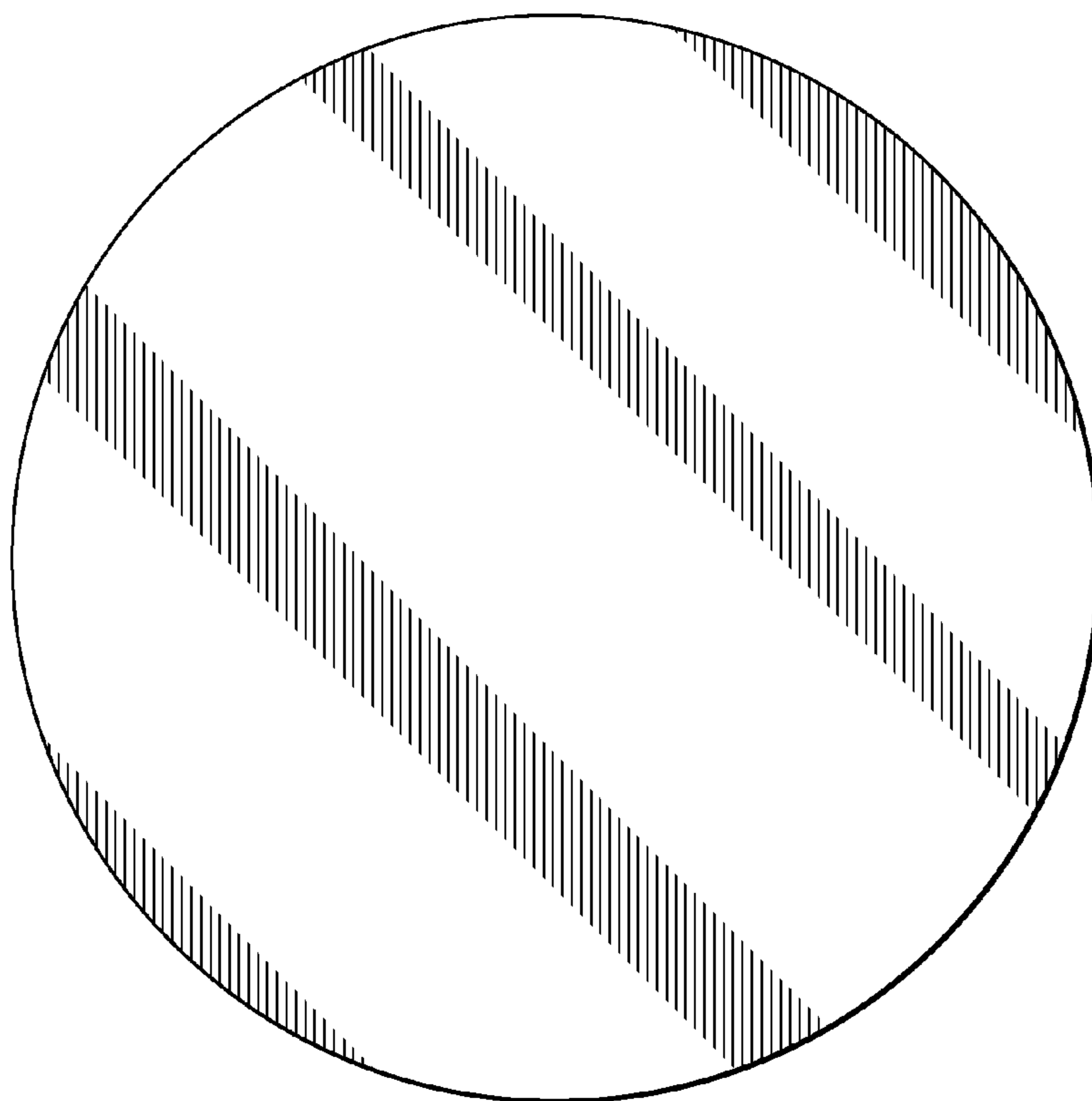
