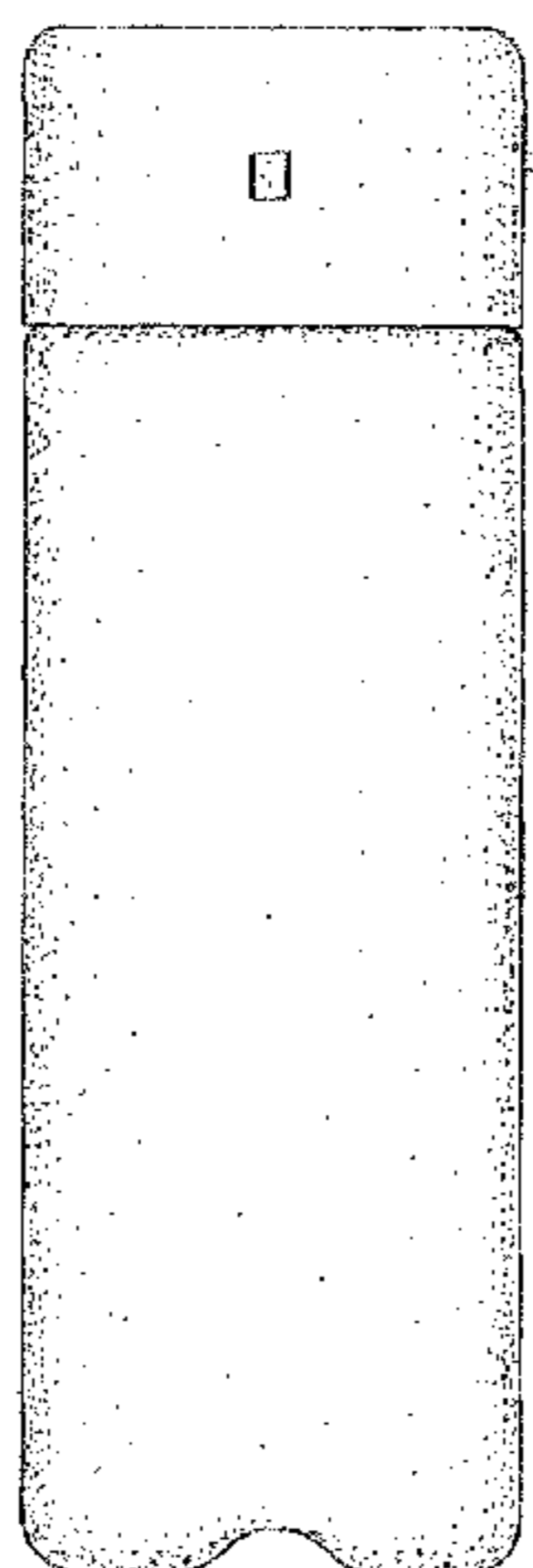
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top and side perspective view of container for food products, showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a side elevational view thereof from the right of FIG. 2;
FIG. 4 is a side elevational view thereof from the side opposite that shown in FIG. 2;
FIG. 5 is a side elevational view thereof from the right of FIG. 4;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

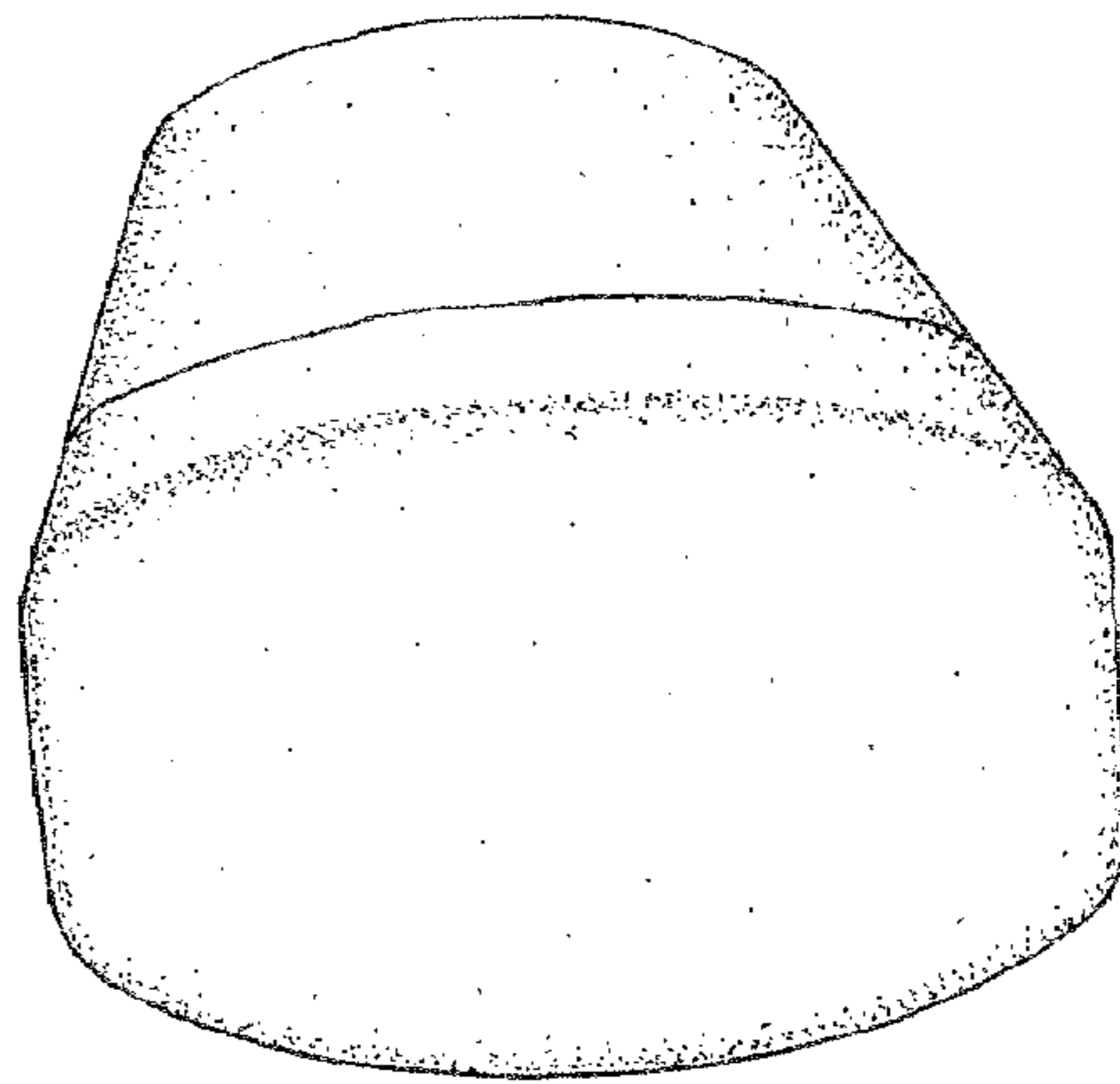

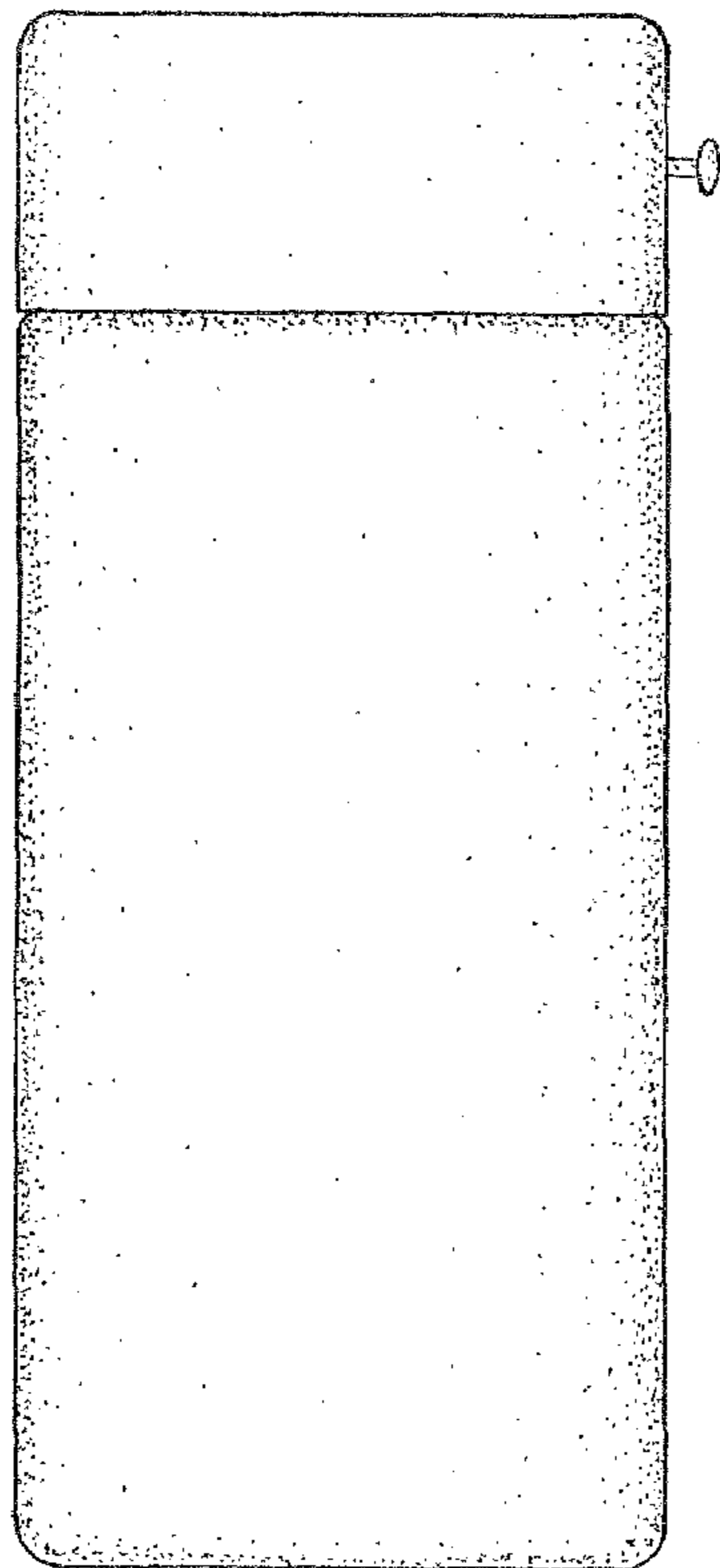

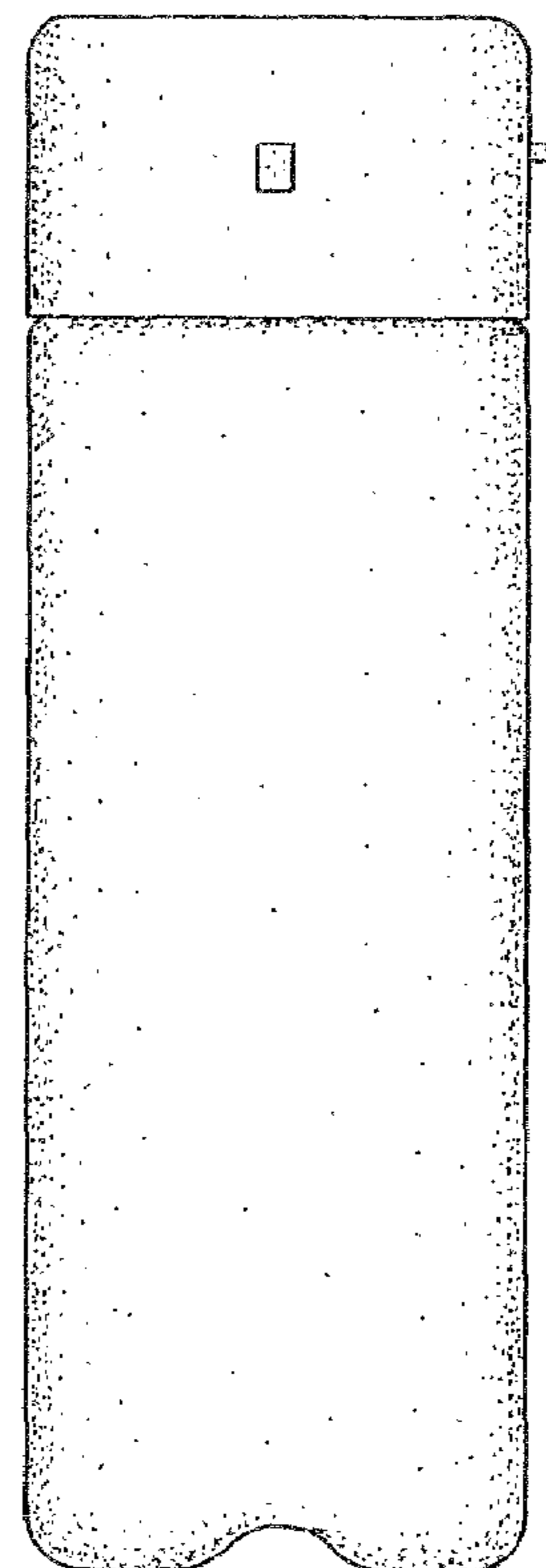

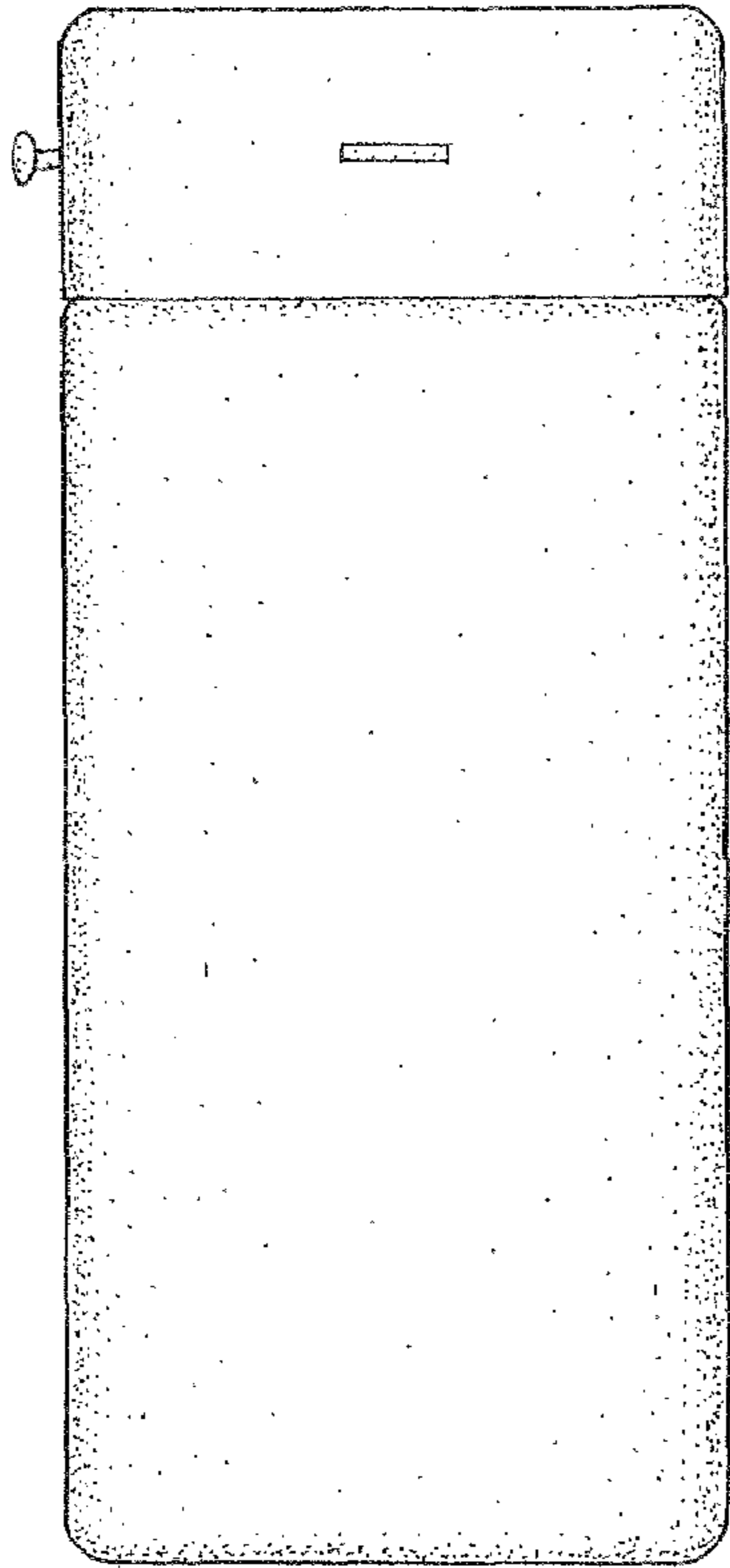

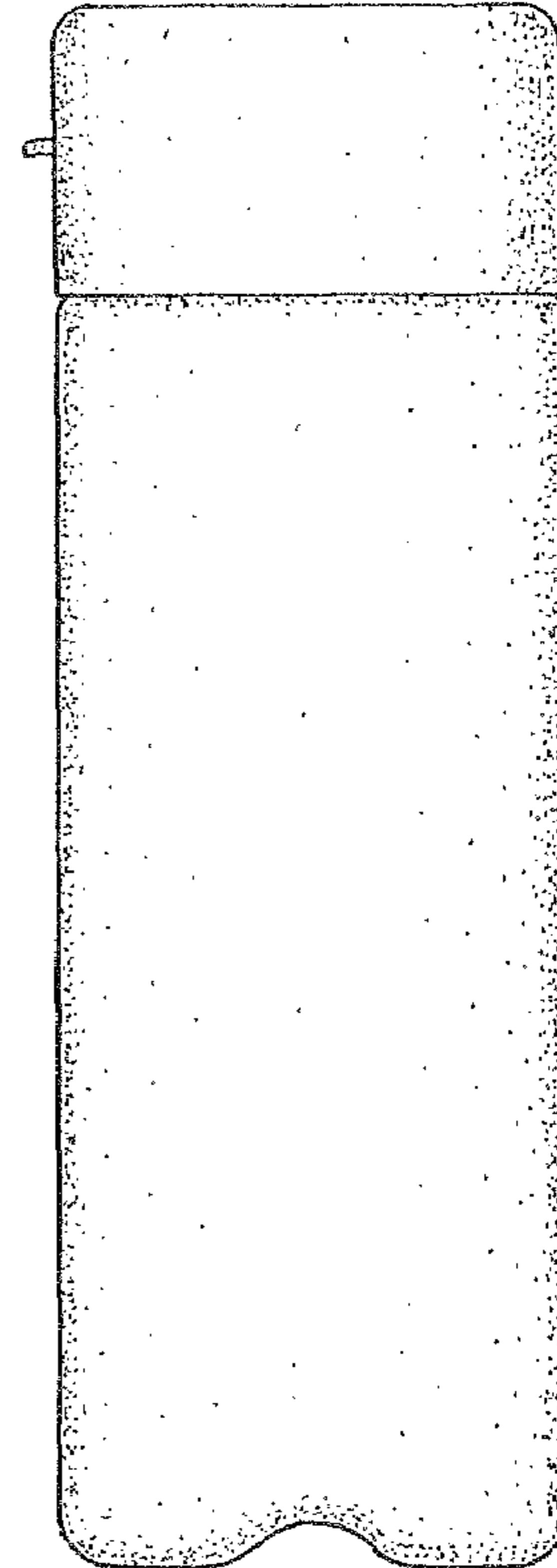

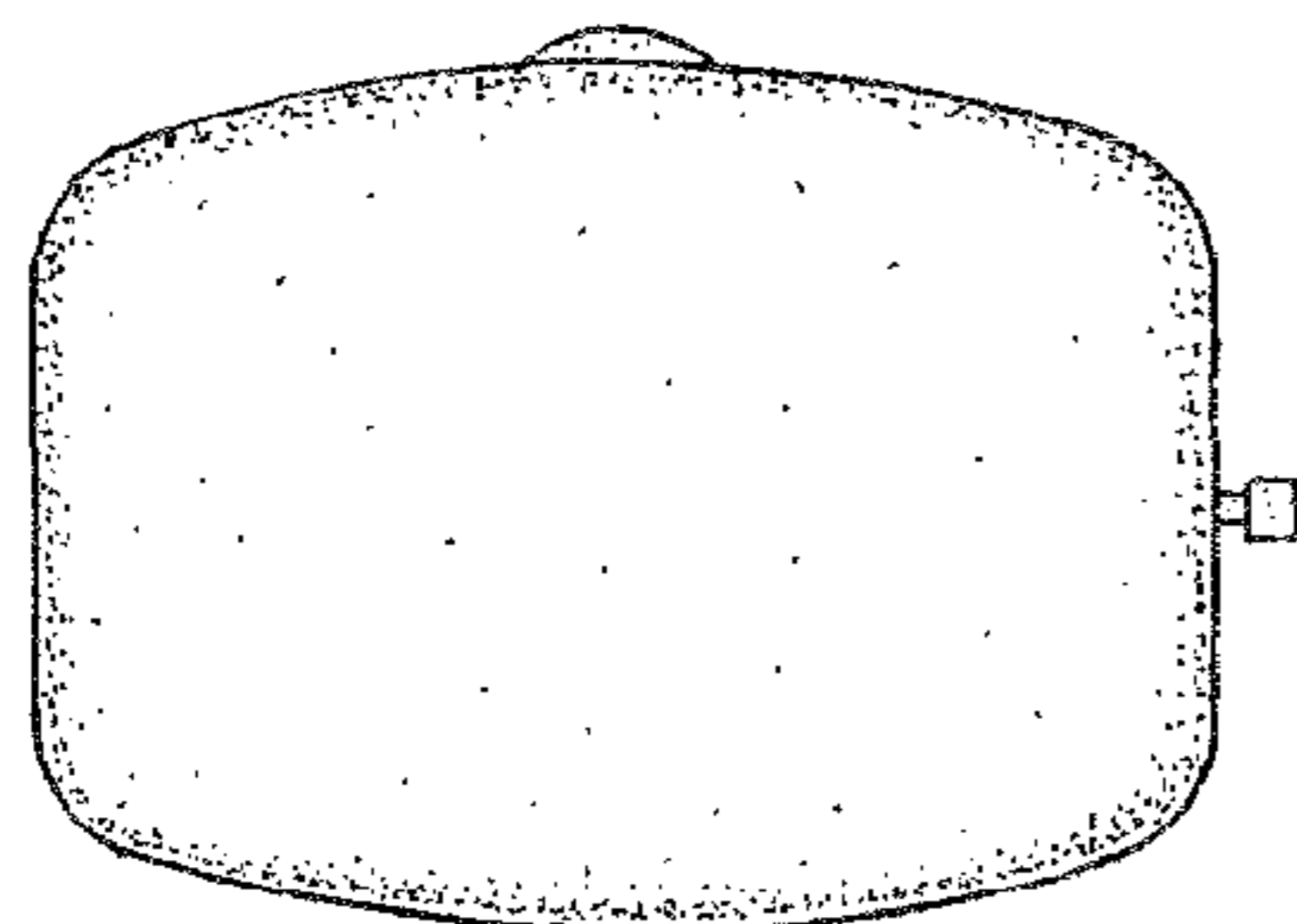

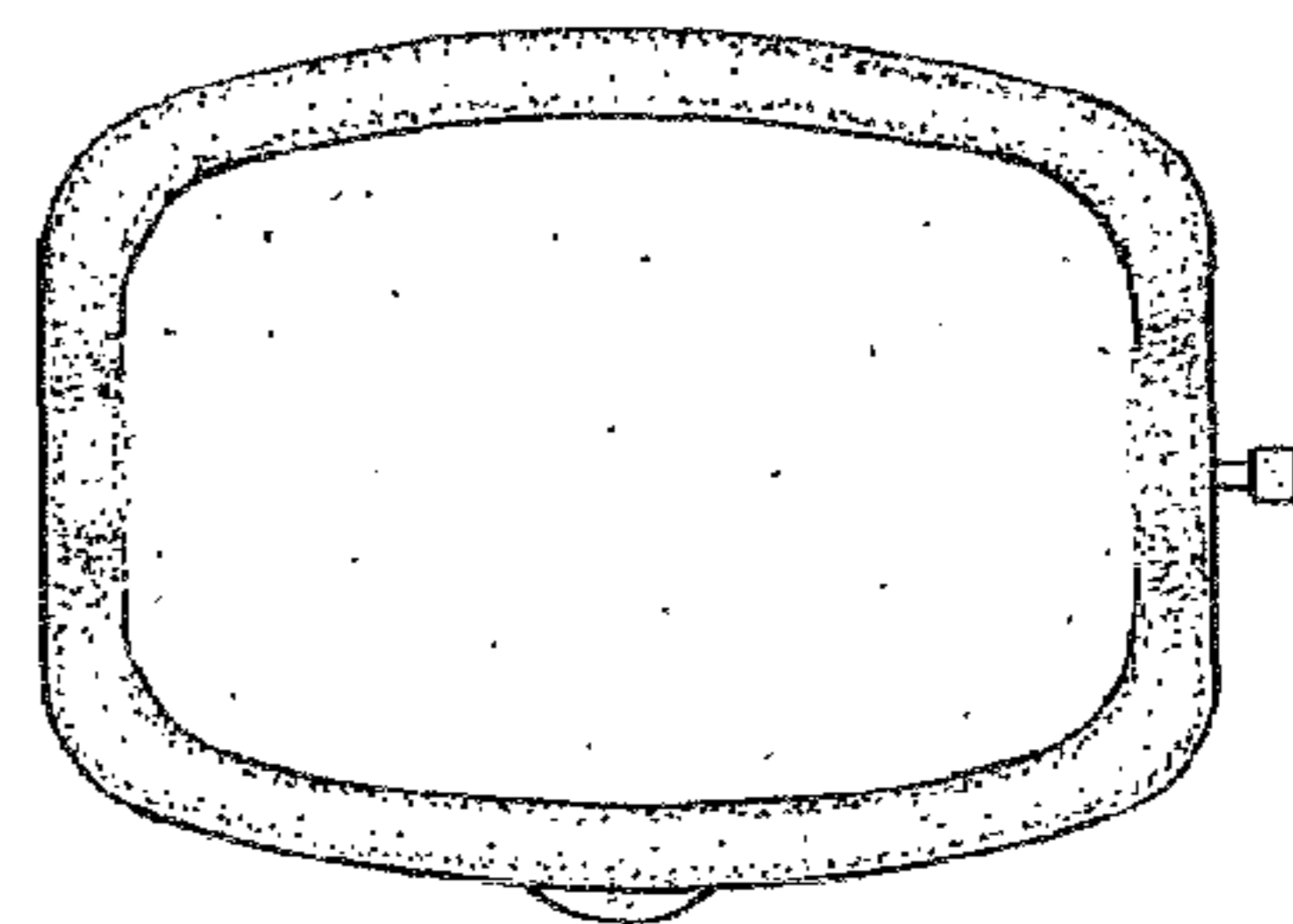
