(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, and left side perspective view of the invention;

FIG. 2 is a left side elevational view thereof, the right side elevational view being identical;

FIG. 3 is a front elevational view thereof, the back elevational view being identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

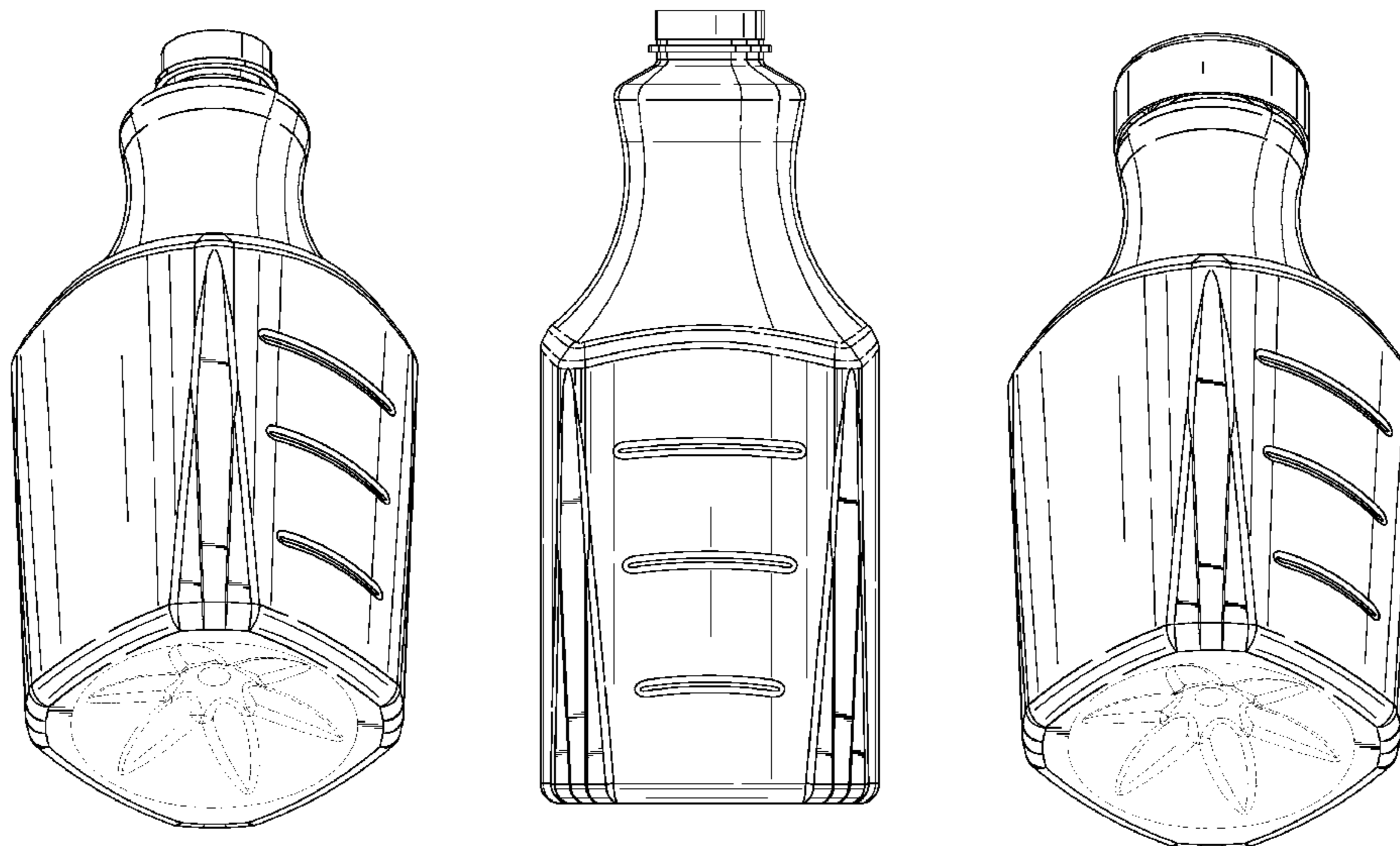
FIG. 6 is a bottom, front, and left side perspective view of the bottle of FIG. 1 shown with a cap thereof, the front, left side, right side, and back side elevations of the cap being identical;

FIG. 7 is a left side elevational view thereof; and,

FIG. 8 is a top plan view thereof.

The broken lines shown on the bottom surface of the bottle in the drawing views are included for the purpose of showing environmental structure that forms no part of the claimed design.

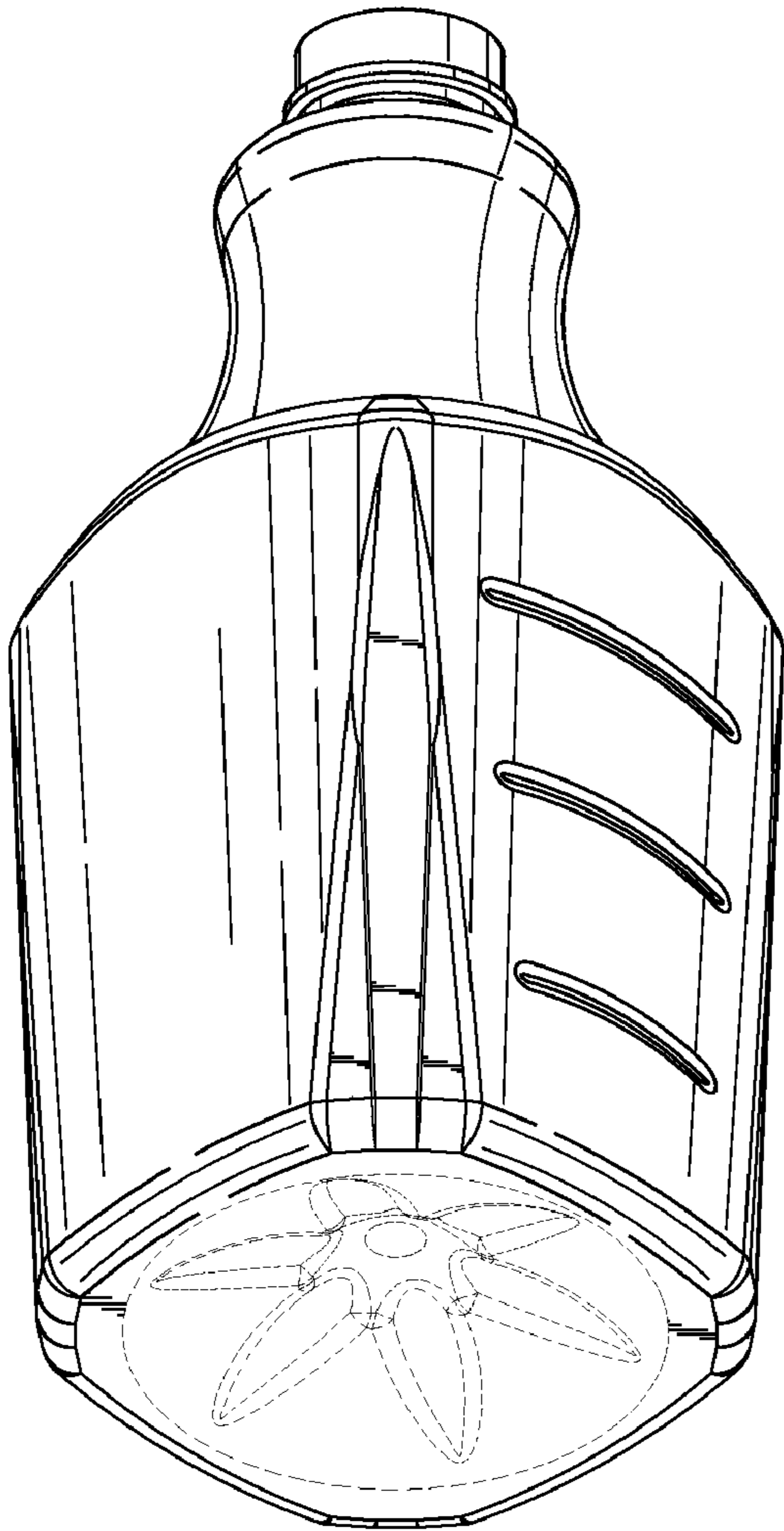

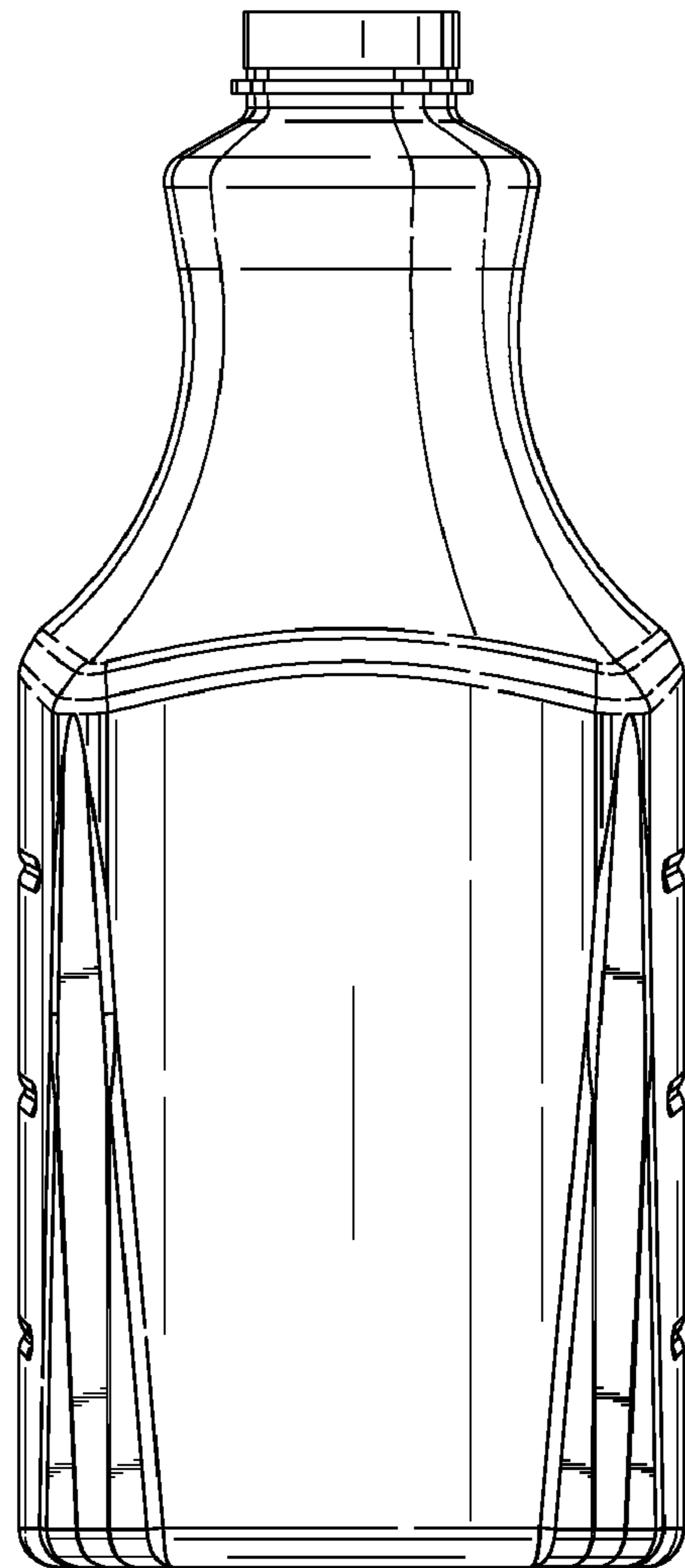

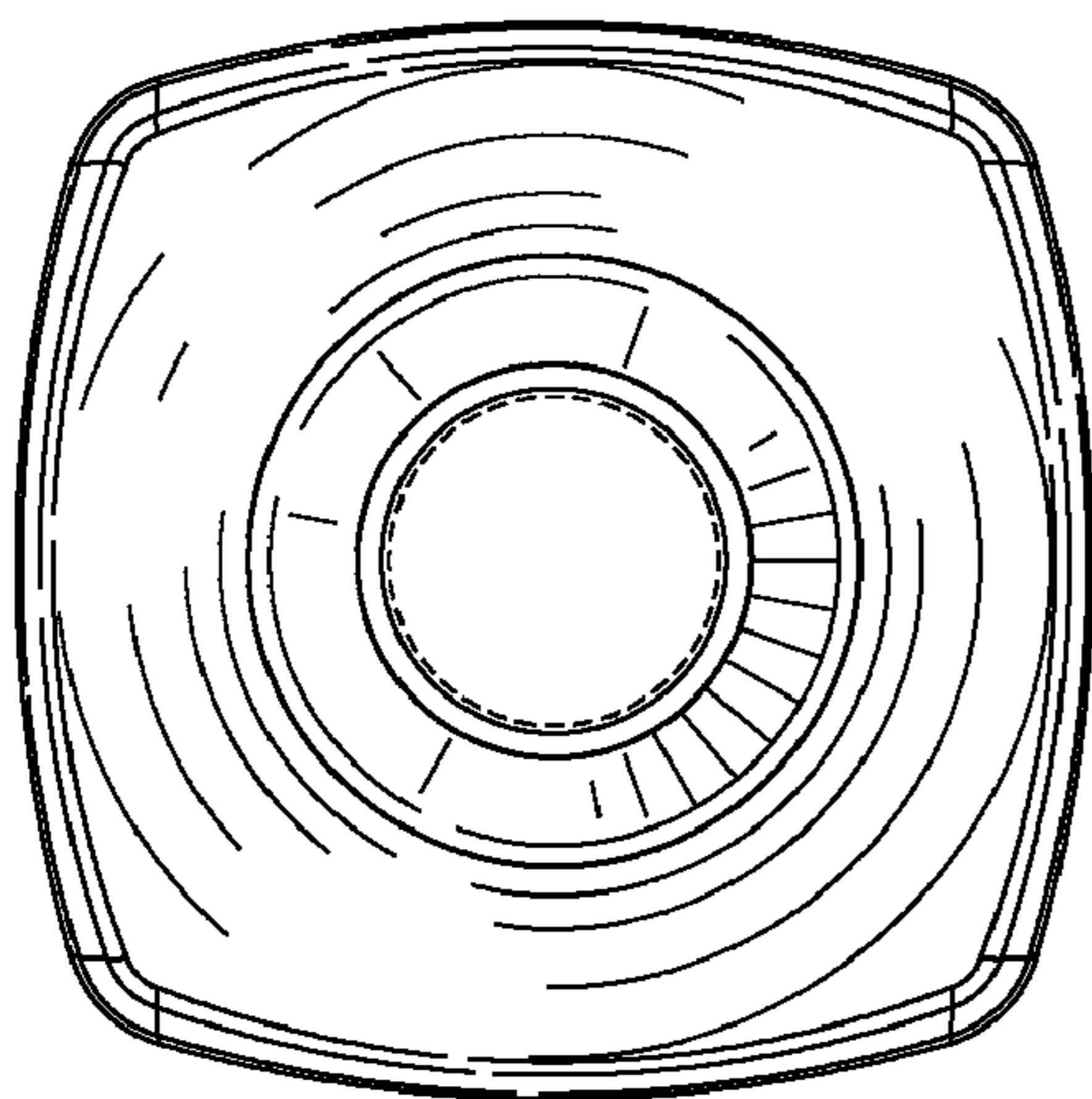
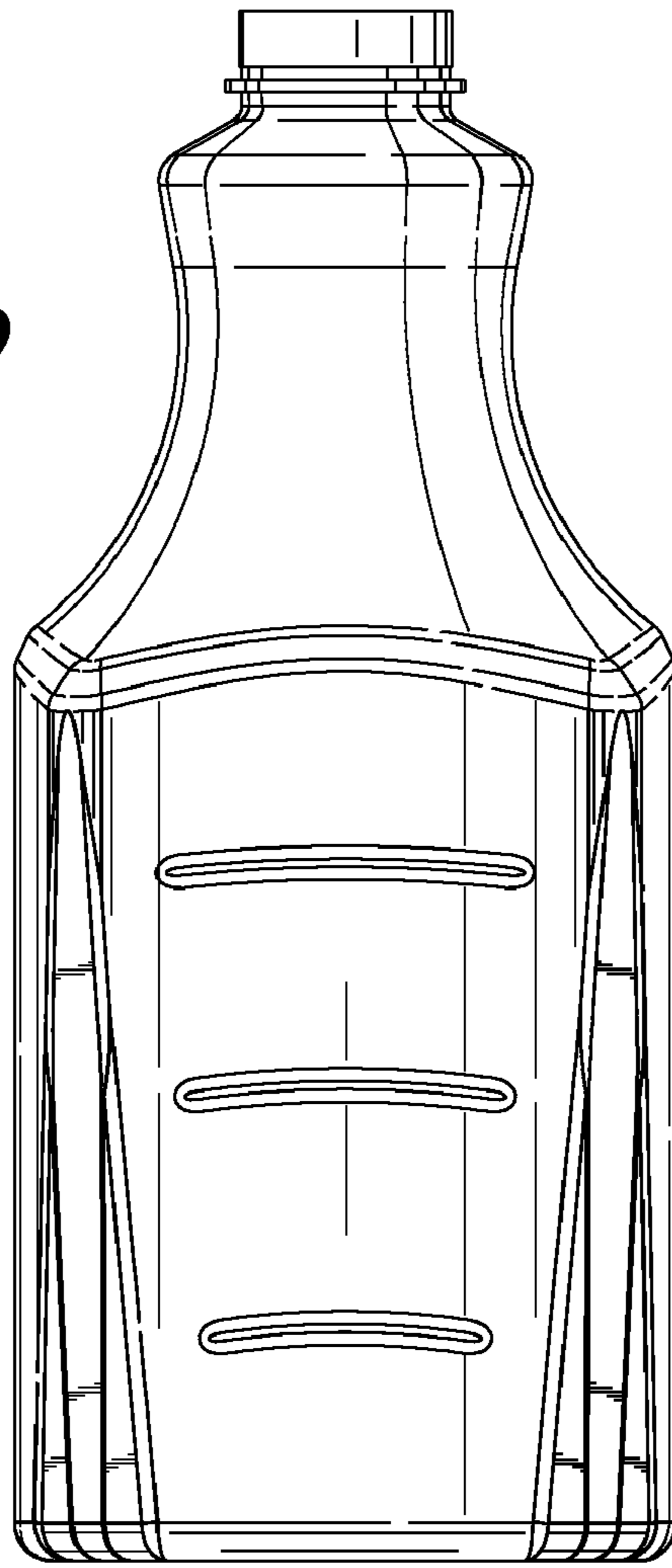

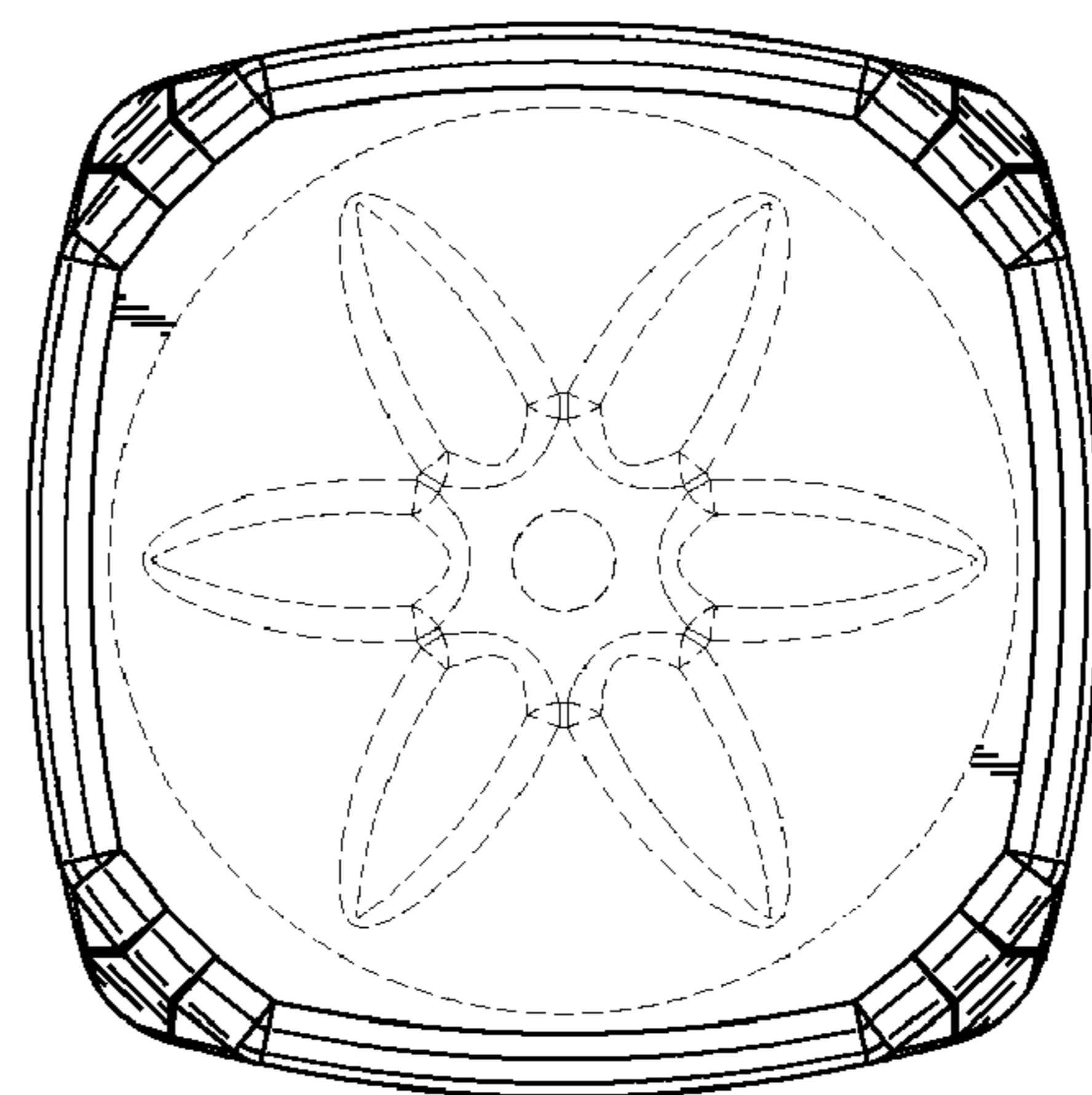

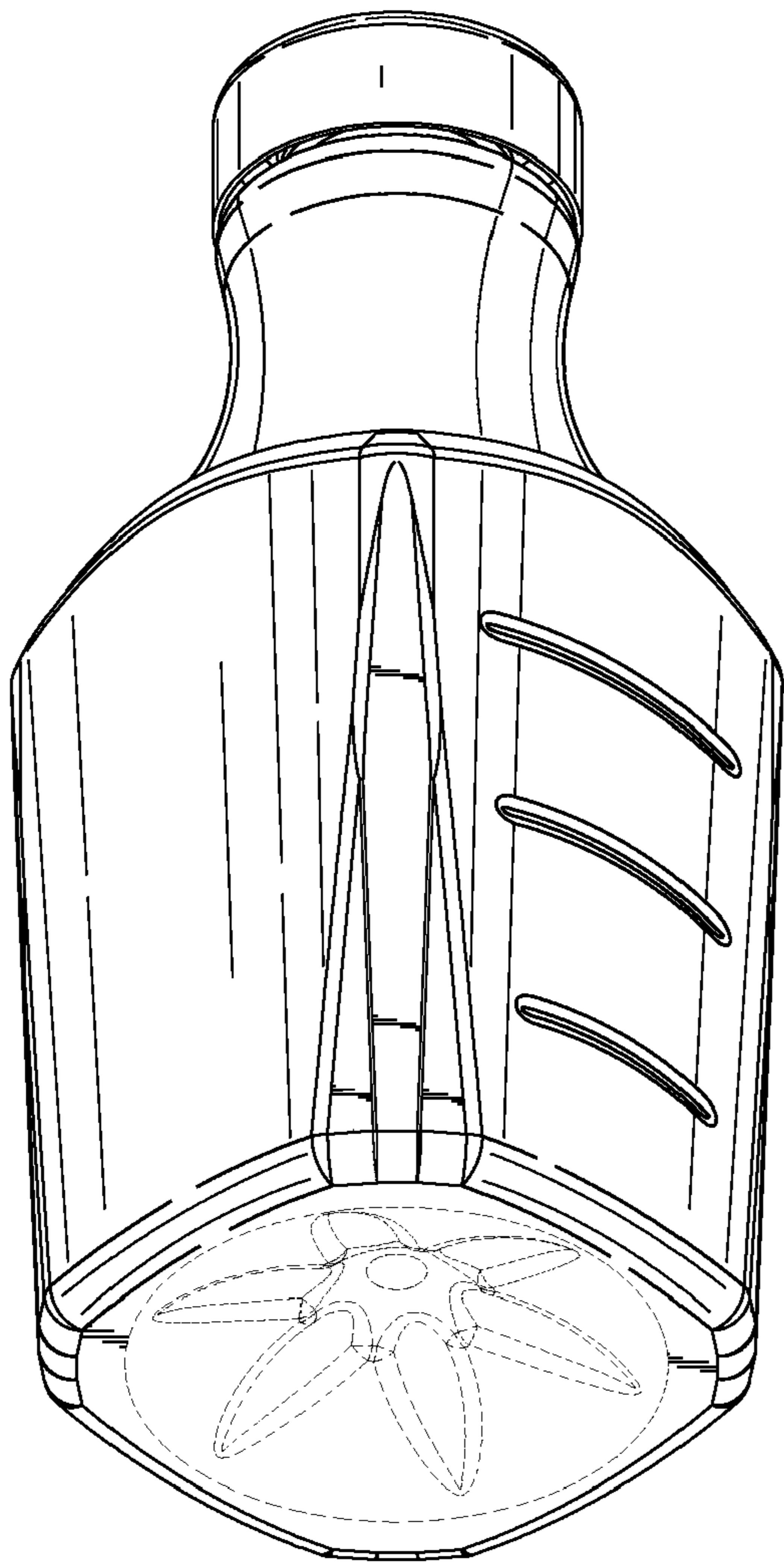

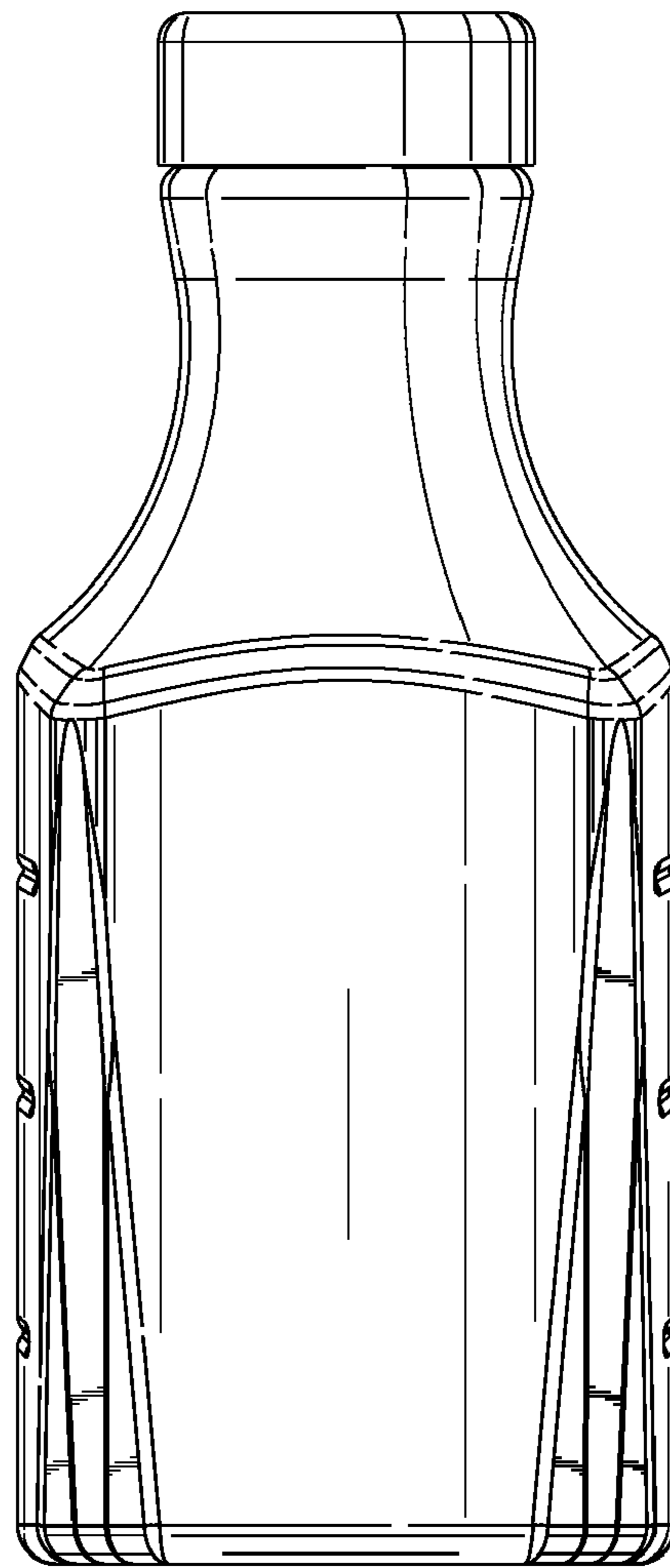

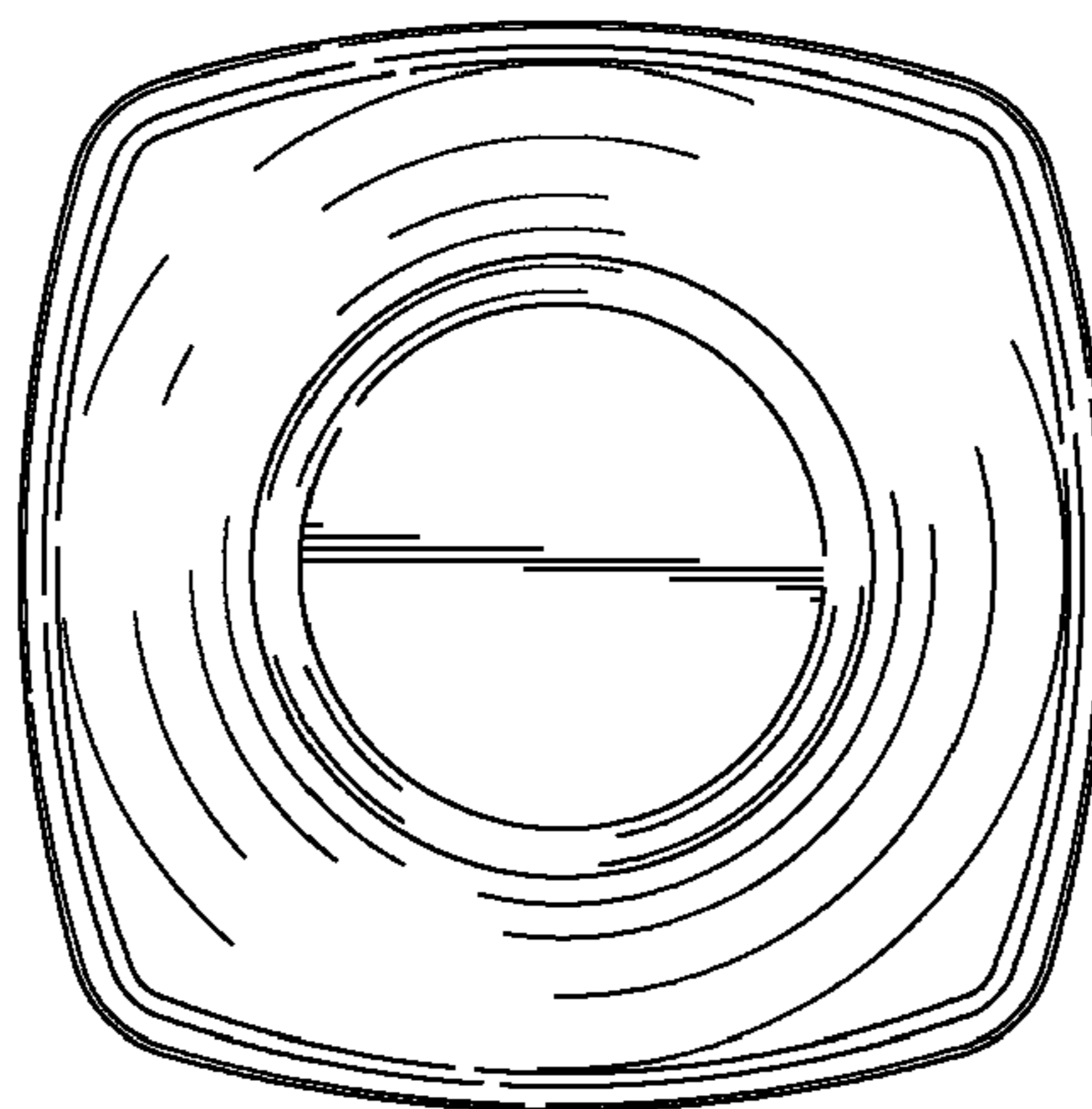
