ing;

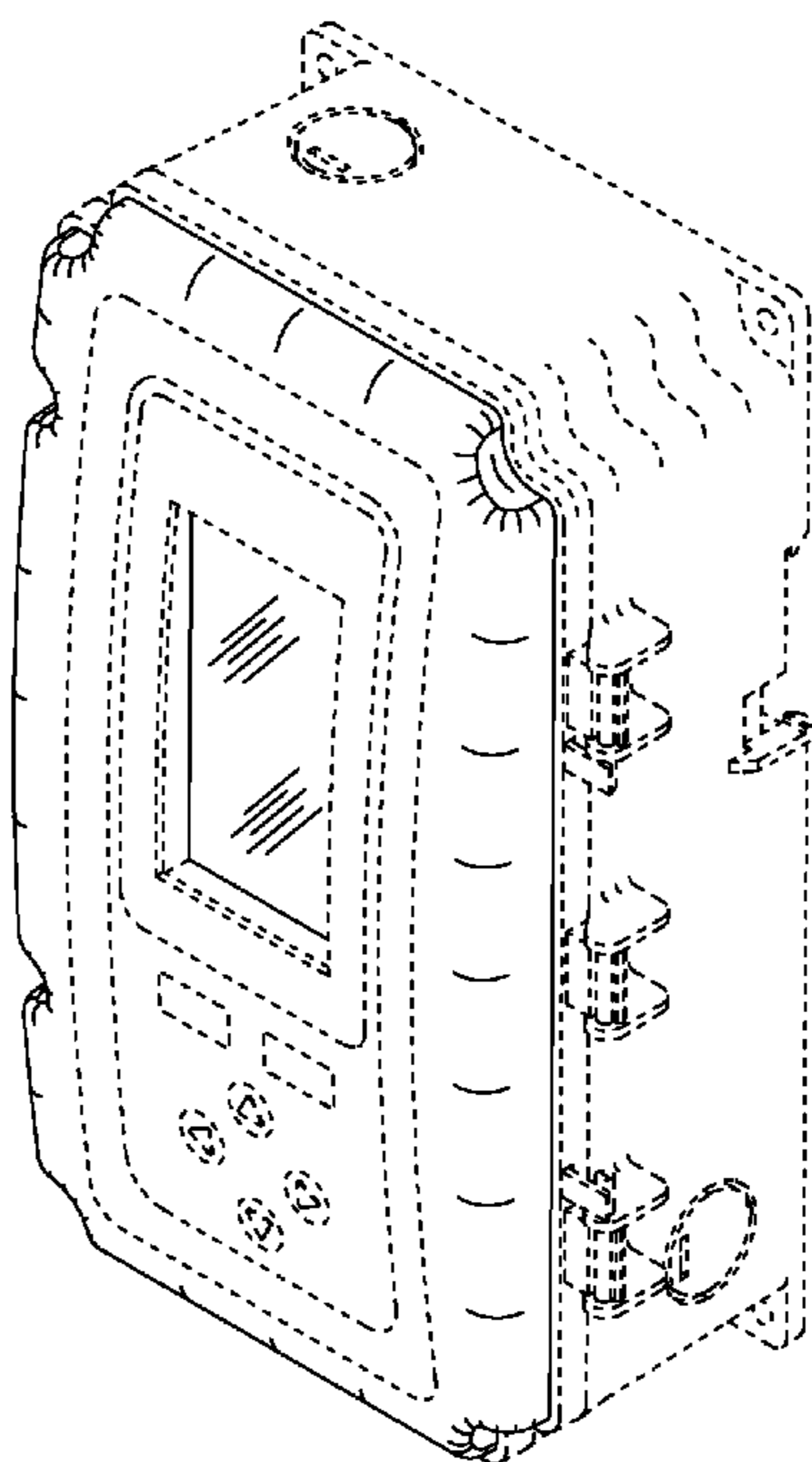
FIG. 2 is front view of the temperature controller housing of

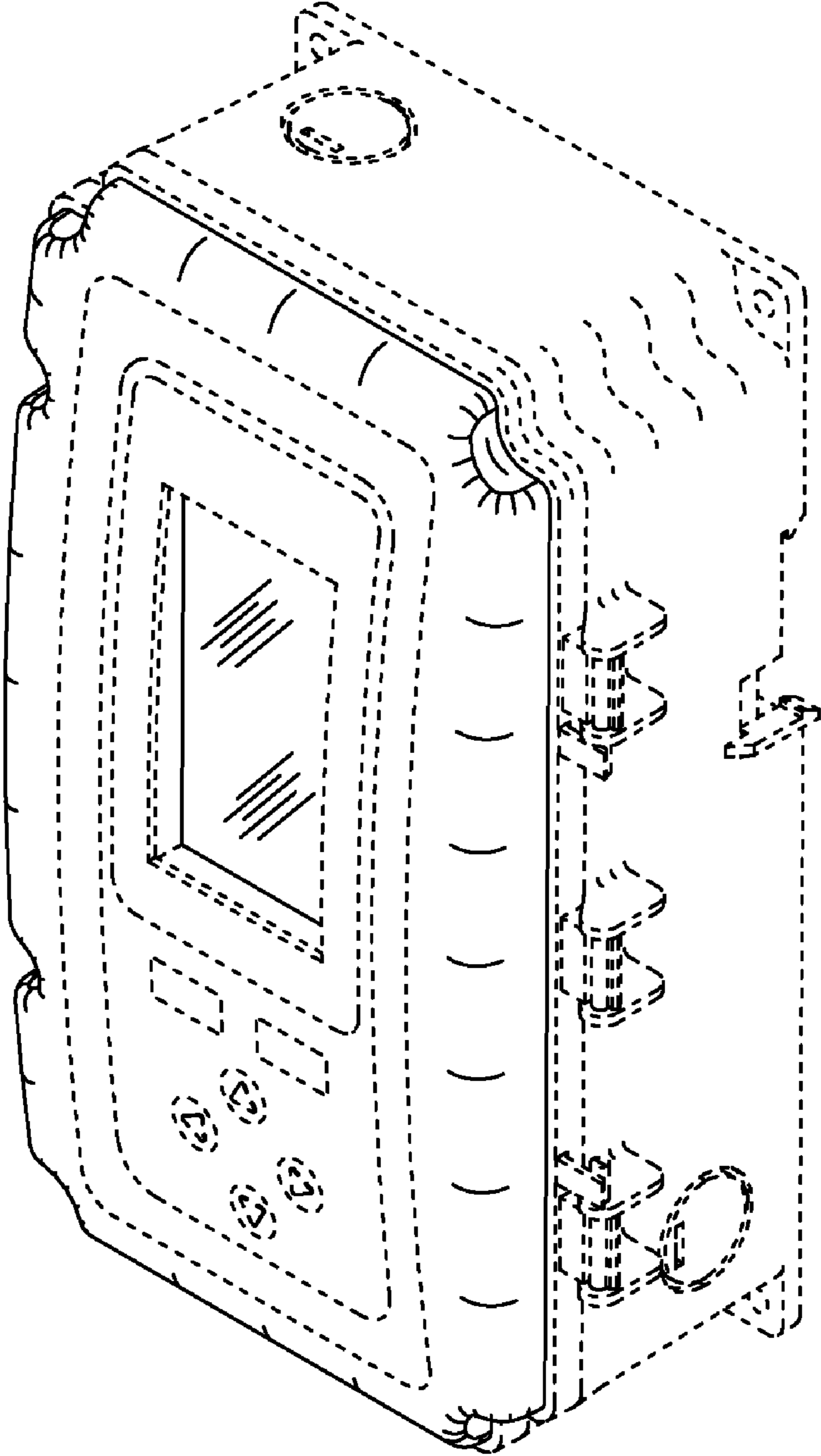

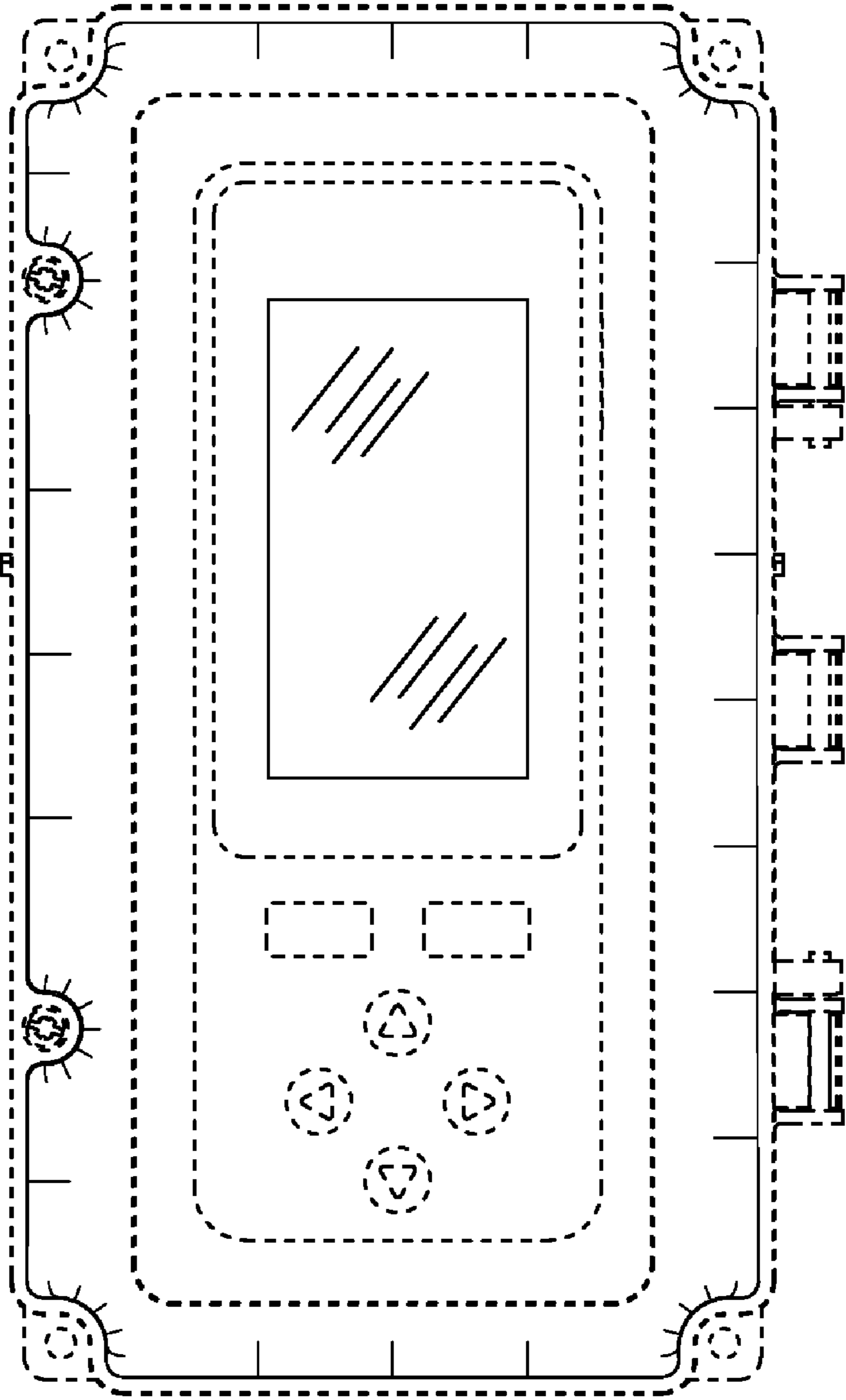

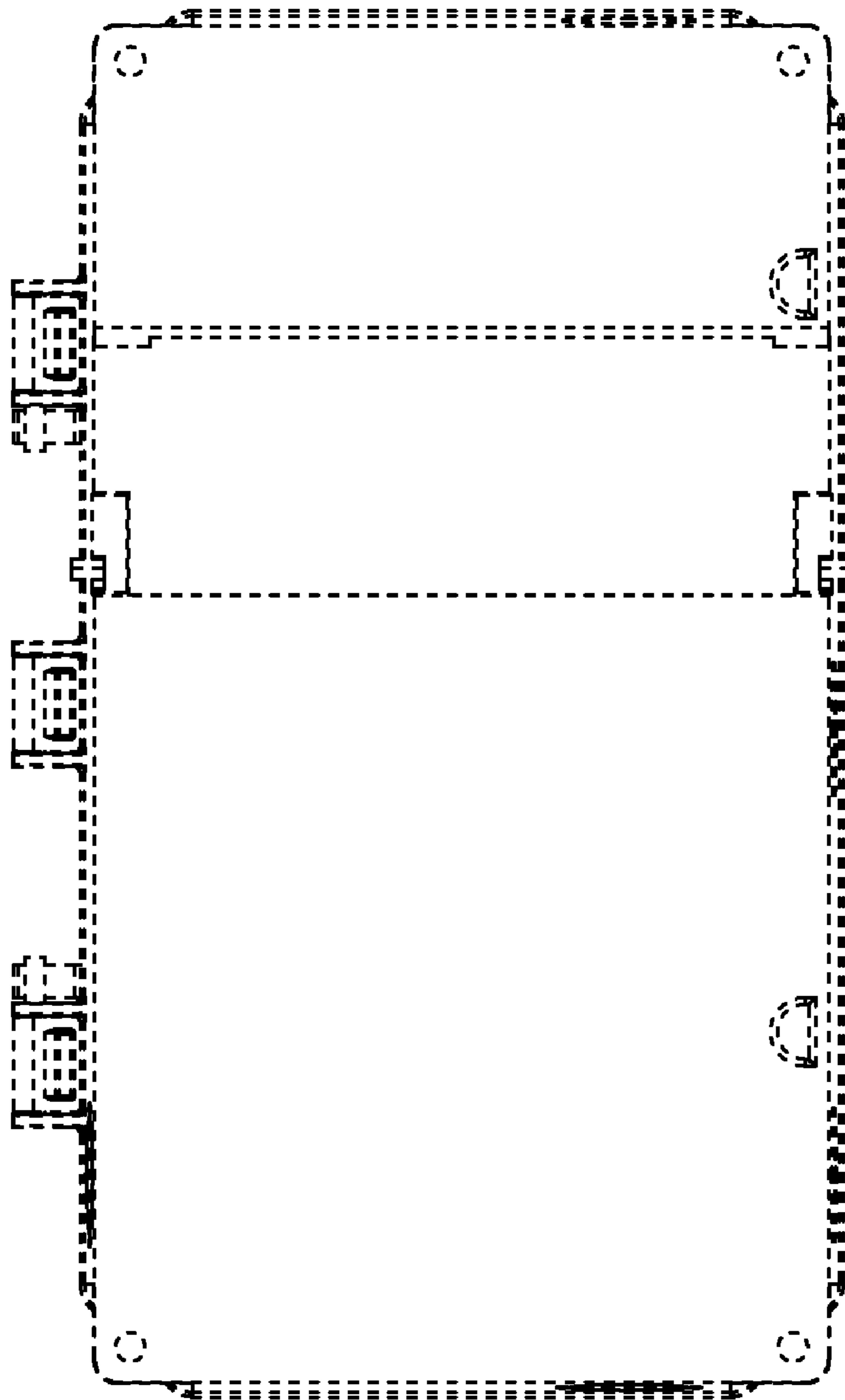

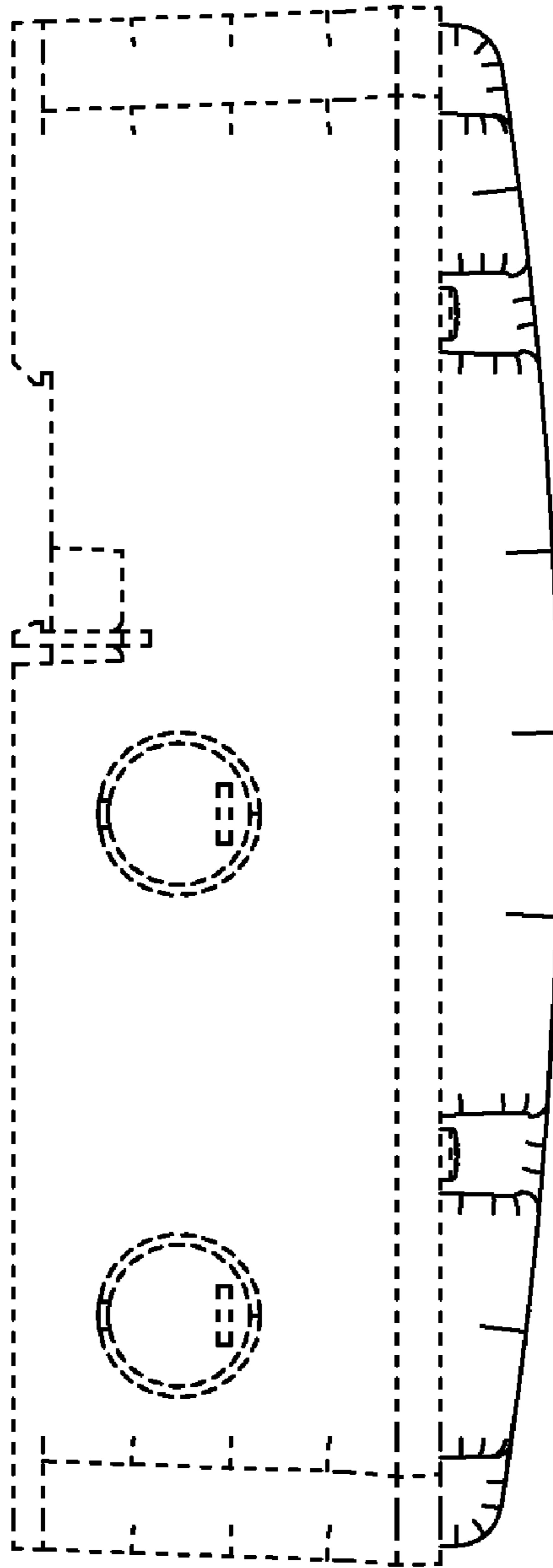

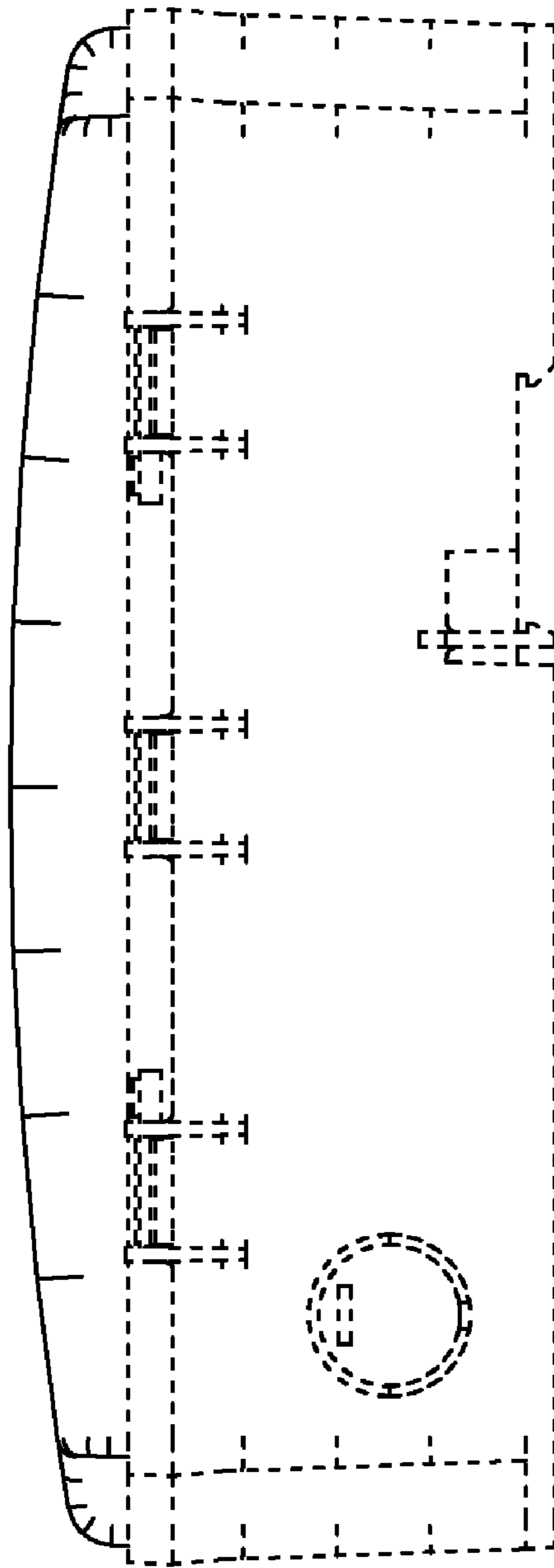

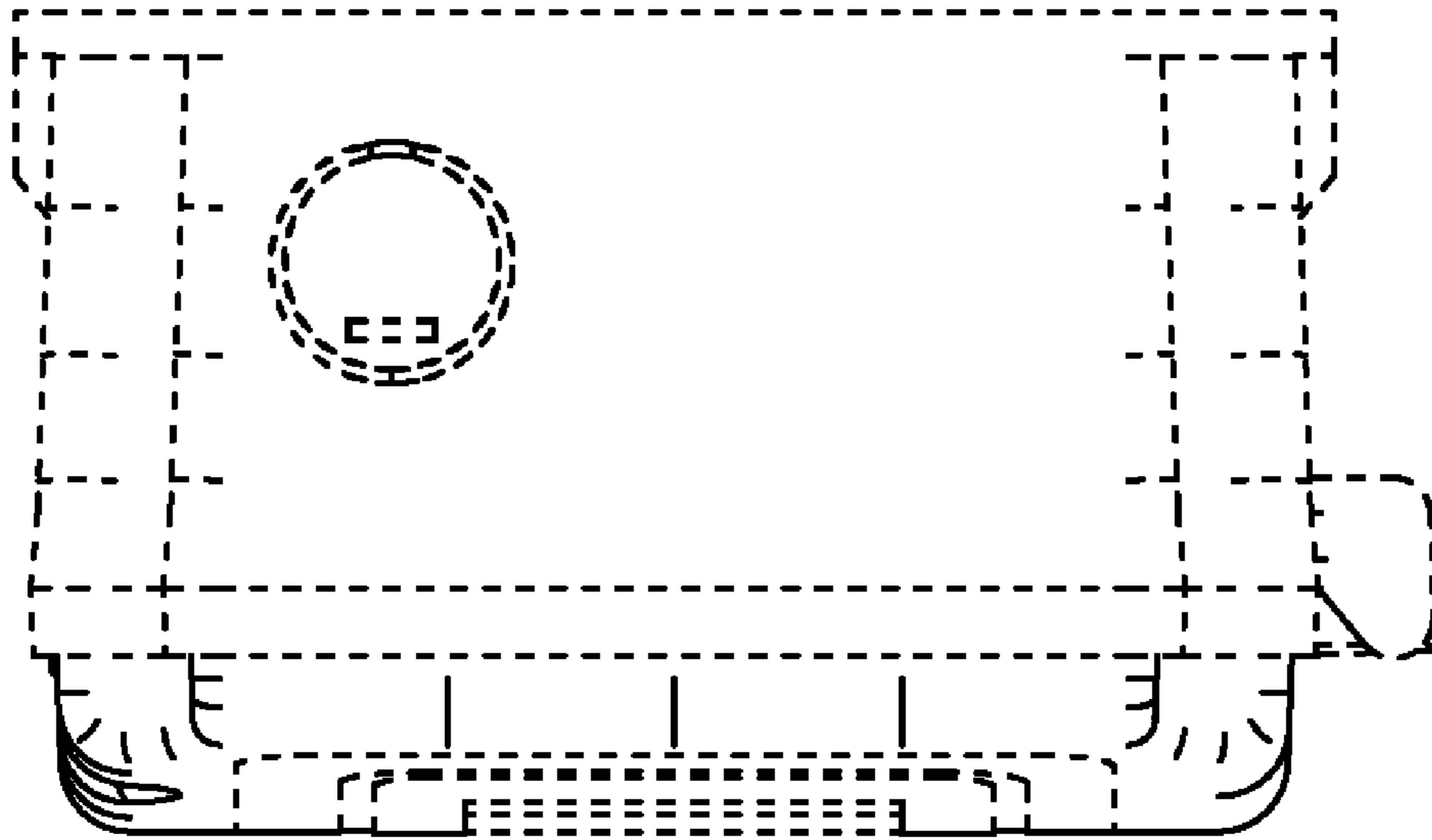

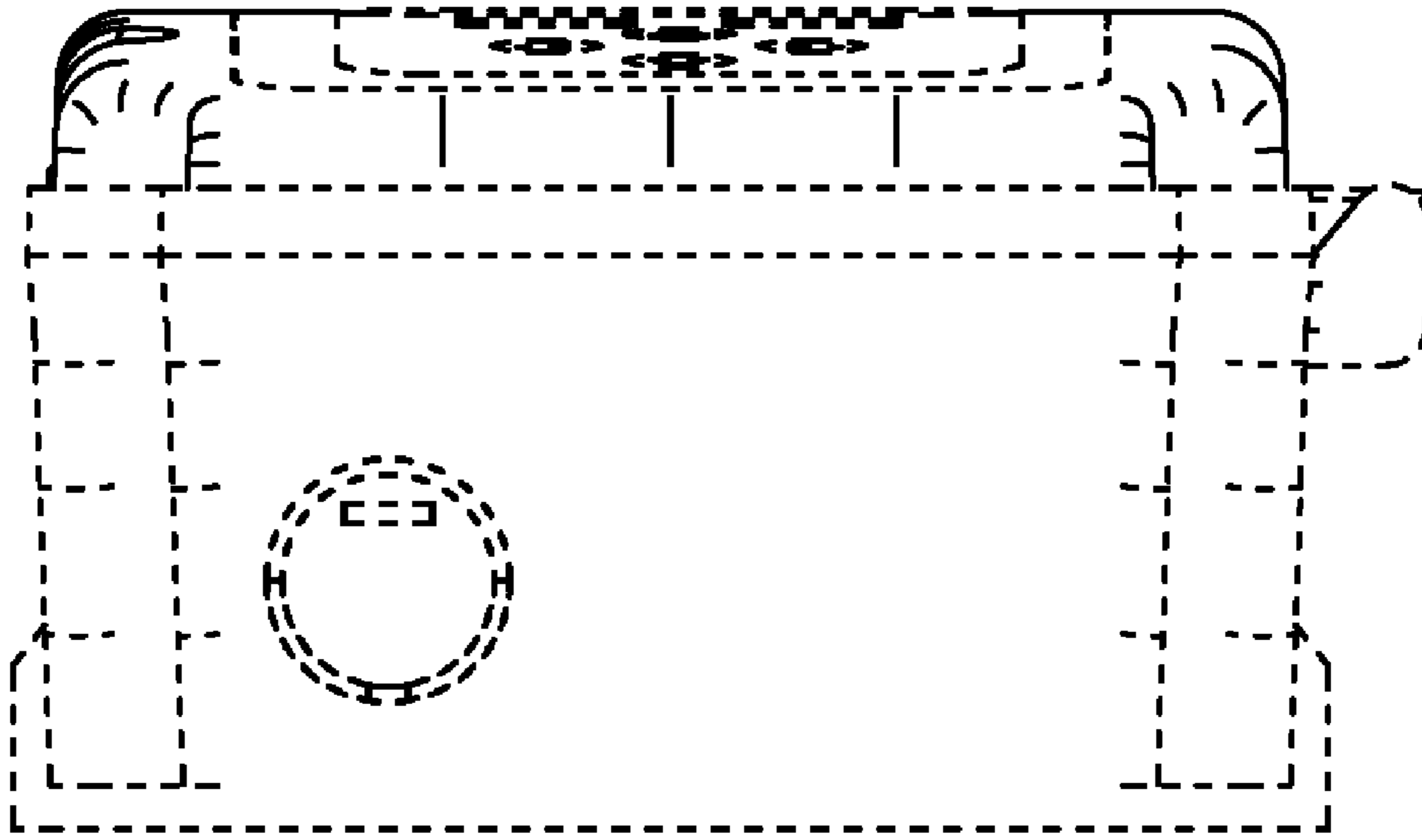
