(57) **CLAIM**

The ornamental design for a header for solar collector, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a header for solar collector, showing my new design;

FIG. 2 is a rear elevational view, thereof;

FIG. 3 is a top plan view, thereof;

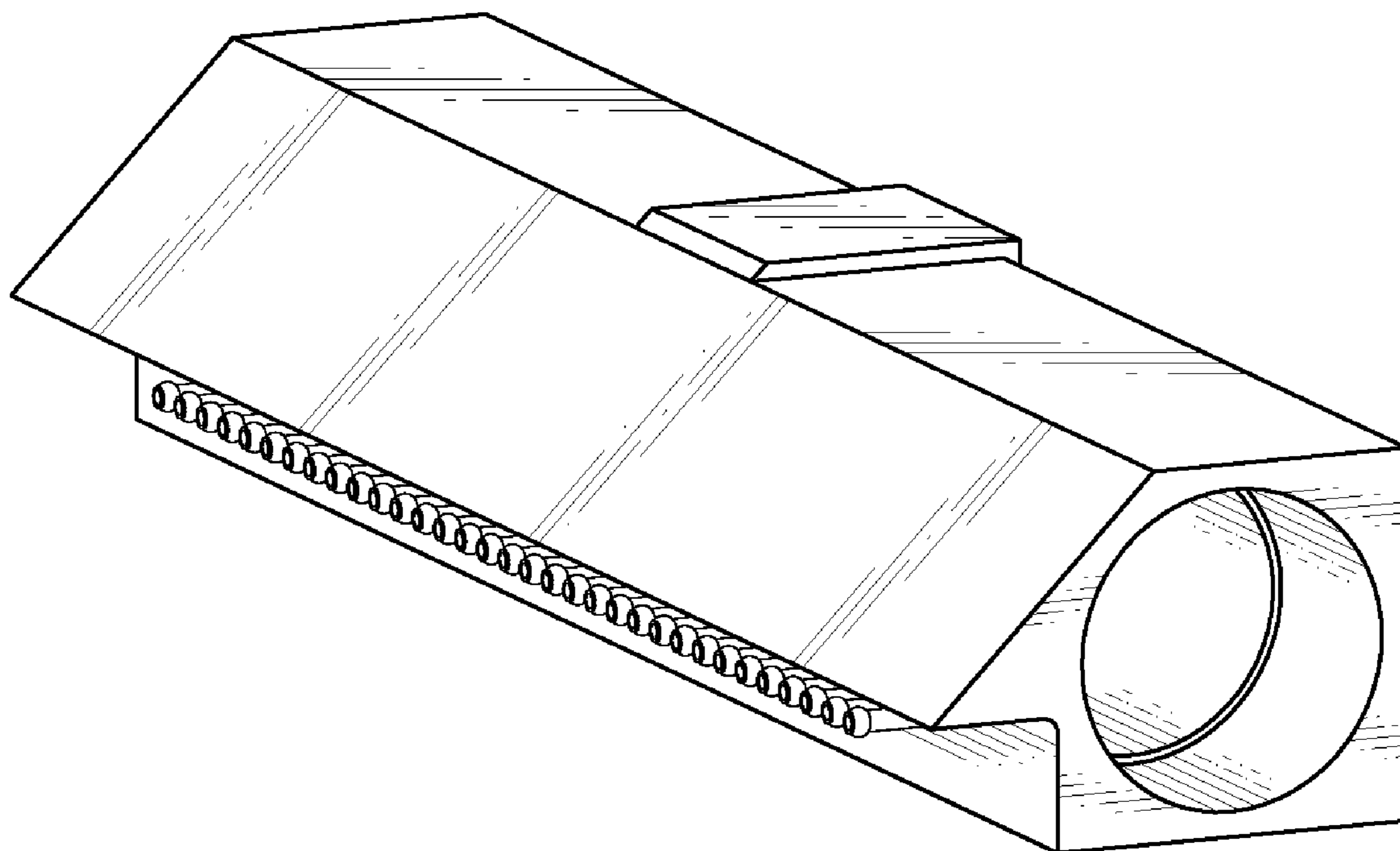
FIG. 4 is an end view thereof;

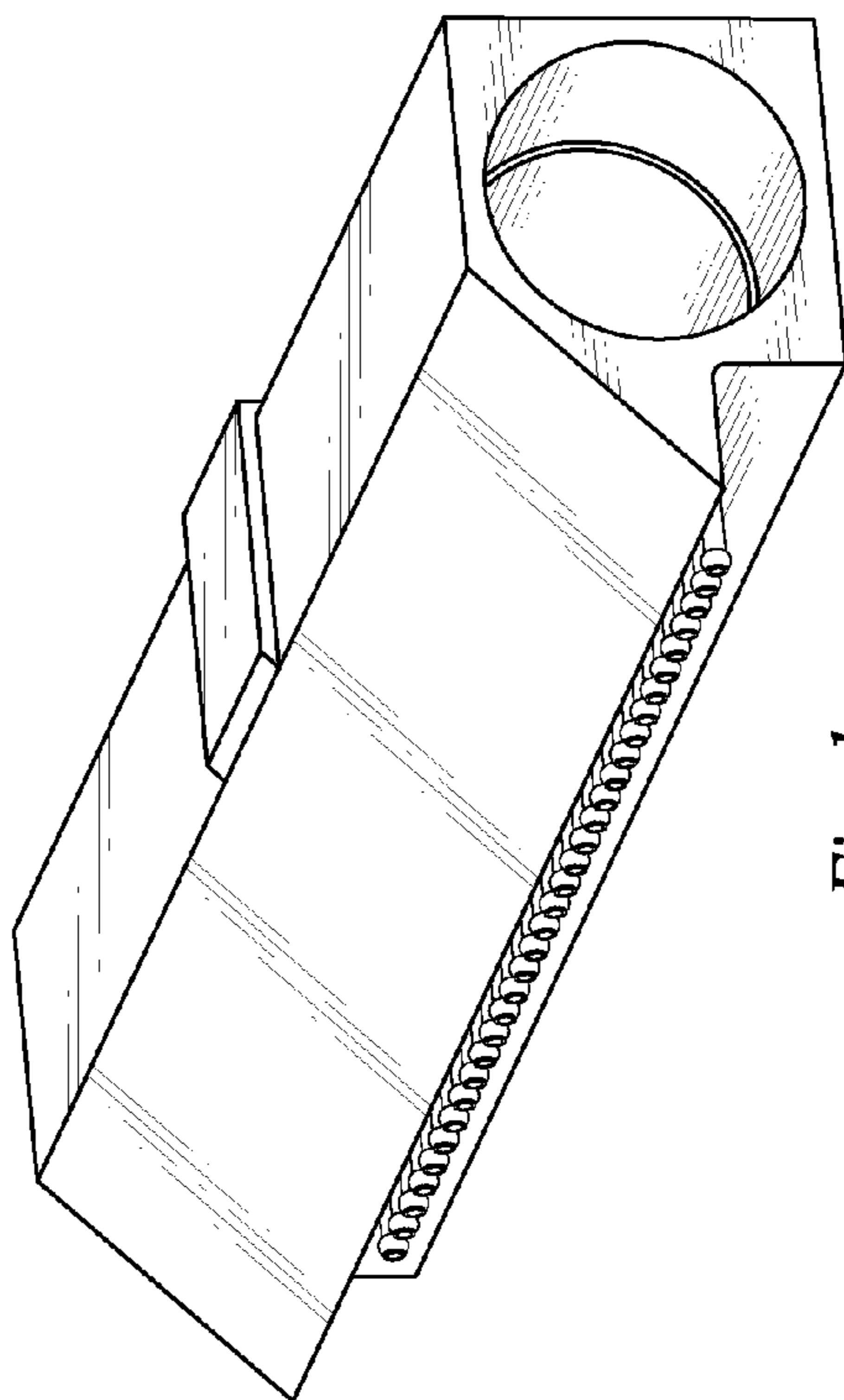

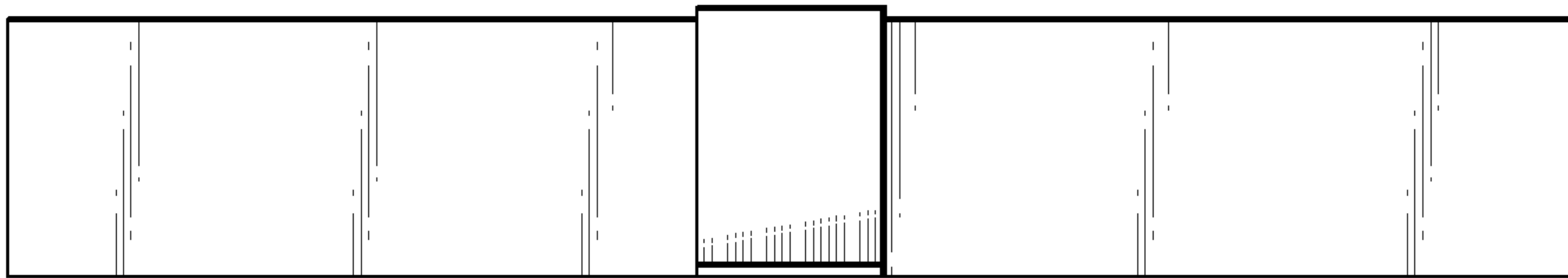

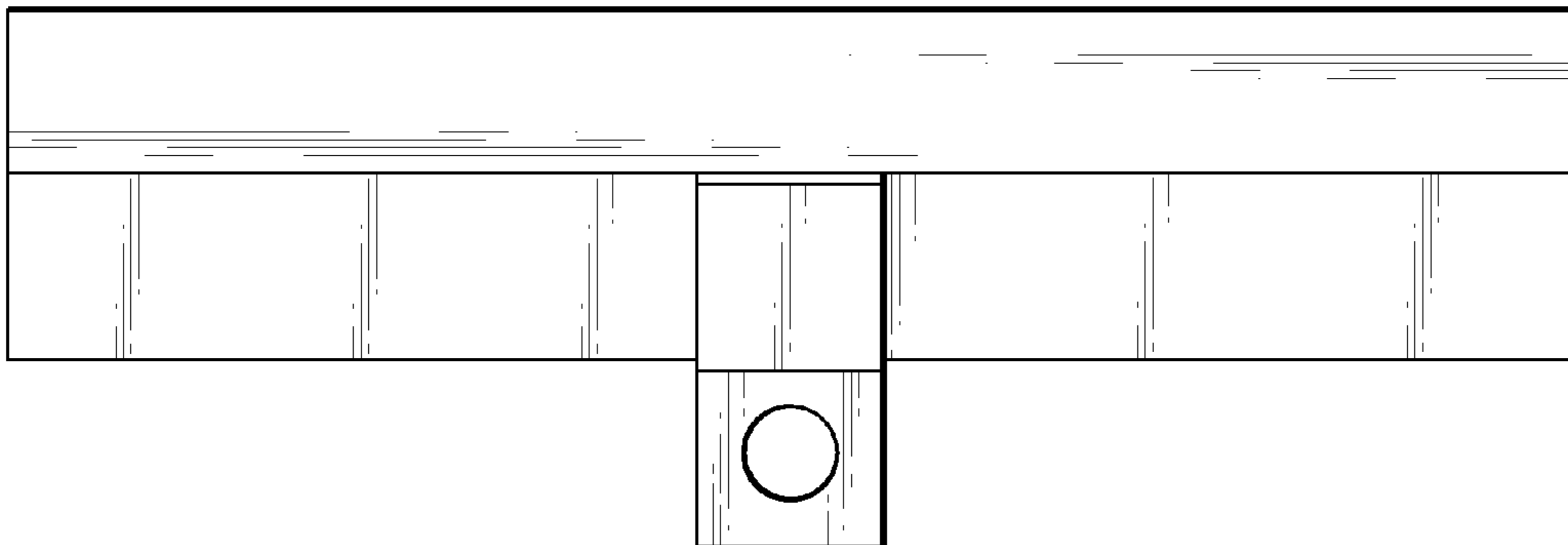

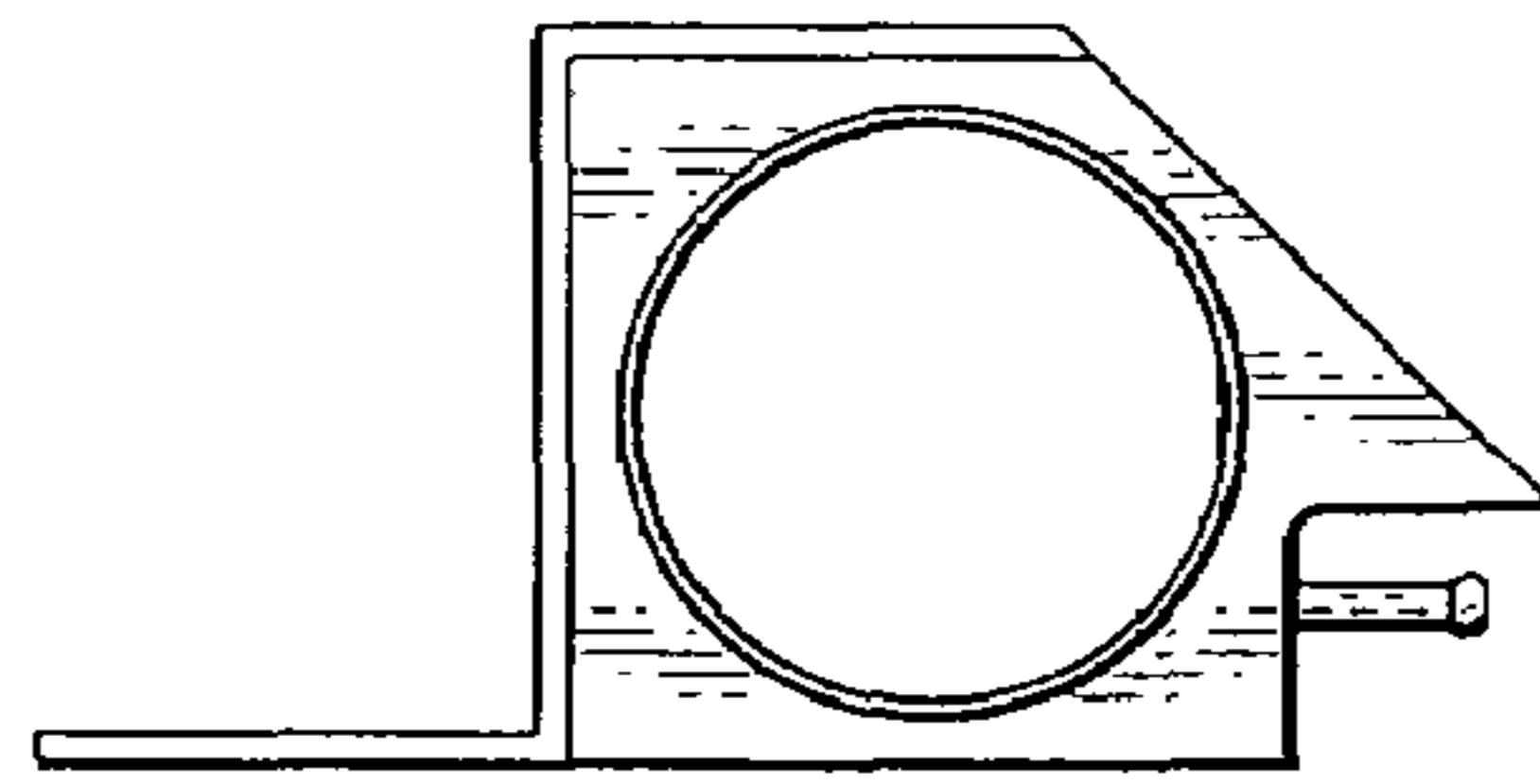

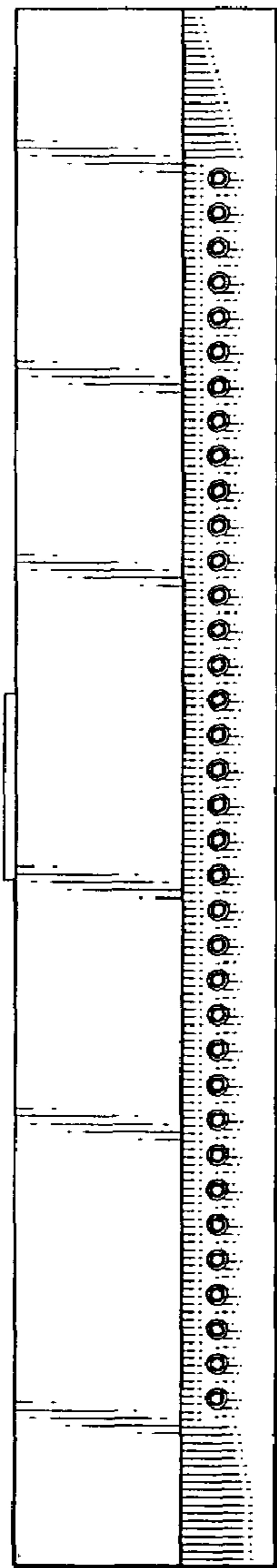

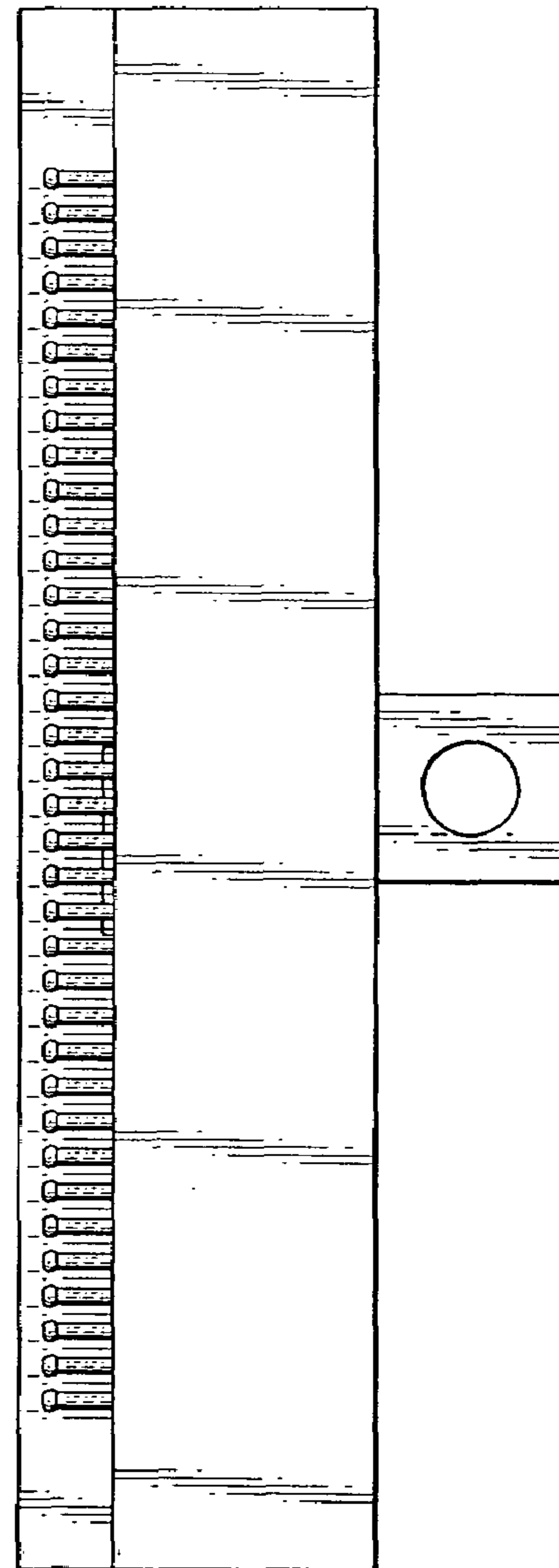

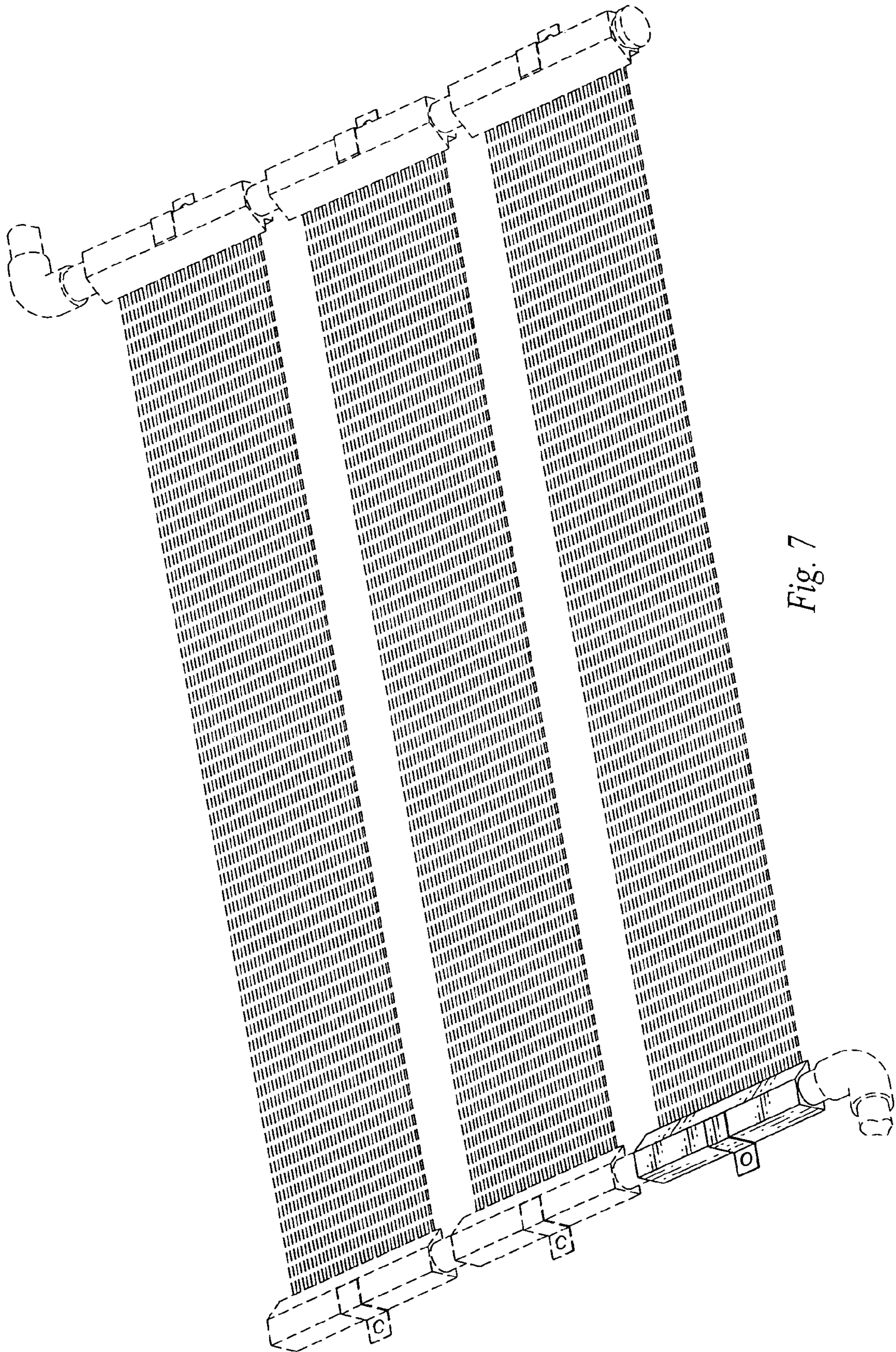
