FIG. 7 is a bottom view of the design according to the invention.

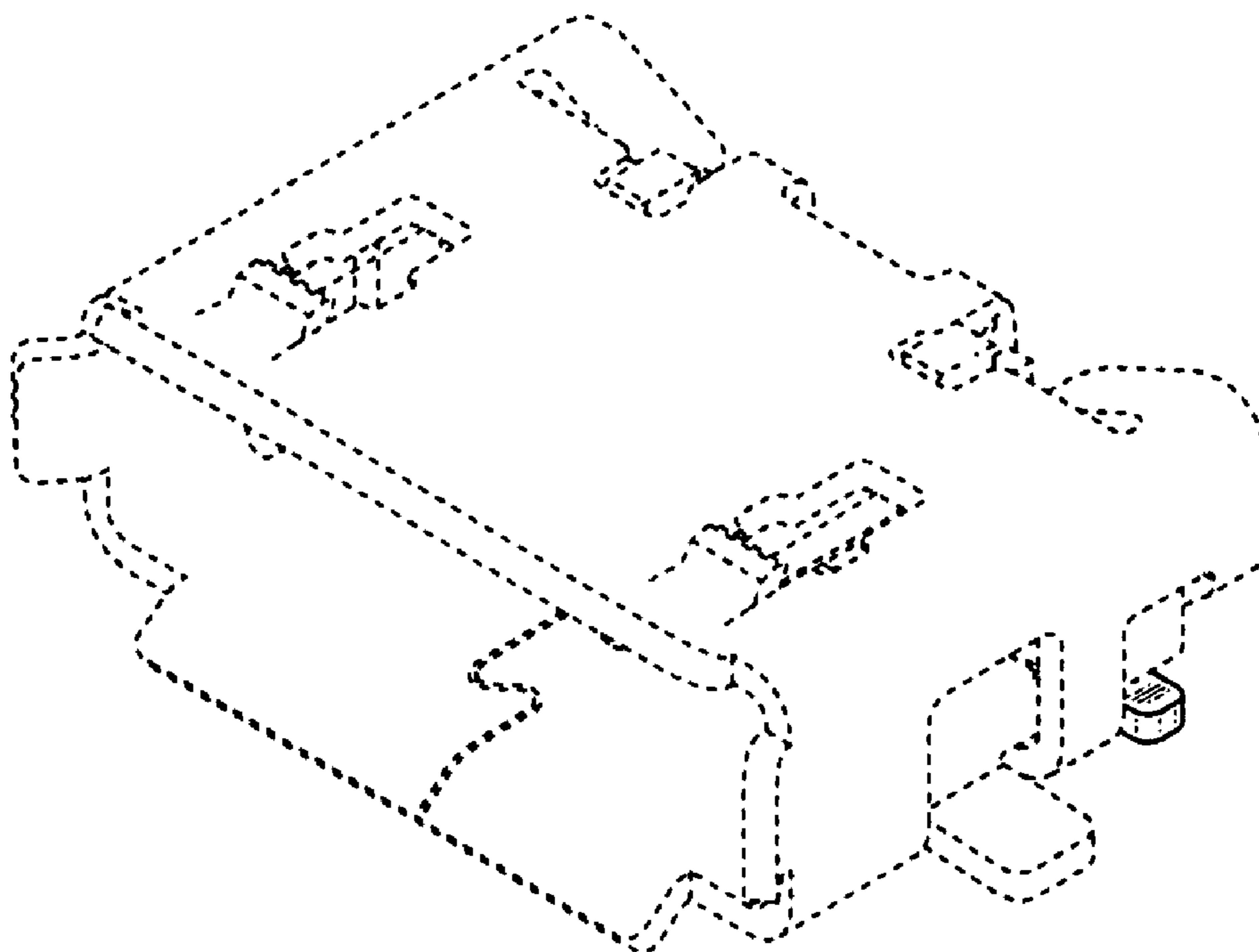
FIG. 8 is a cross-sectional view of the design taken along line A—A as shown in FIG. 2 according to the invention.

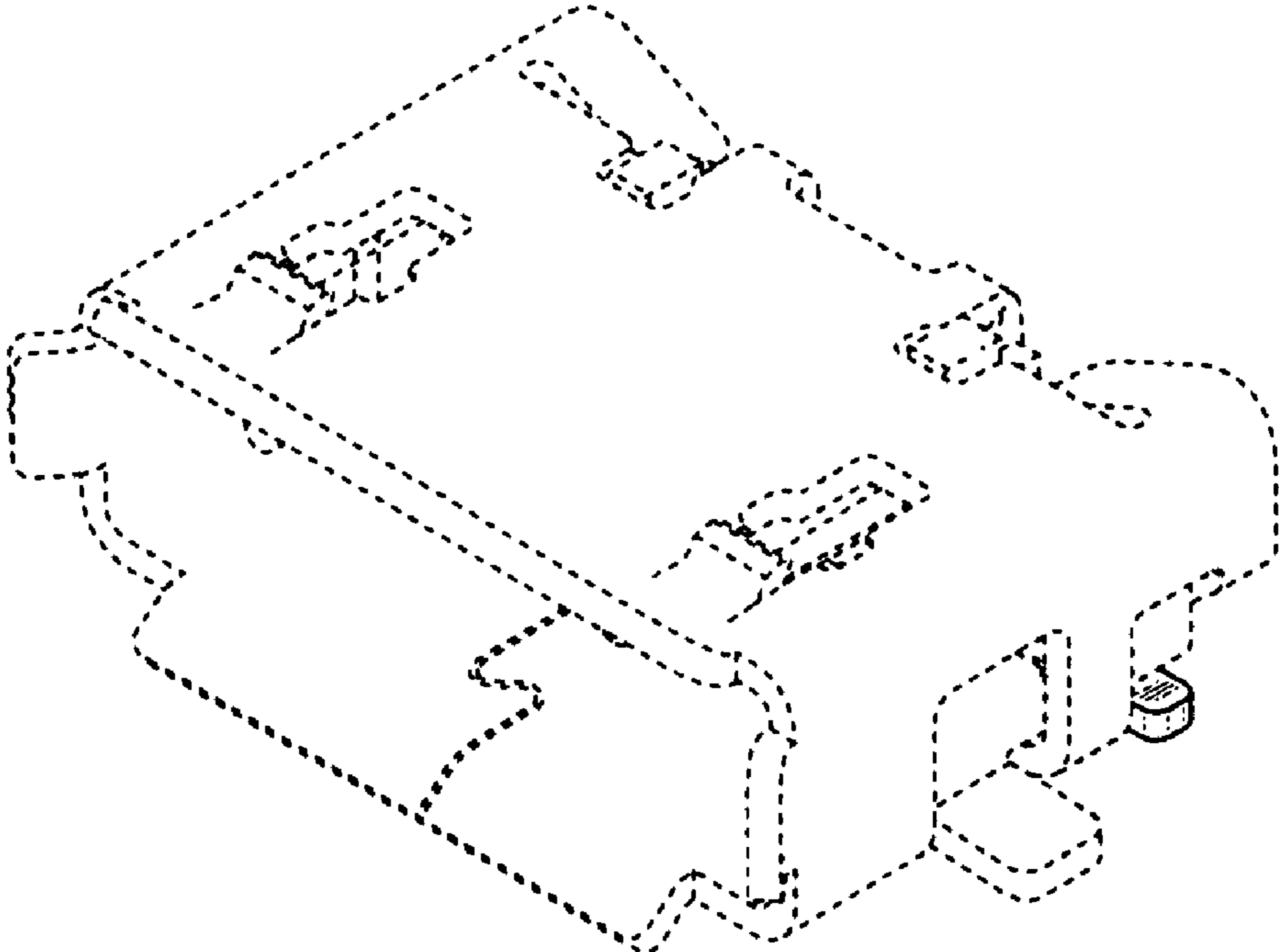

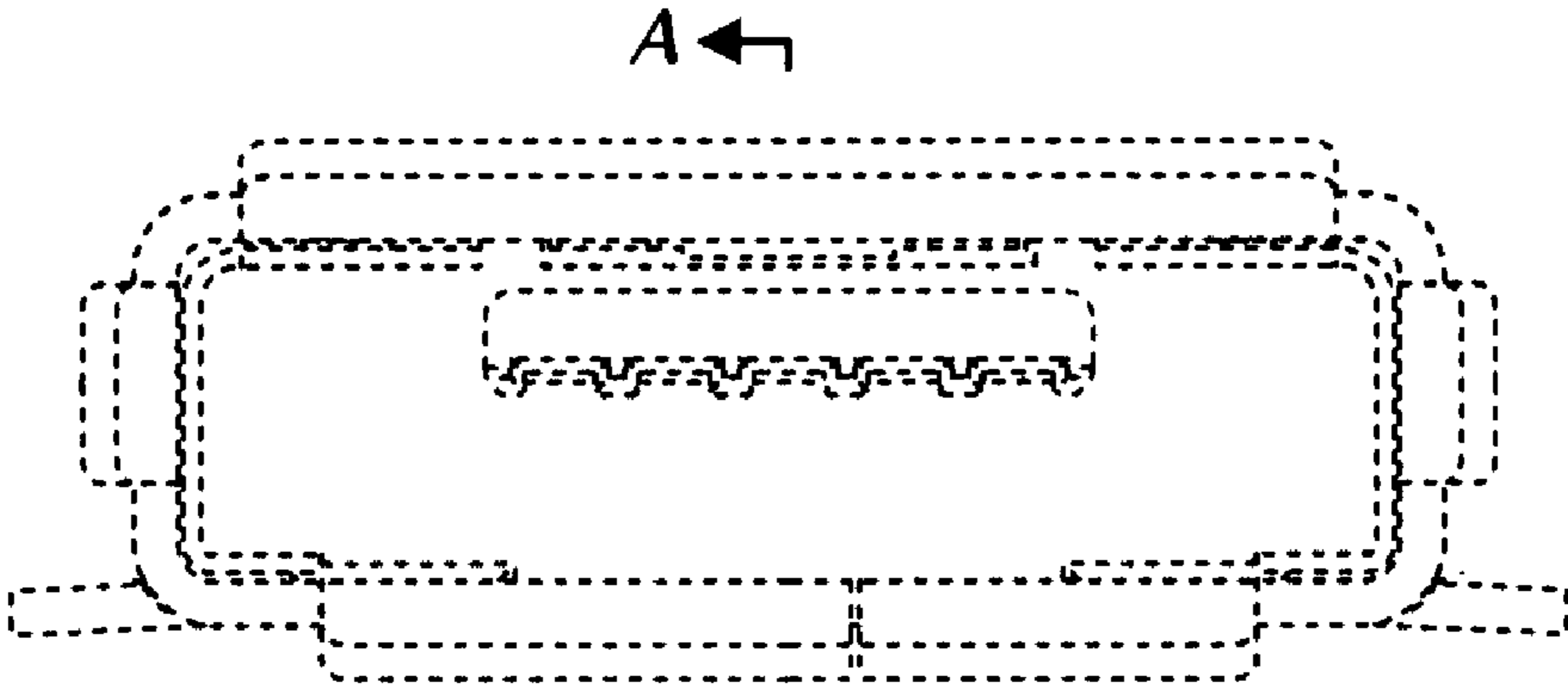

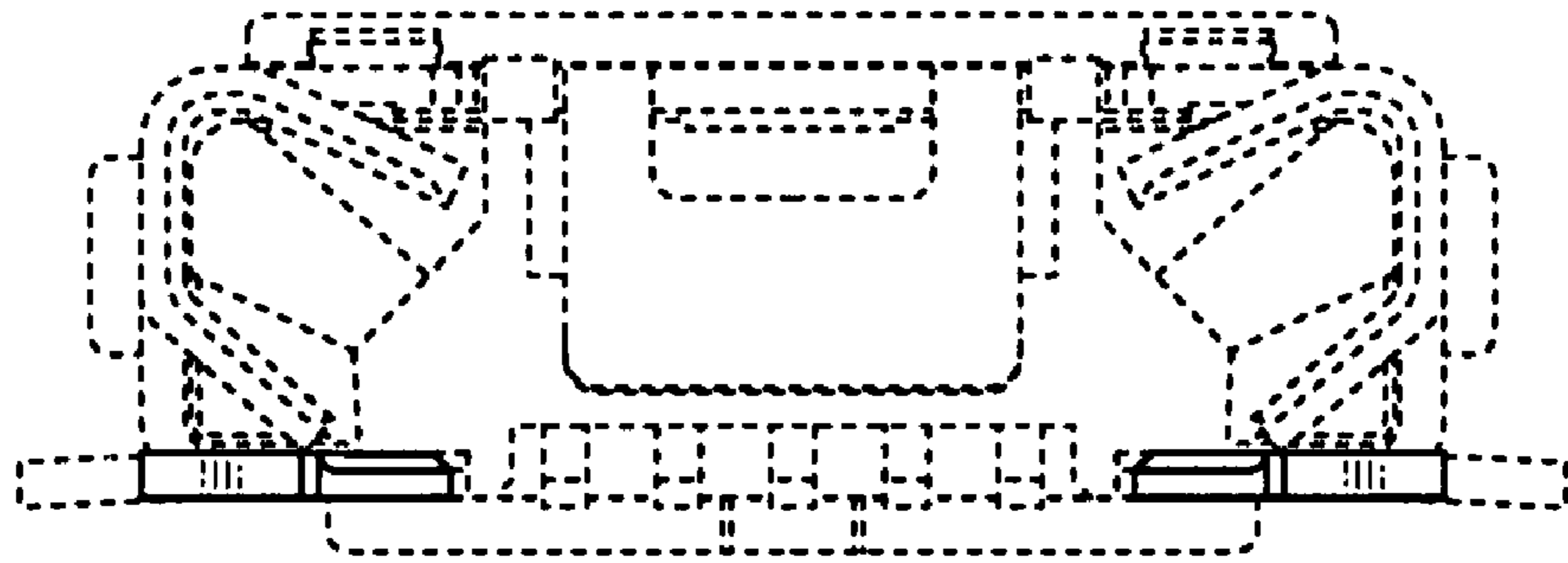

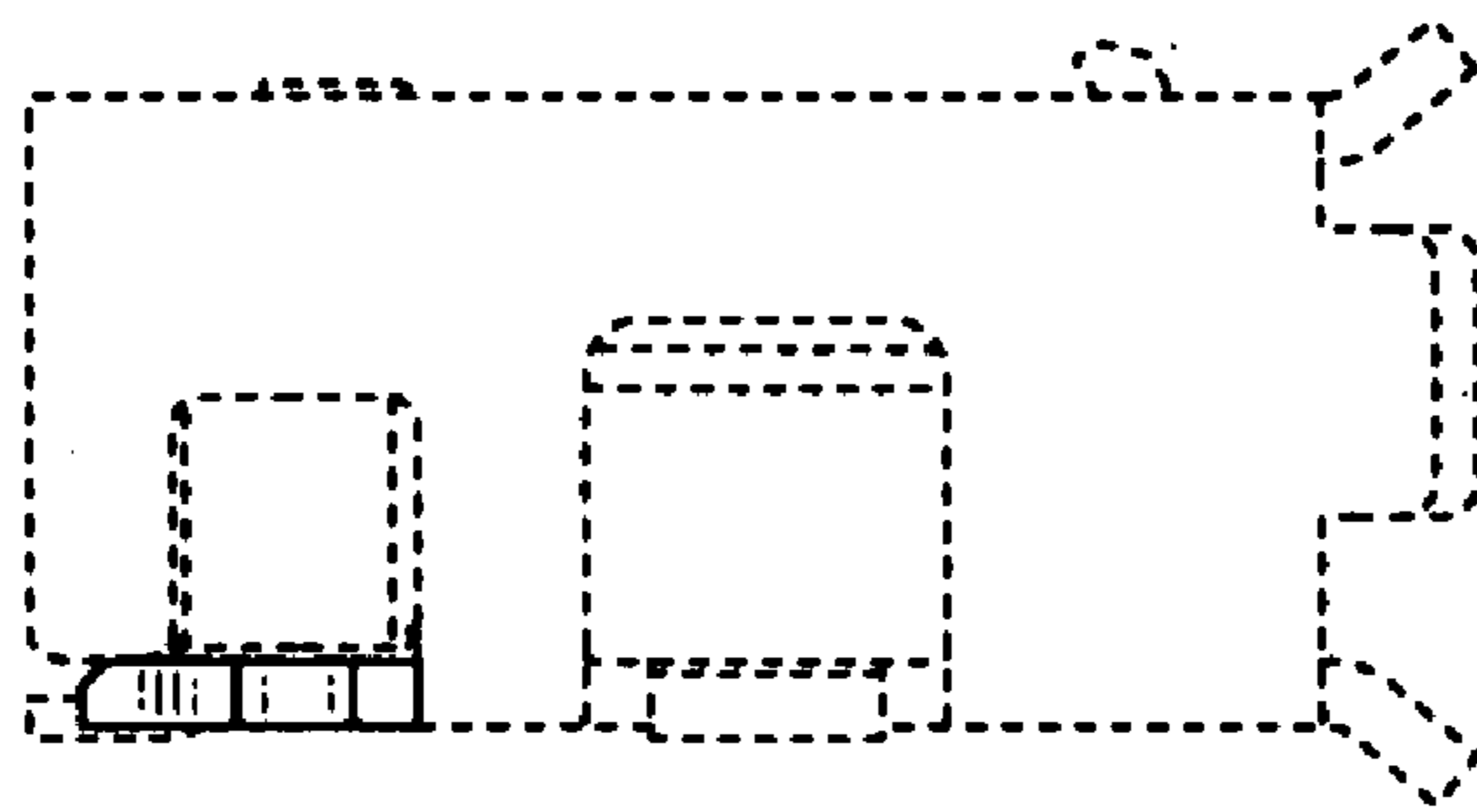

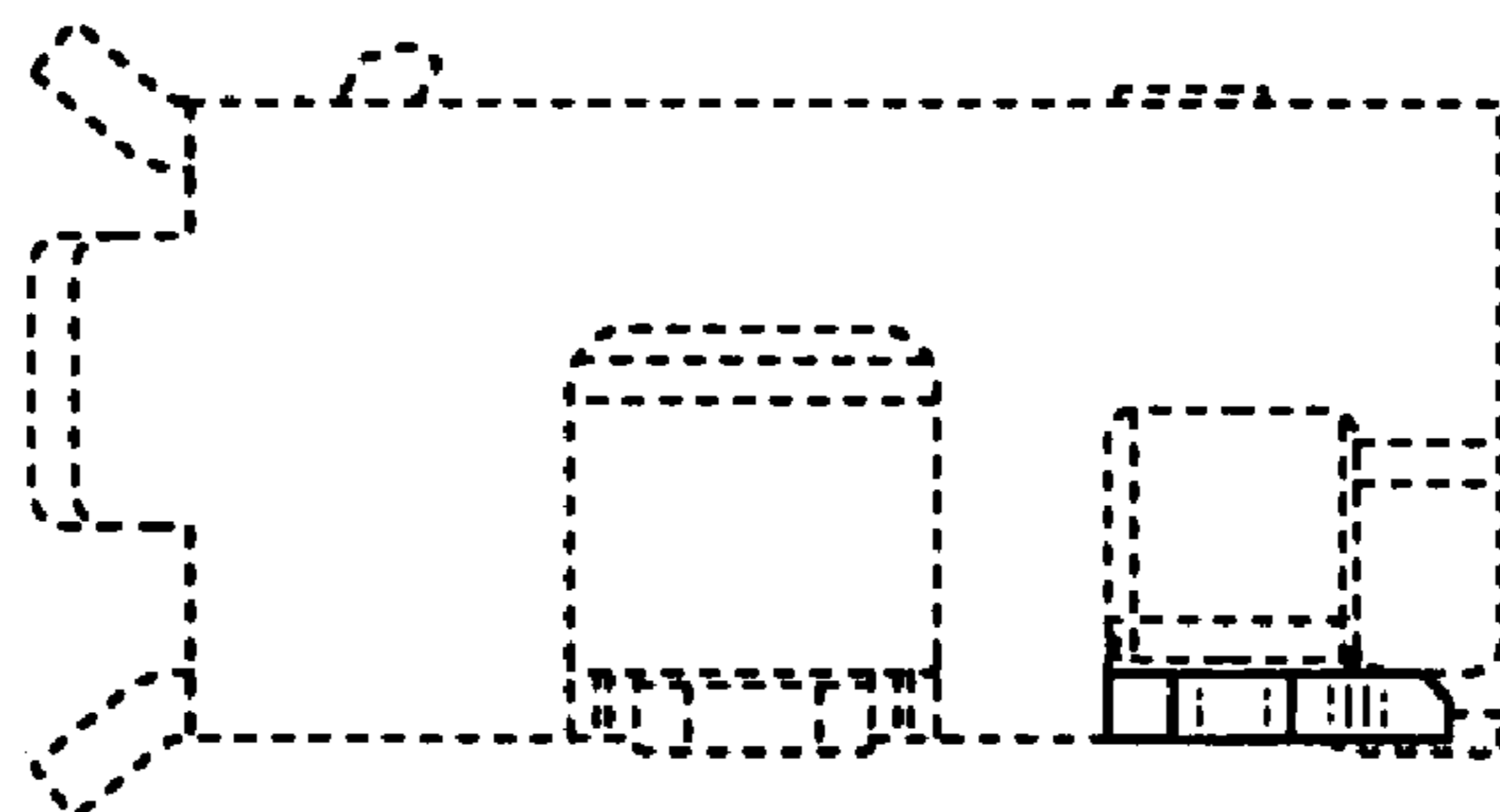

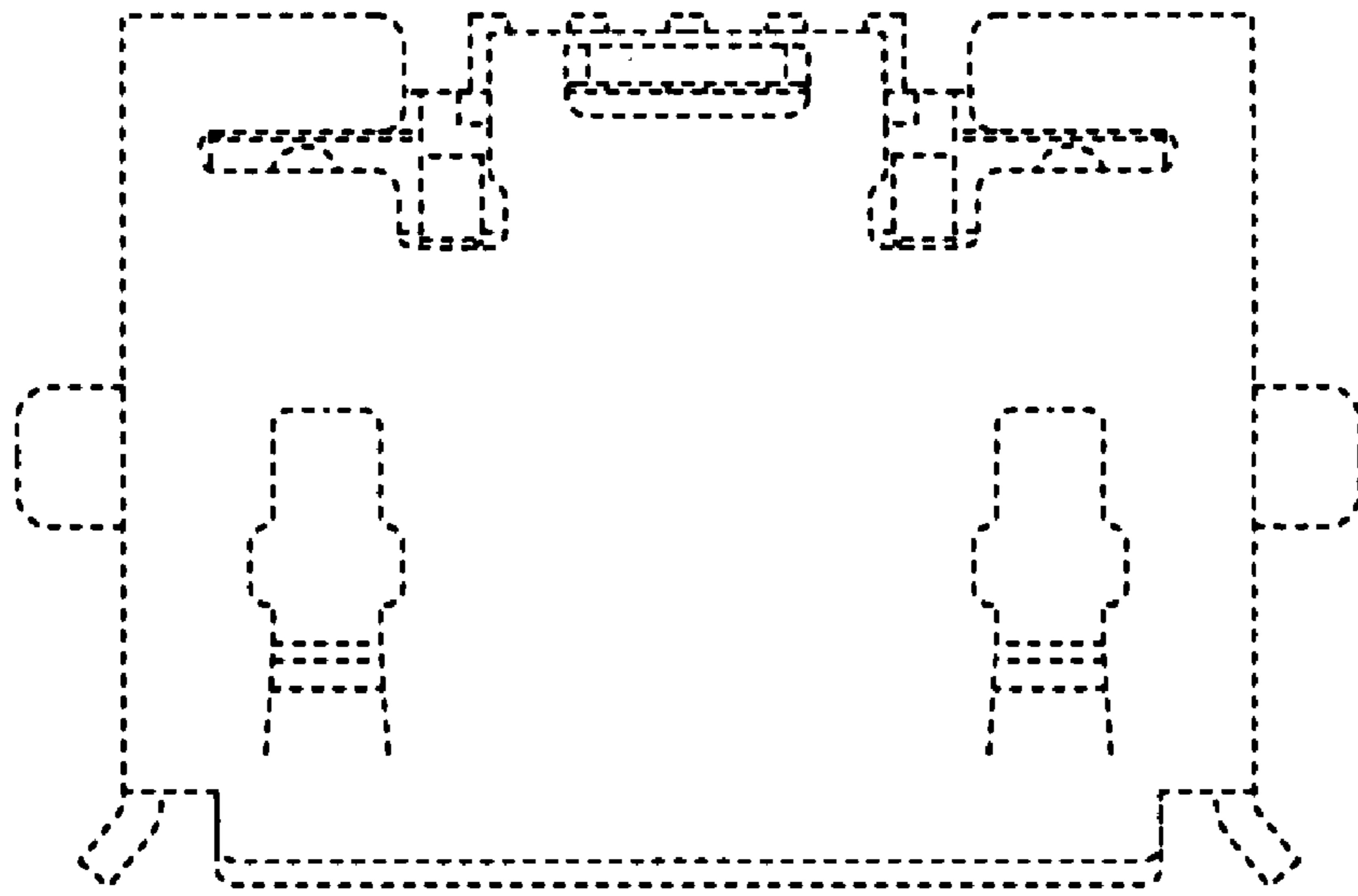

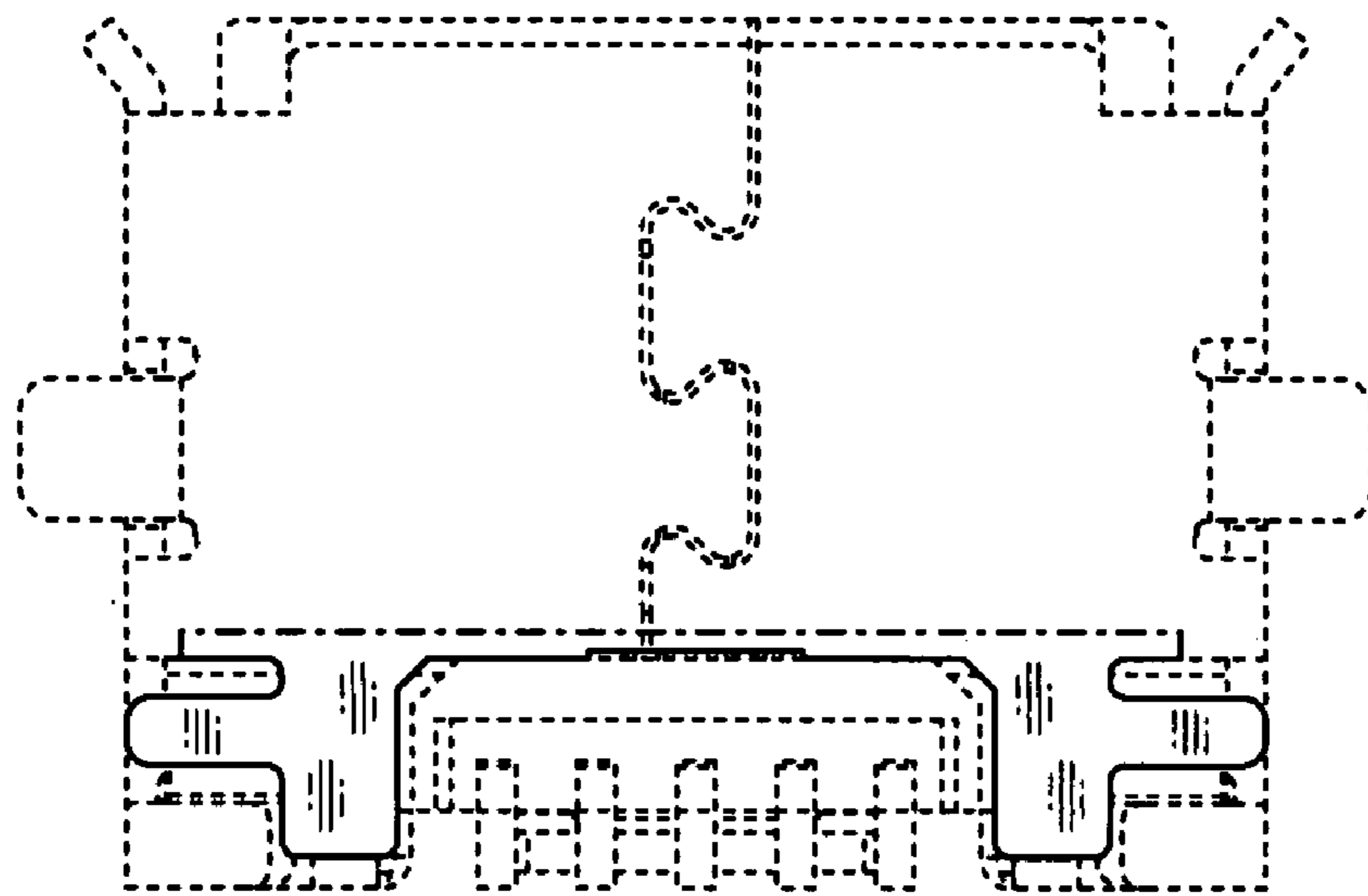

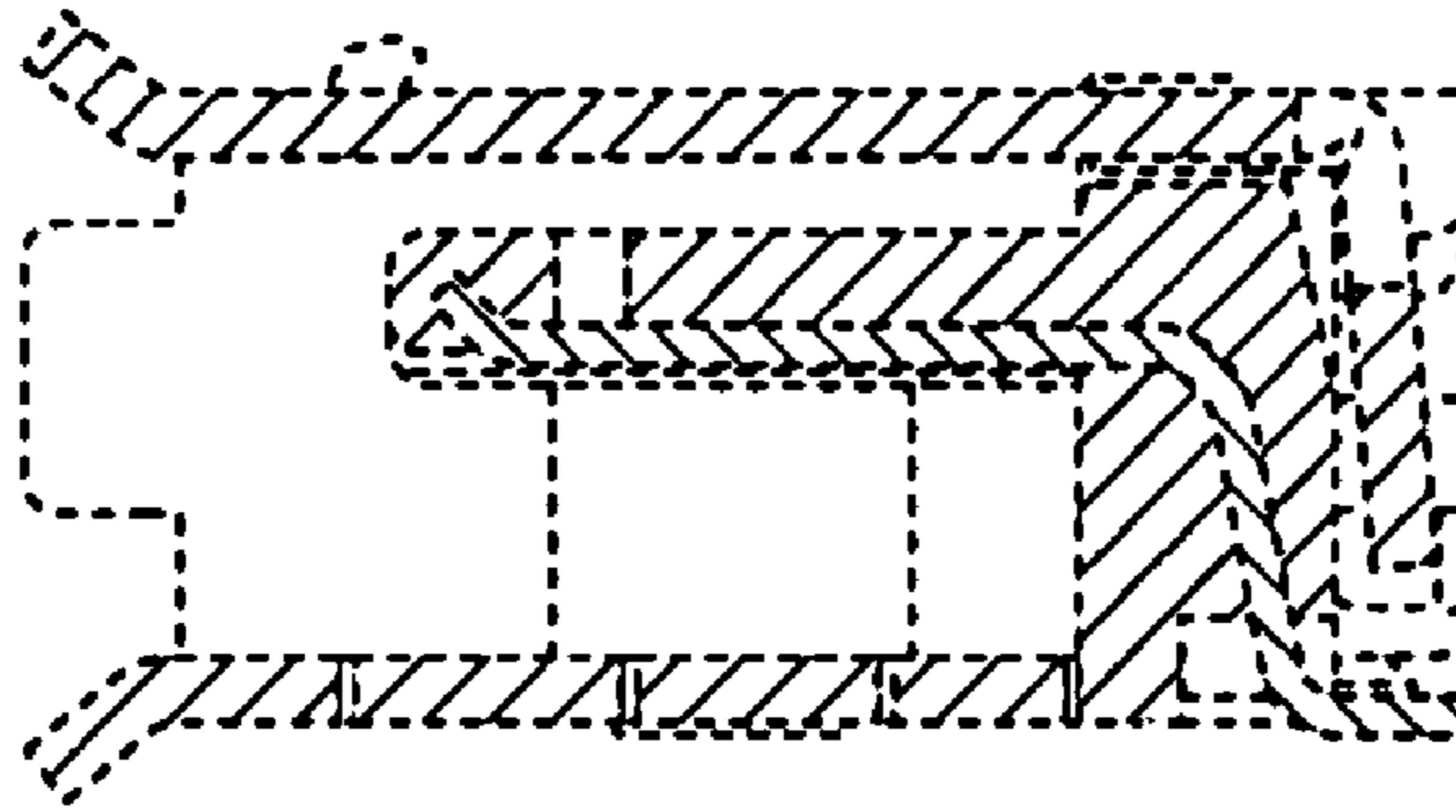

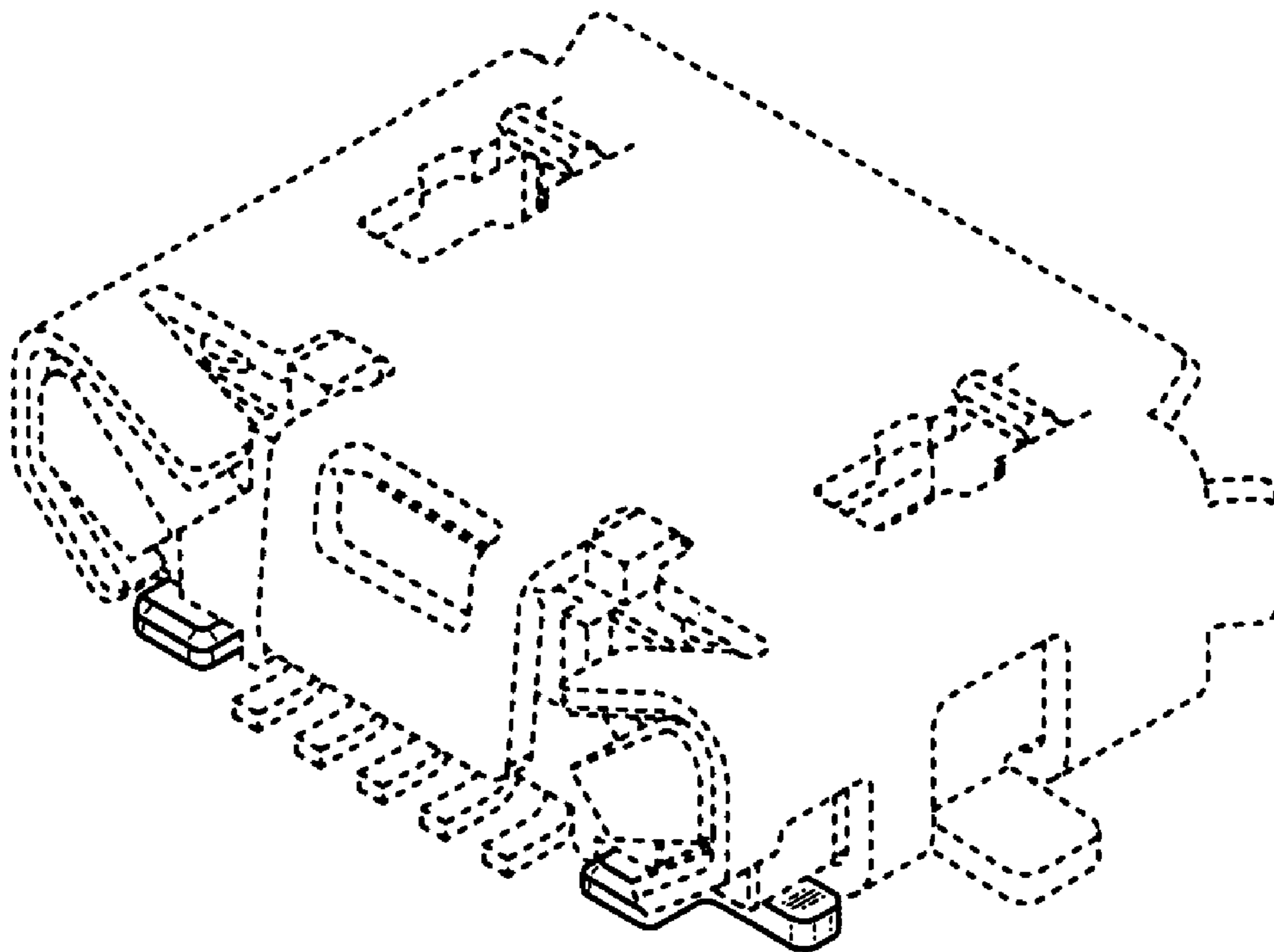

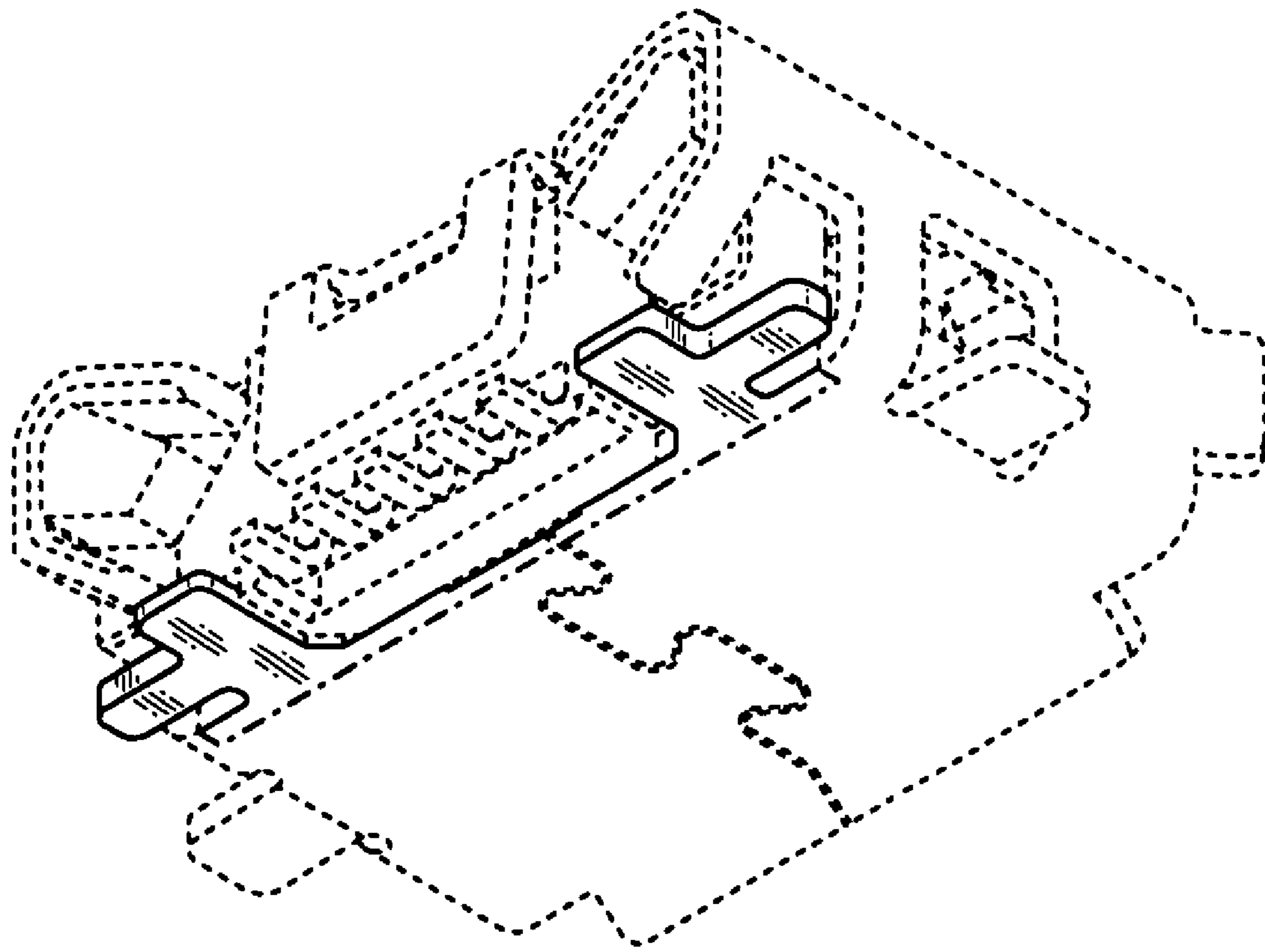
