(57) **CLAIM**

The ornamental design for an airplane window control switch, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an airplane window control switch showing our new design, in a usage condition at the bottom of an airplane window;

FIG. 2 is a front perspective view thereof;

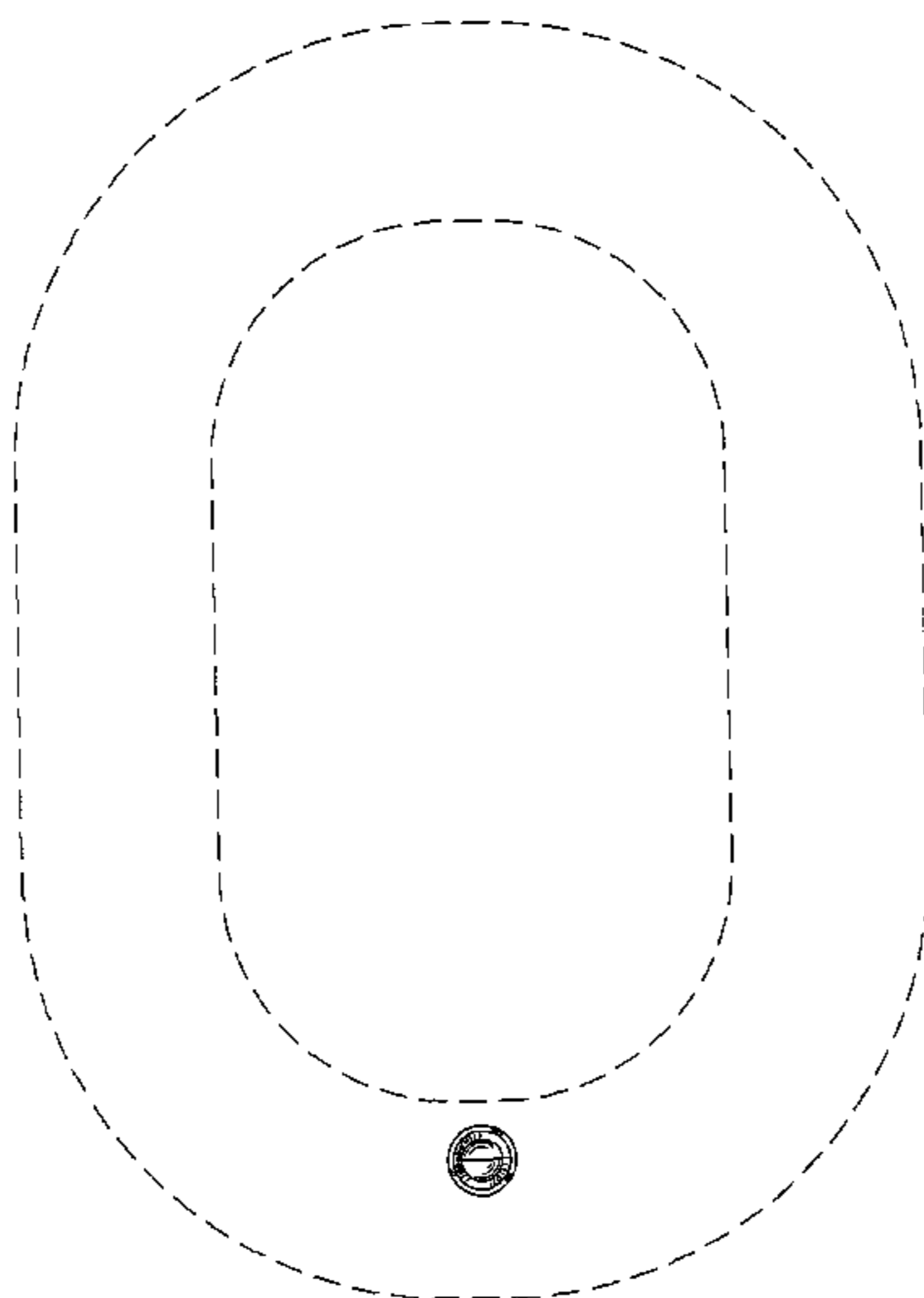
FIG. 3 is a front view thereof;

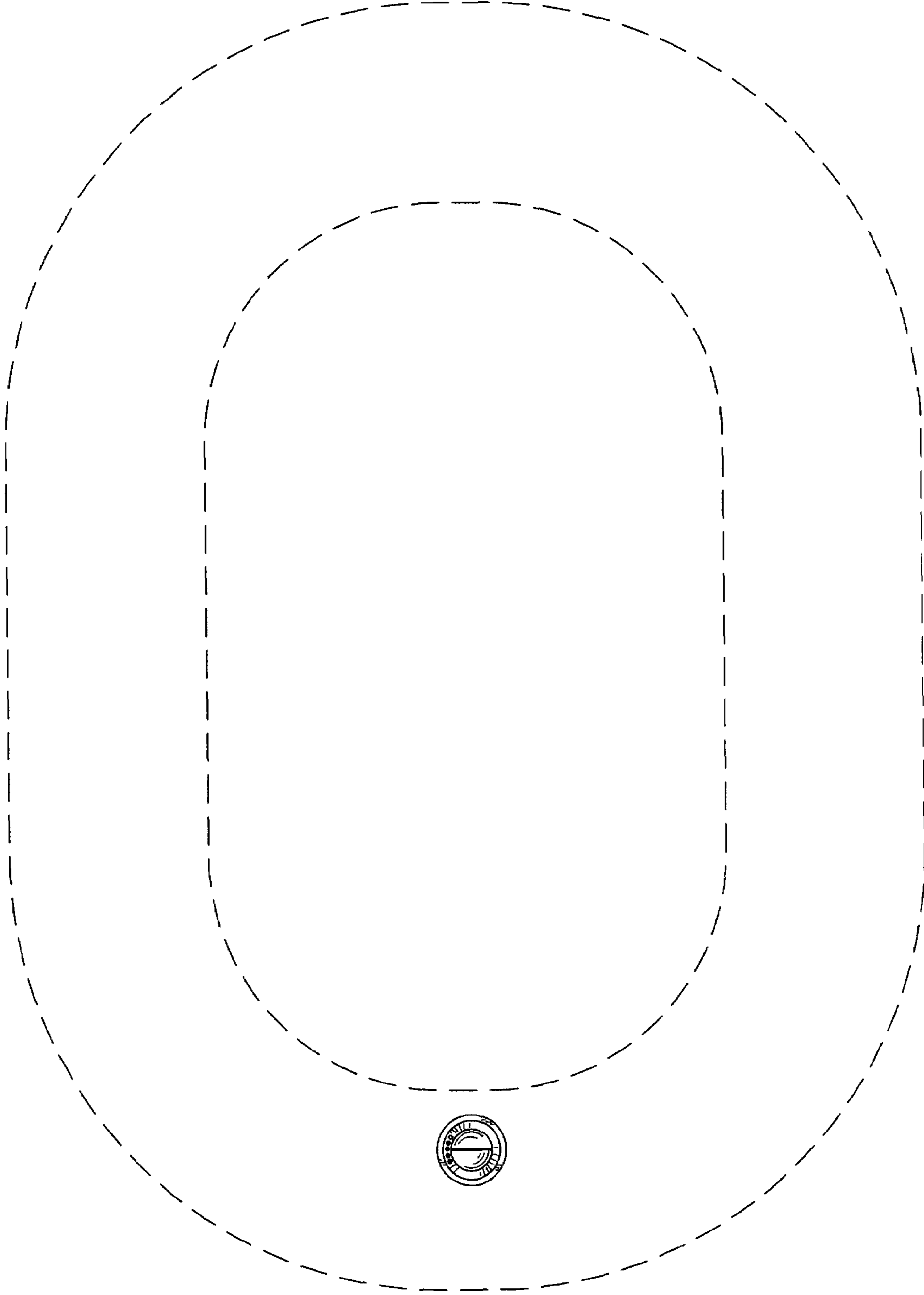

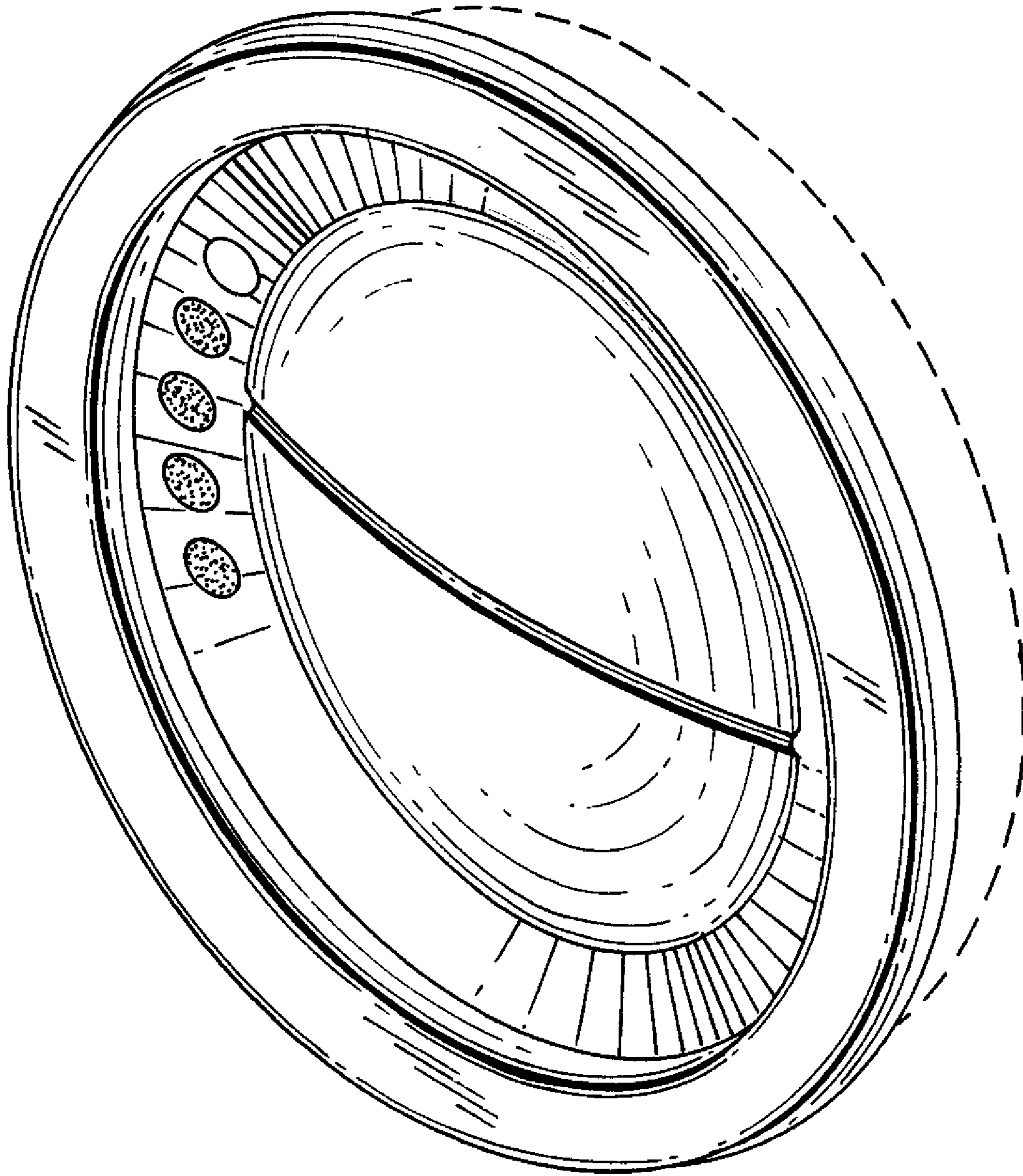

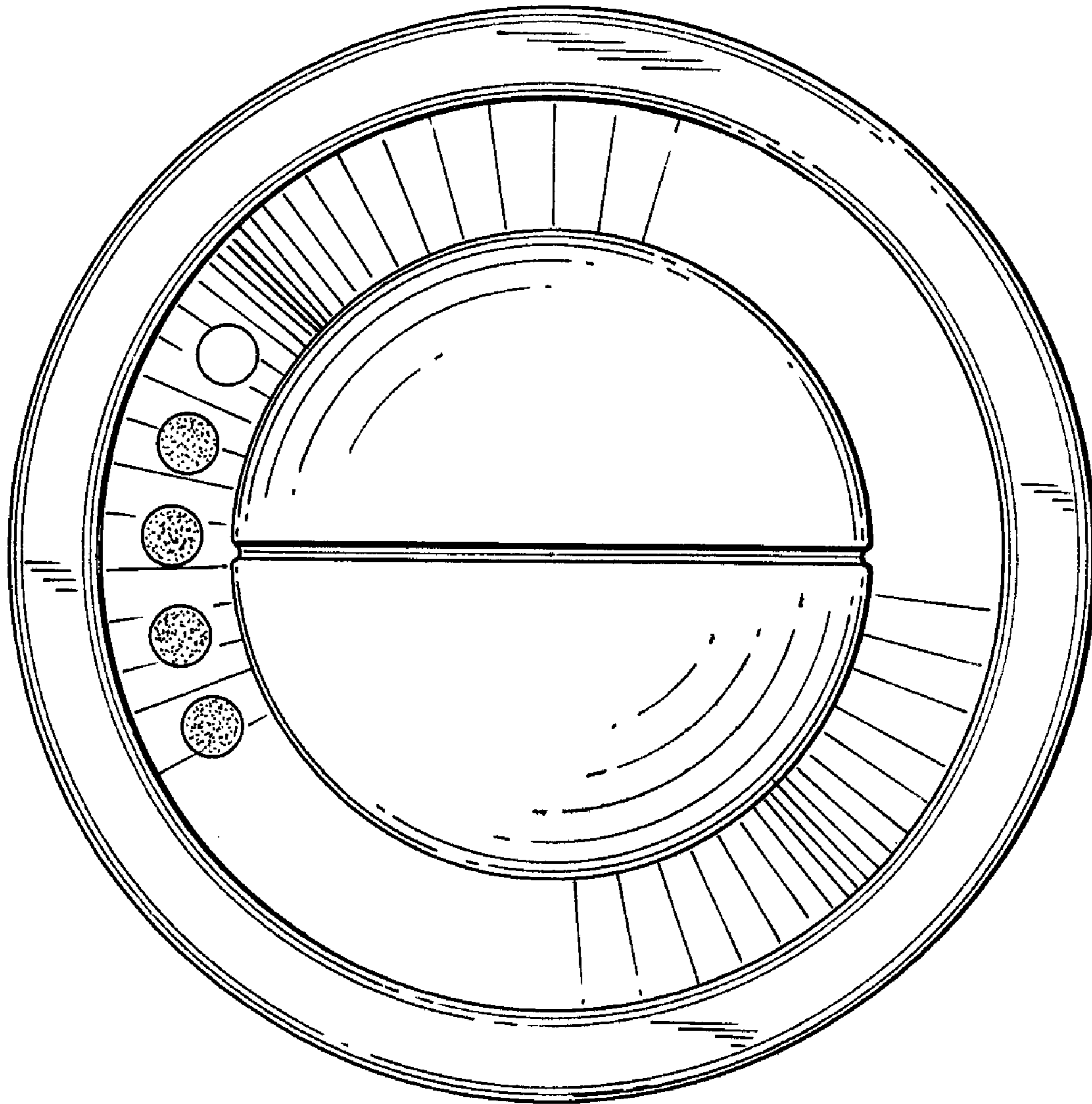

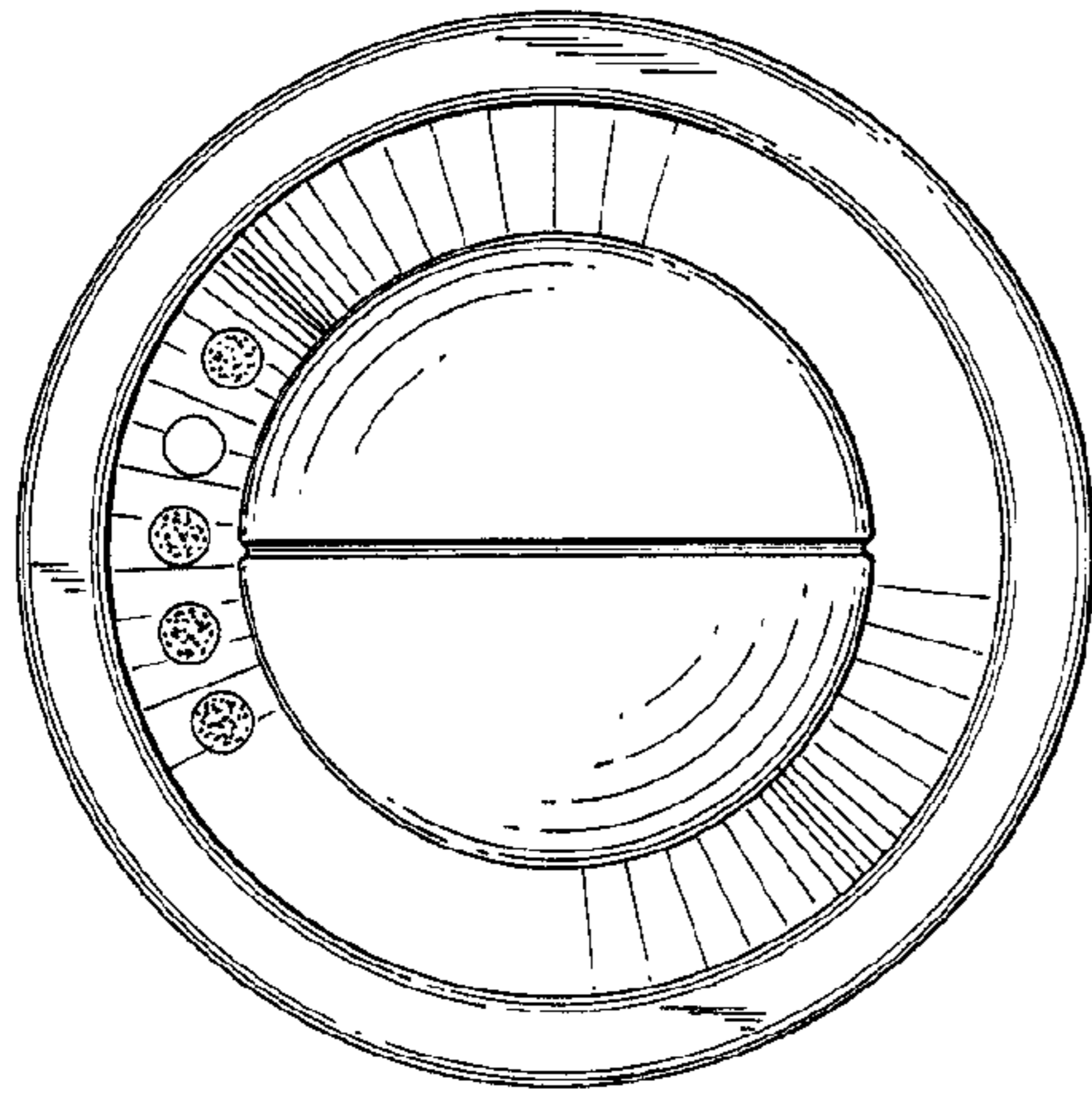

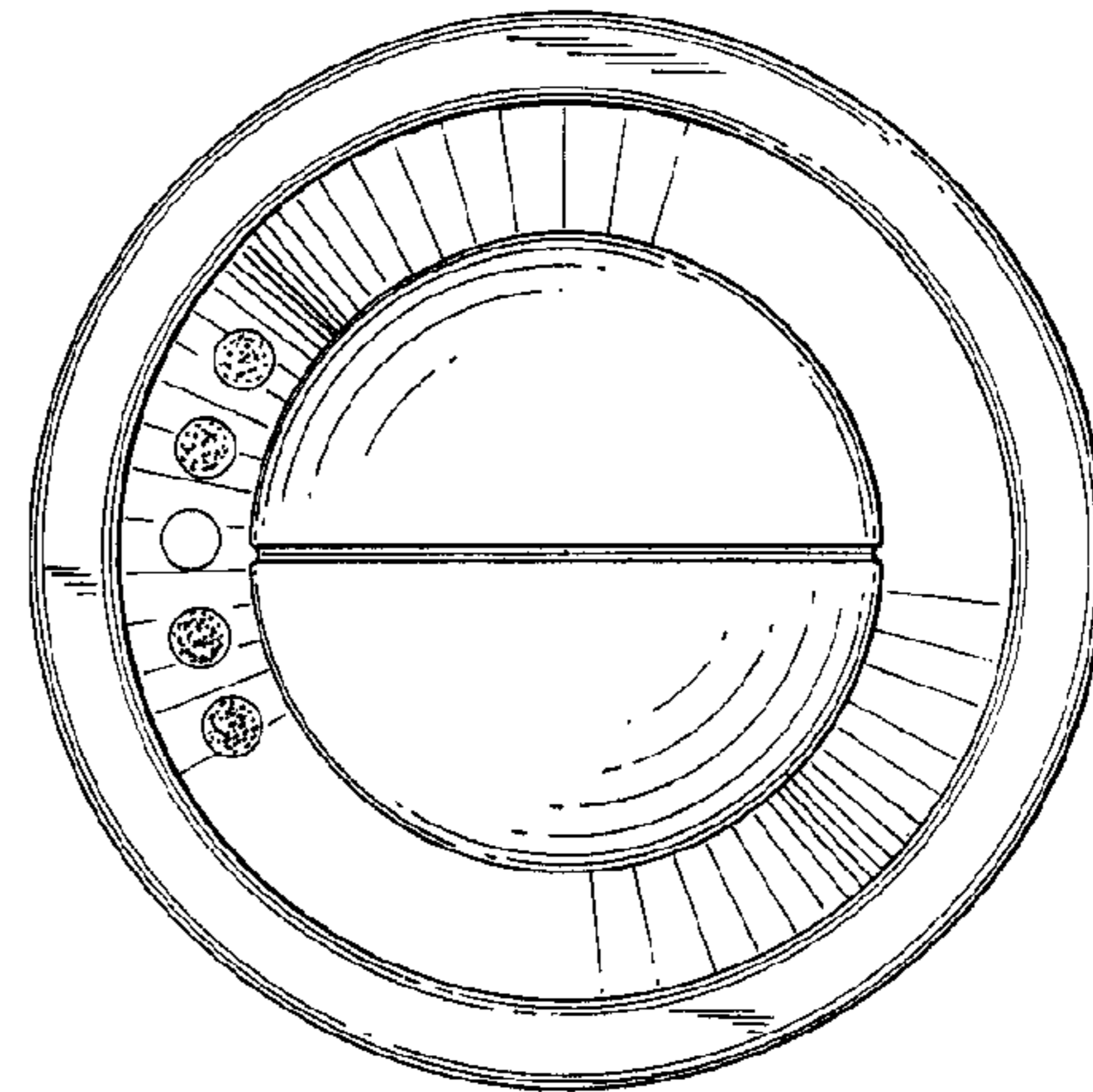

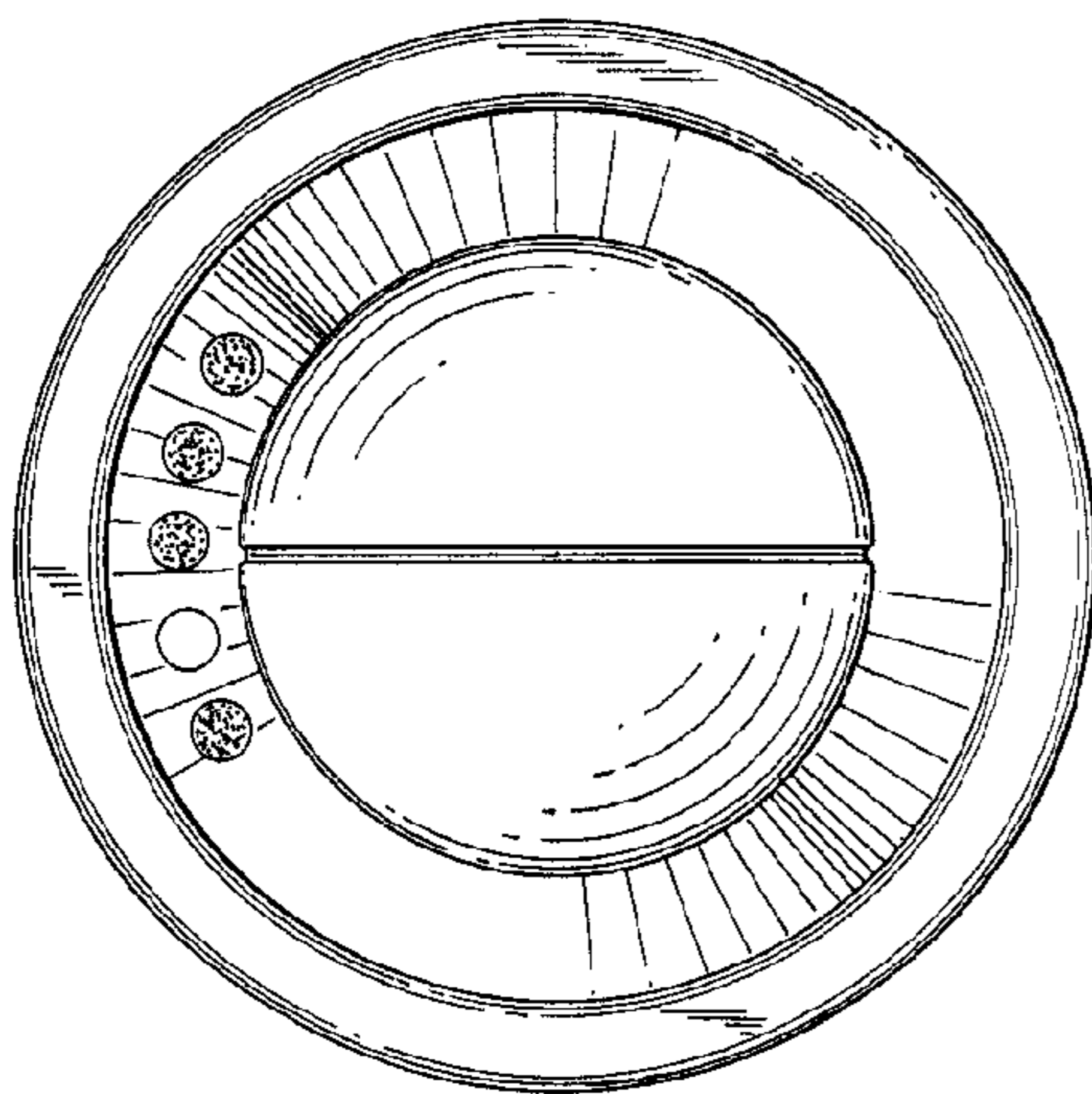

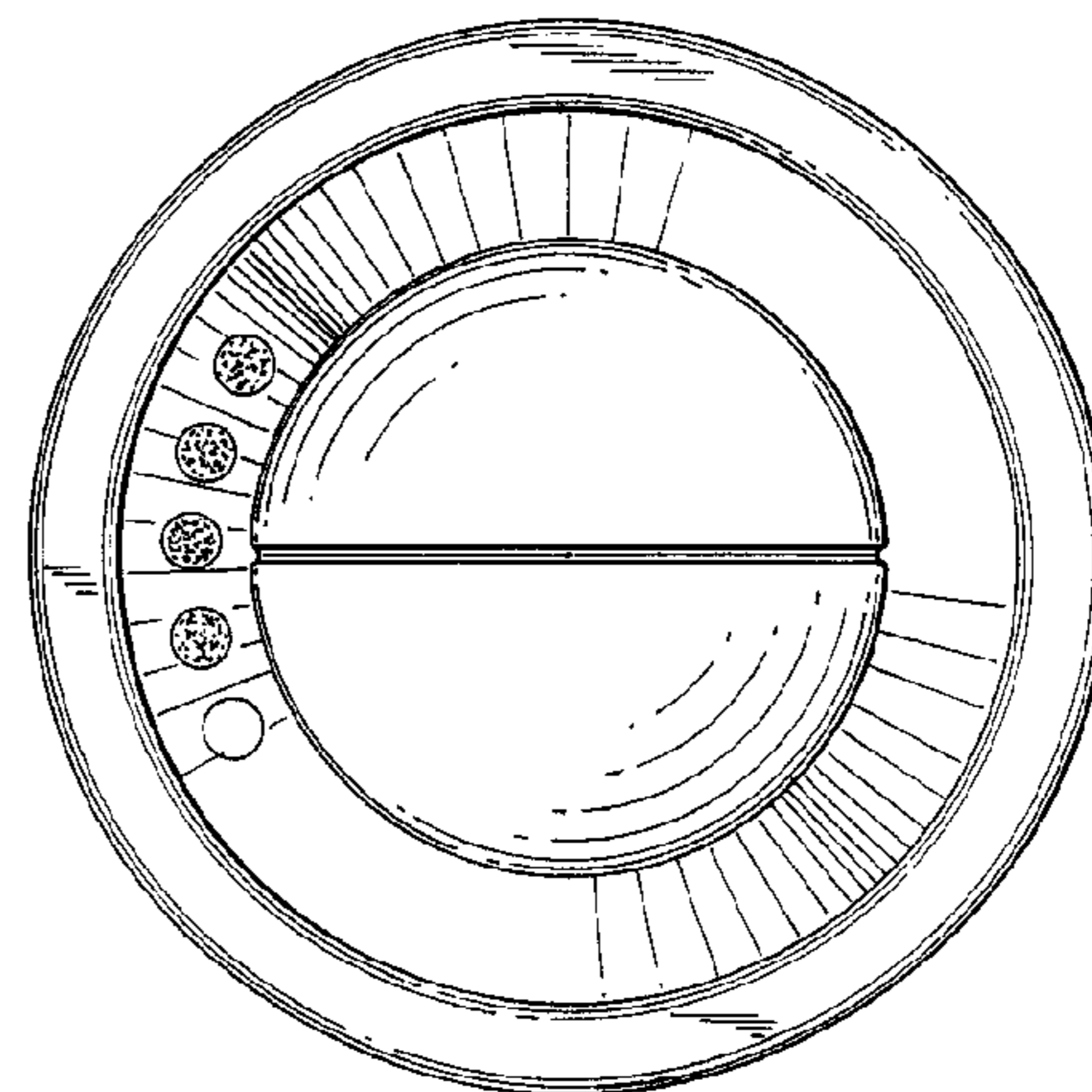

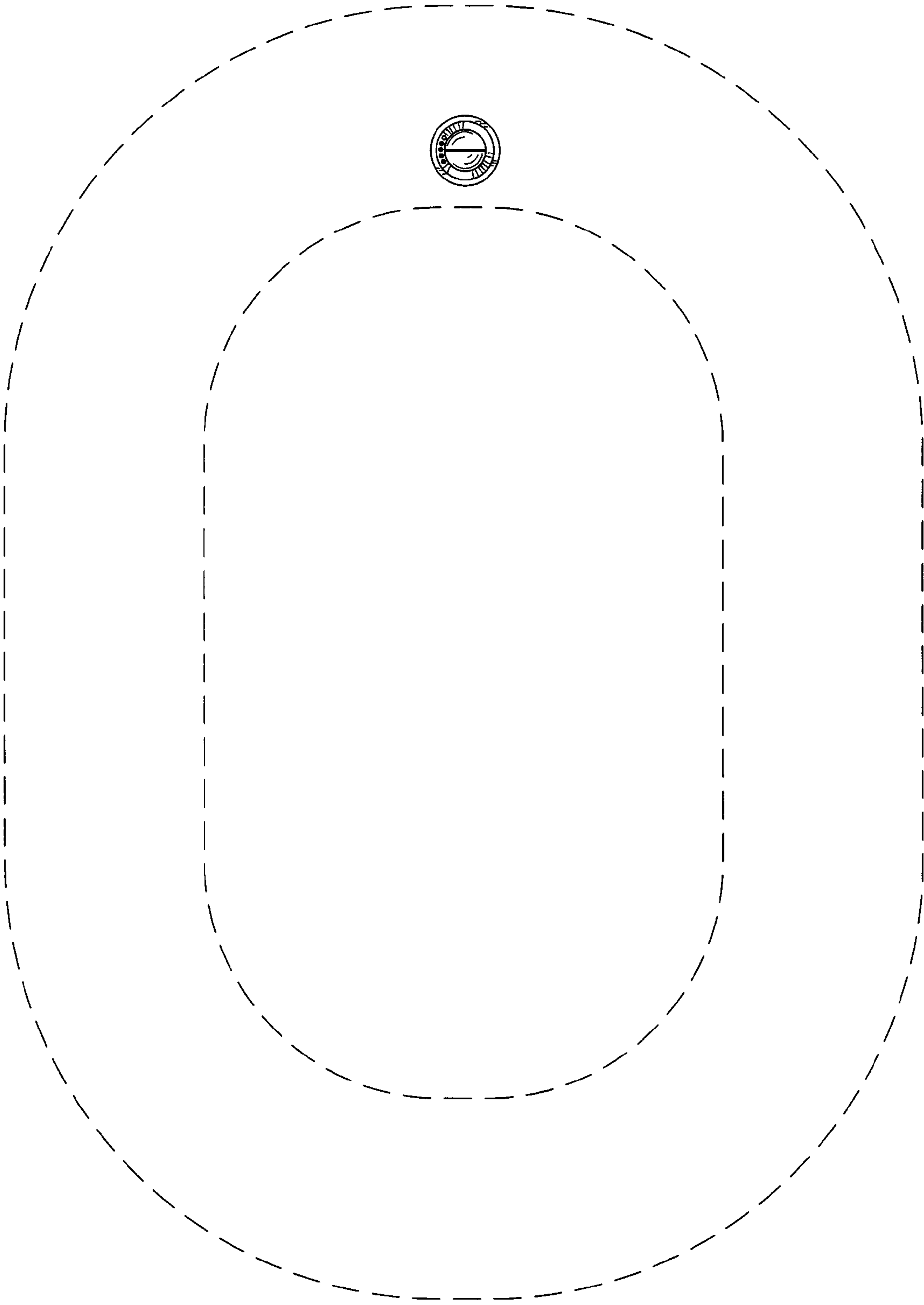
