The ornamental design for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone;  
FIG. 2 is a front view of the mobile phone of FIG. 1;  
FIG. 3 is a rear view of the mobile phone of FIG. 1;  
FIG. 4 is left-side of the mobile phone of FIG. 1;  
FIG. 5 is right-side of the mobile phone of FIG. 1;  
FIG. 6 is top plan view of the mobile phone of FIG. 1;  
FIG. 7 is bottom plan view of the mobile phone of FIG. 1; and,  
FIG. 8 is an open perspective view of the mobile phone of FIG. 1, where the display portion is slid upward.

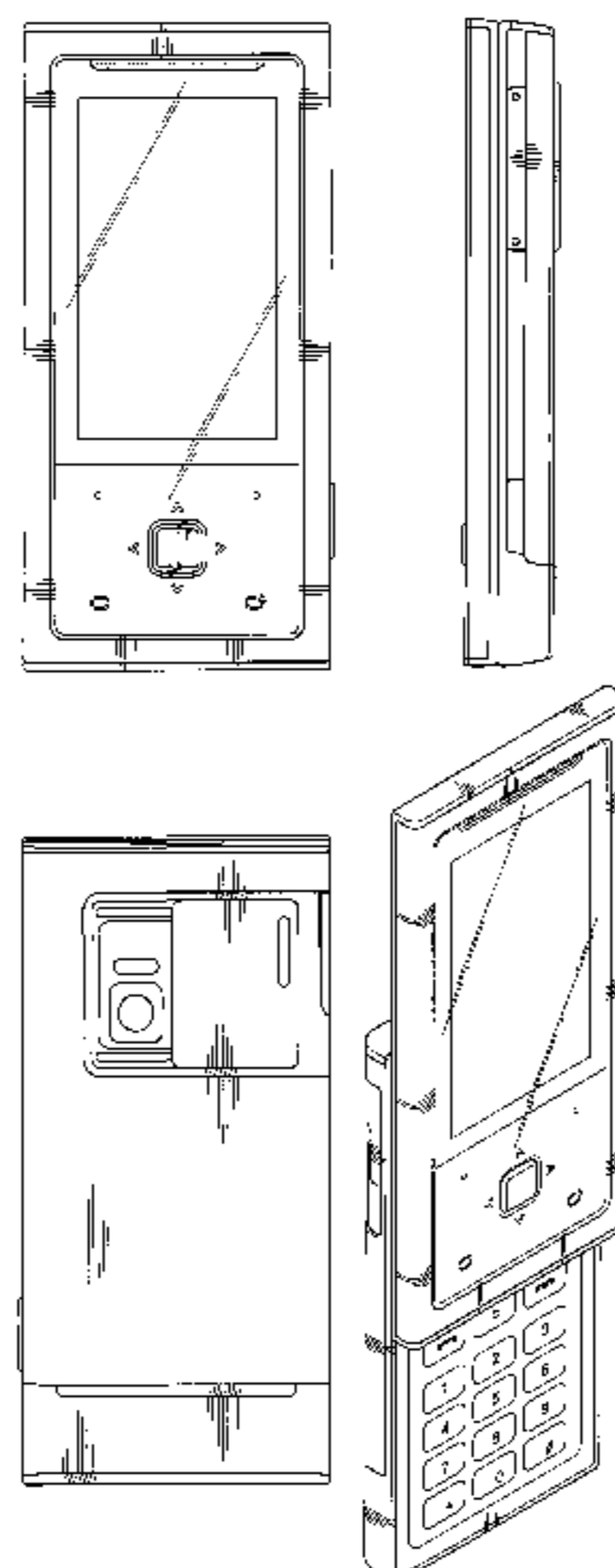
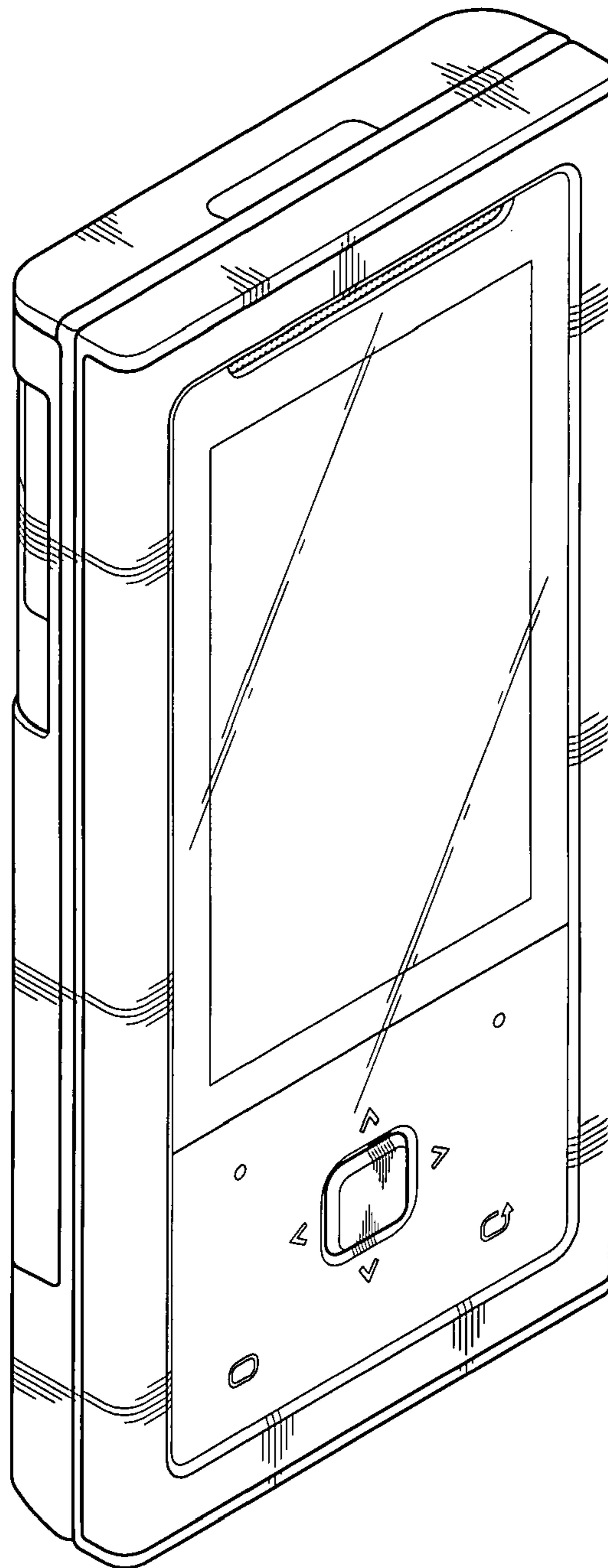

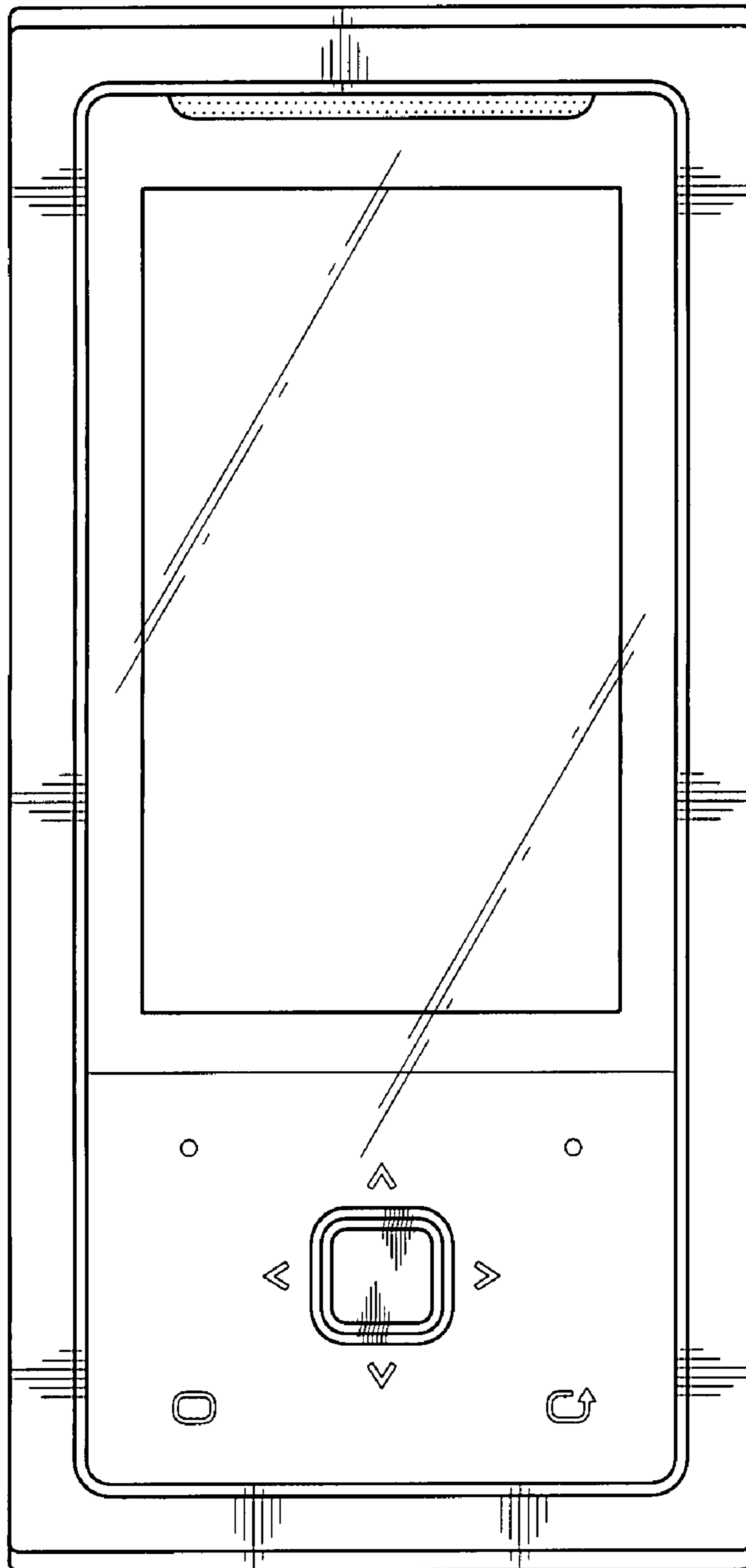

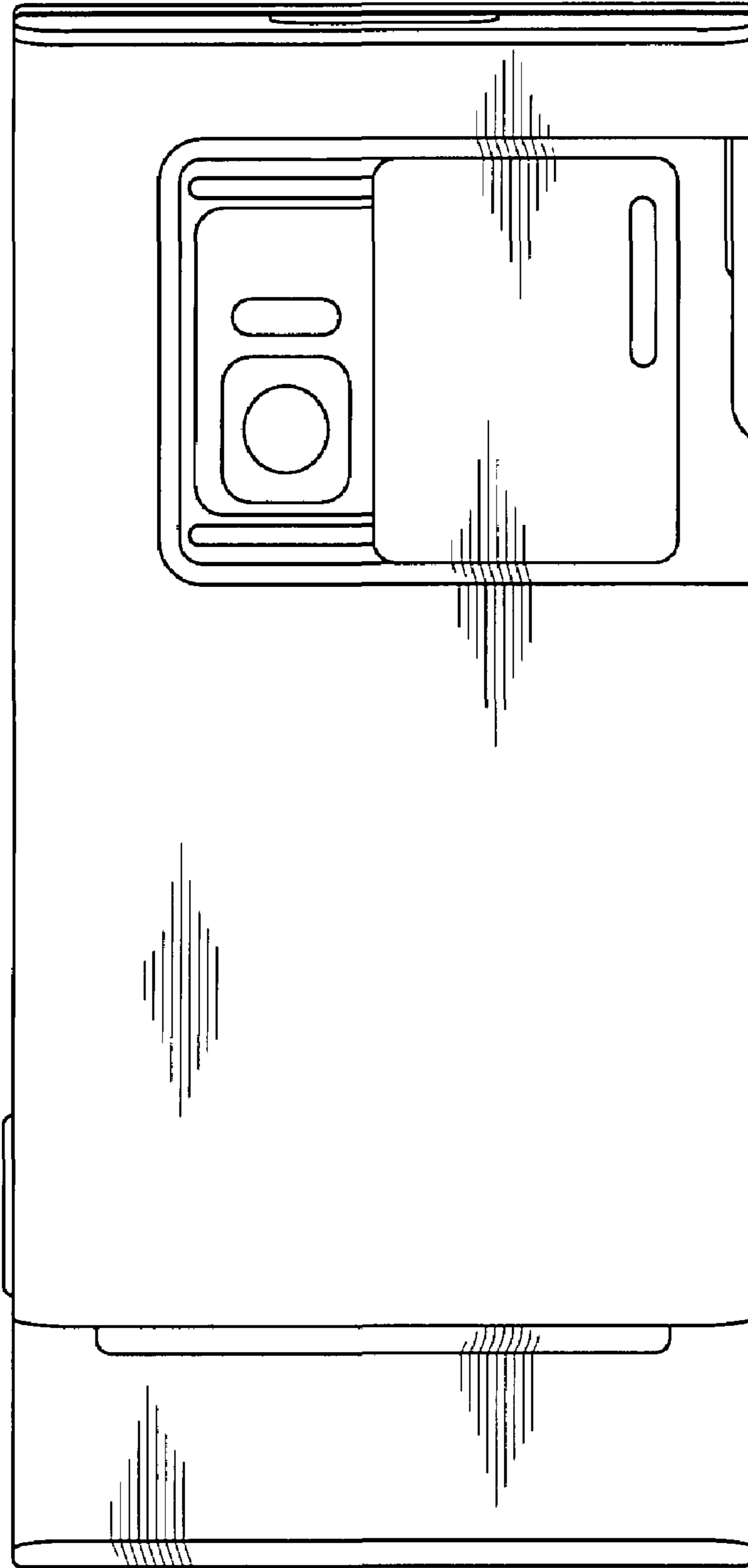

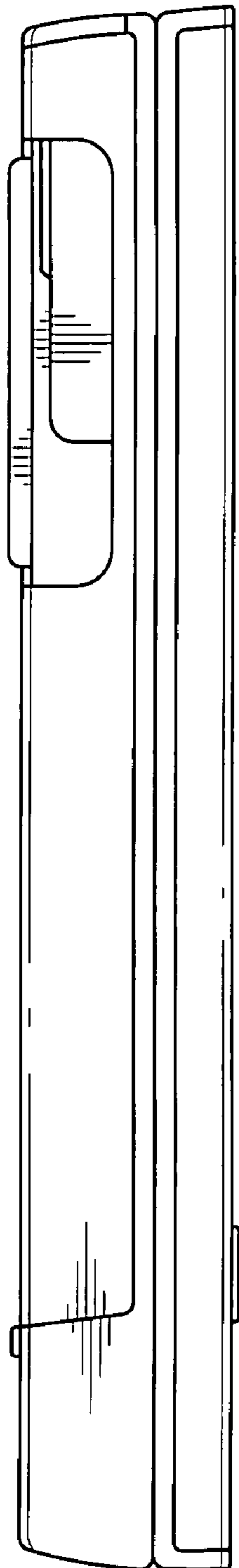

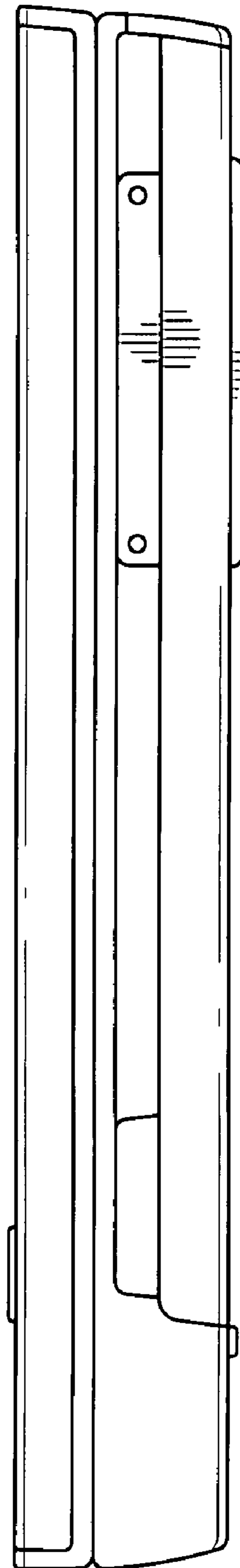

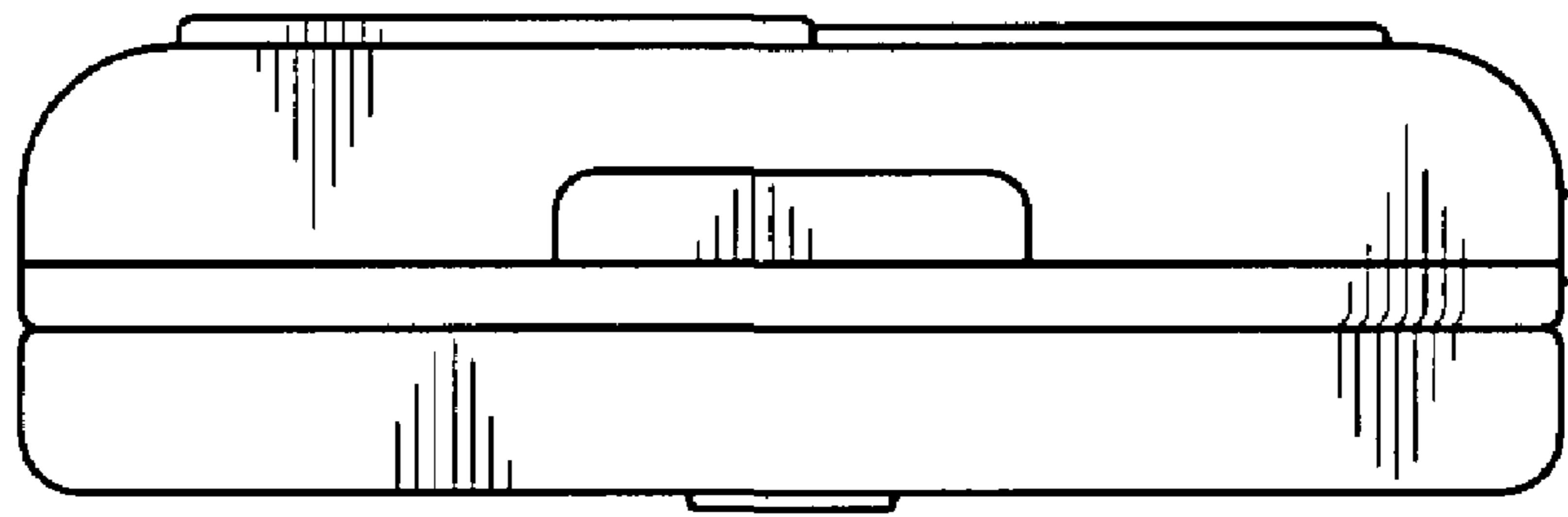

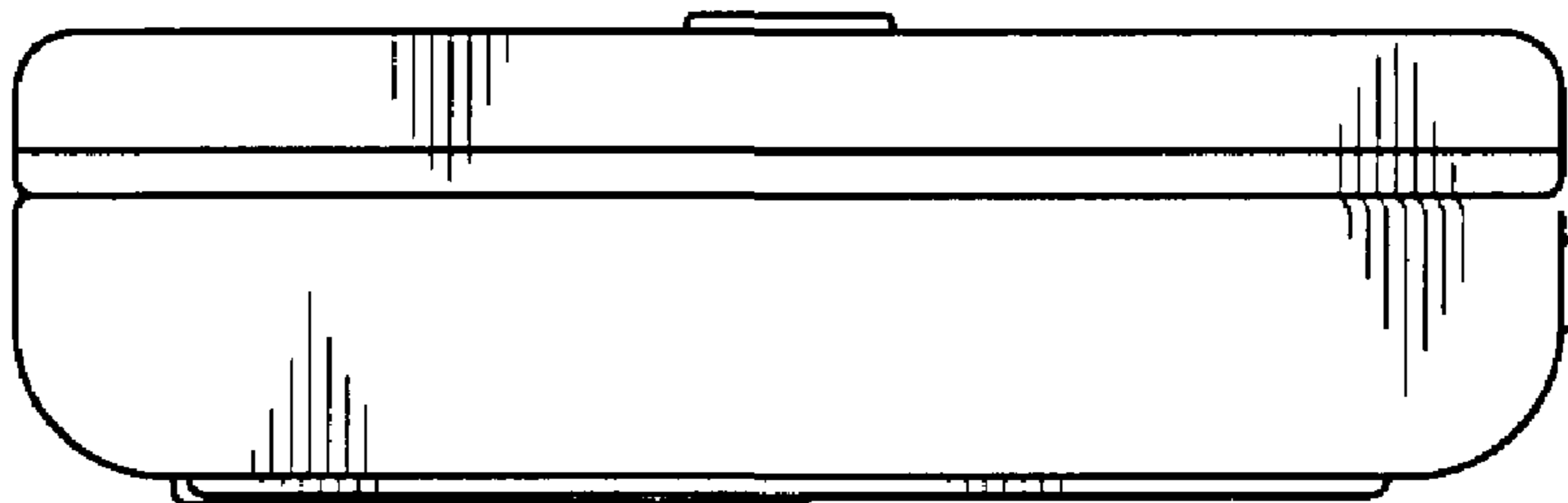
