FIG. 1 is a front perspective view of a luggage tag showing my new design;

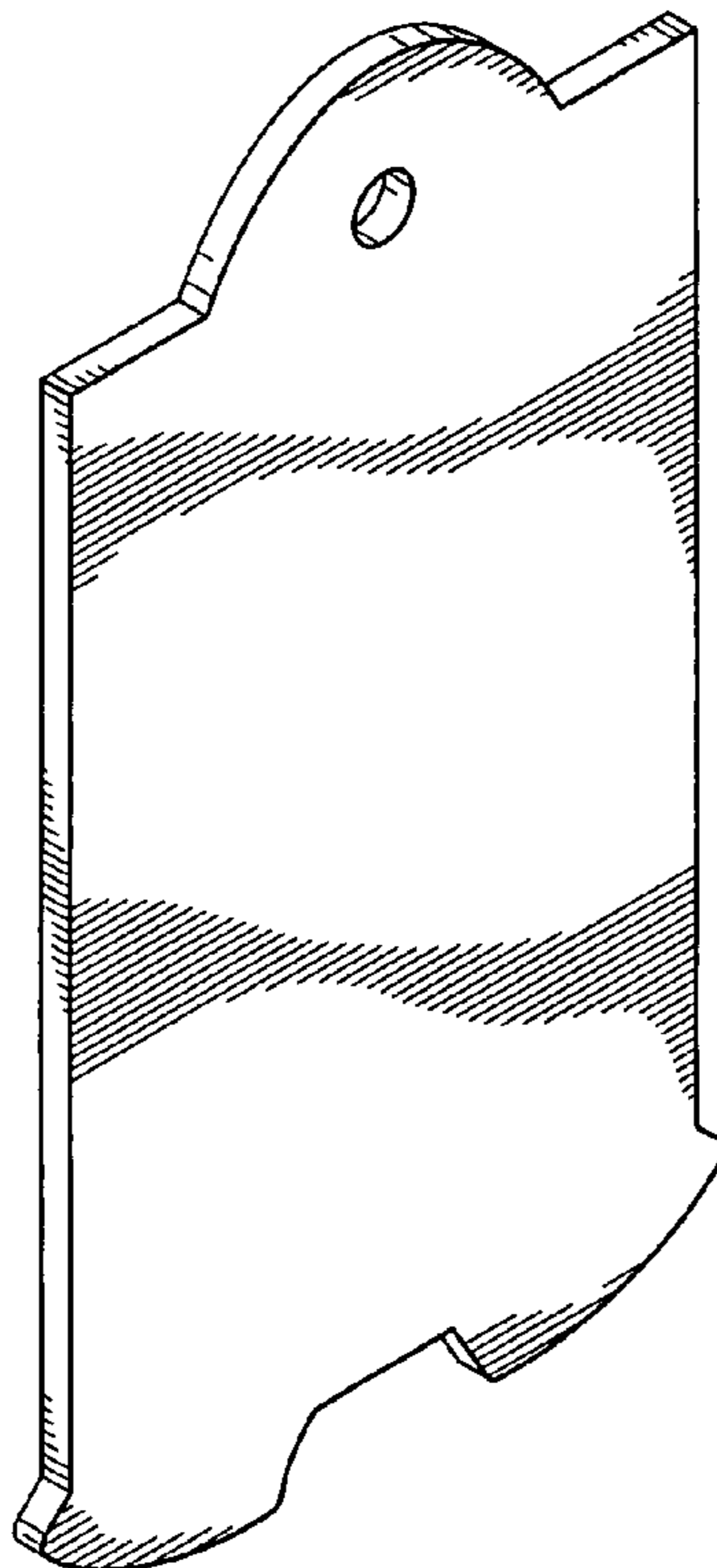
FIG. 2 is a front view thereof, the back view being identical thereto;

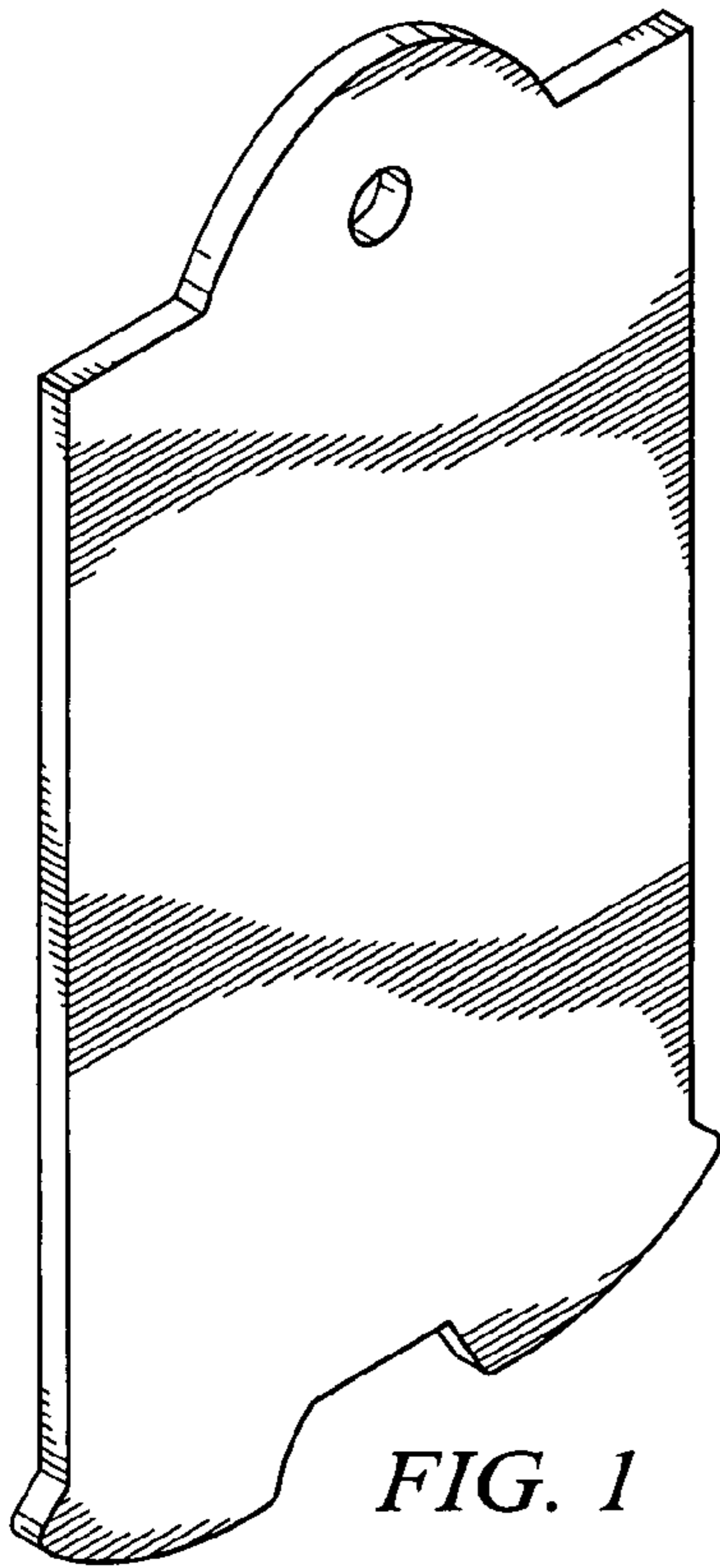

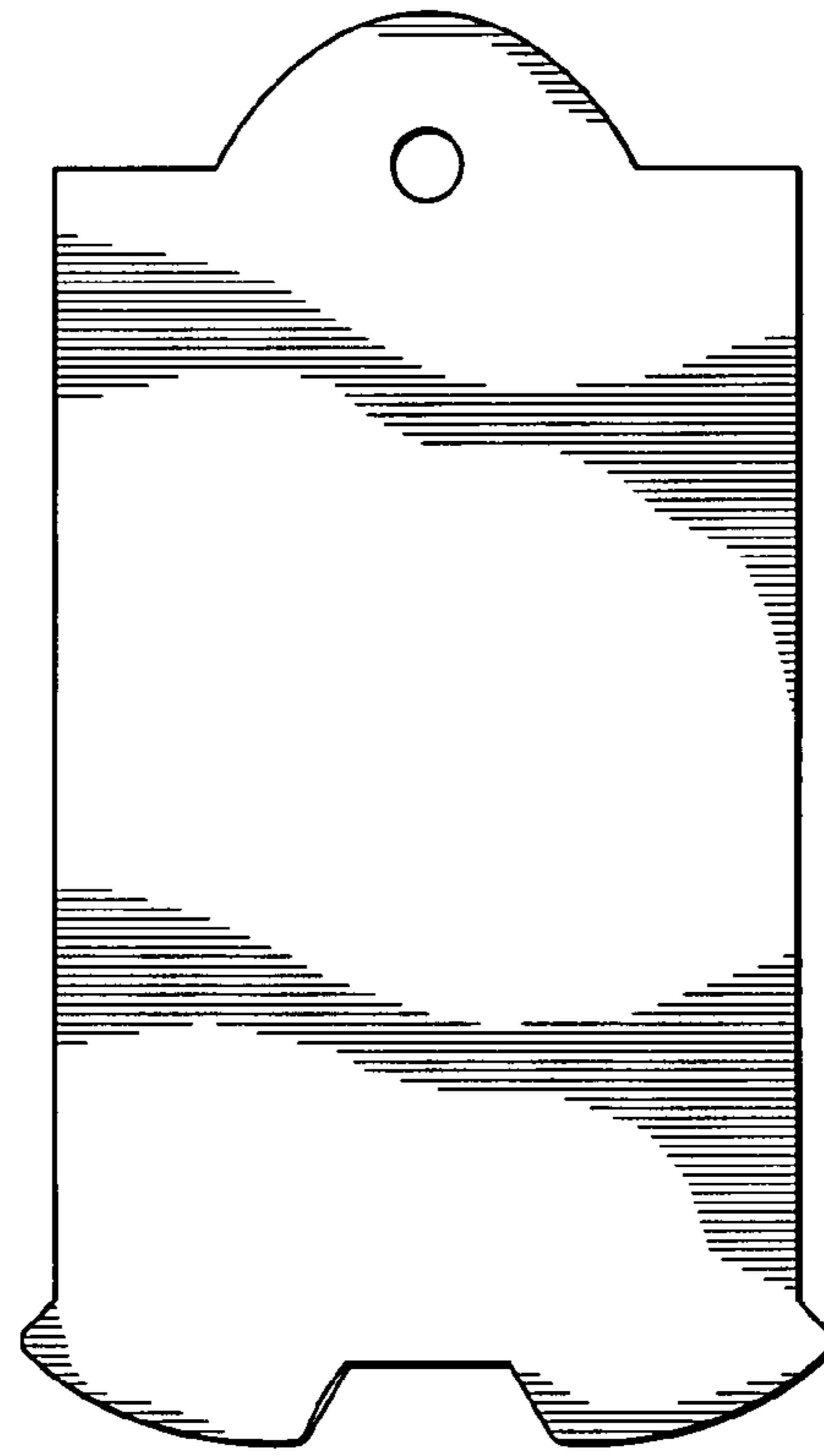
