The ornamental design for an air purifier, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the air purifier of the present invention;

FIG. 2 is a front elevation view of the air purifier of FIG. 1;

FIG. 3 is a right side elevational view of the air purifier of FIG. 1, the left side being a mirror image thereof;

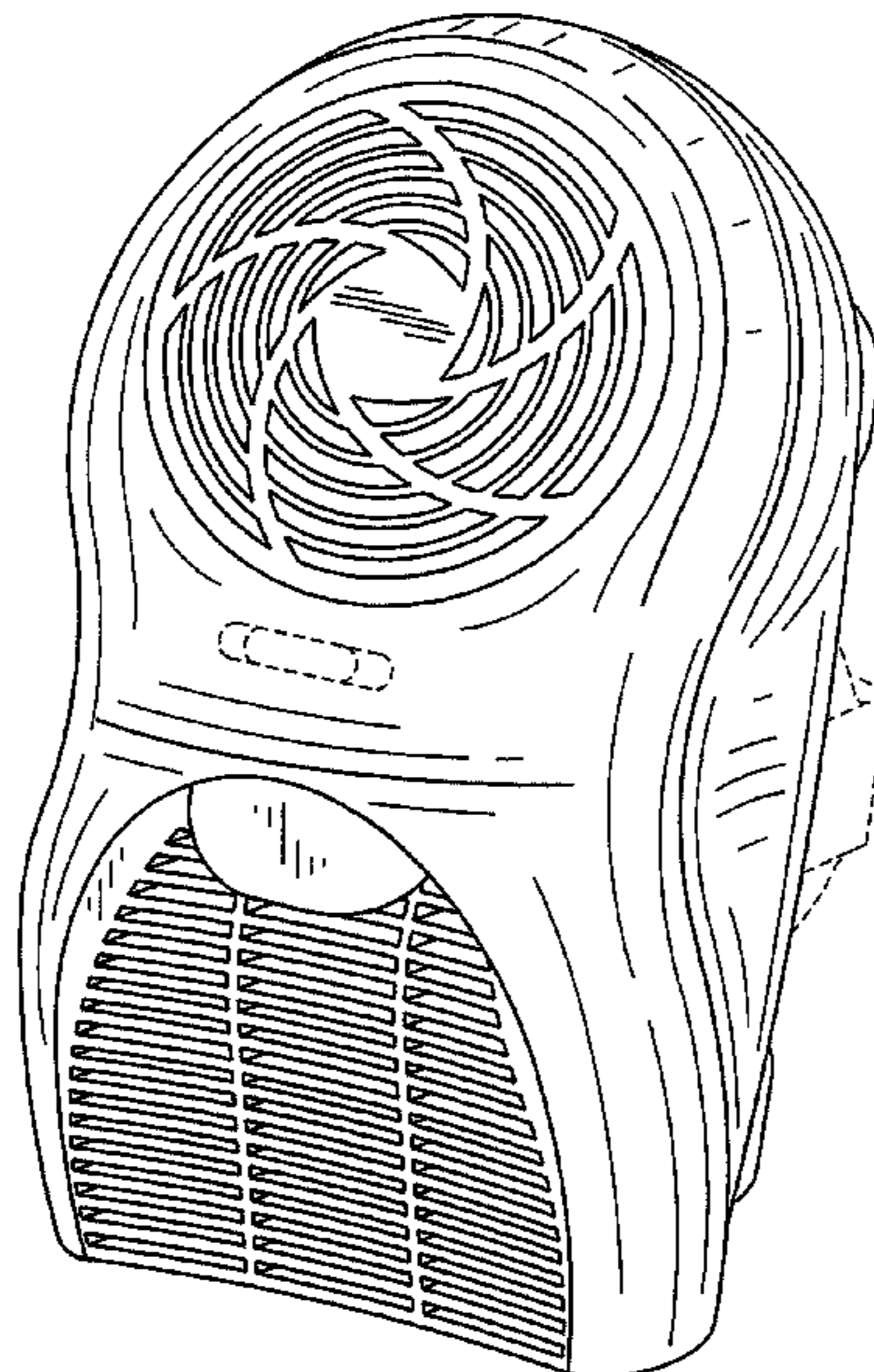
FIG. 4 is a top plan view of the air purifier of FIG. 1;

FIG. 5 is a rear elevational view of the air purifier of FIG. 1; and,

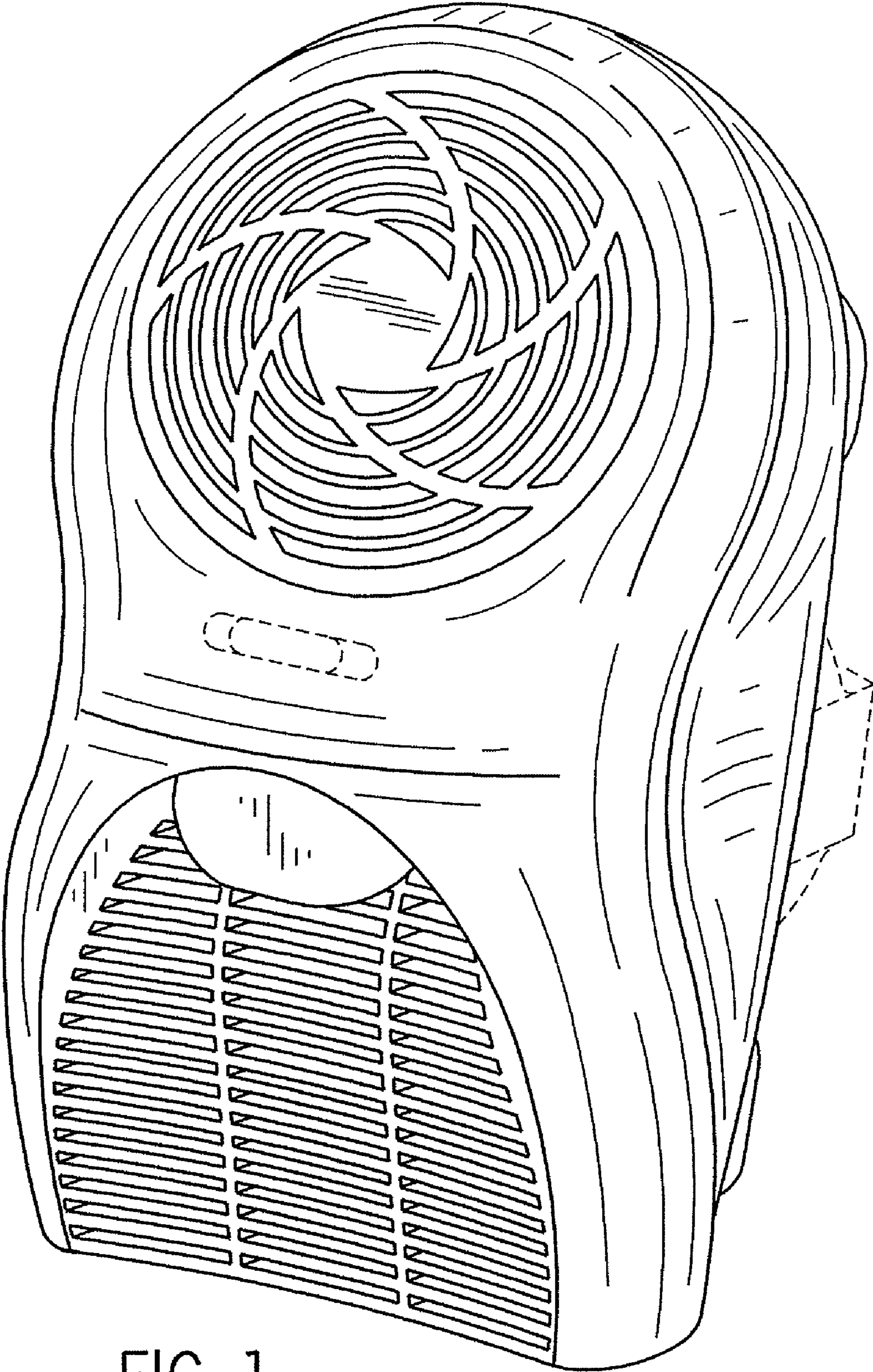

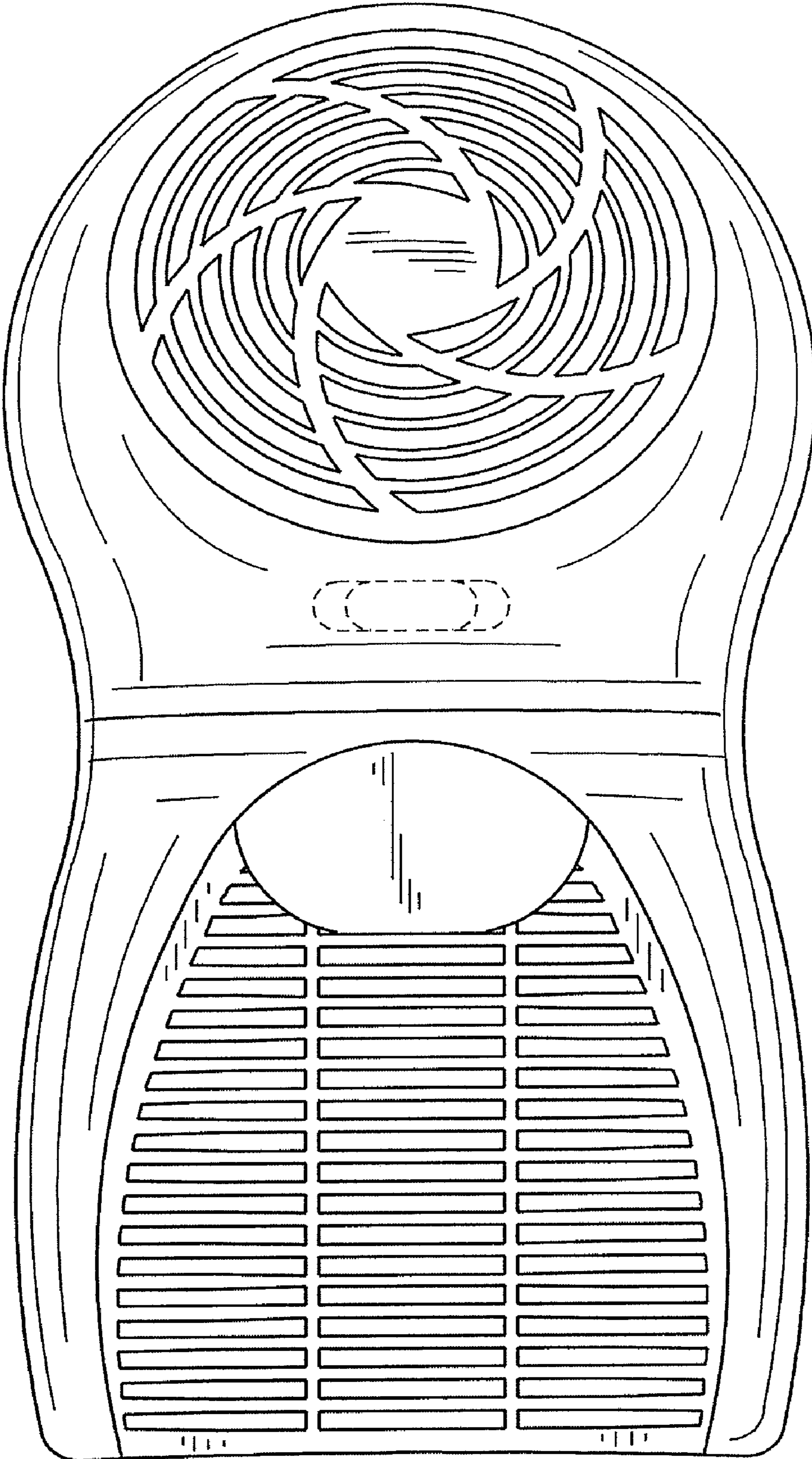

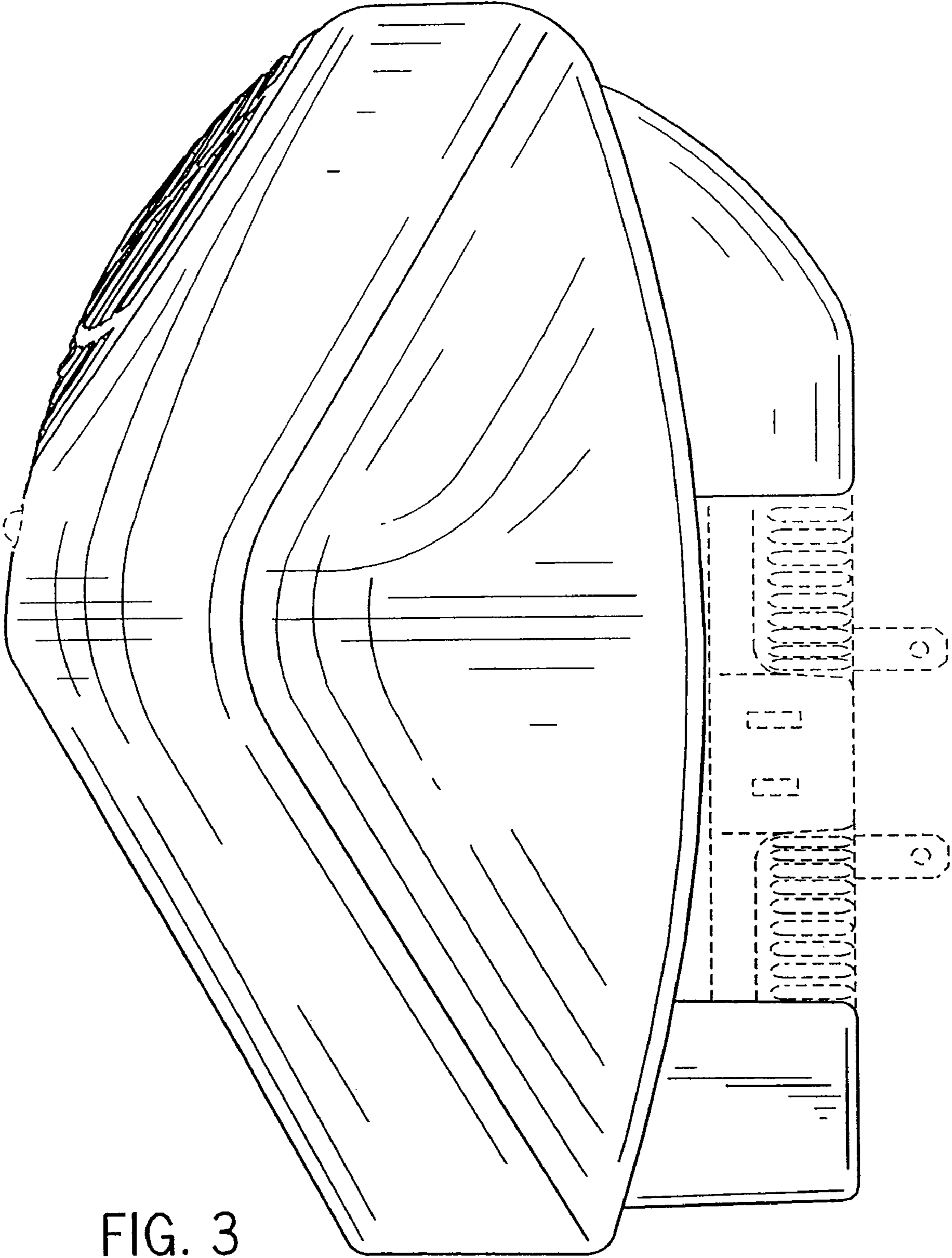

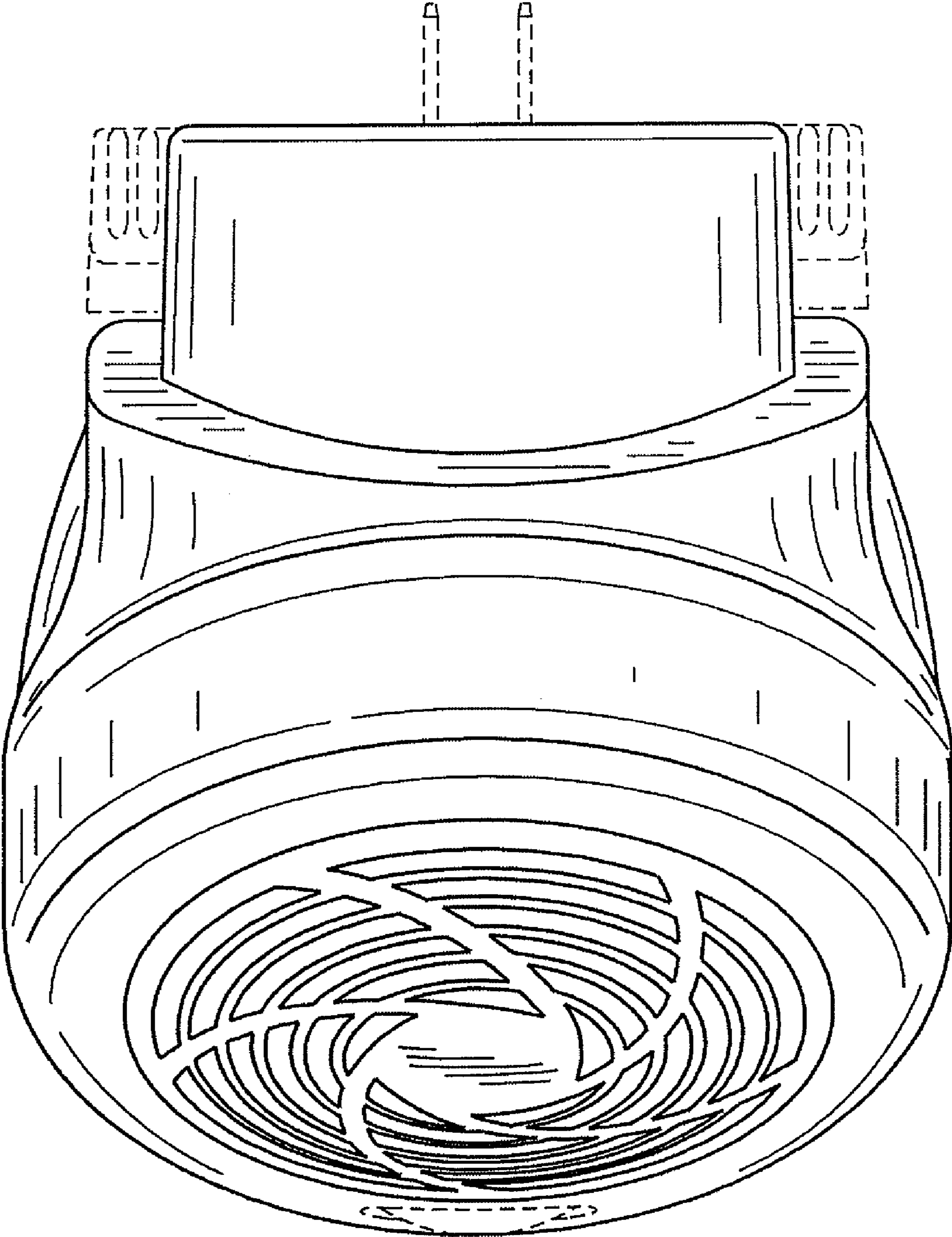

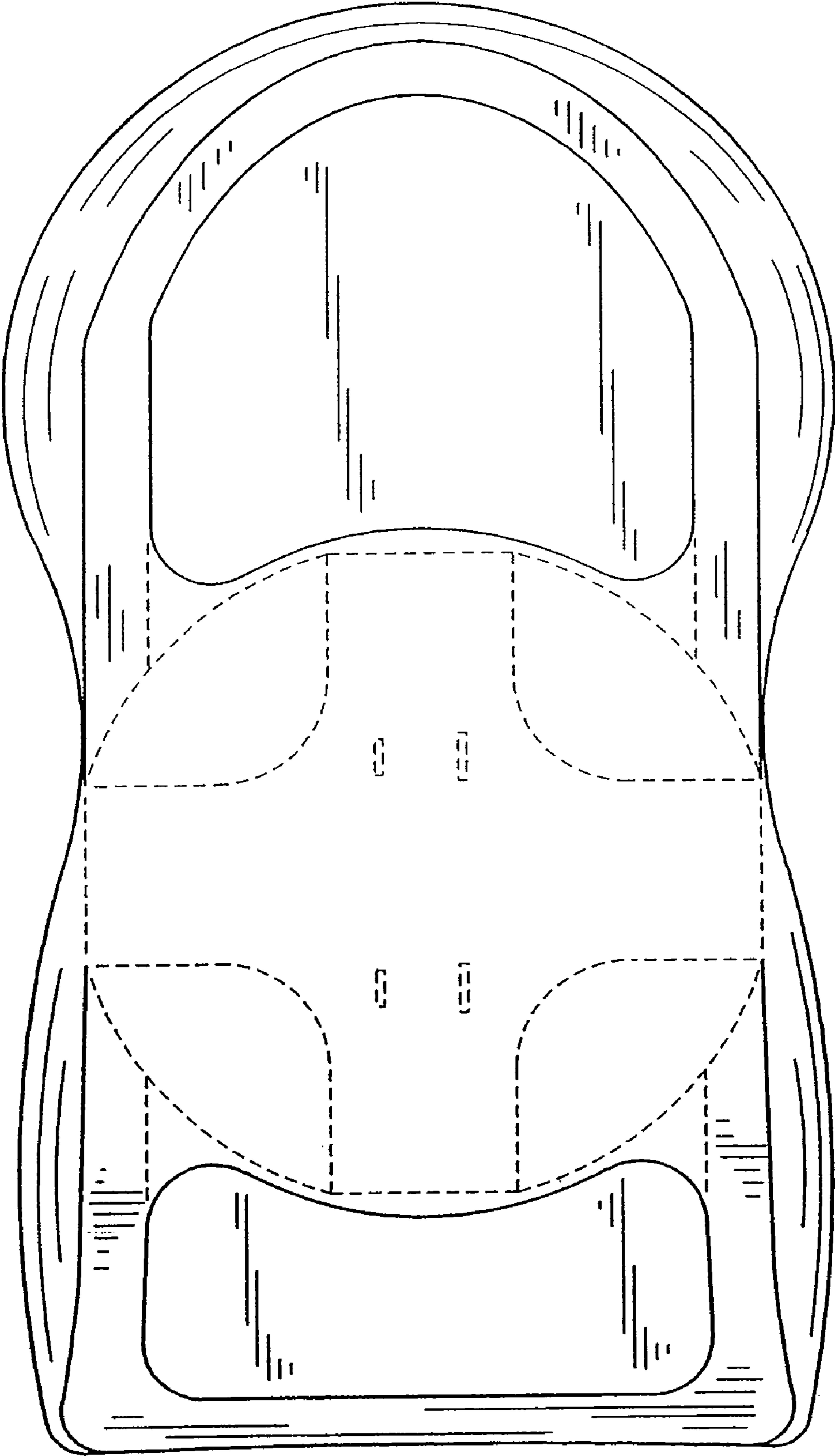

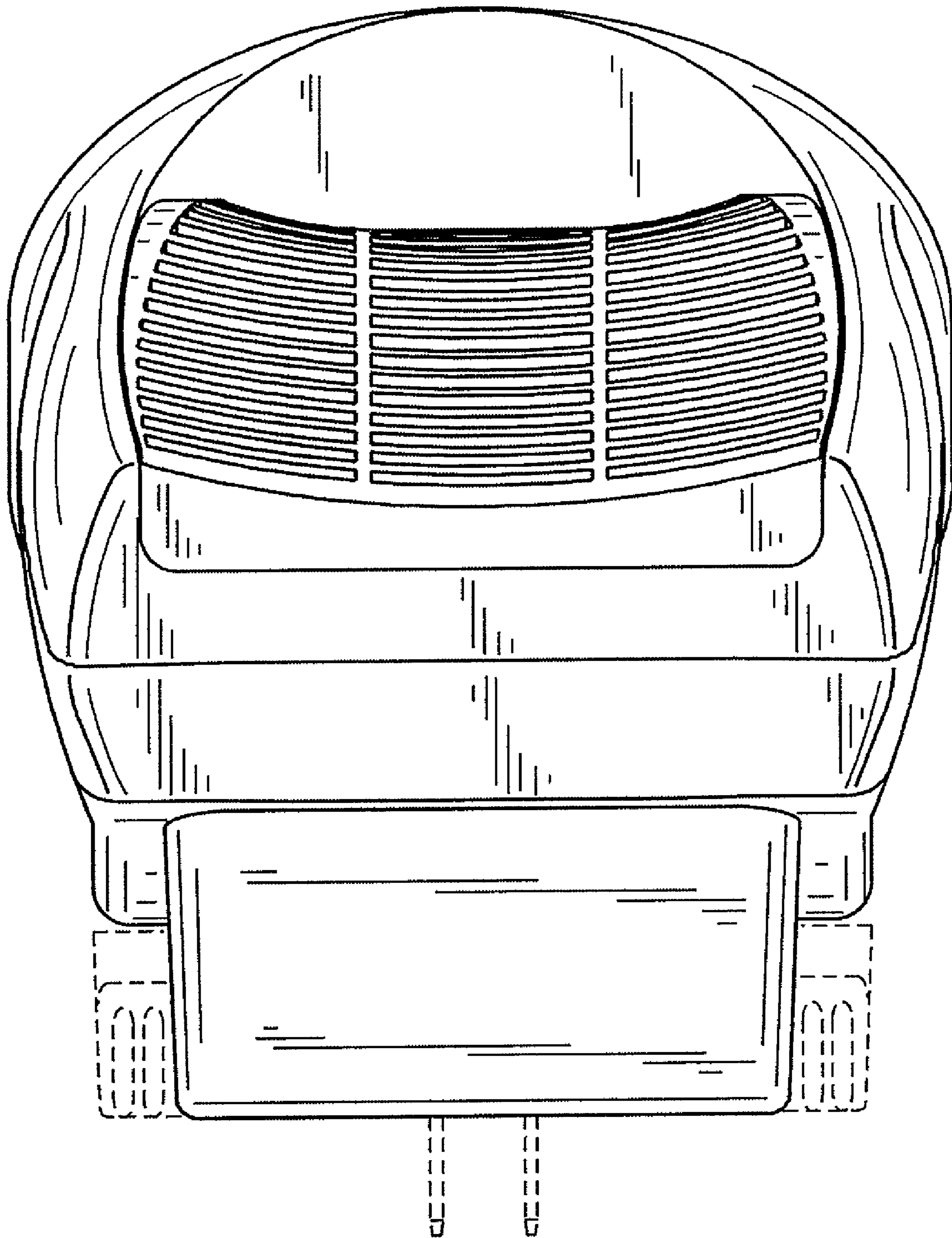
