FIG. 3 is right elevational view thereof;

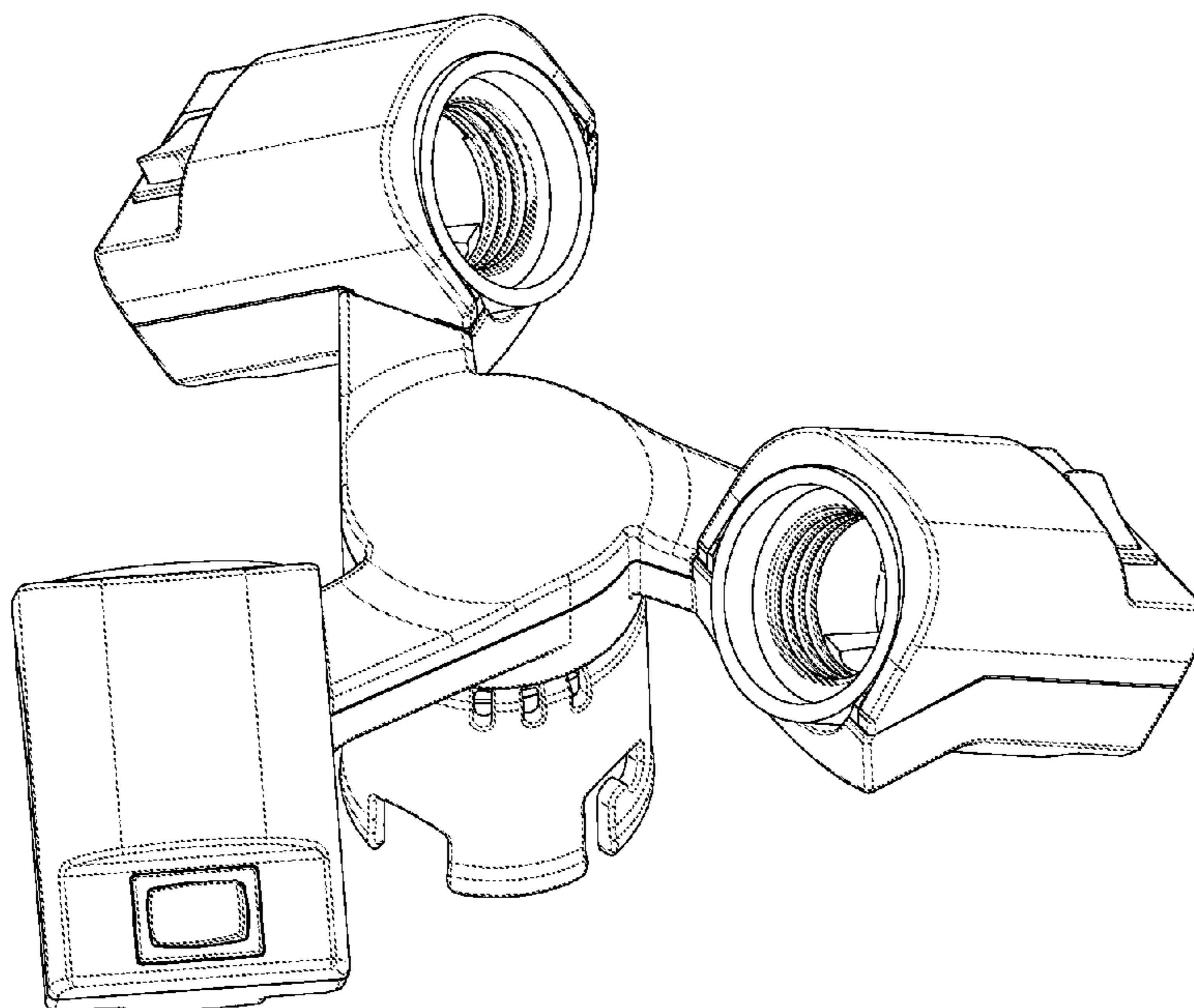
FIG. 4 is front elevational view thereof;

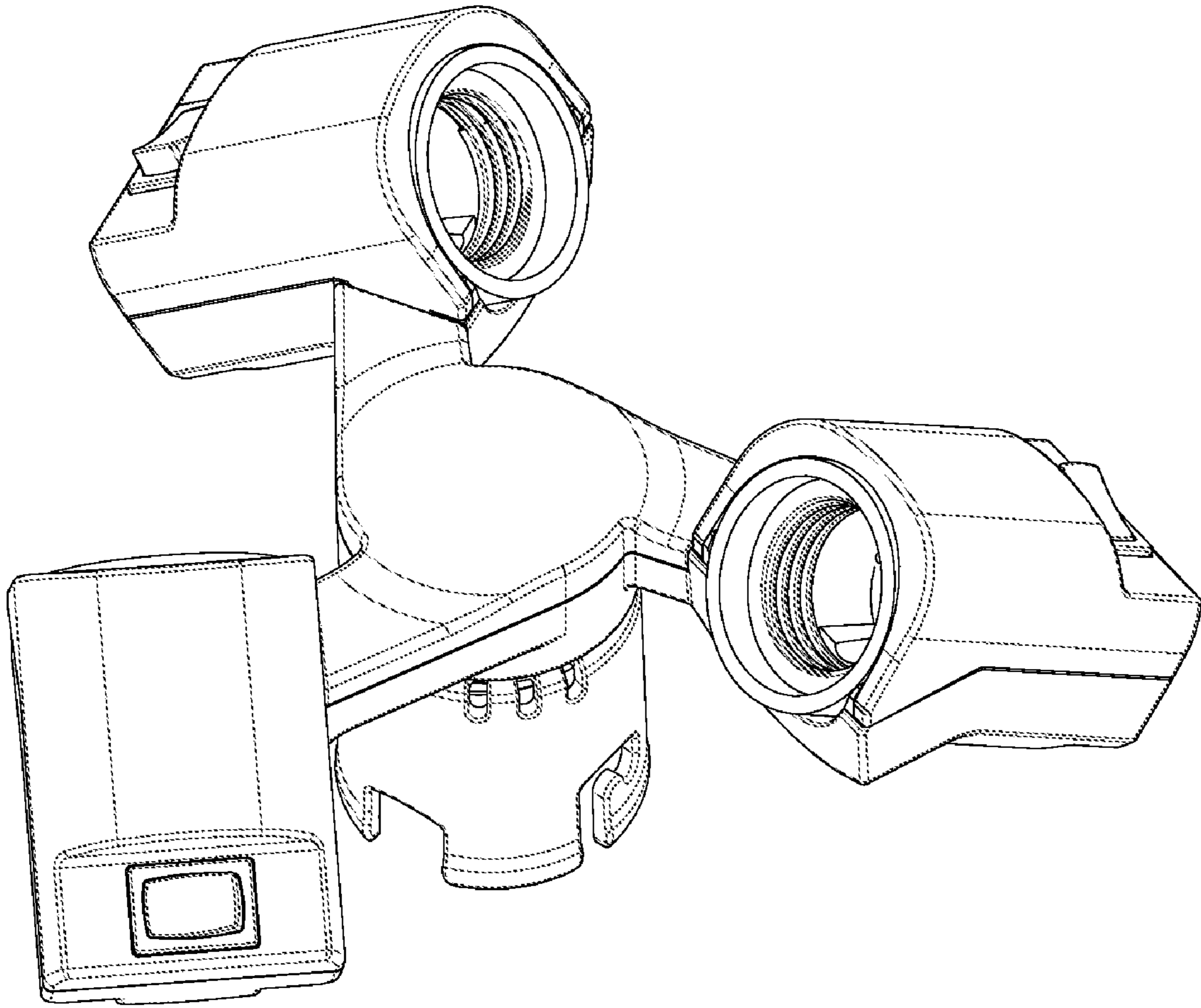

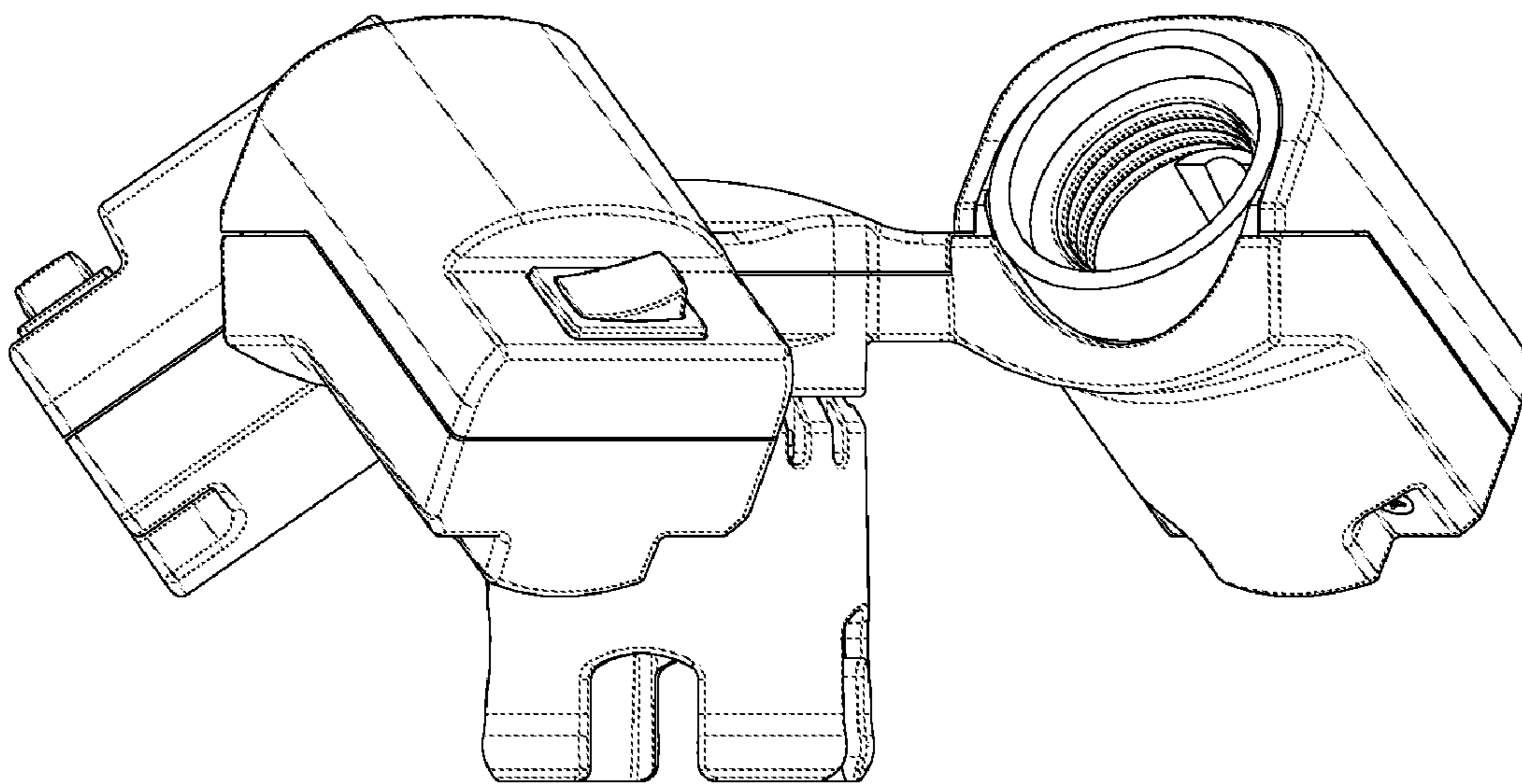

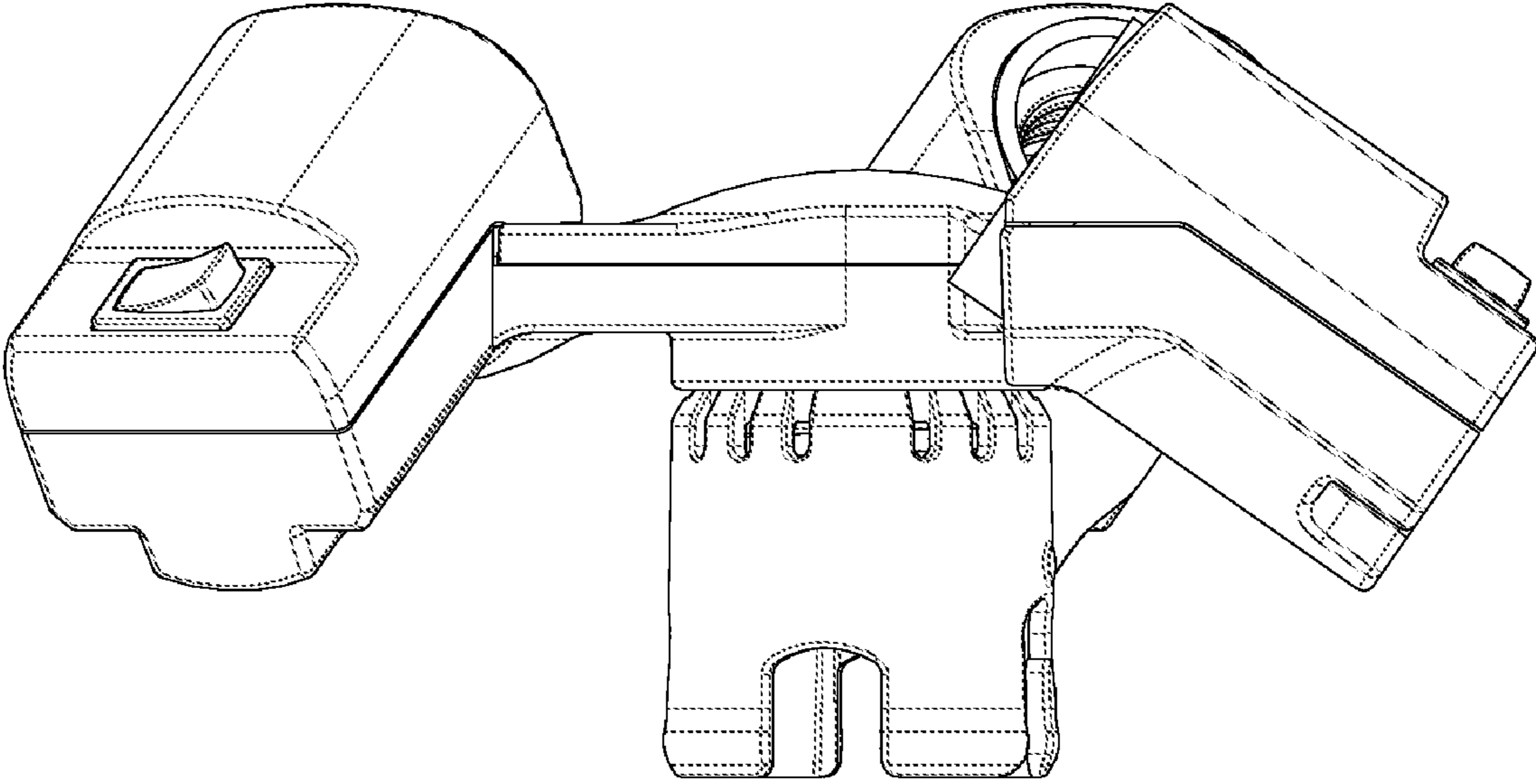

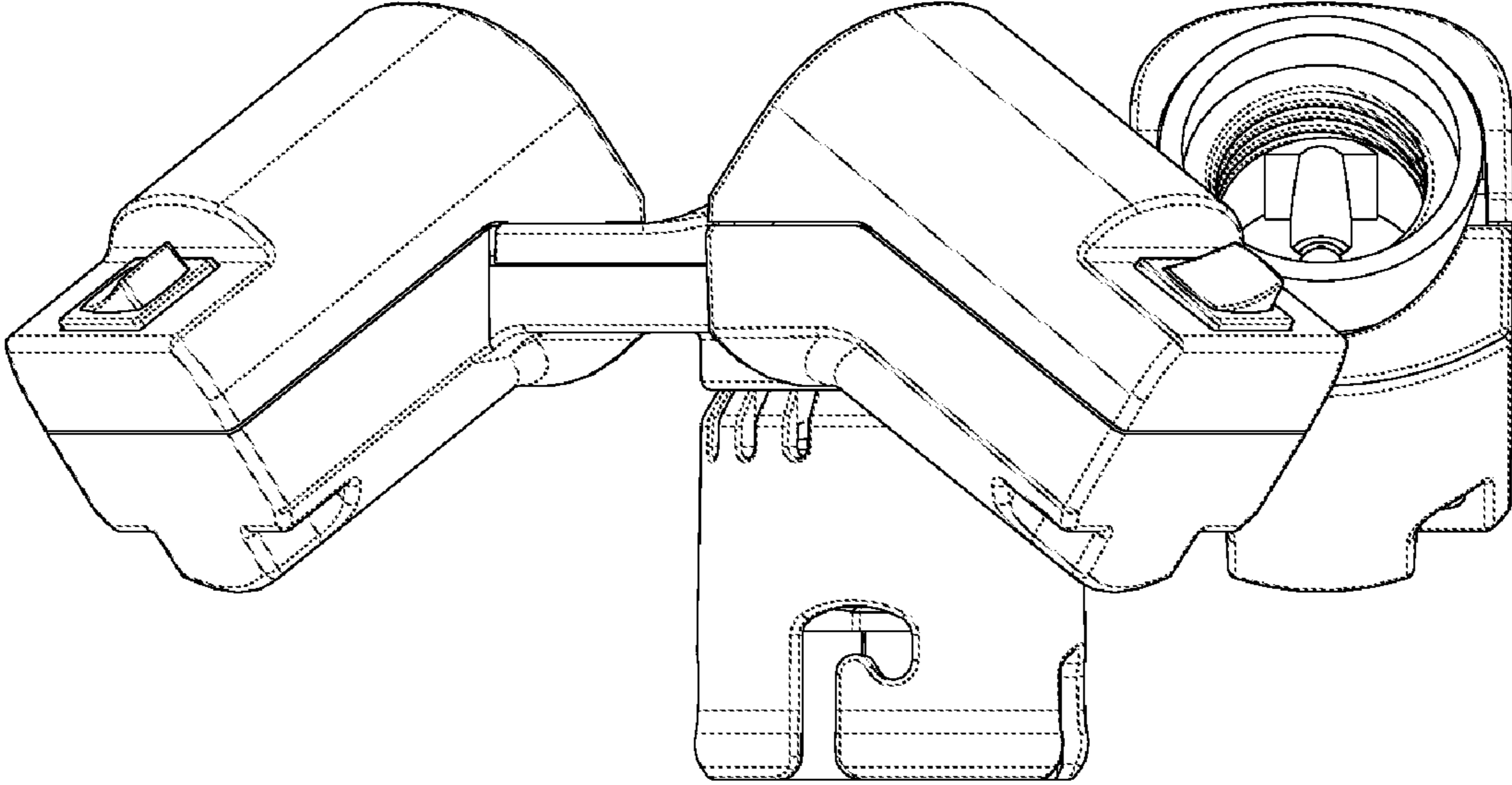

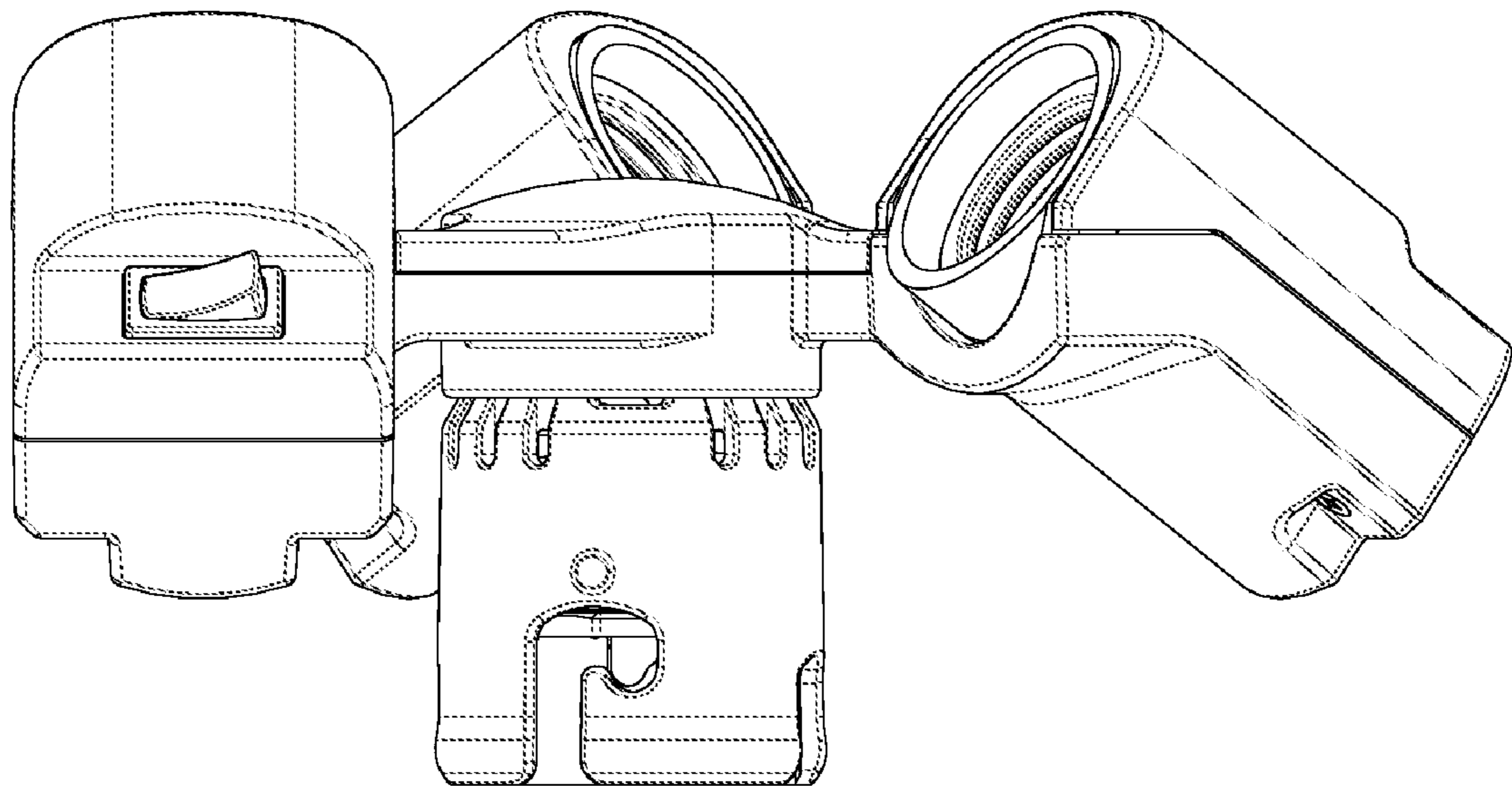

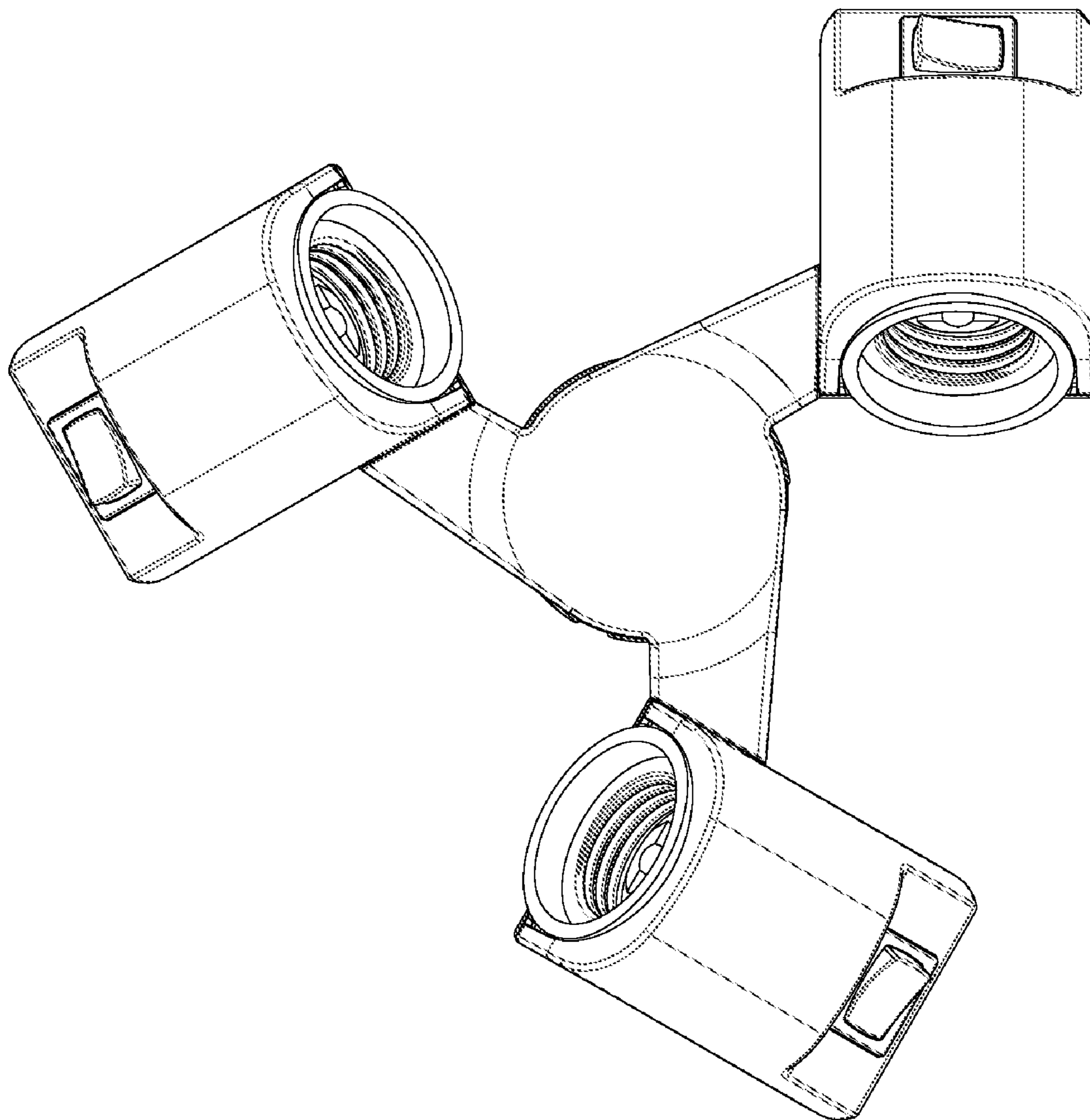

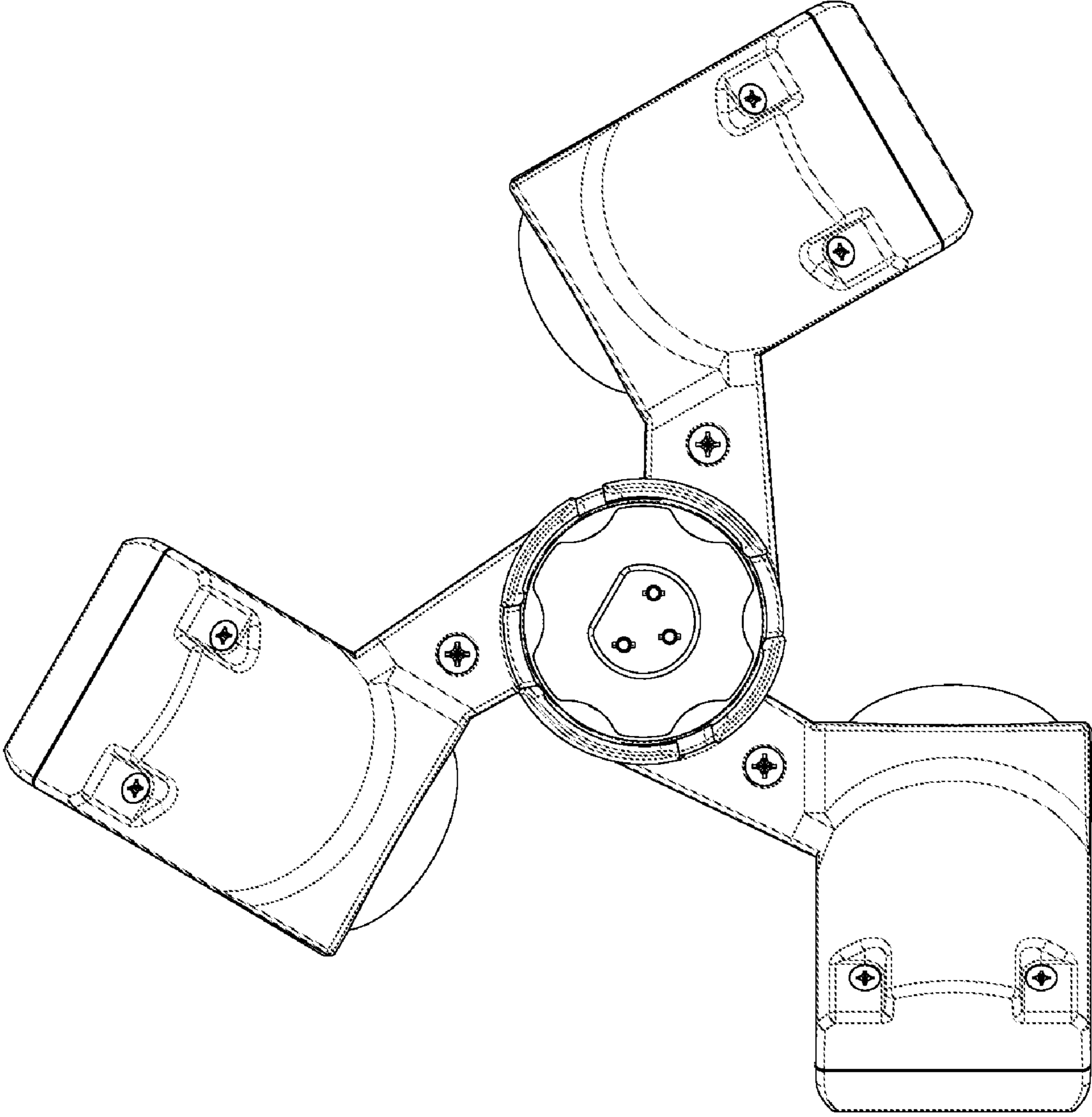
