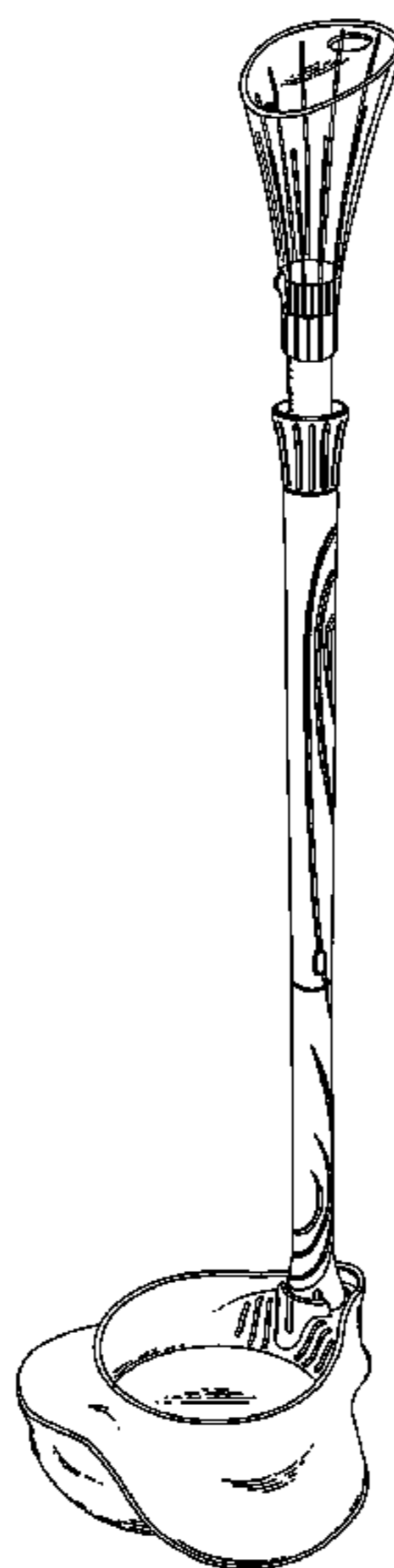
(57) **CLAIM**

I claim the ornamental design for a bowl lifting and filling apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bowl lifting and filling apparatus showing the new design;
FIG. 2 is a rear perspective view of the bowl lifting and filling apparatus showing the new design;
FIG. 3 is a side view of the bowl lifting and filling apparatus.
FIG. 4 is the other side view of the bowl lifting and filling apparatus.
FIG. 5 is a top view of the bowl lifting and filling apparatus.
FIG. 6 is a bottom view of the bowl lifting and filling apparatus.
FIG. 7 is an enlargement for clarity, in perspective, of the top end fluid intake portion of the bowl lifting and filling apparatus;
FIG. 8 is an enlargement for clarity, in perspective, of the elevator section of the bowl lifting and filling apparatus;
FIG. 9 is another enlargement for clarity, in perspective, of the elevator section of the bowl lifting and filling apparatus; and,
FIG. 10 is an enlargement for clarity, in perspective, of the bowl section of the bowl lifting and filling apparatus.

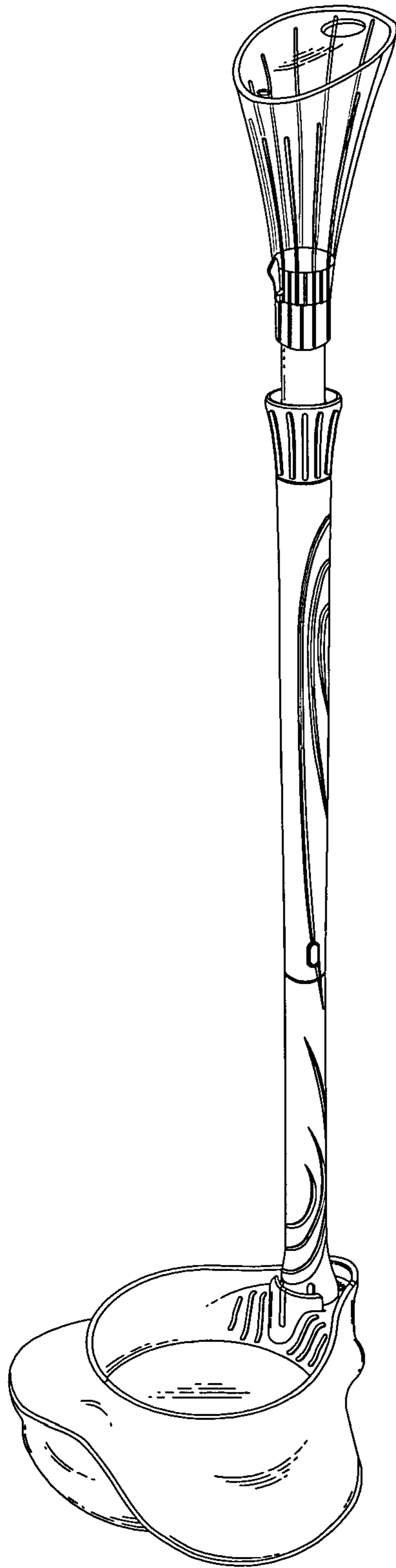

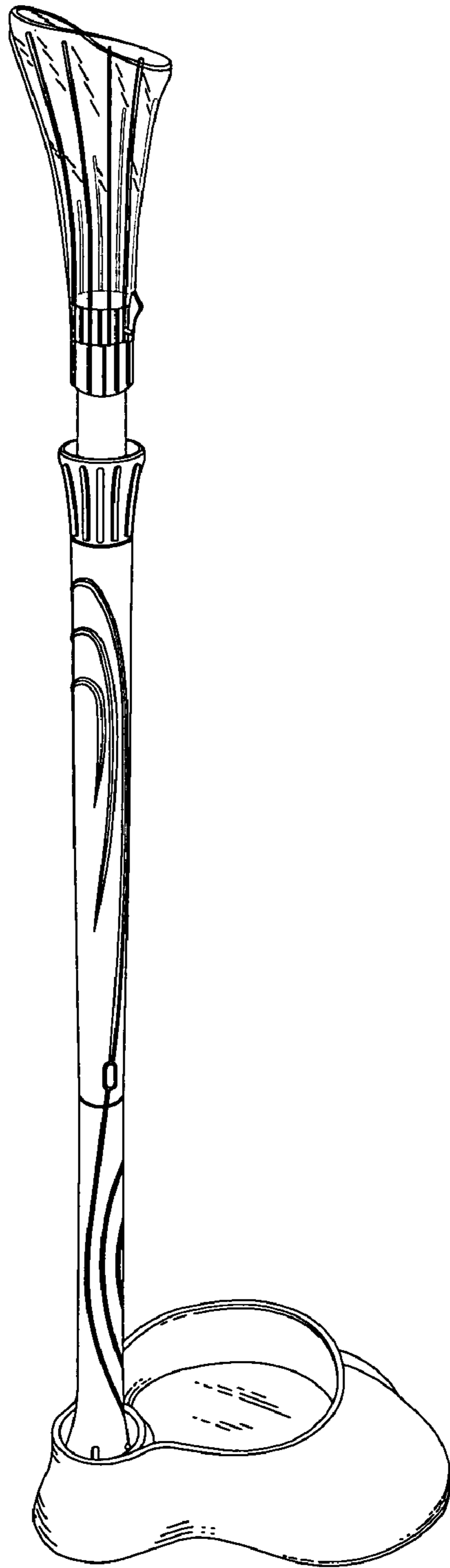

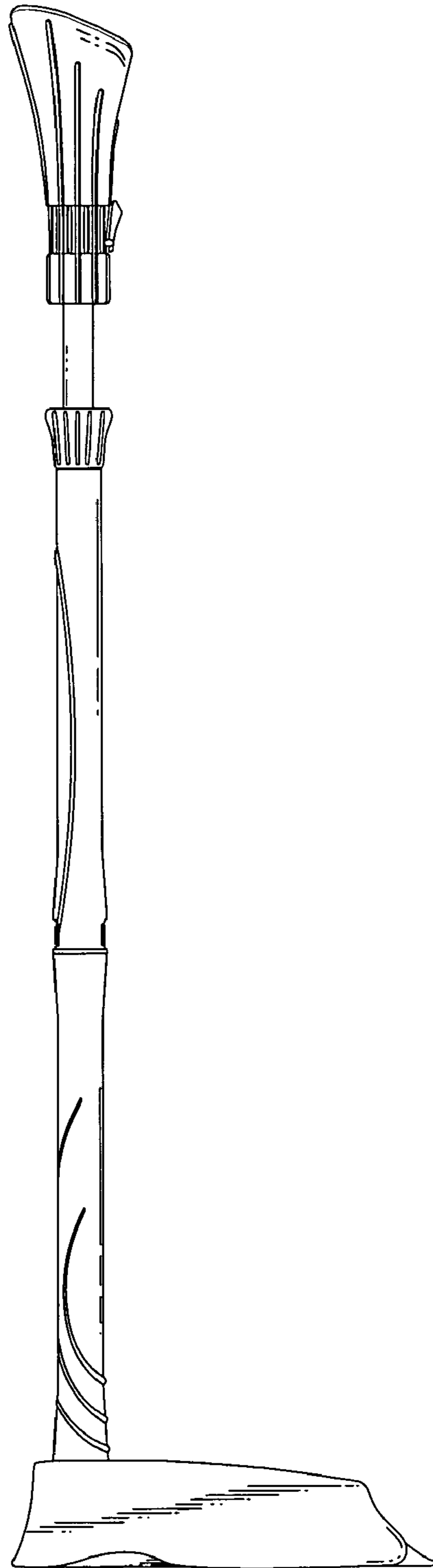

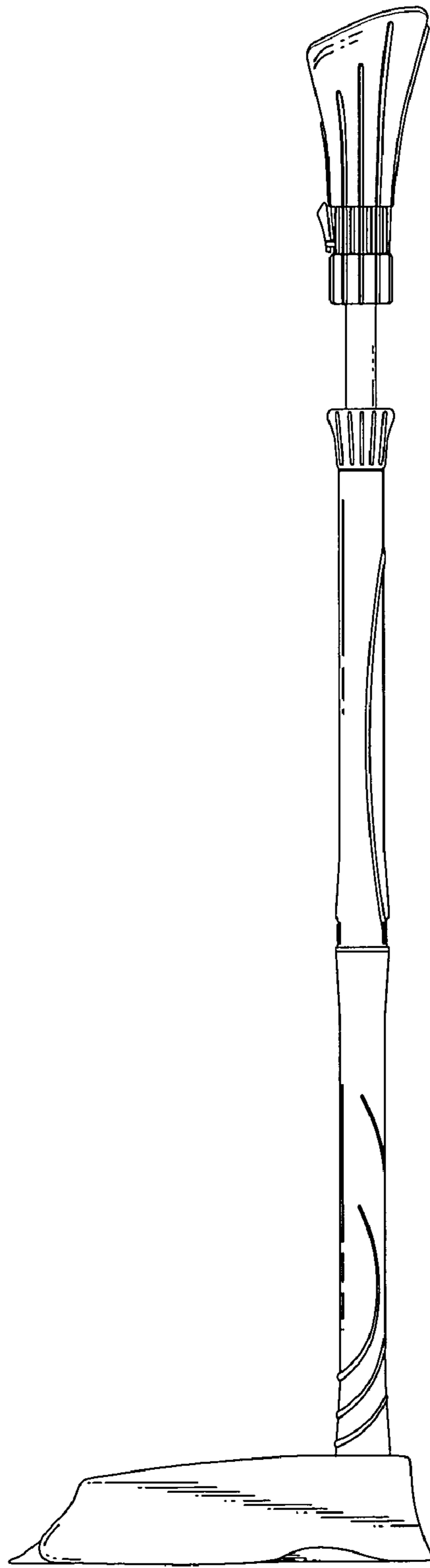

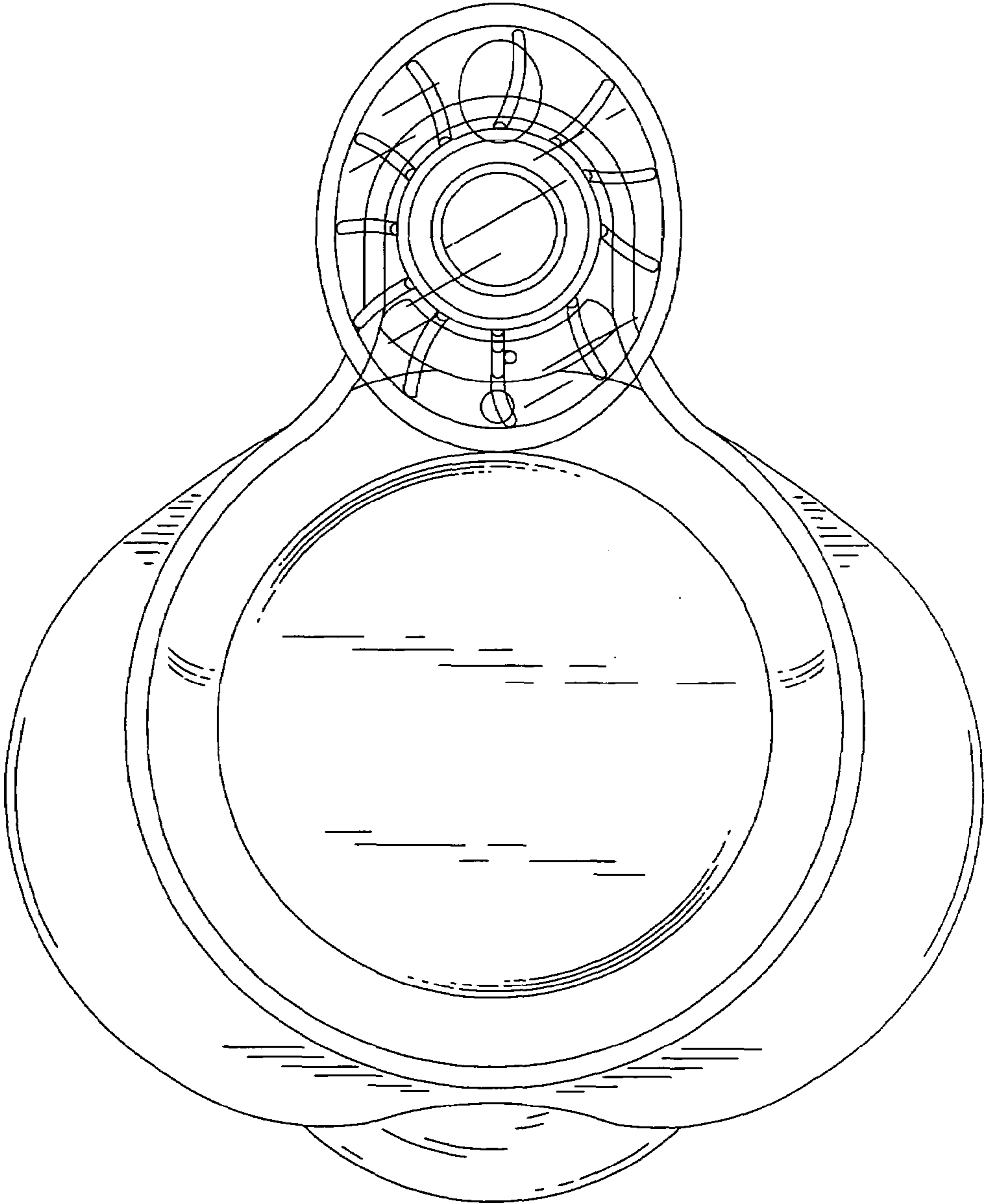

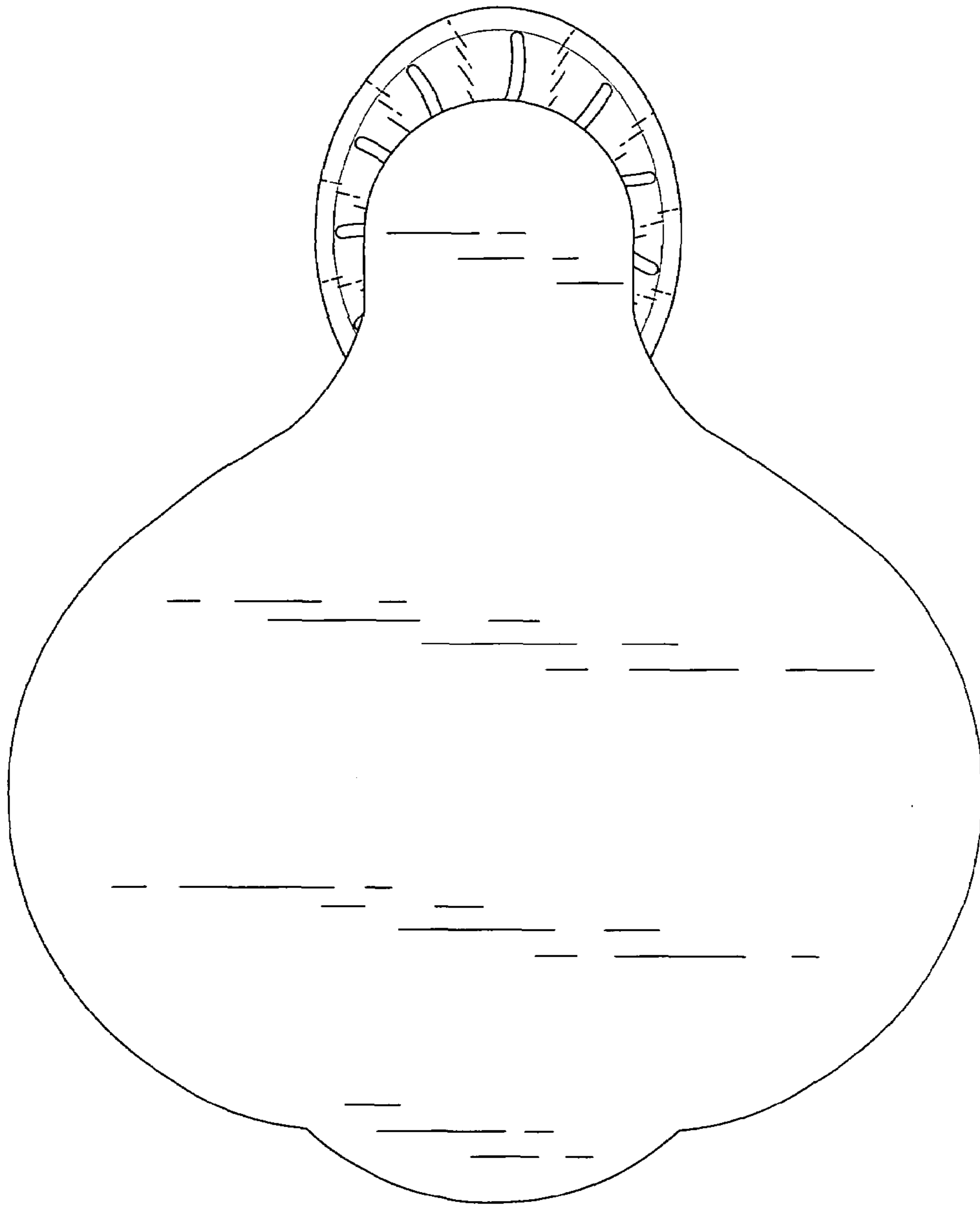

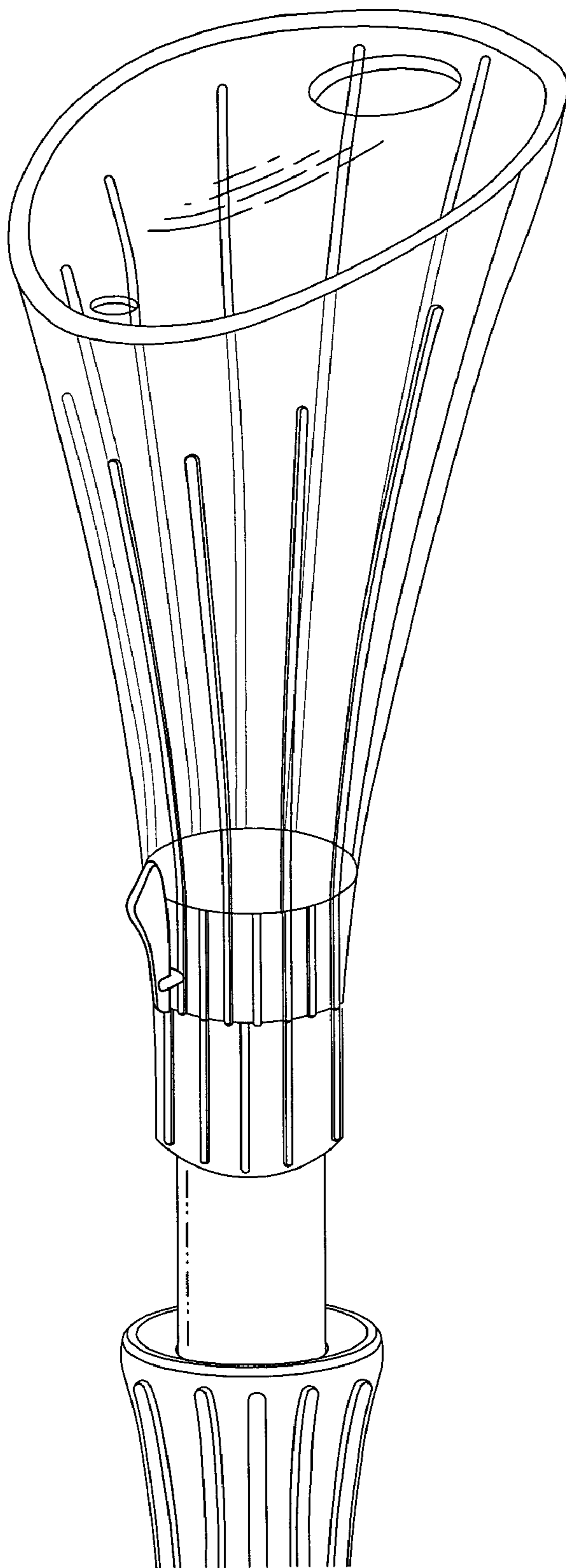

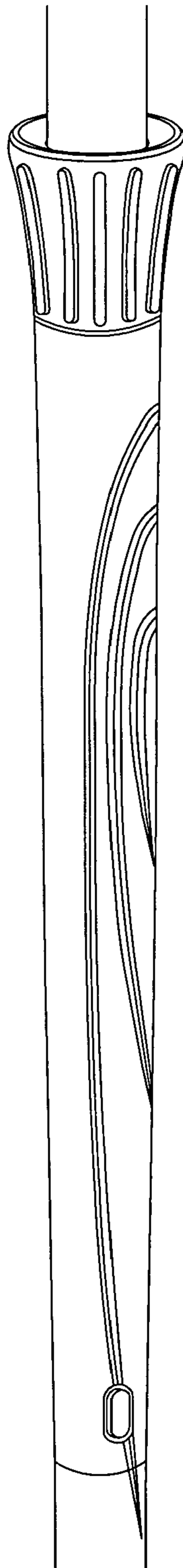

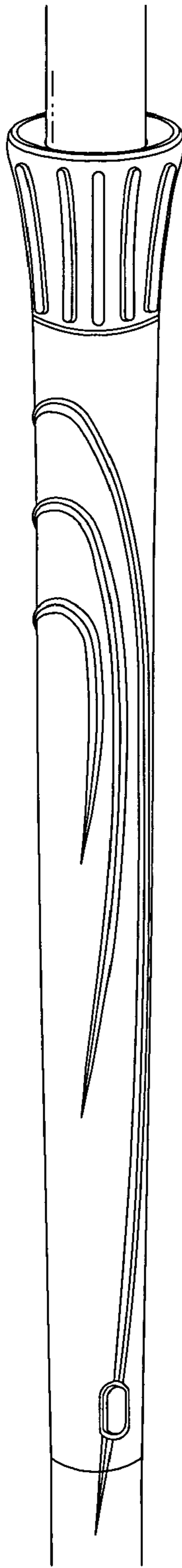

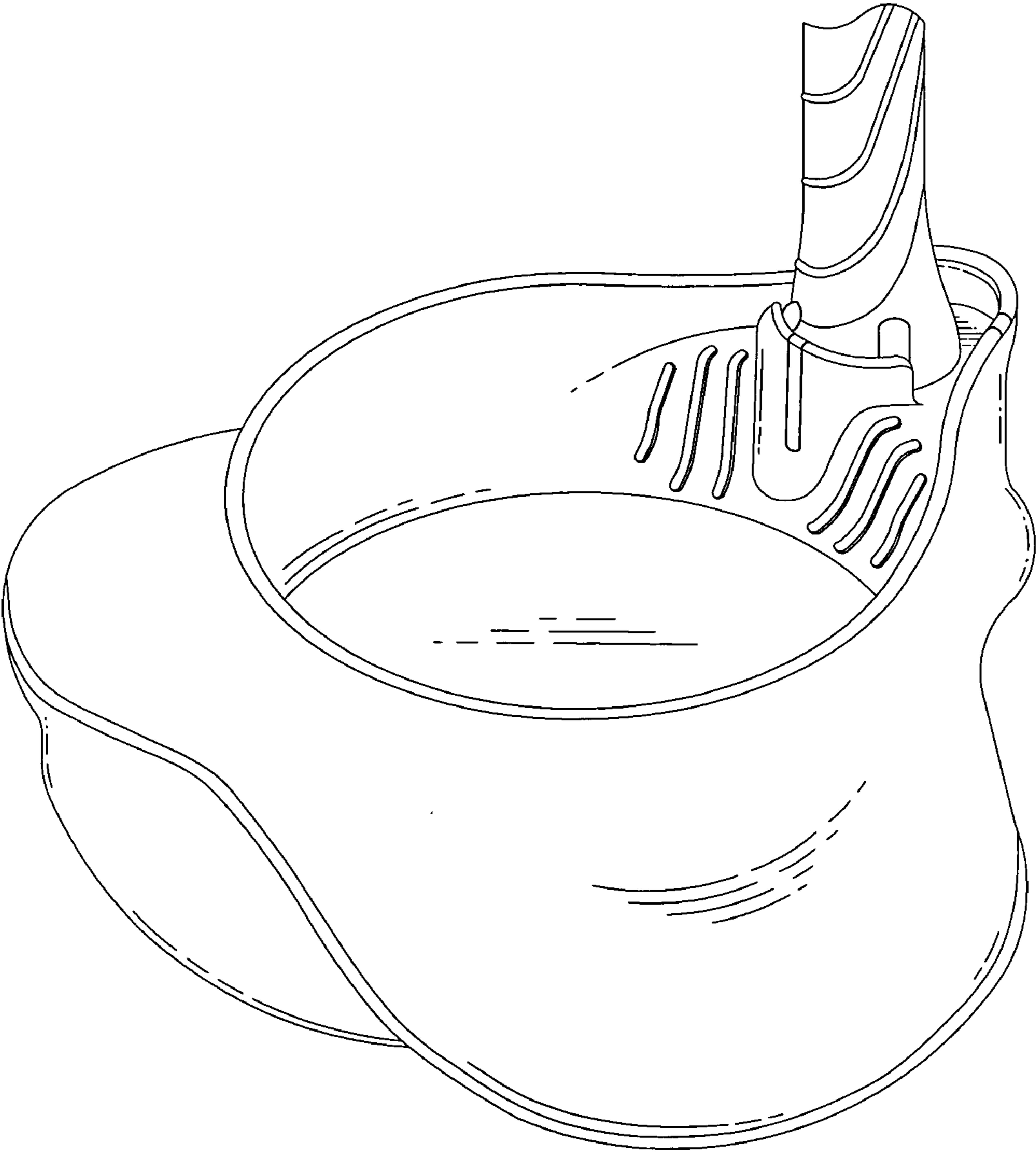
