The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a lateral side view of a shoe upper showing my new design;

FIG. 2 is a medial side view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof; and,

FIG. 6 is a front perspective view thereof.

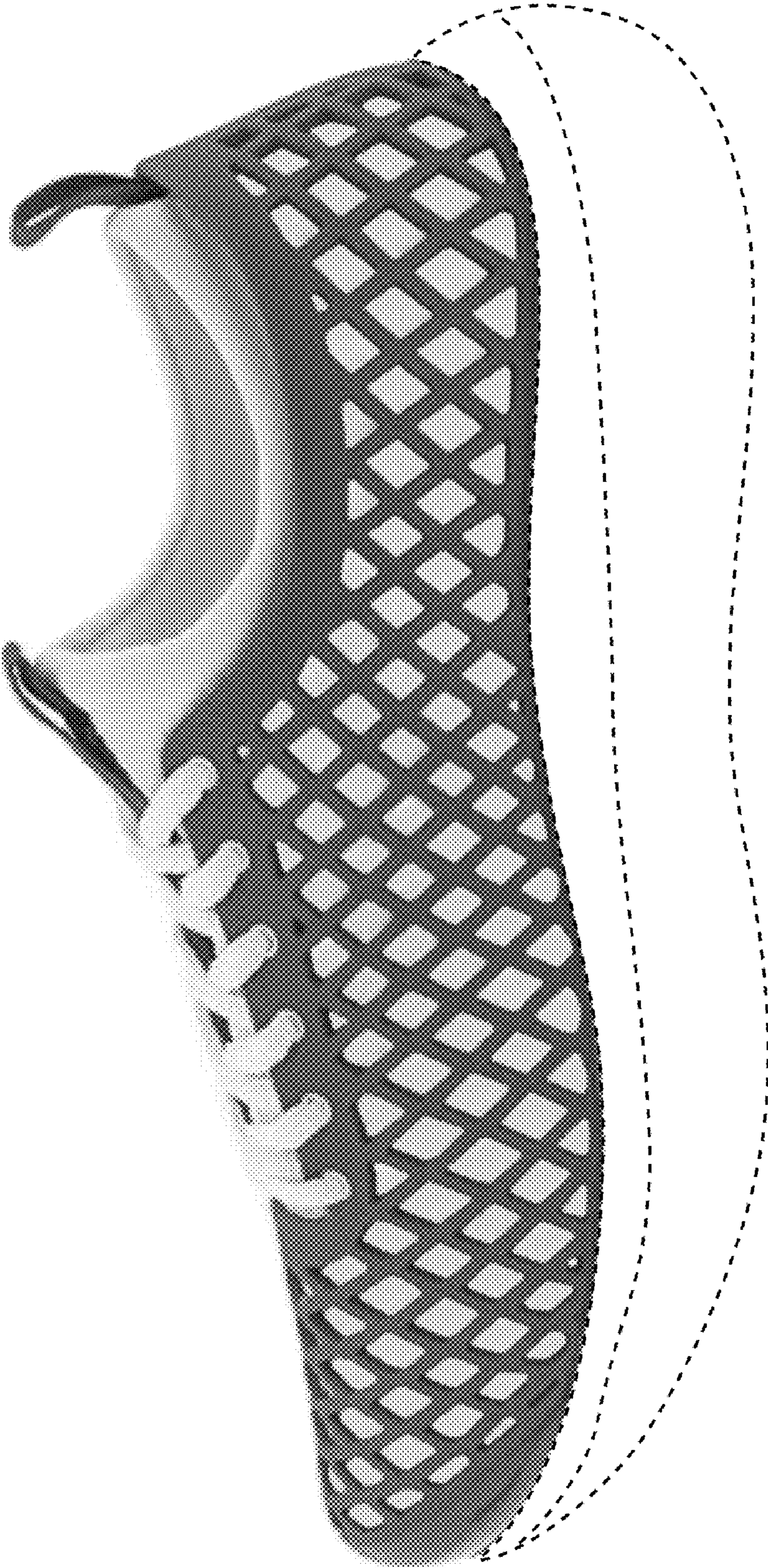

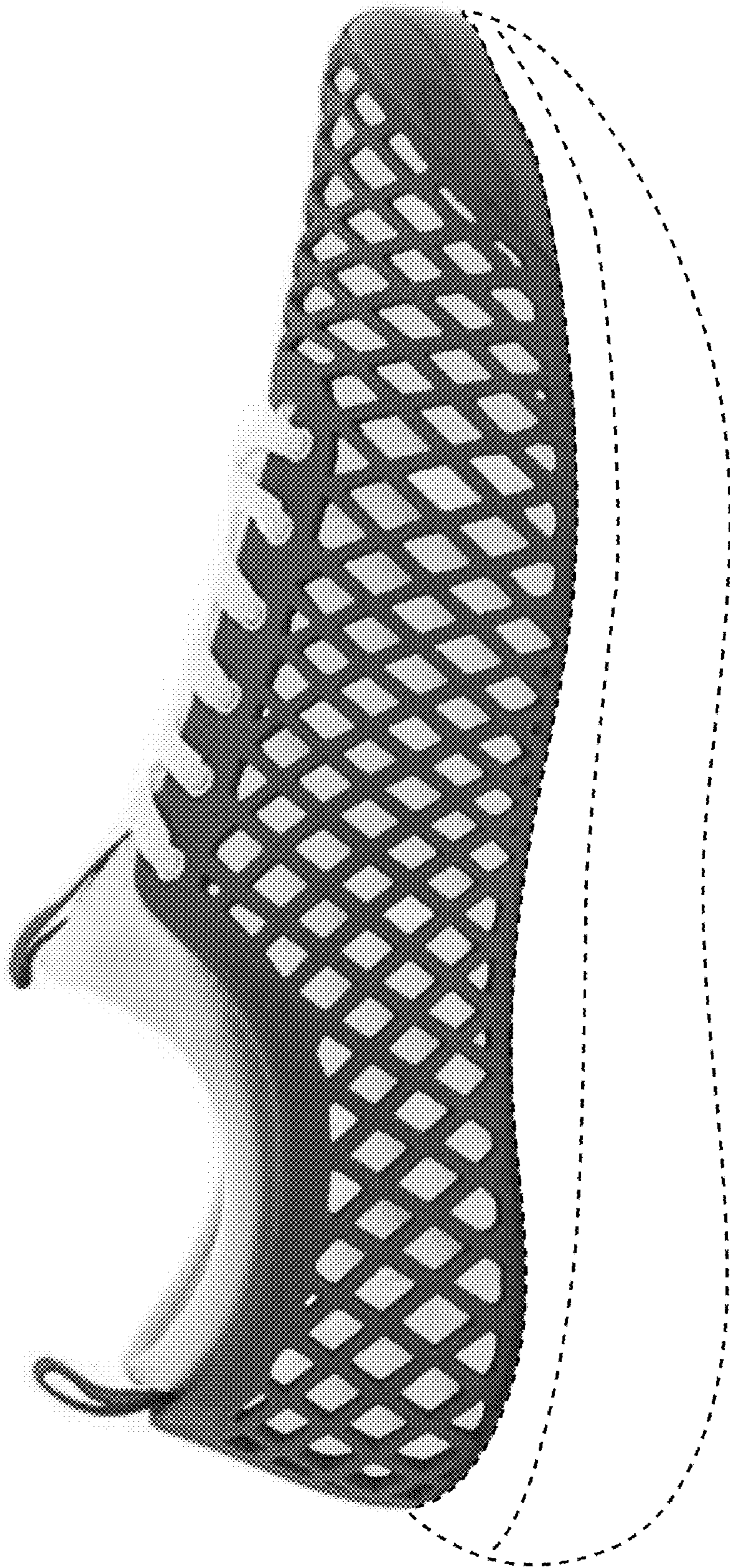

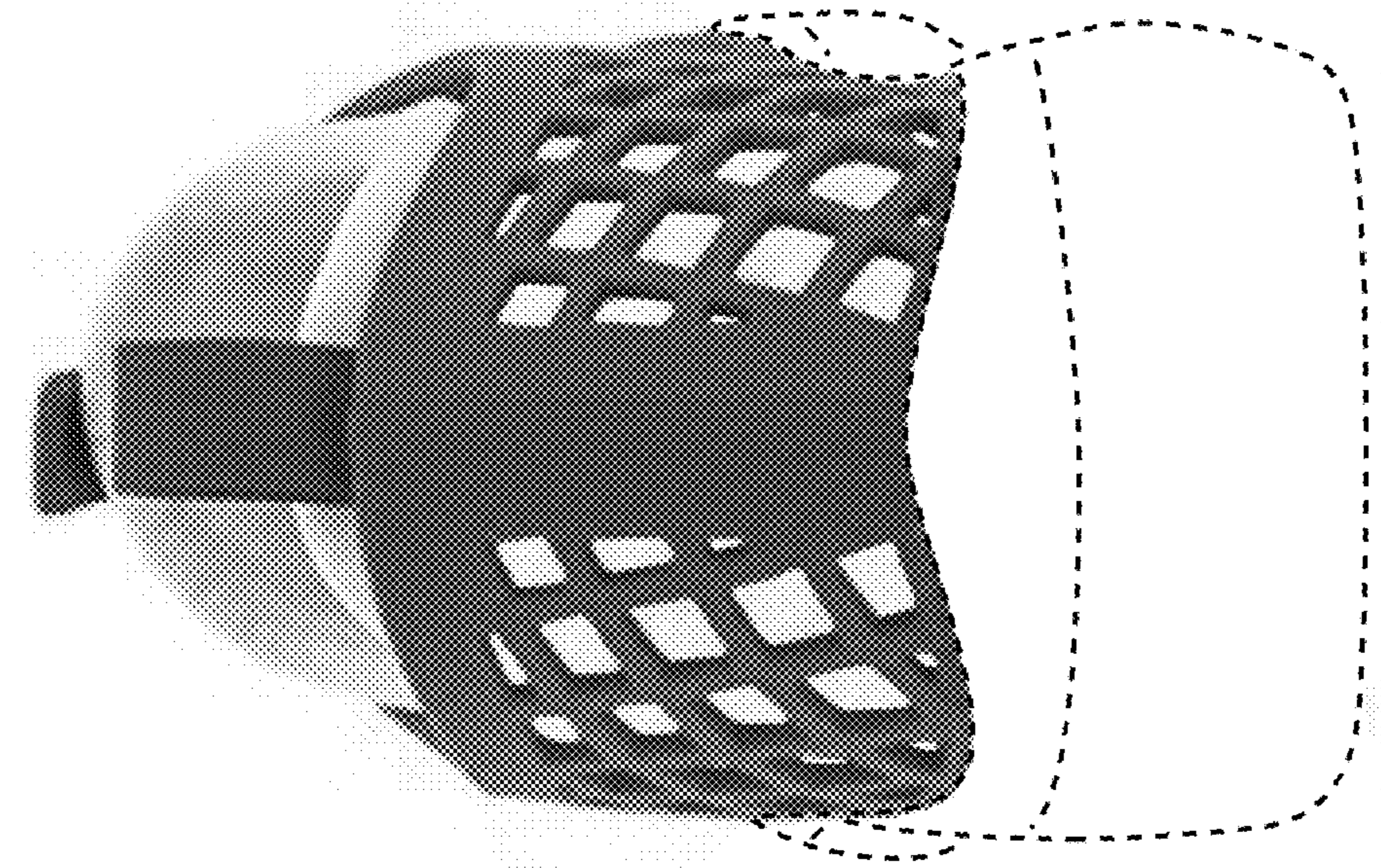

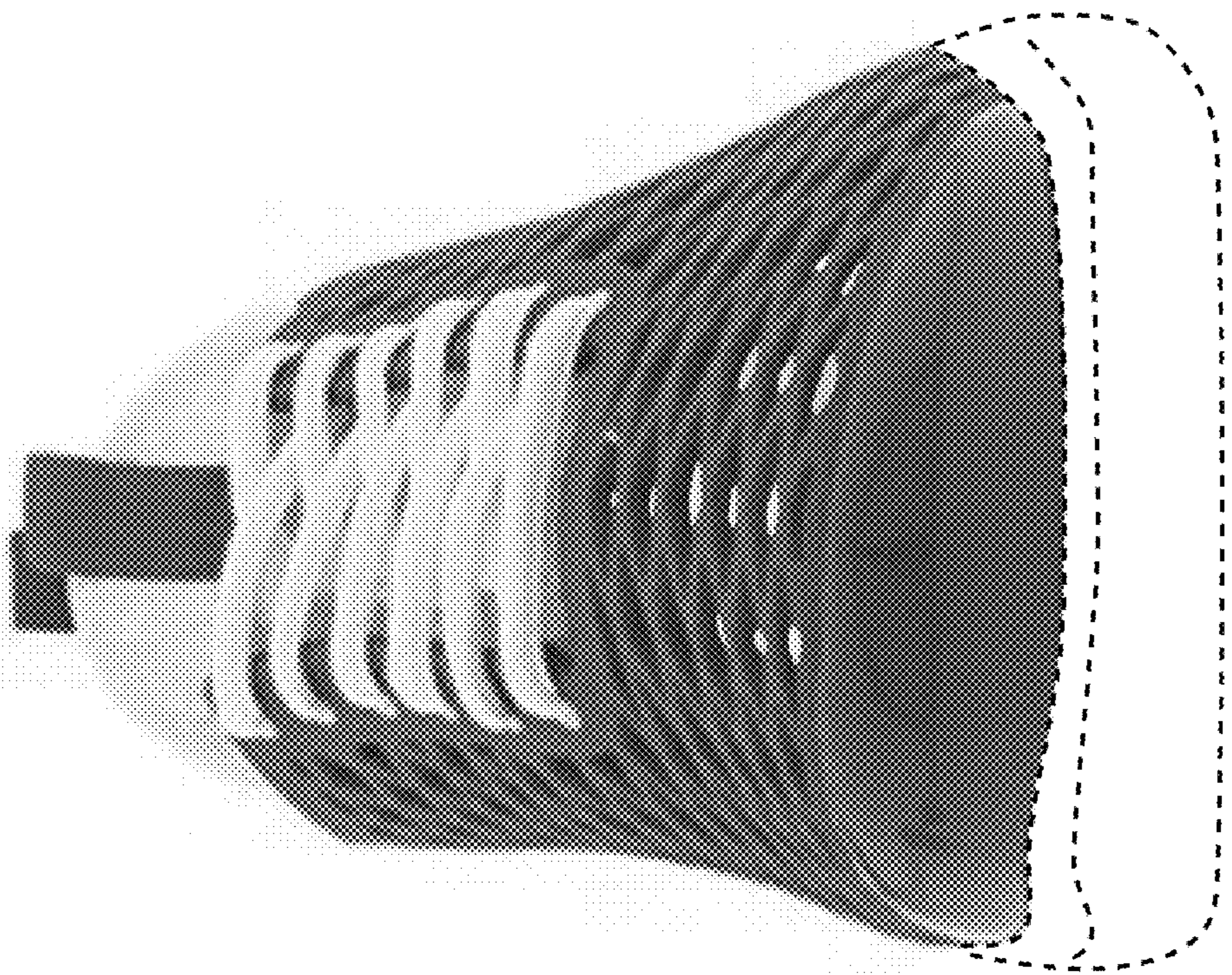
