DESCRIPTION

FIG. 6 is a perspective view of a stacking basket in stackable configuration;

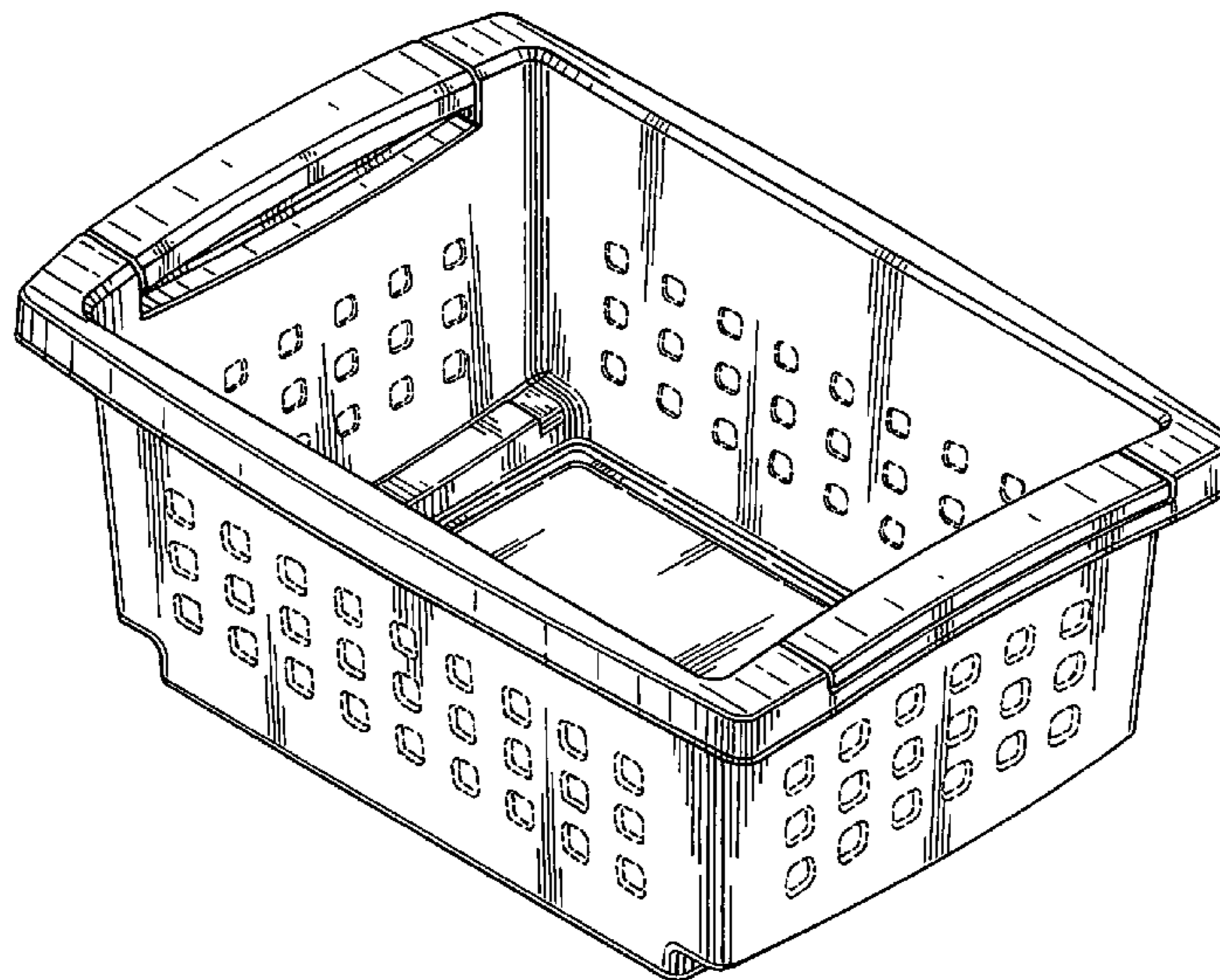
FIG. 7 is a front view of the basket of FIG. 6;

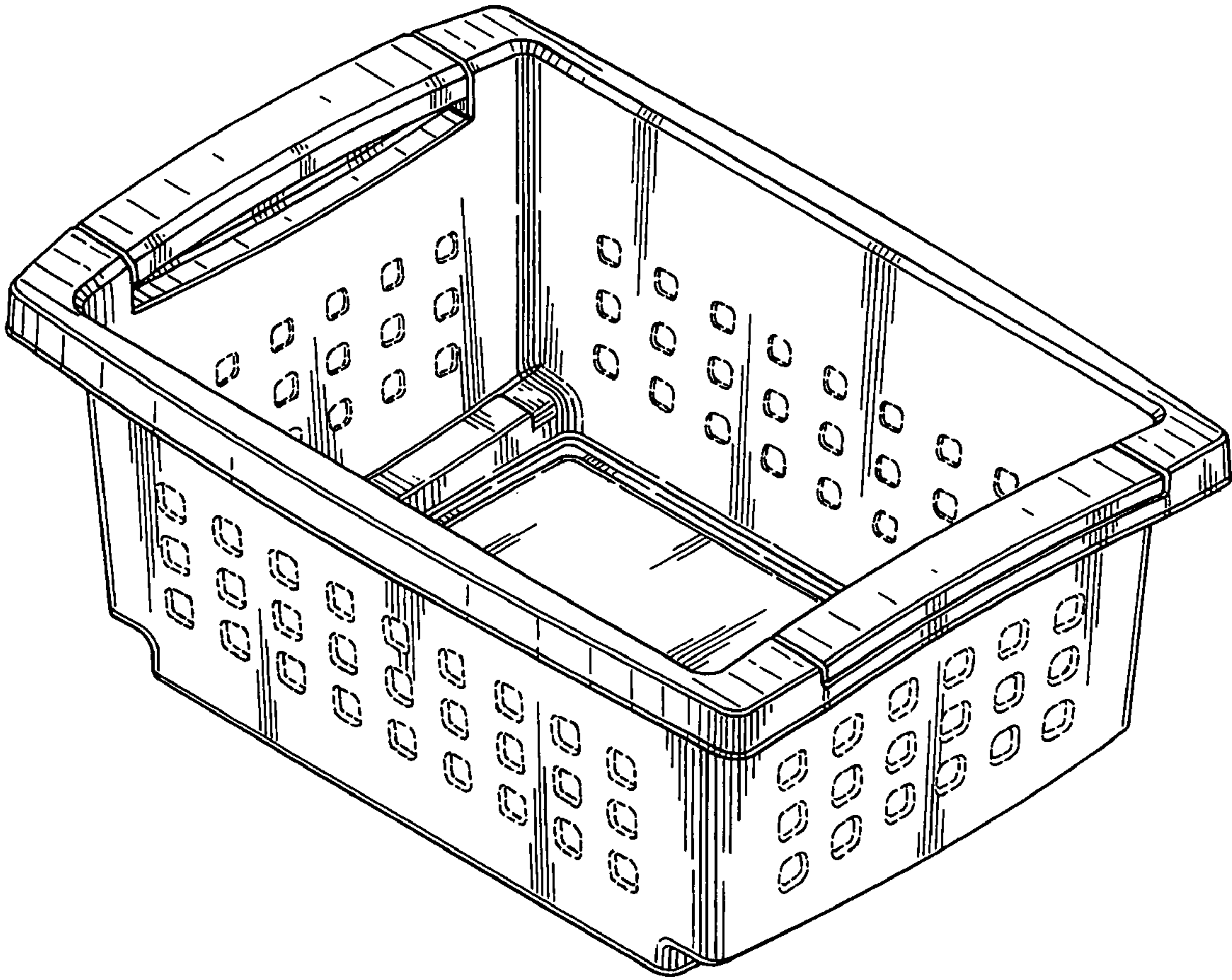

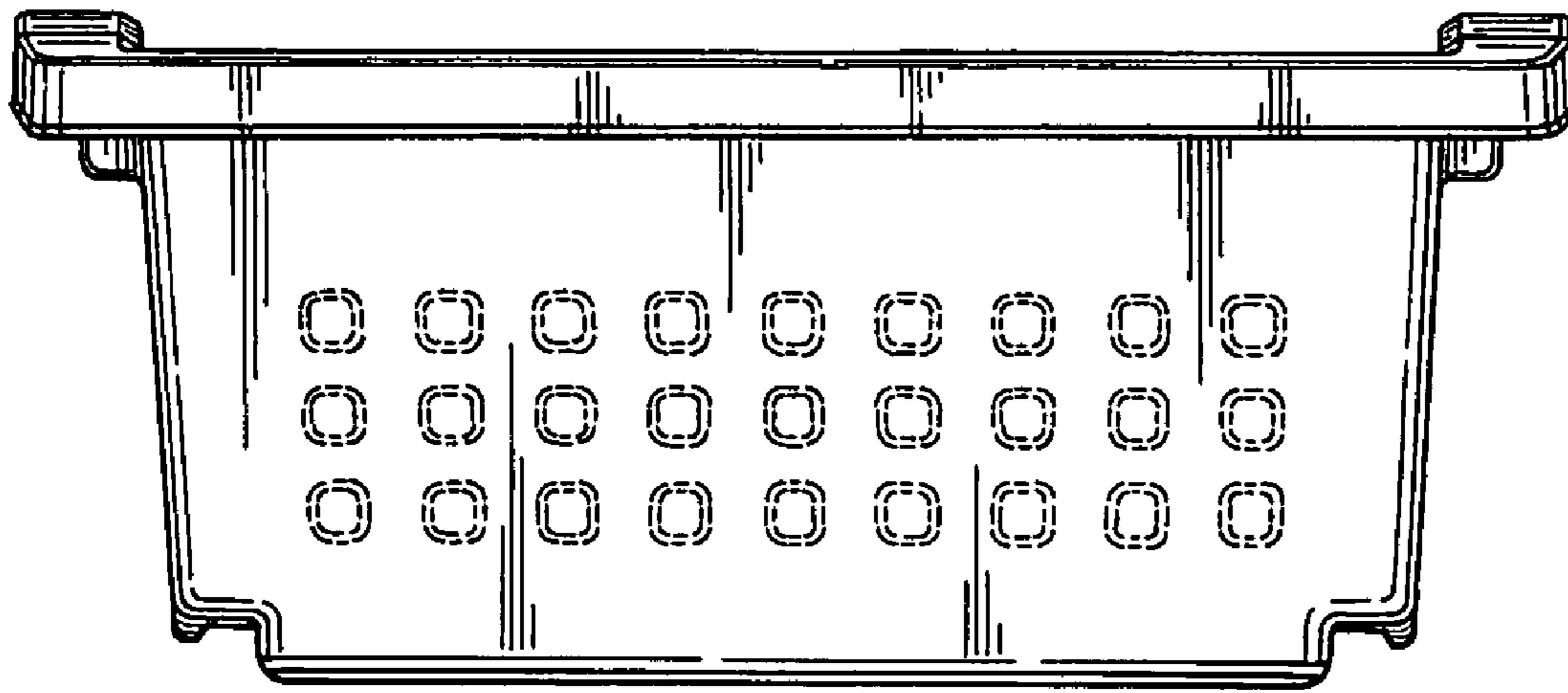

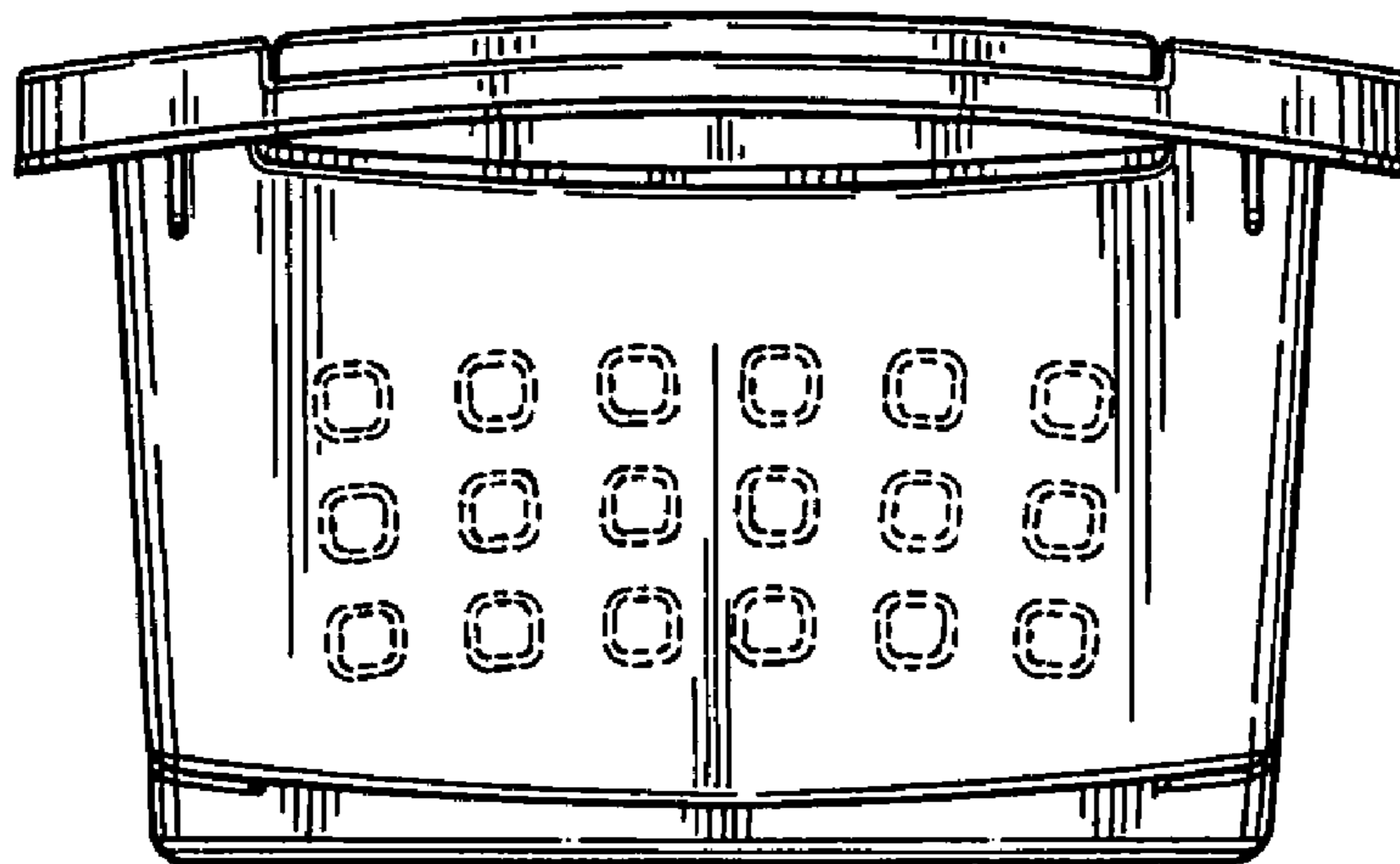

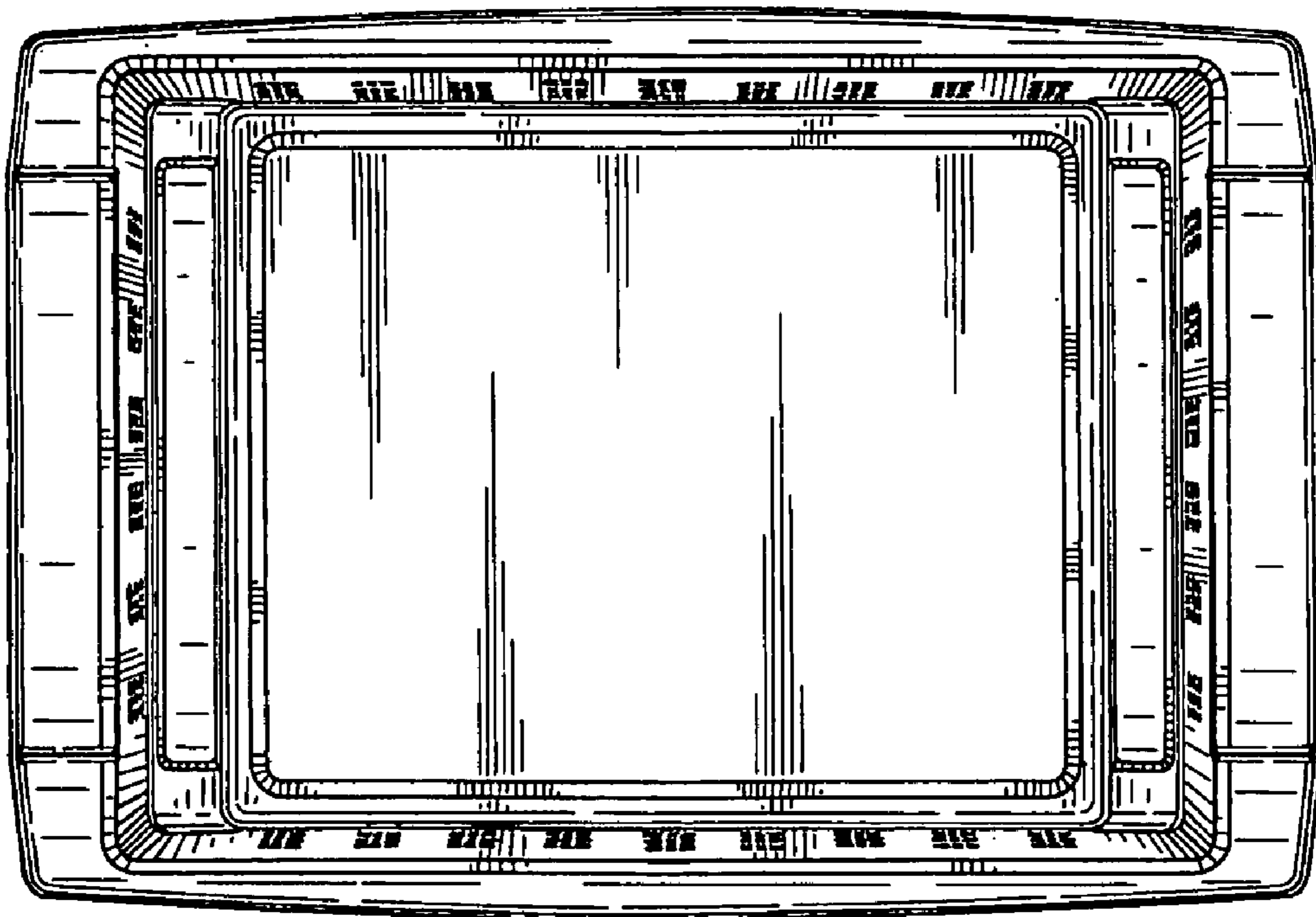

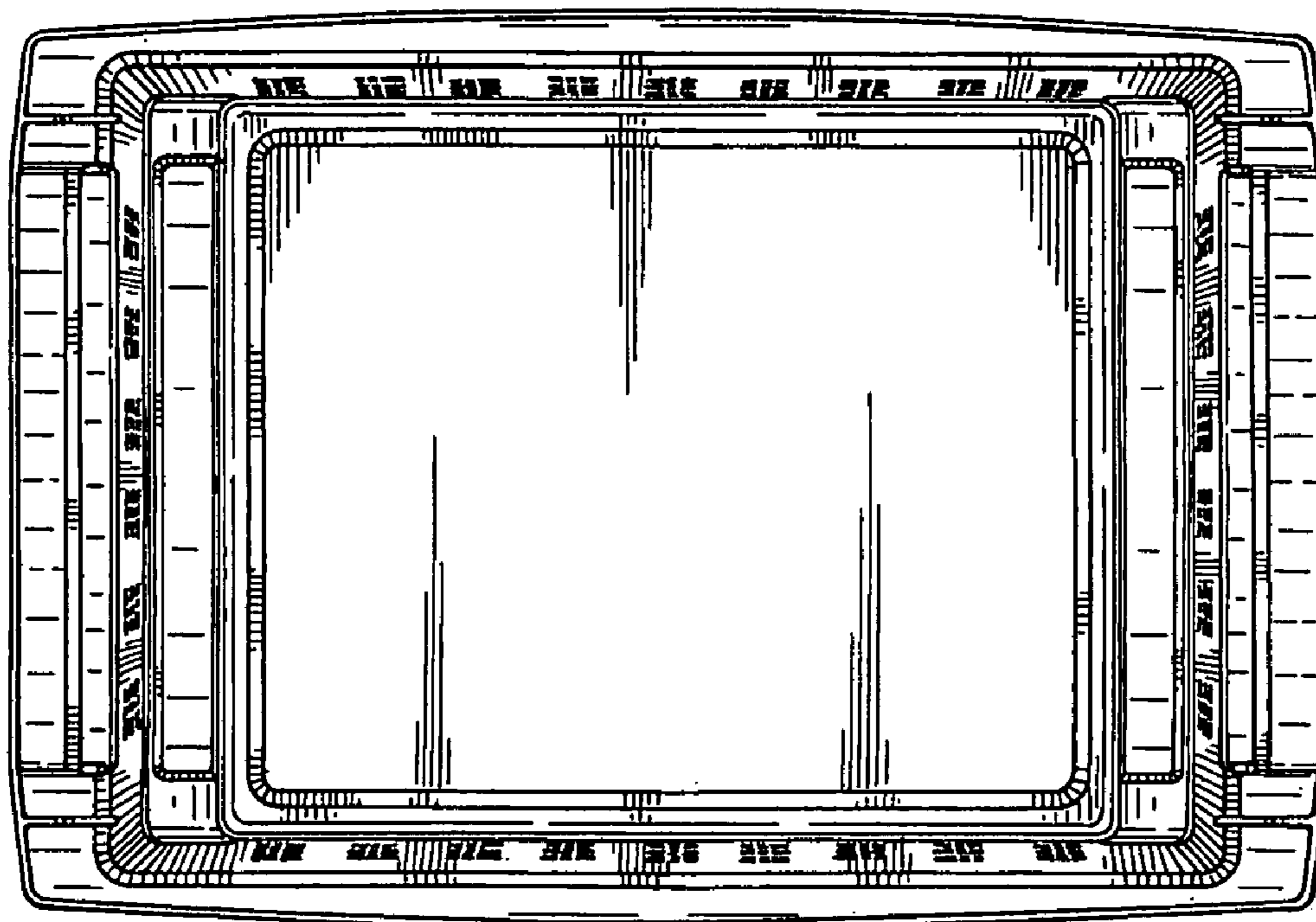

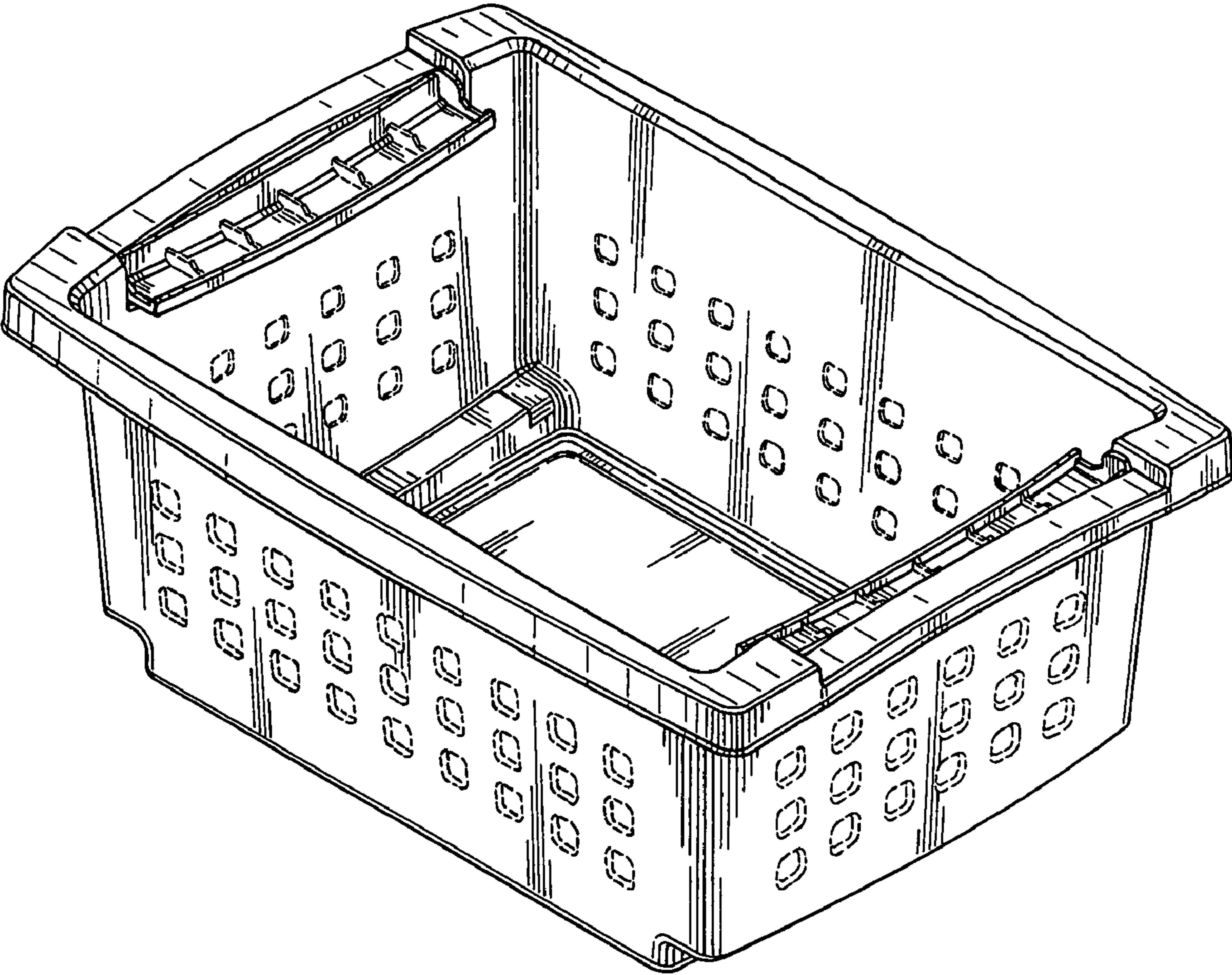

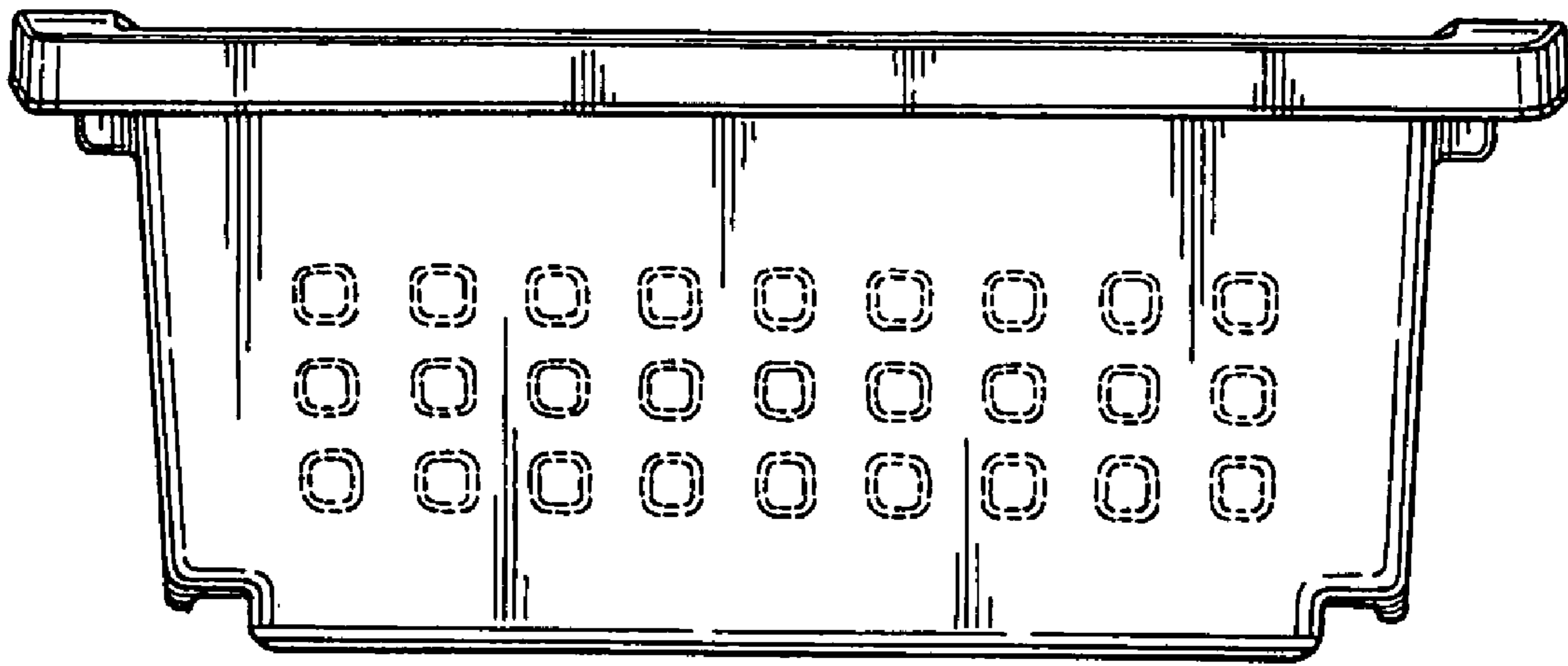

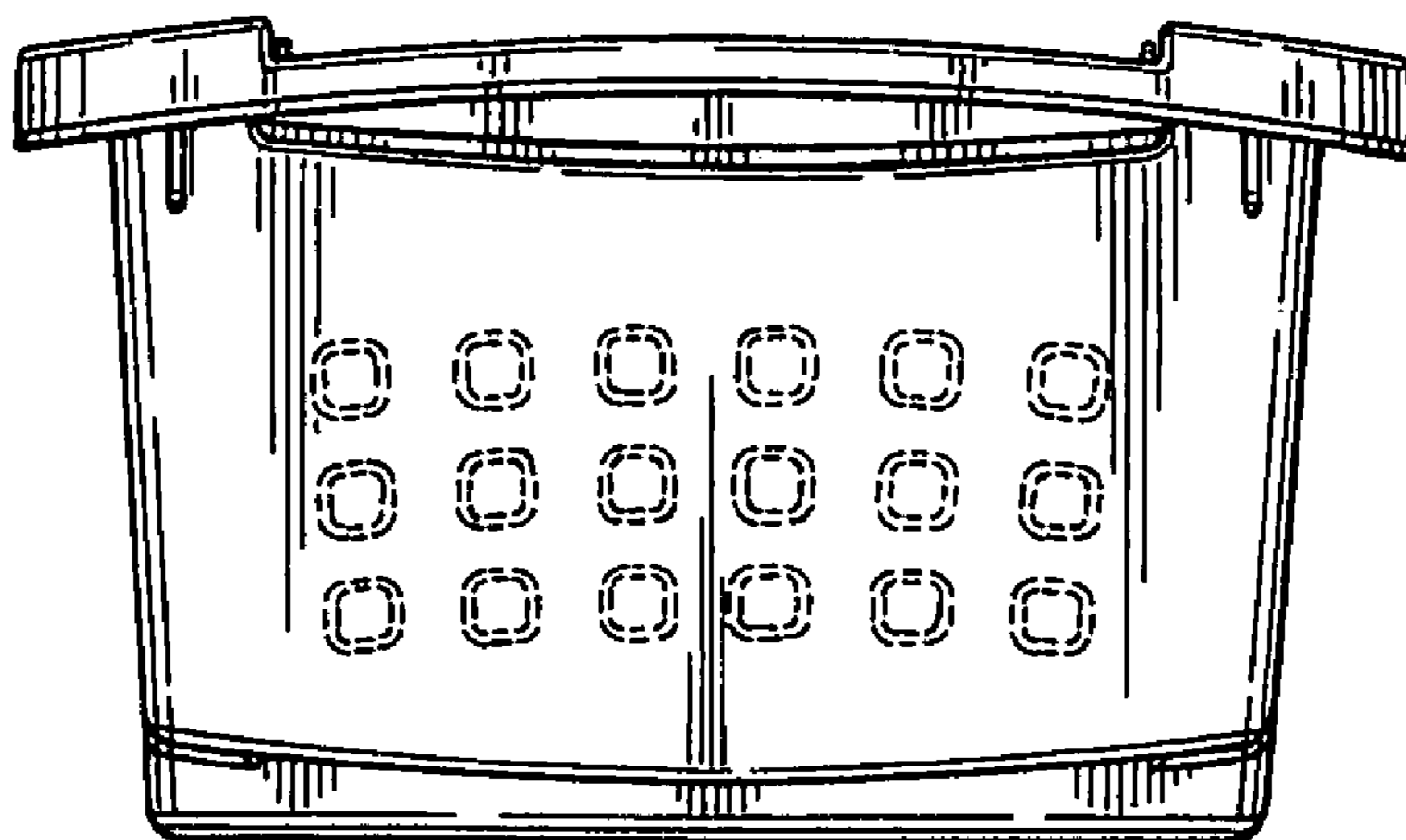

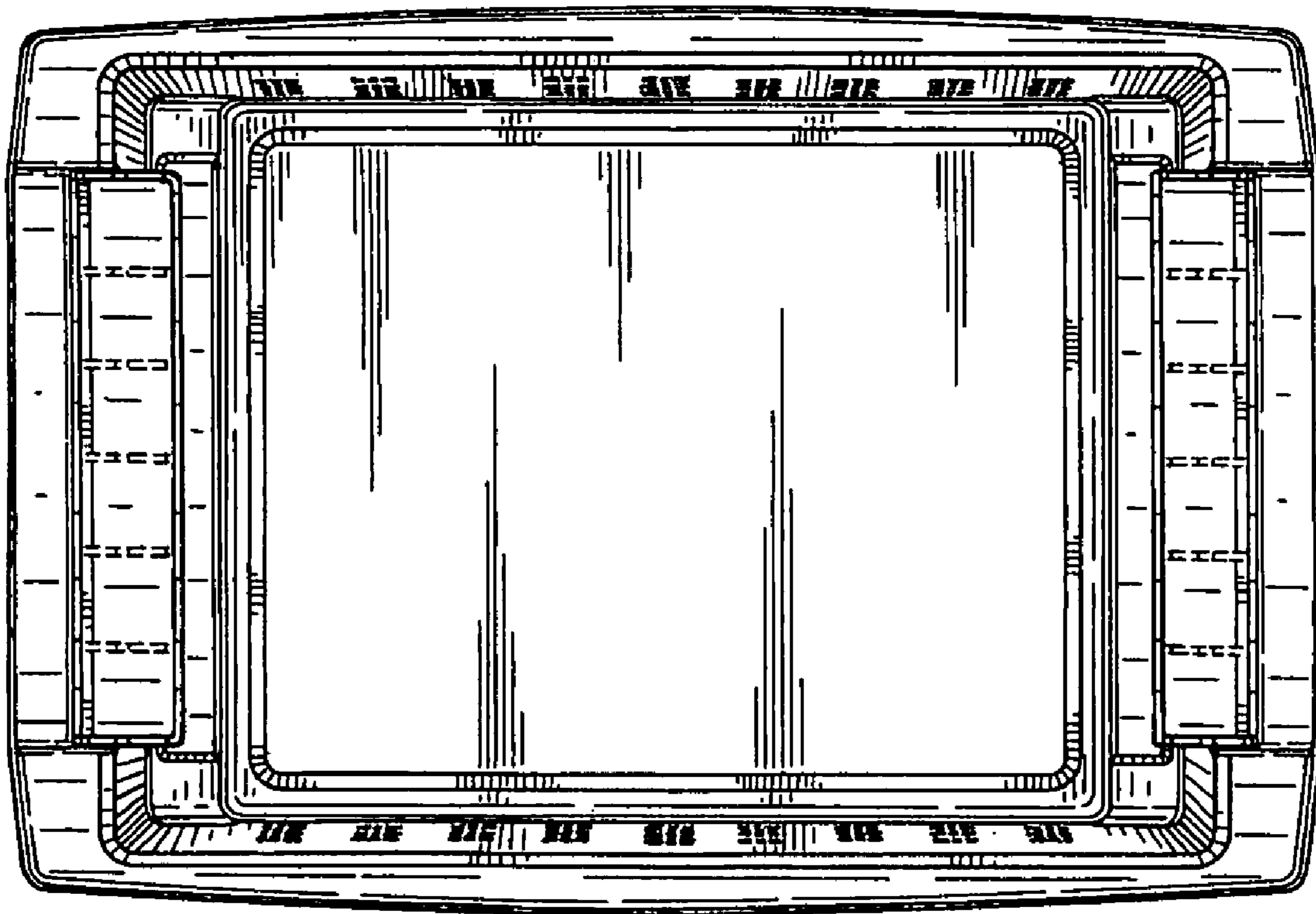
