The ornamental design for a vehicle seat, as shown and described.

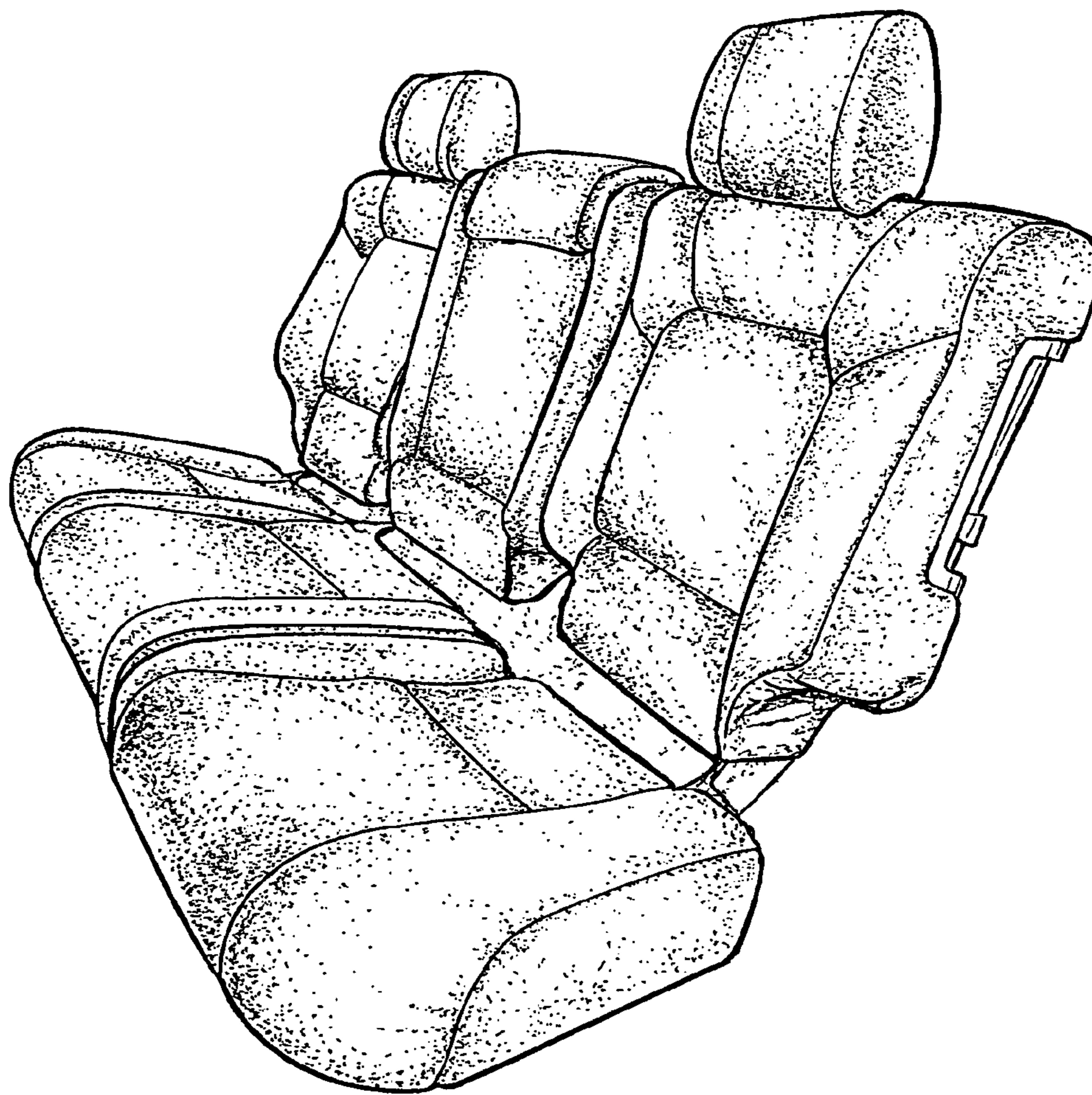
DESCRIPTION

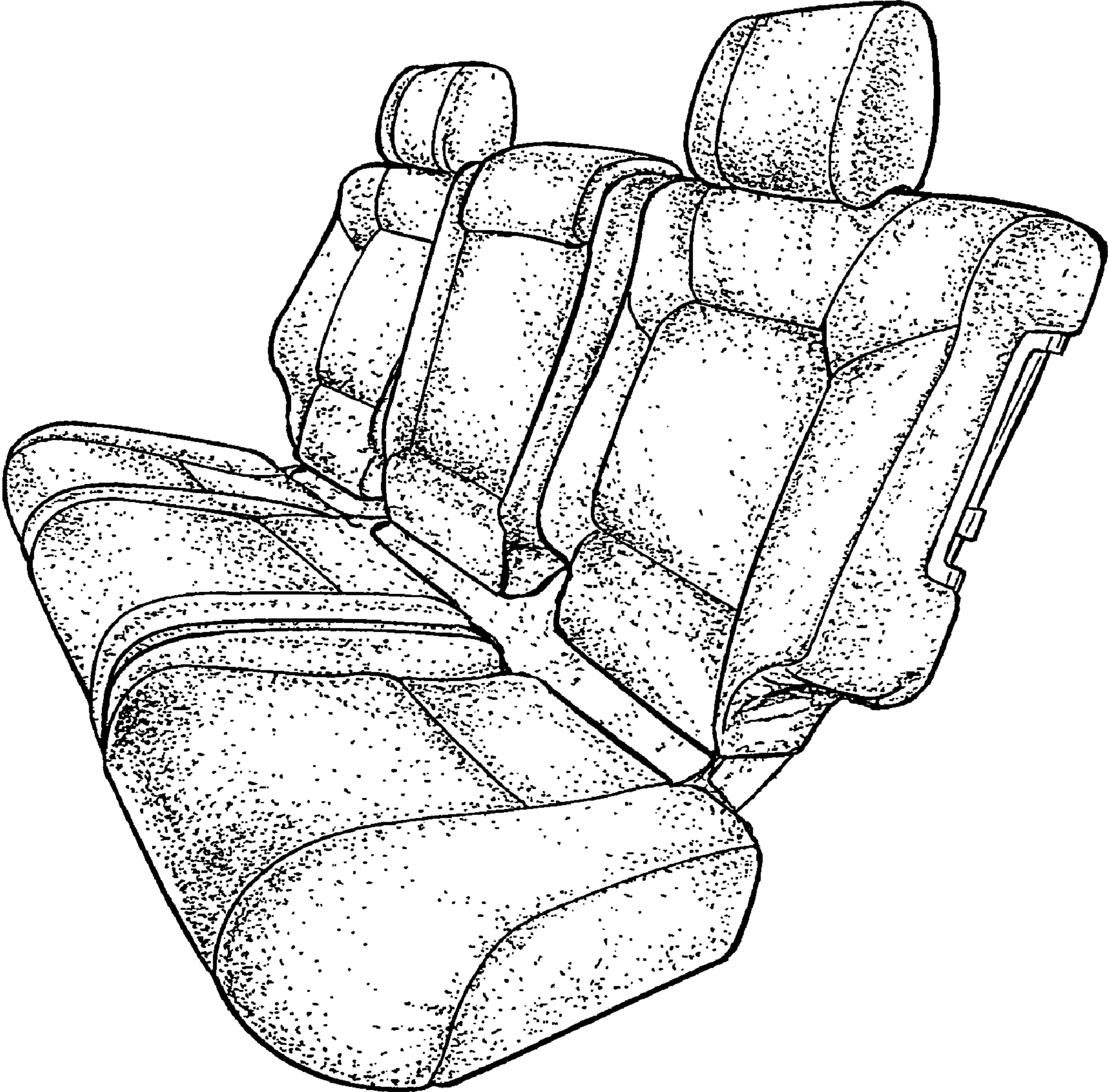

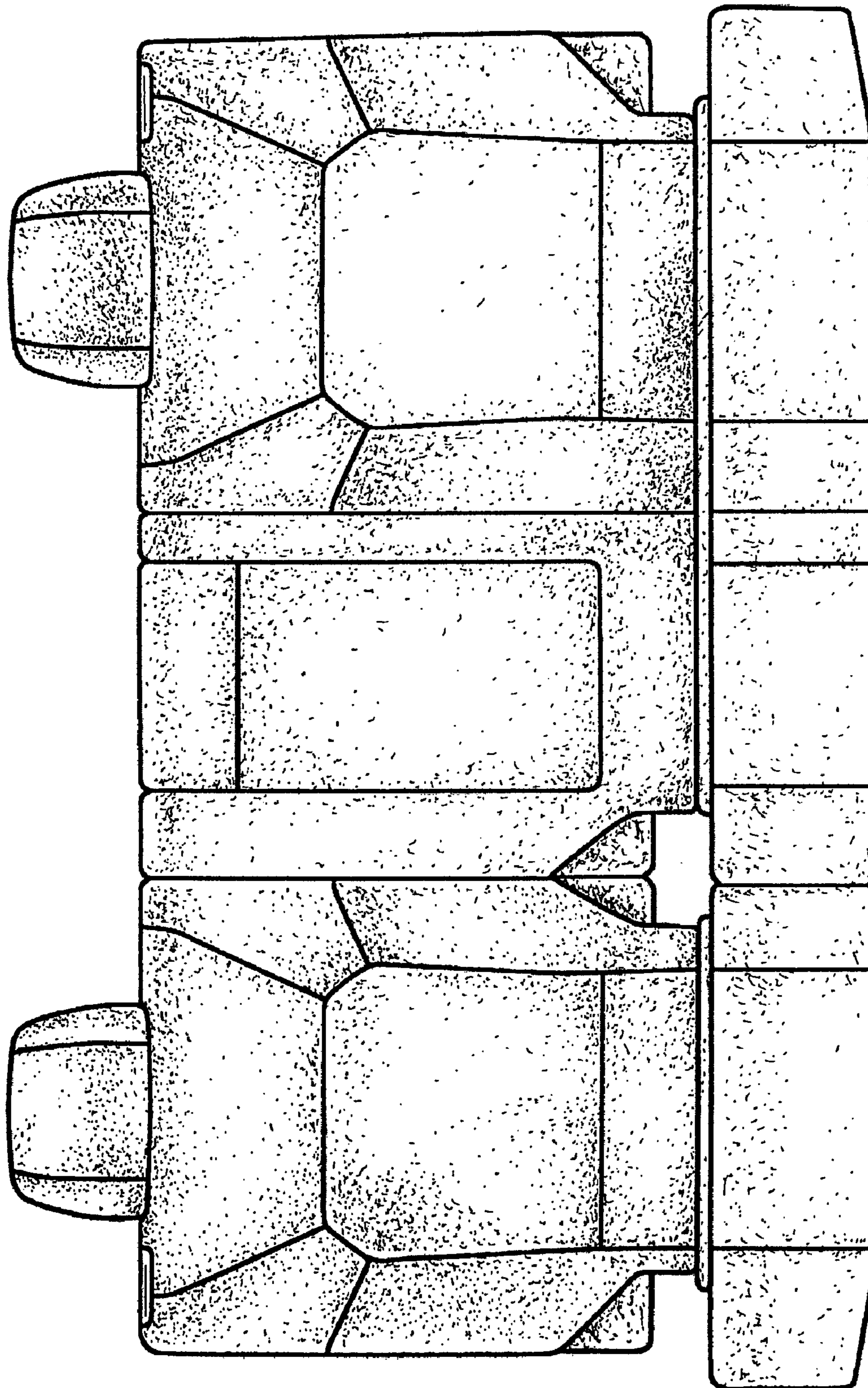

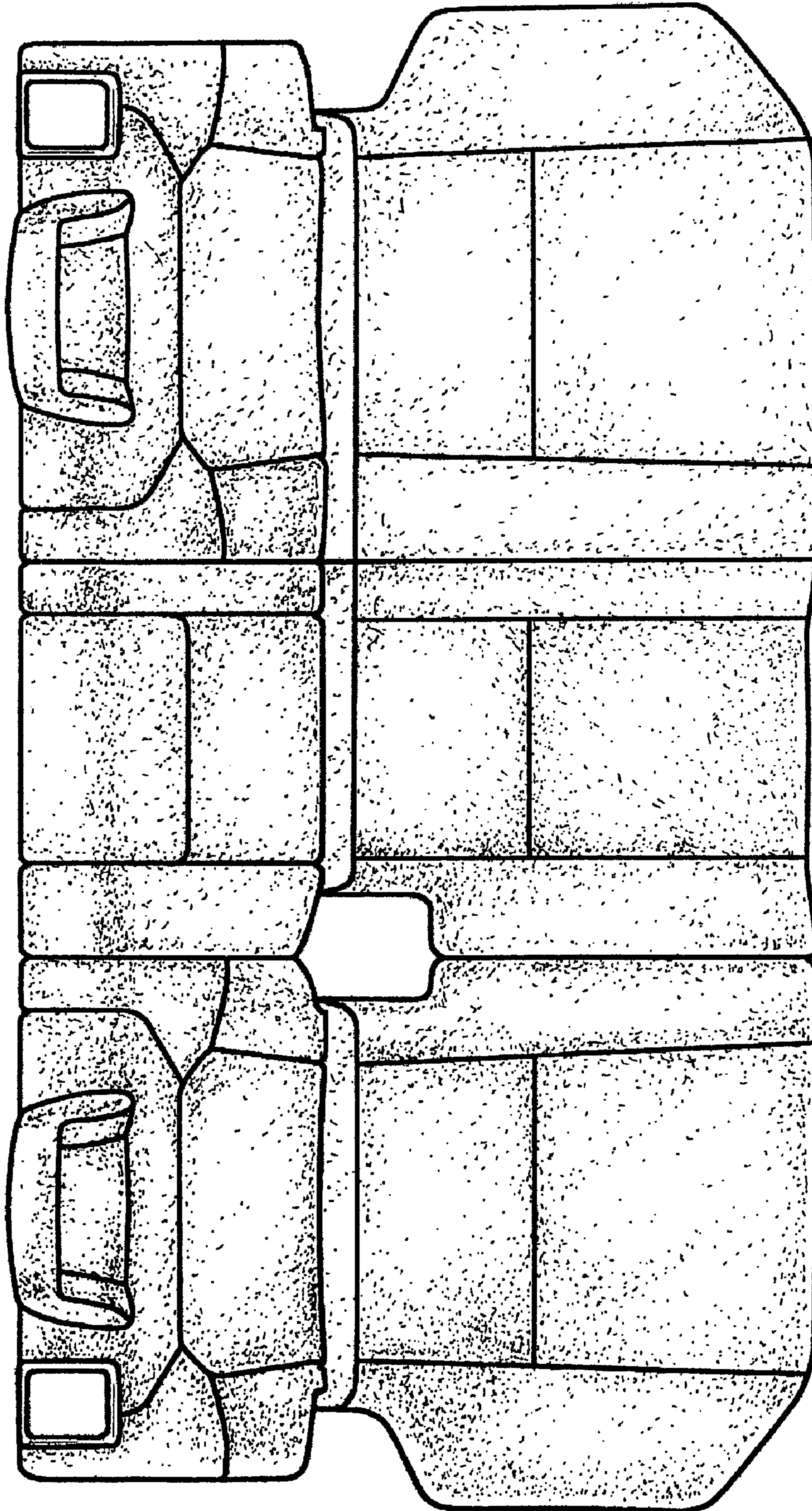
