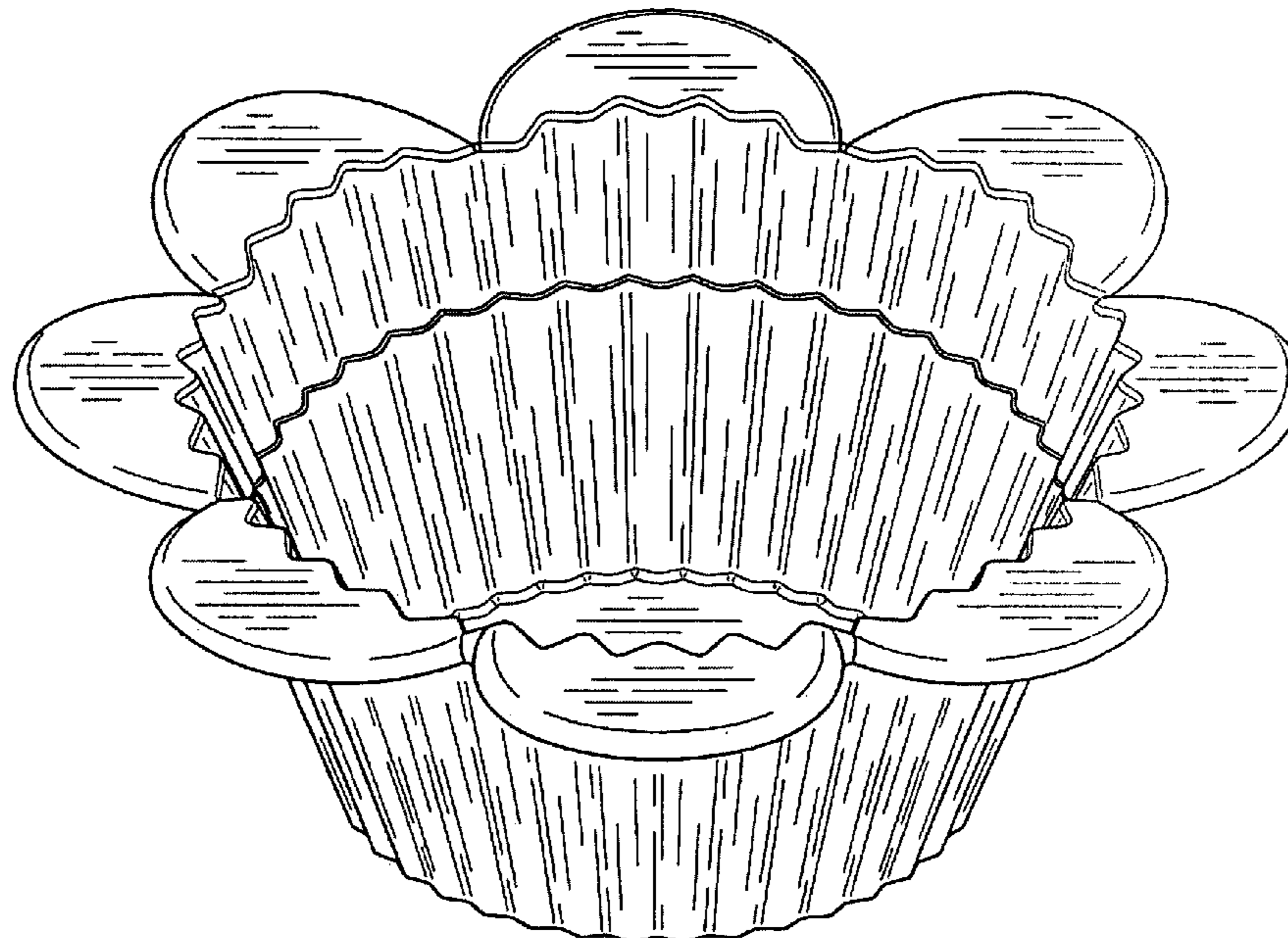

DESCRIPTION

FIG. 1 is a top perspective view of the flower cupcake holder; FIG. 2 is a front side elevational view of the flower cupcake holder, the rear side, left side, and right side elevational views thereof being mirror images of the front side shown; FIG. 3 top plan view of the flower cupcake holder; and, FIG. 4 is a bottom plan view of the flower cupcake holder.

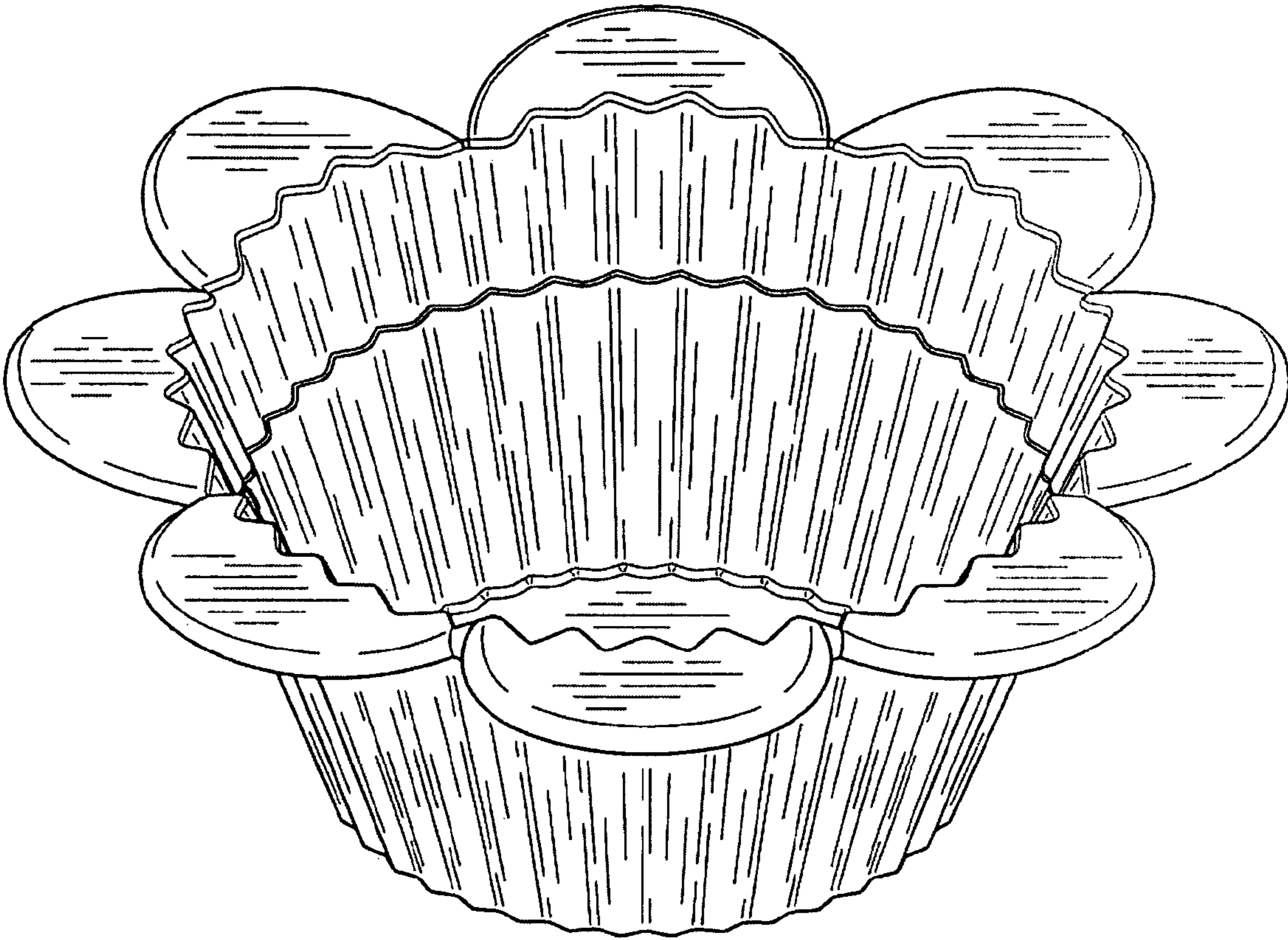

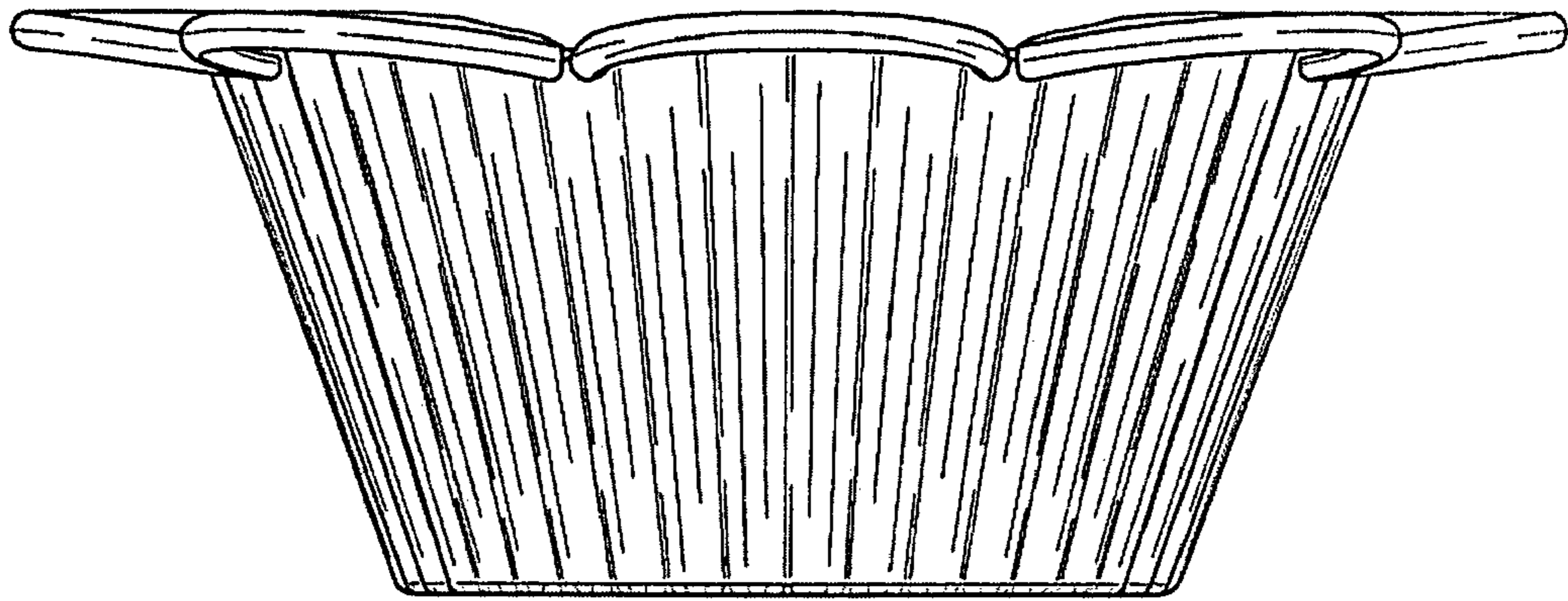

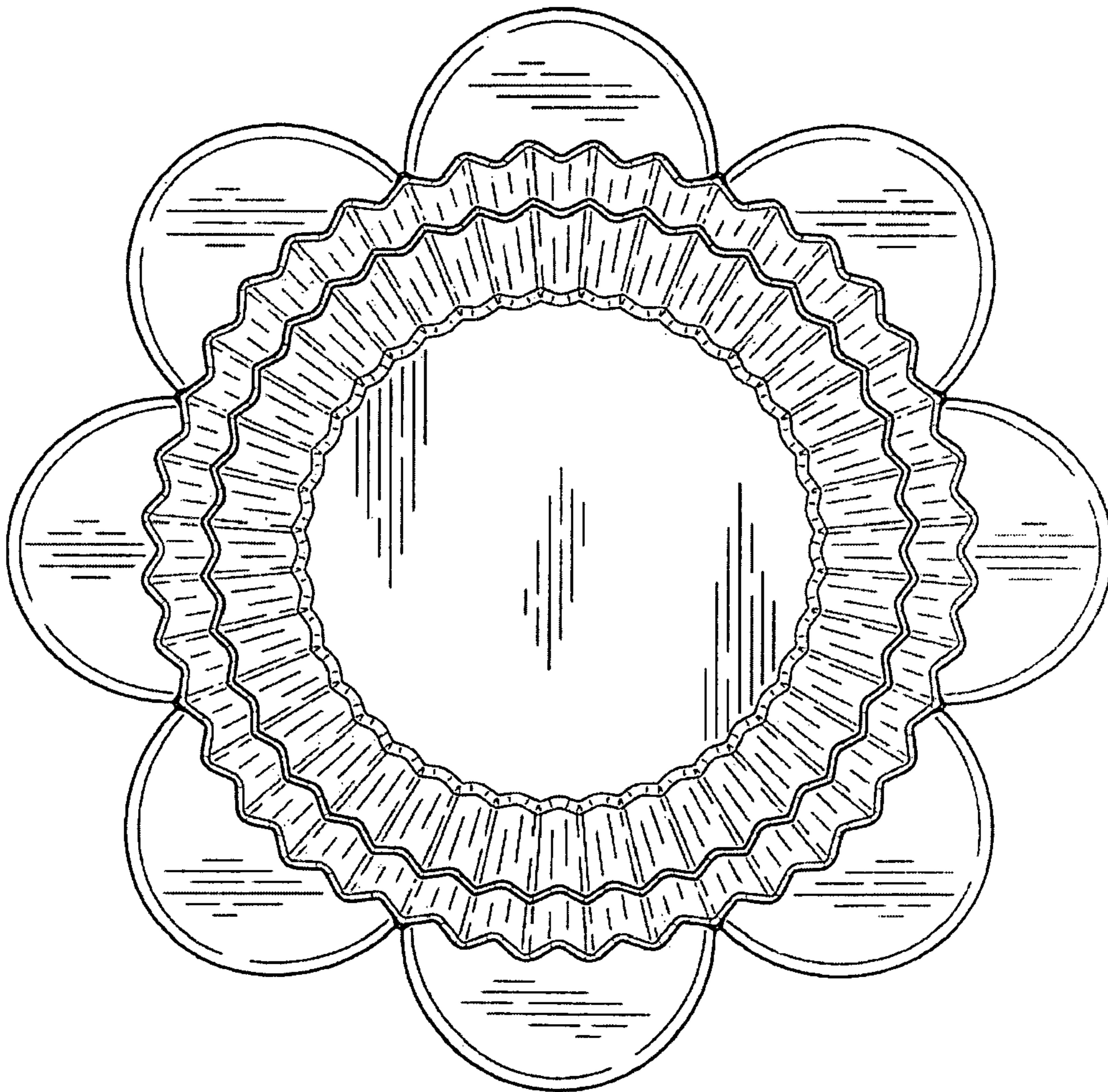

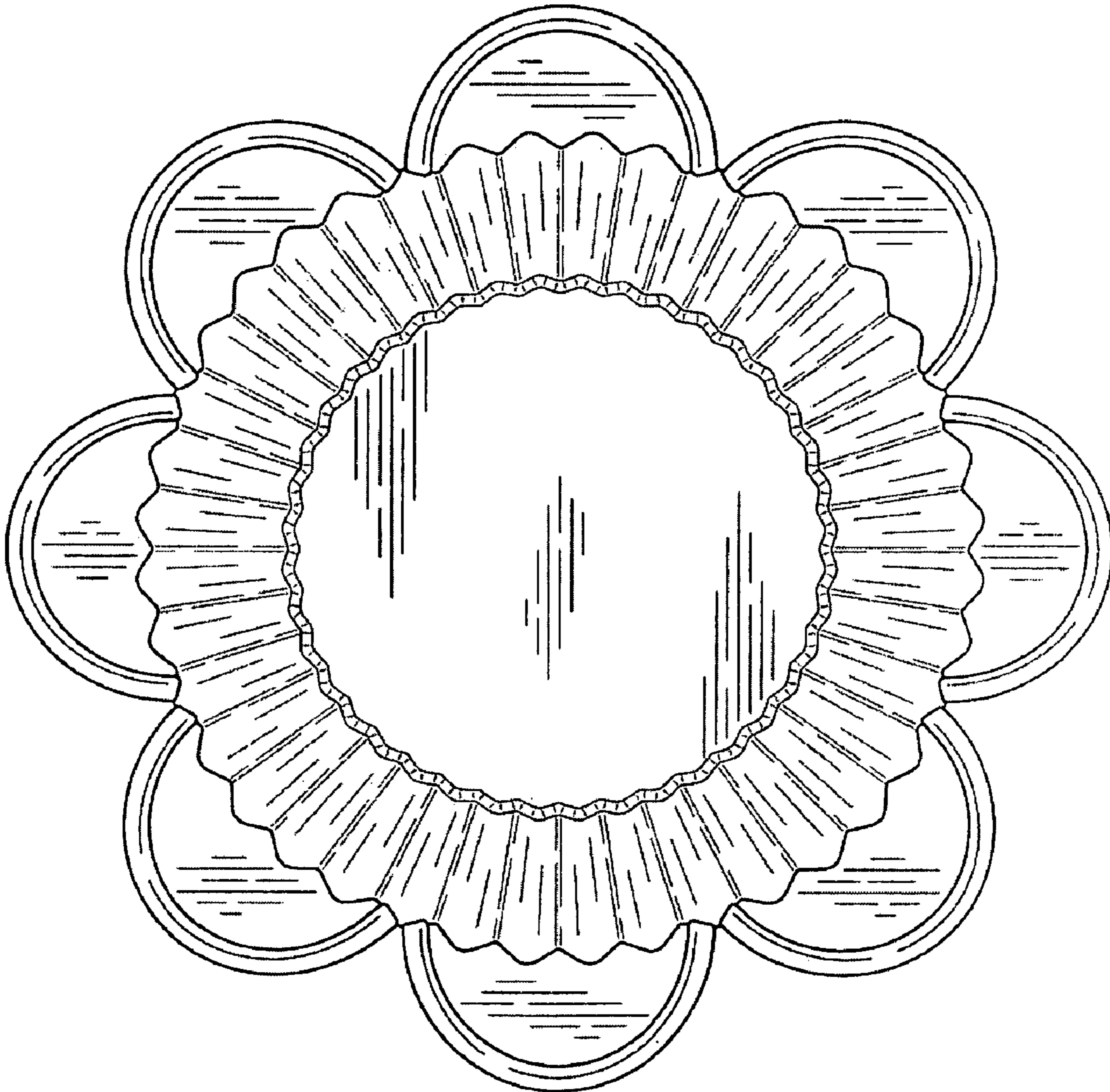
