FIG. 4 is a second side view of the sugar spoon of the present invention showing my new design.

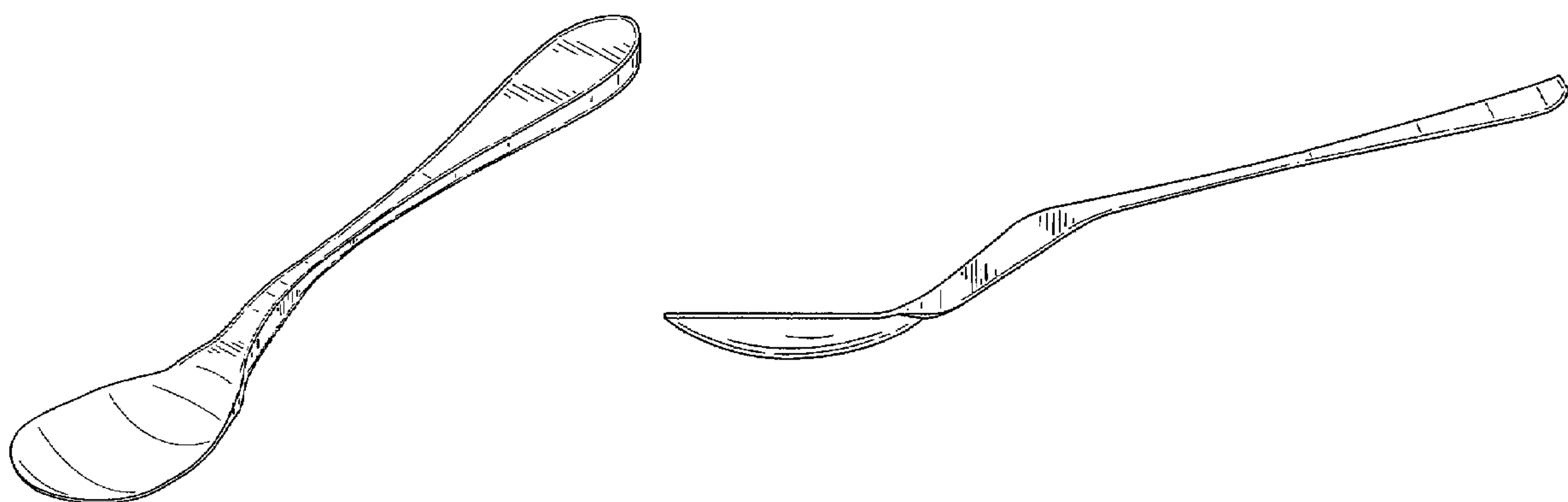
FIG. 5 is a first end view of the sugar spoon of the present invention showing my new design.

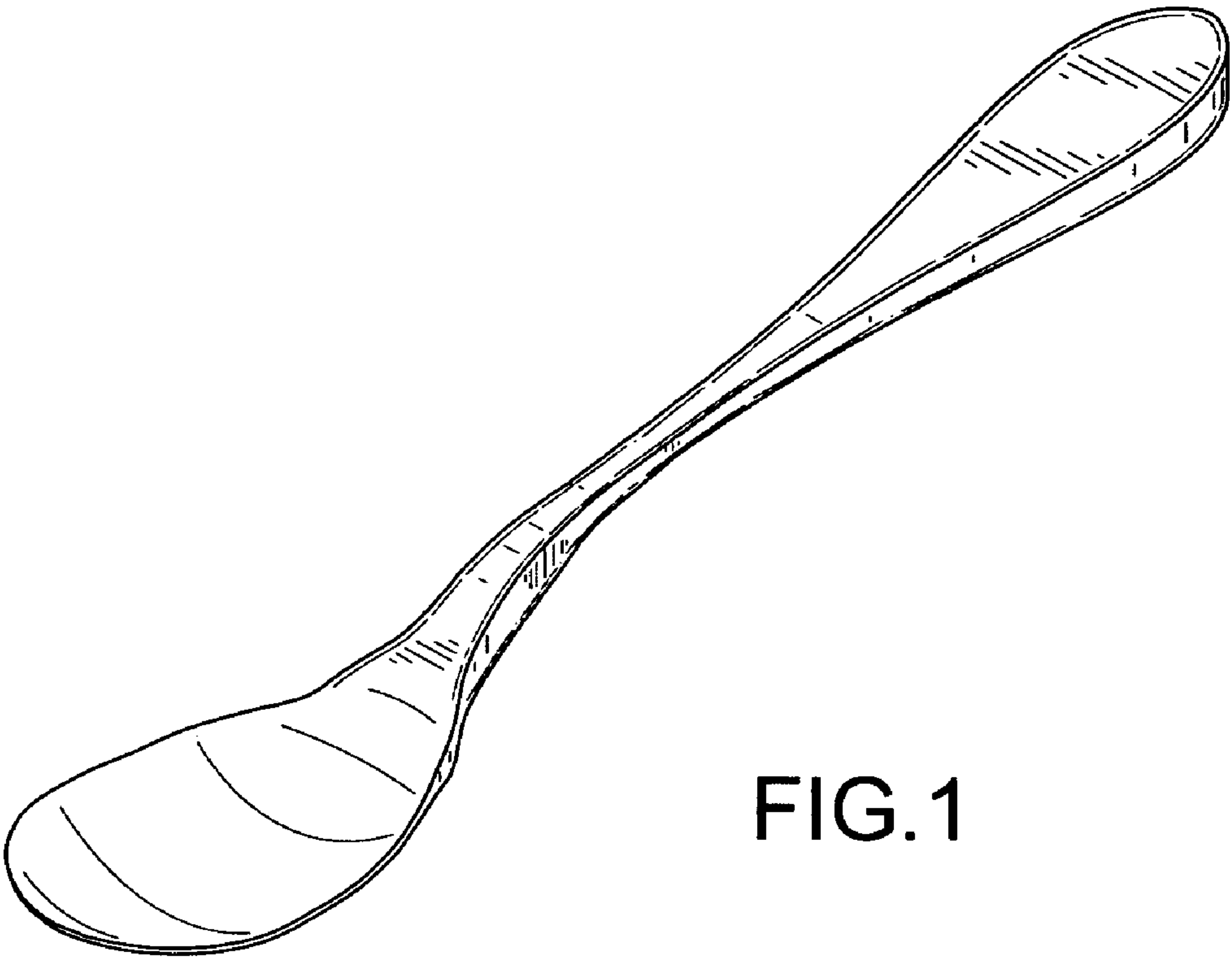

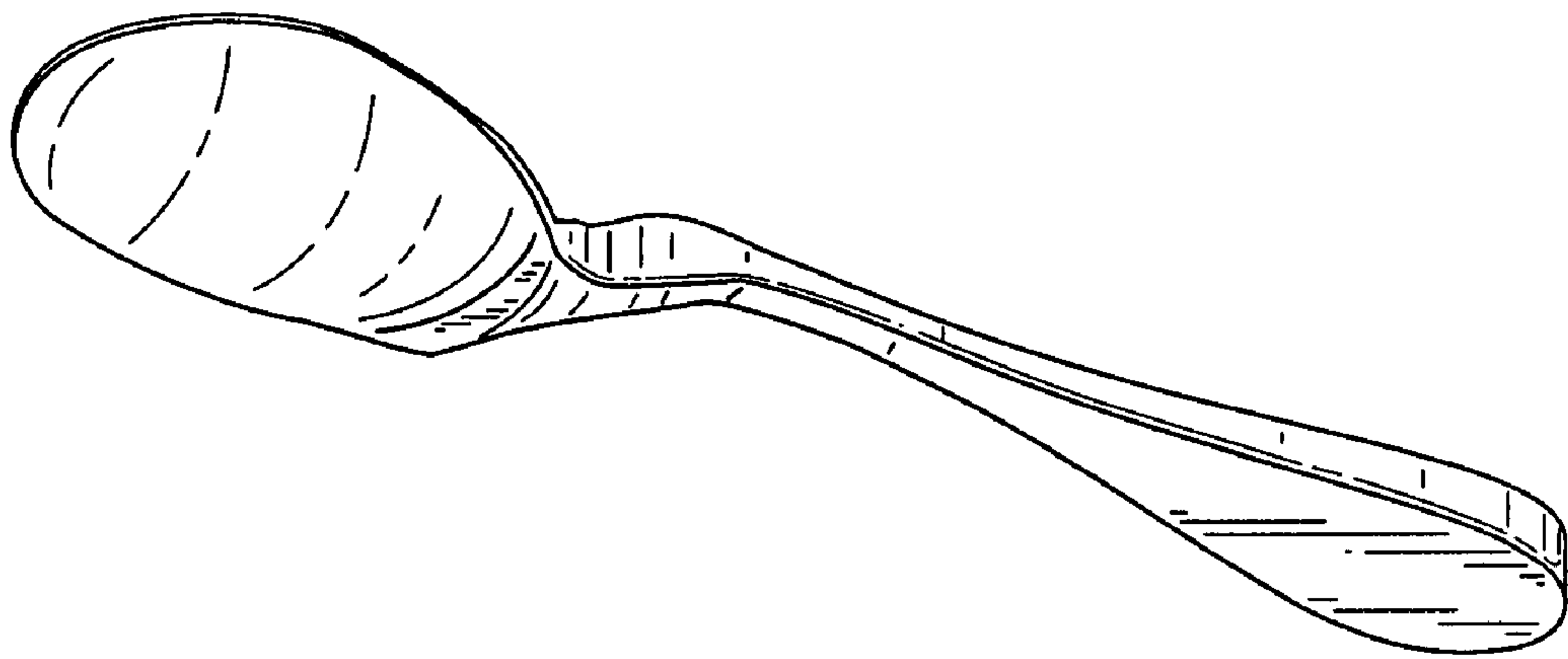

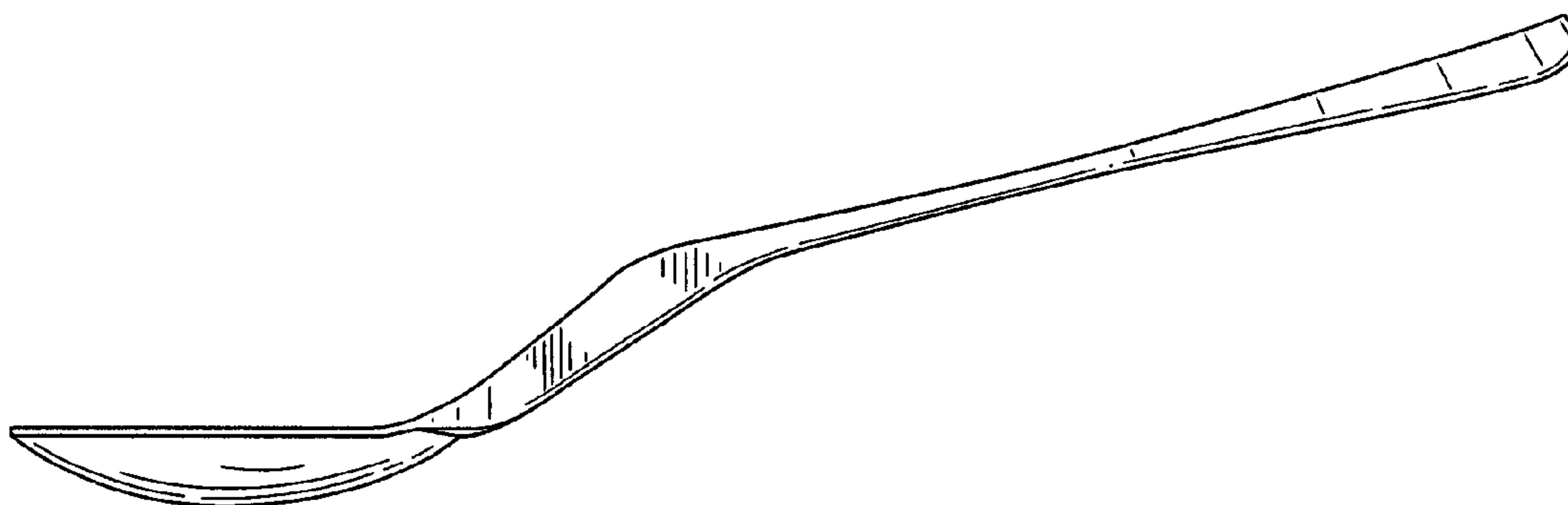

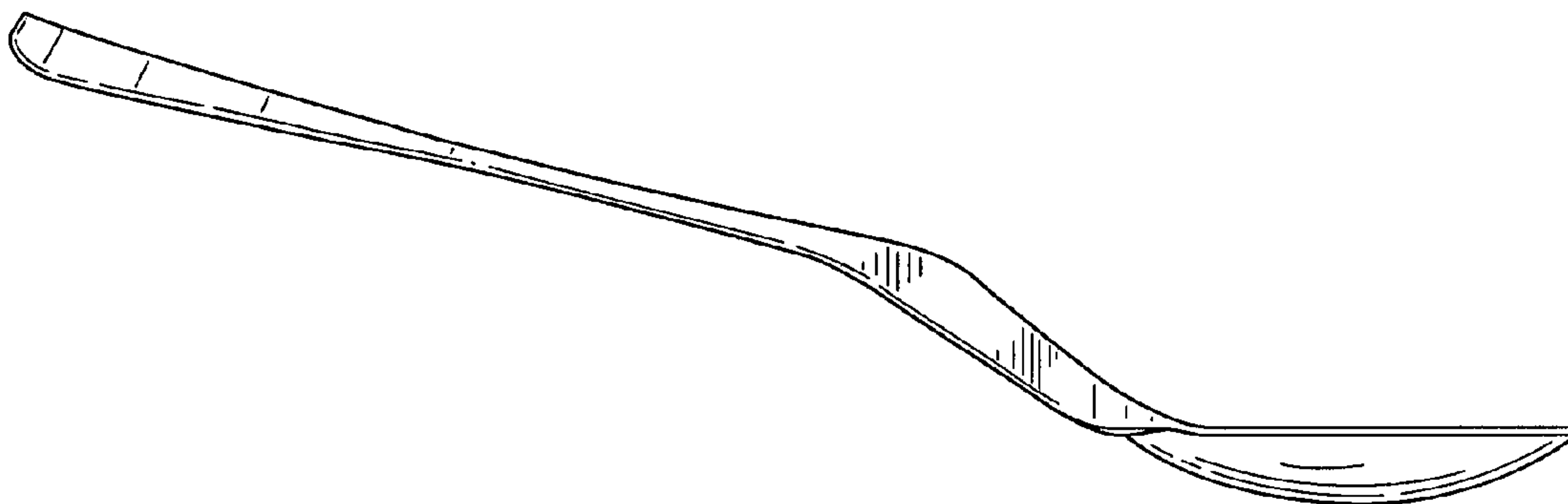

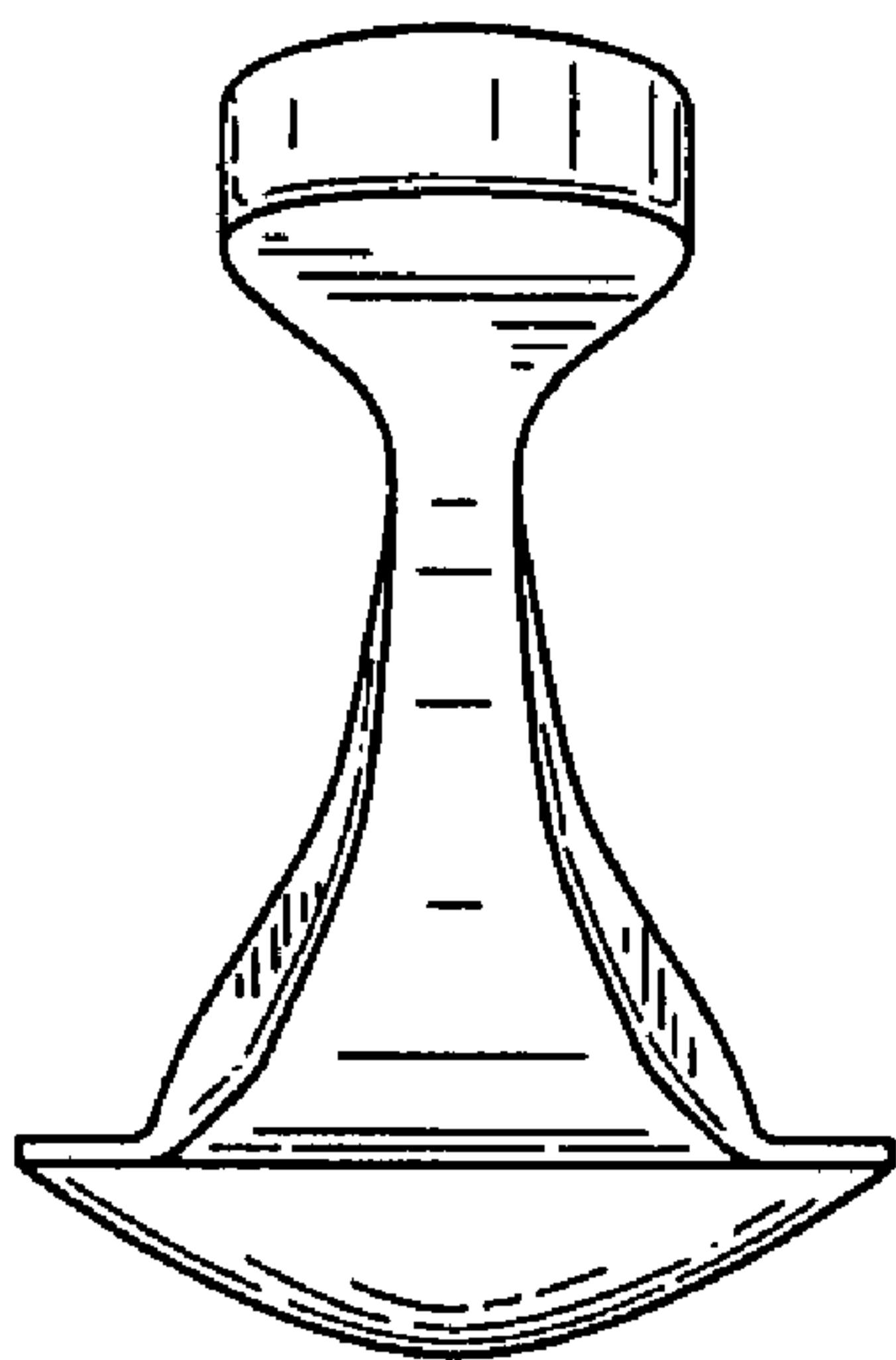

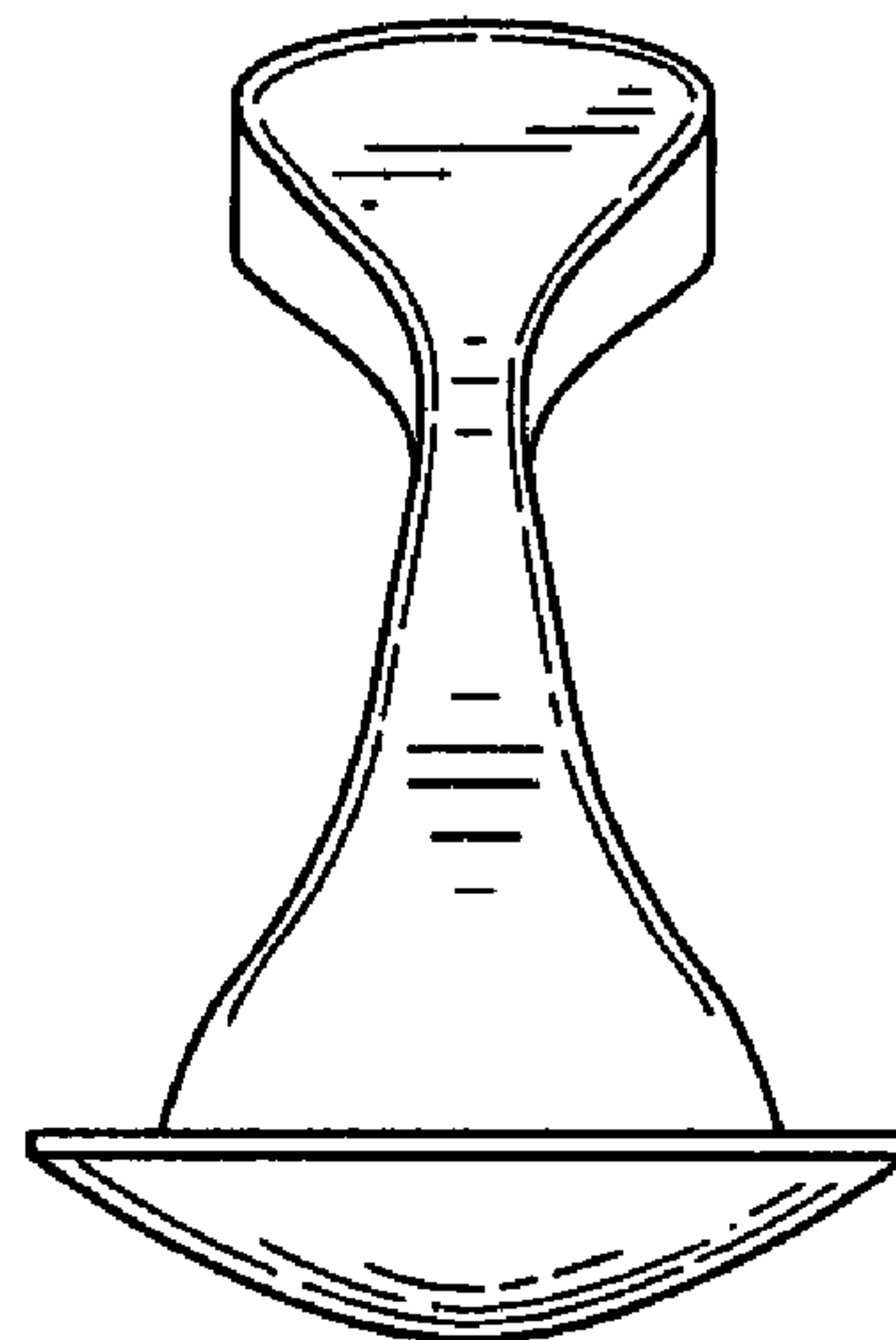

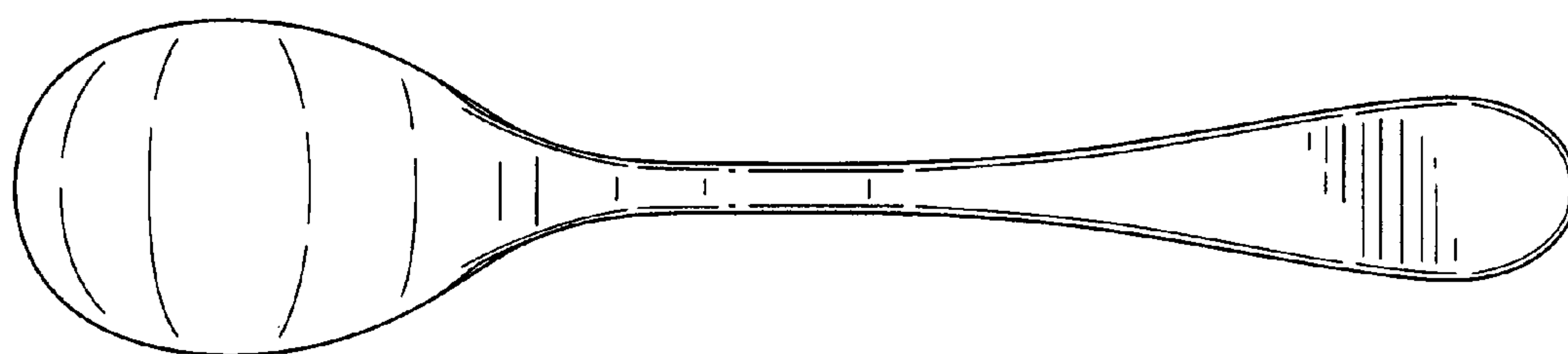

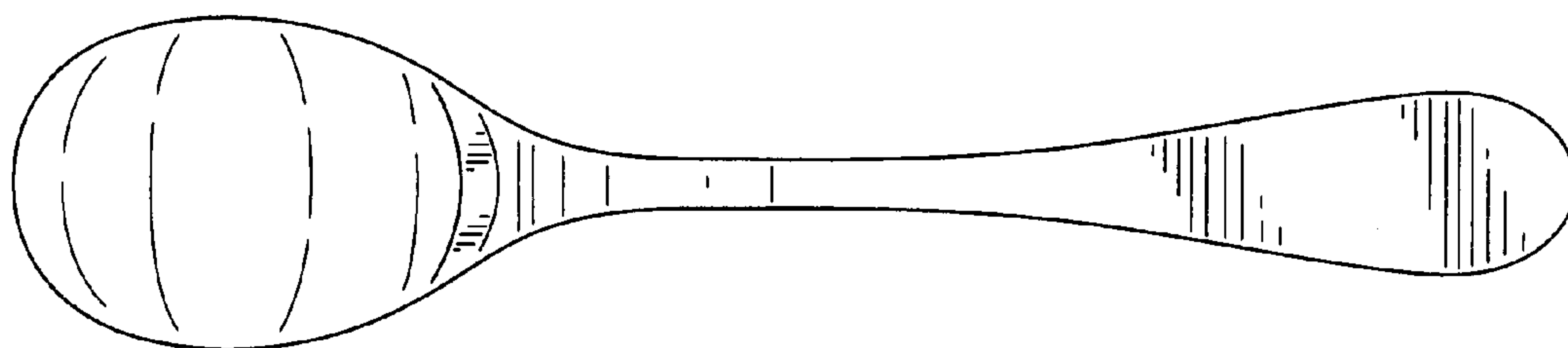
