We claim the ornamental design for front portion of the housing of a handle and housing assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front left perspective view of a front portion of the housing of a handle and housing assembly showing our new design;

FIG. 2 is a front view thereof;

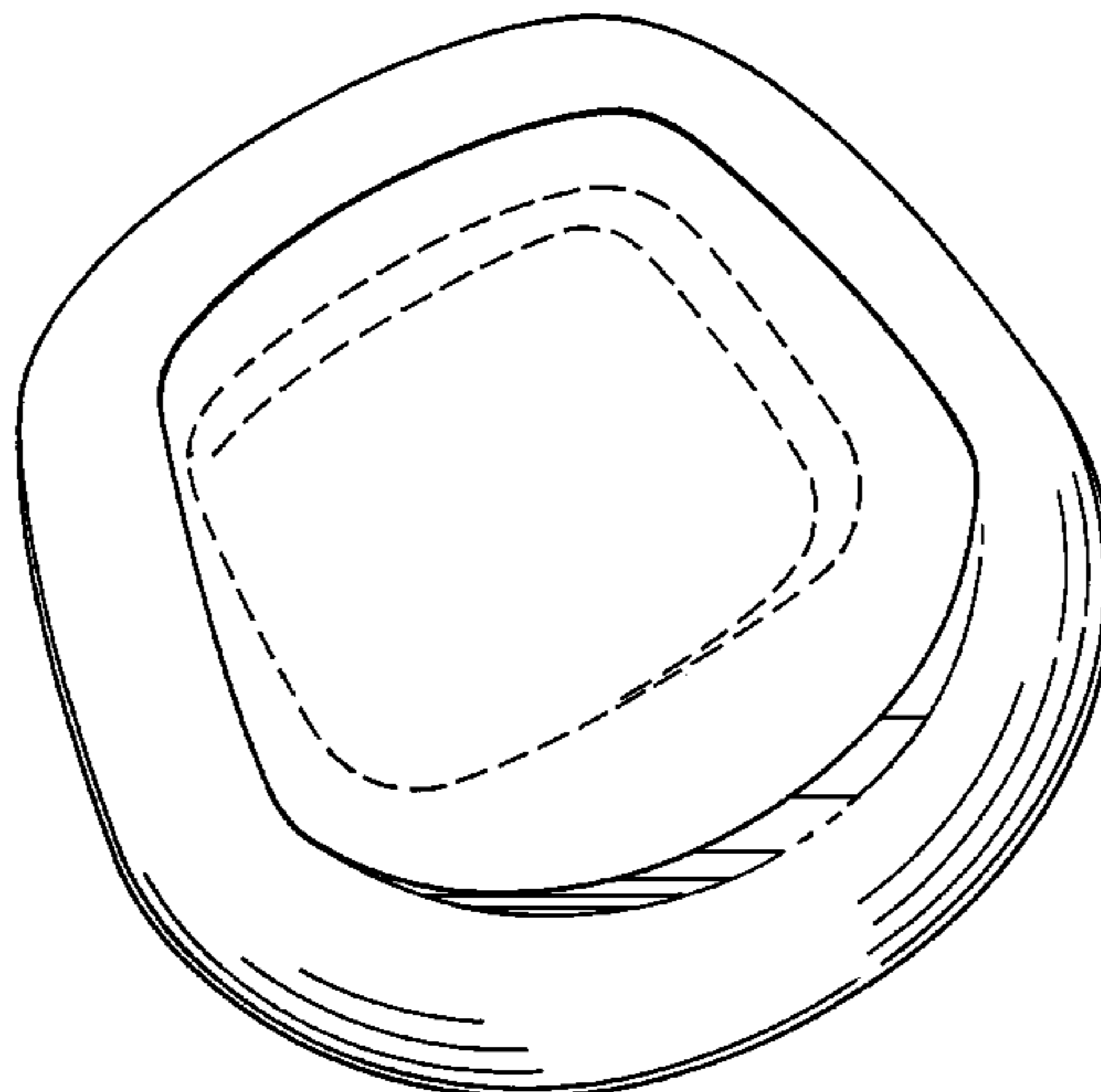
FIG. 3 is a left side view, the right side being a mirror image thereof;

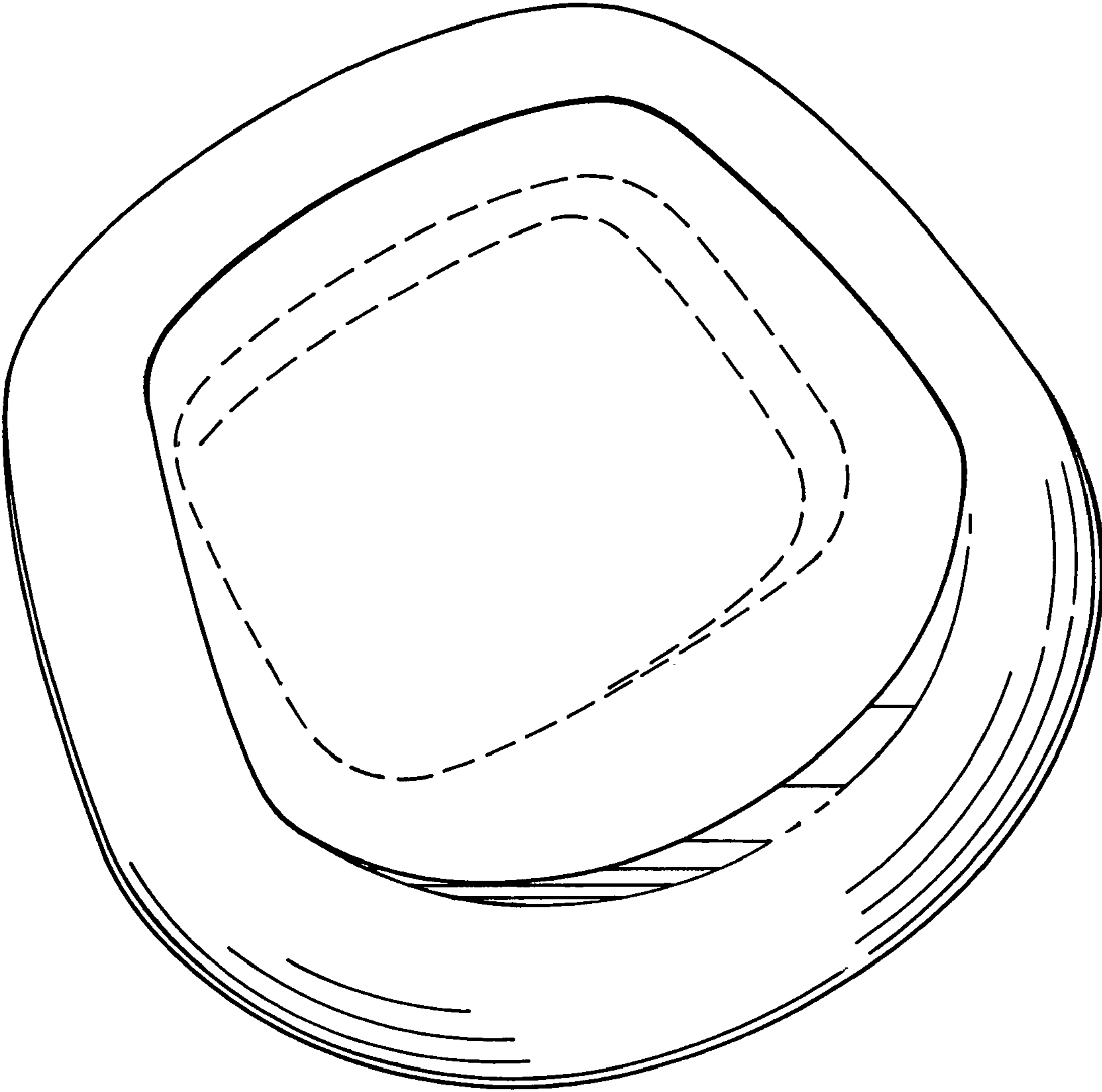

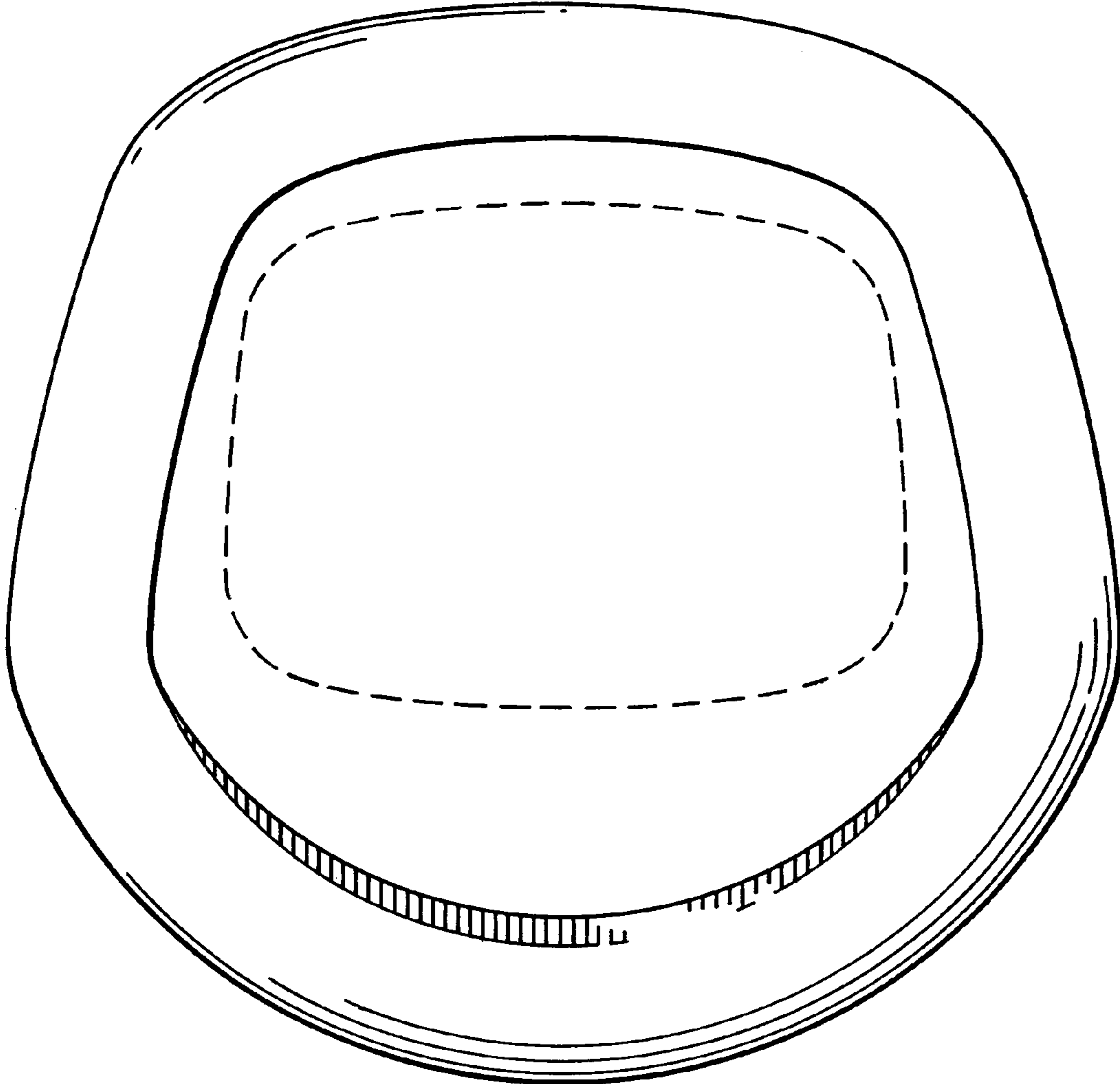

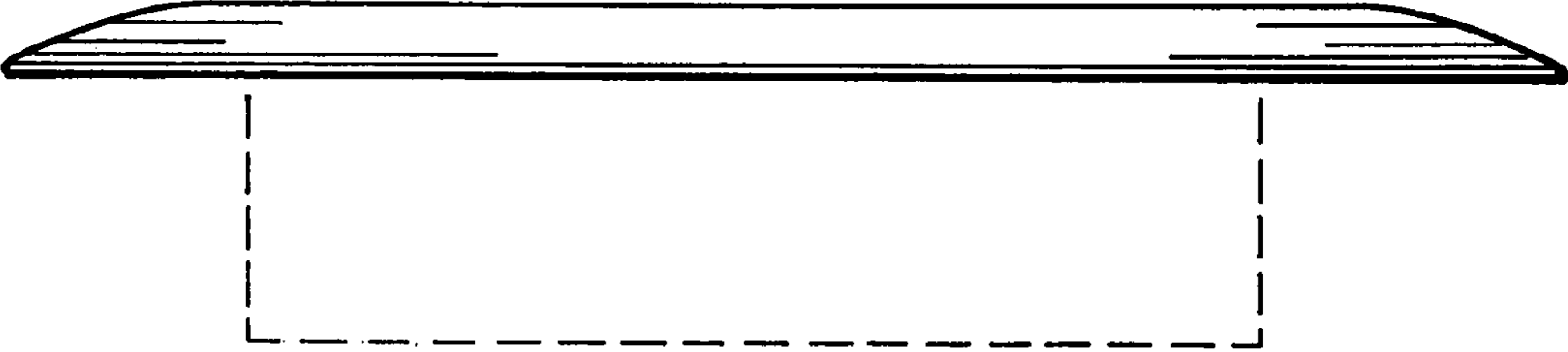

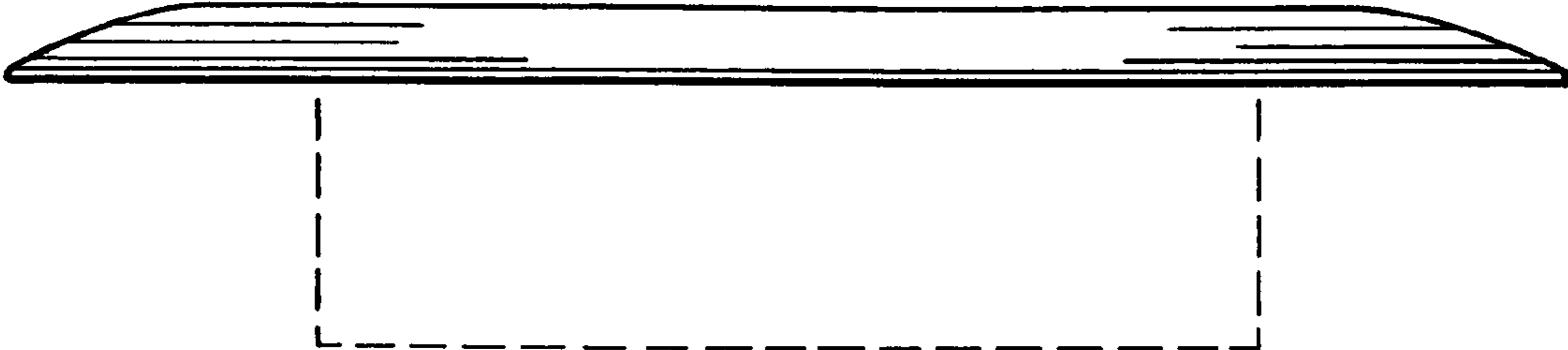

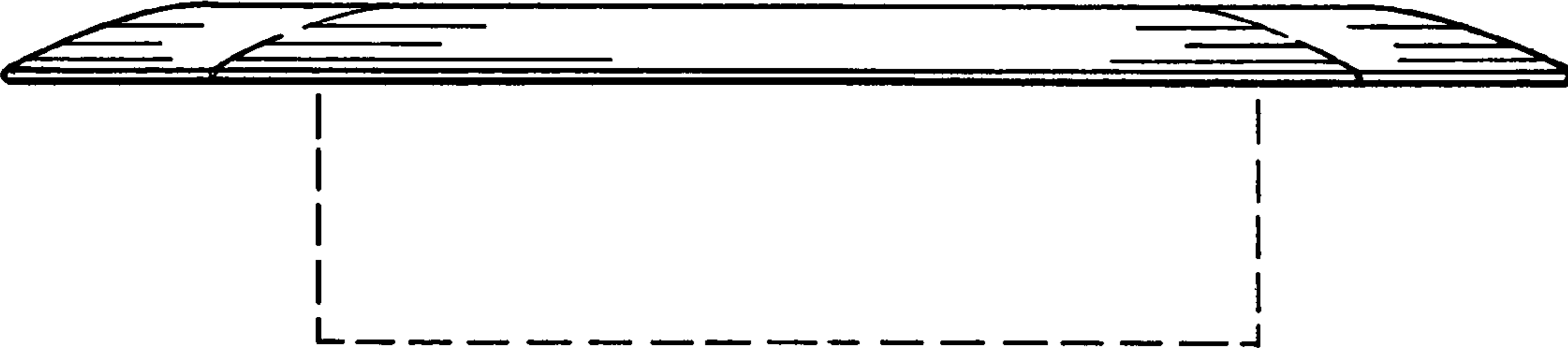
