FIG. 22 is a front right side perspective view of a package bearing a fourth embodiment of the package, the design including a bottle design;

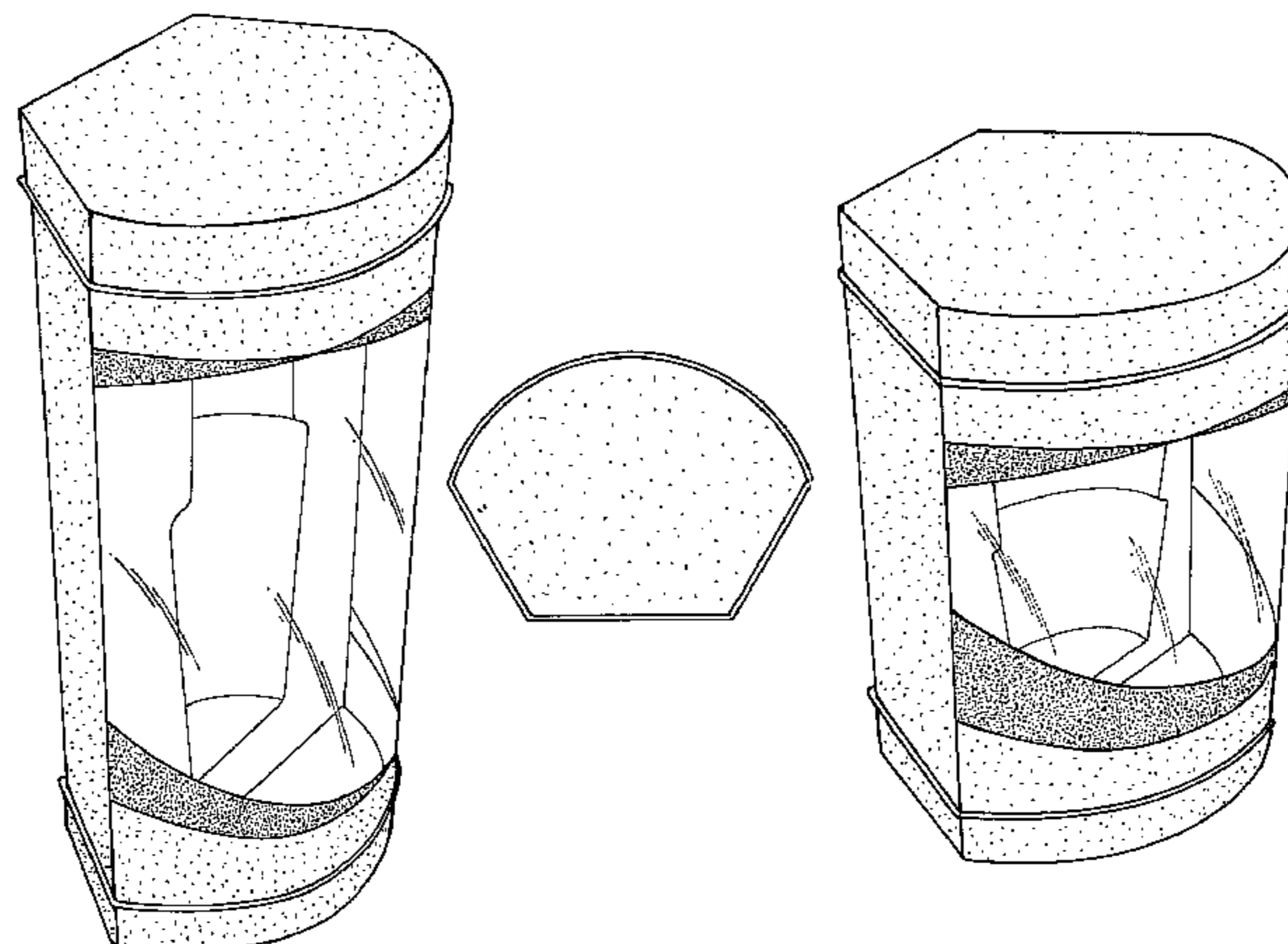


FIG. 23 is a front elevation view thereof;

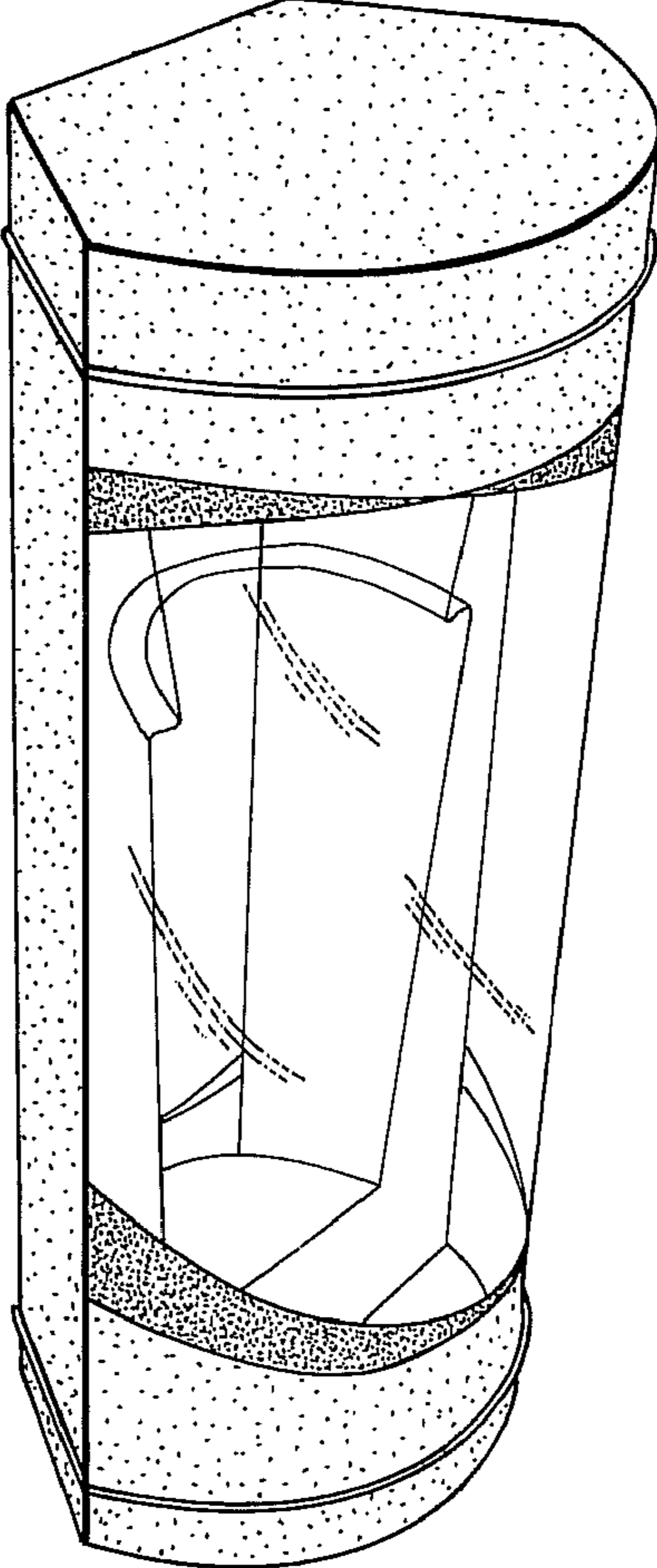

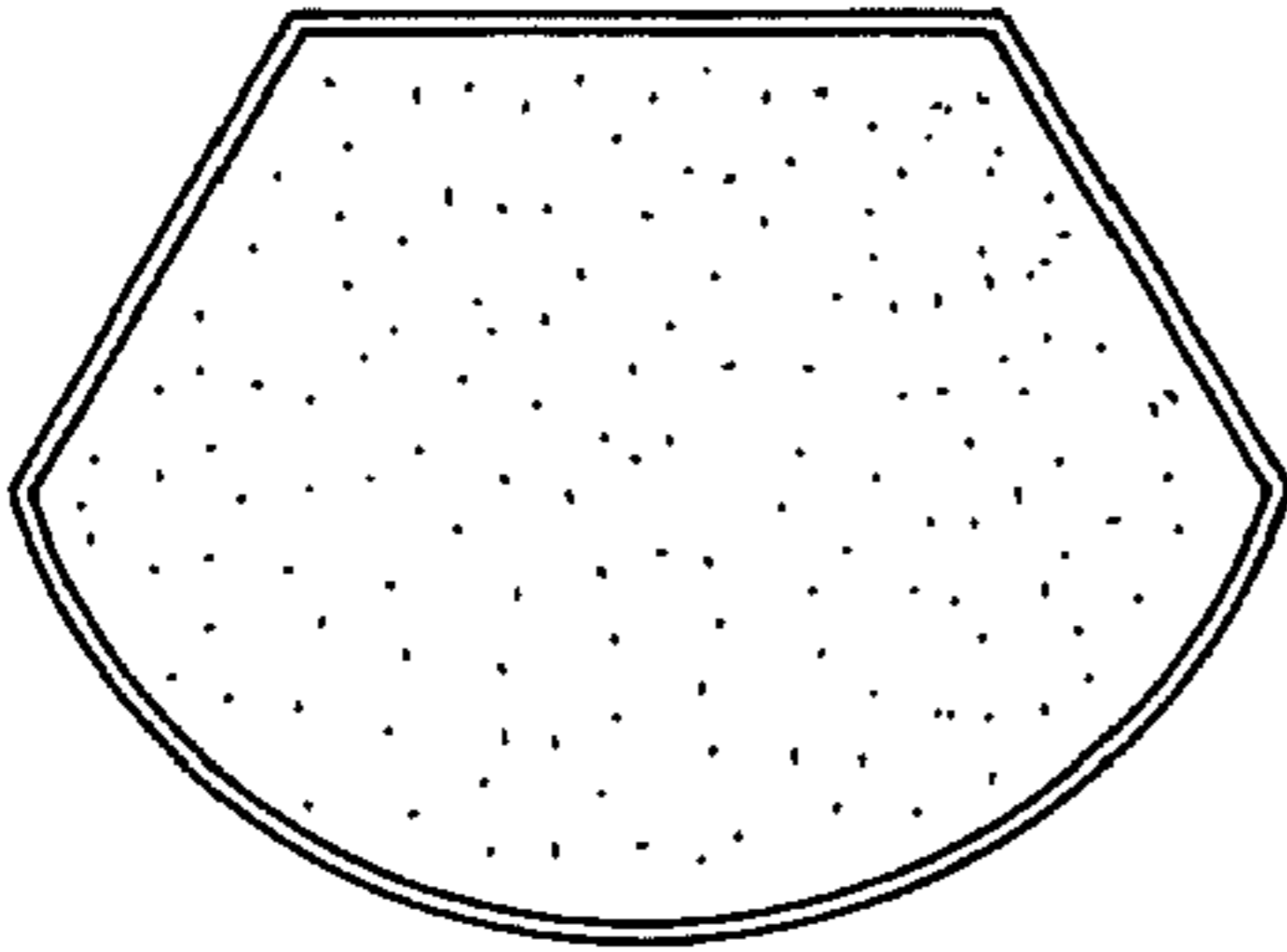

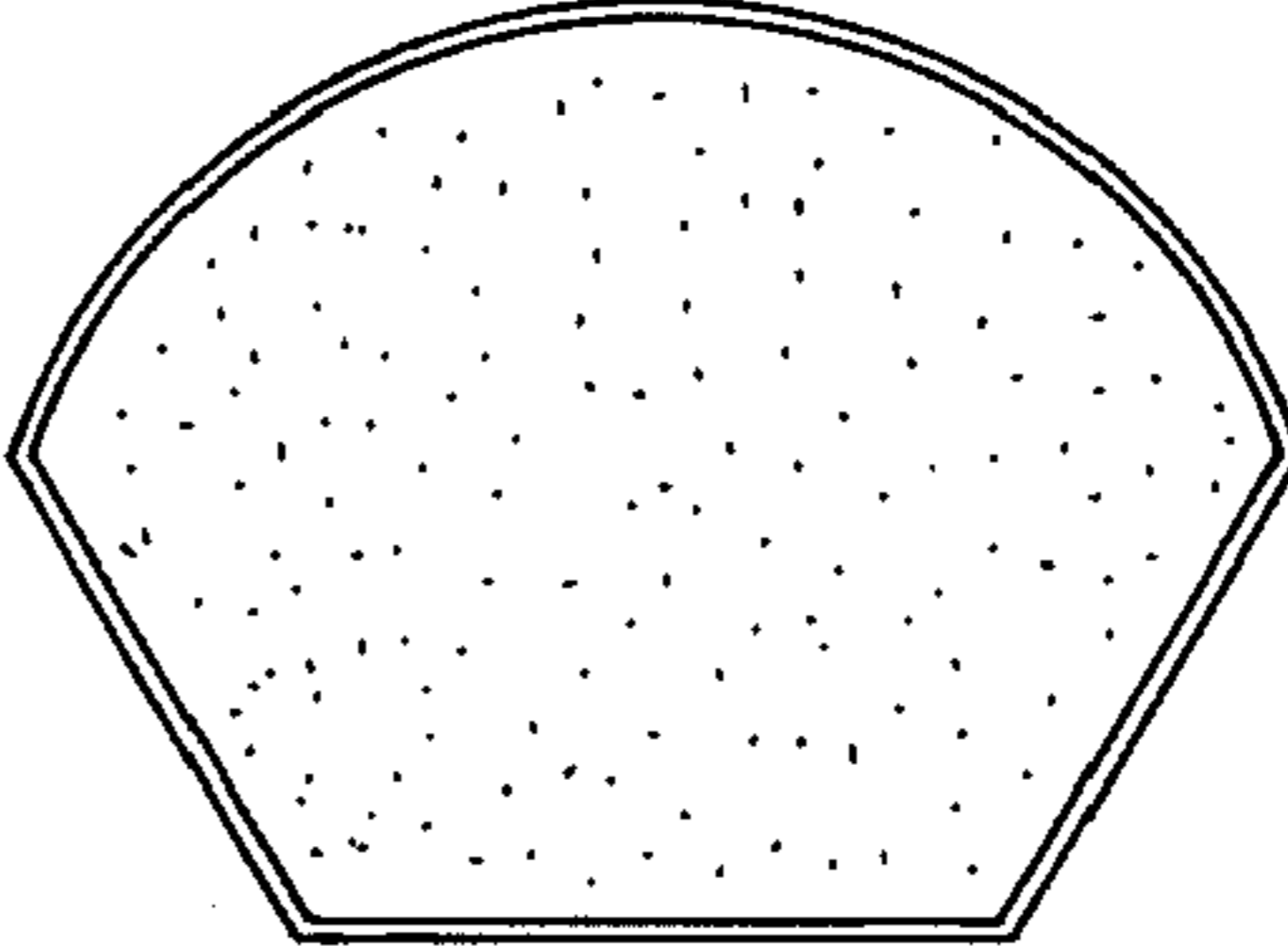

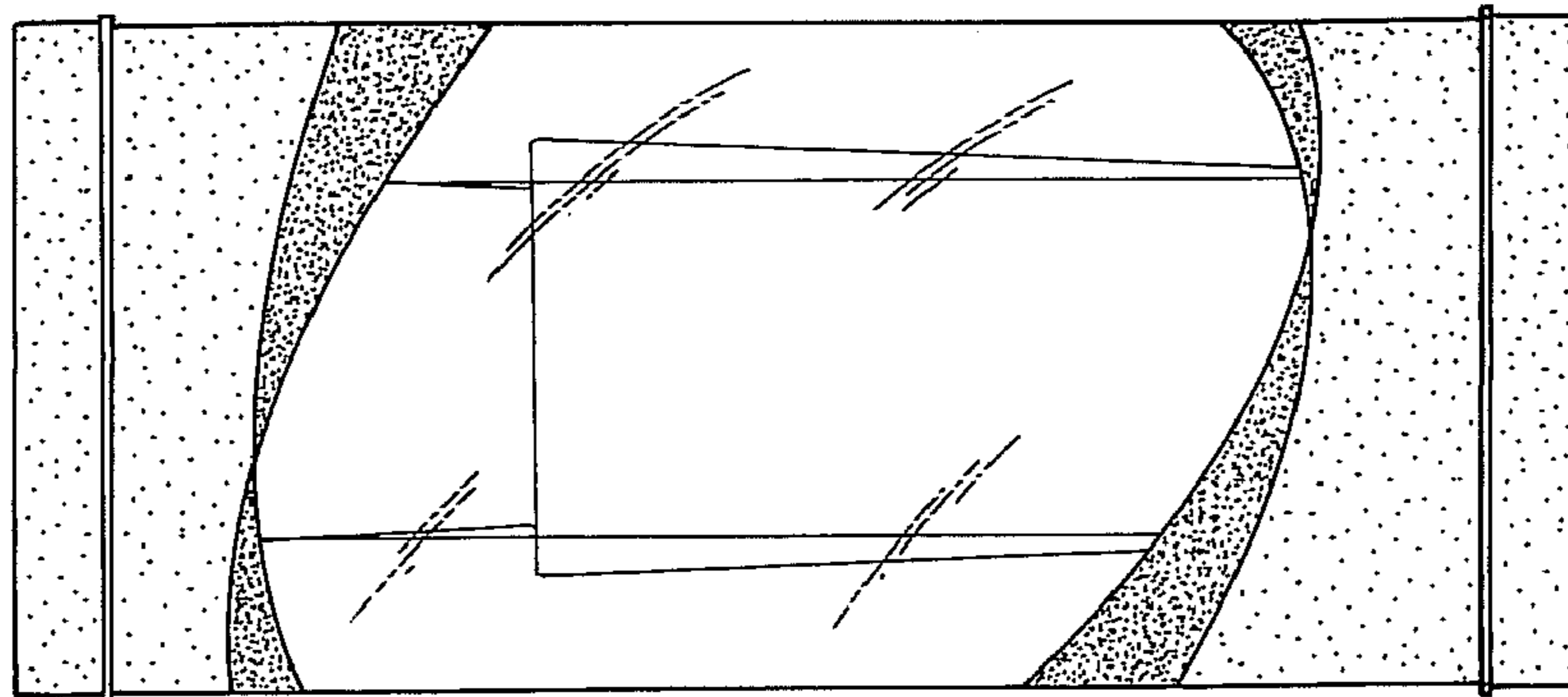

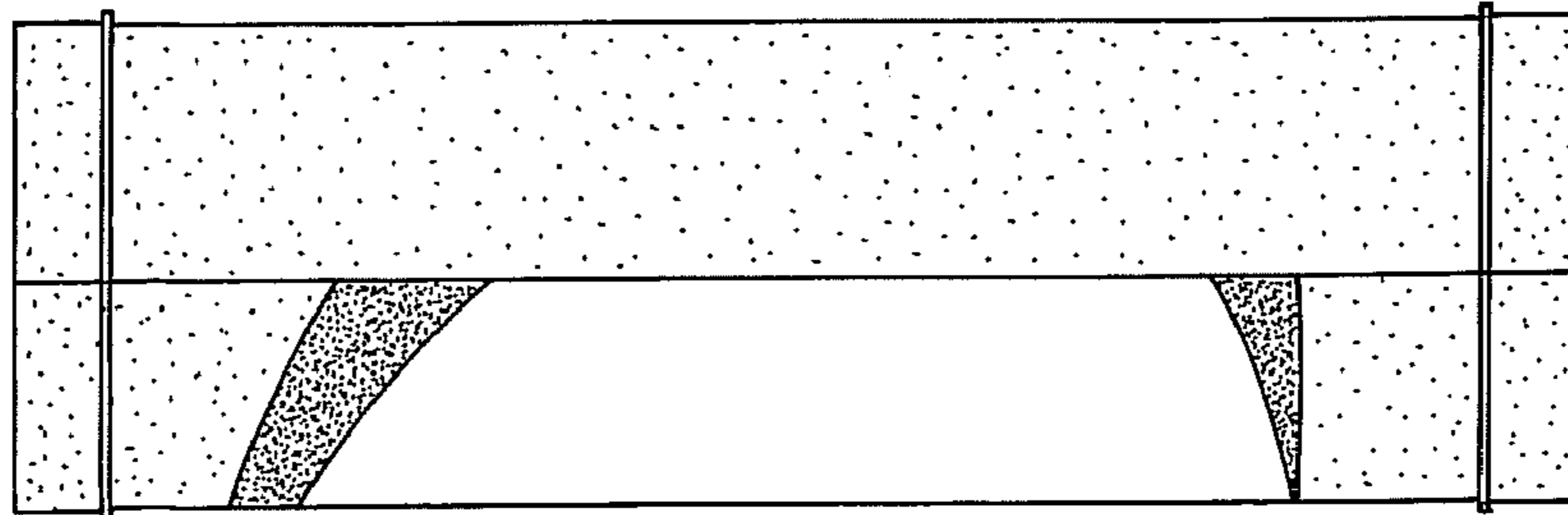

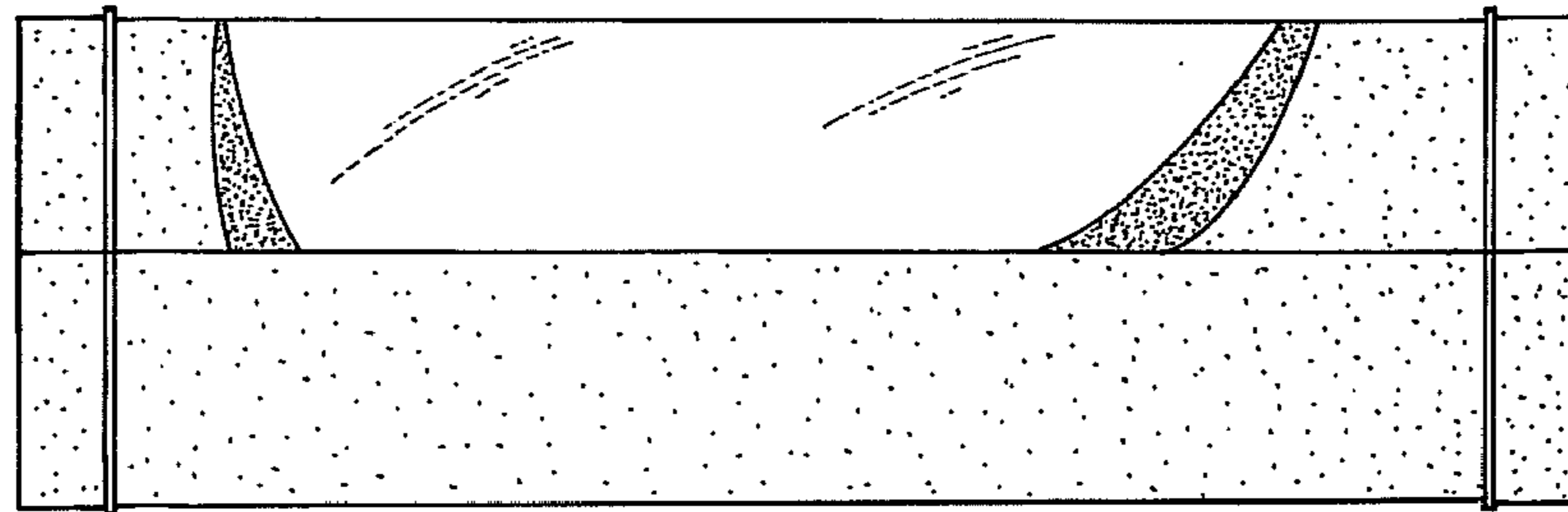

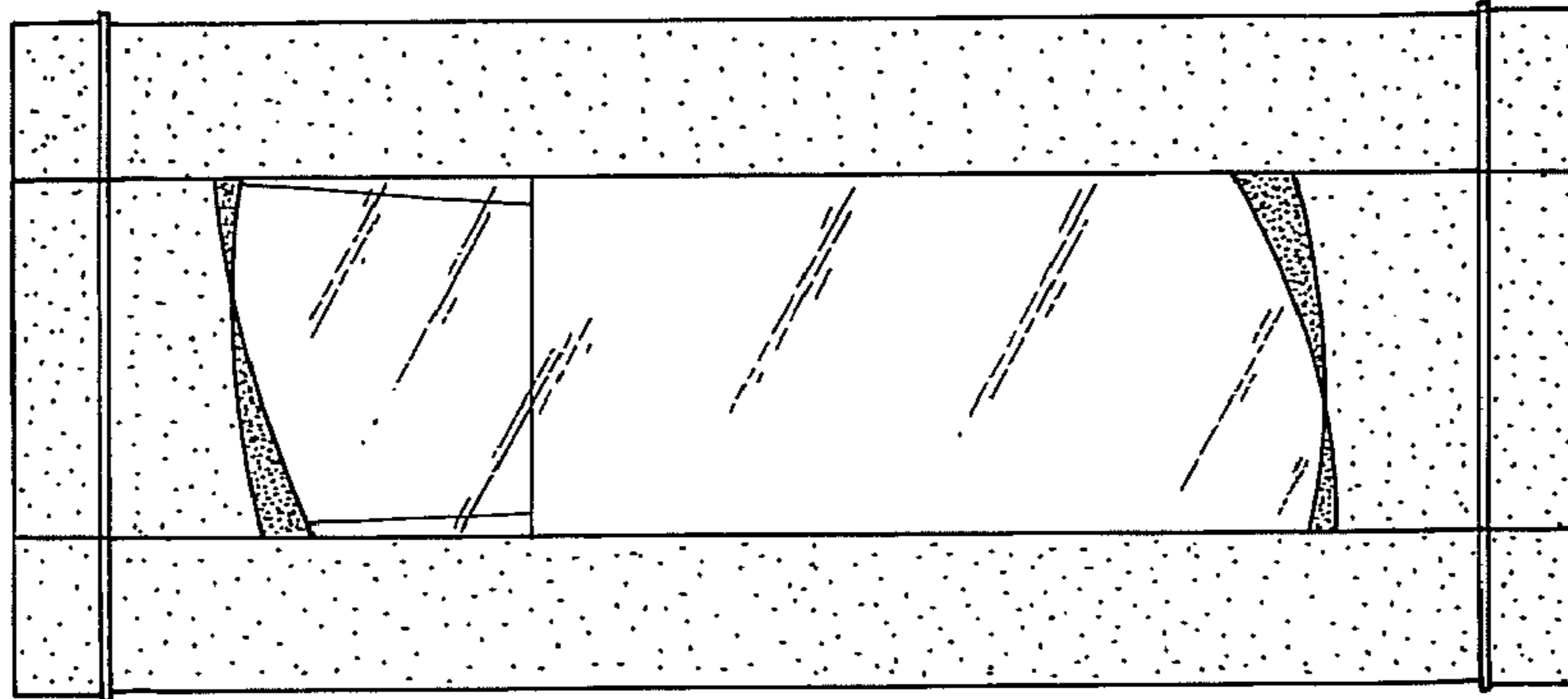

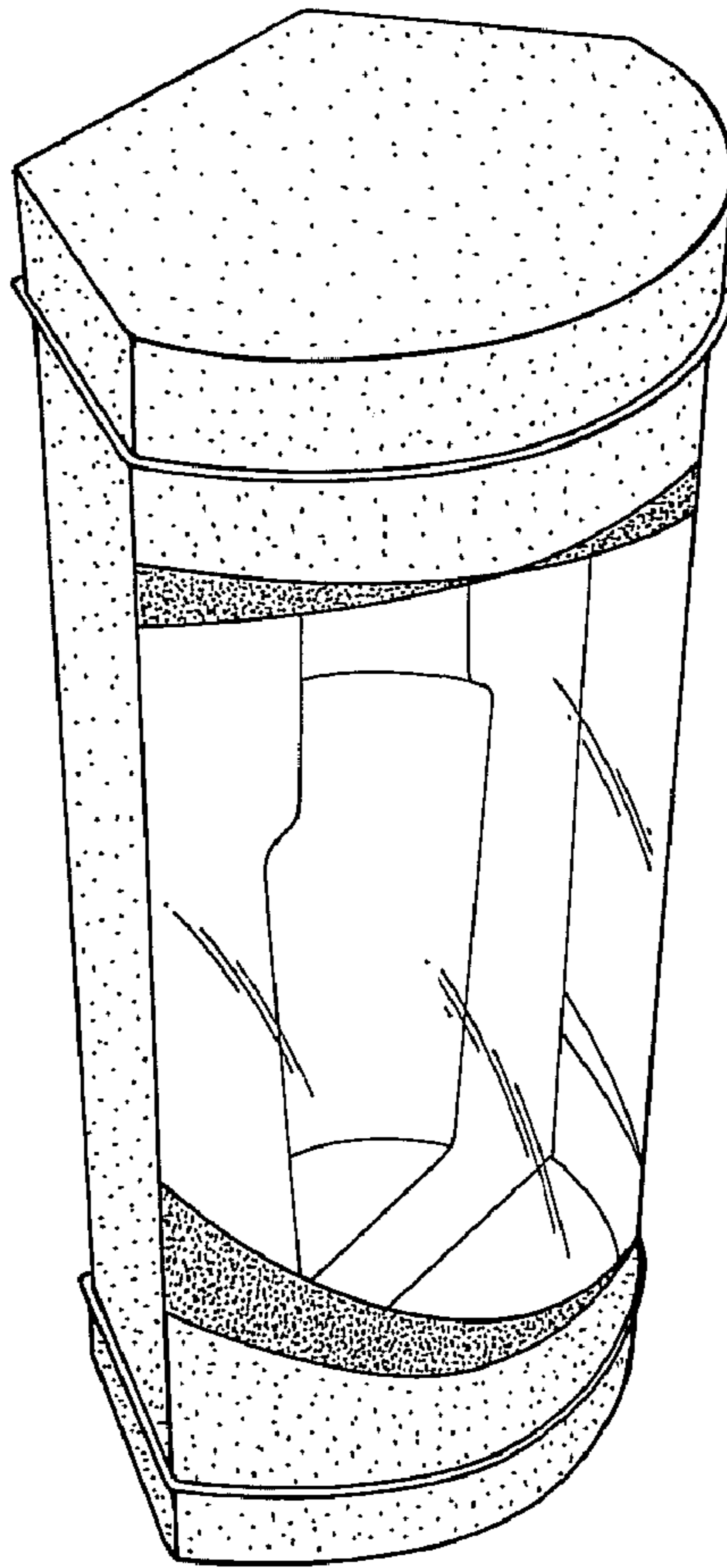

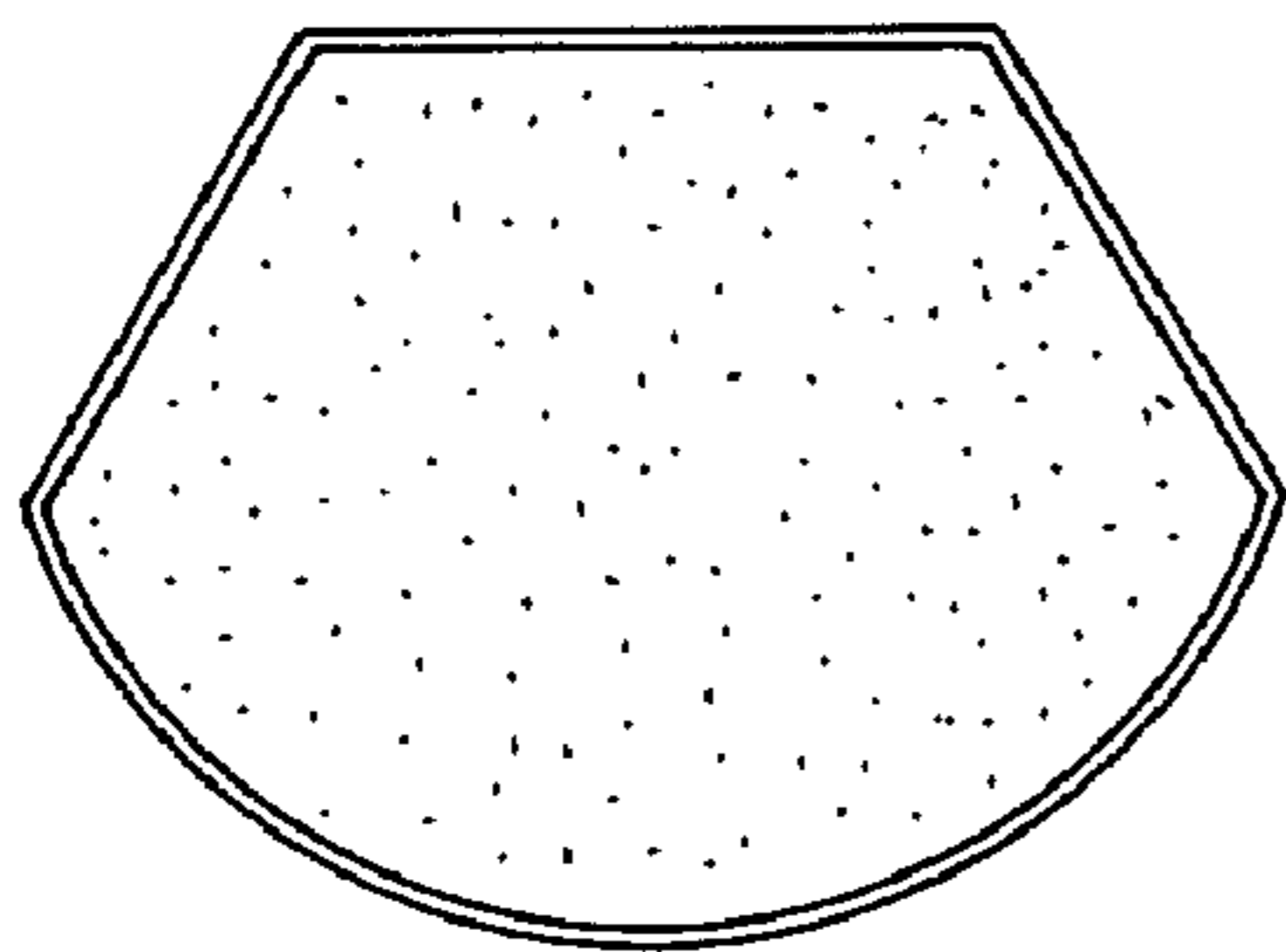

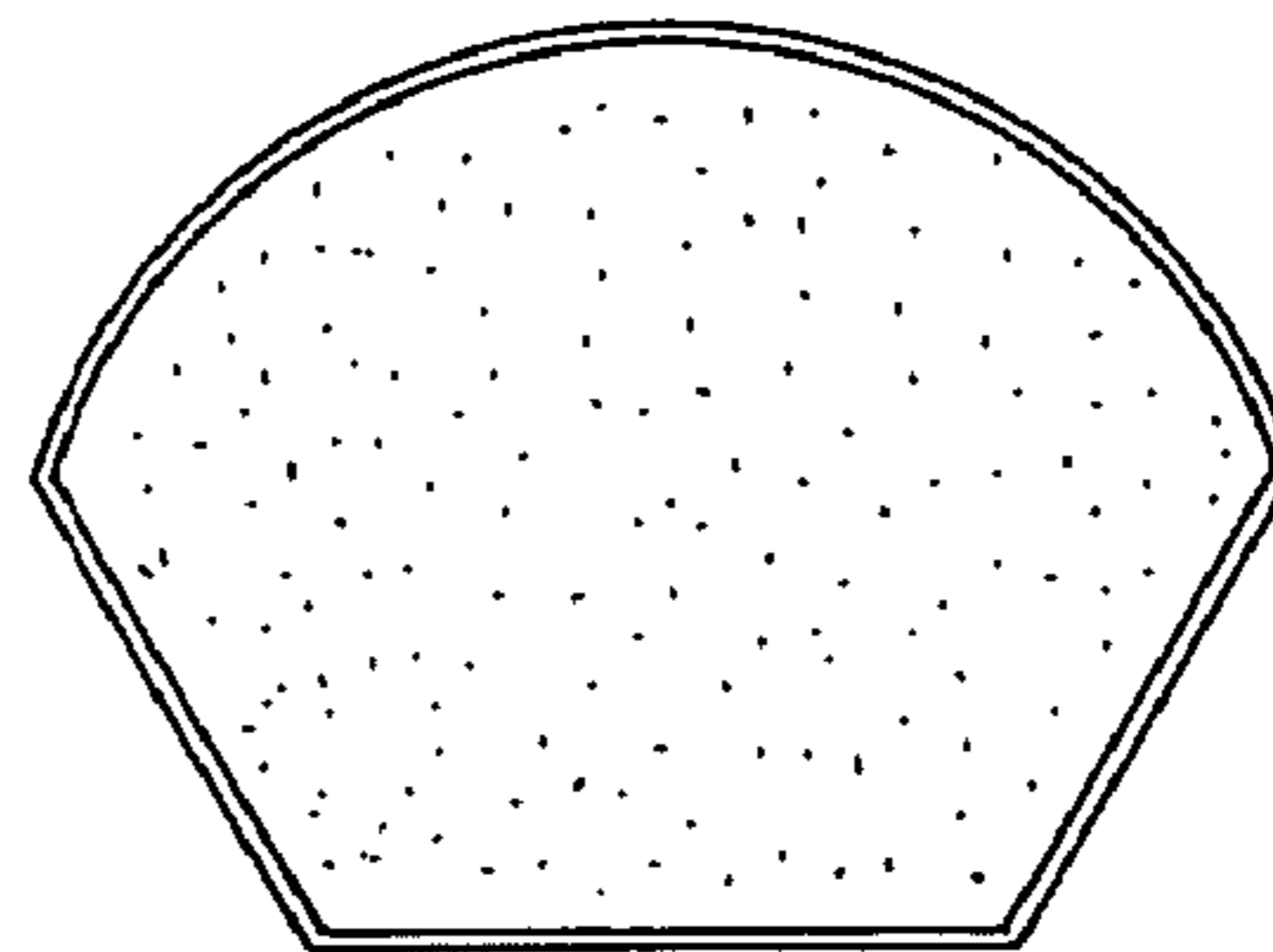

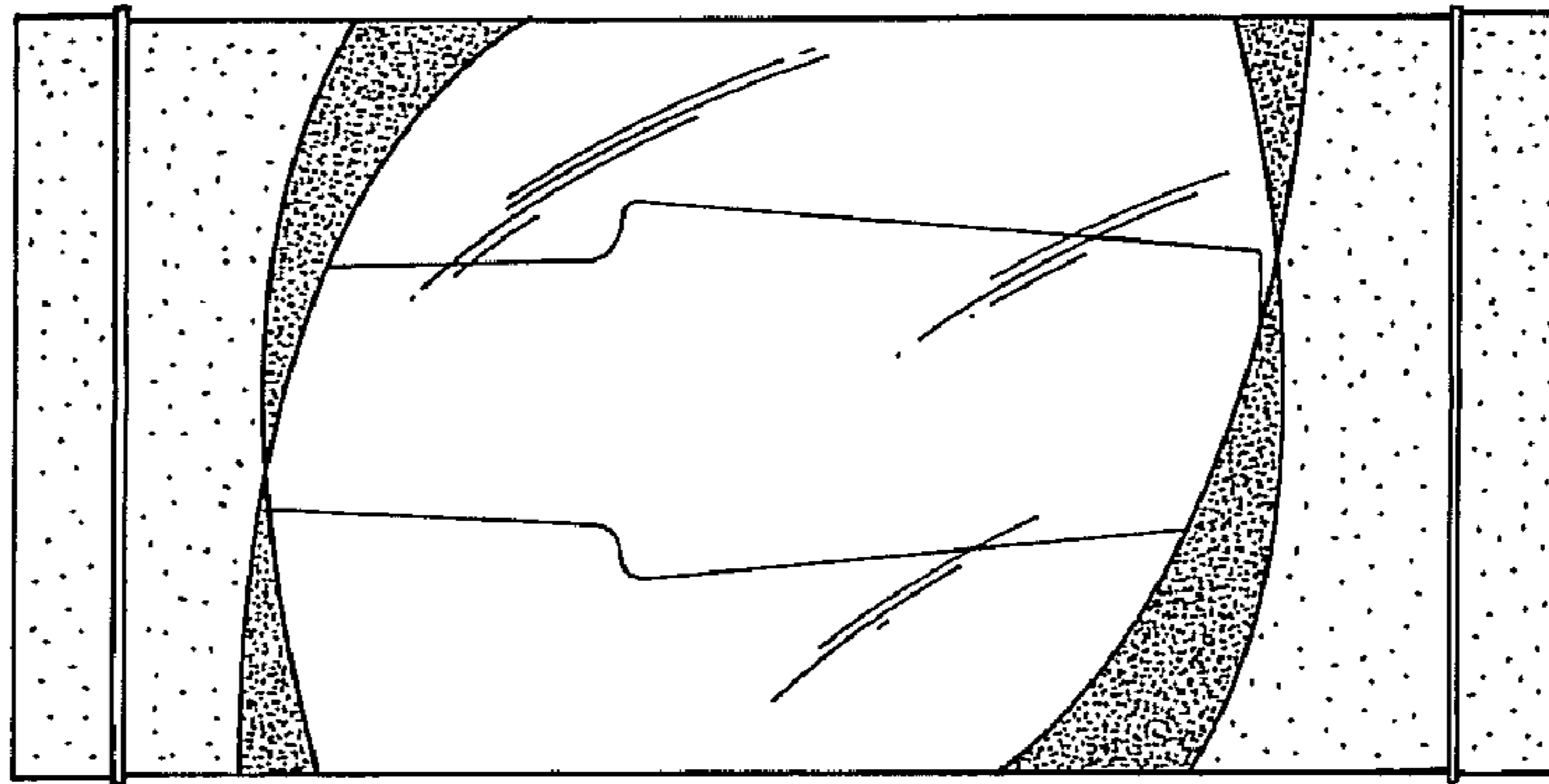

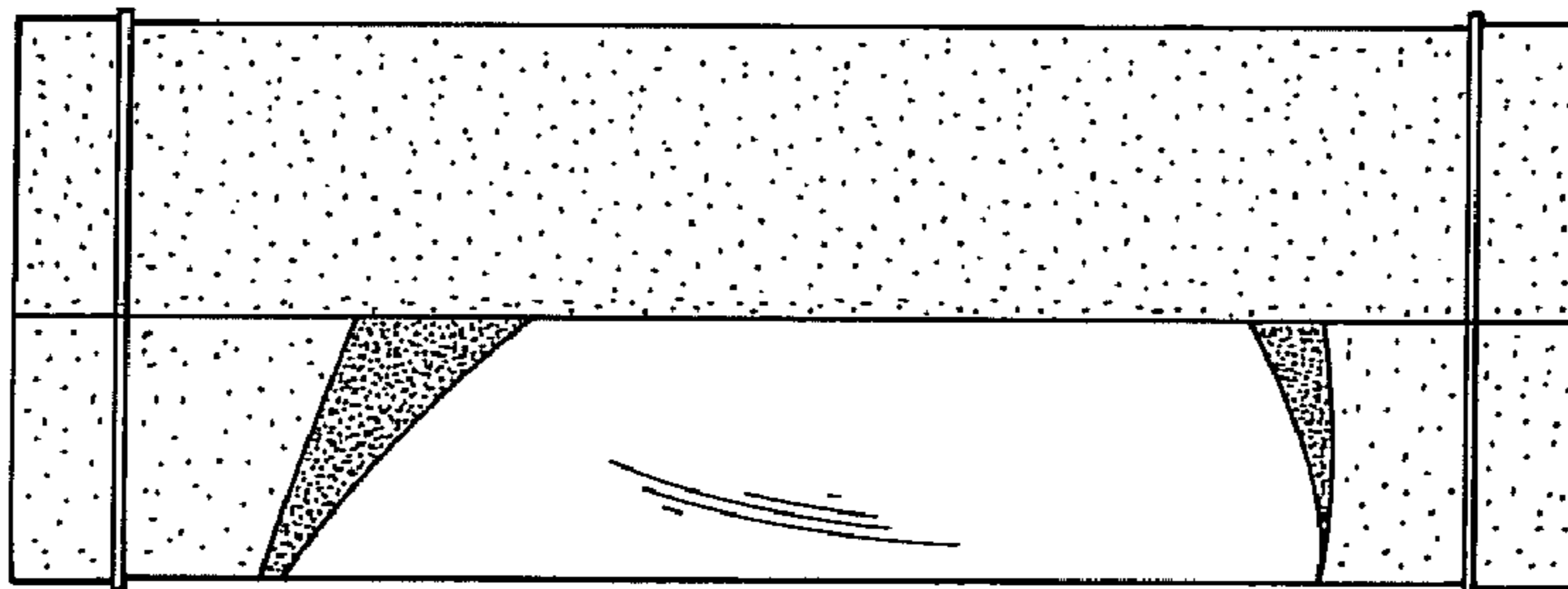

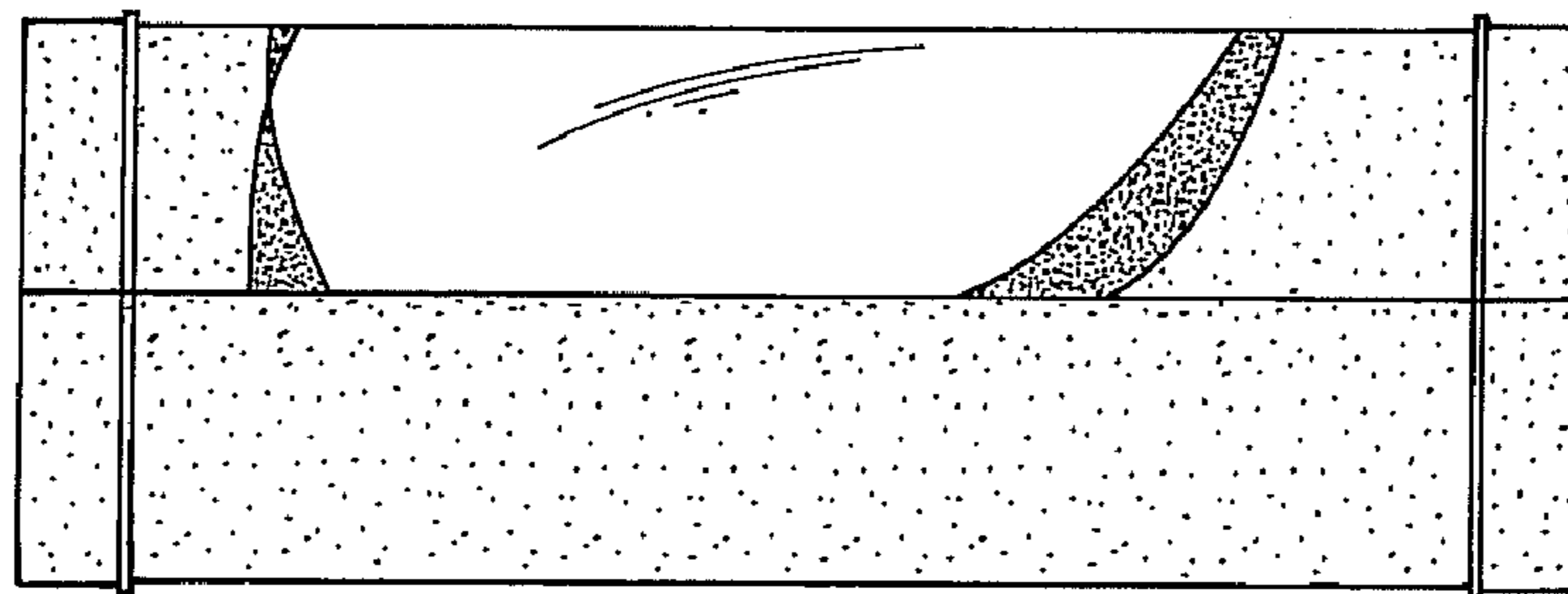

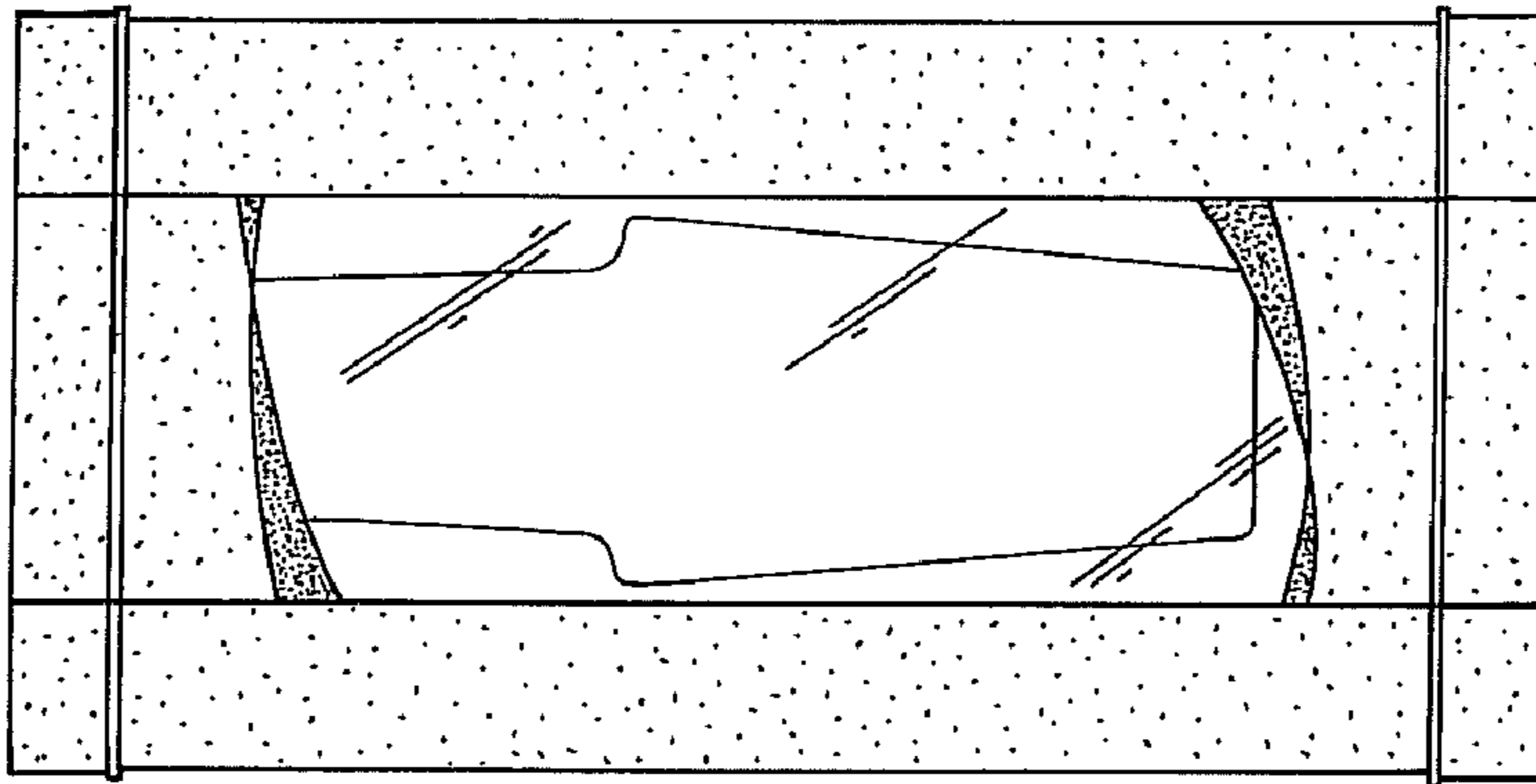

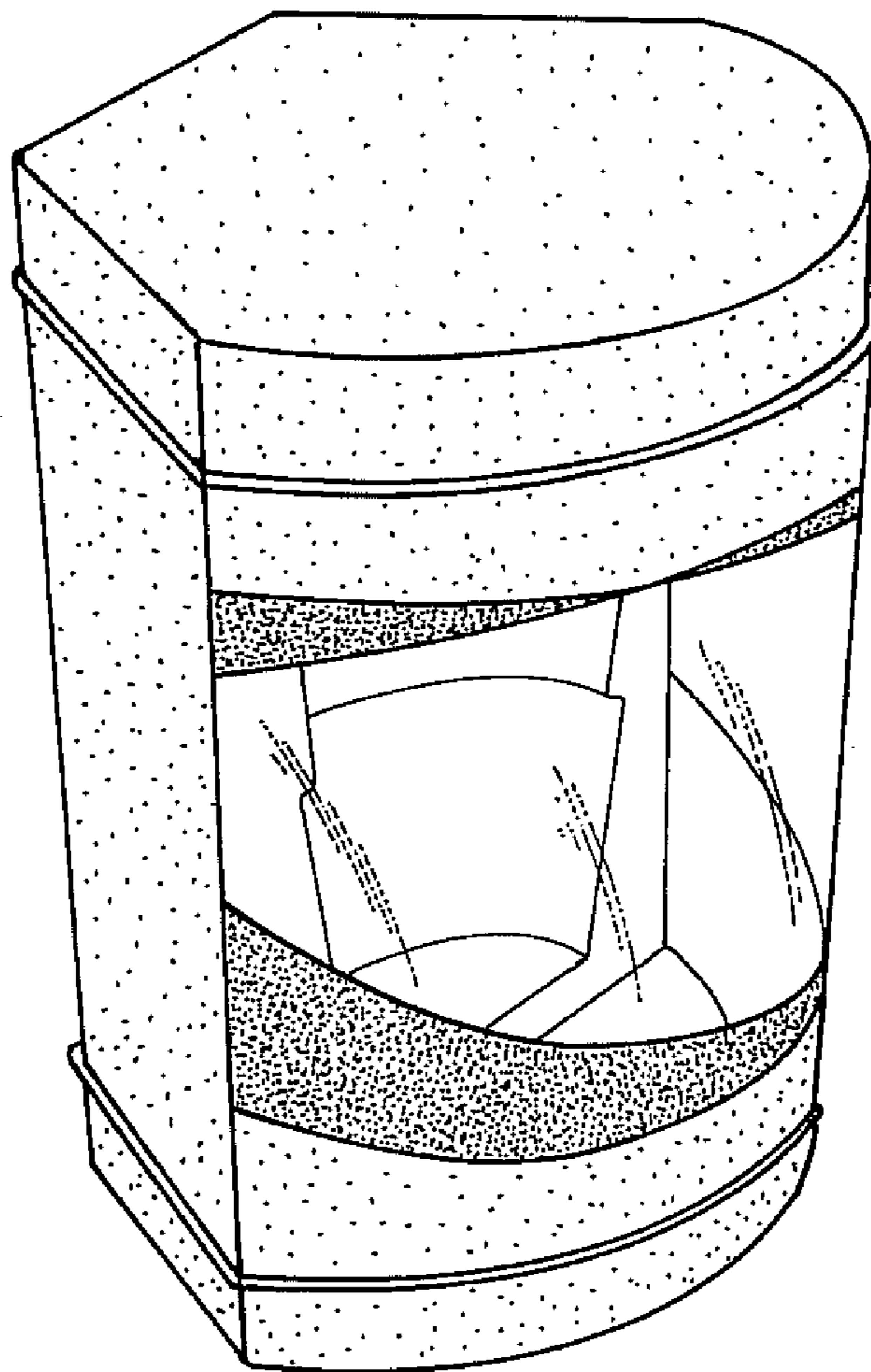

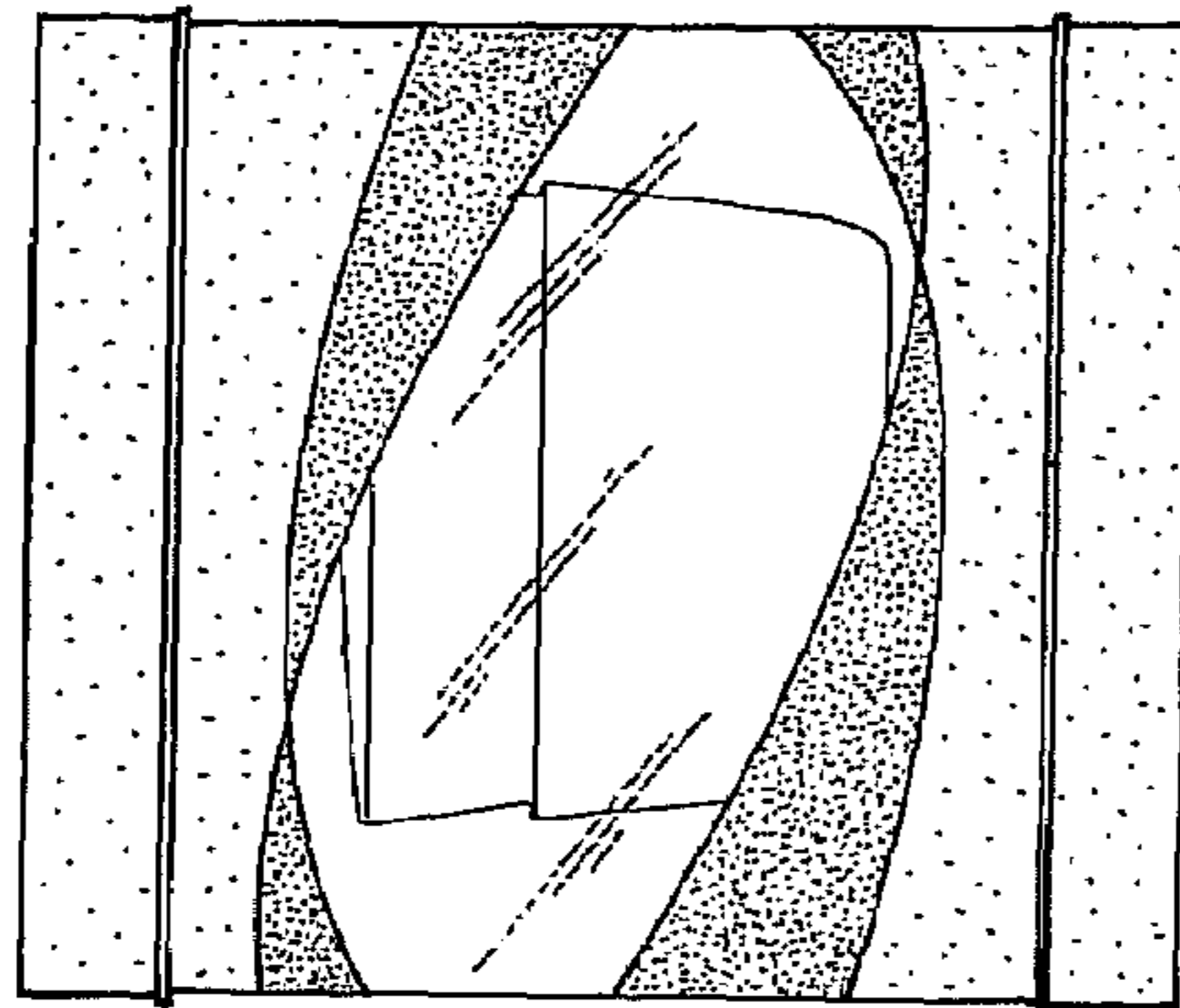

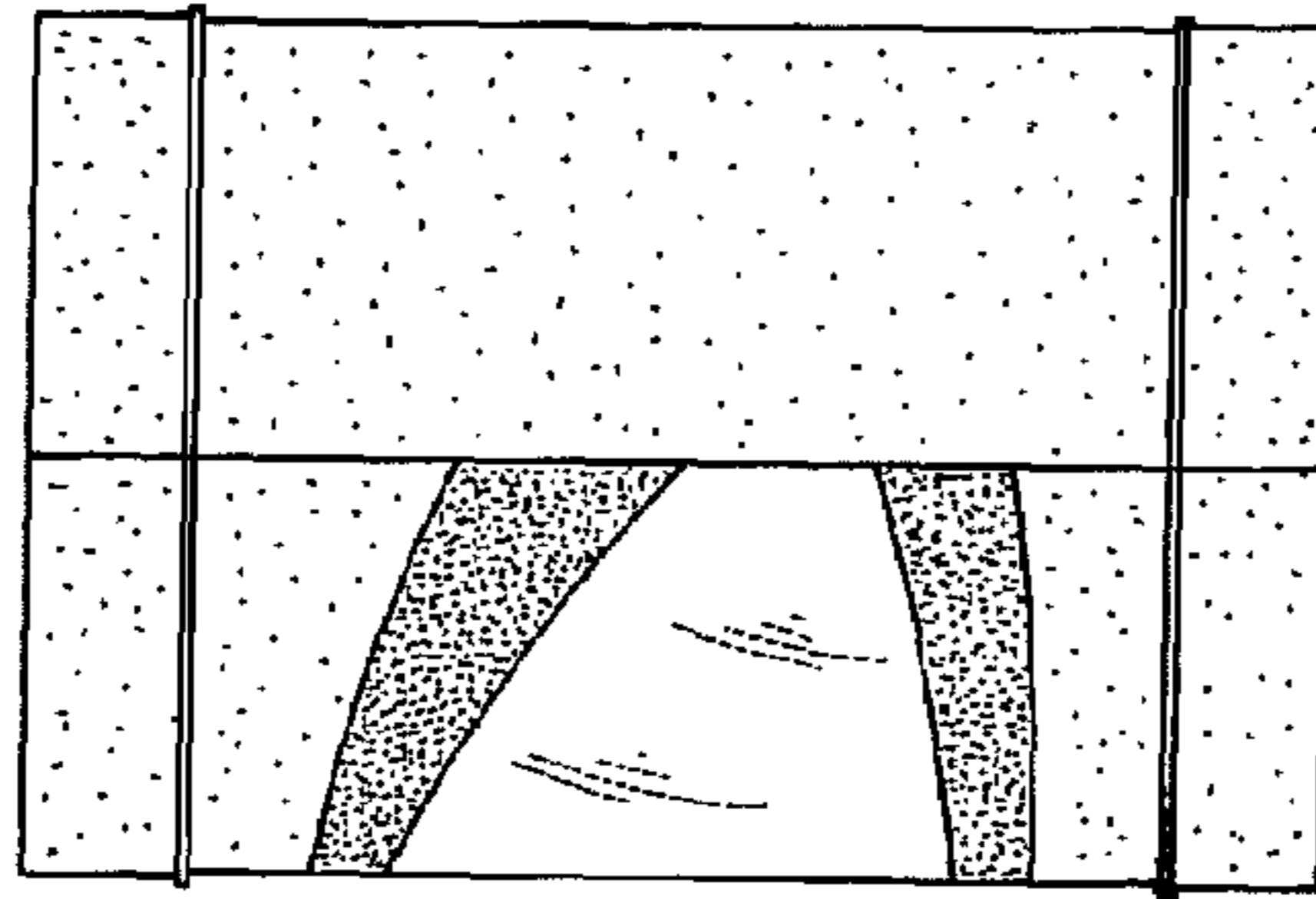

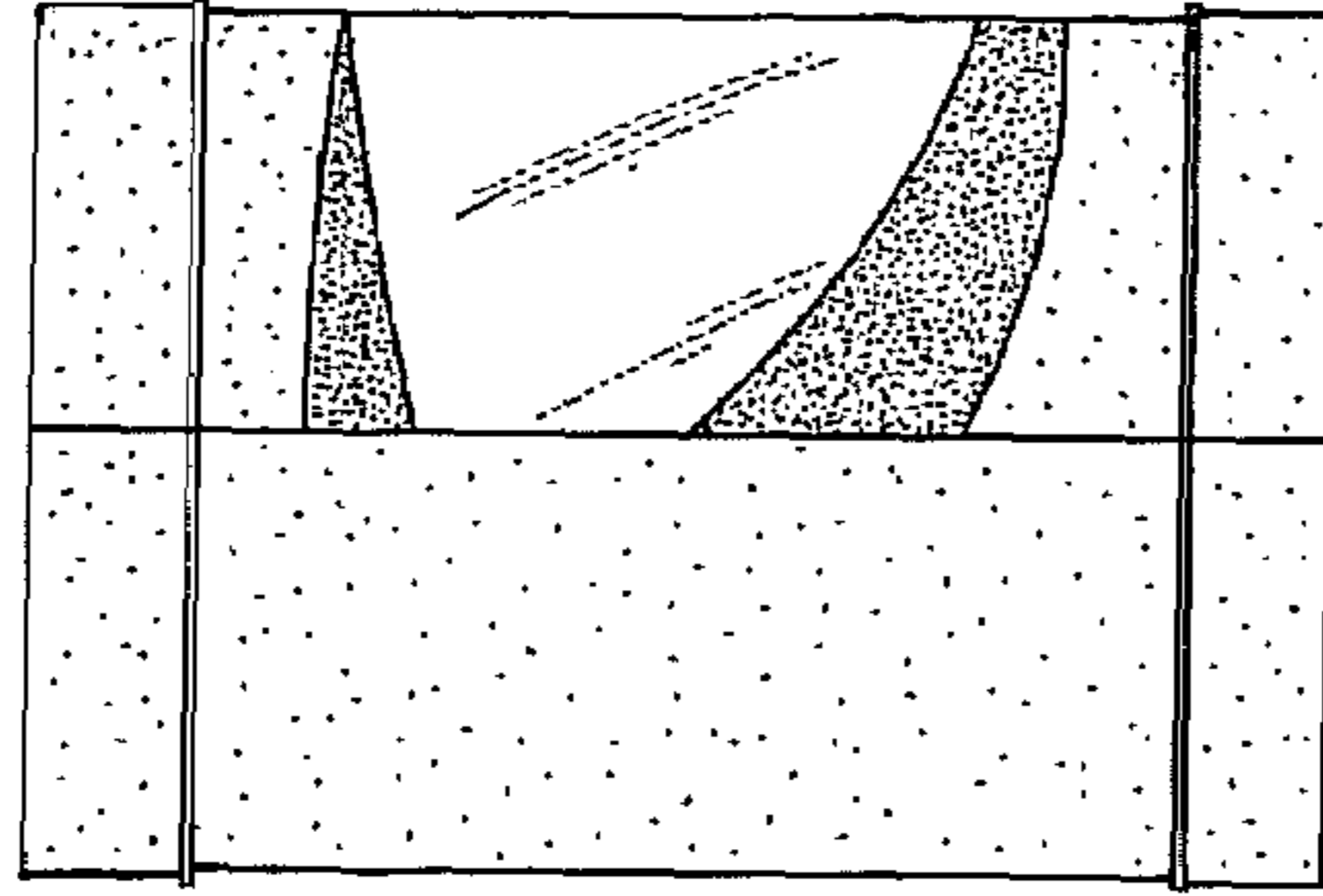

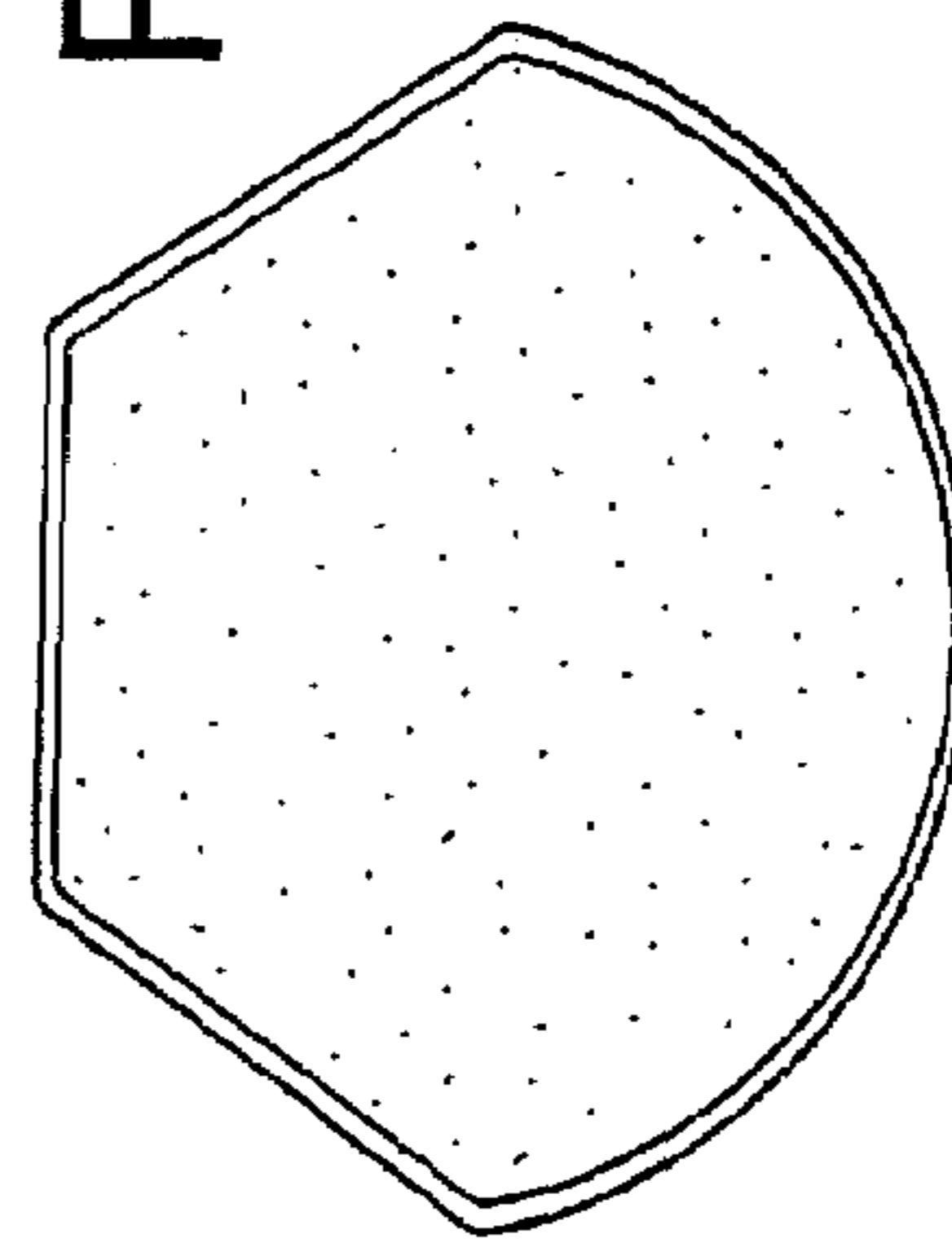
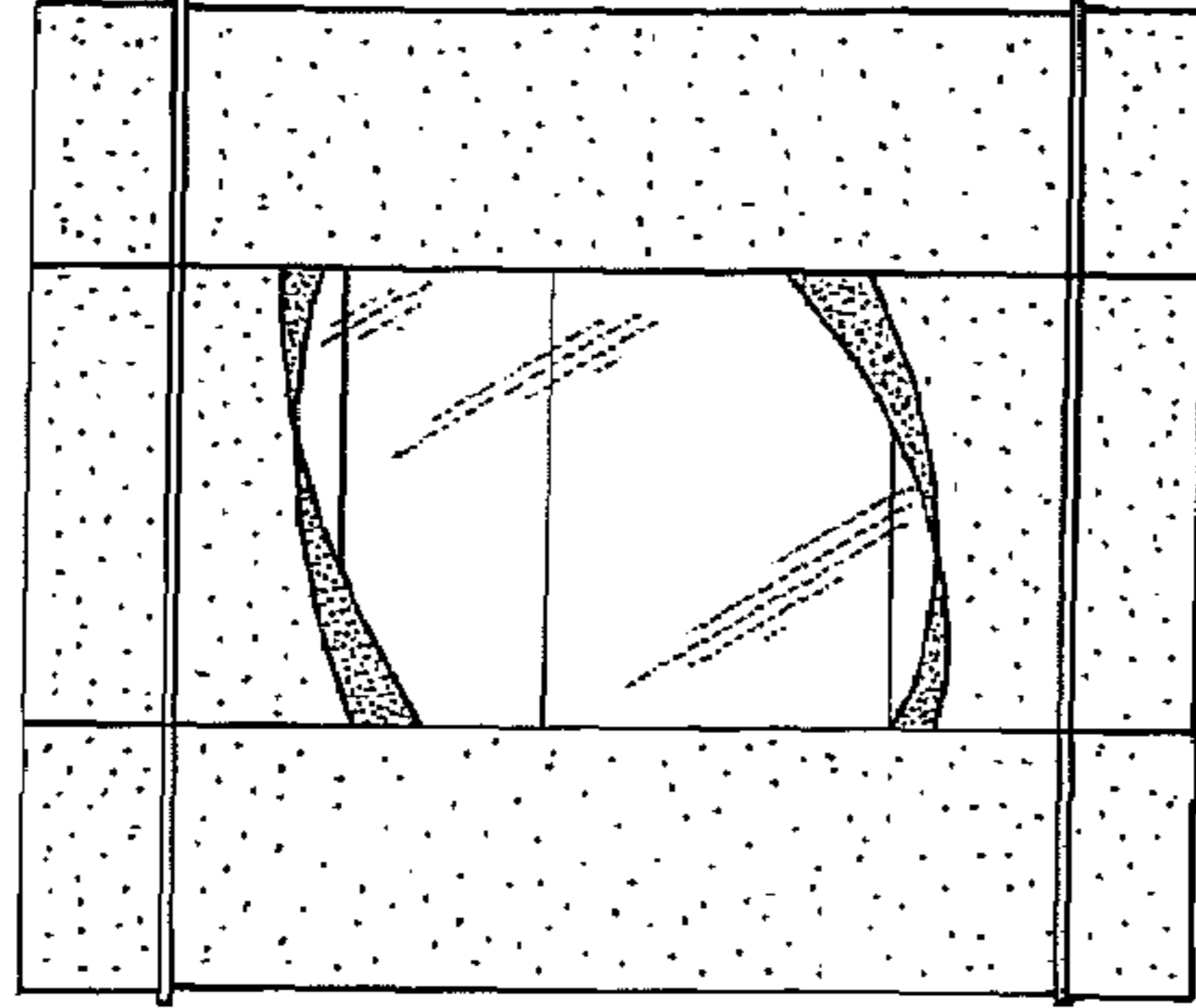

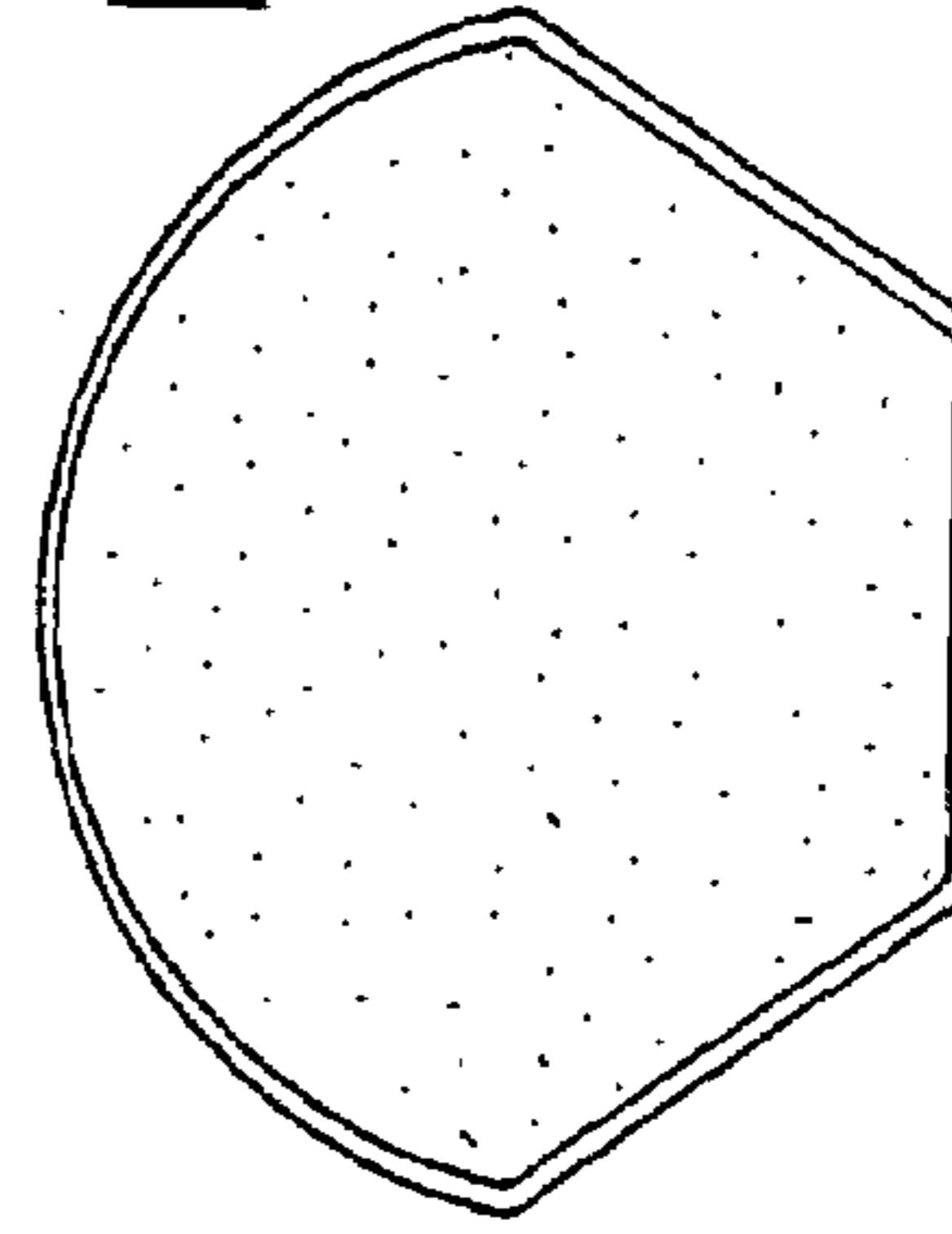

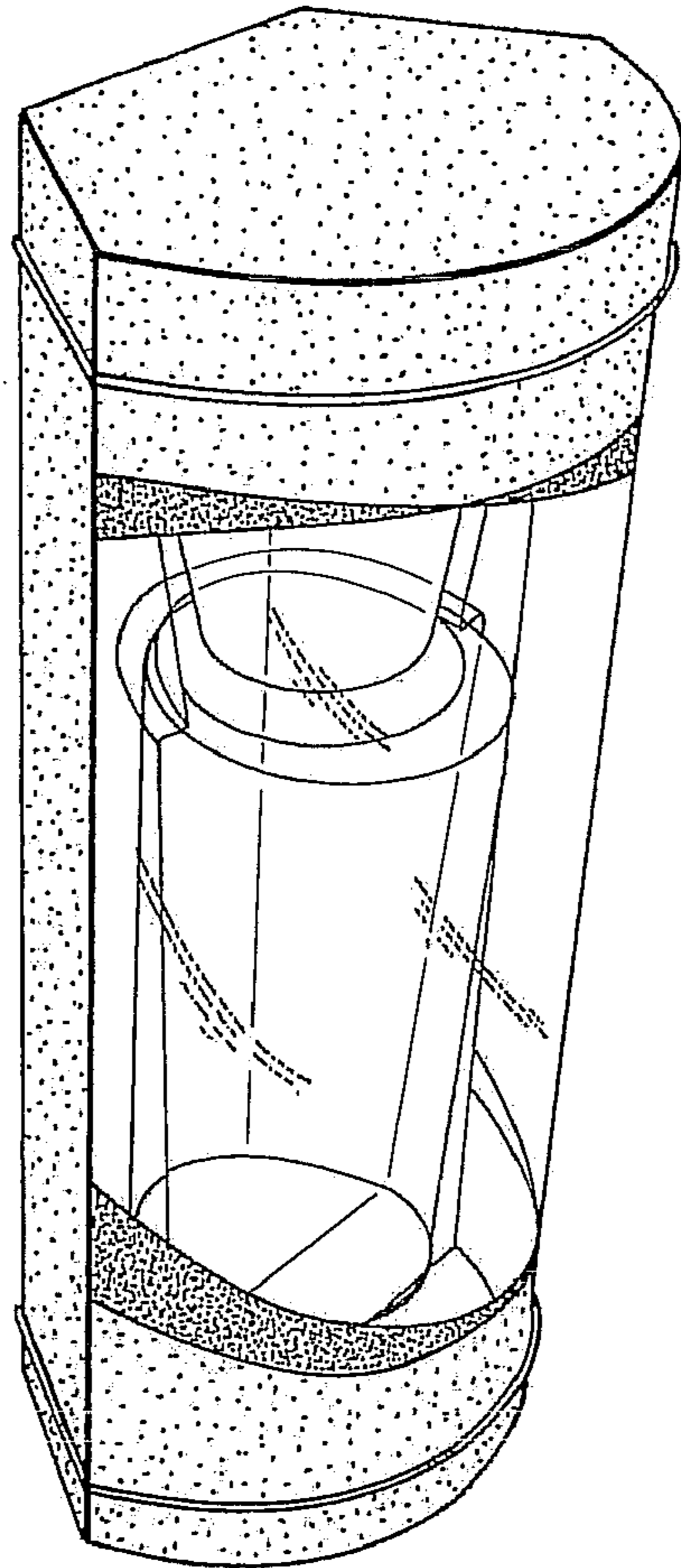

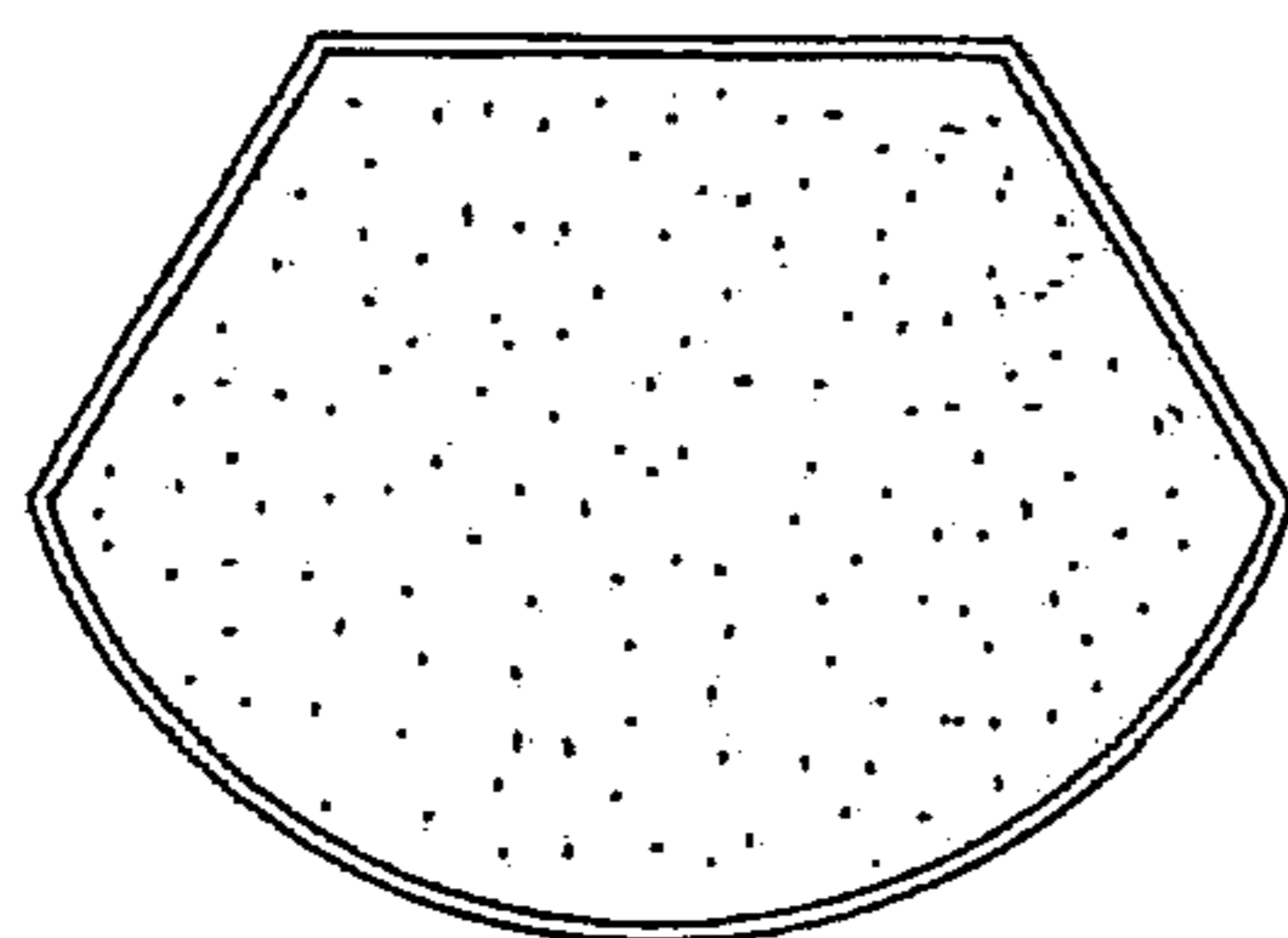

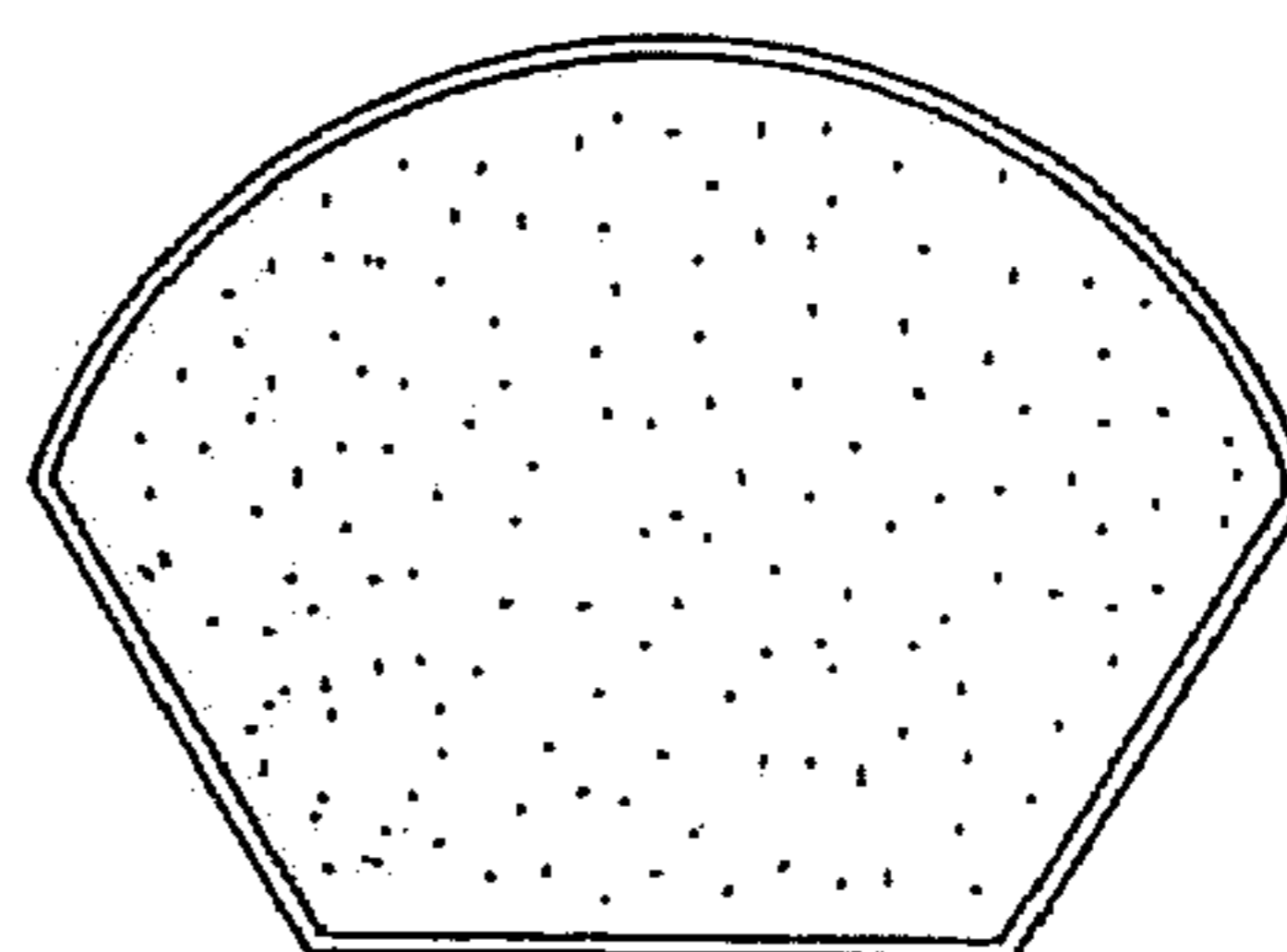

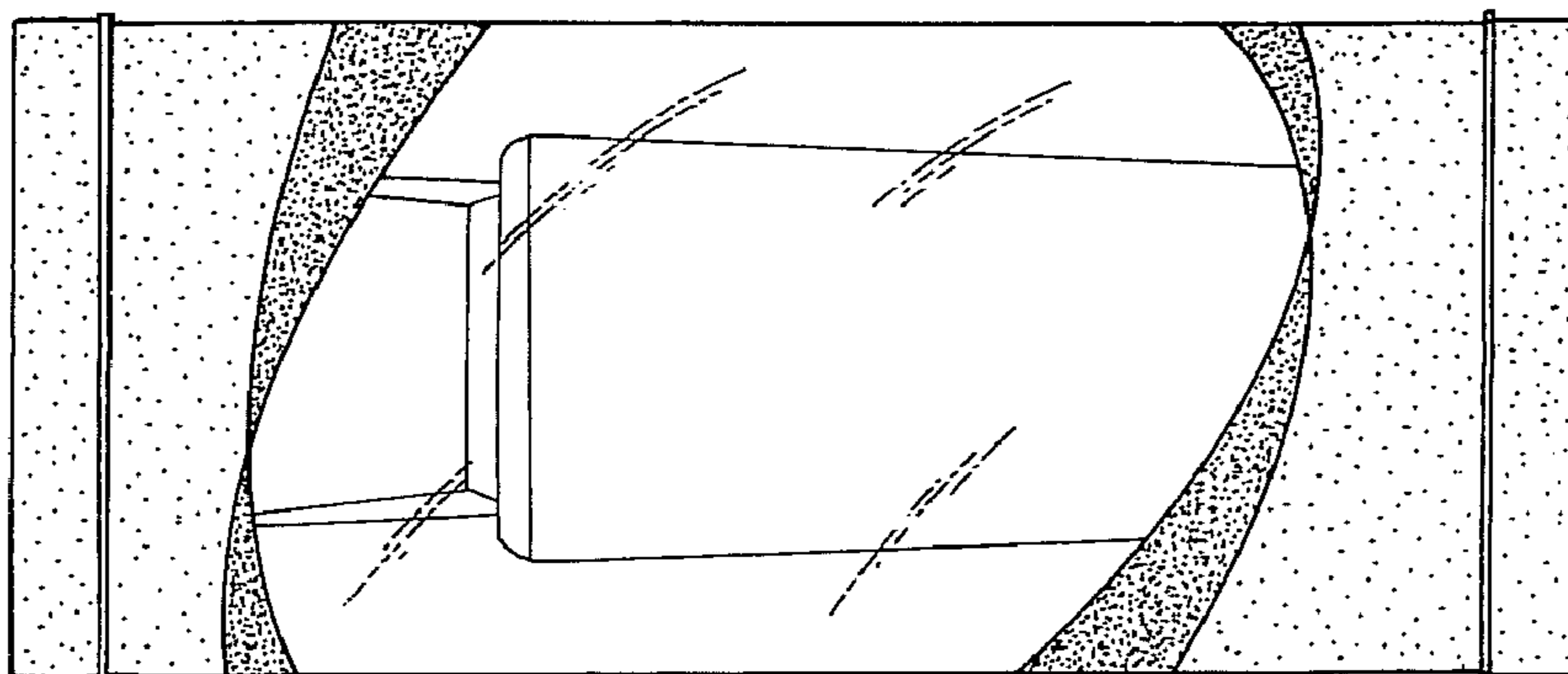

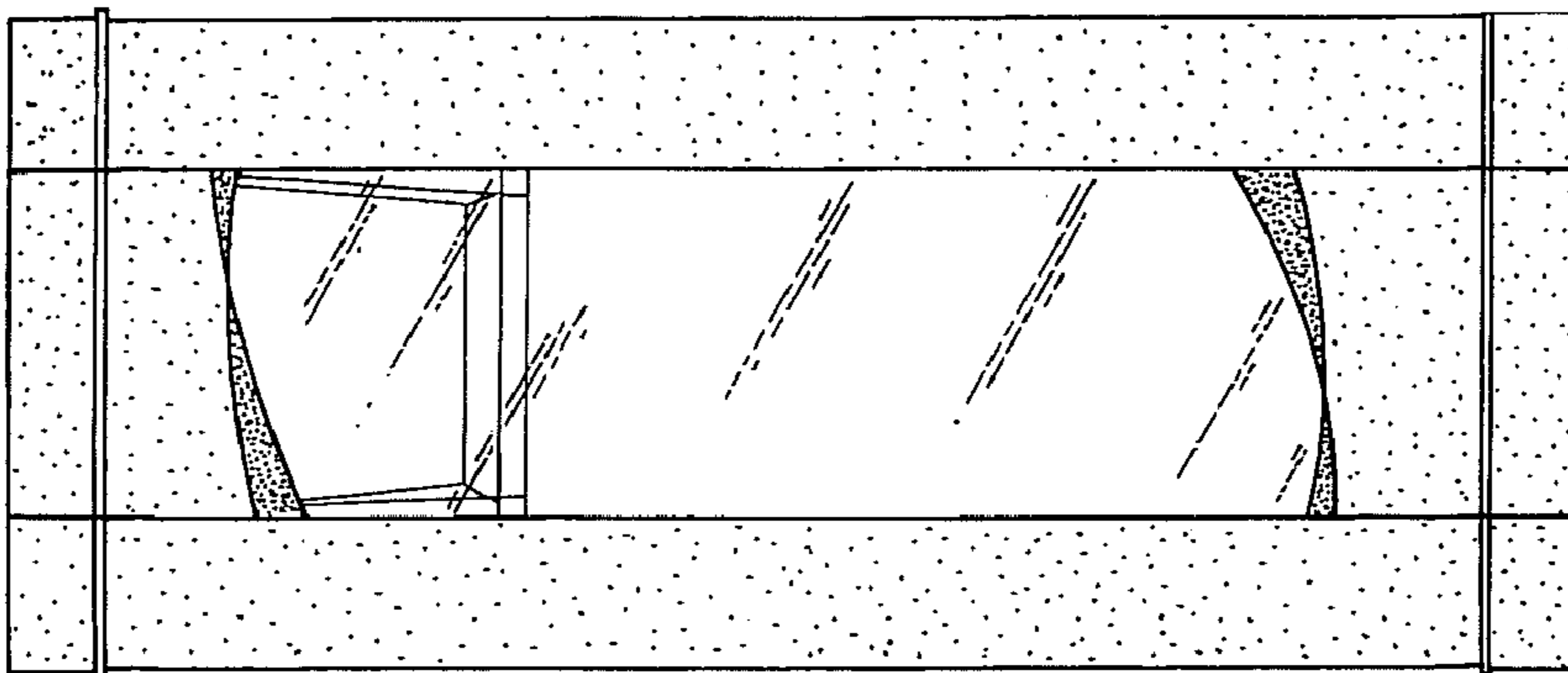

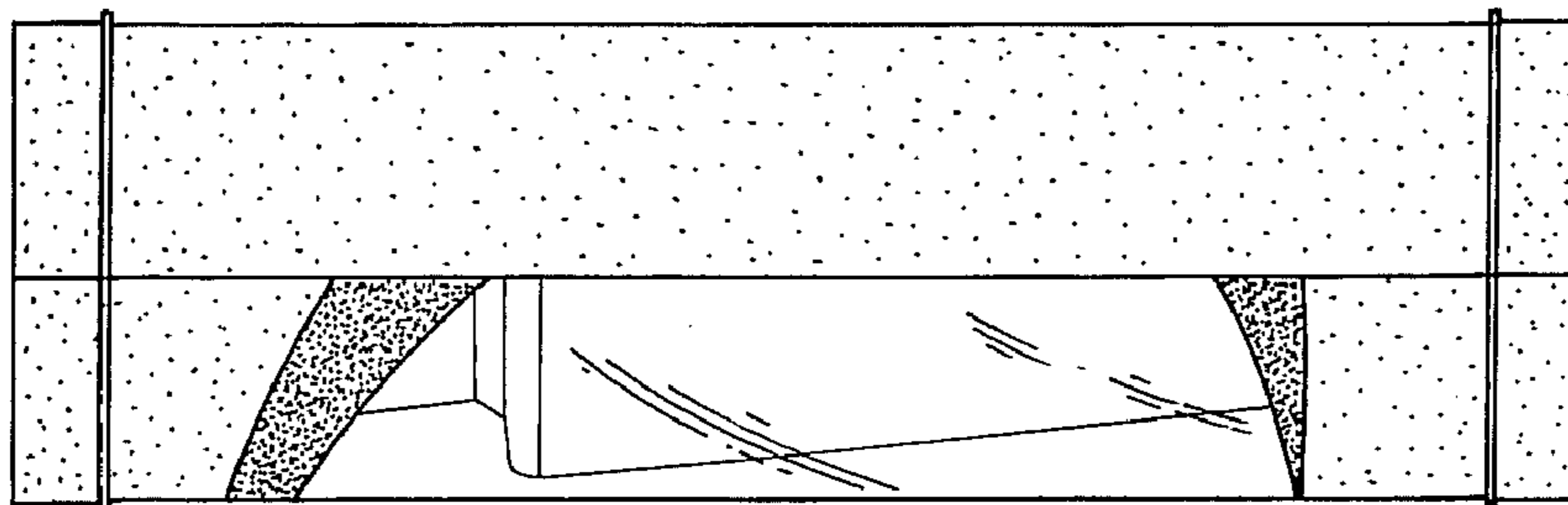

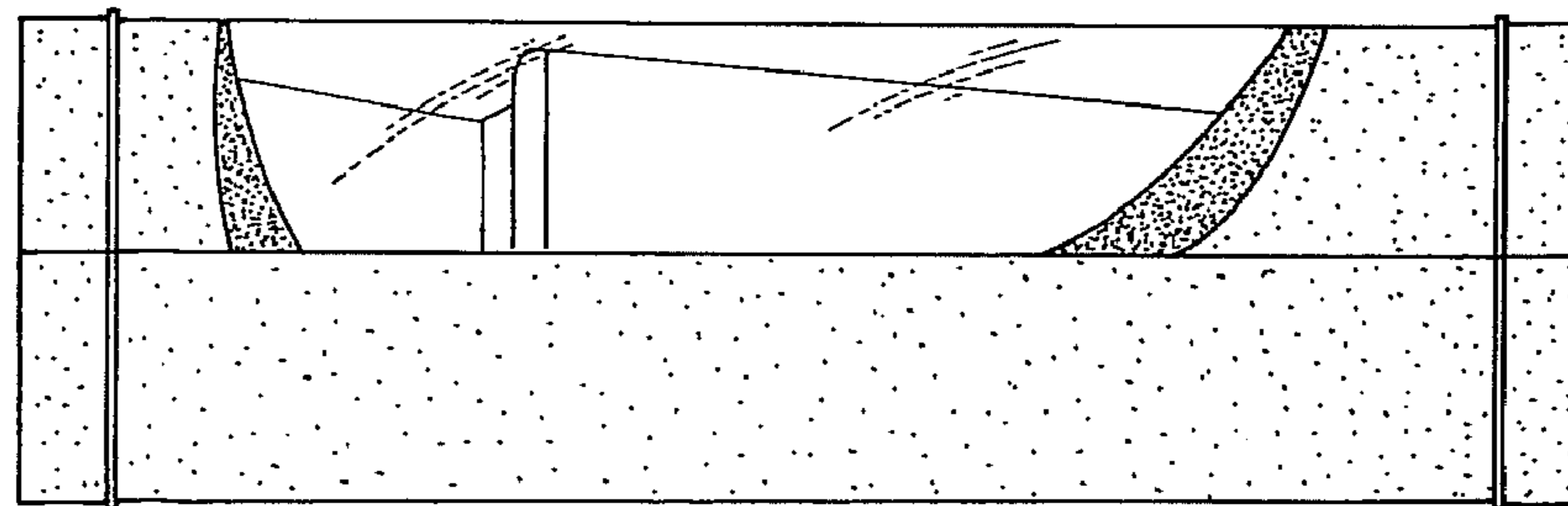

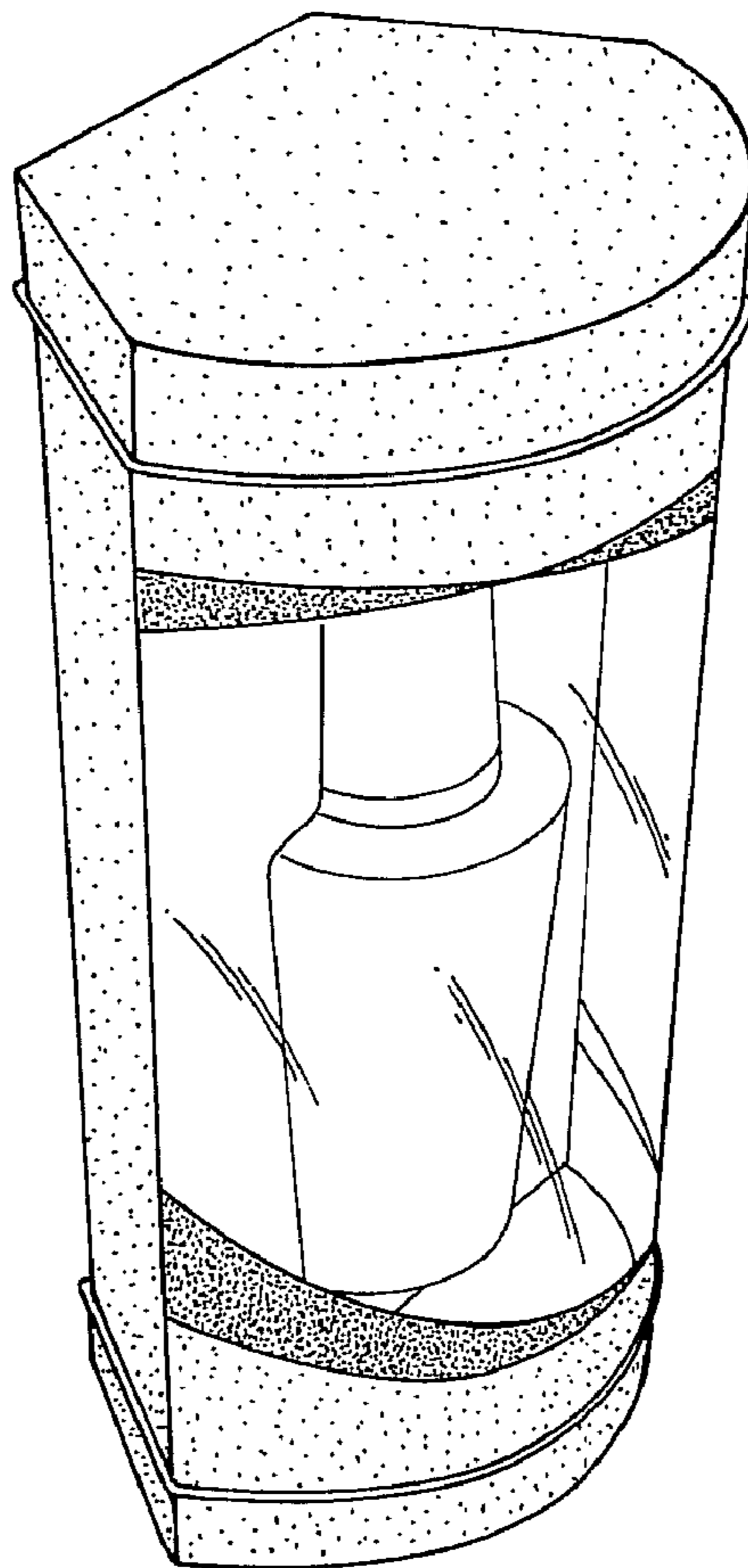

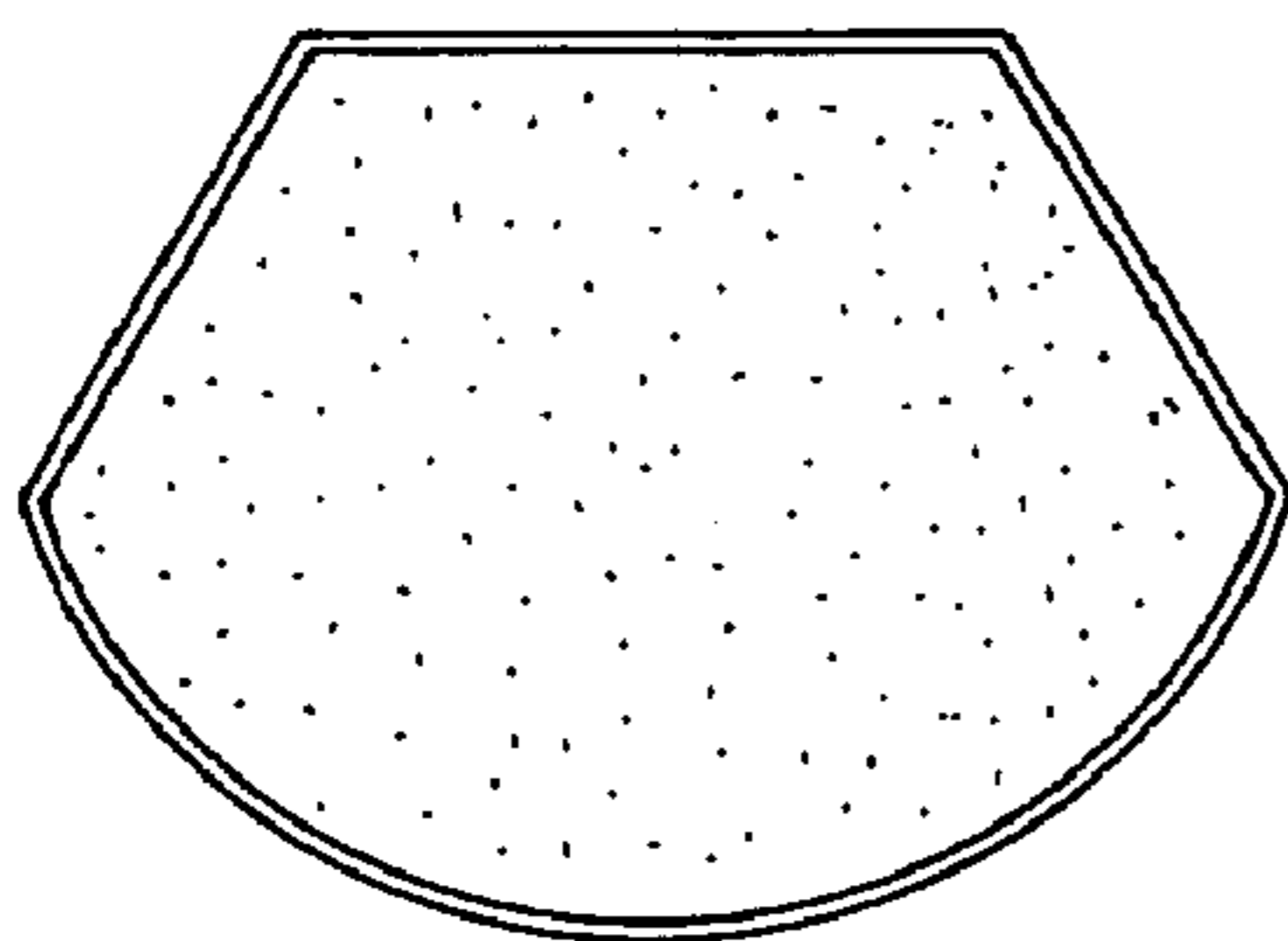

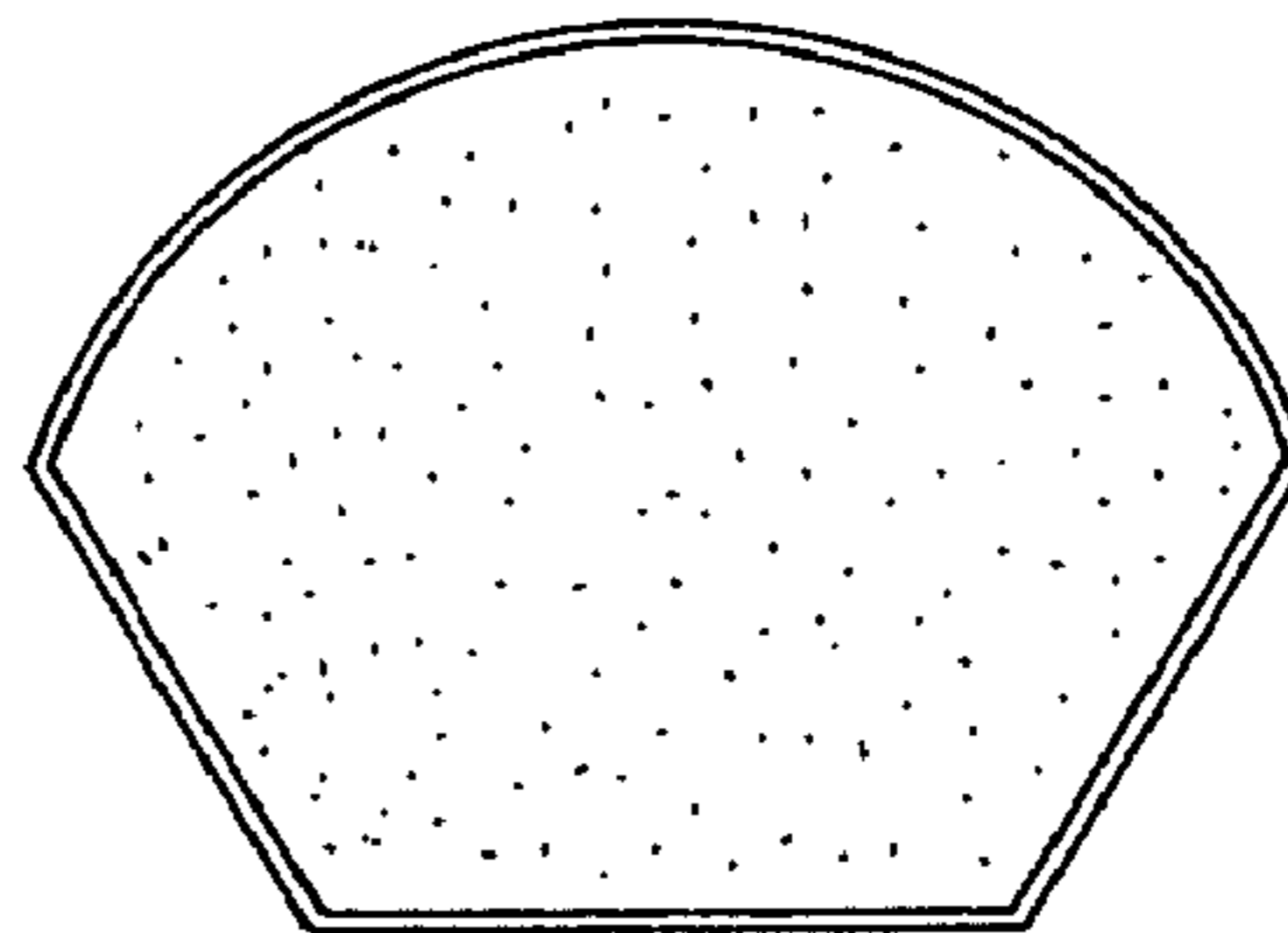

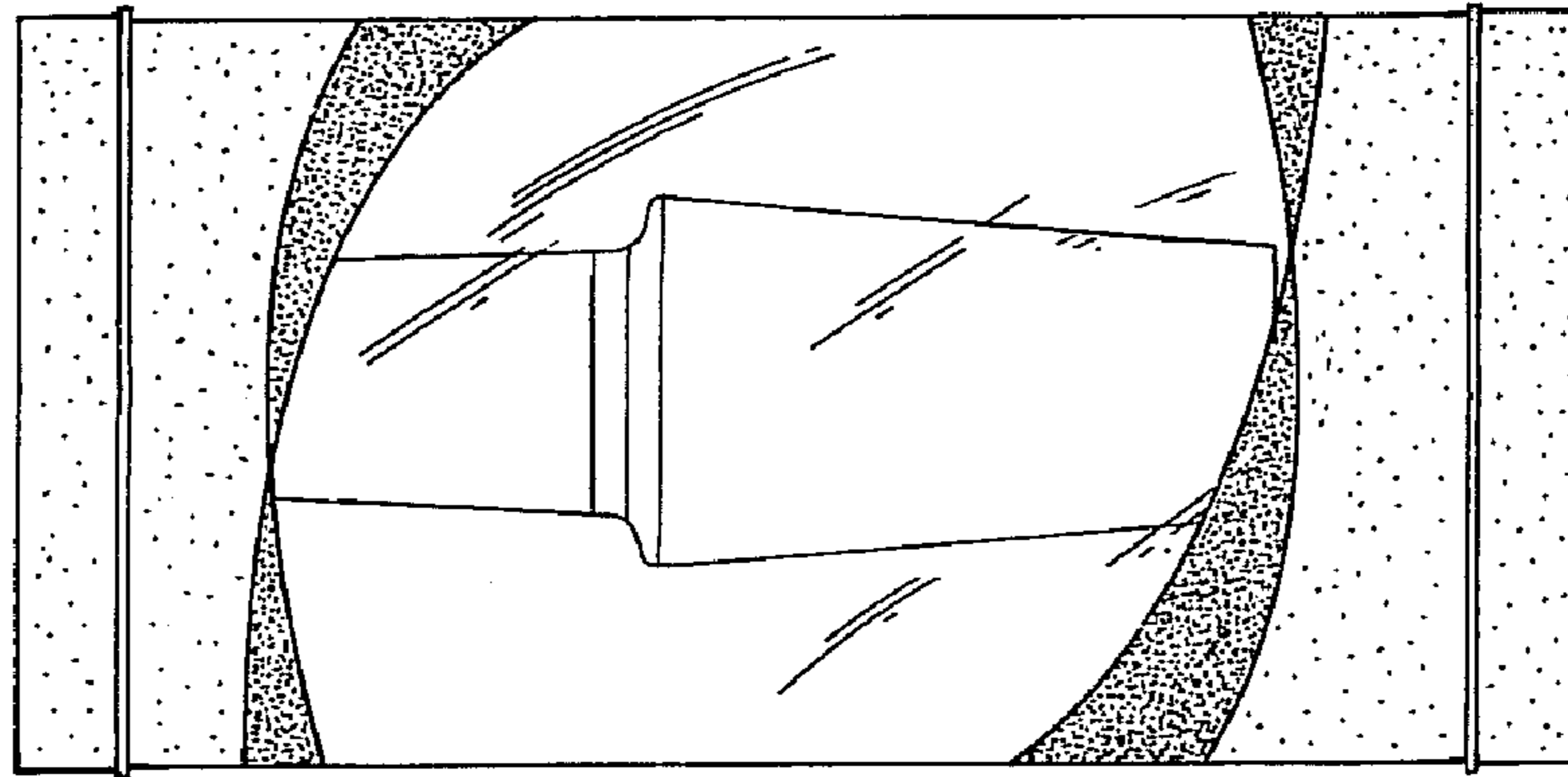

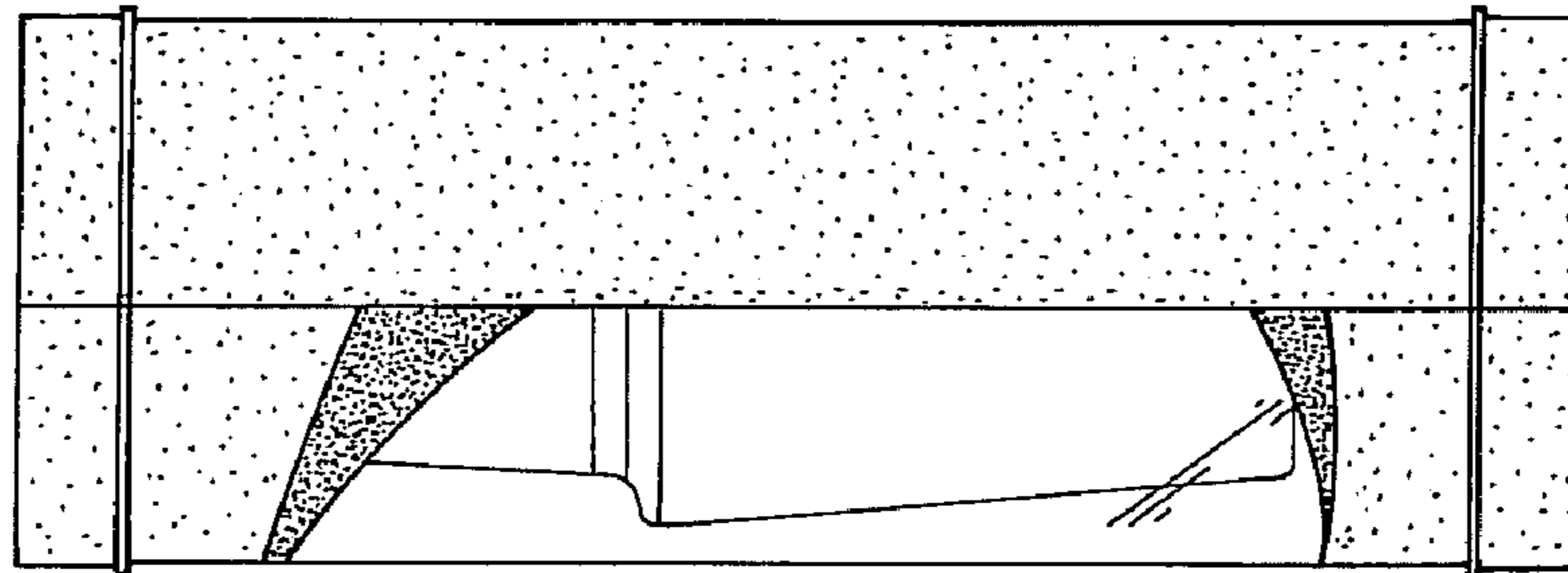

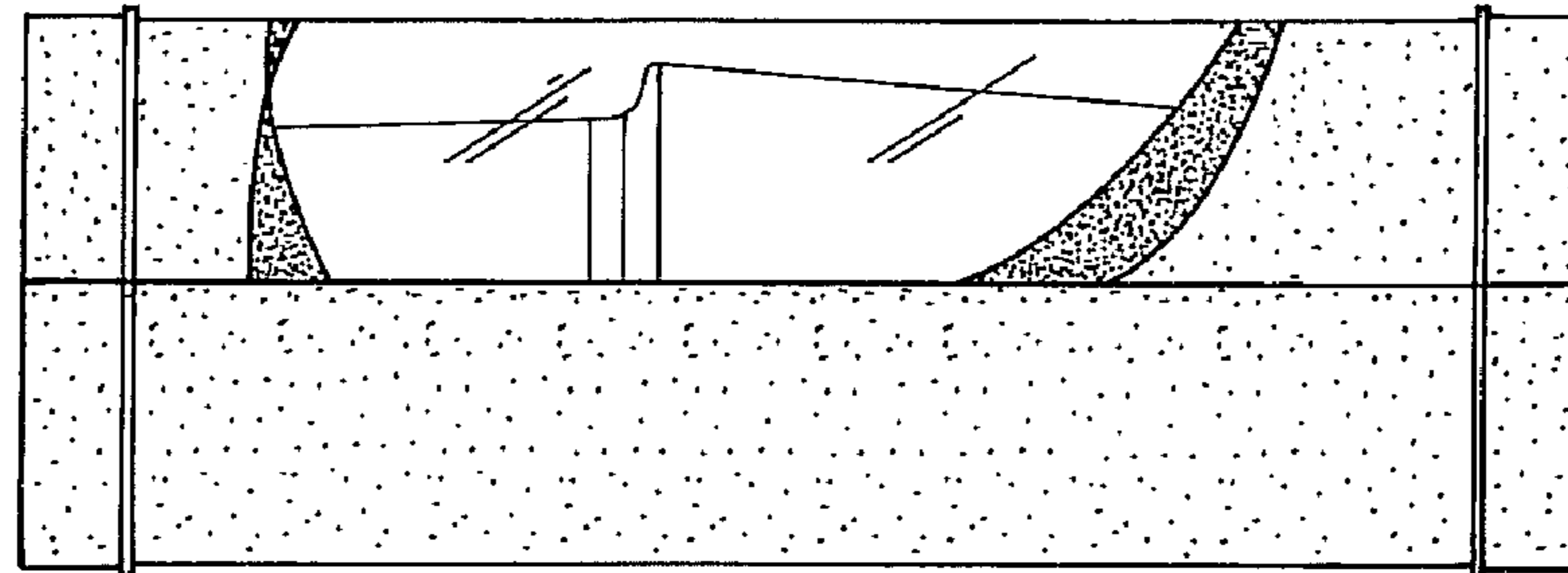

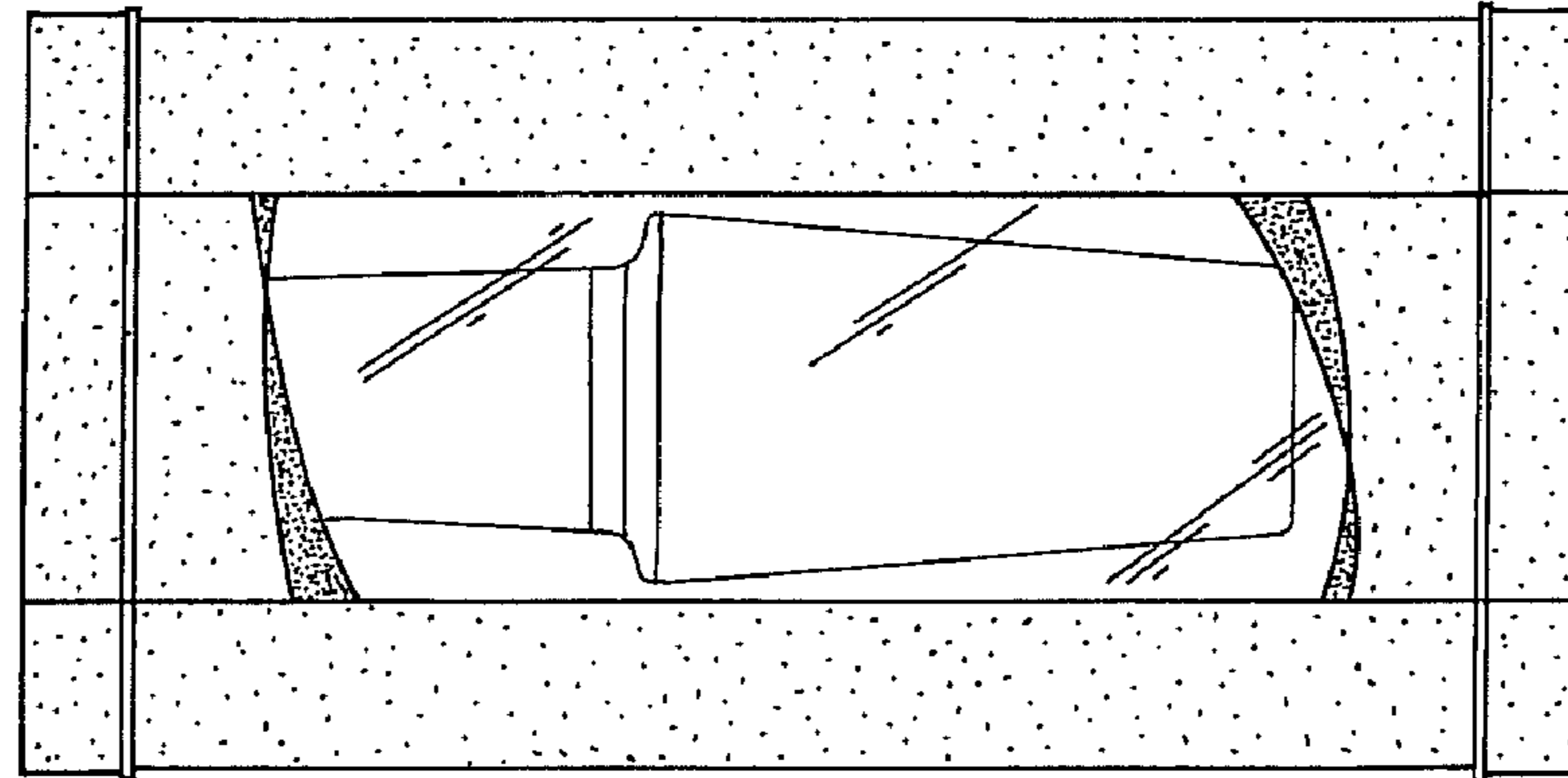

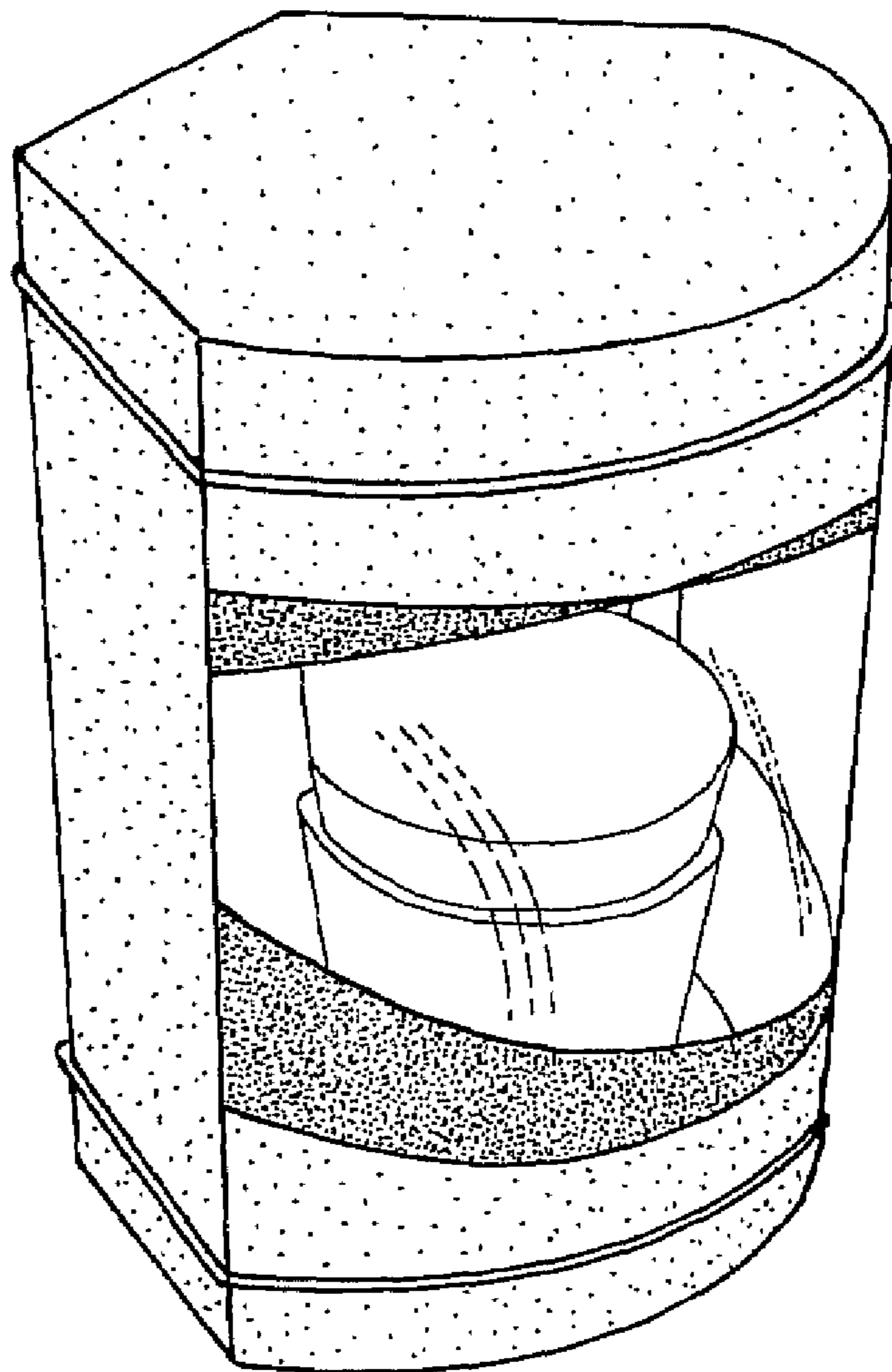

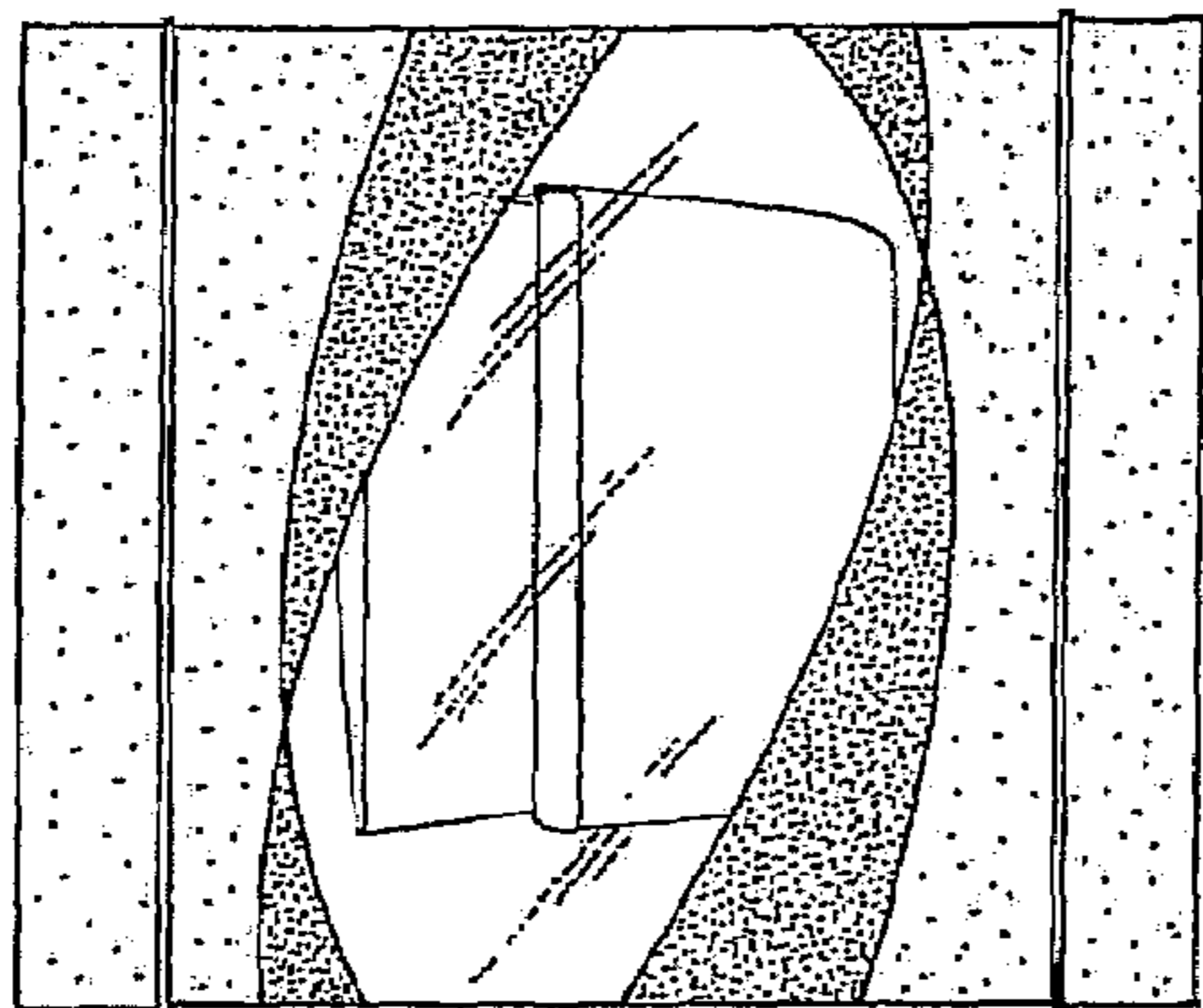

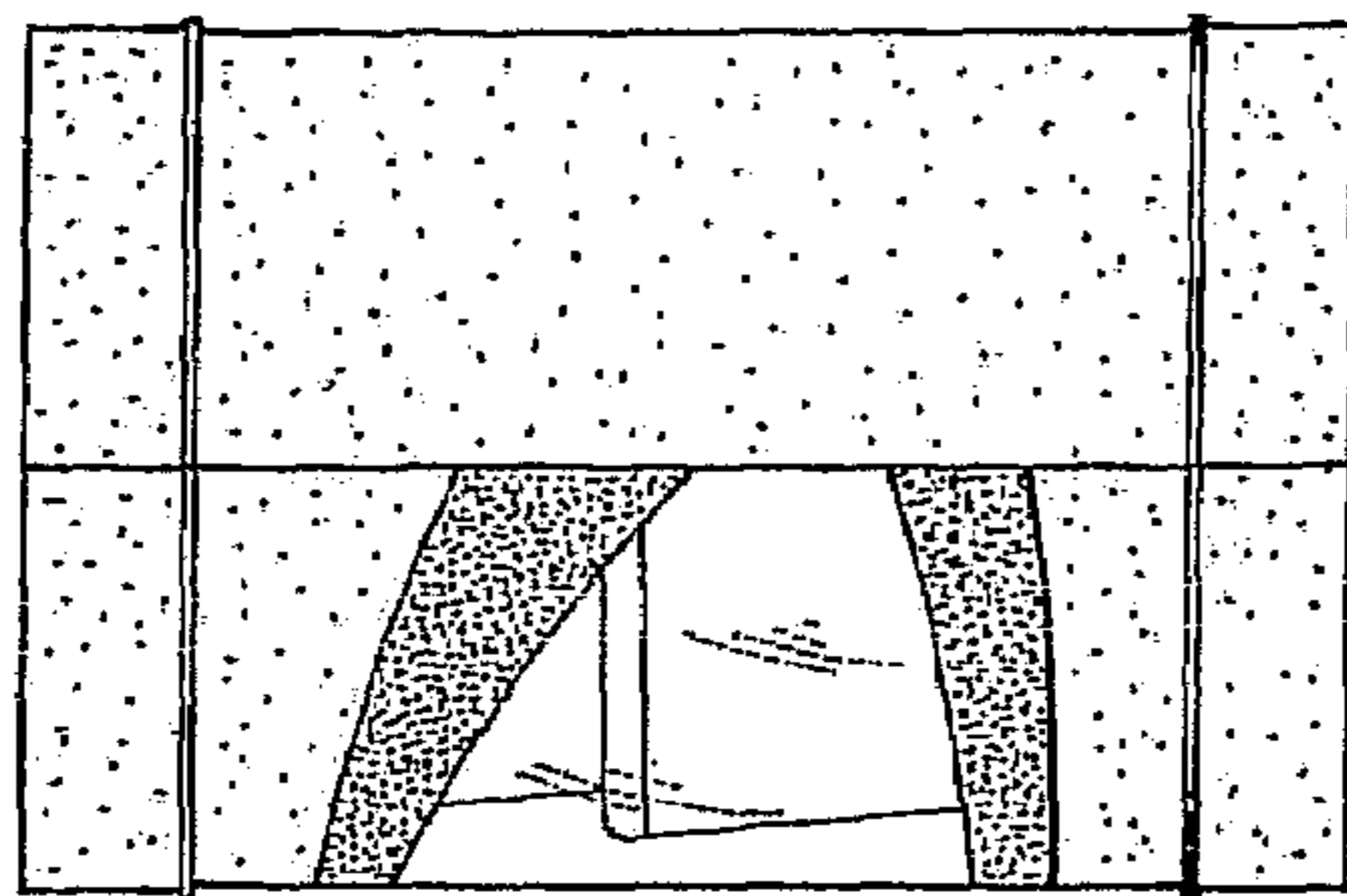

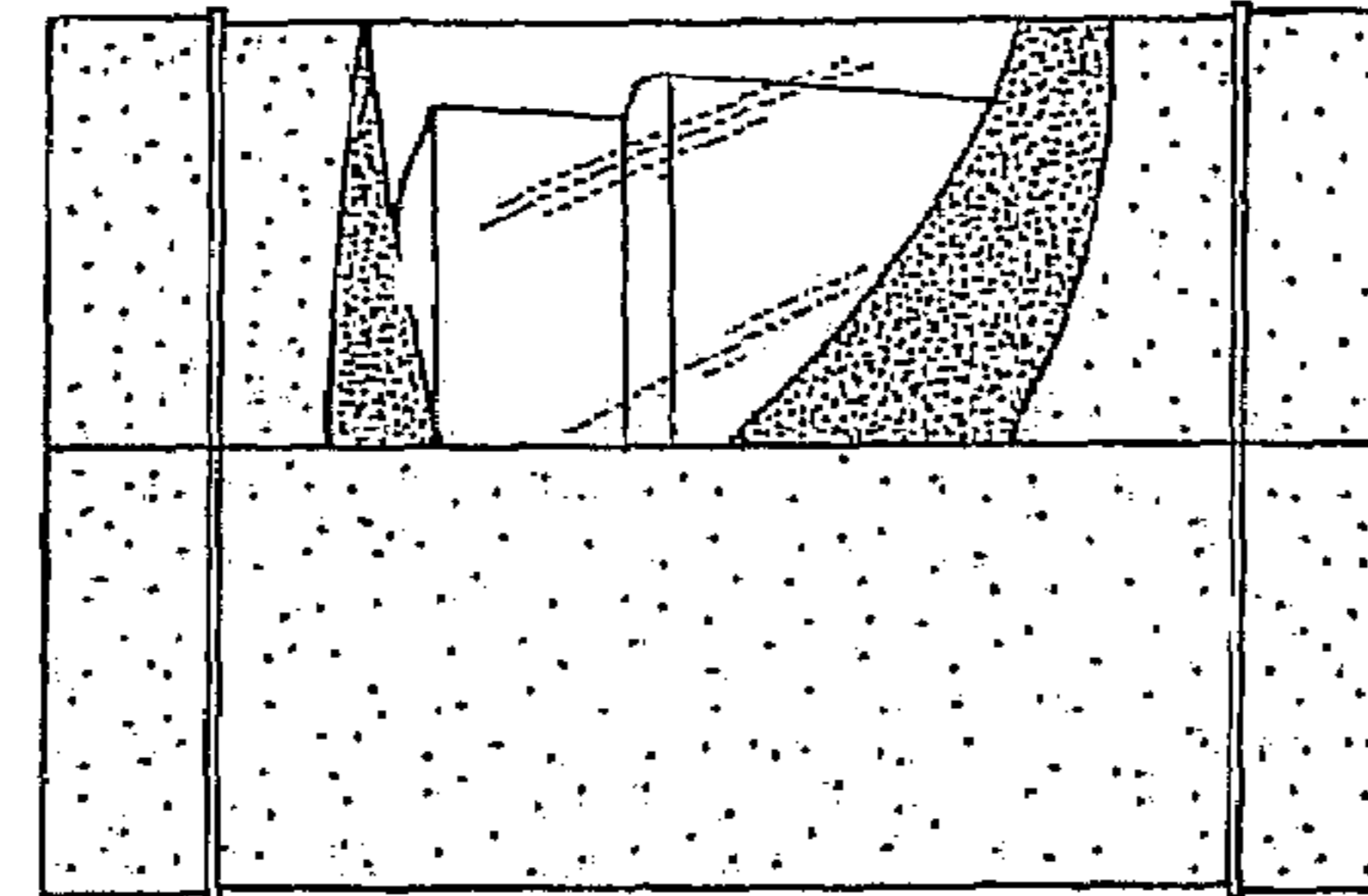

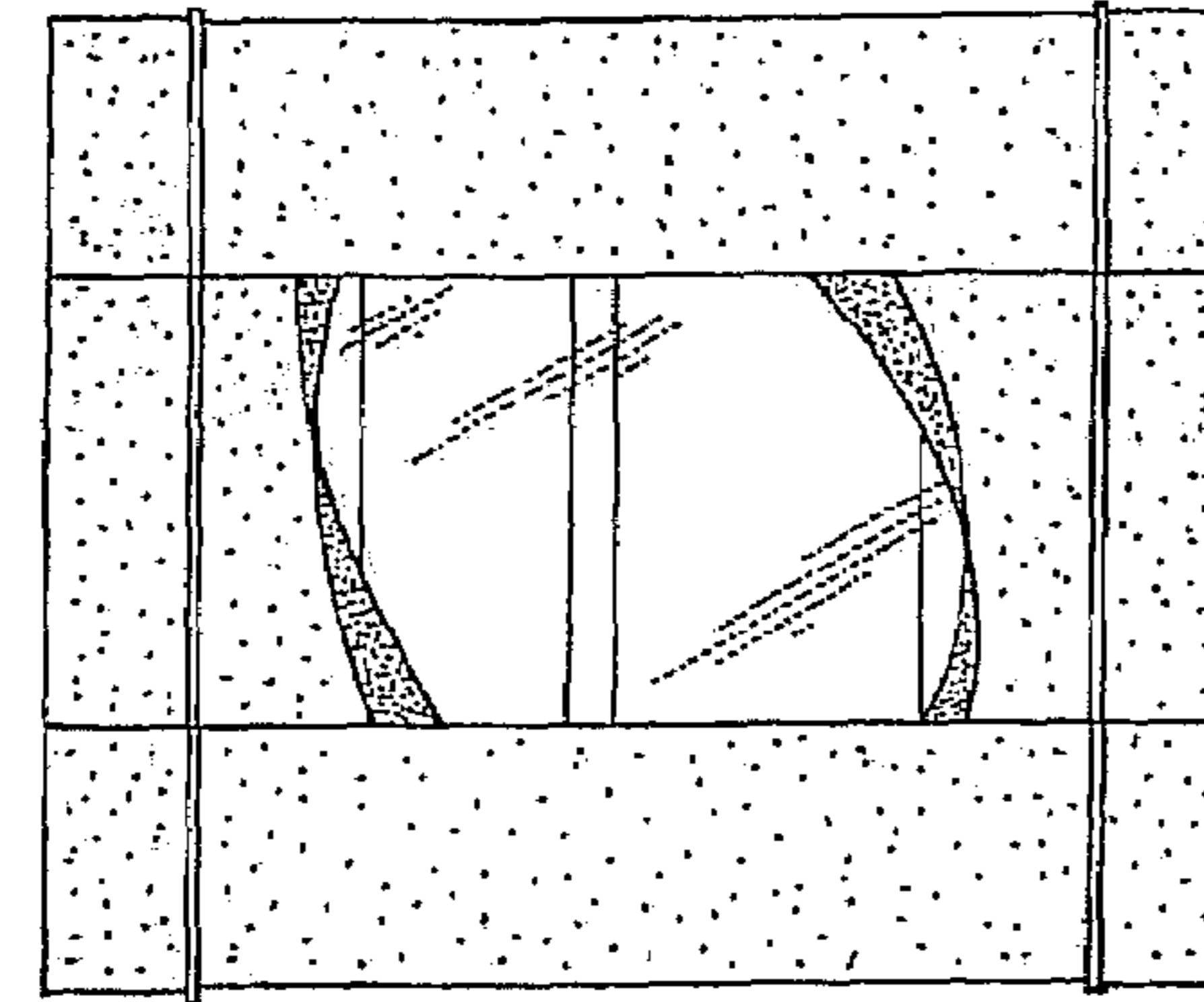

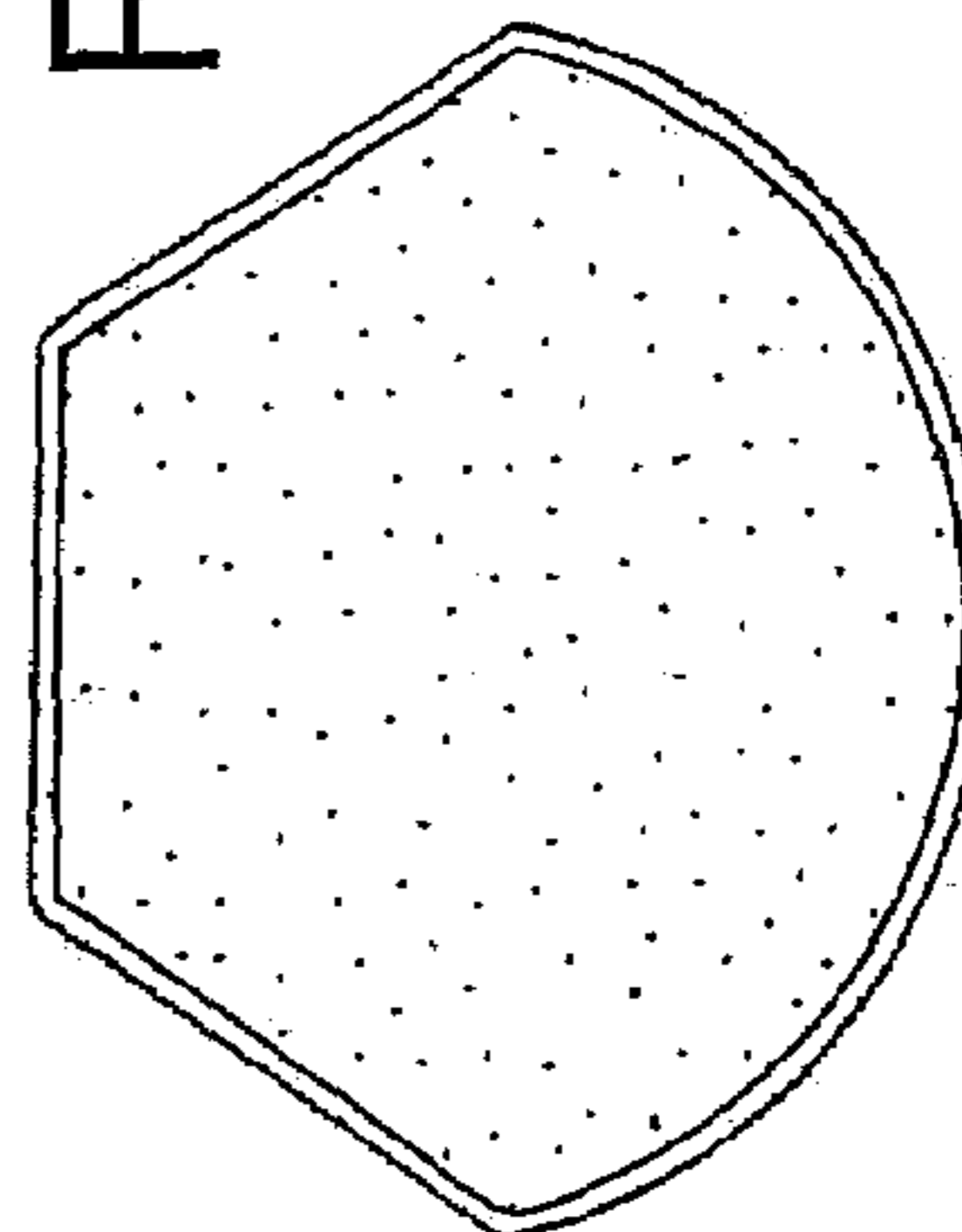
