FIG. 1 is a top, front, and left side perspective view of a personal care dispenser showing the new design;

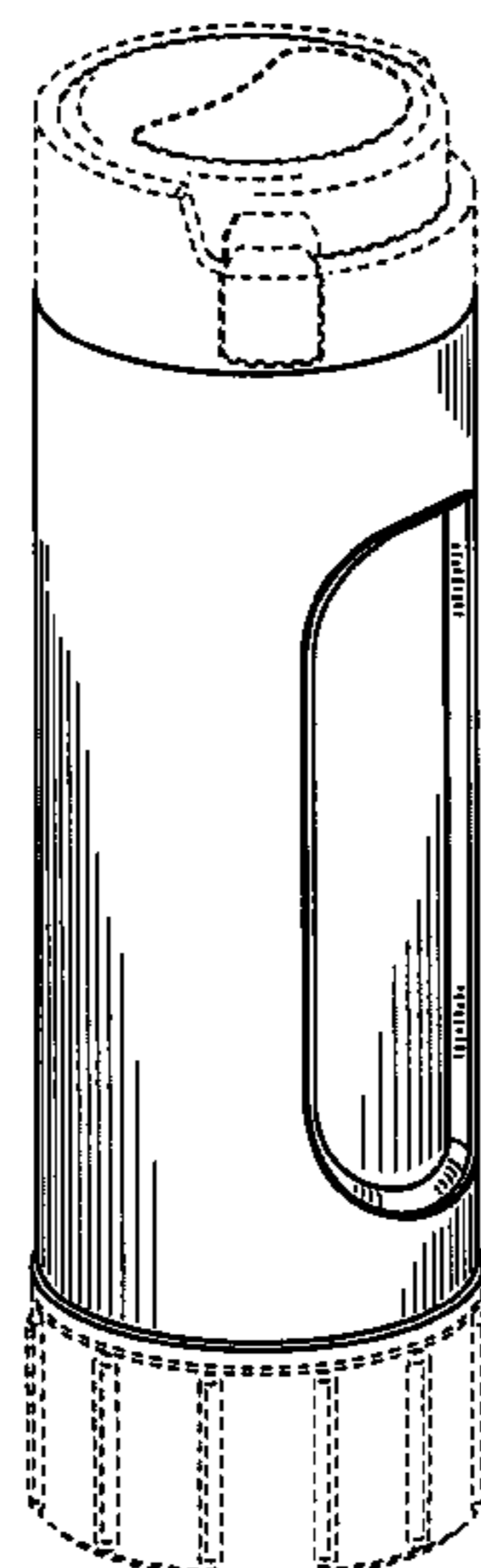
FIG. 2 is a front elevational view thereof;

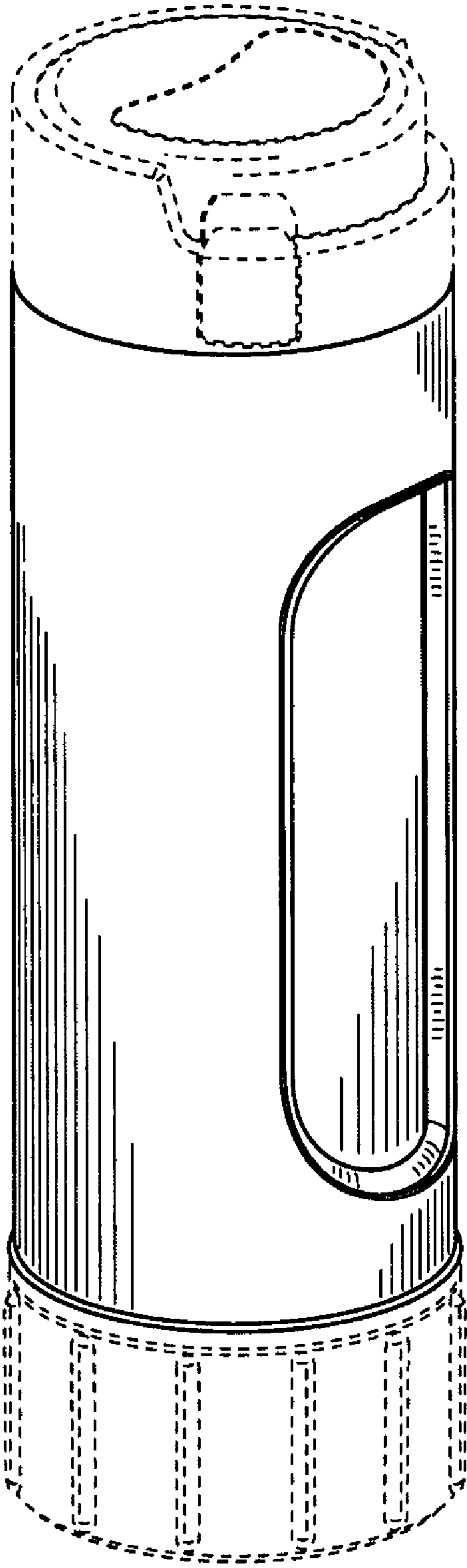

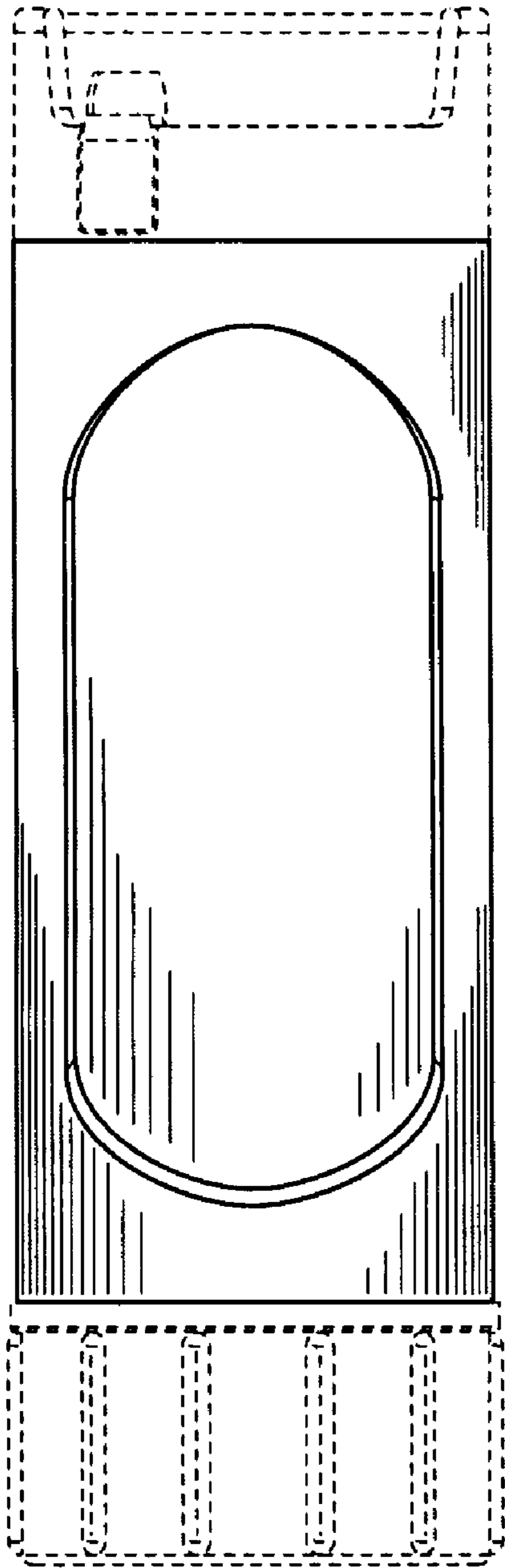

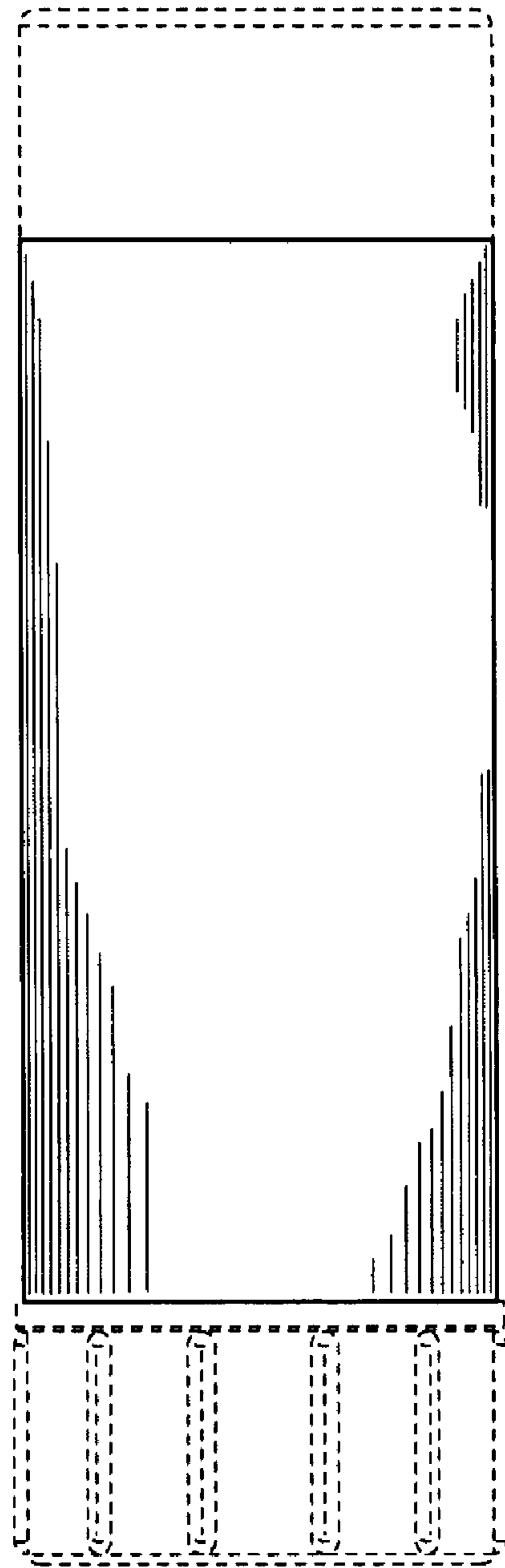

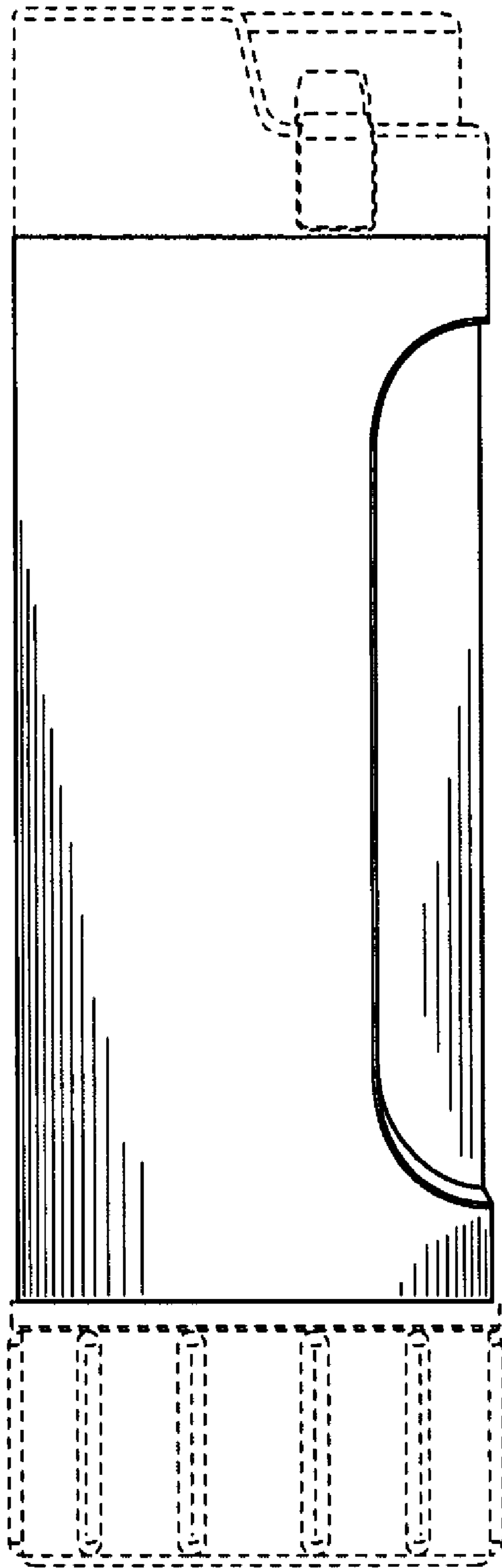
