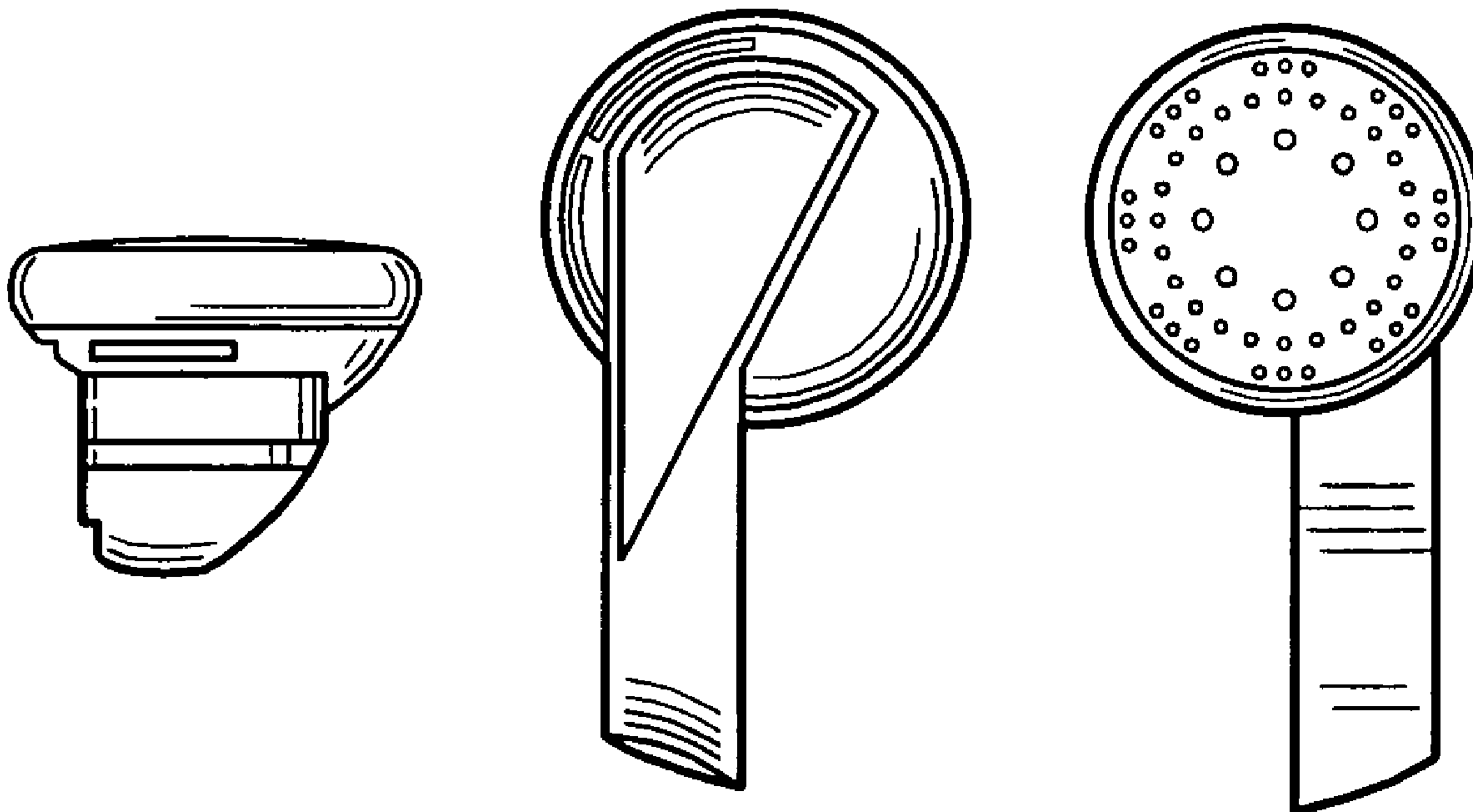
(57) **CLAIM**

An ornamental design for earphone, as shown and described.

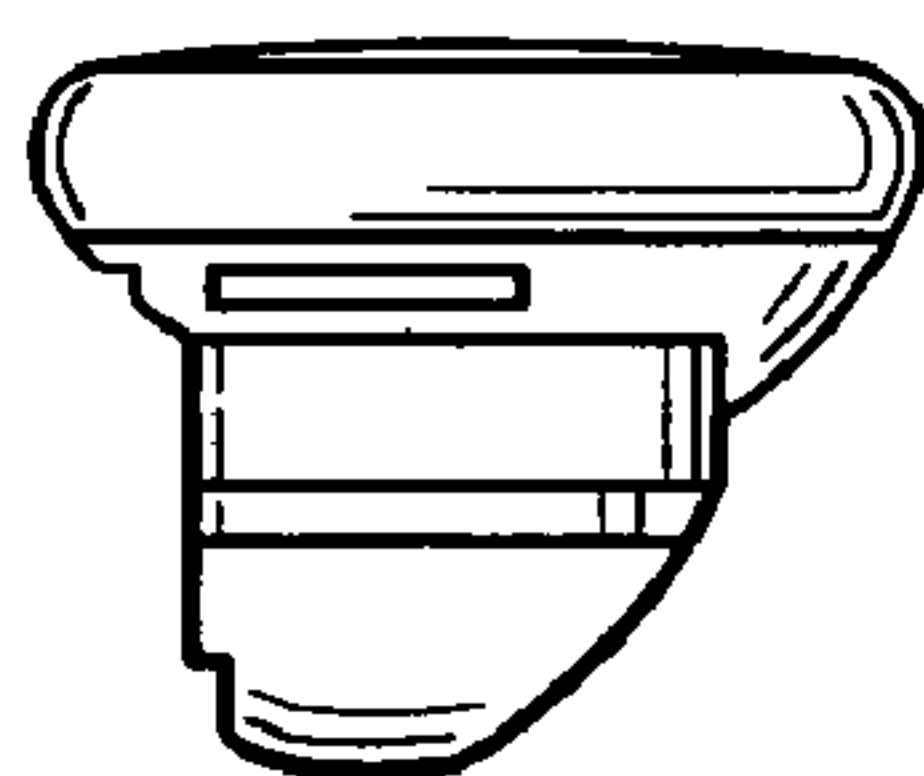
**DESCRIPTION**

FIG. 7 is a rear perspective view thereof.

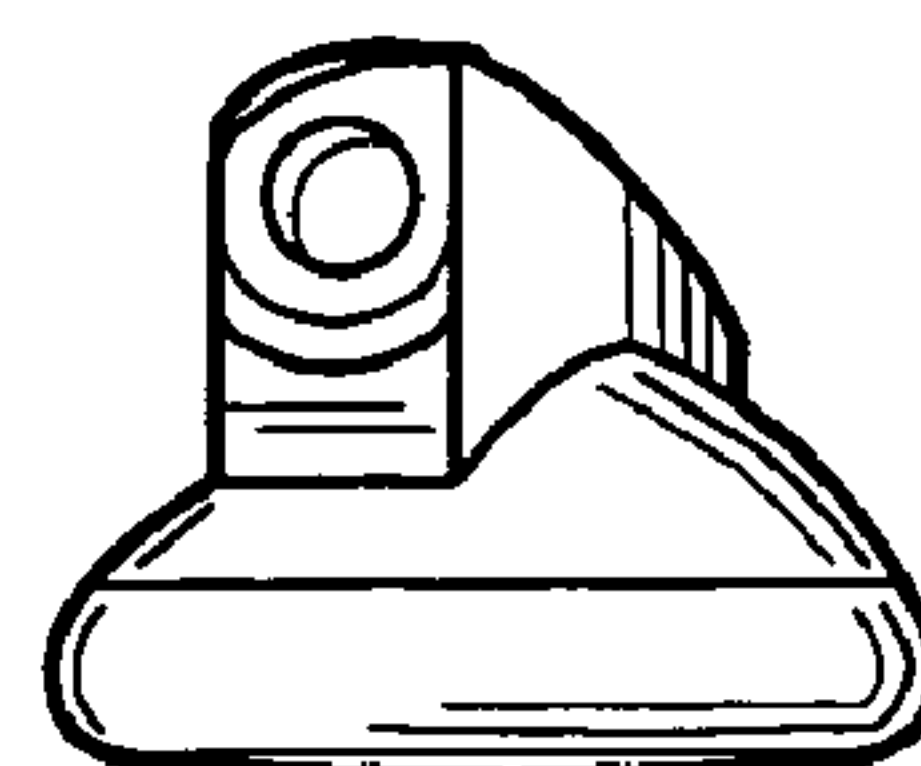

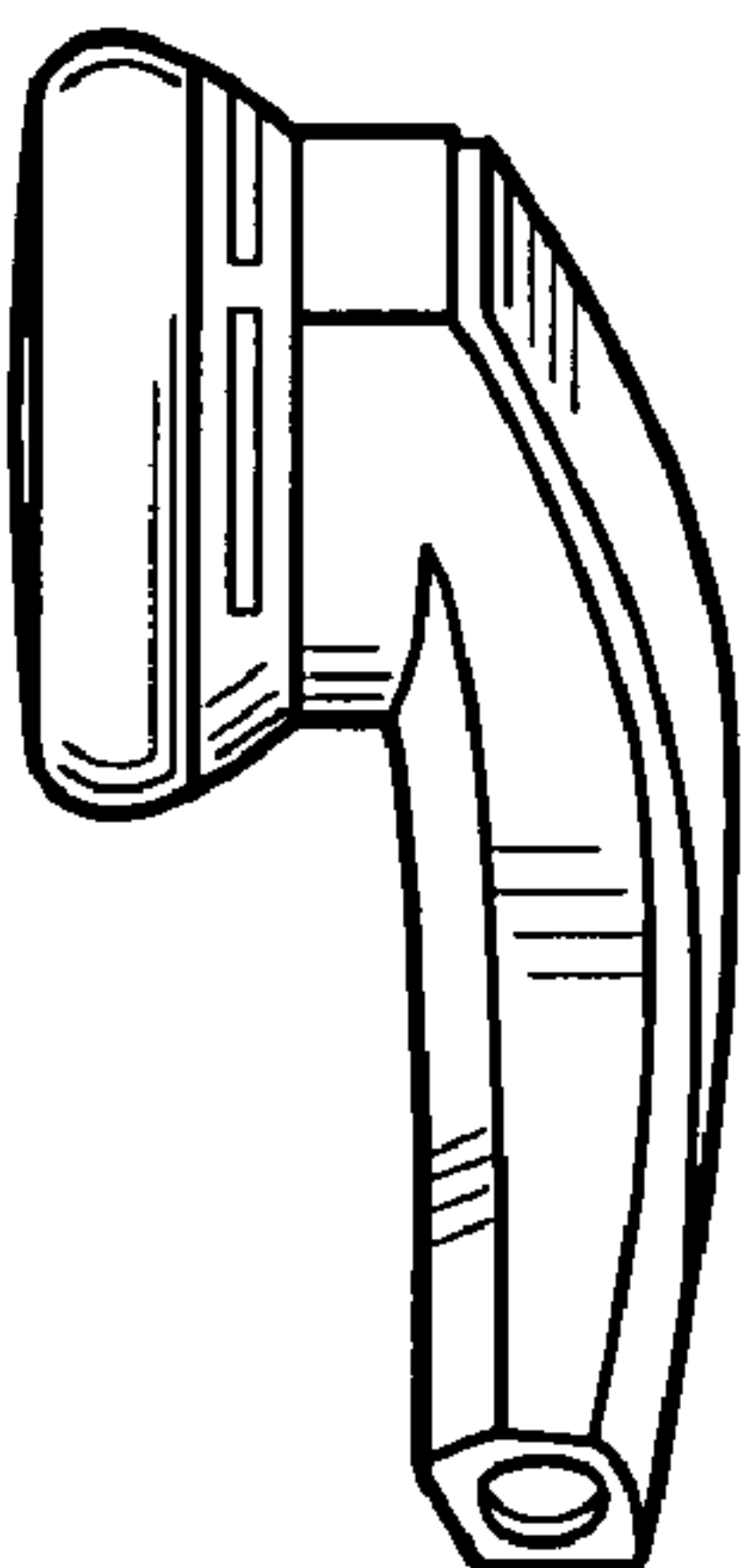

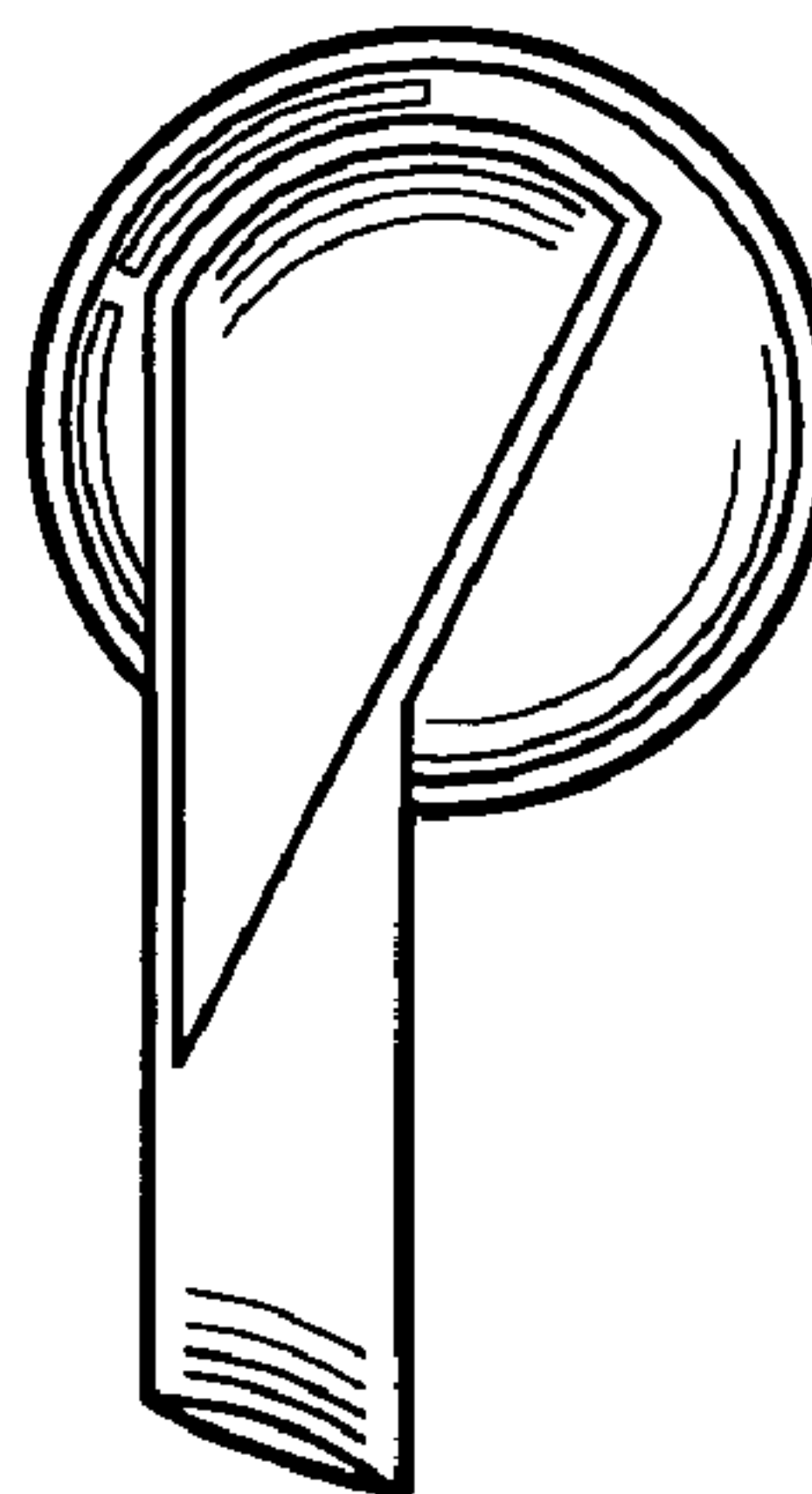

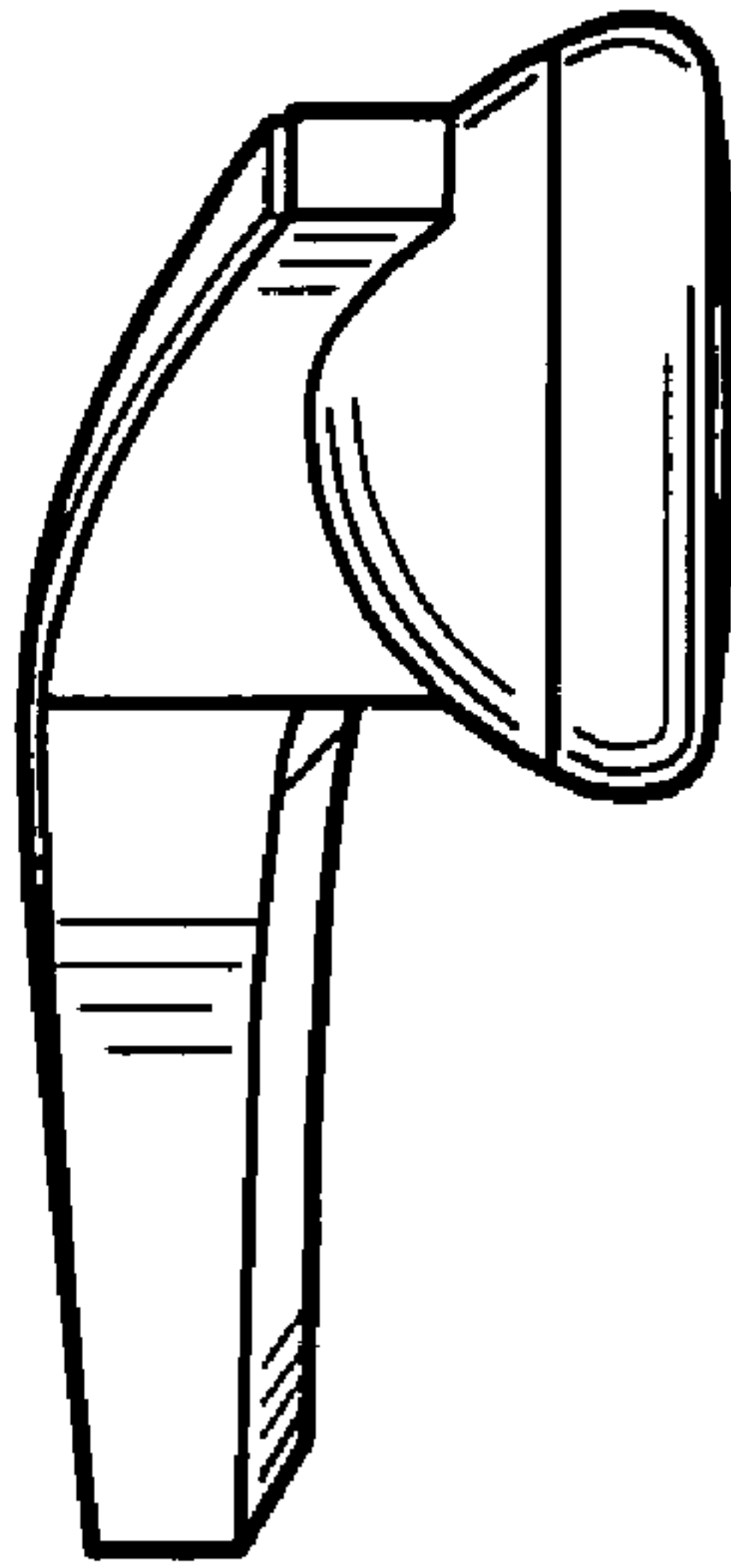

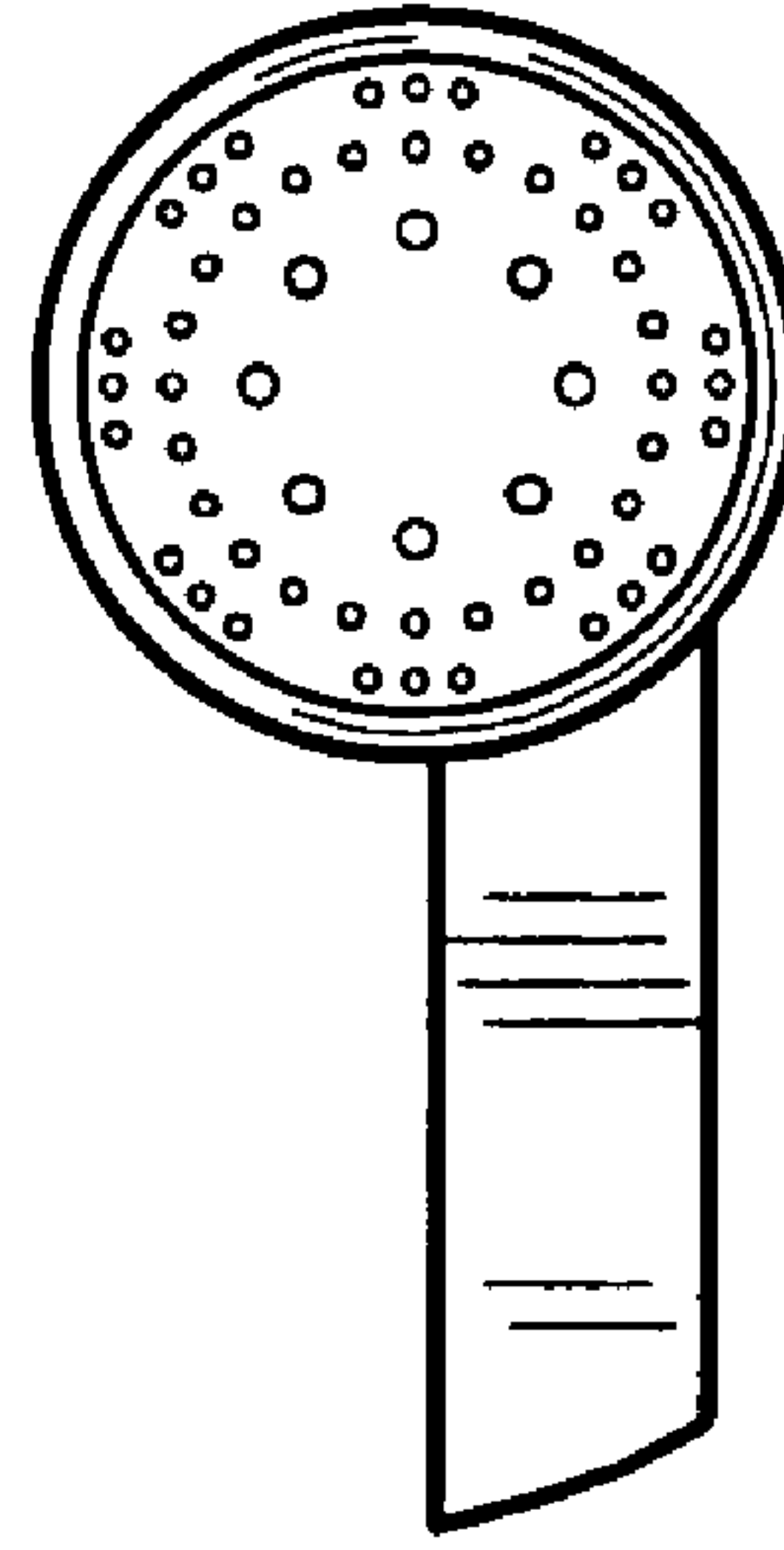
