(57) **CLAIM**

I claim the ornamental design for an automatic card shuffler,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automatic card shuffler
showing my new design;

FIG. 2 is another perspective view of the design of FIG. 1,
where a hinged lid is shown in an opened position;

FIG. 3 shows a top view of the design of FIG. 1;

FIG. 4 is an end view thereof;

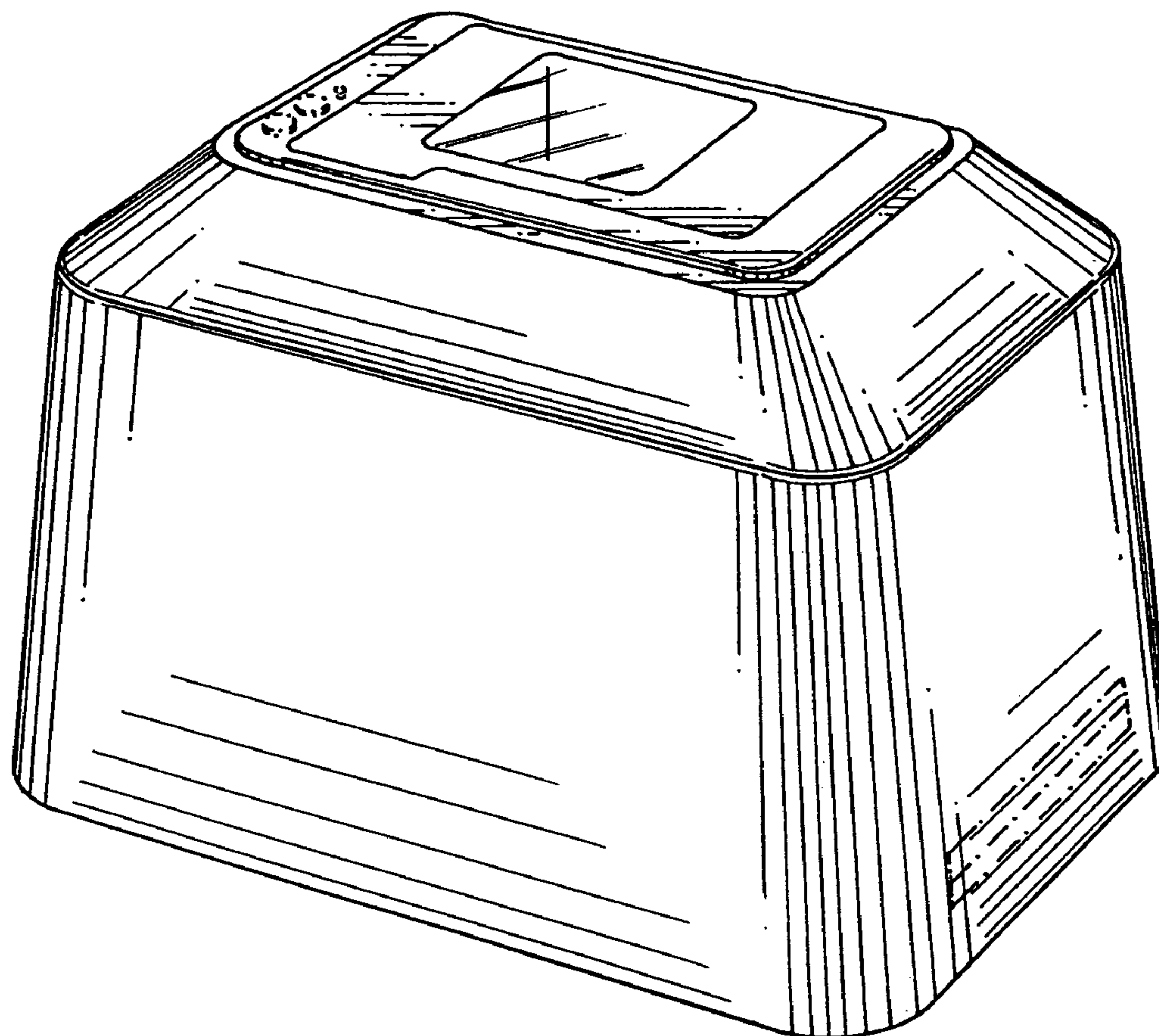
FIG. 5 is a side view thereof, the opposite side being the same;

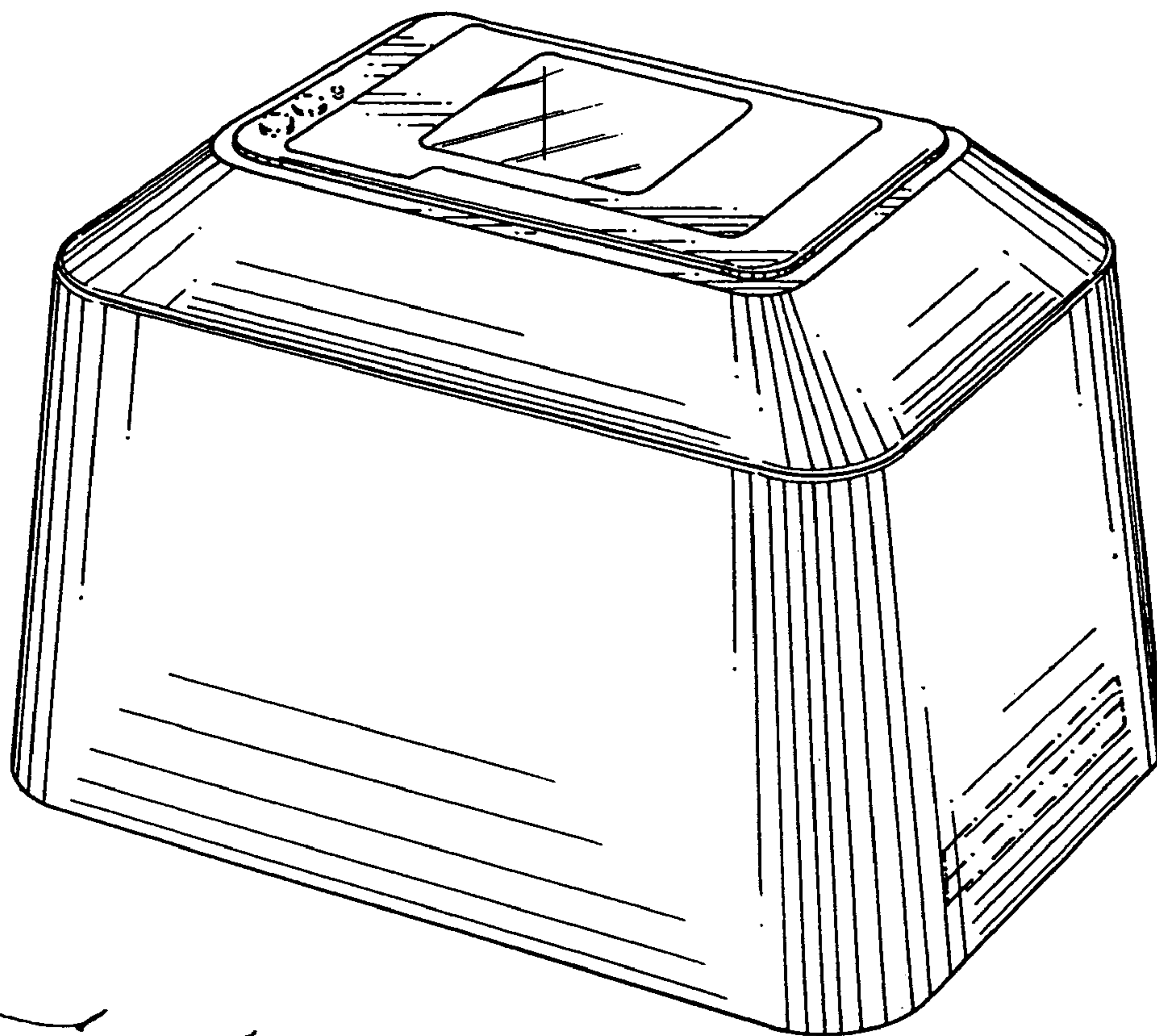

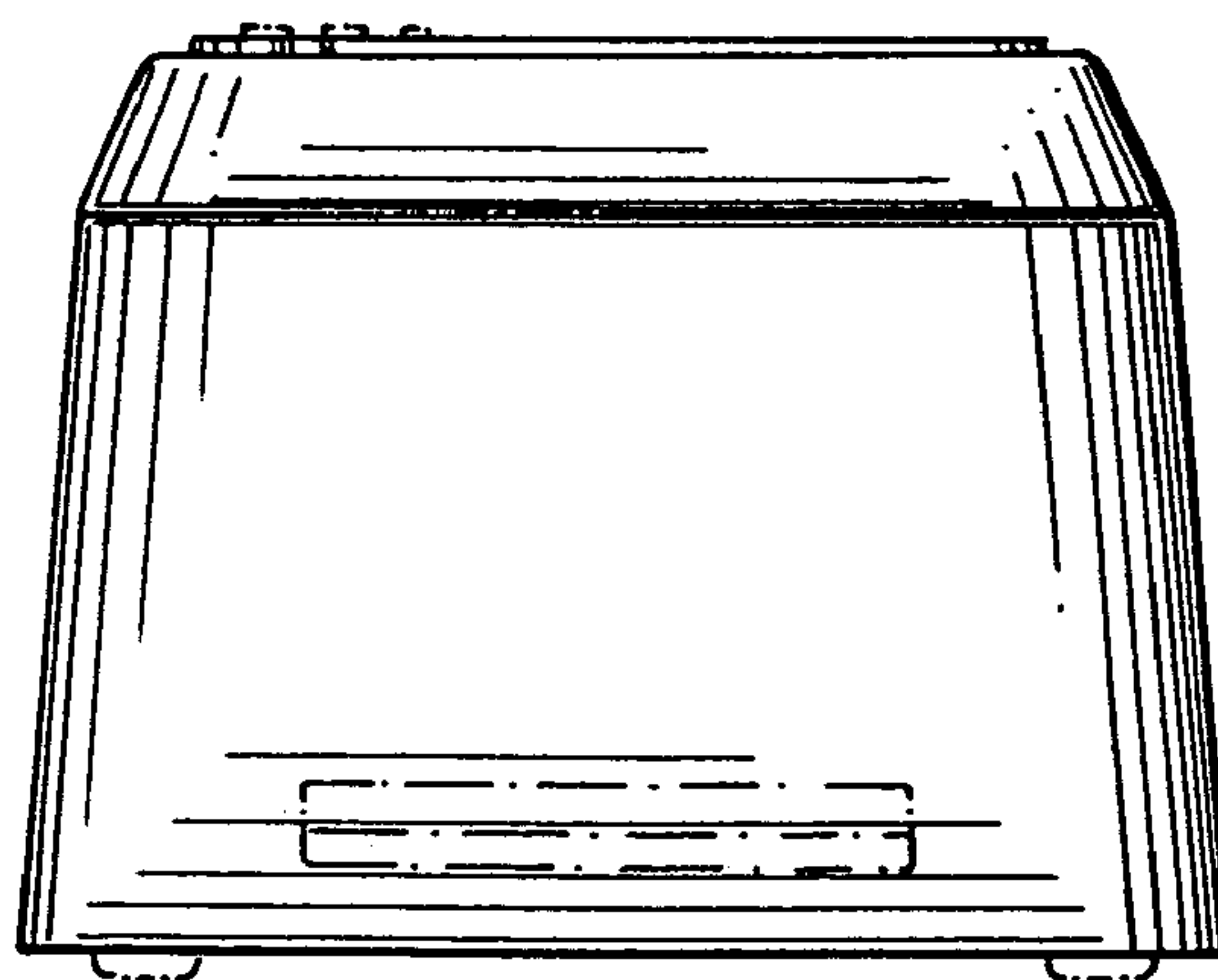

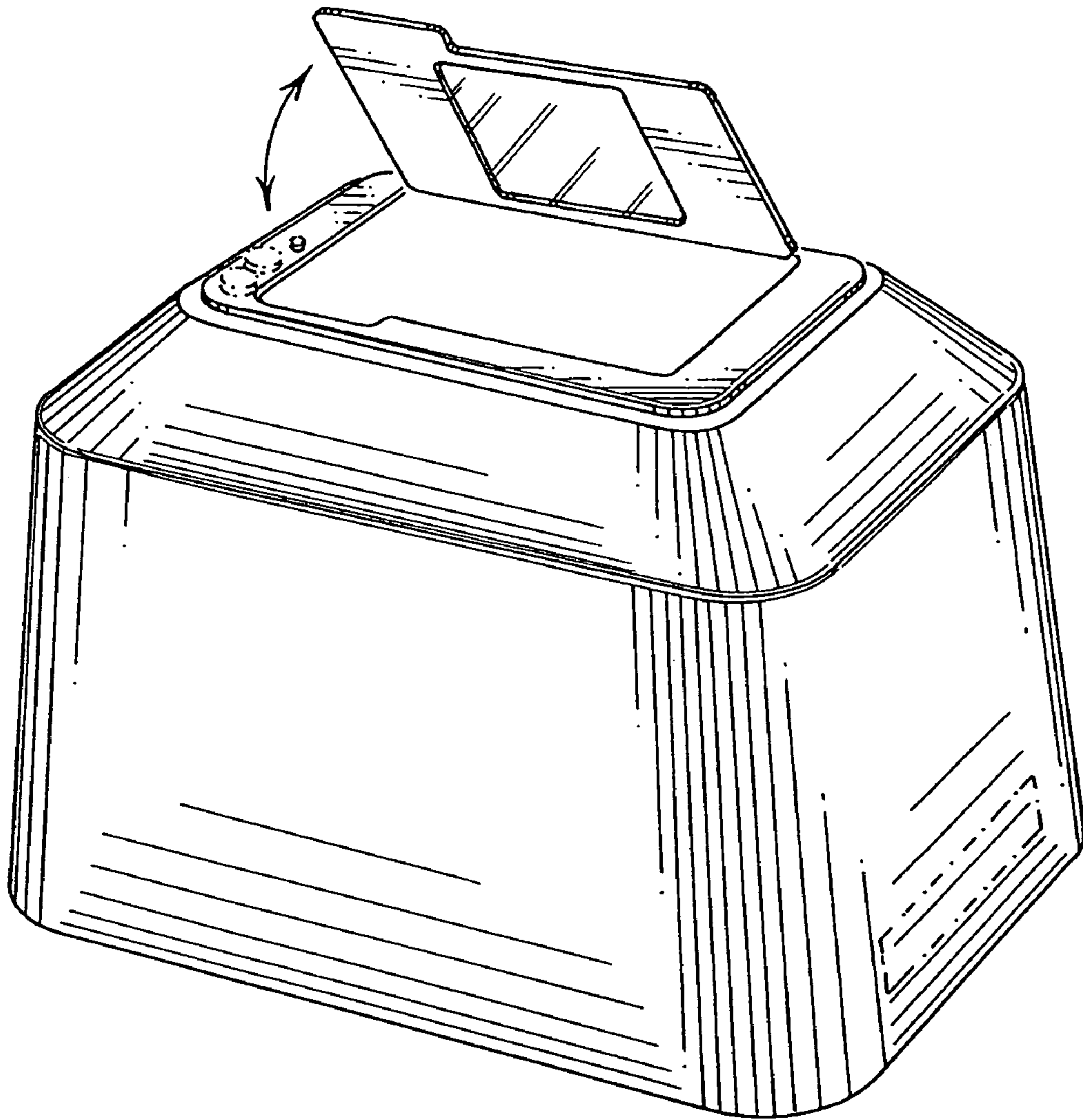

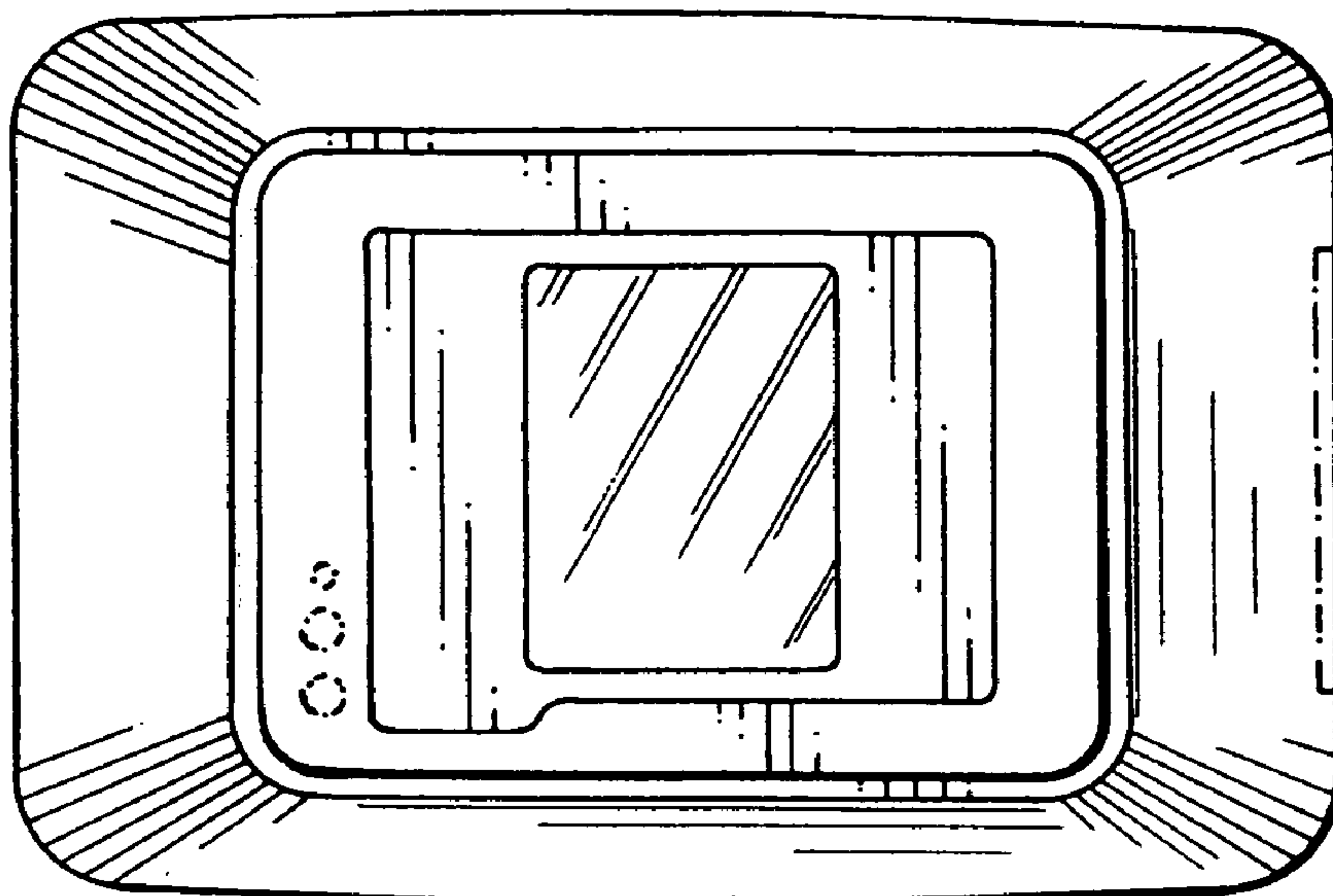

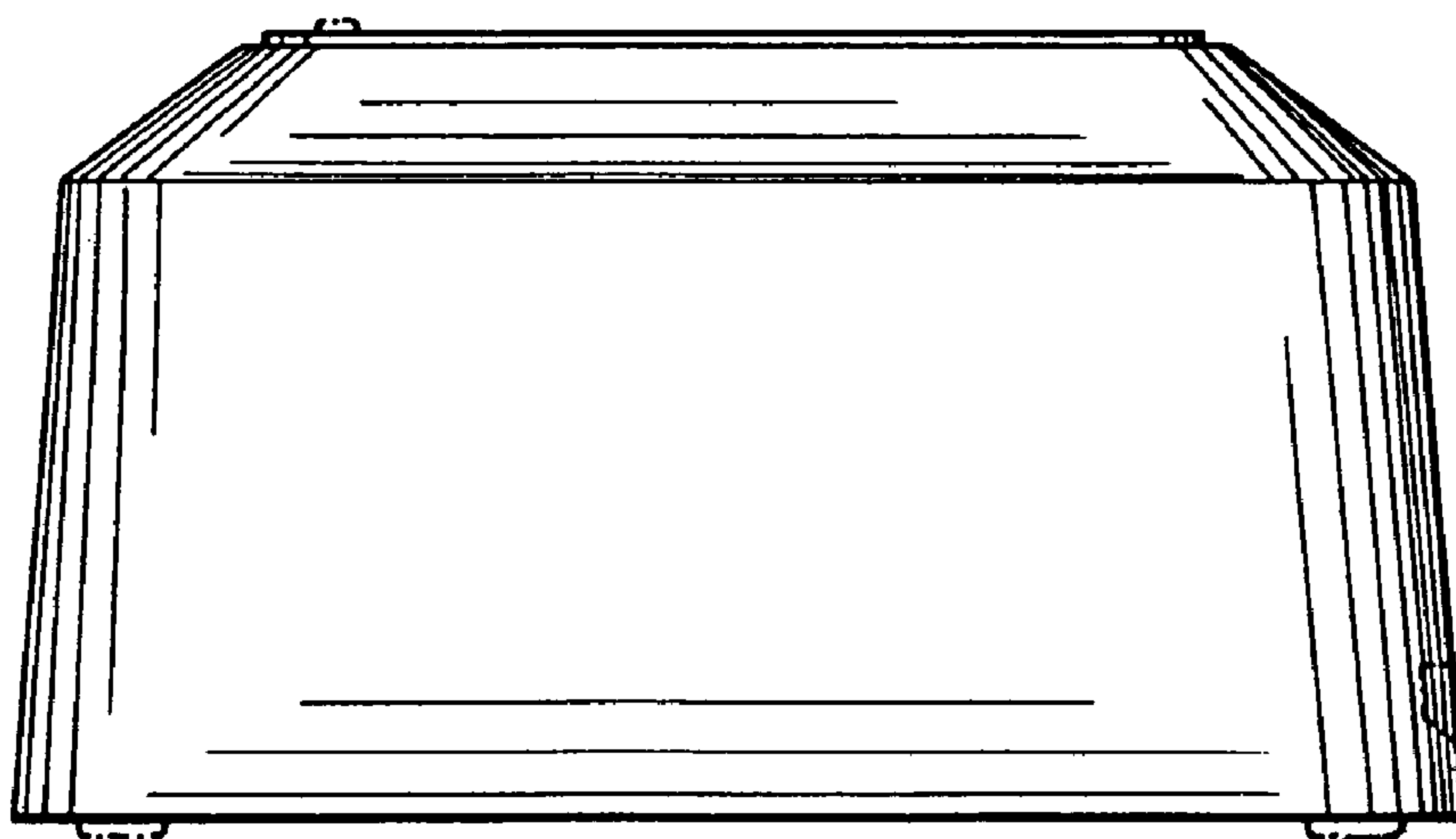

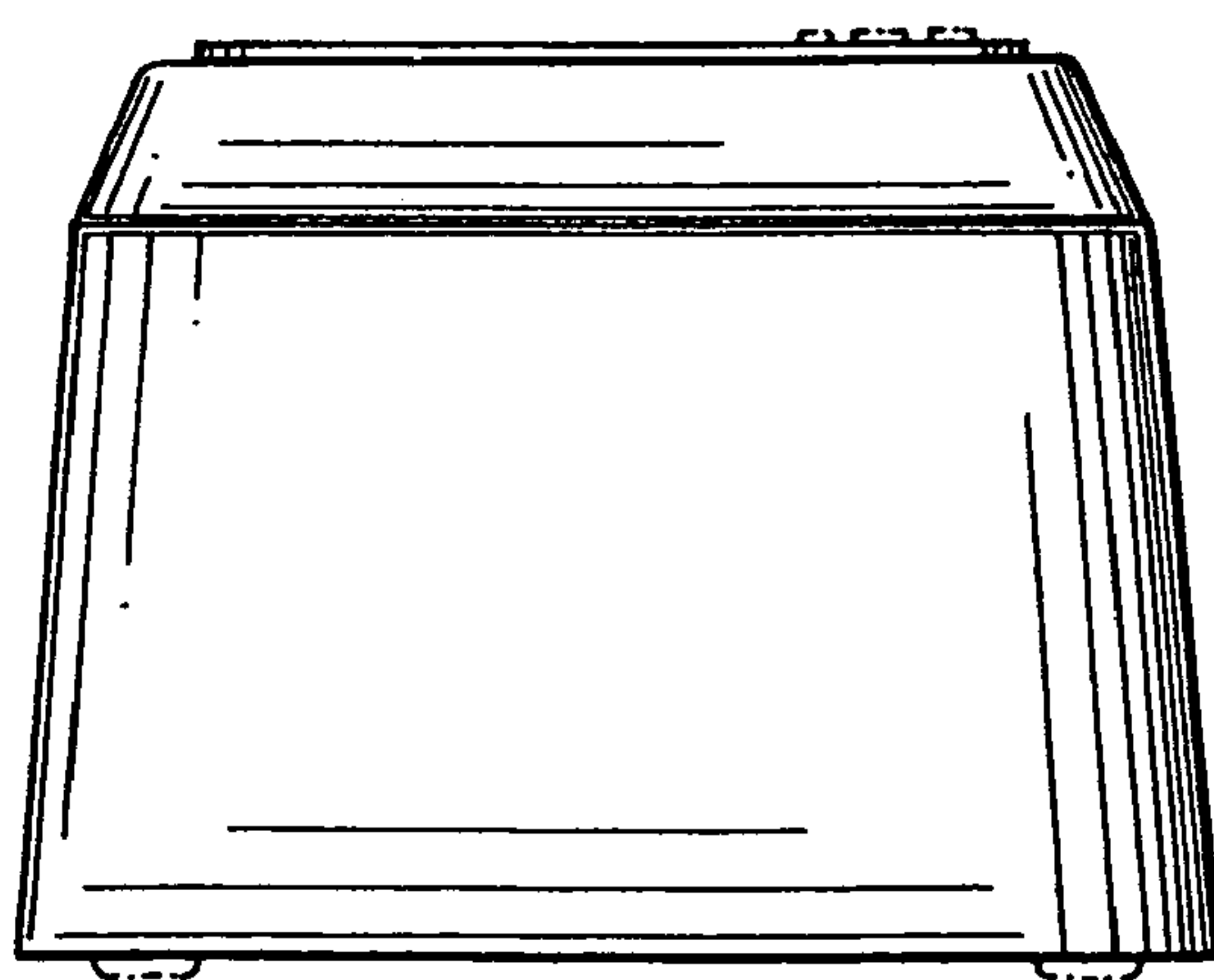
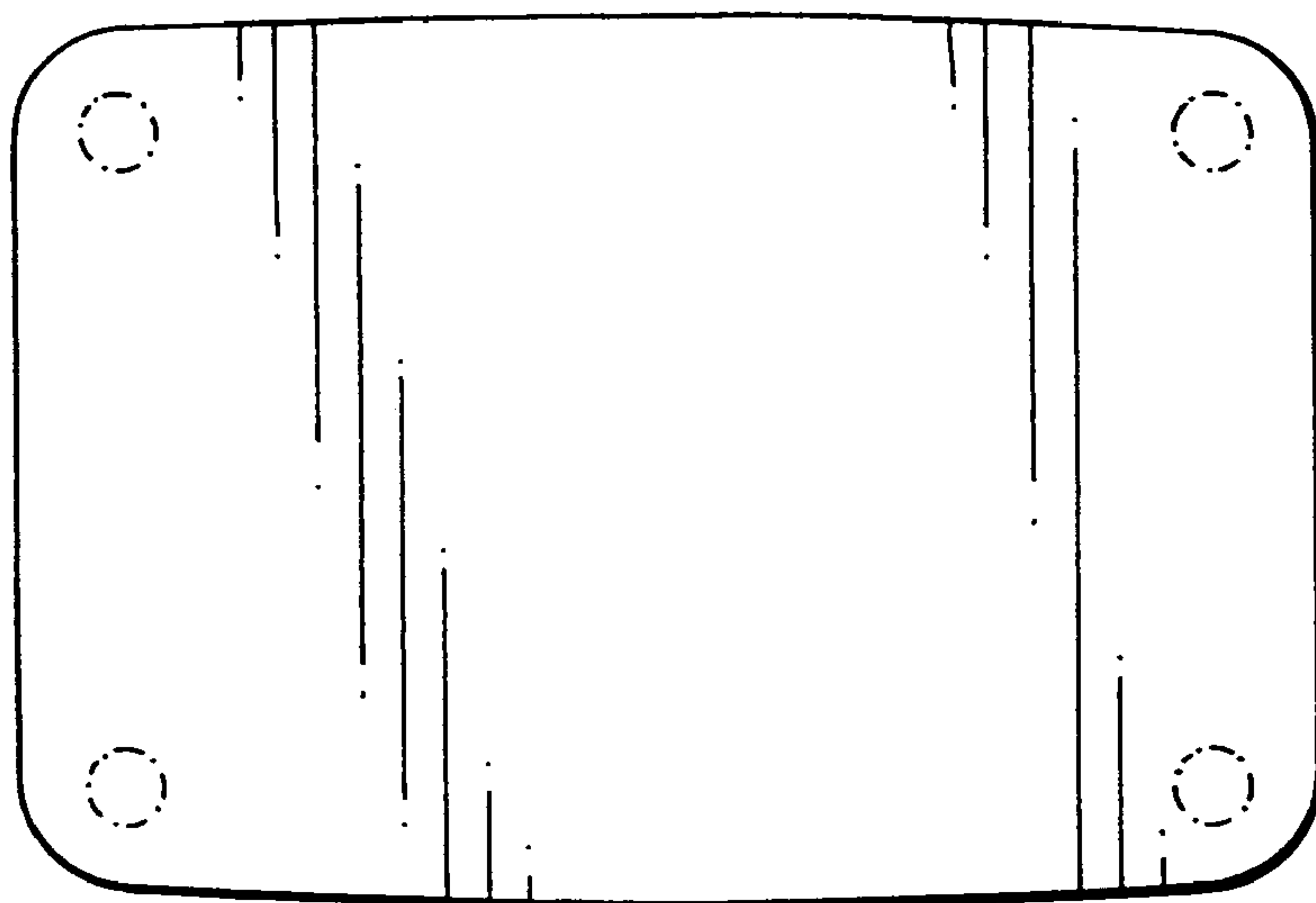
