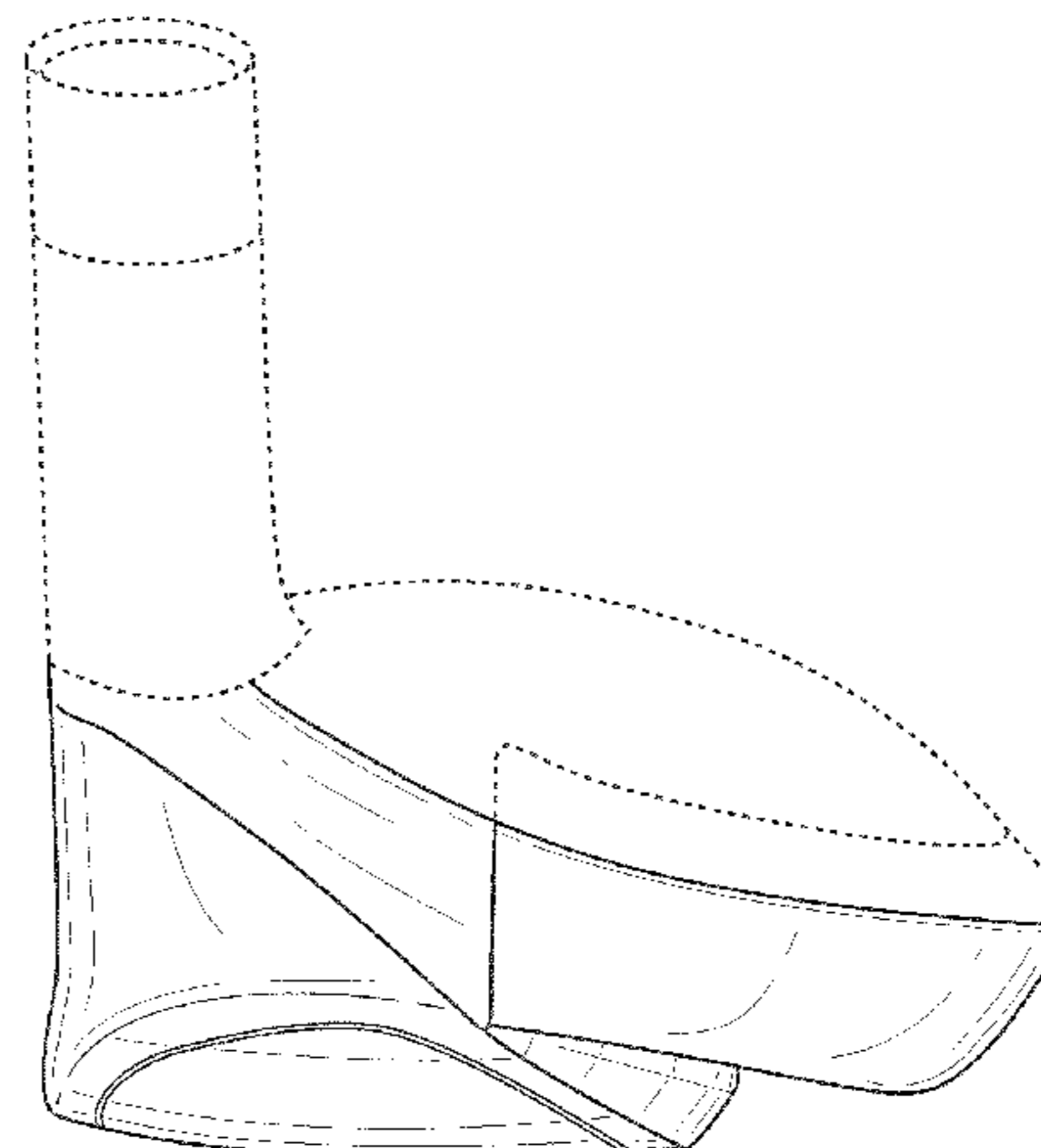
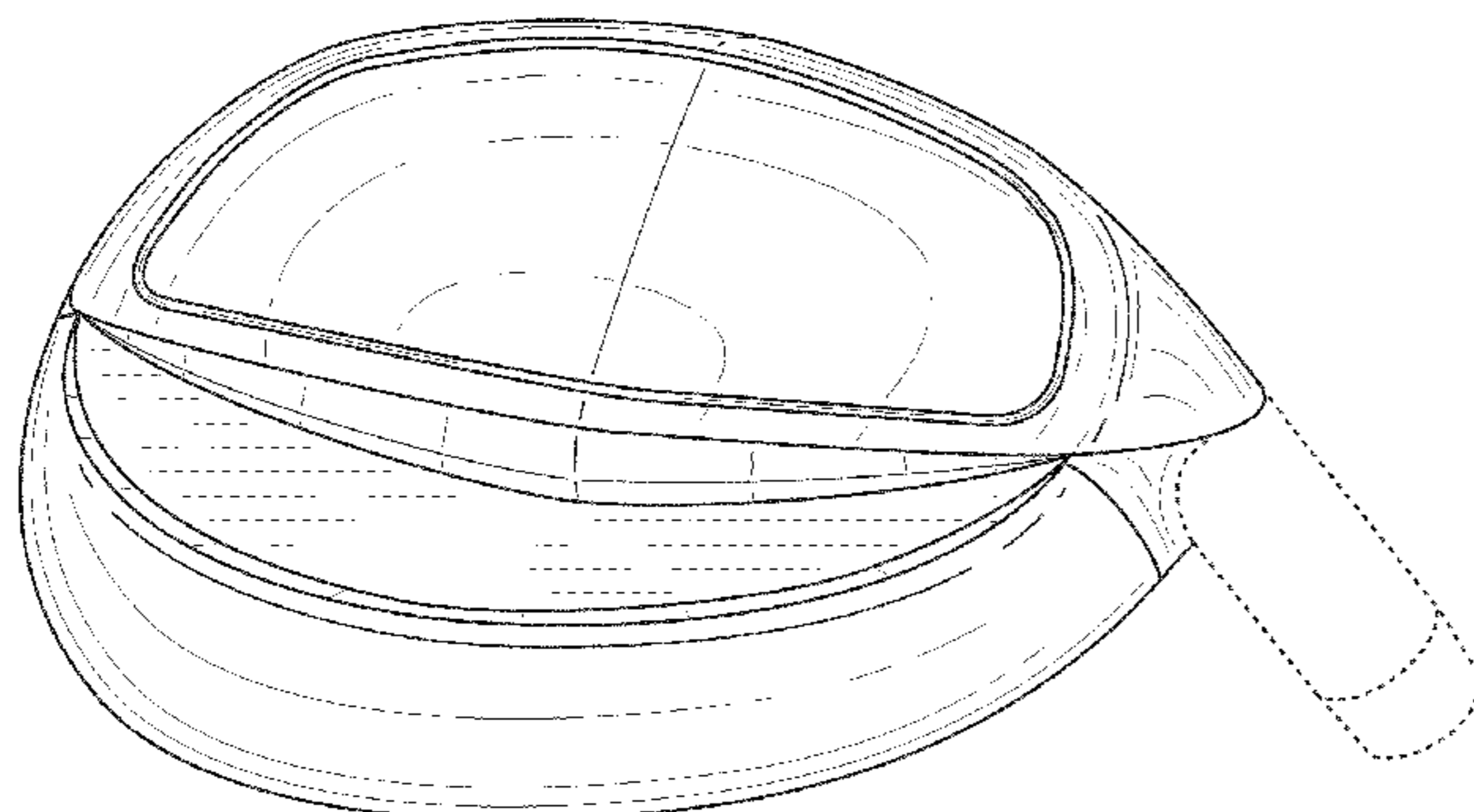
(57) **CLAIM**

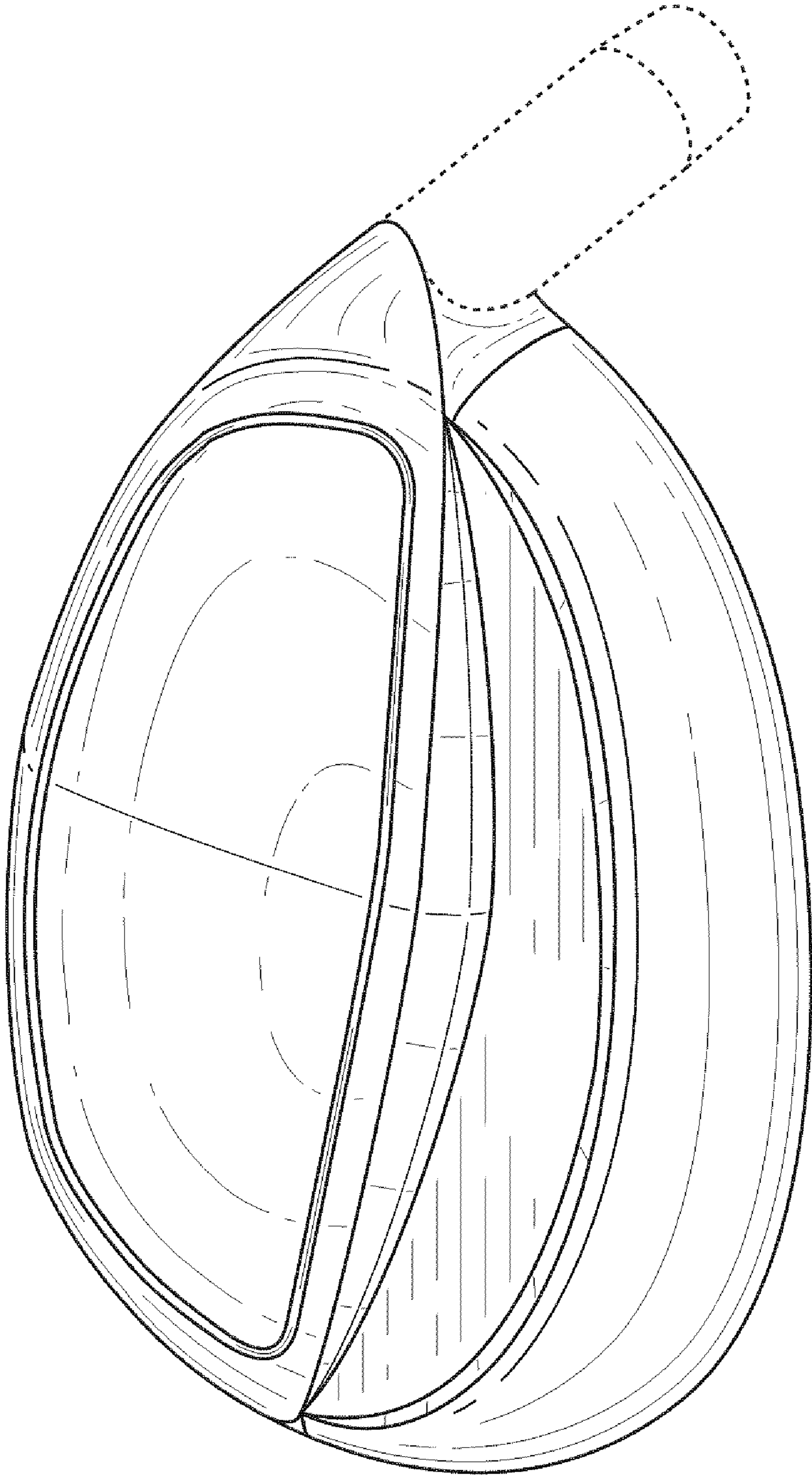
The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a golf club head showing our new design;  
 FIG. 2 is a heel end view thereof;

 The broken line showing of the remainder of the golf club head is for illustrative purposes only and forms no part of the claimed design.

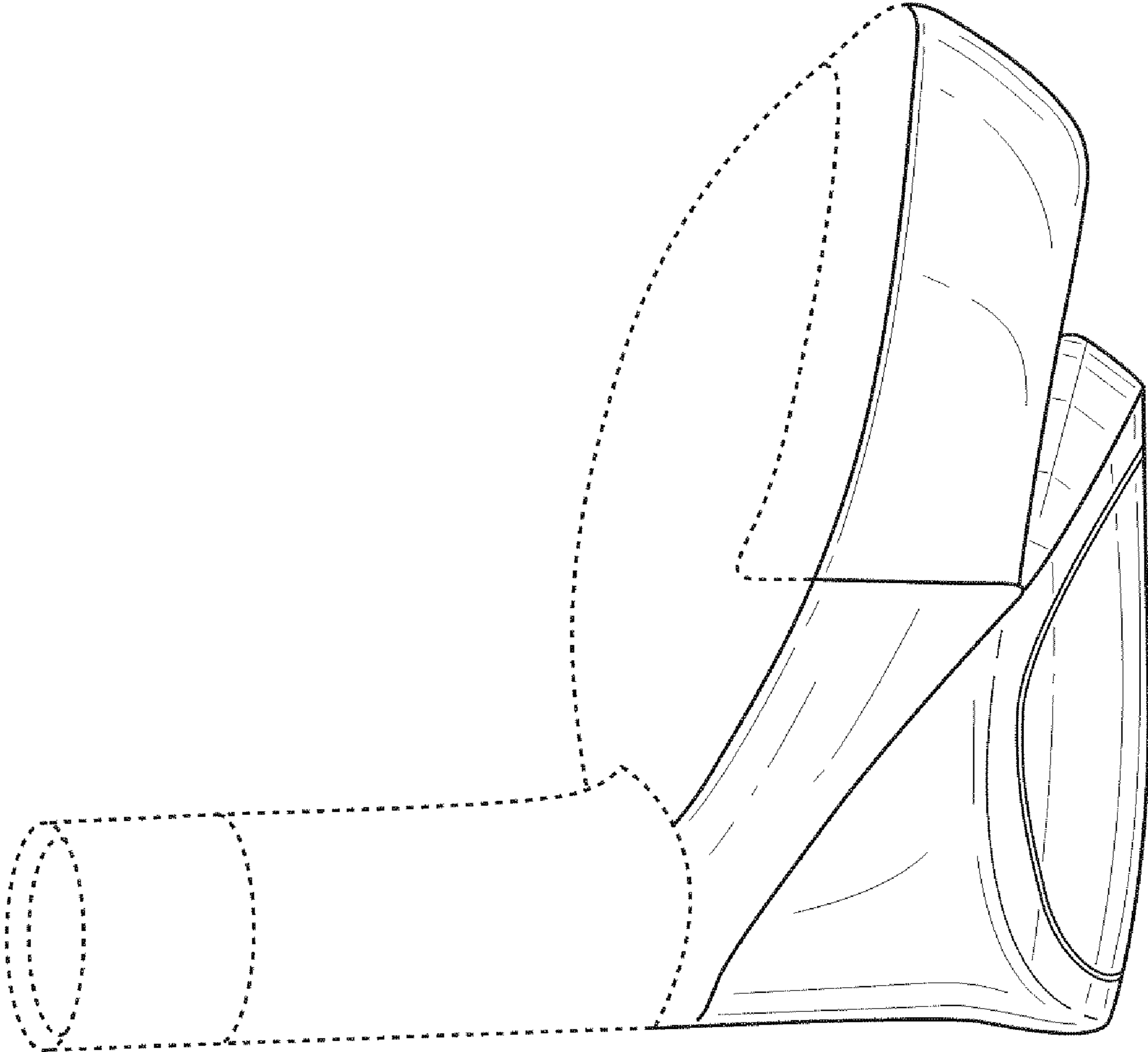

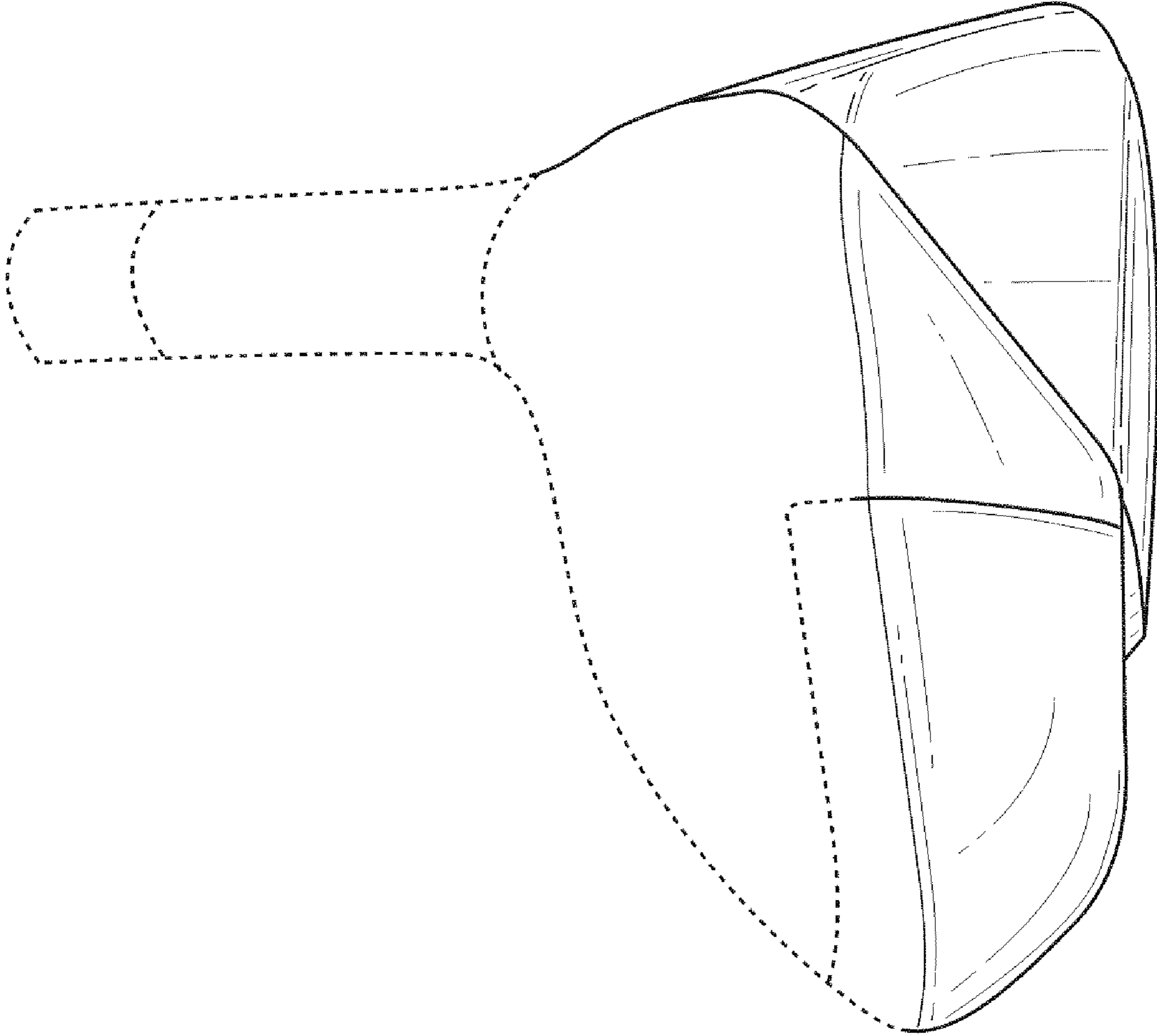

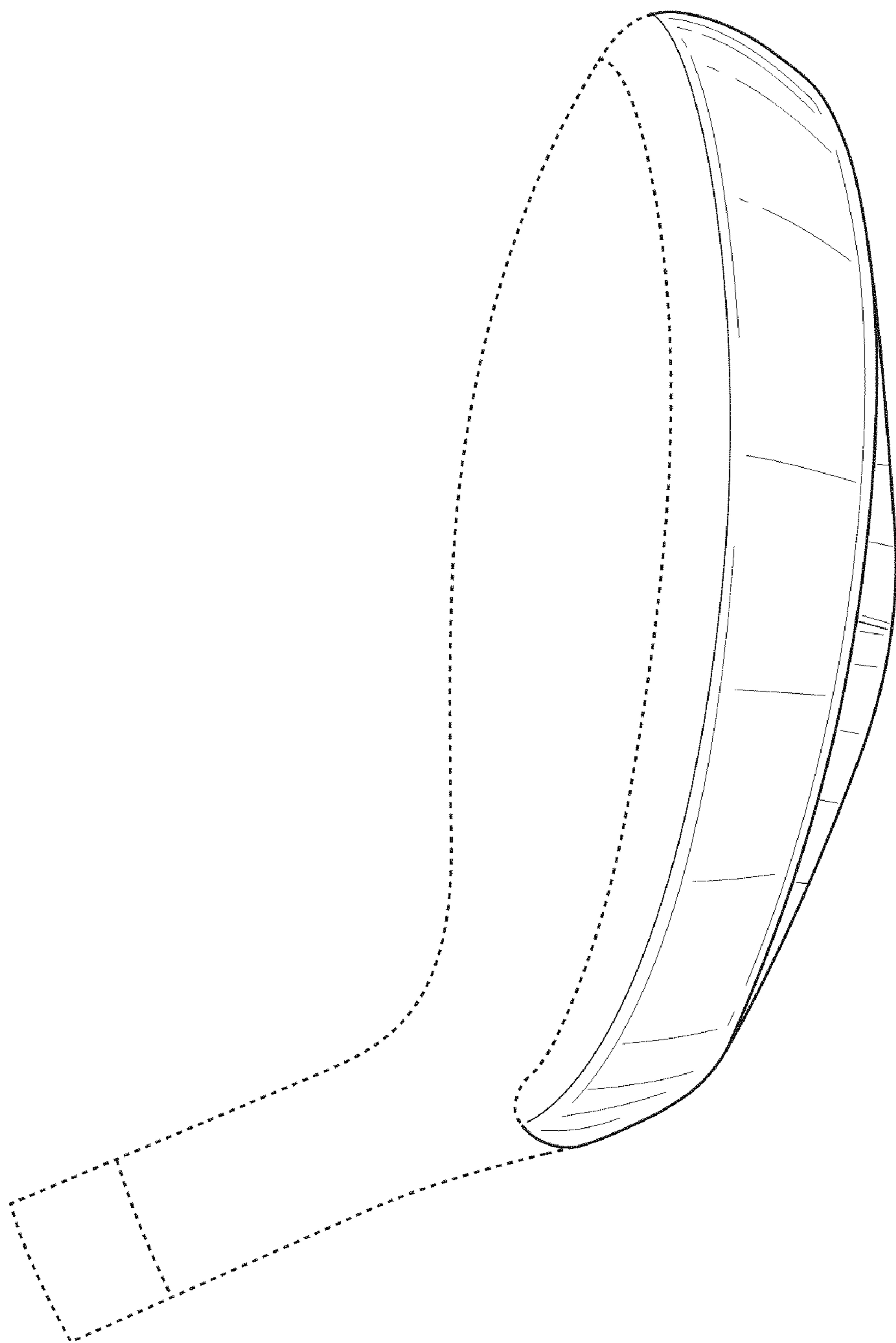

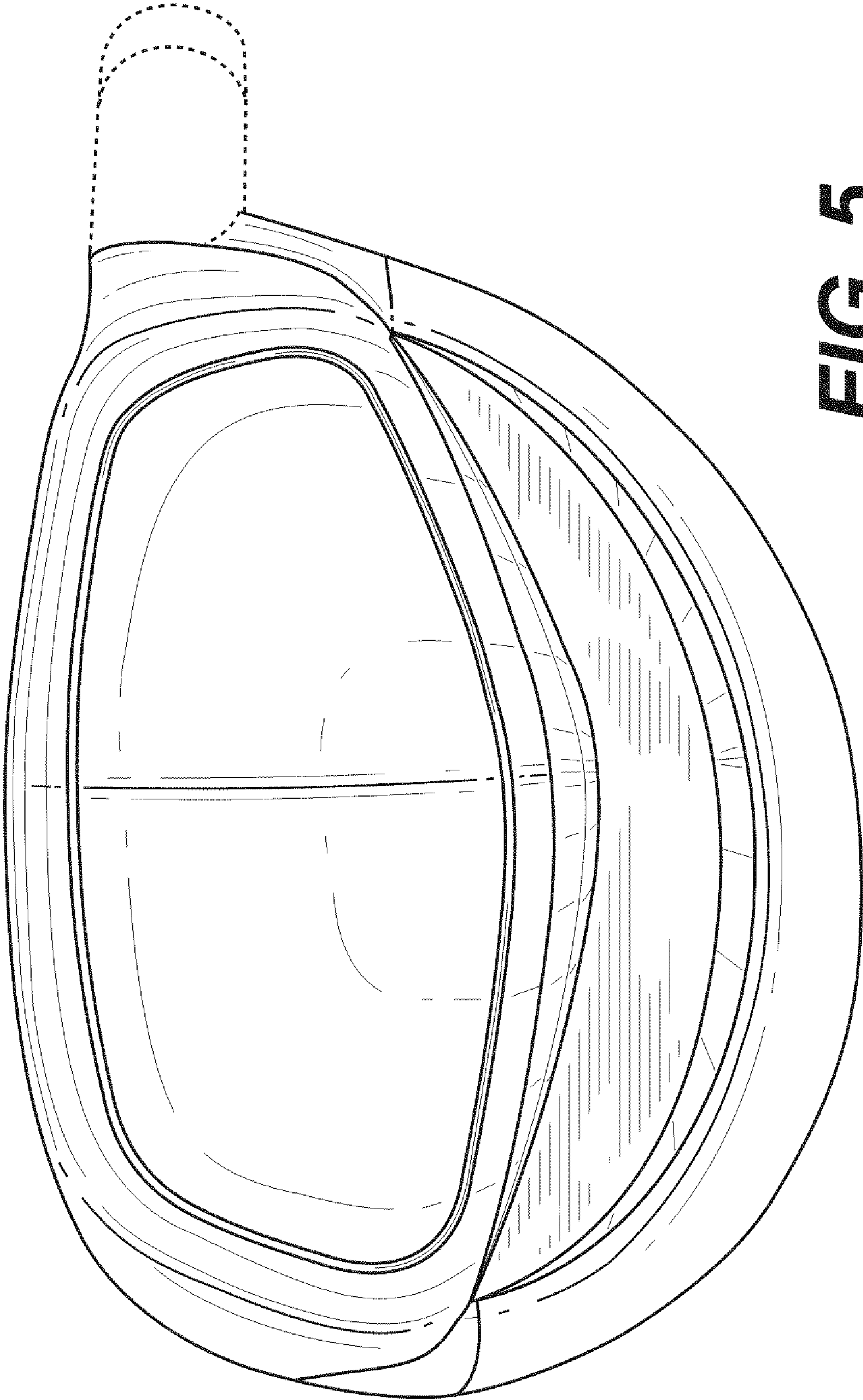
