(57) **CLAIM**

The ornamental design for a cartridge catch cloth, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged top plan view of a cartridge catch cloth showing my new design, shown broken in section for ease of illustration;

FIG. 2 is an enlarged bottom plan view thereof.

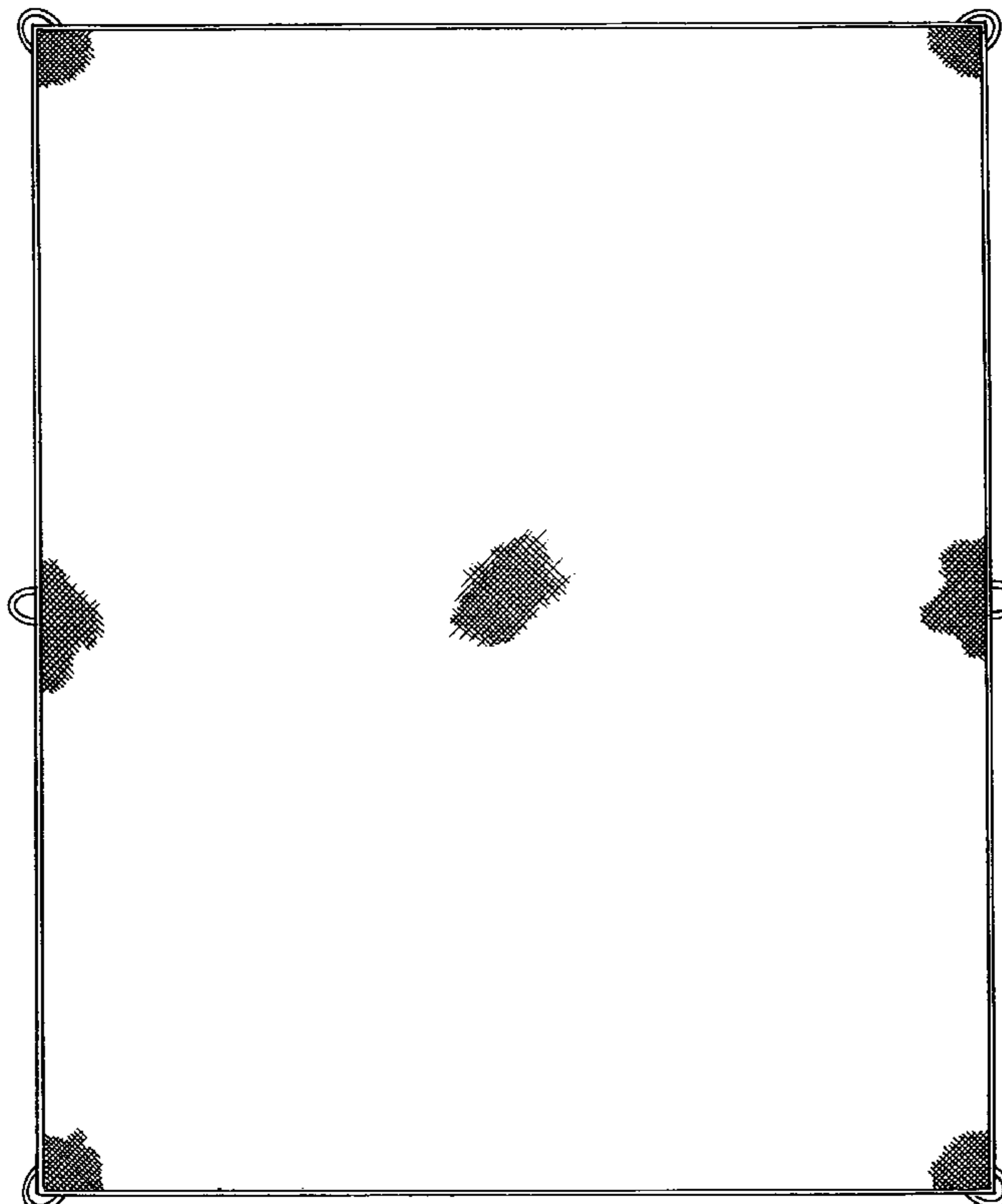
FIG. 3 is a front end view thereof;

FIG. 4 is a rear end view thereof;

FIG. 5 is a left side view thereof, the right side view being a mirror image thereof; and,

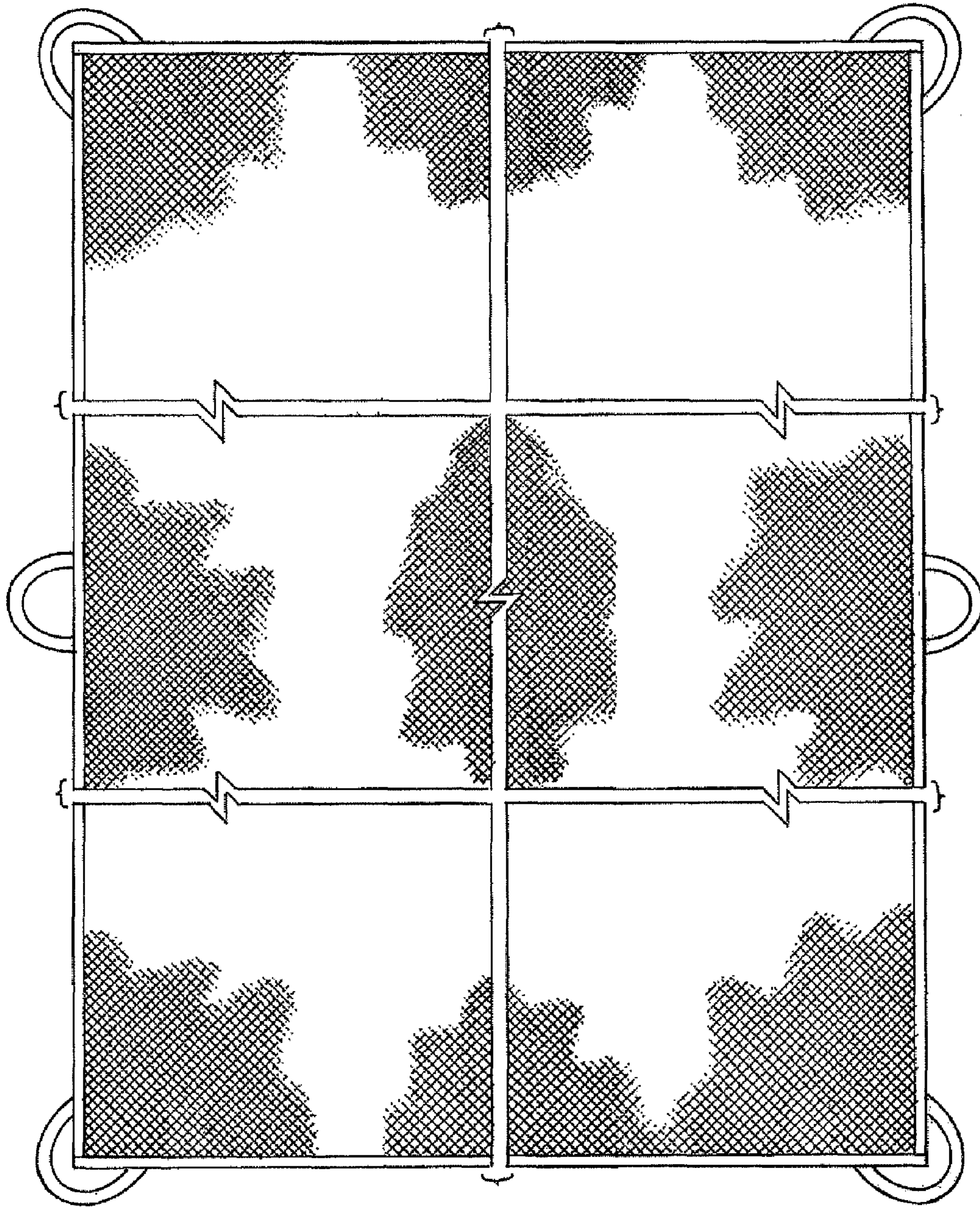

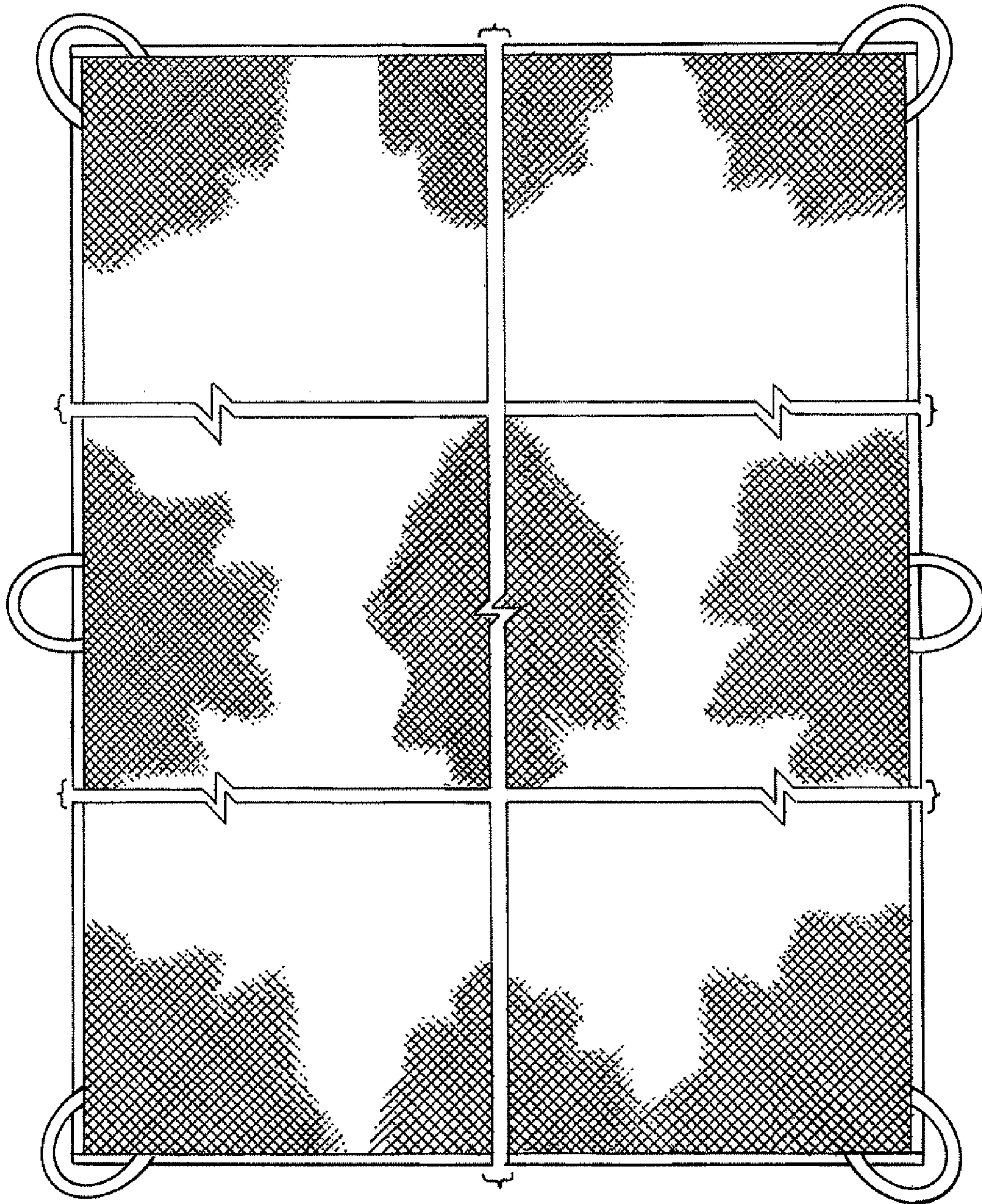

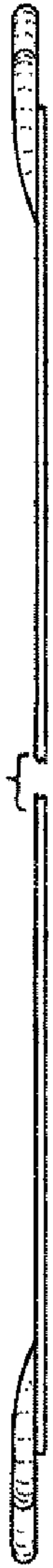

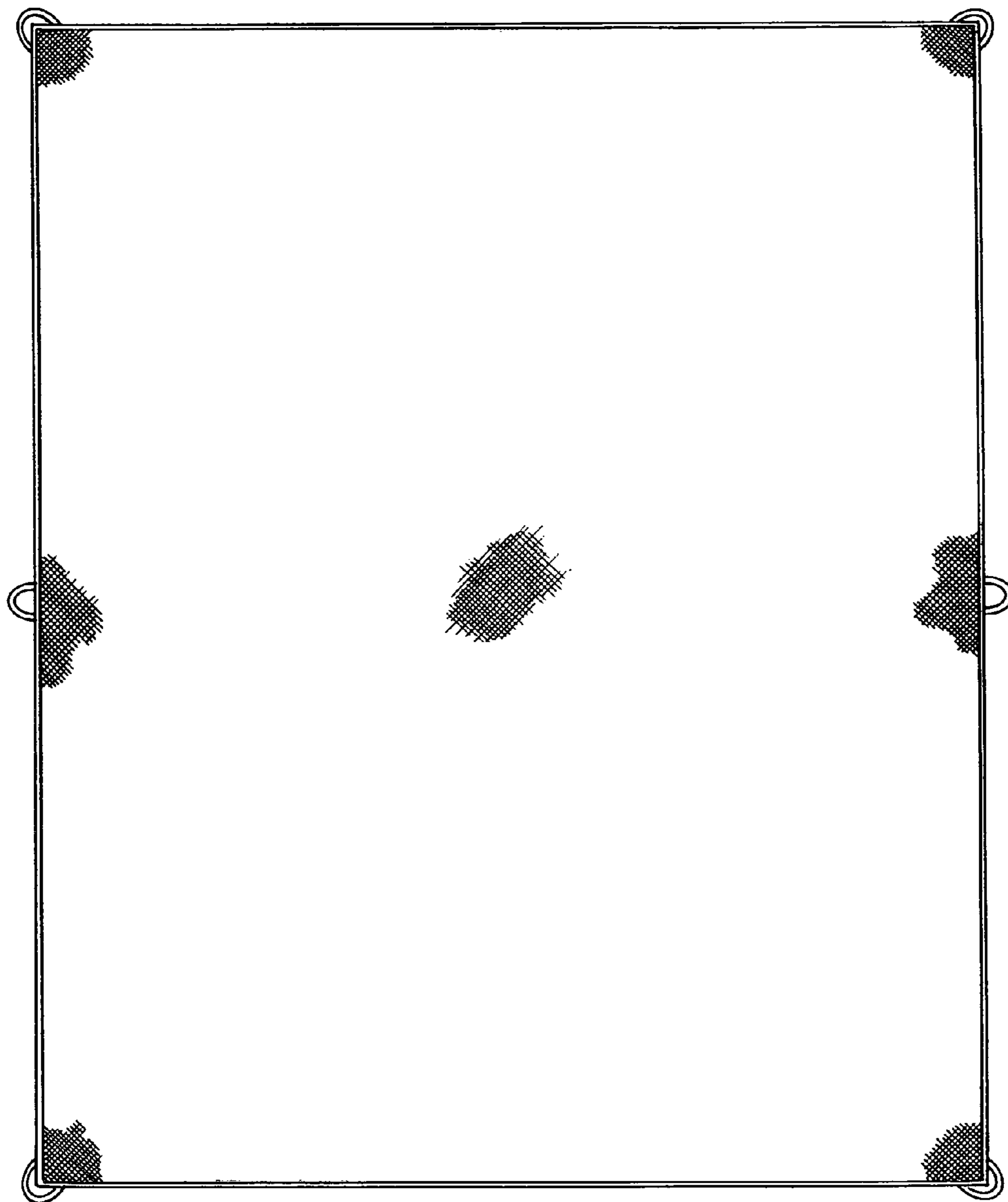
