(57) **CLAIM**

The ornamental design for a vented hexagonal pattern panel, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portion of a vented panel showing our new design according to one embodiment of the invention.

FIG. 2 is a rear view of the portion of the vented panel of FIG. 1.

FIG. 3 is a top view of the portion of the vented panel of FIG. 1.

FIG. 4 is a bottom view of the portion of the vented panel of FIG. 1.

FIG. 5 is a left side view of the portion of the vented panel of FIG. 1, the right side view being a mirror image.

FIG. 6 is a front view of a portion of a vented panel showing our new design according to a second embodiment of the invention.

FIG. 7 is a rear view of the portion of the vented panel of FIG. 6.

FIG. 8 is a top view of the portion of the vented panel of FIG. 6.

FIG. 9 is a bottom view of the portion of the vented panel of FIG. 6.

FIG. 10 is a left side view of the portion of the vented panel of FIG. 6, the right side view being a mirror image.

FIG. 11 is a front view of a portion of a vented panel showing our new design according to a third embodiment of the invention.

FIG. 12 is a rear view of the portion of the vented panel of FIG. 11.

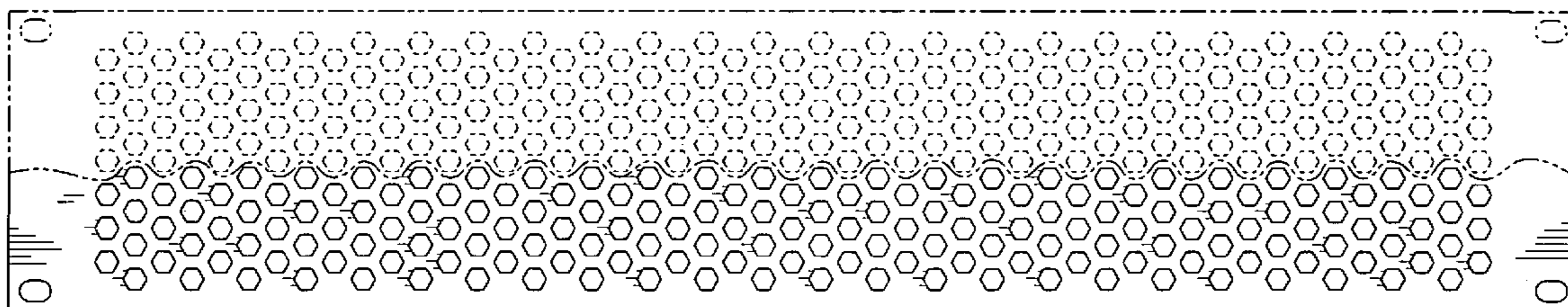
FIG. 13 is a top view of the portion of the vented panel of FIG. 11.

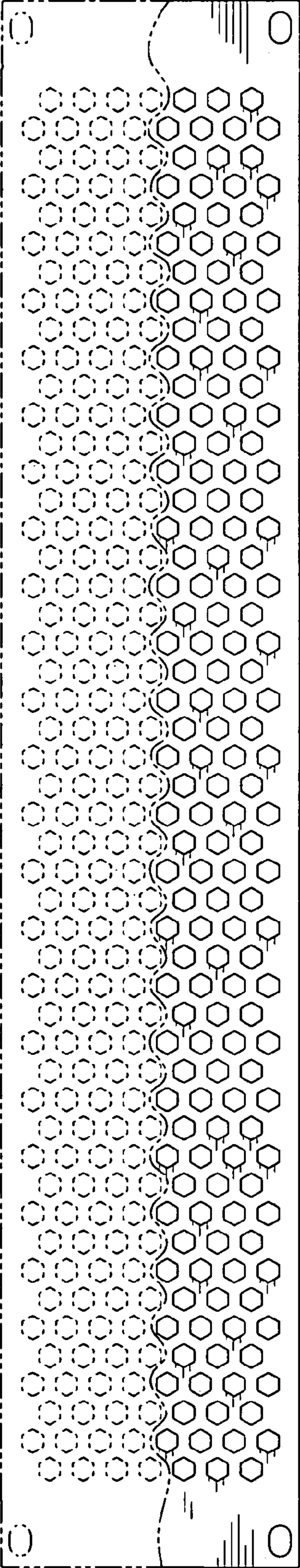

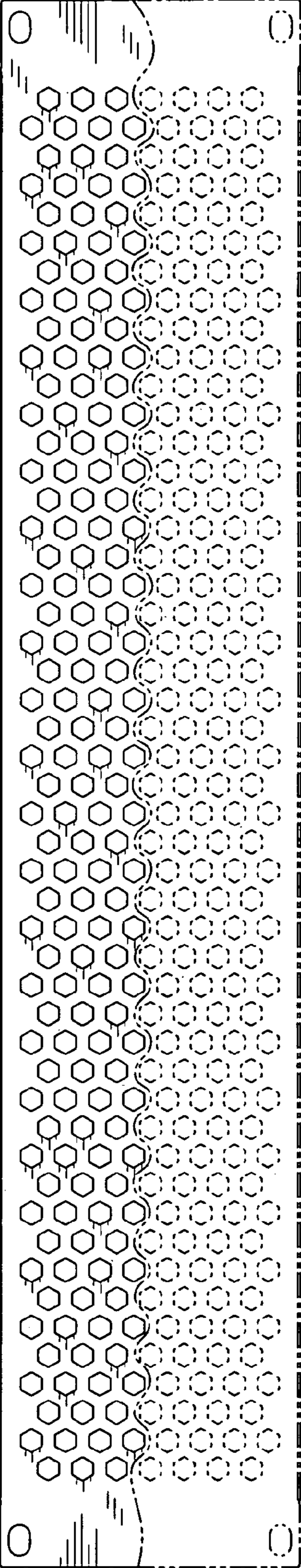

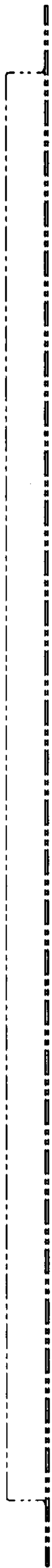

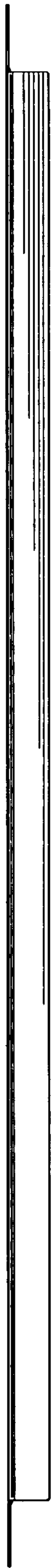

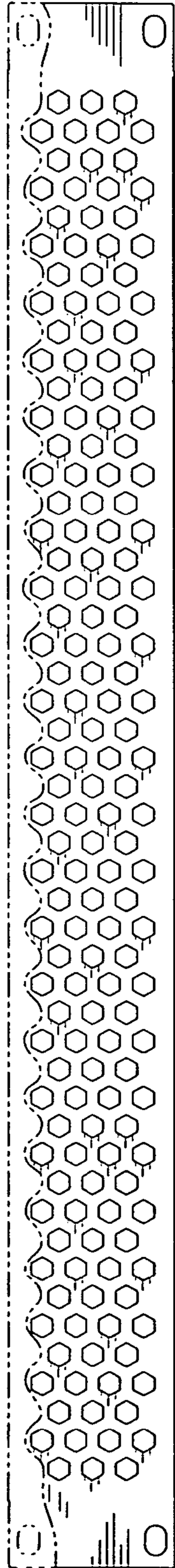

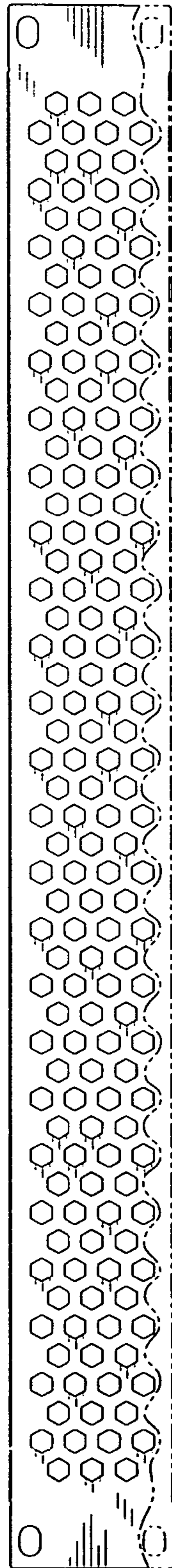

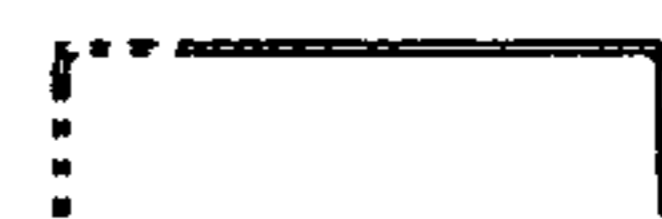

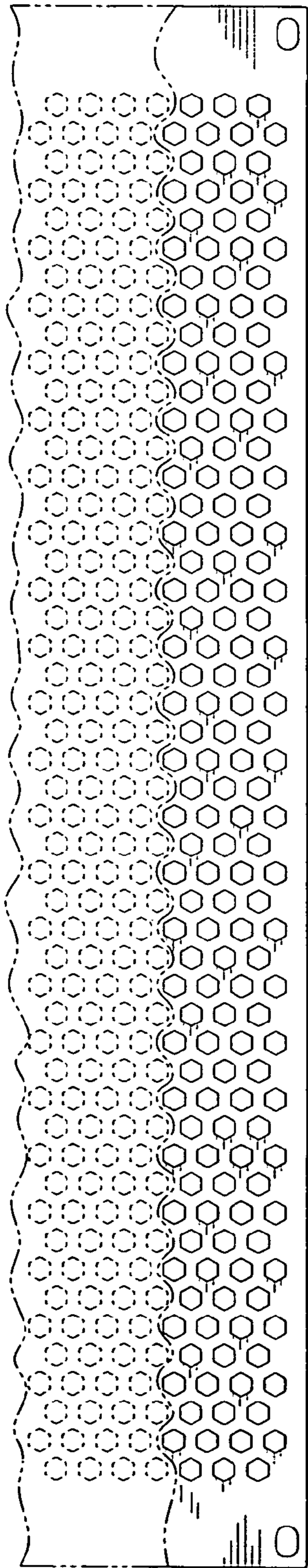

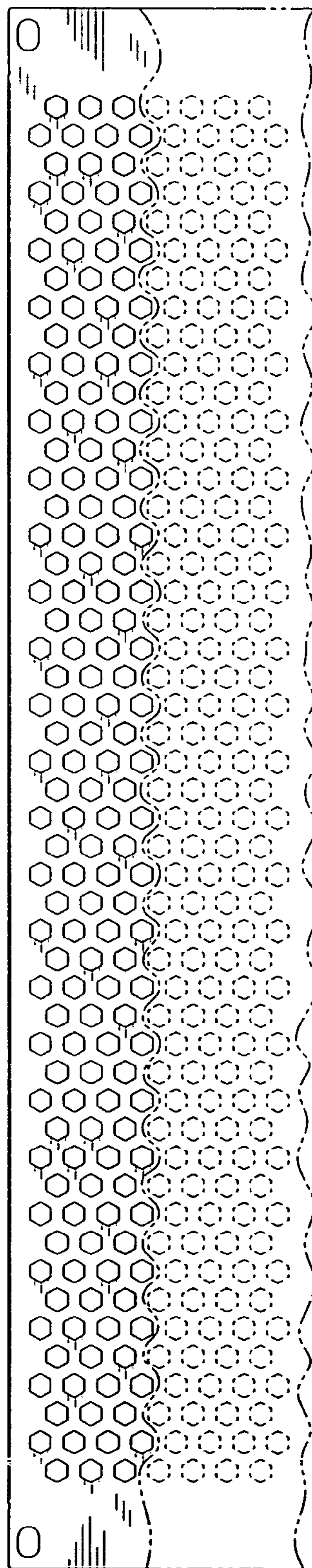

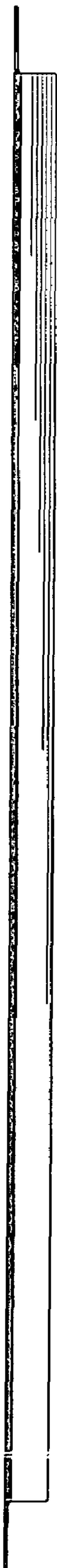

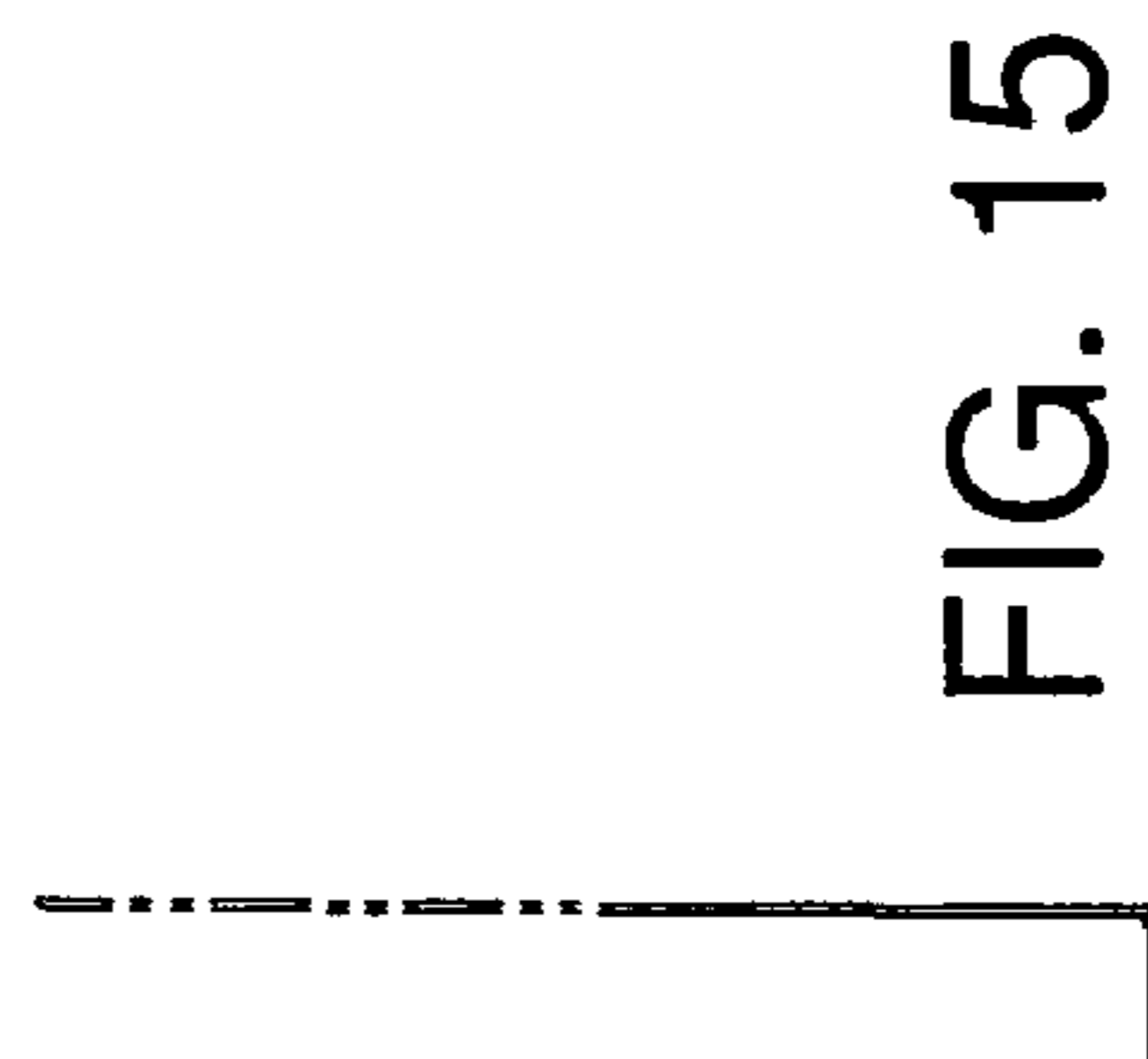
