DESCRIPTION

FIG. 1 is a bottom view of a petri dish showing my new design;

FIG. 4 is front view thereof;

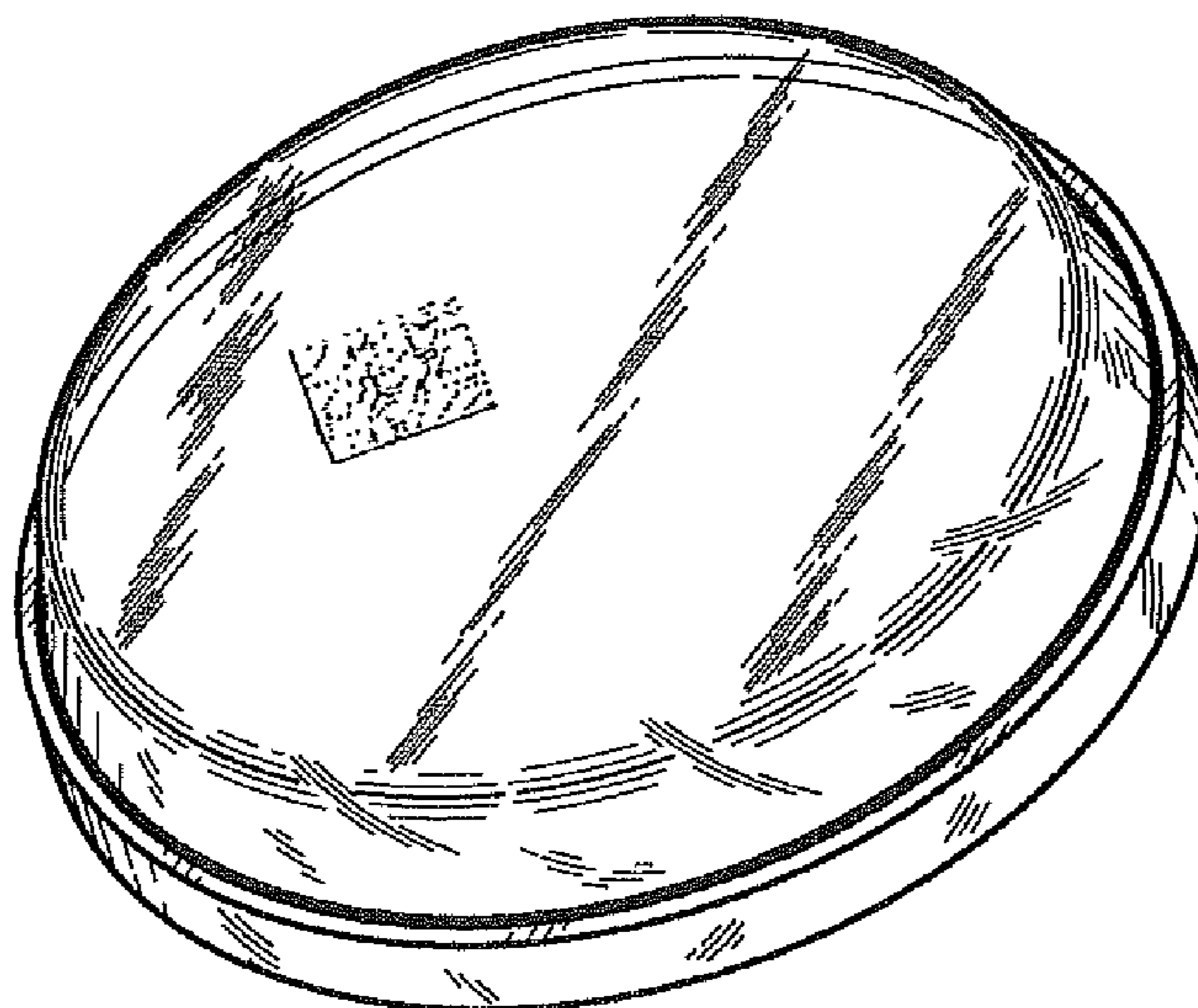
FIG. 5 is a left side view thereof;

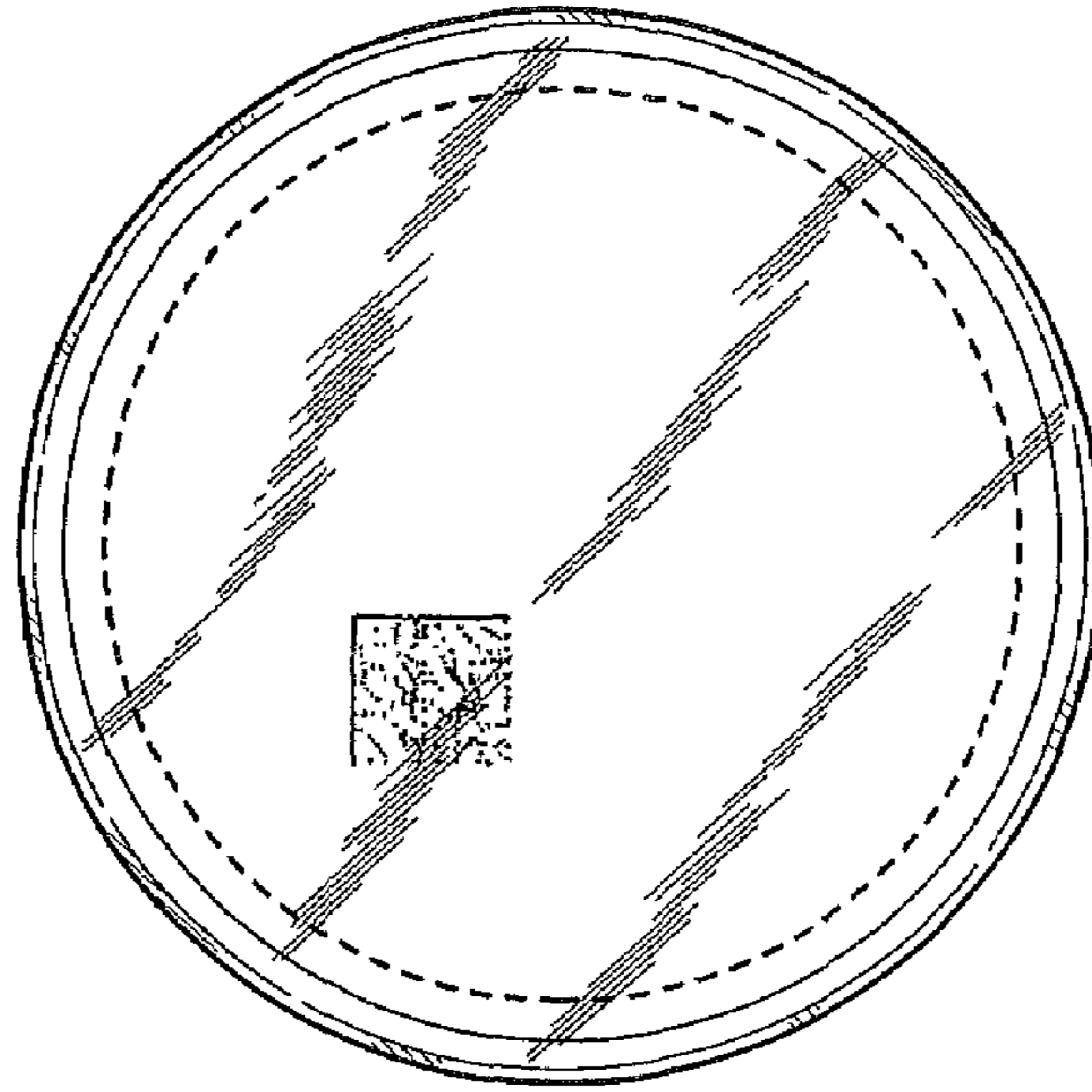

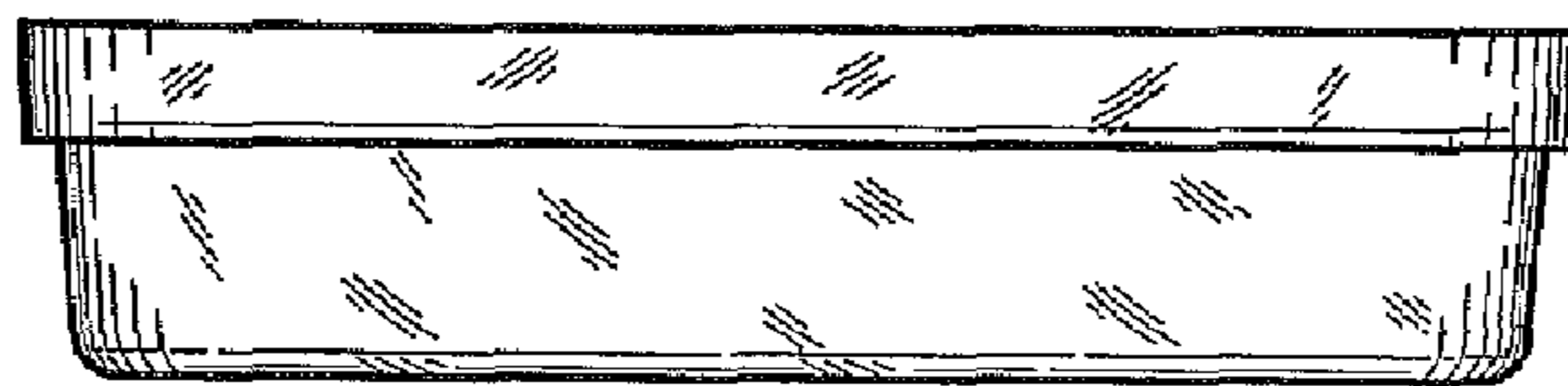

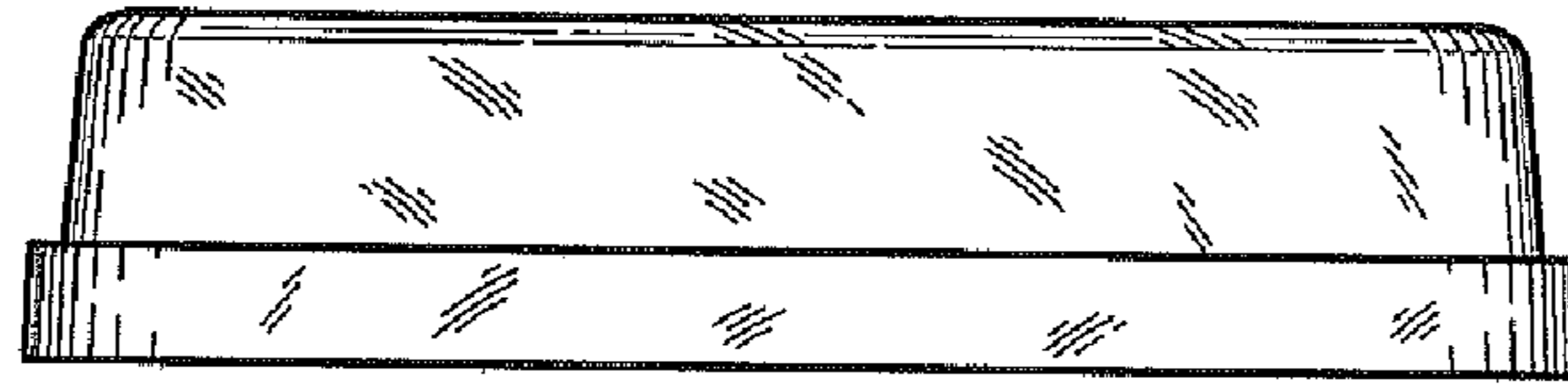

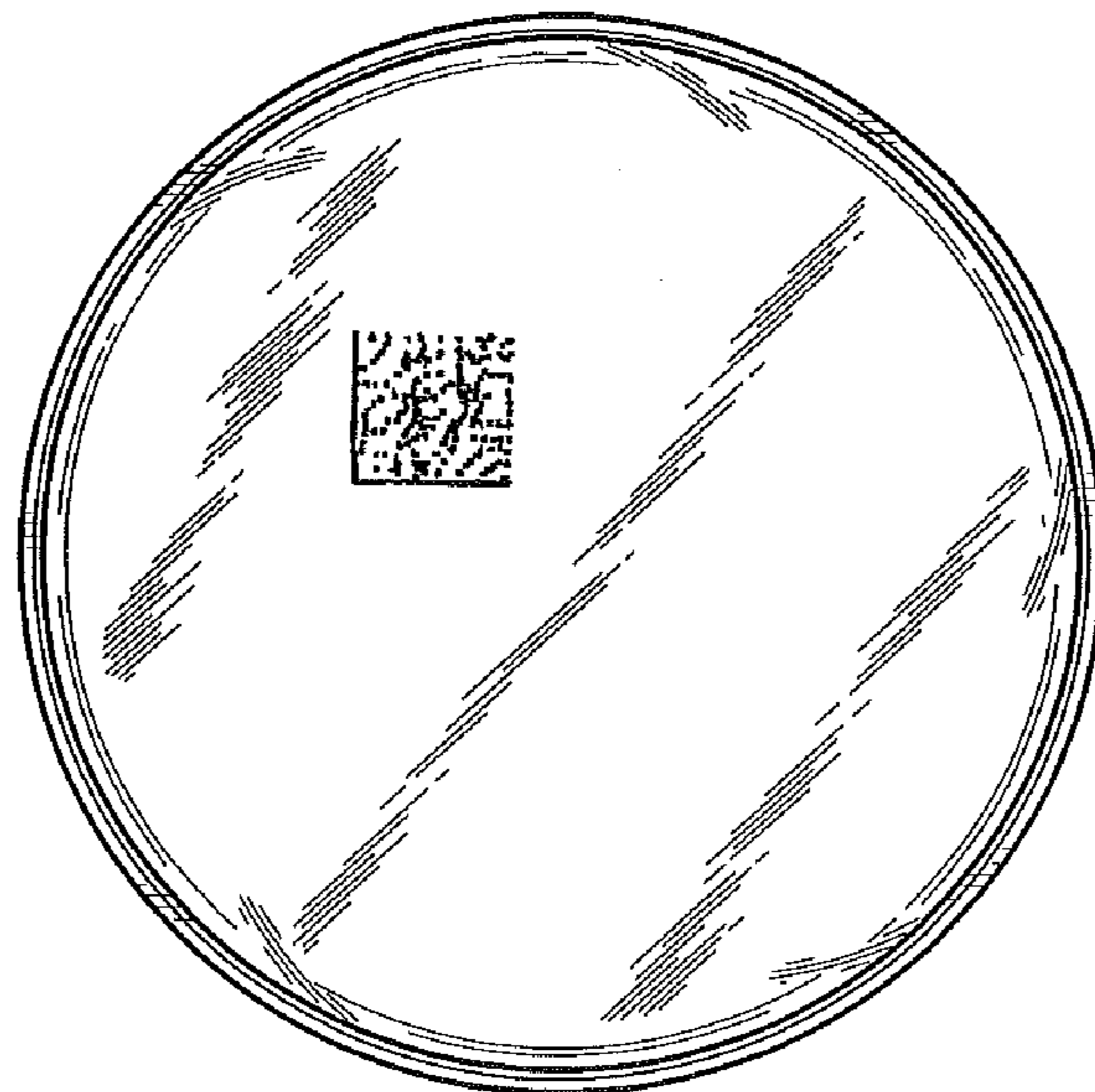

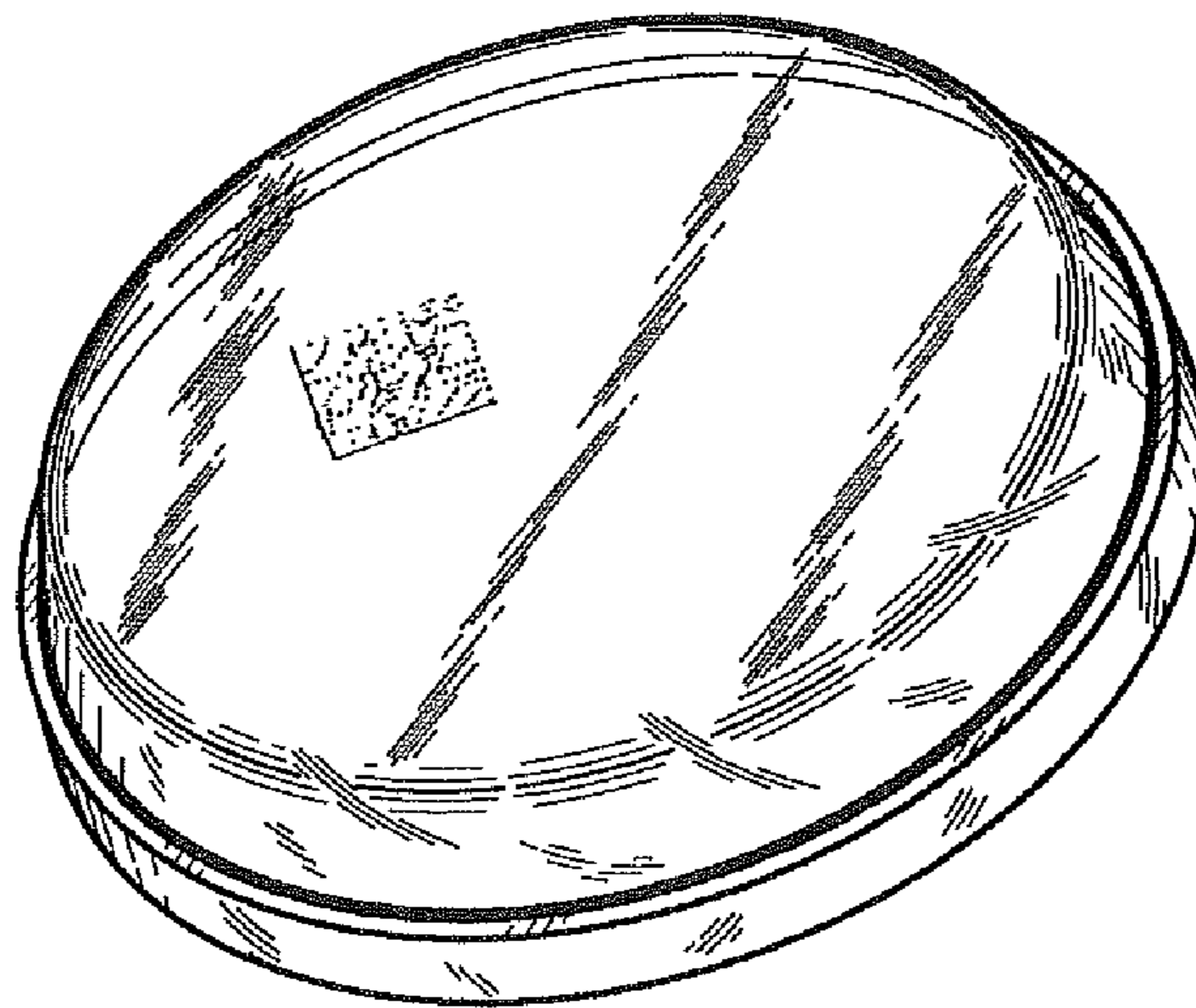
