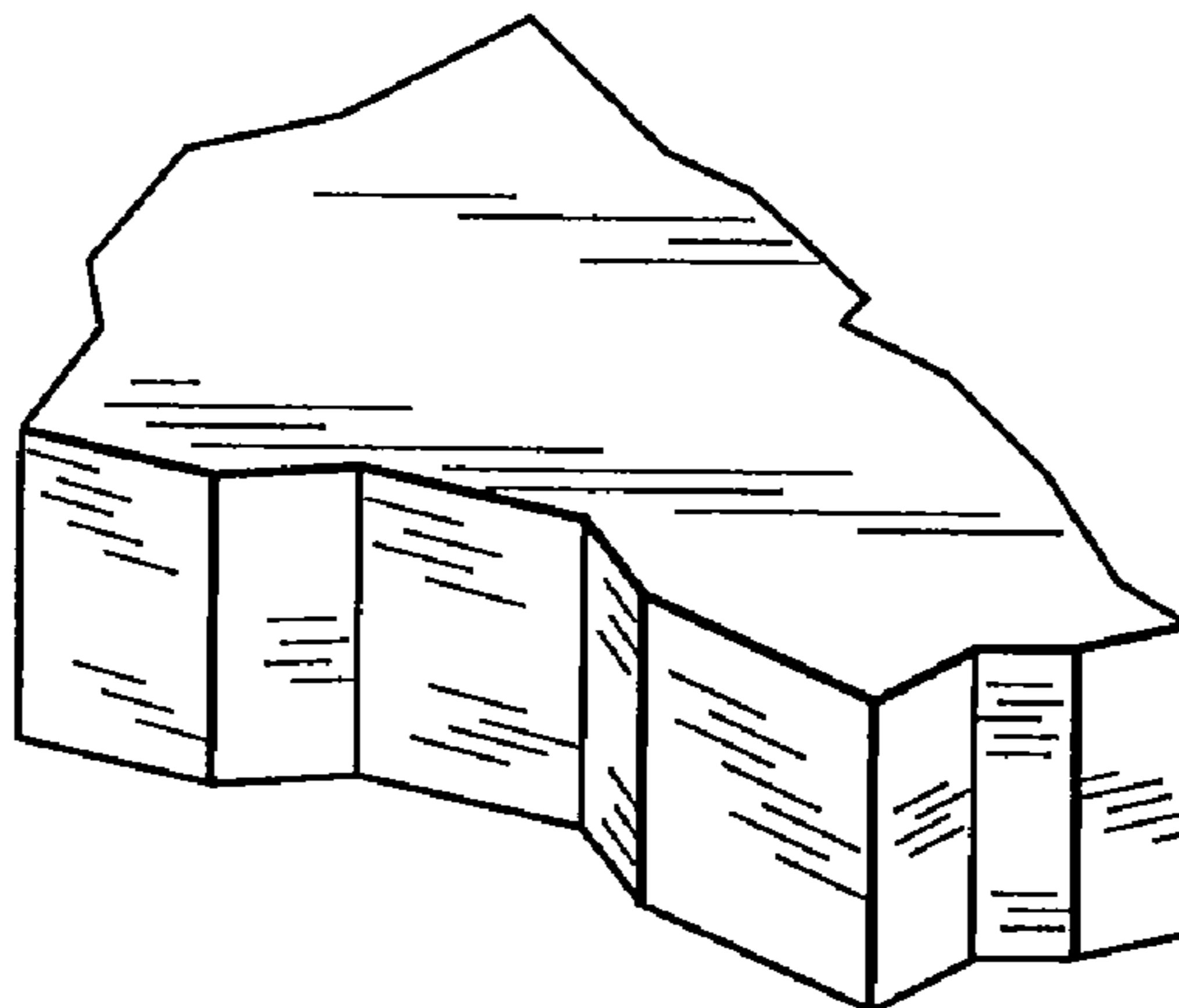

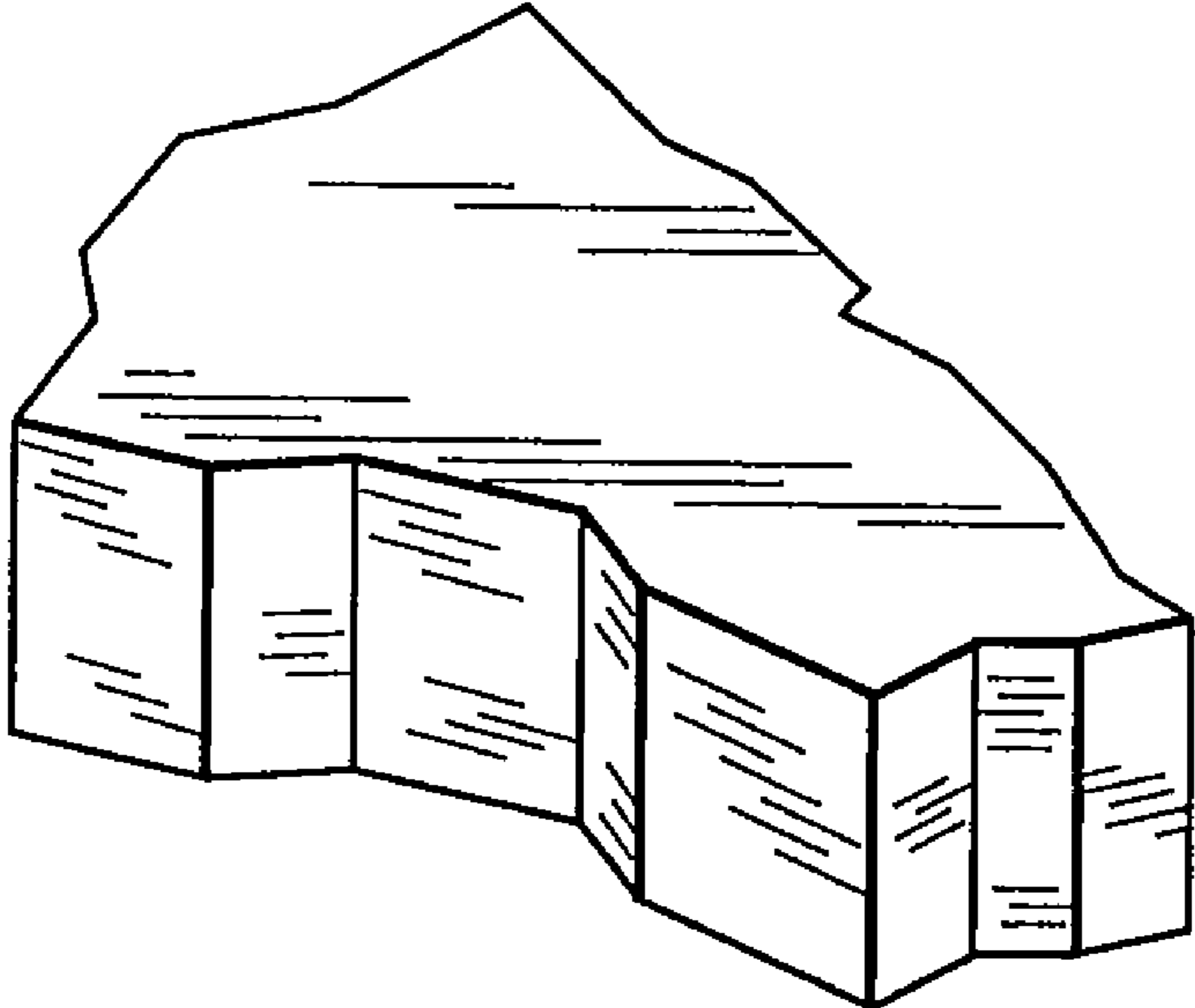
The ornamental design for a paver, as shown.

**DESCRIPTION**

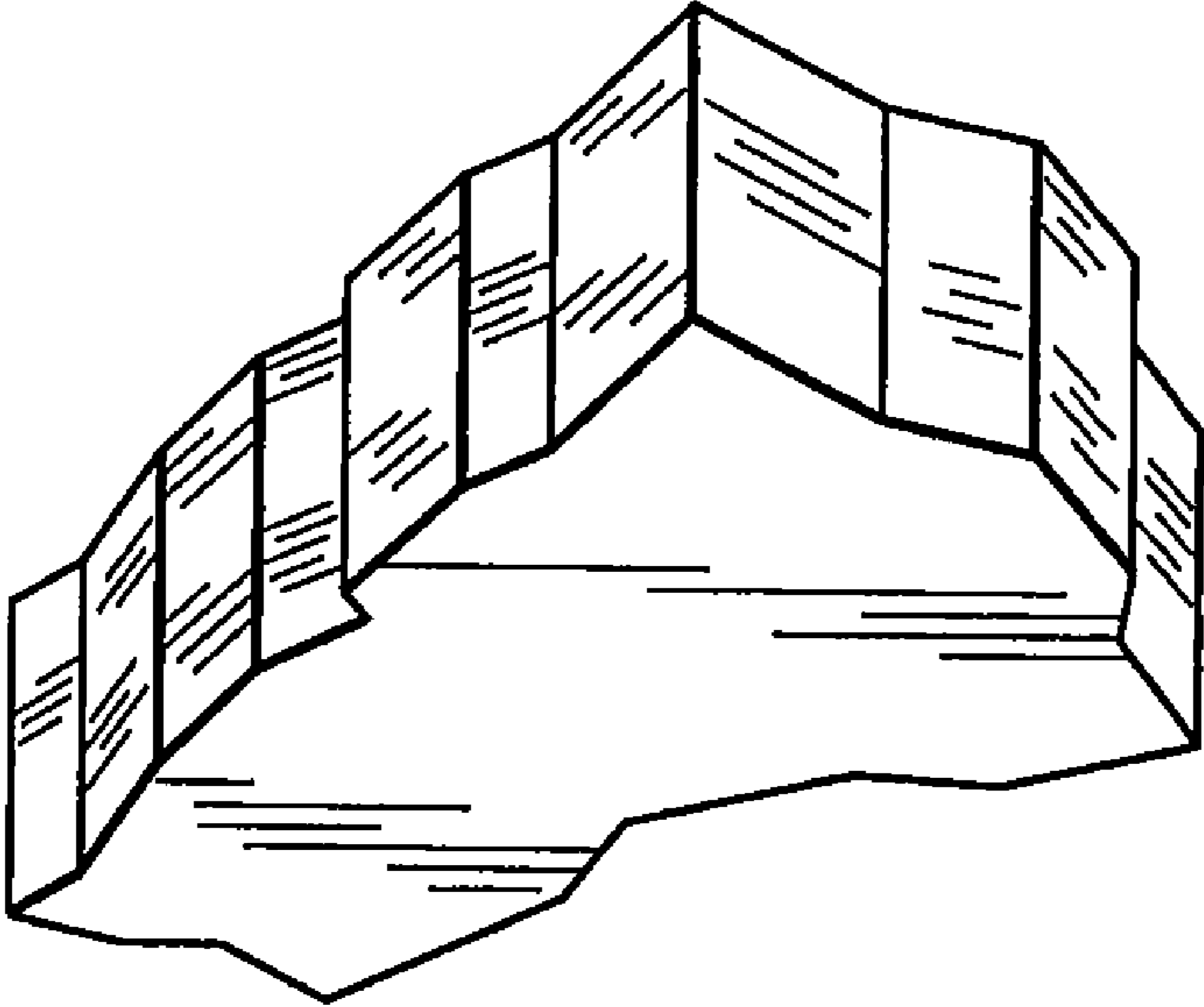
FIG. 1 is a top perspective view of the design;

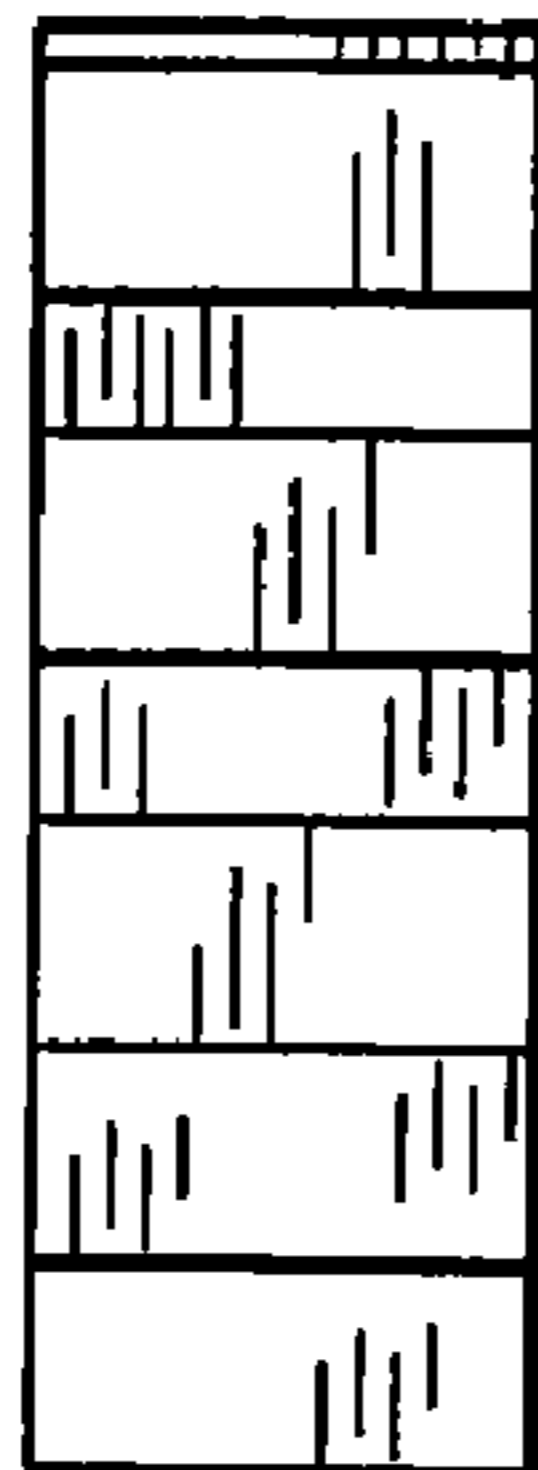

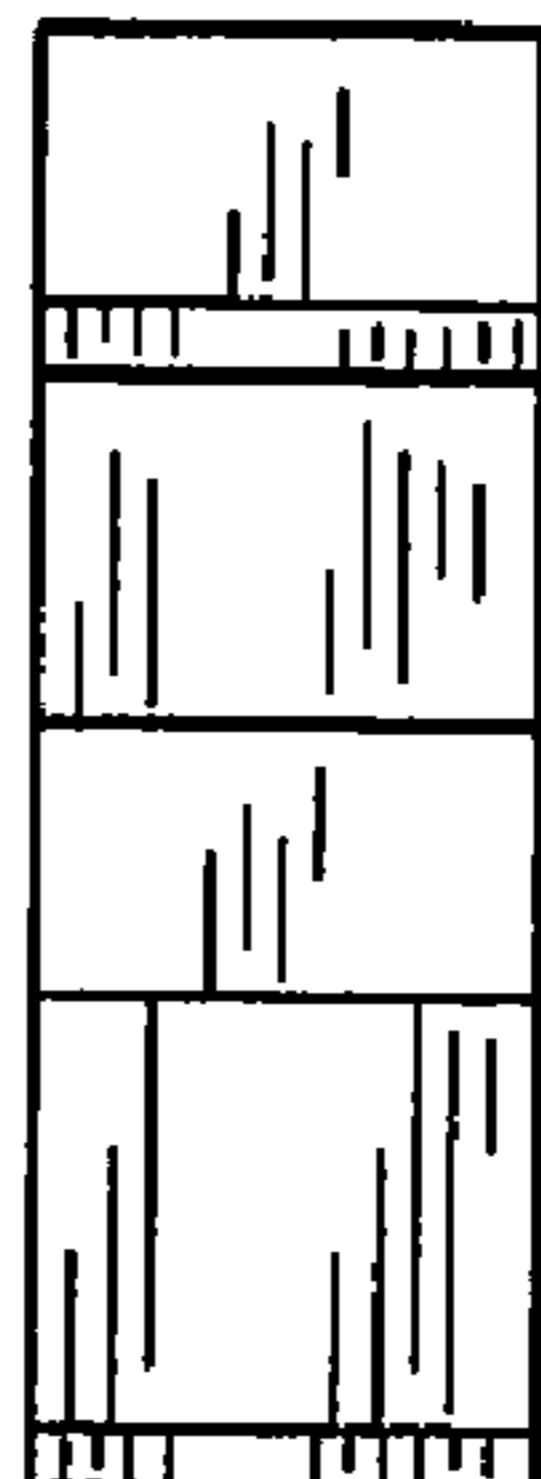

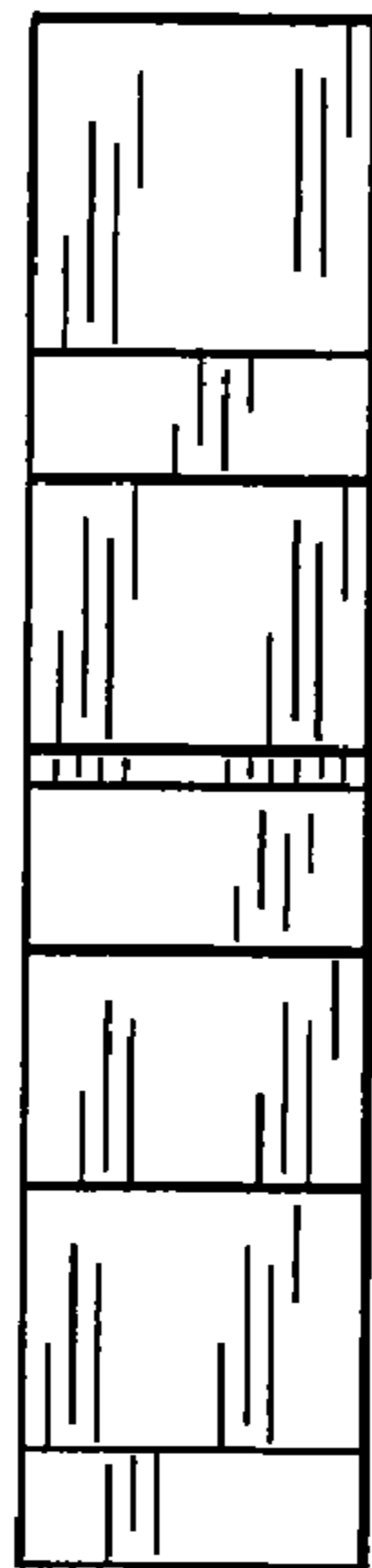
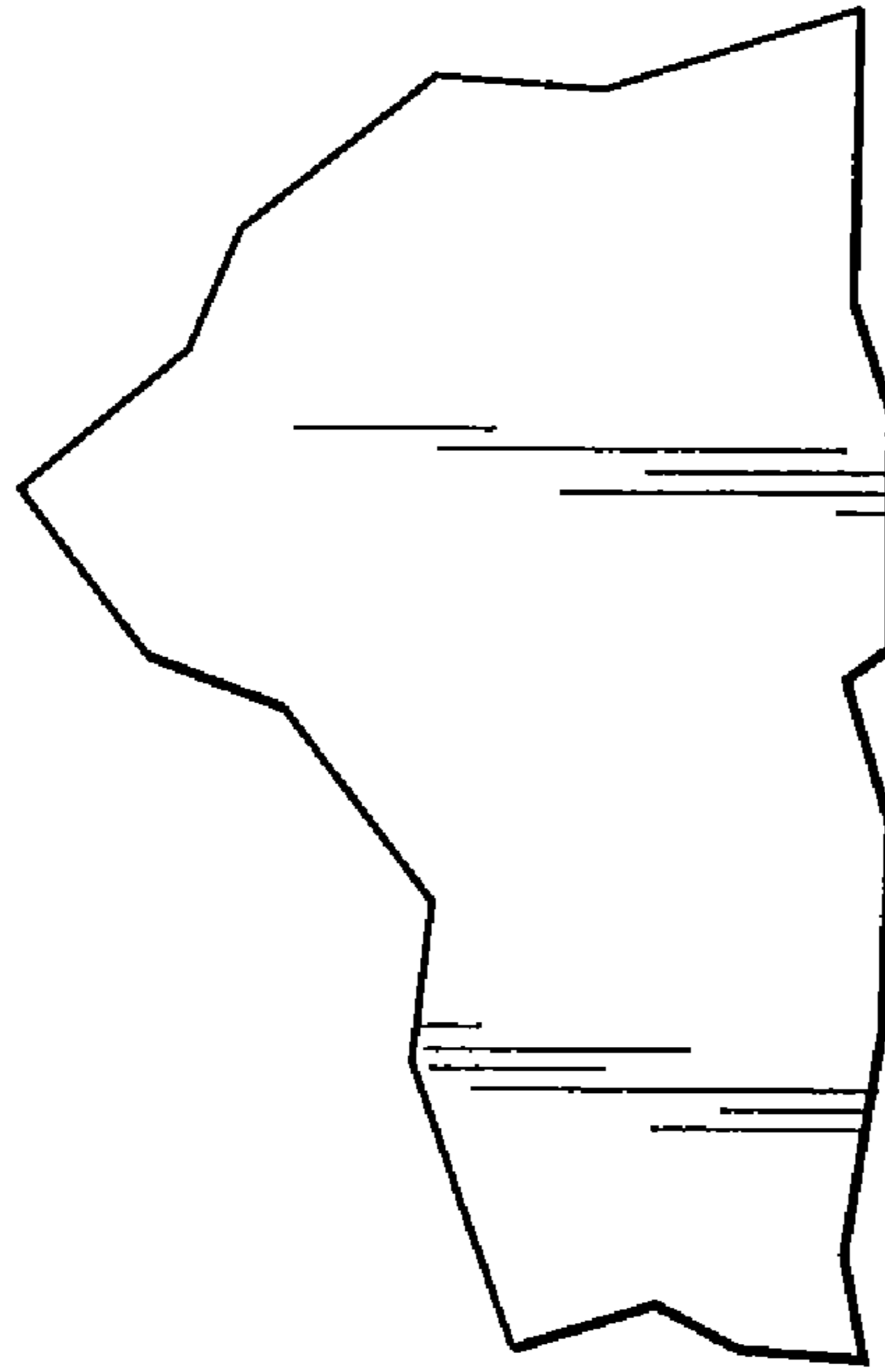
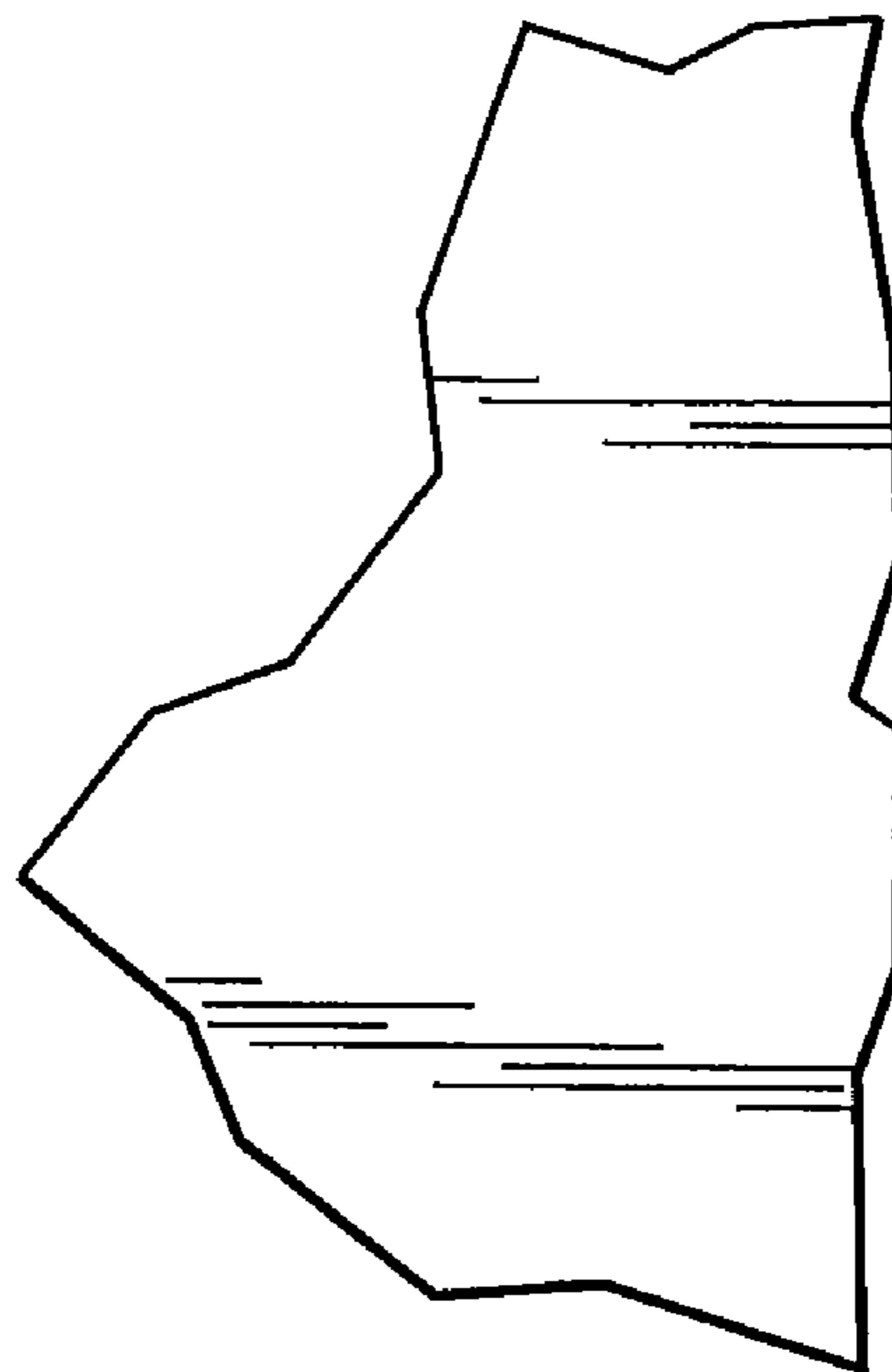
