(57) **CLAIM**

The ornamental design for a marker light, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right perspective view of a marker light showing the new design;

FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image duplicate;

FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image duplicate;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front, top, right perspective view of an alternate arrangement of the marker light of FIGS. 1-5;

FIG. 7 is a front elevation view thereof, the rear elevation view being a mirror image duplicate;

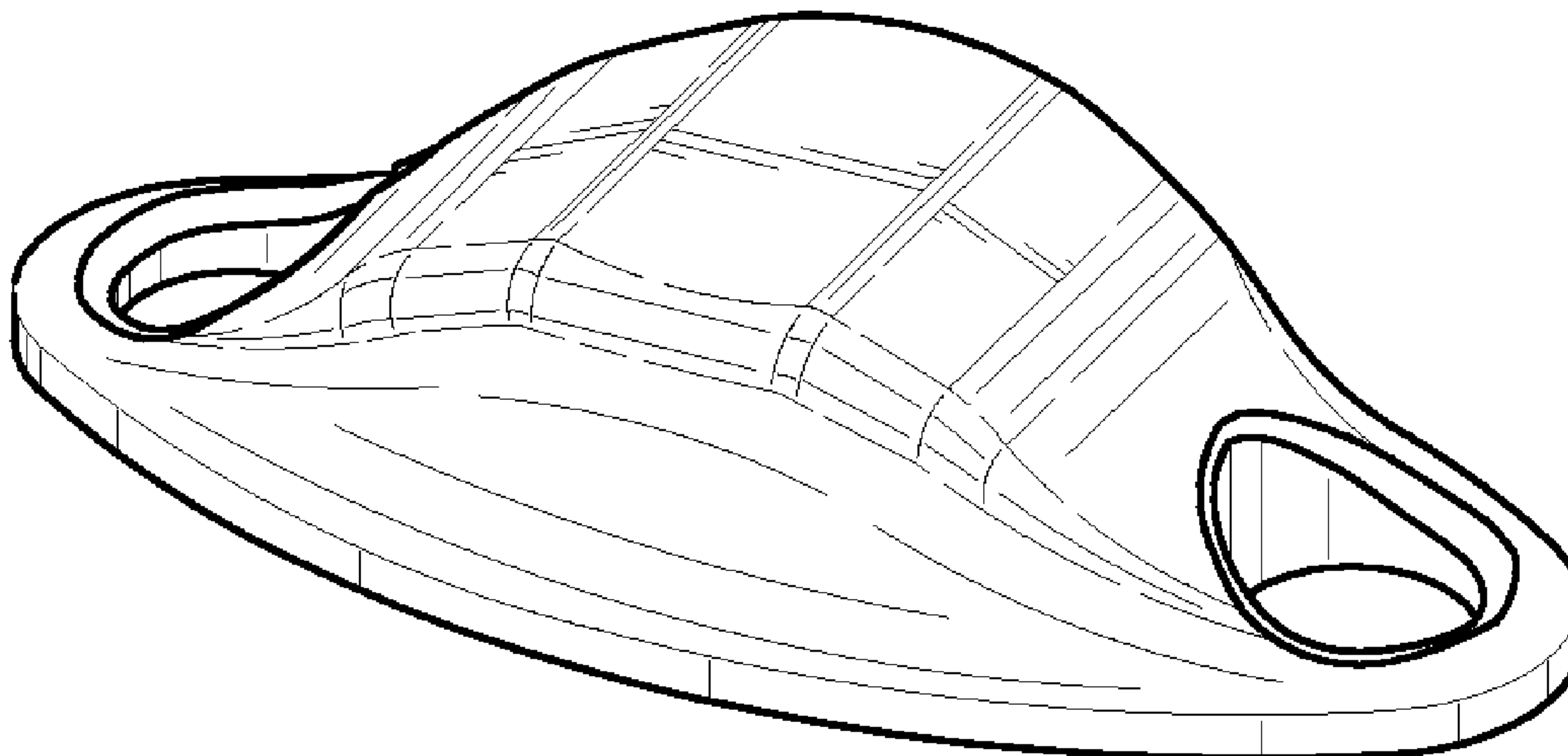
FIG. 8 is a right side elevation view thereof, the left side elevation view being a mirror image duplicate;

FIG. 9 is a top plan view thereof; and,

FIG. 10 is a bottom plan view thereof.

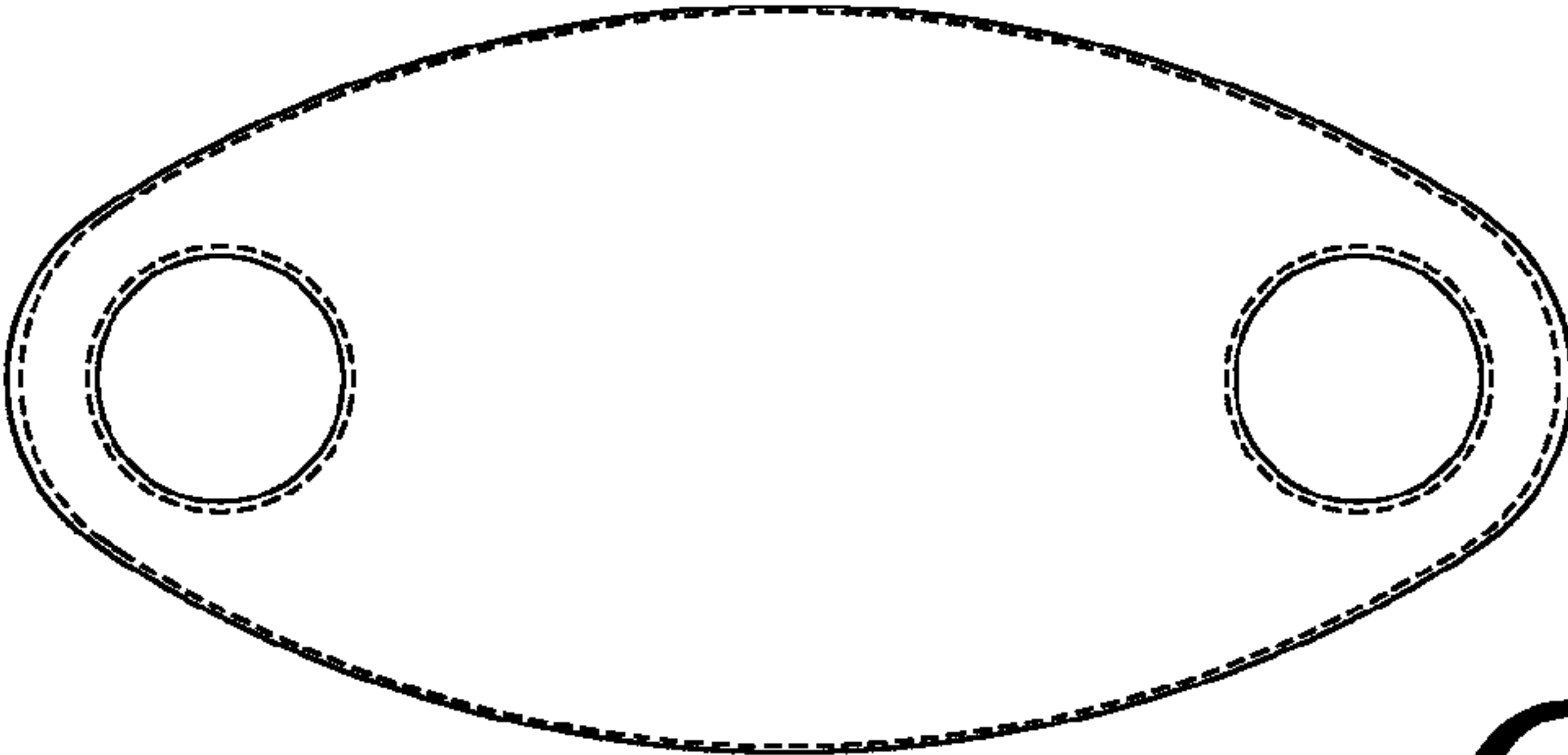
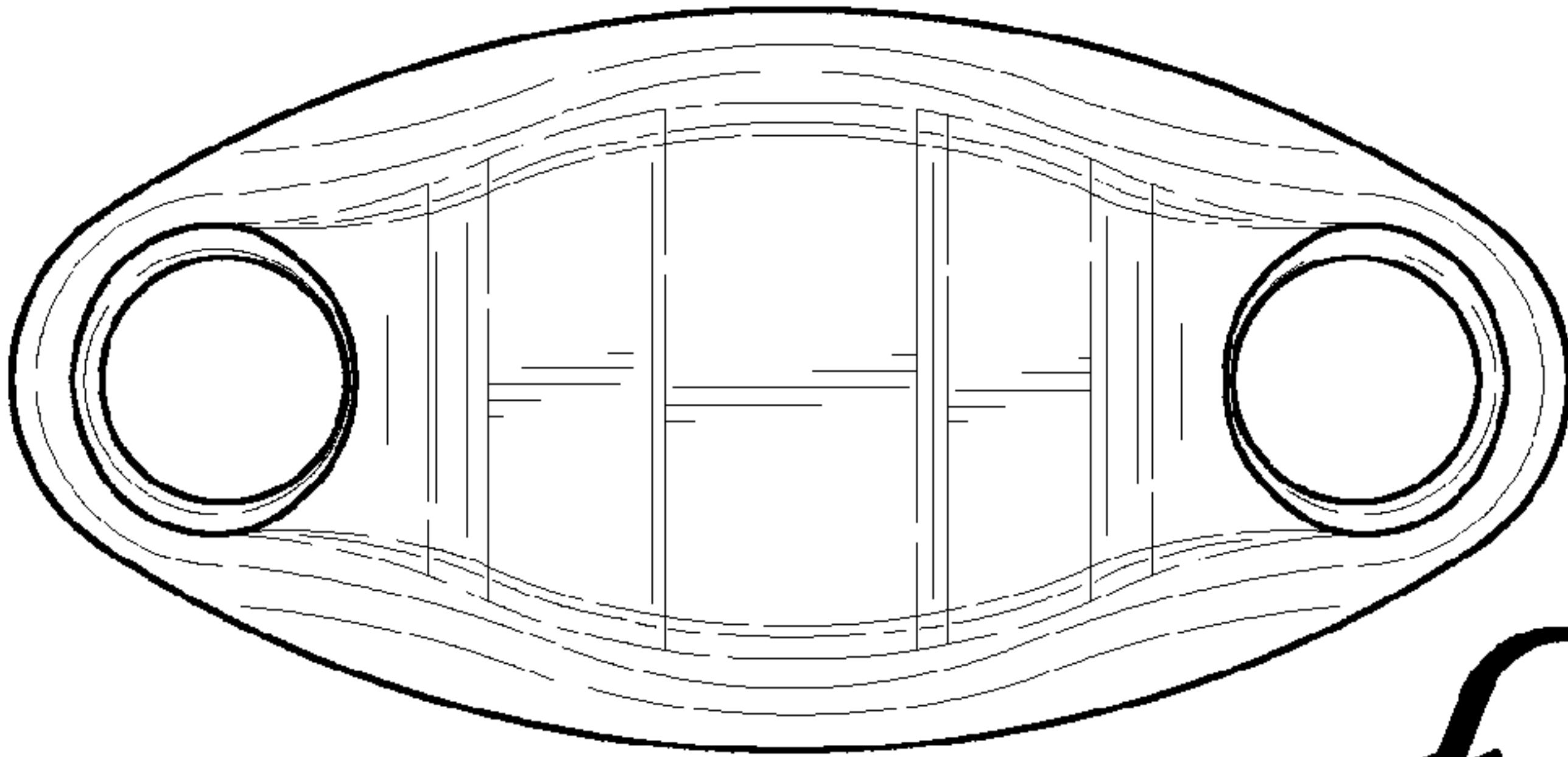
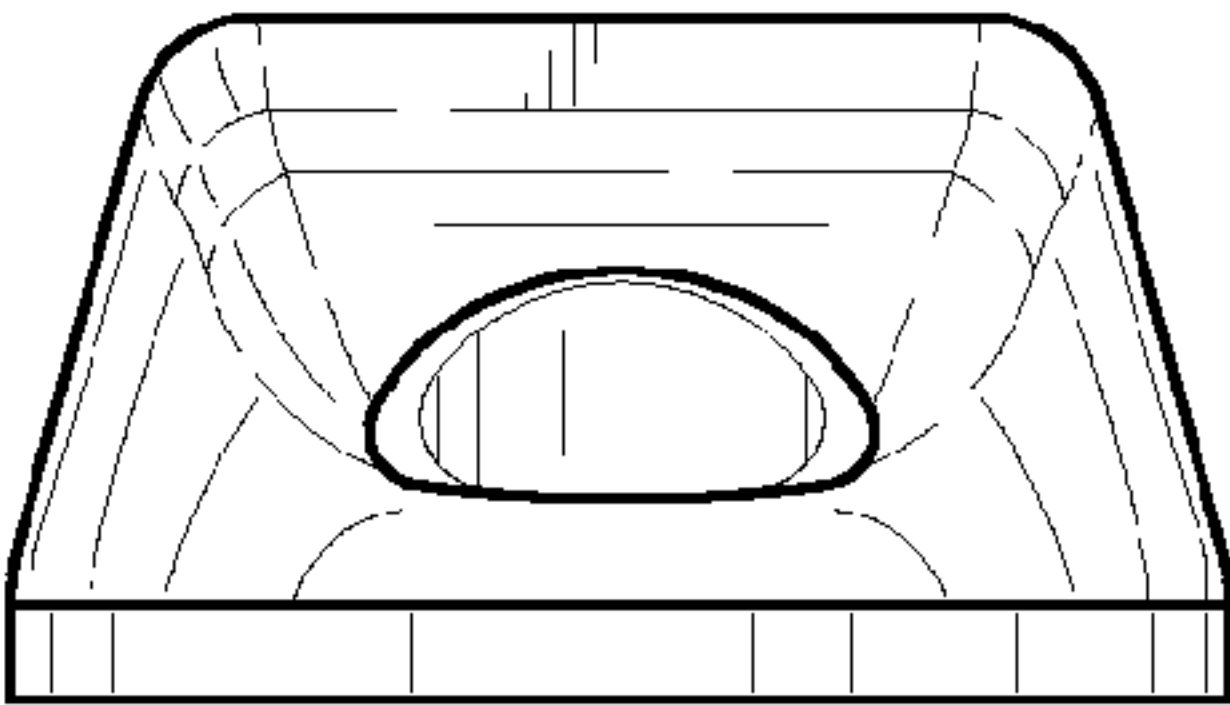
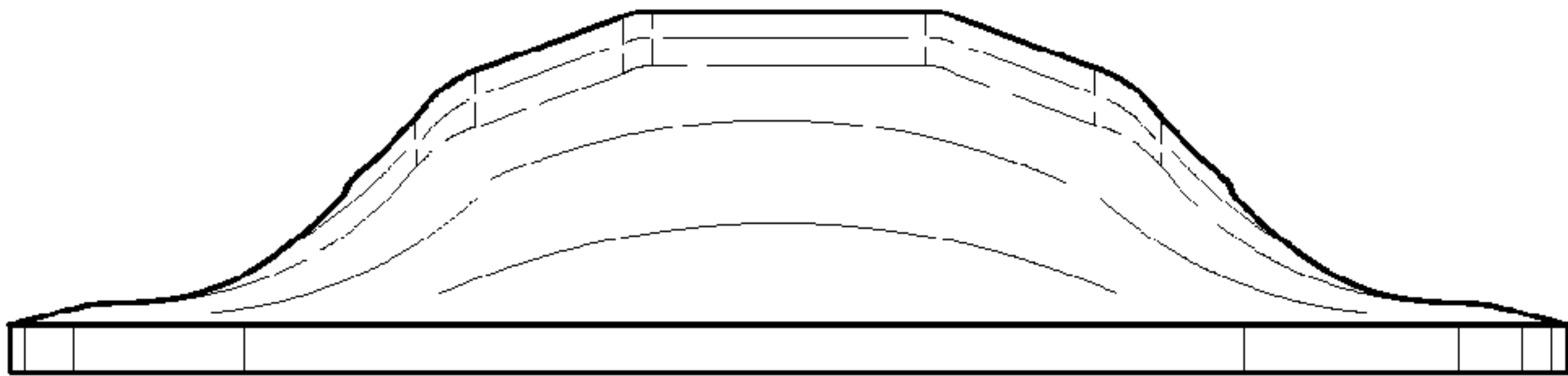
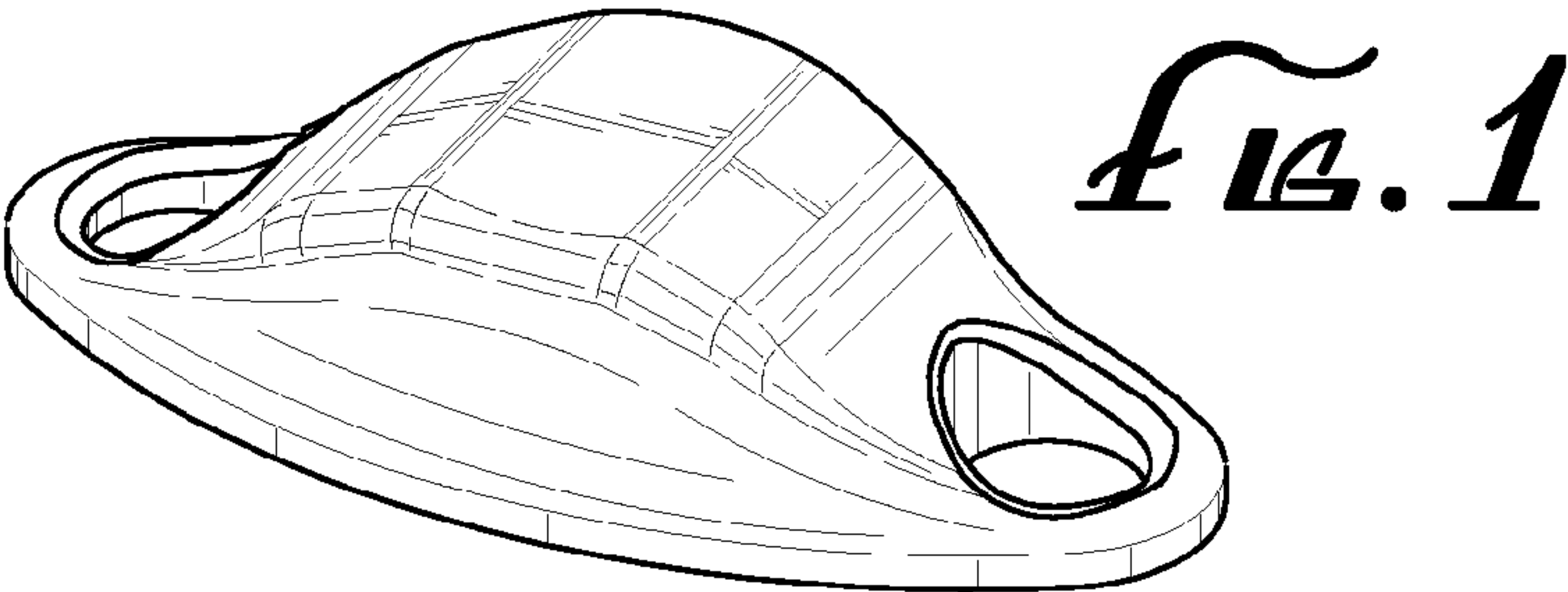

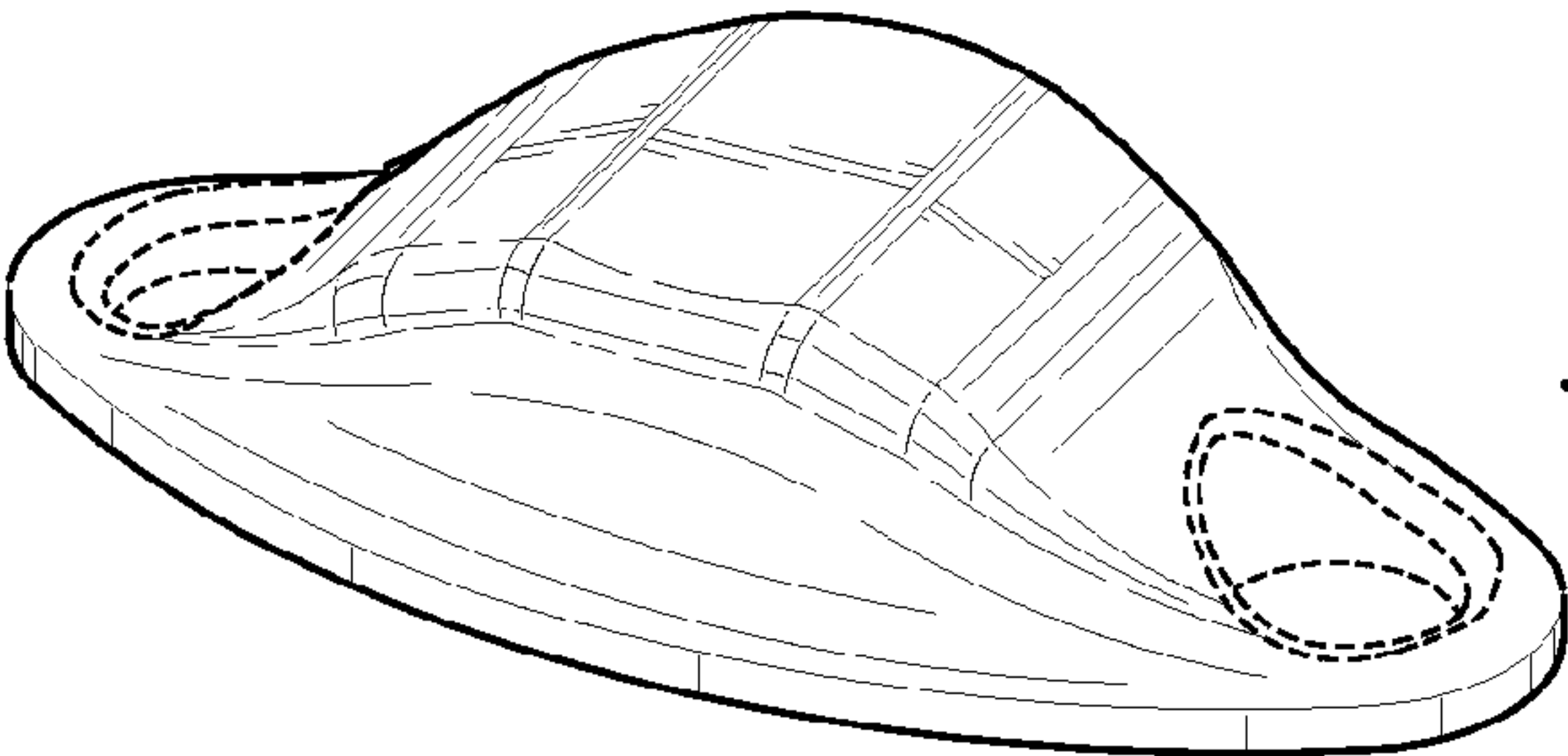

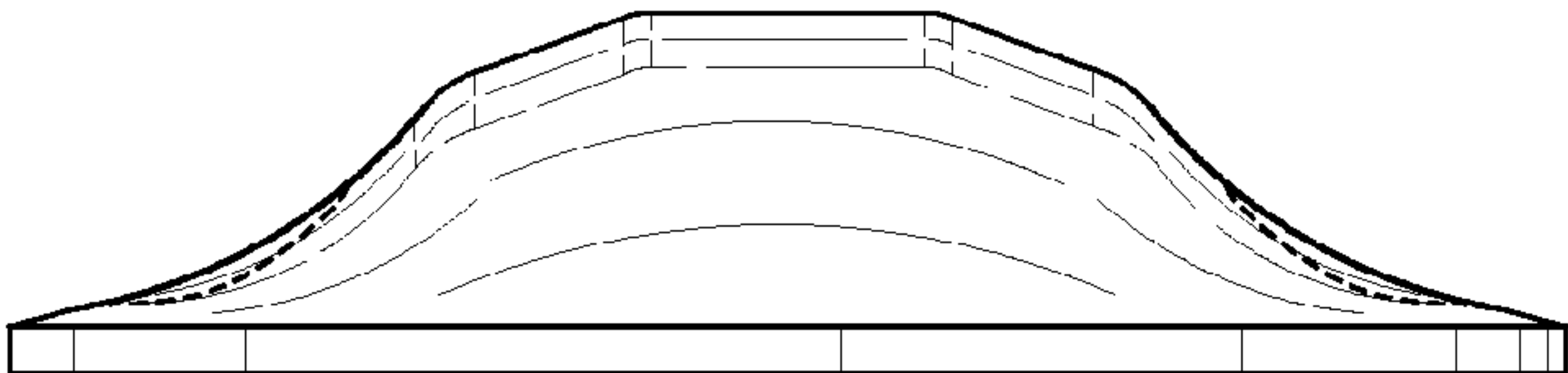

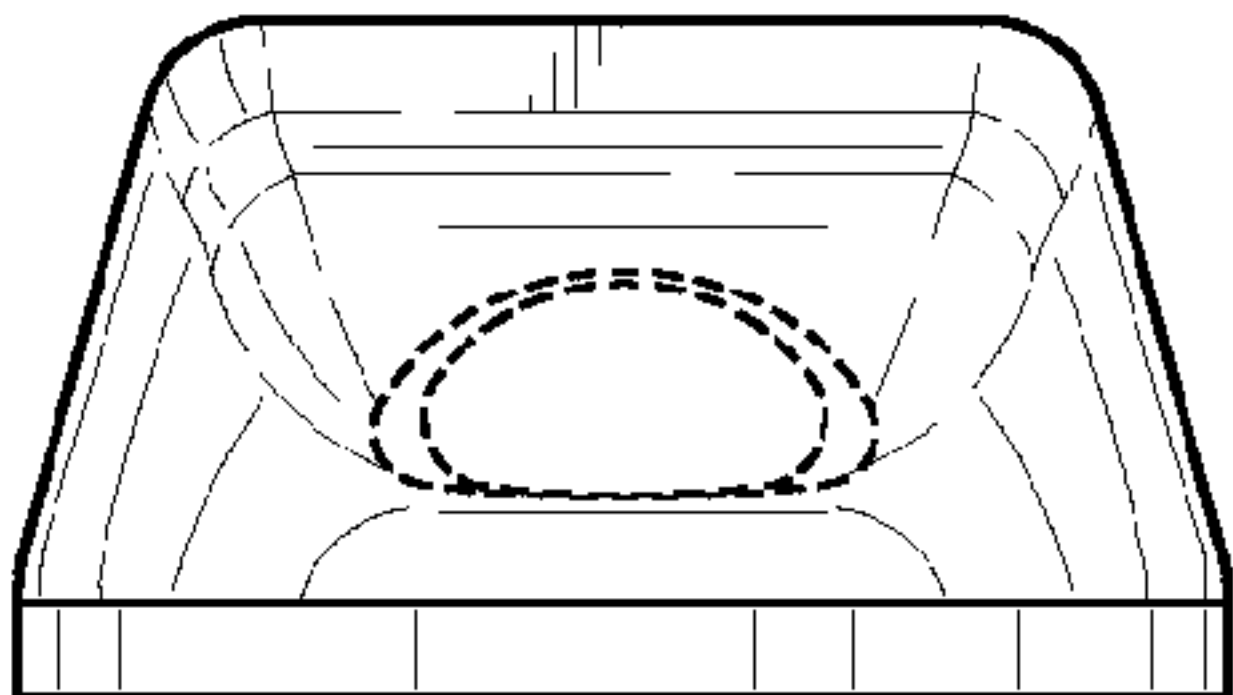

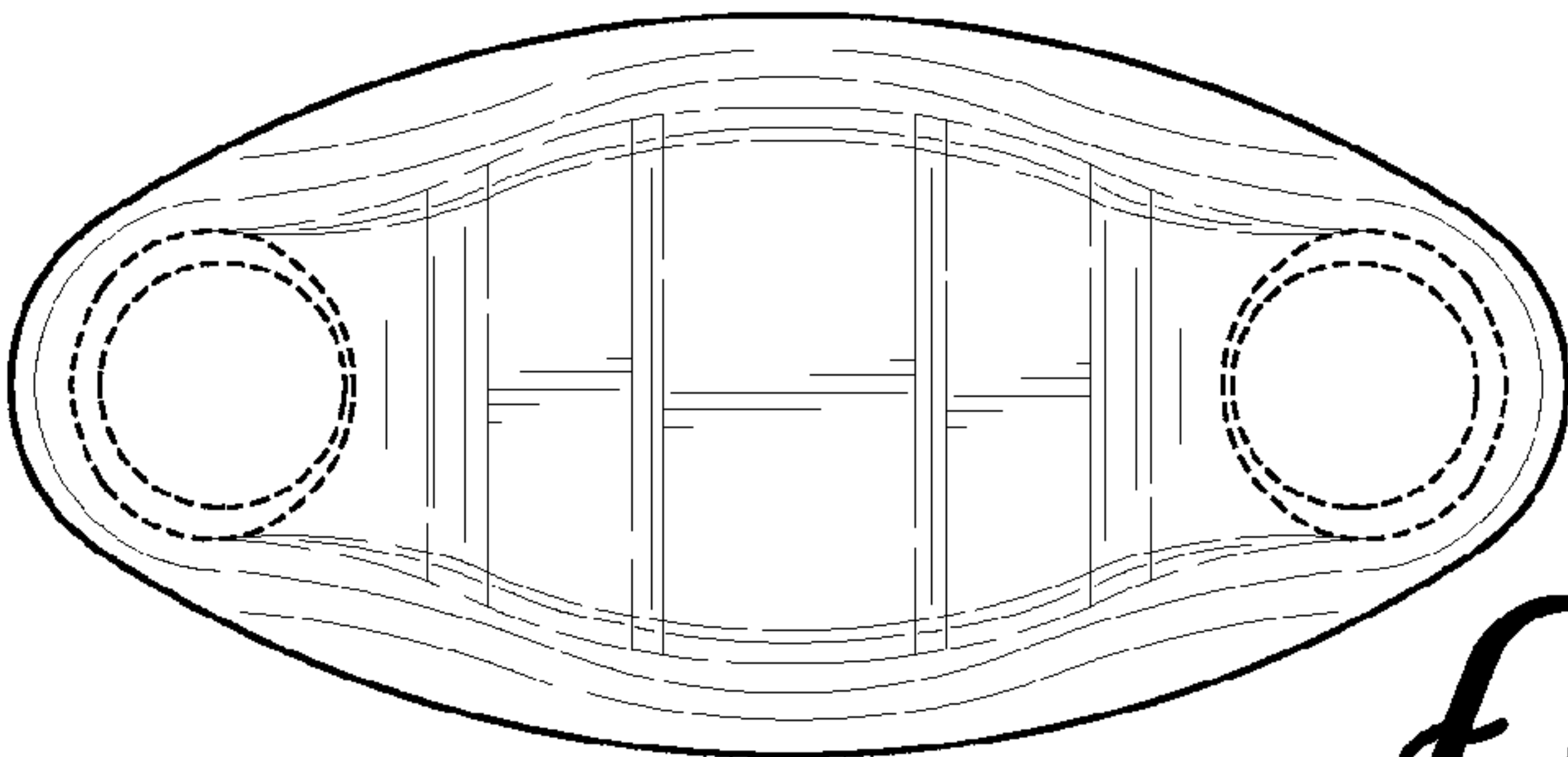

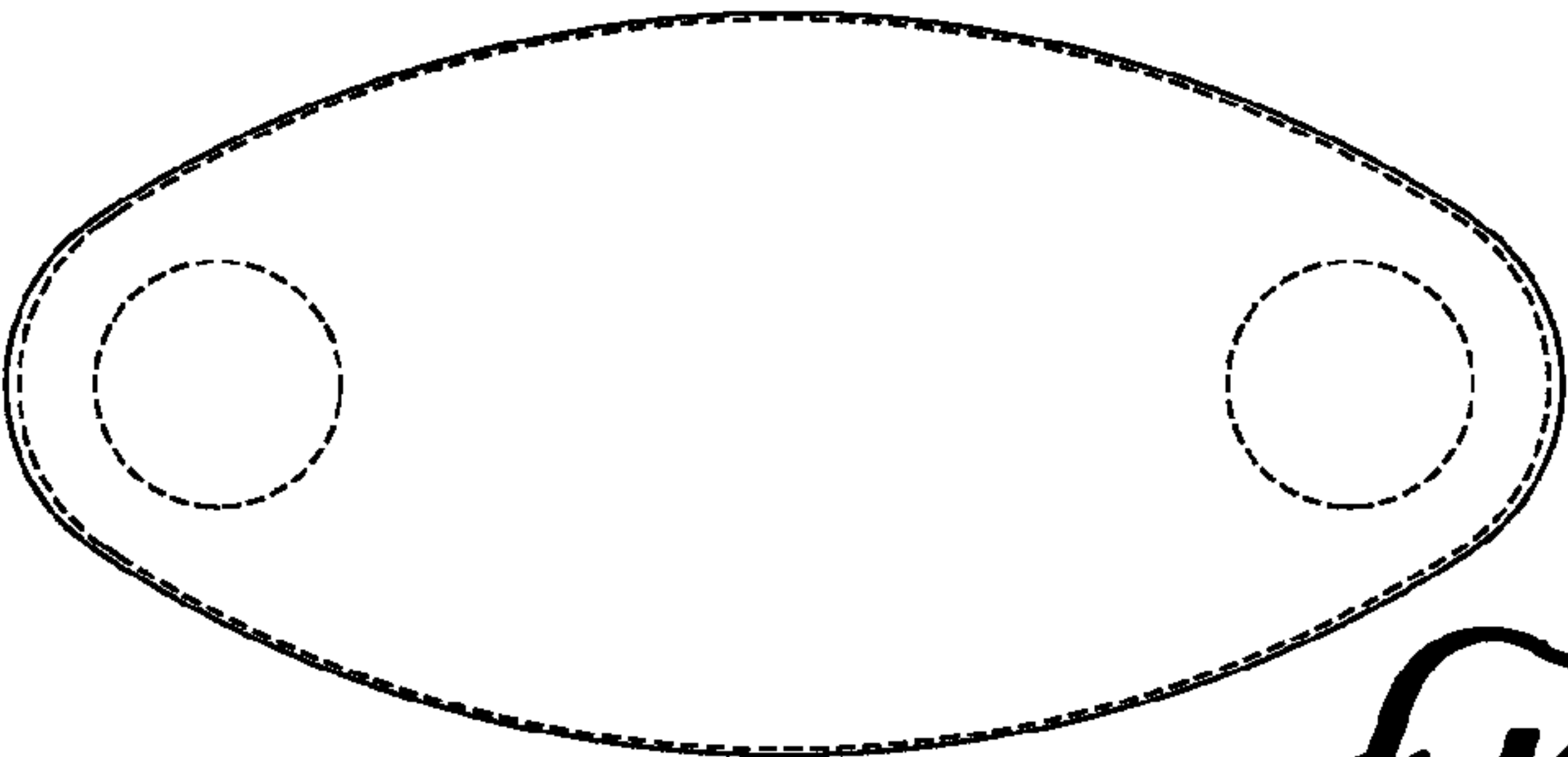
