FIG. 1 is a perspective view of the extrusion for base of linear lighting apparatus of the present design.

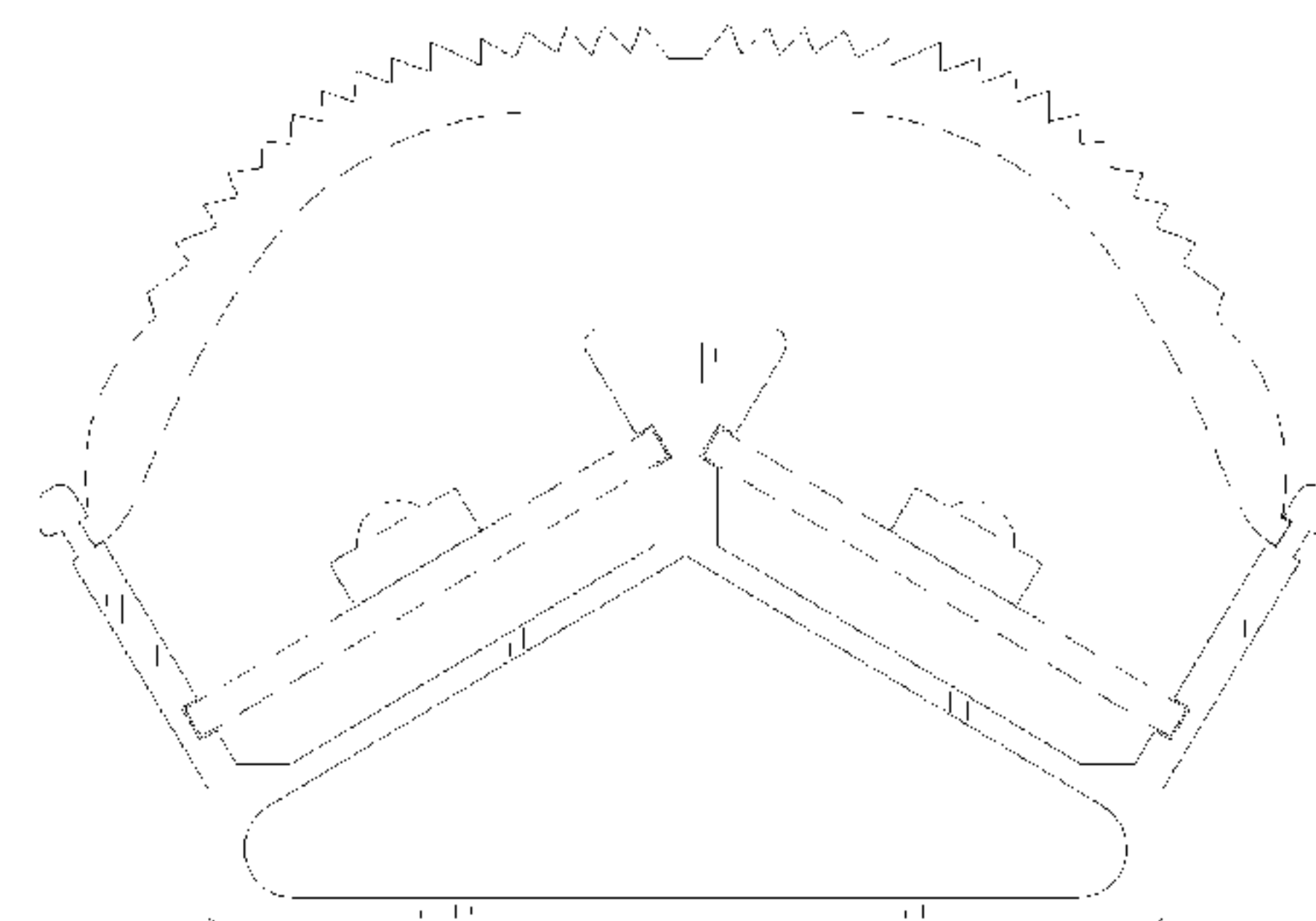
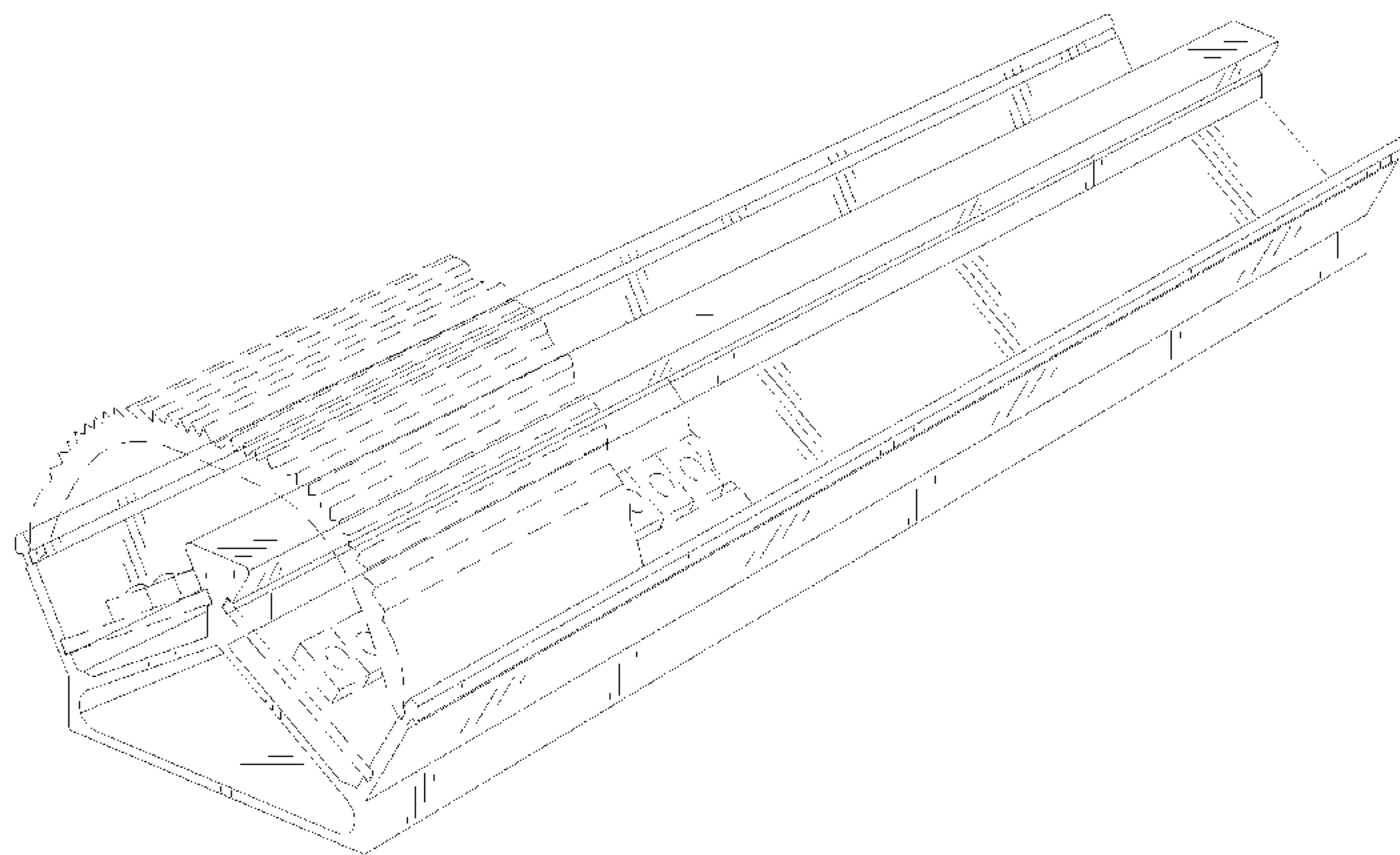
FIG. 2 is a left side elevational view, the right side elevational view being a mirror image thereof.

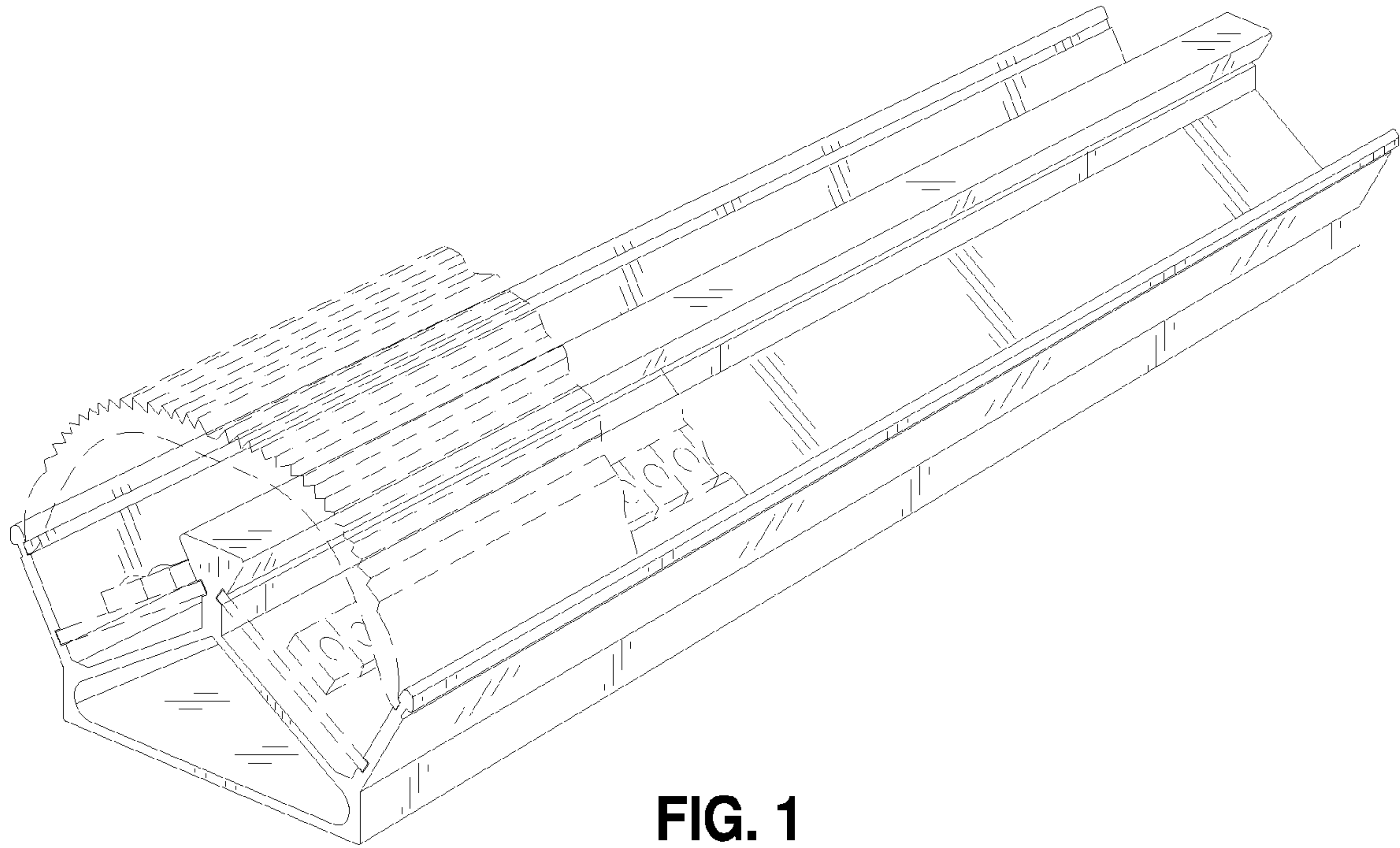

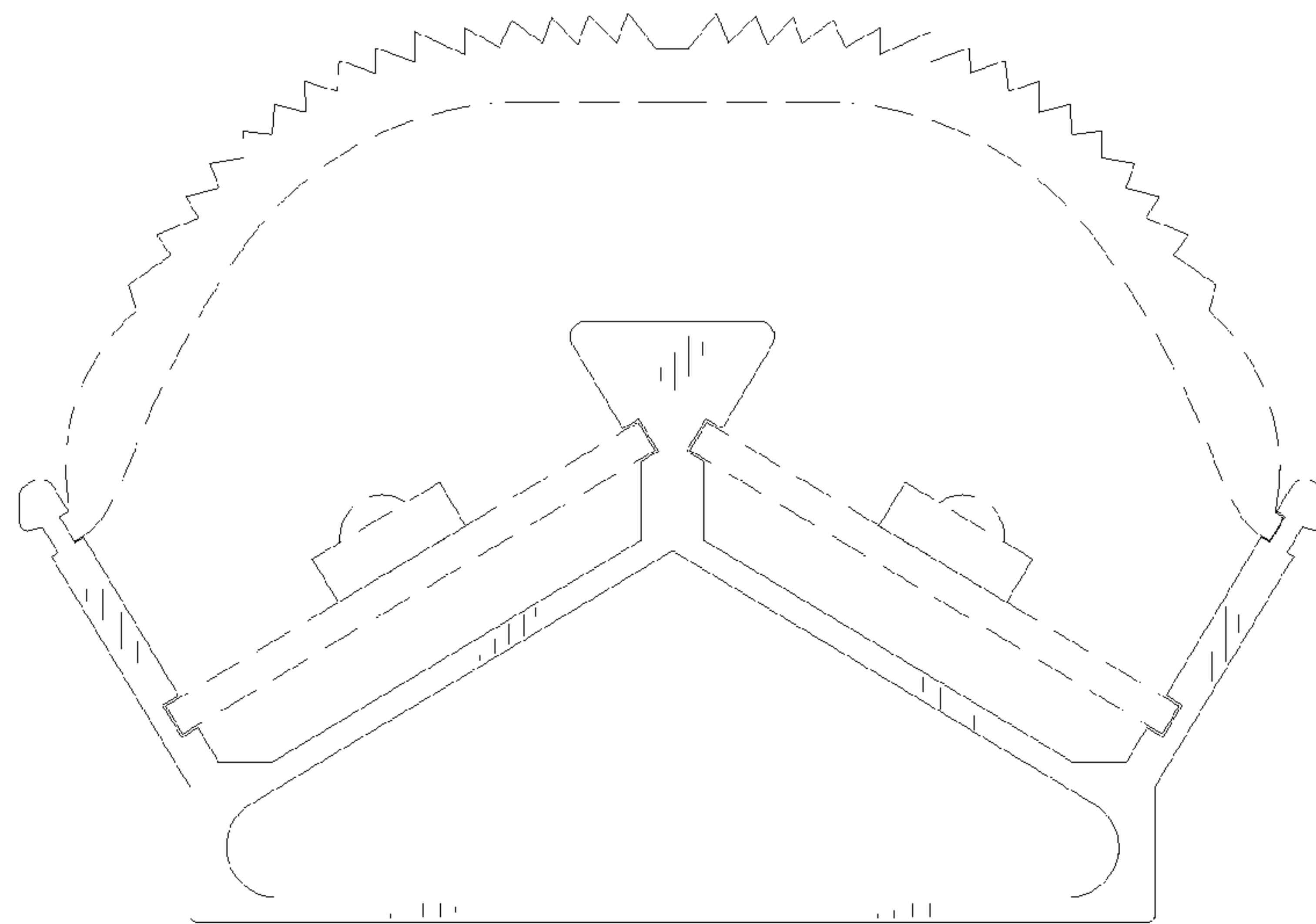
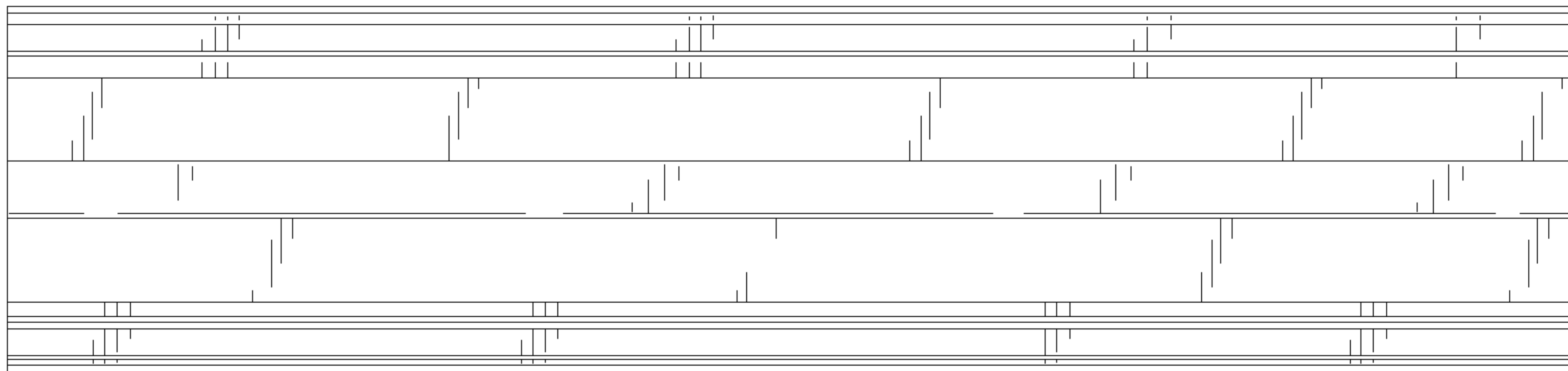
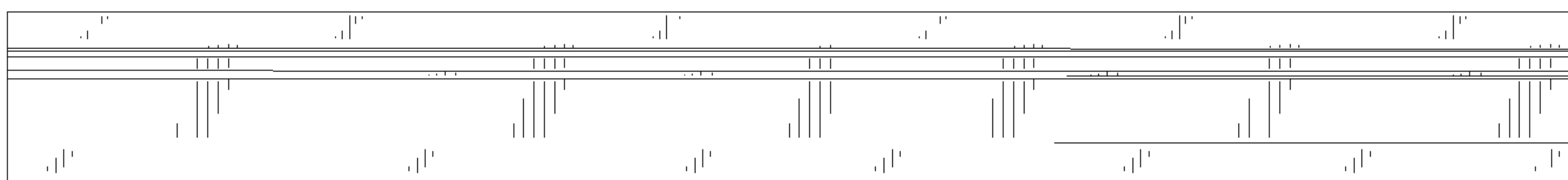


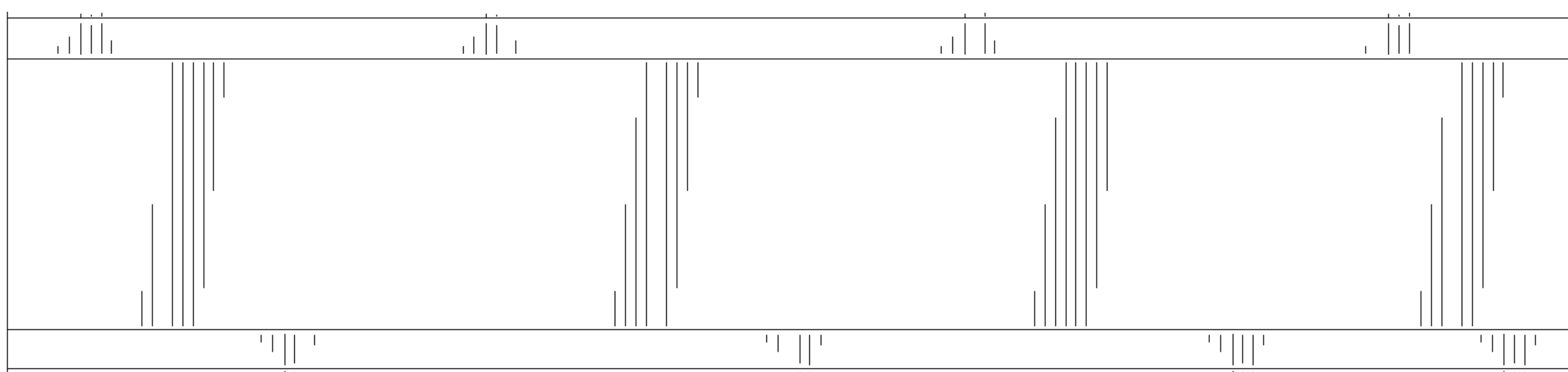
