FIG. 2 is a top view of my new design;

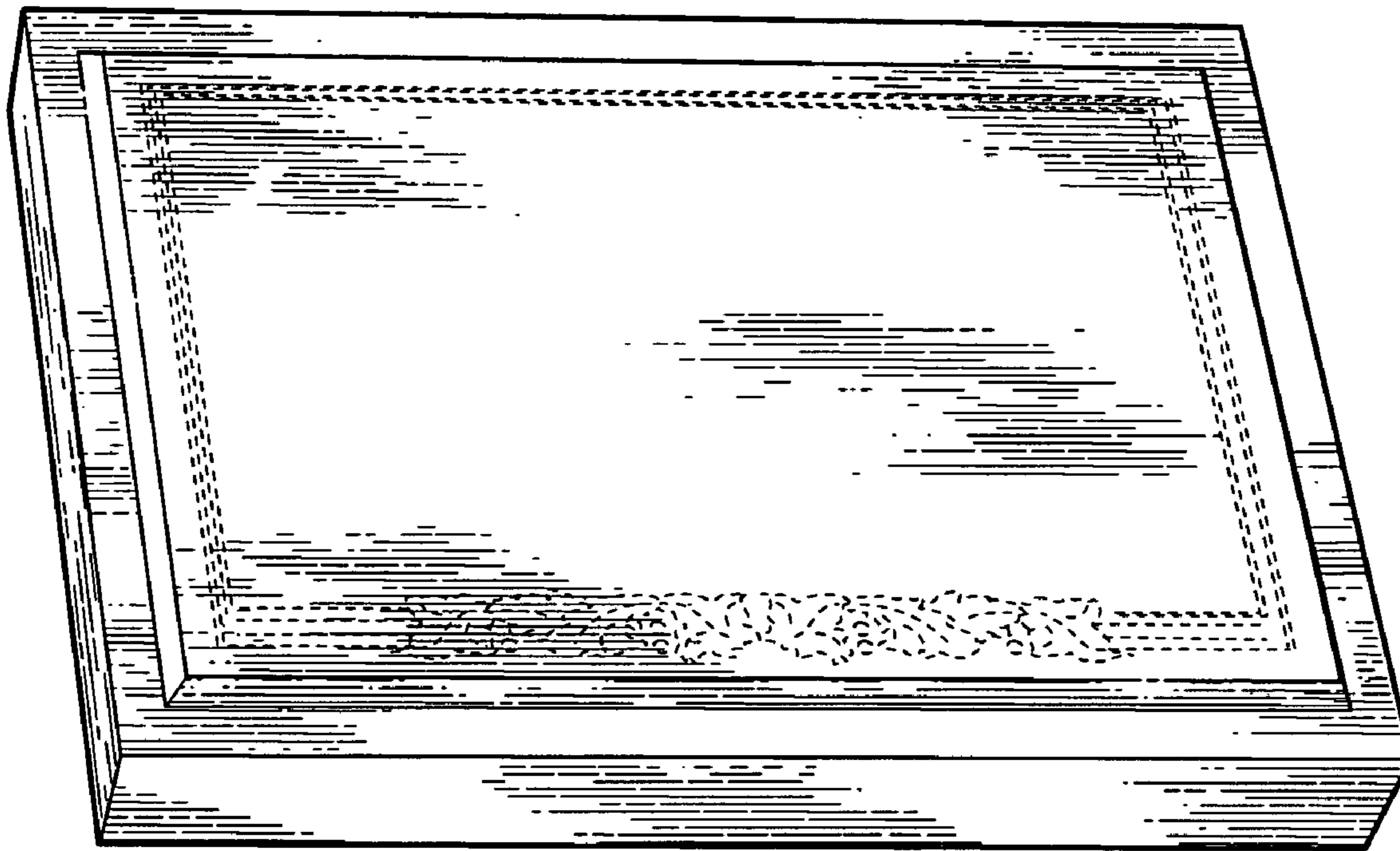
FIG. 3 is a bottom view of my new design;

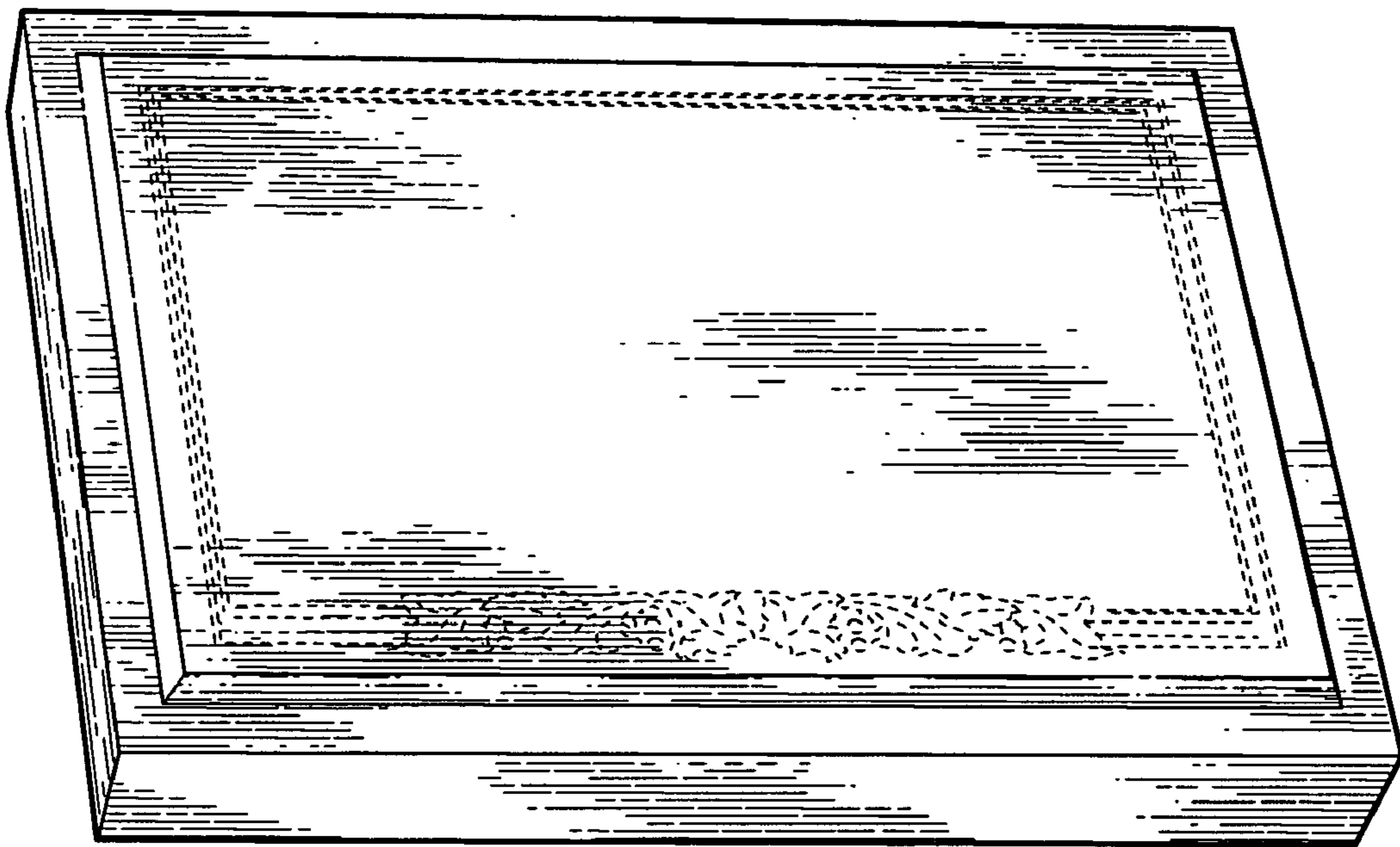

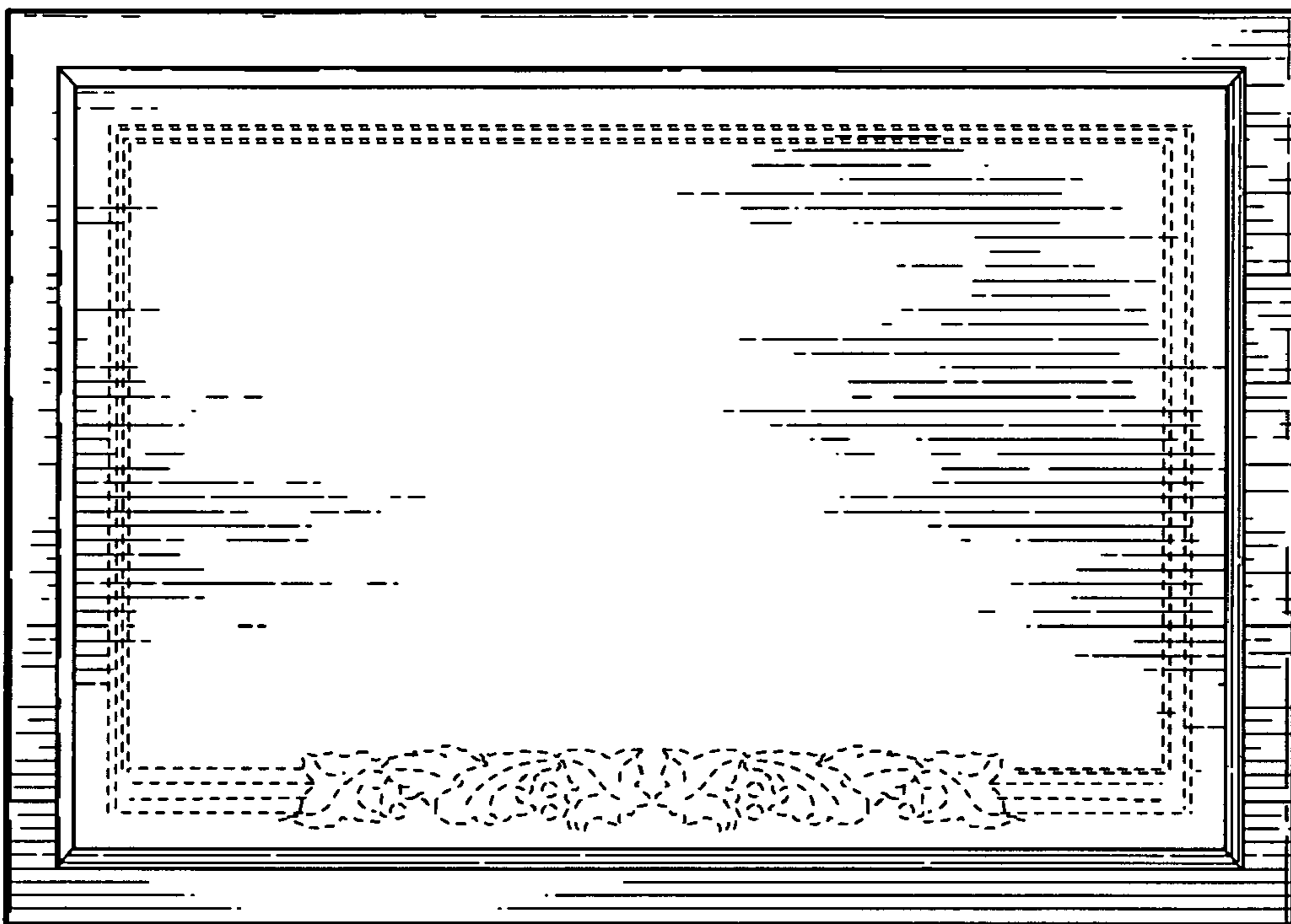

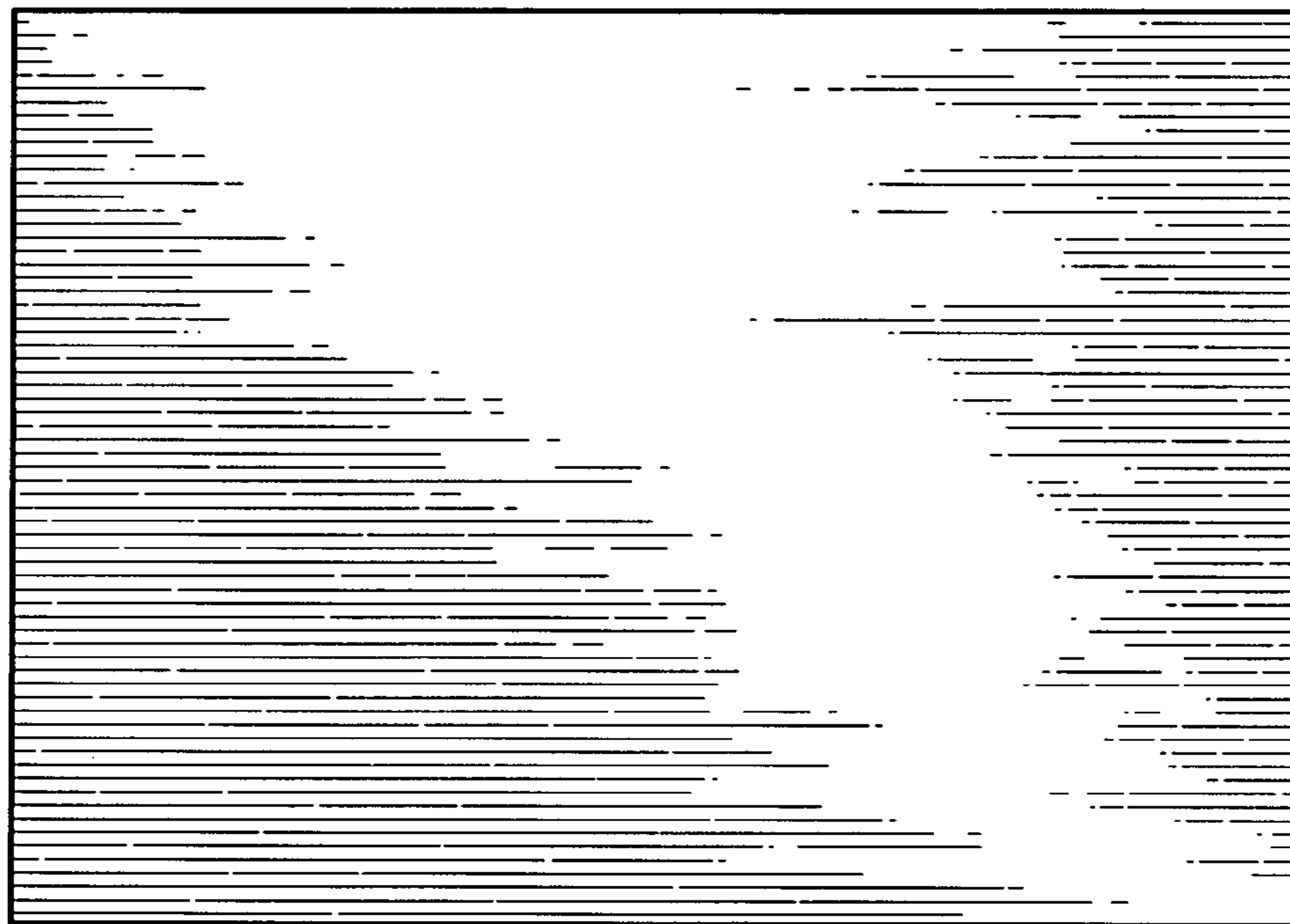

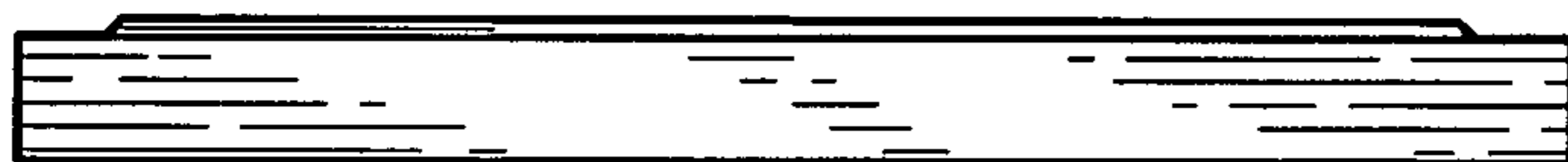

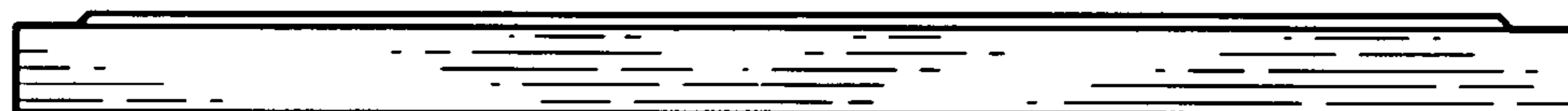
