(57) **CLAIM**

The ornamental design for confection, as shown and described.

DESCRIPTION

FIG. 1: is a front, left perspective view of a confection showing our new design;

FIG. 2: is a top plan view of the design shown in FIG. 1;

FIG. 3: is a bottom plan view of the design shown in FIG. 1;

FIG. 4: is a left end elevational view of the design shown in FIG. 1, wherein the right end is a mirror image thereof; and

FIG. 5: is a front elevational view of the design shown in FIG. 1, wherein the rear elevational view is a mirror image thereof.

FIG. 6: is a front, left perspective view of a confection showing our new design;

FIG. 7: is a top plan view of the design shown in FIG. 6;

FIG. 8: is a bottom plan view of the design shown in FIG. 6;

FIG. 9: is a left end elevational view of the design shown in FIG. 6, wherein the right end is a mirror image thereof; and,

FIG. 10: is a front elevational view of the design shown in FIG. 6, wherein the rear elevational view is a mirror image thereof.

The broken line showing the indicia in FIGS. 6-10 are for the purpose of illustrating unclaimed portions and form no part of the claimed design.

The indicia of the letter 'D' shown in FIGS. 1-5, forming part of the claimed design herein, is a registered trademark of Mars, Incorporated.

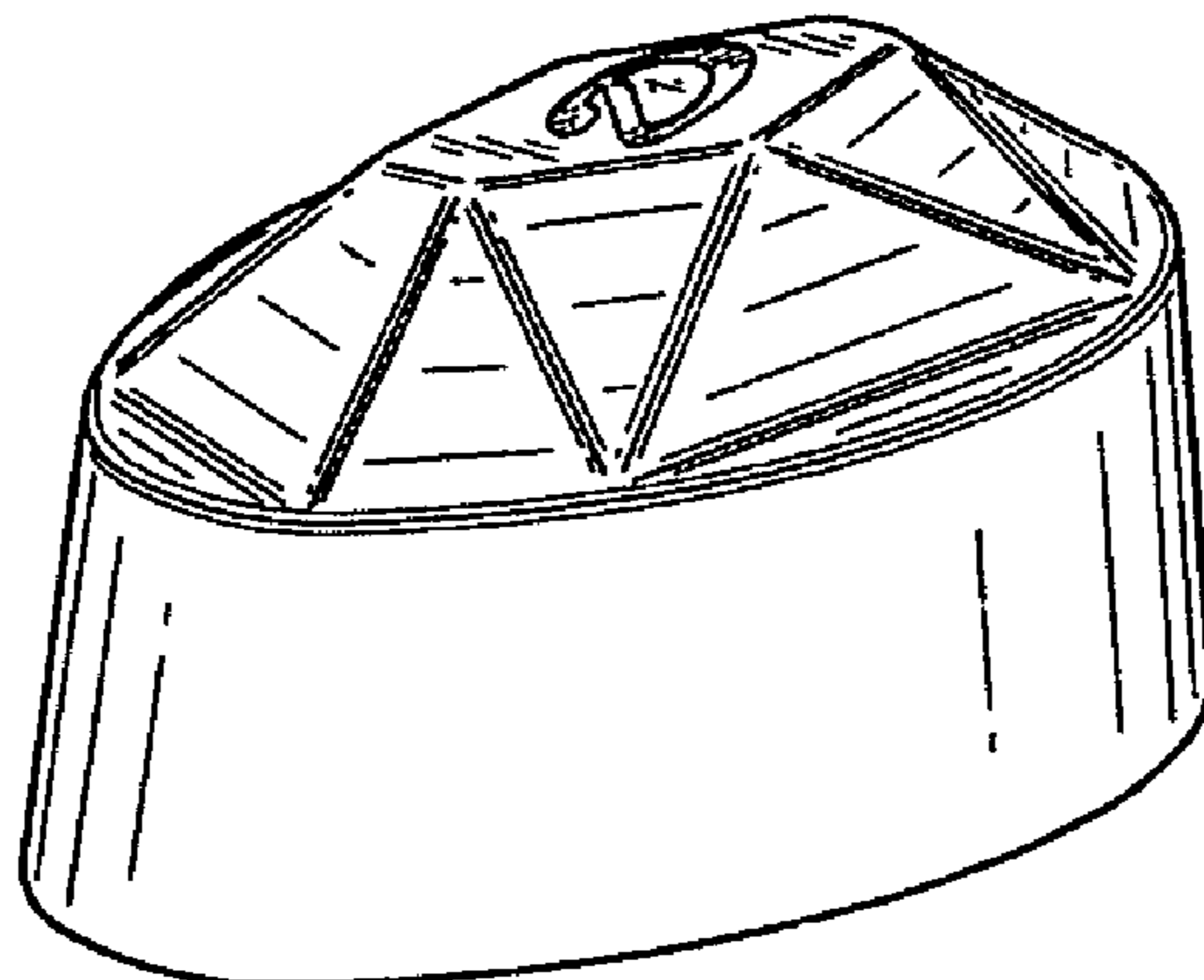

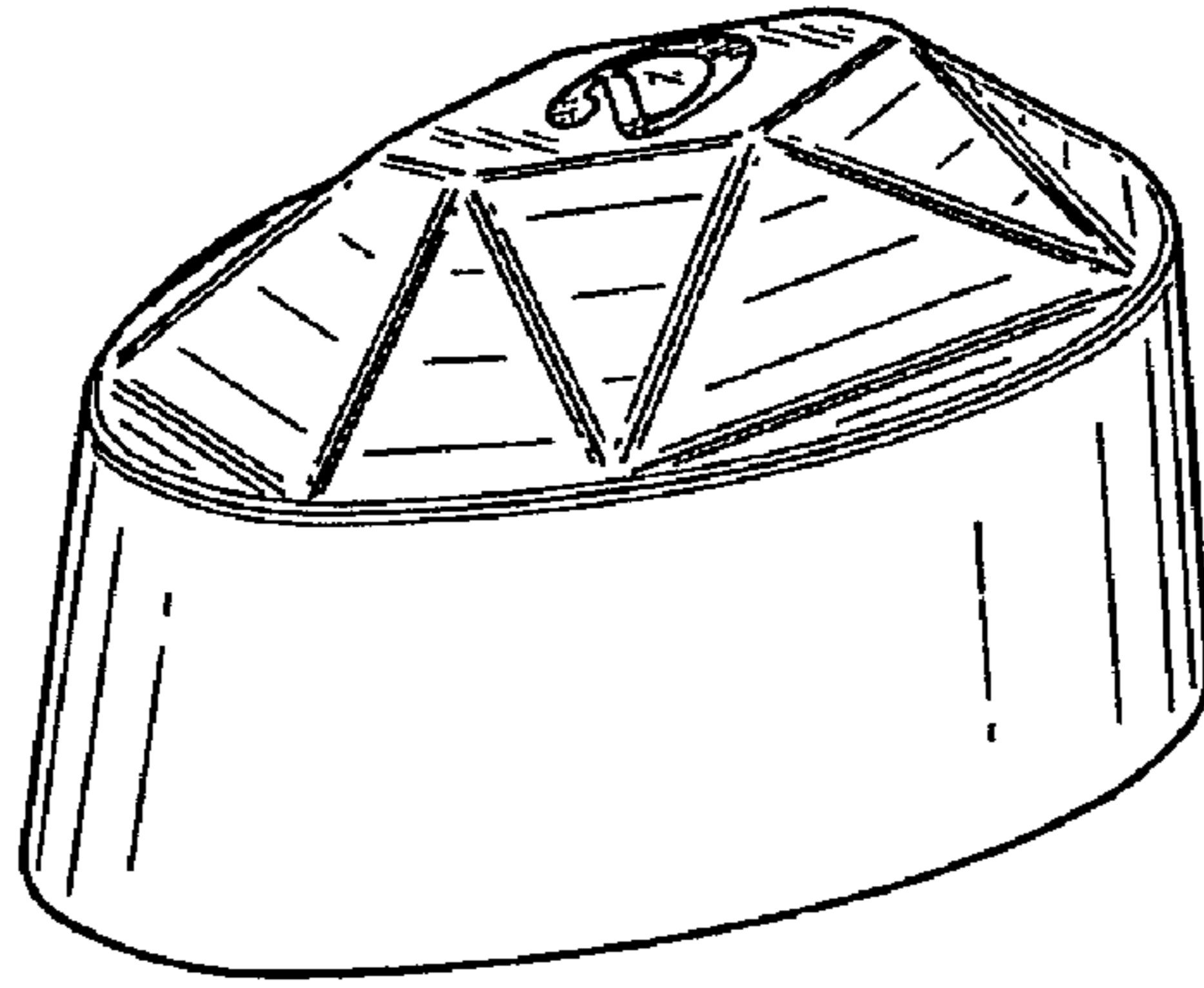

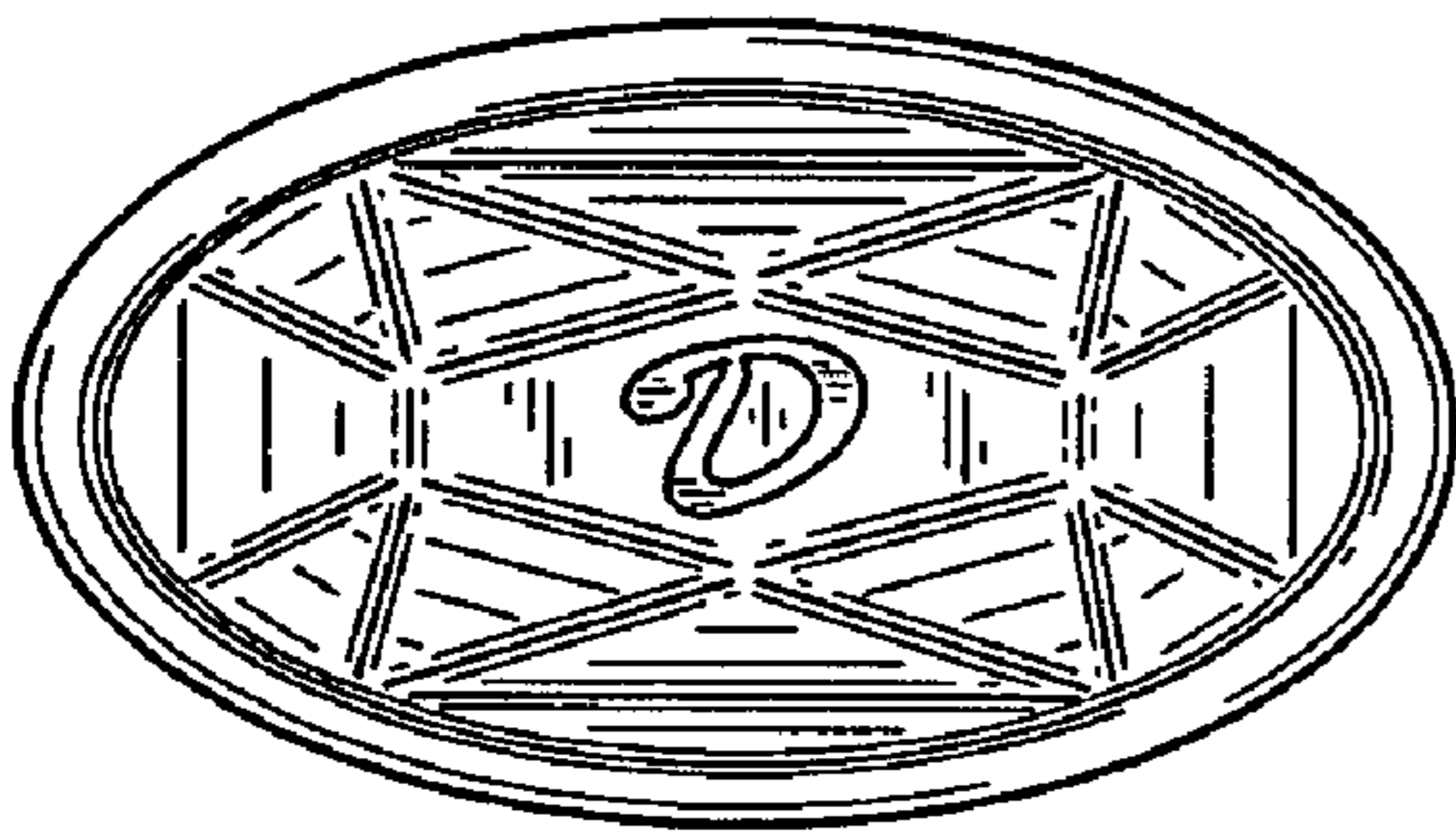

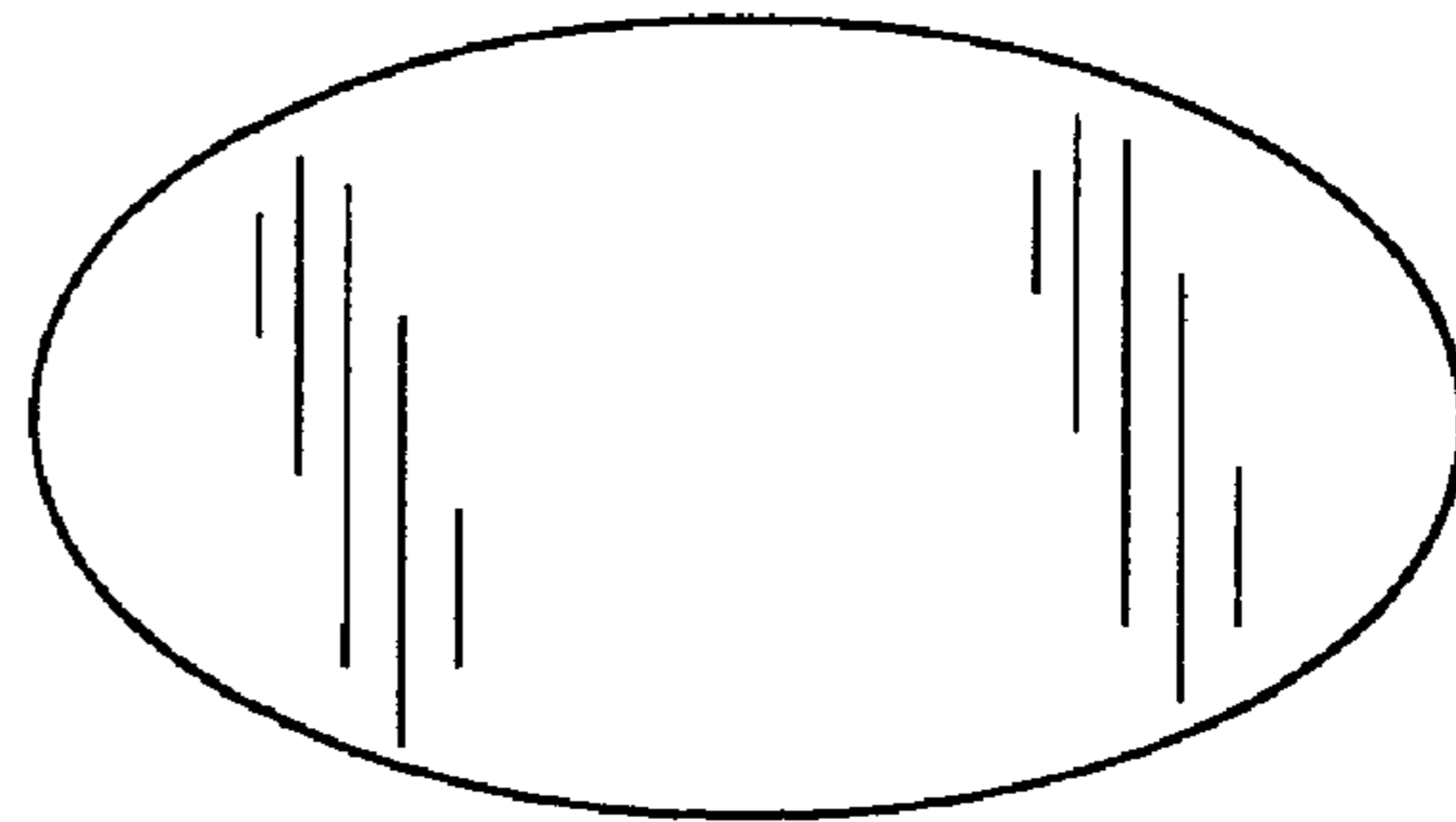

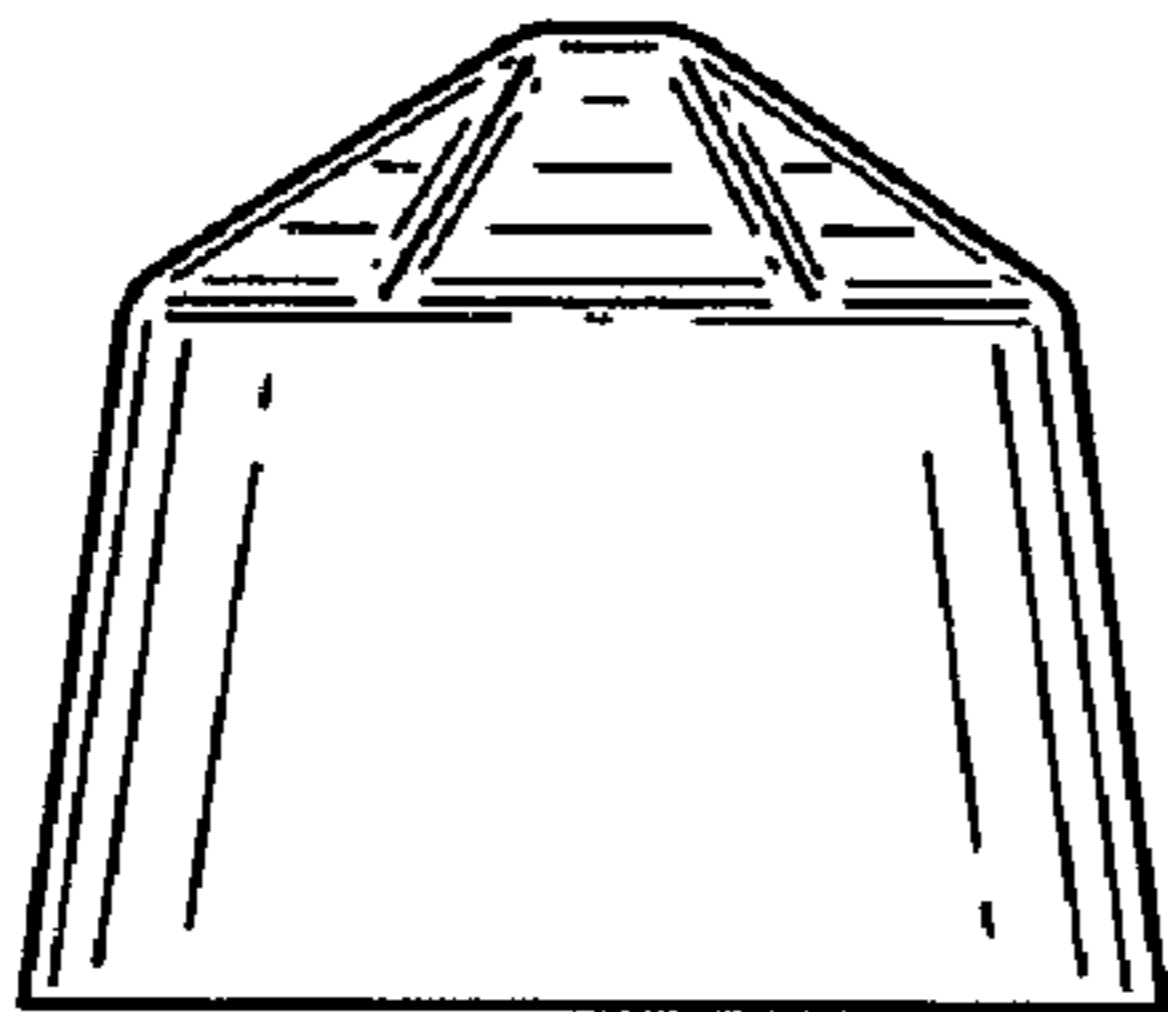

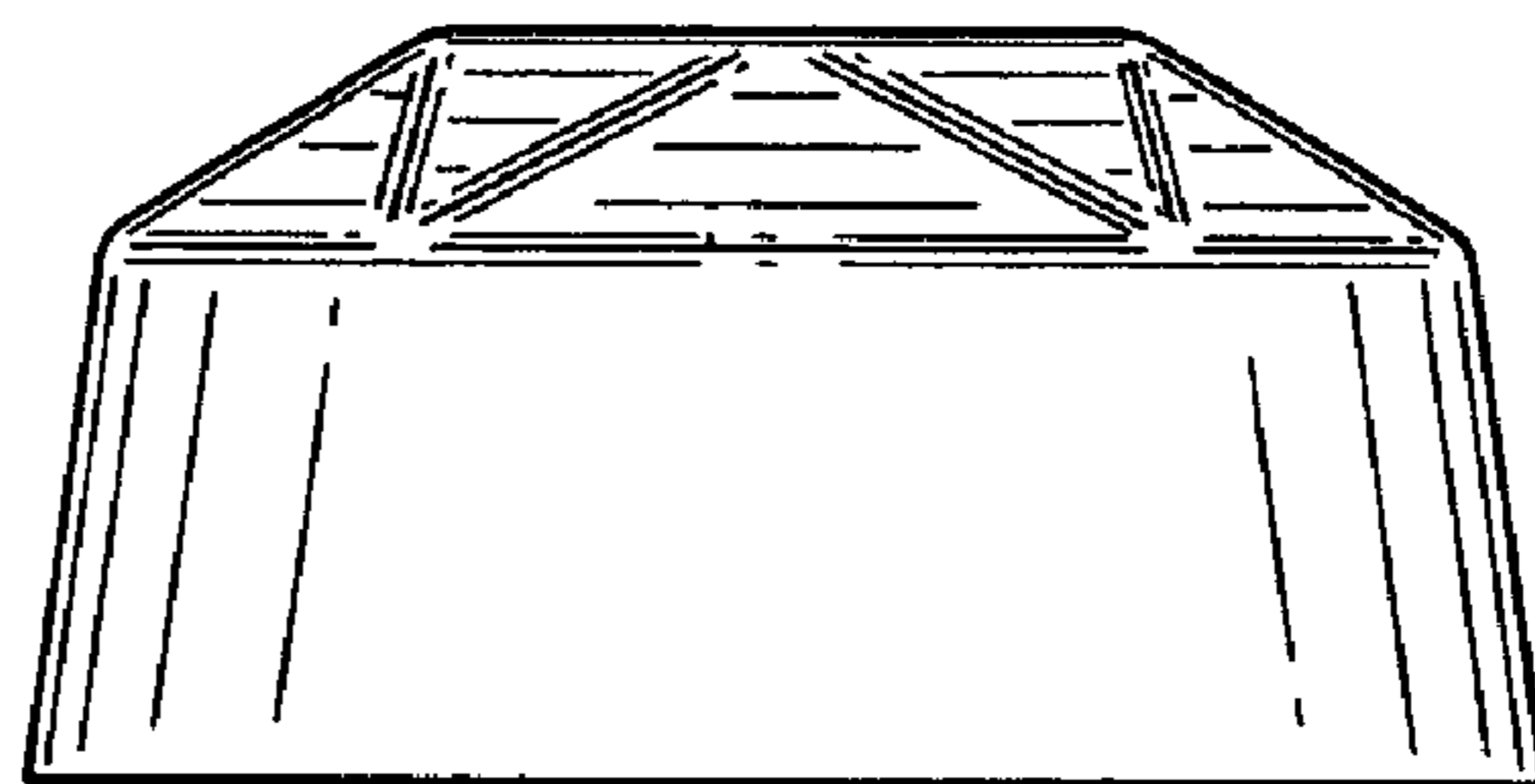

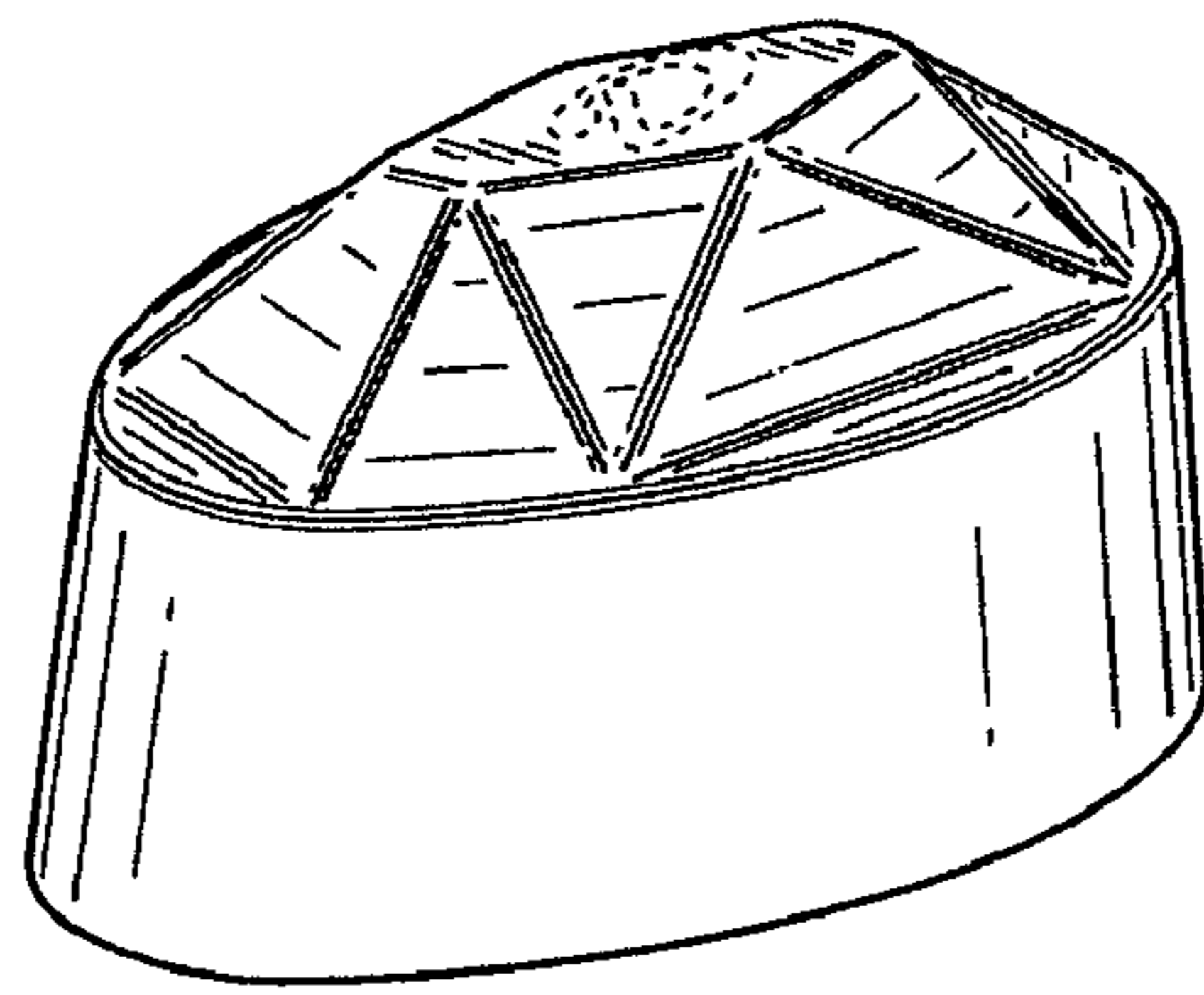

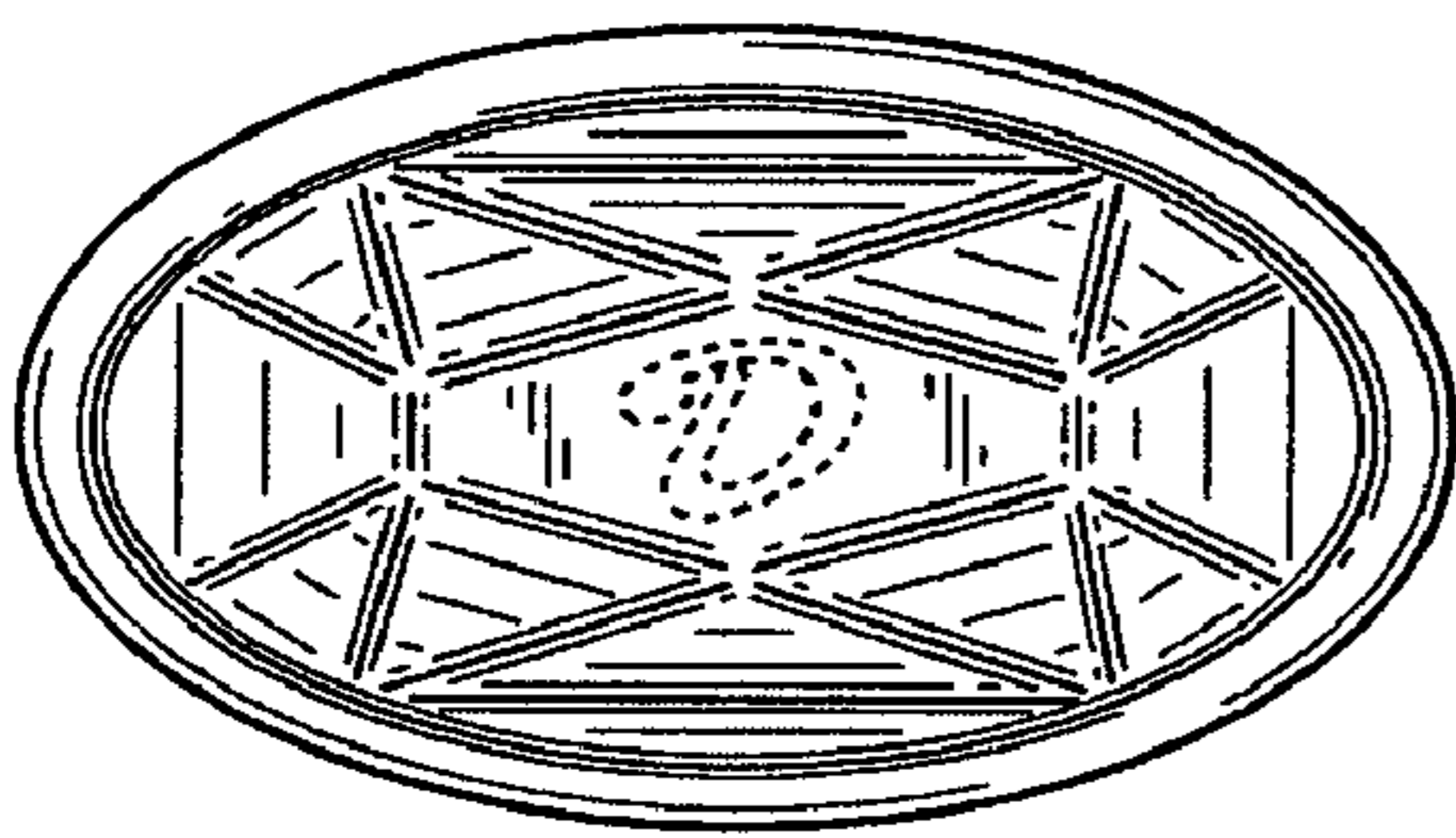

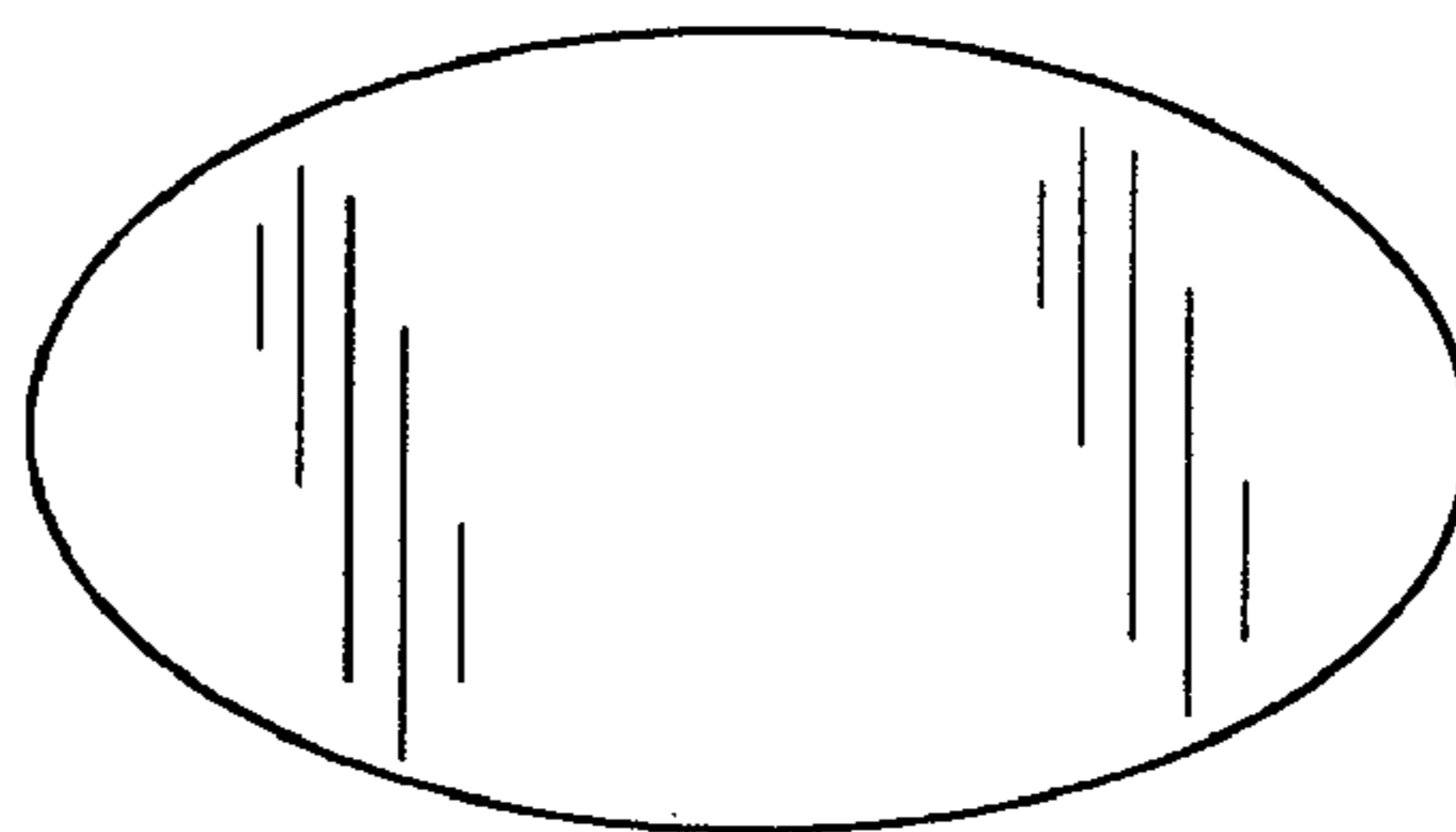

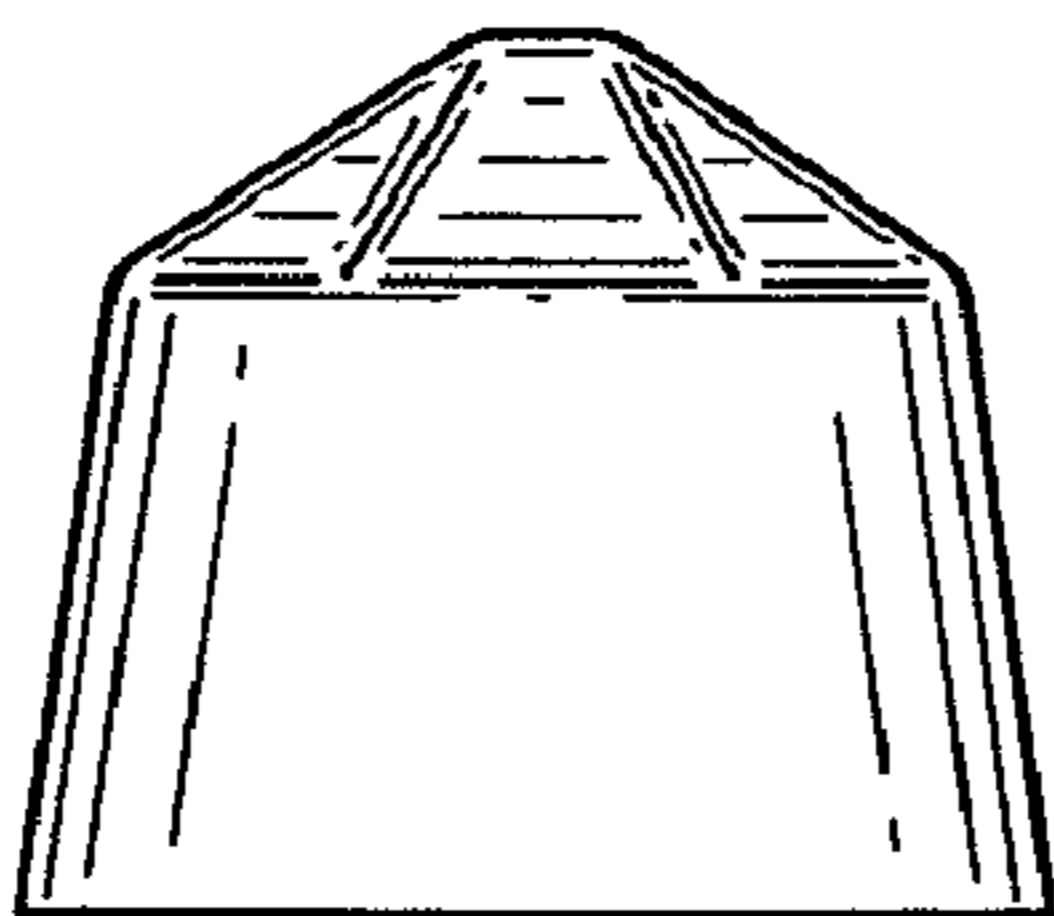
