(57) **CLAIM**

The ornamental design for a candy bar, as shown and described.

DESCRIPTION

FIG. 1: is a perspective view of the candy bar showing our new design;

FIG. 2: is a top view of the design shown in FIG. 1;

FIG. 4: is a left side view of the design shown in FIG. 1;

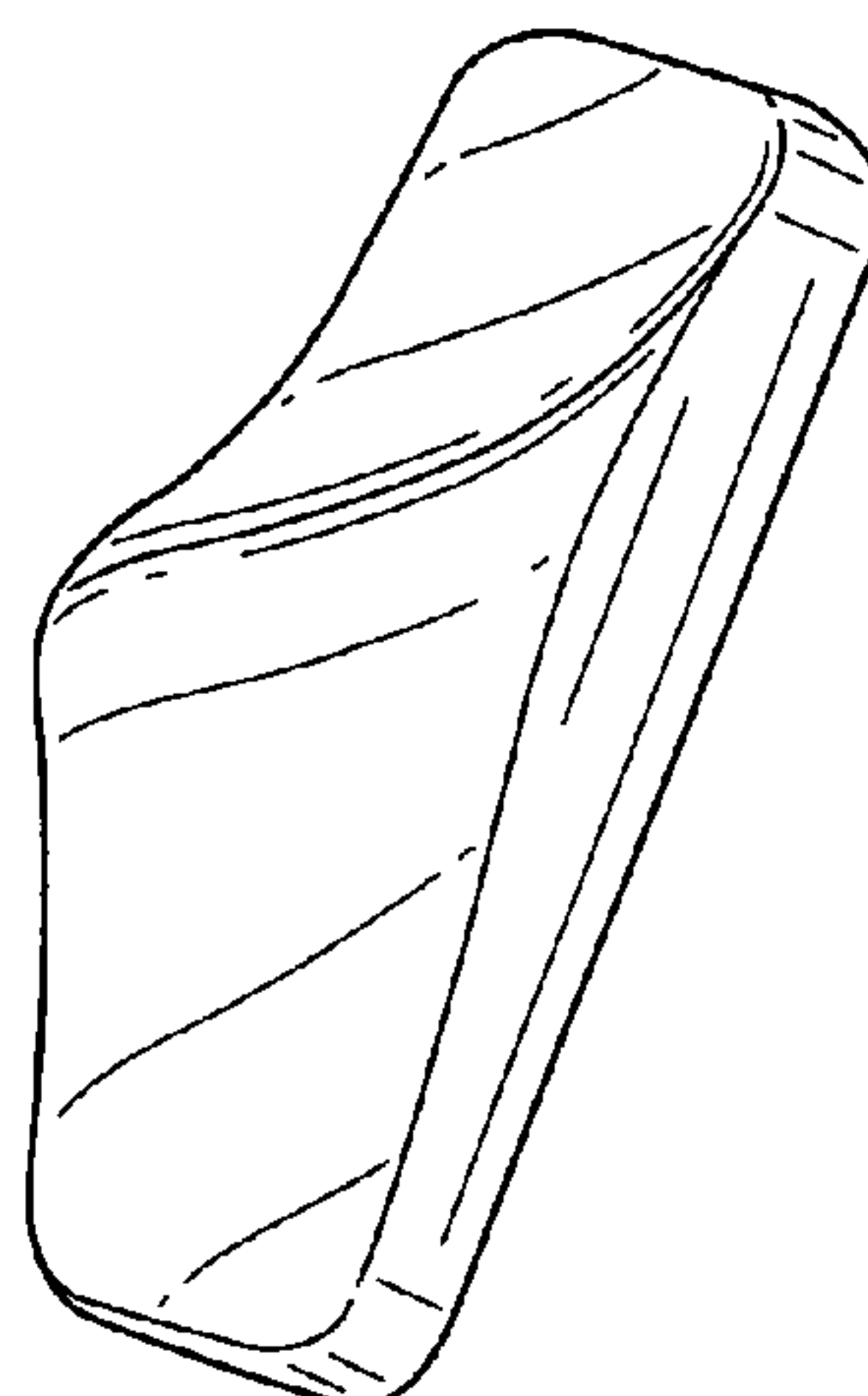
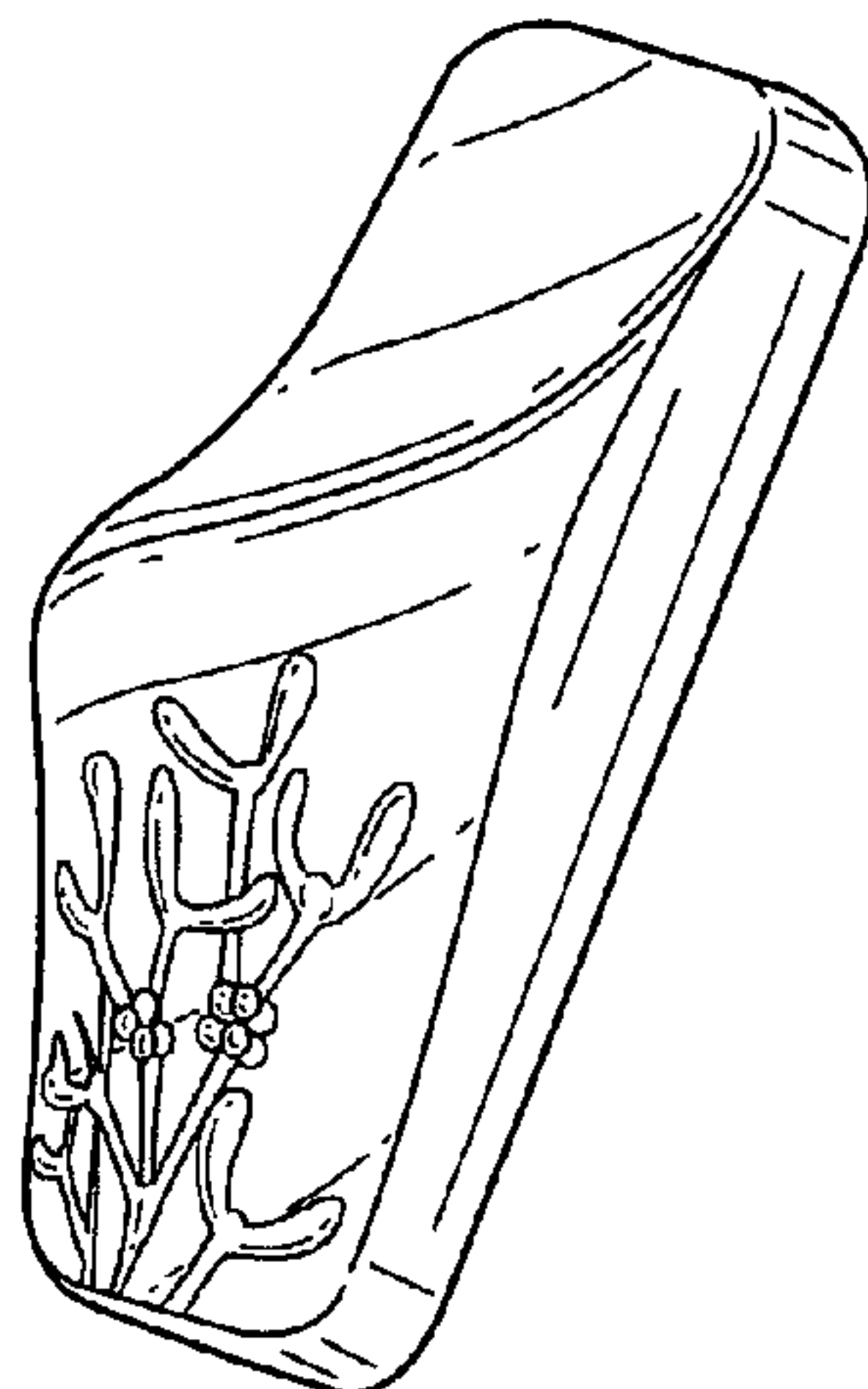

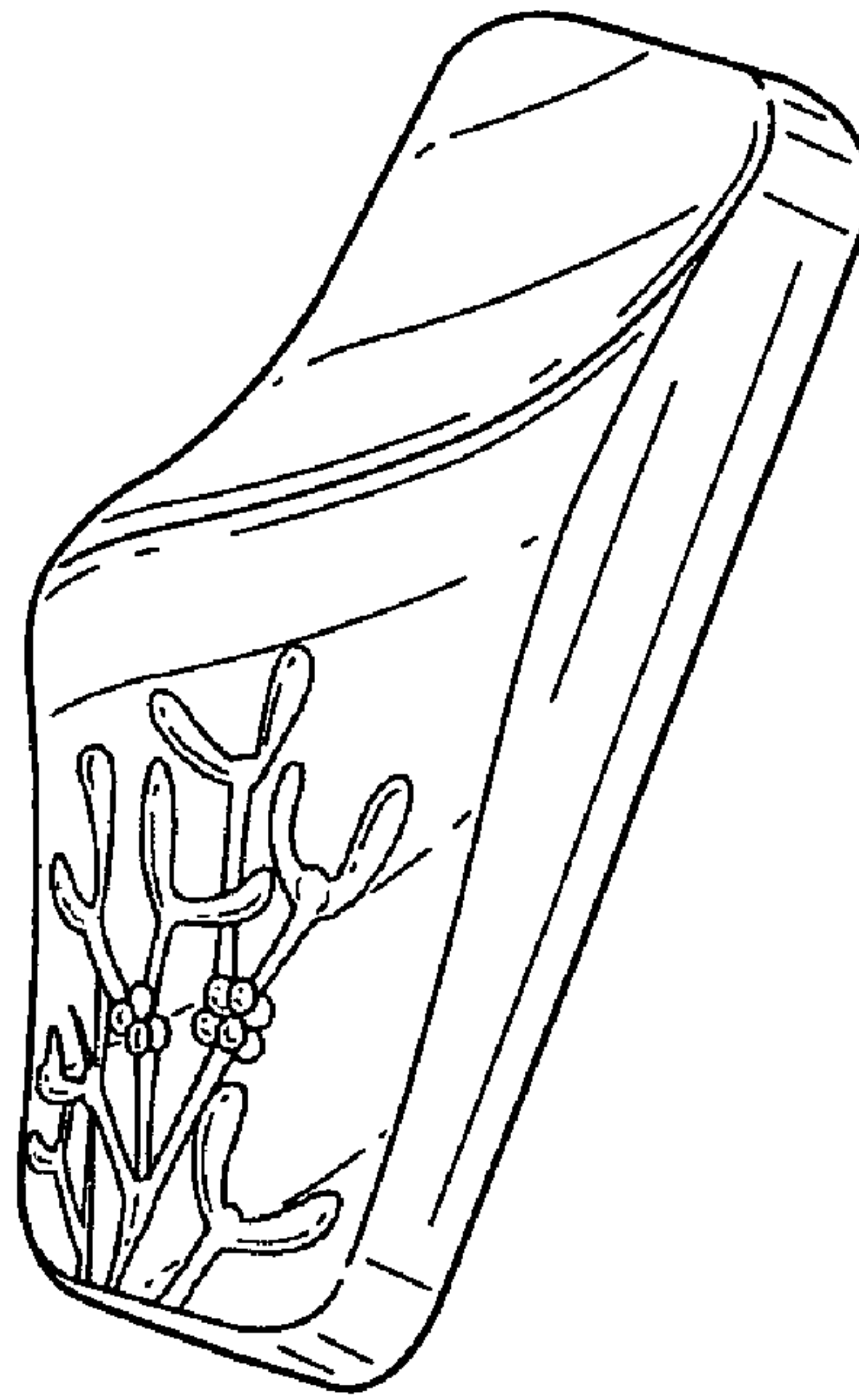

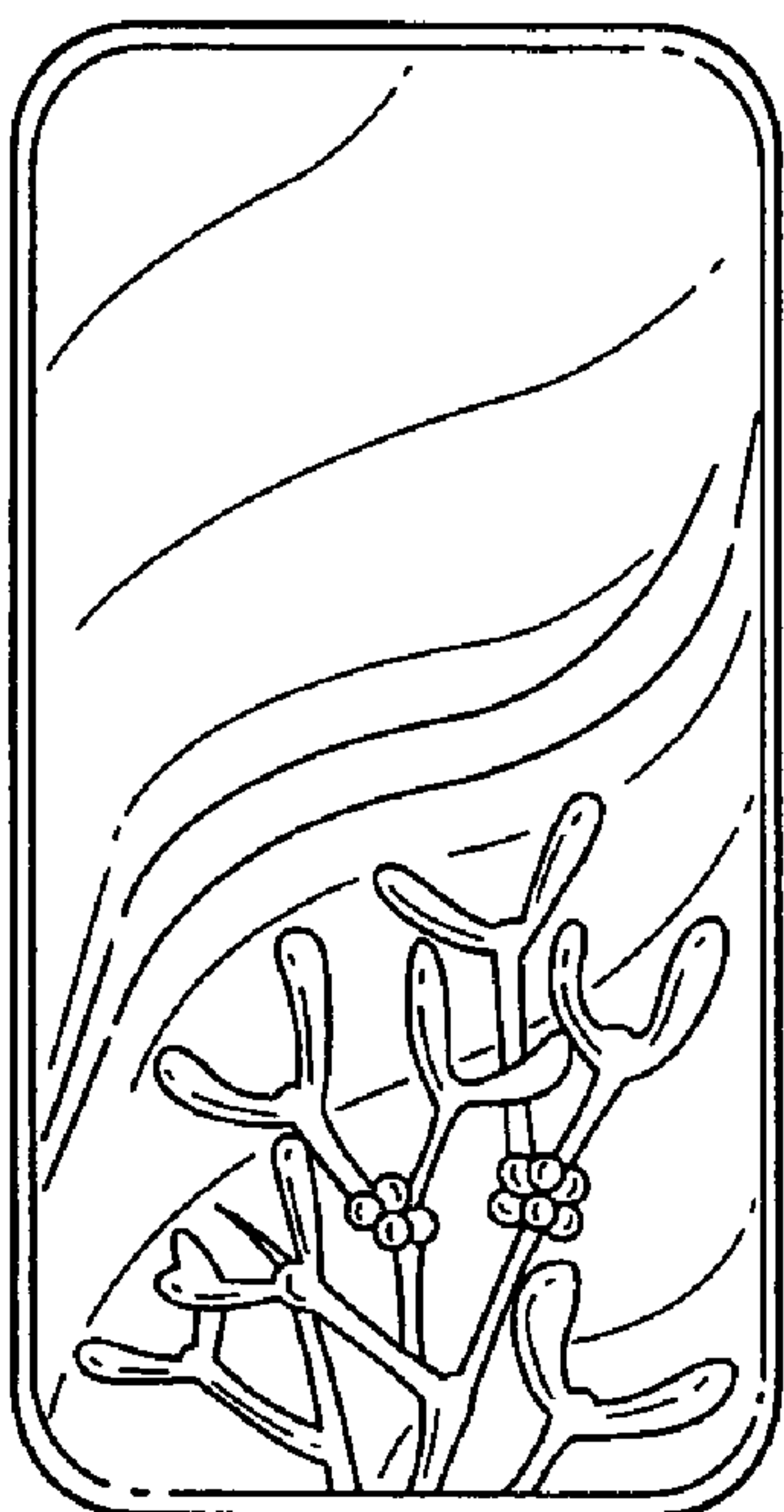

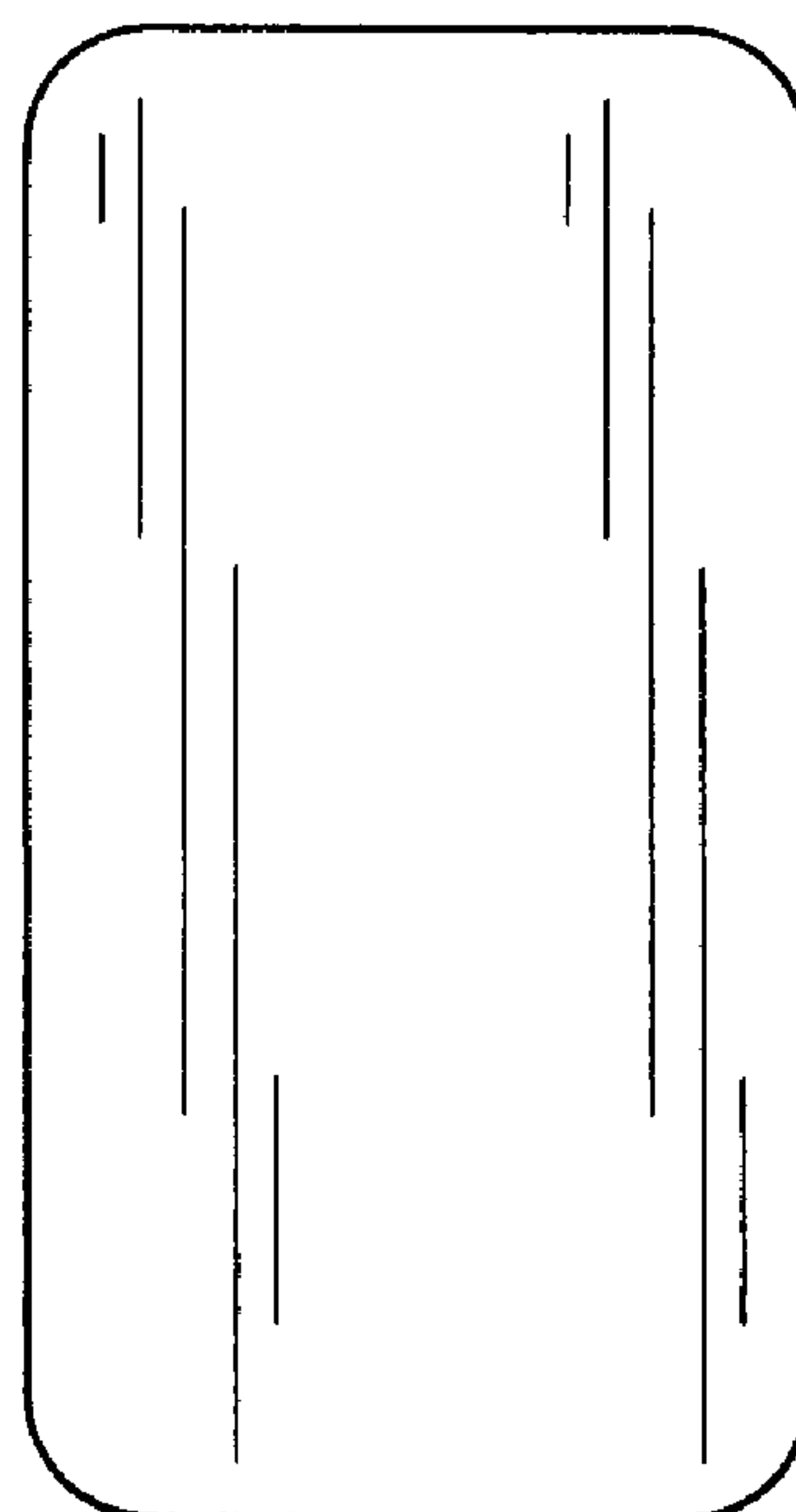

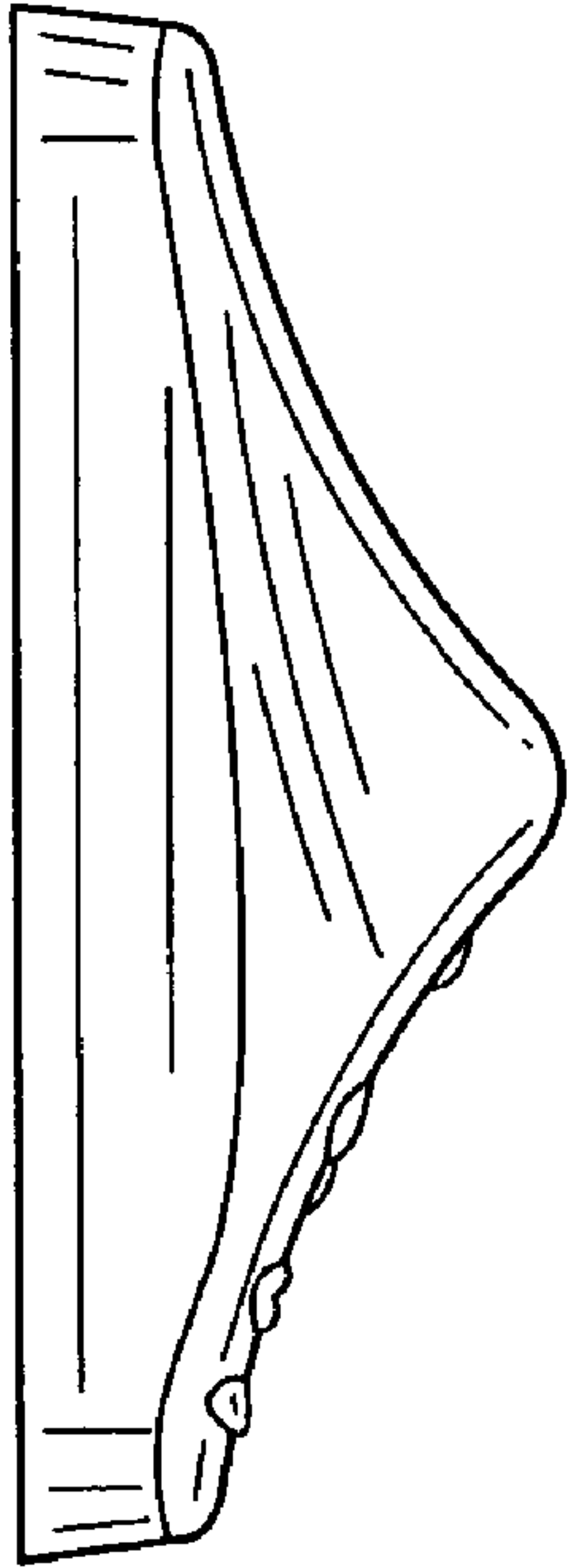

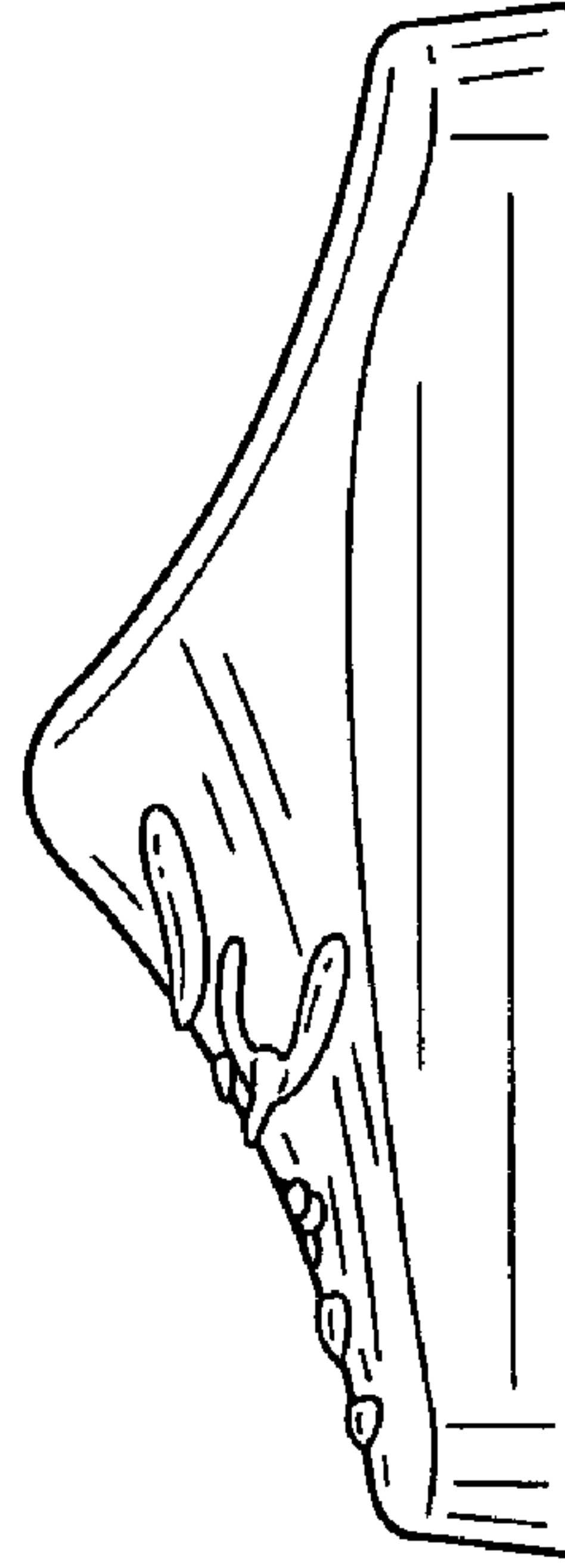

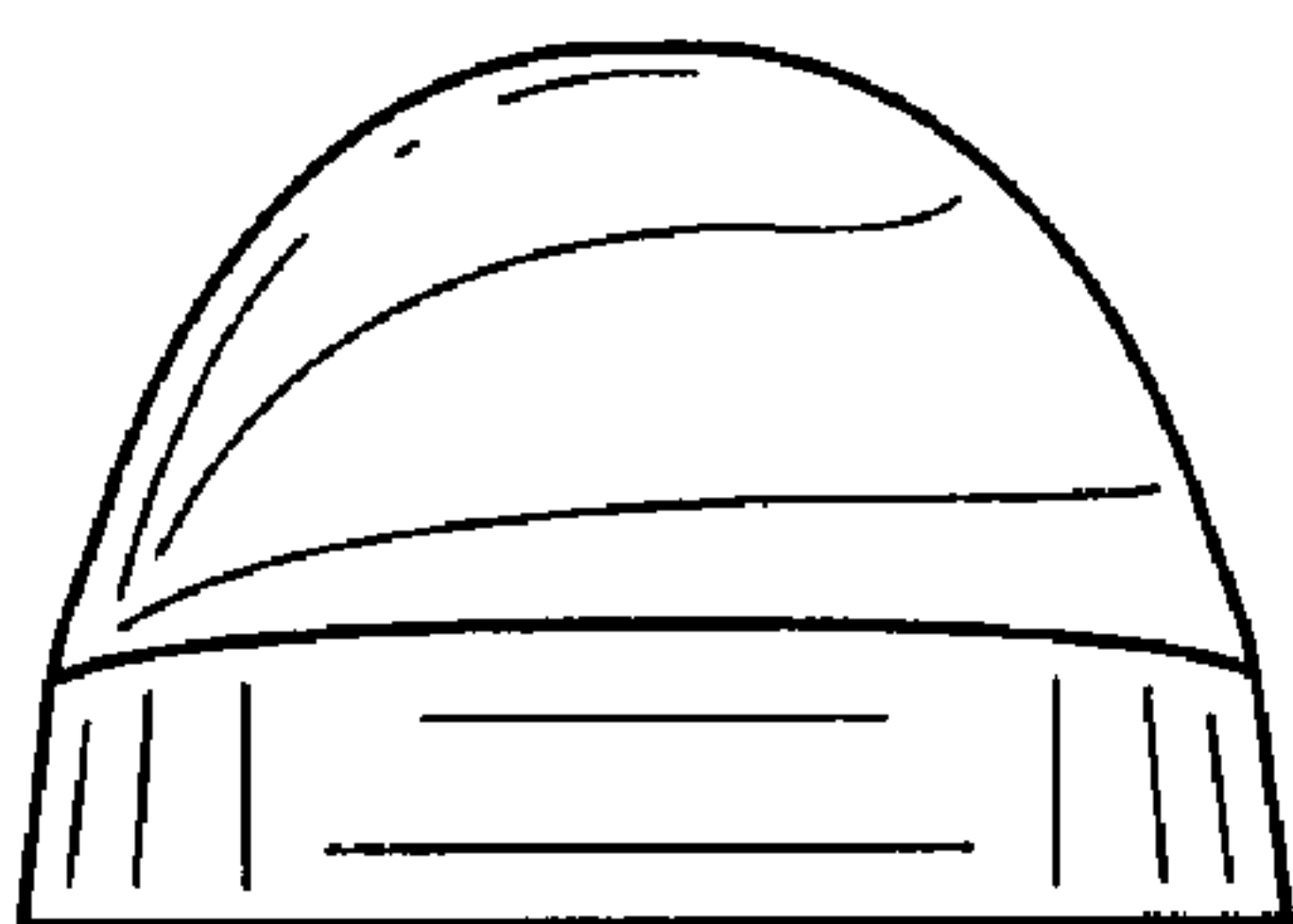

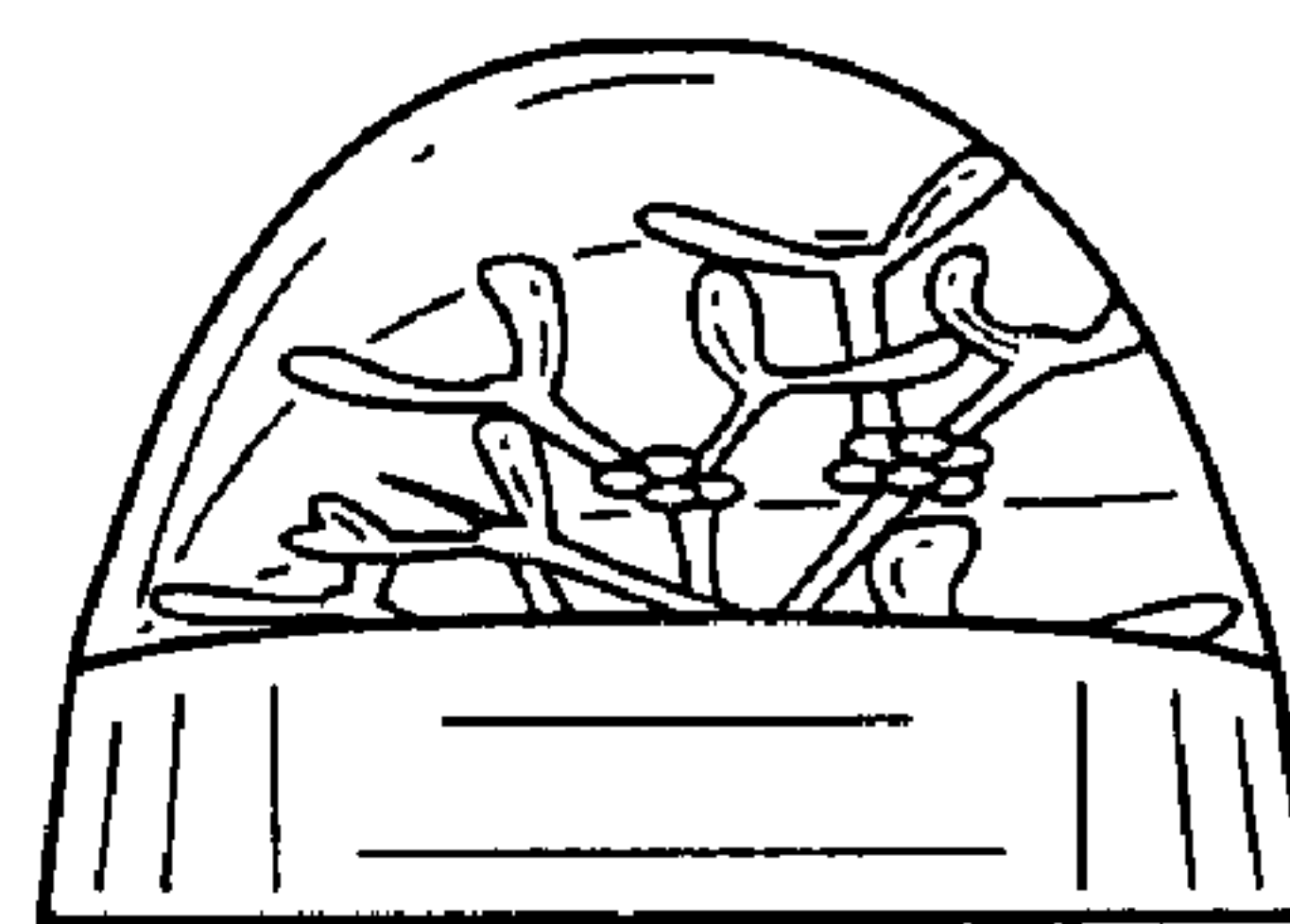

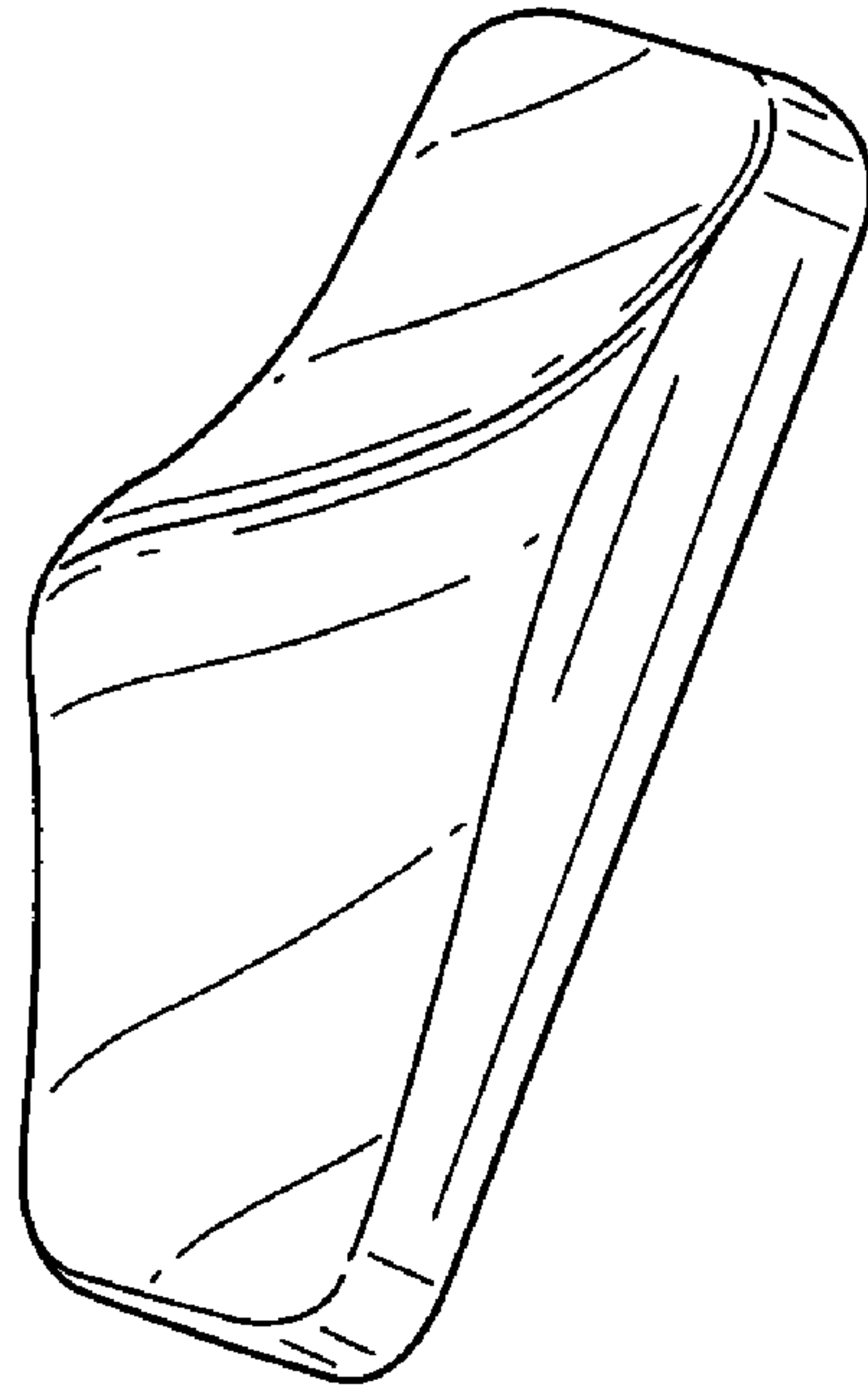

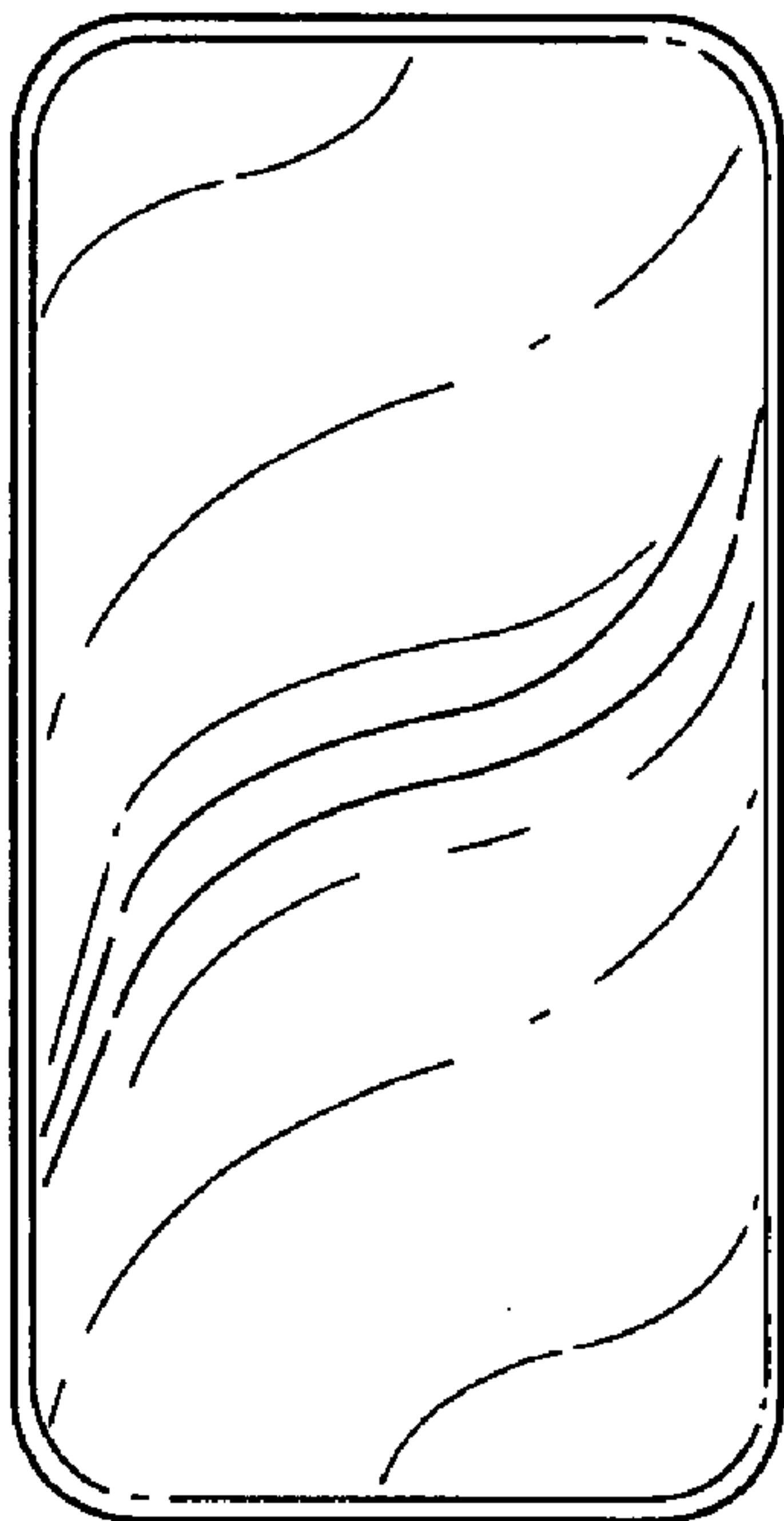

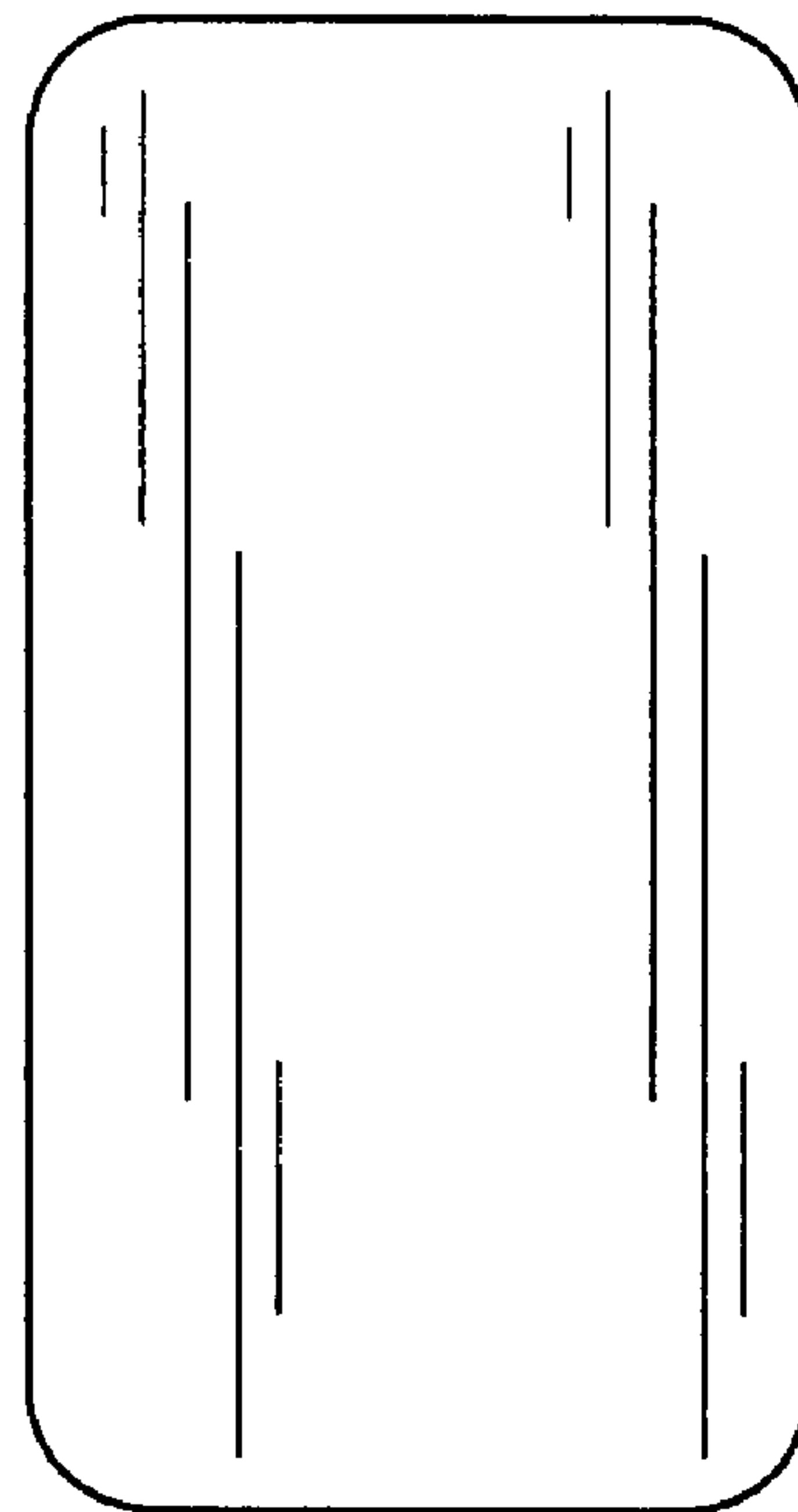

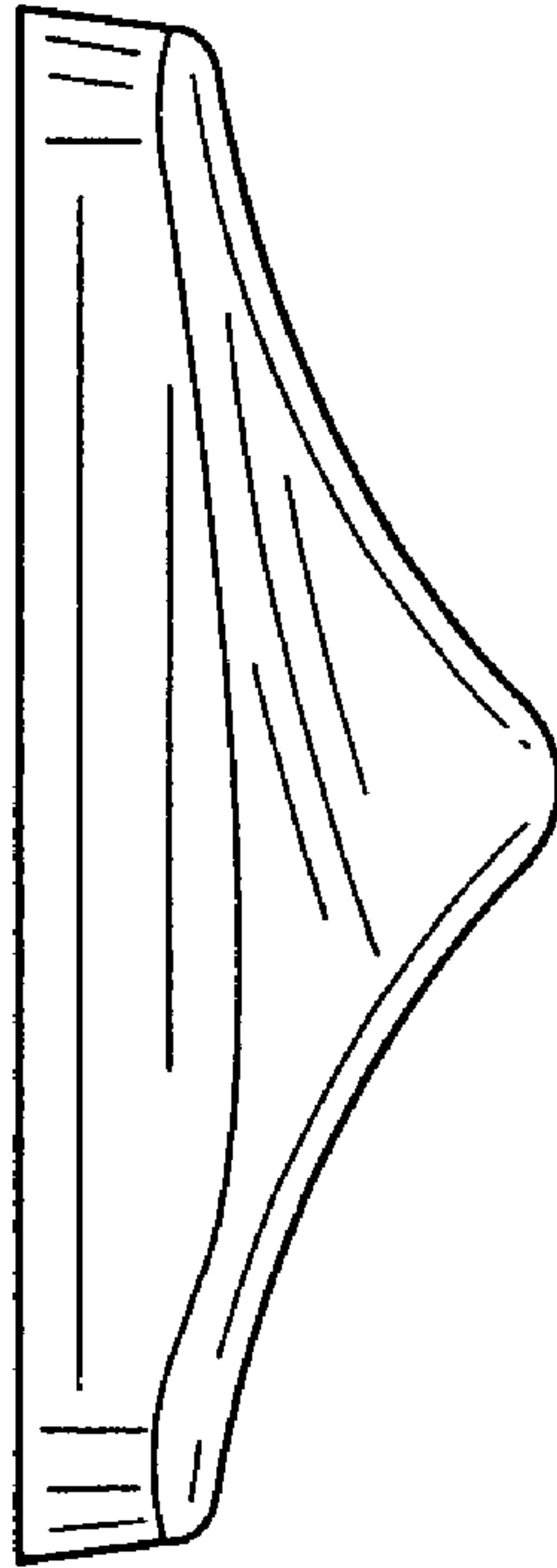
