(57) **CLAIM**

The ornamental design for a cap with front visor and rear visor, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of the left side of the cap with front visor and rear visor;

FIG. 2 is a side view of the right side of the cap with front visor and rear visor;

FIG. 3 is a front view of the cap with front visor and rear visor;

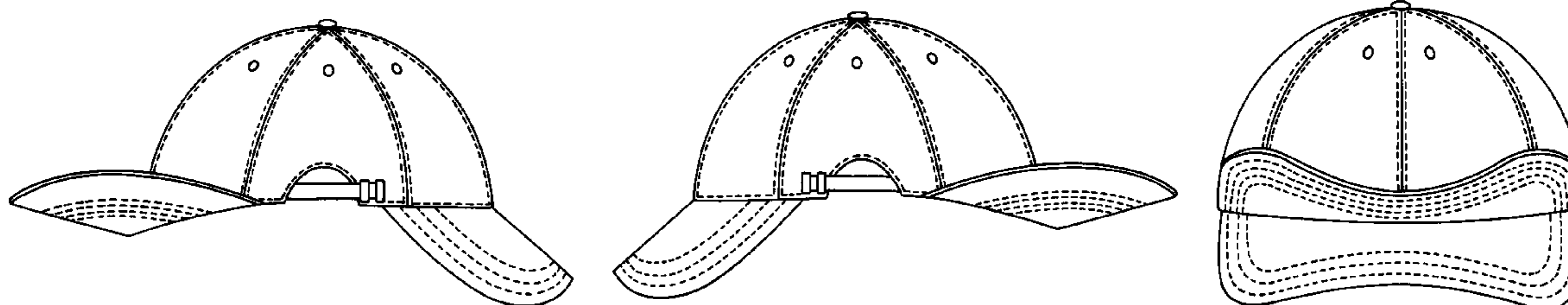
FIG. 4 is a rear view of the cap with front visor and rear visor;

FIG. 5 is a top view of the cap with front visor and rear visor; and,

FIG. 6 is a bottom view of the cap with front visor and rear visor.

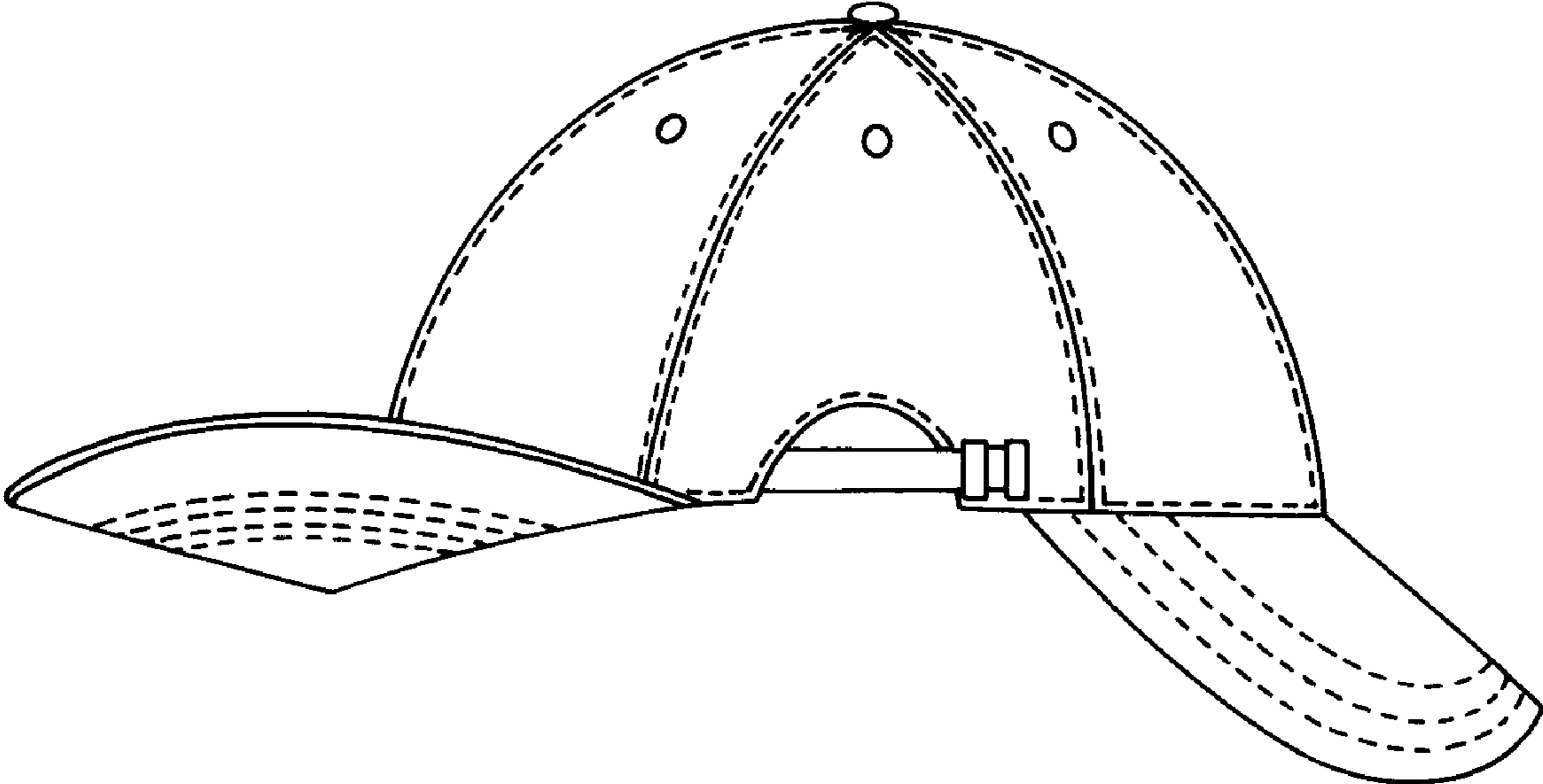

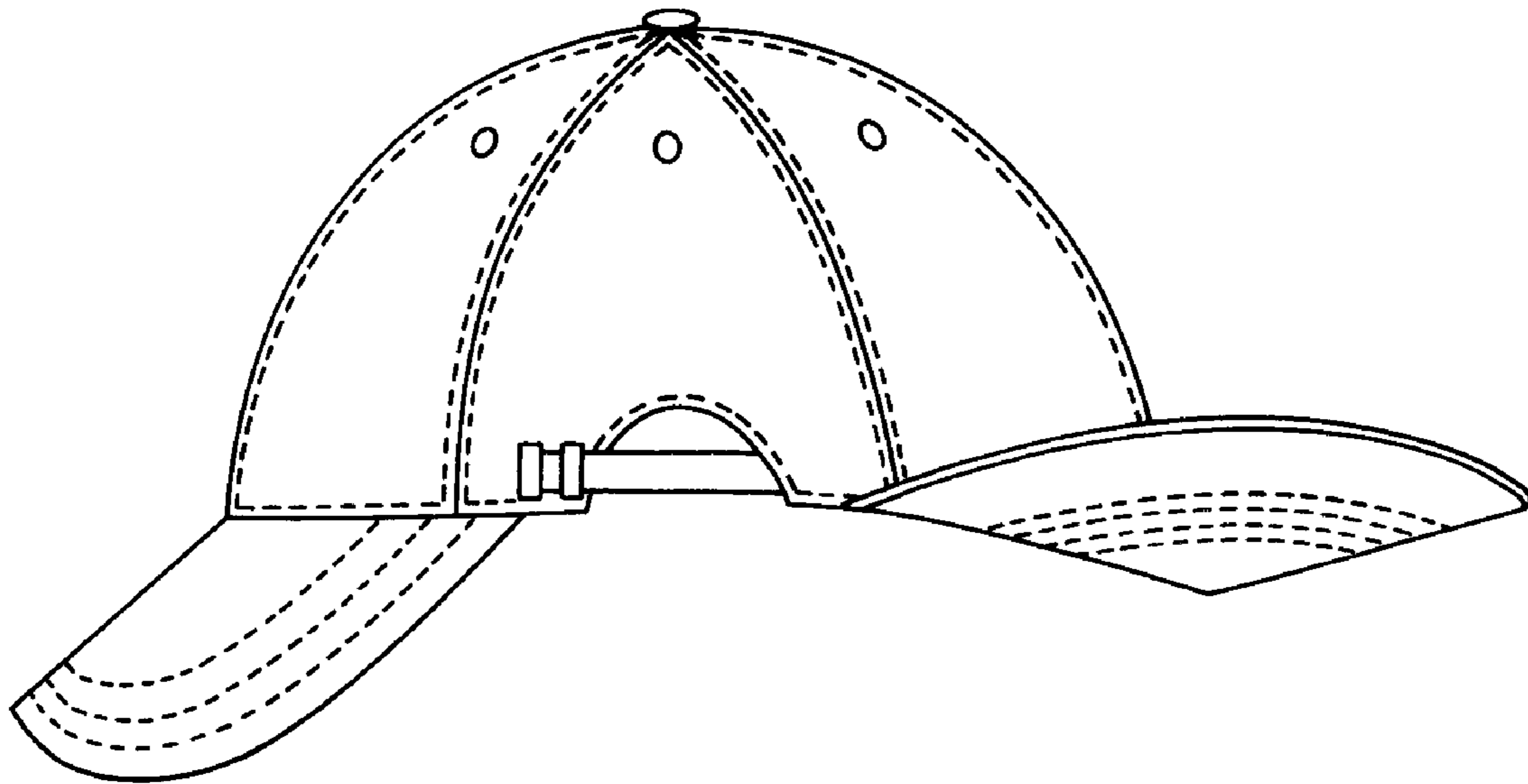

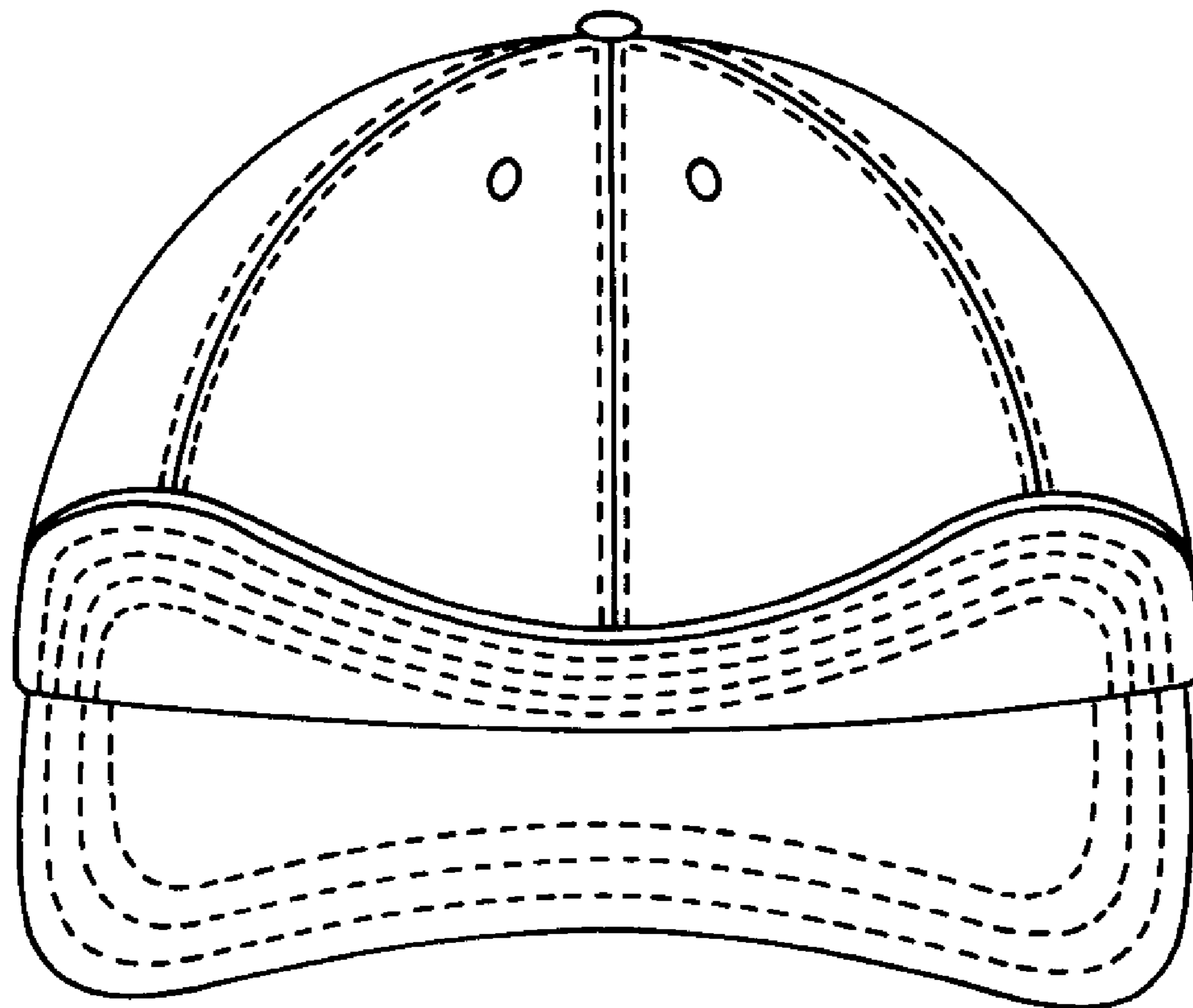

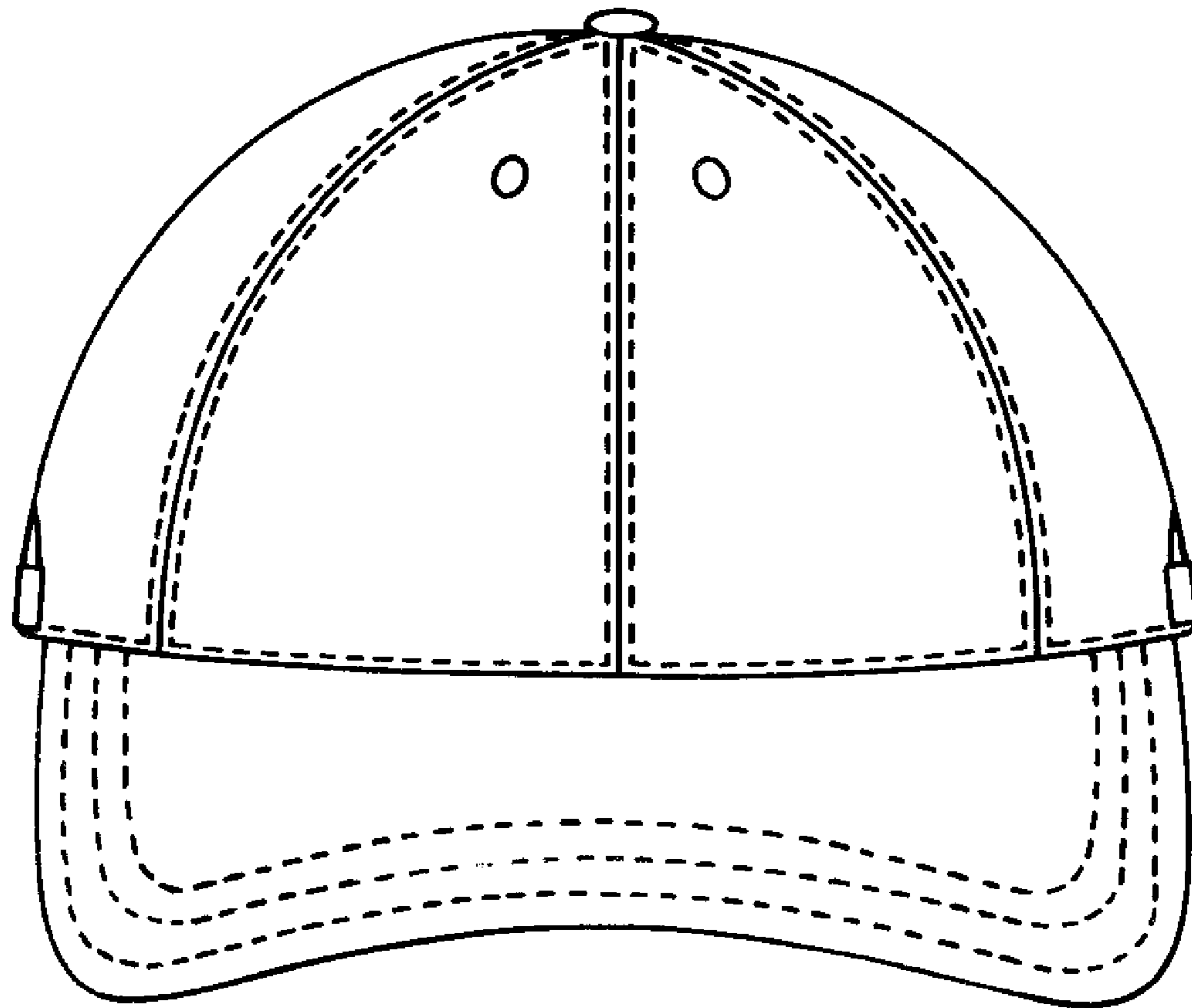

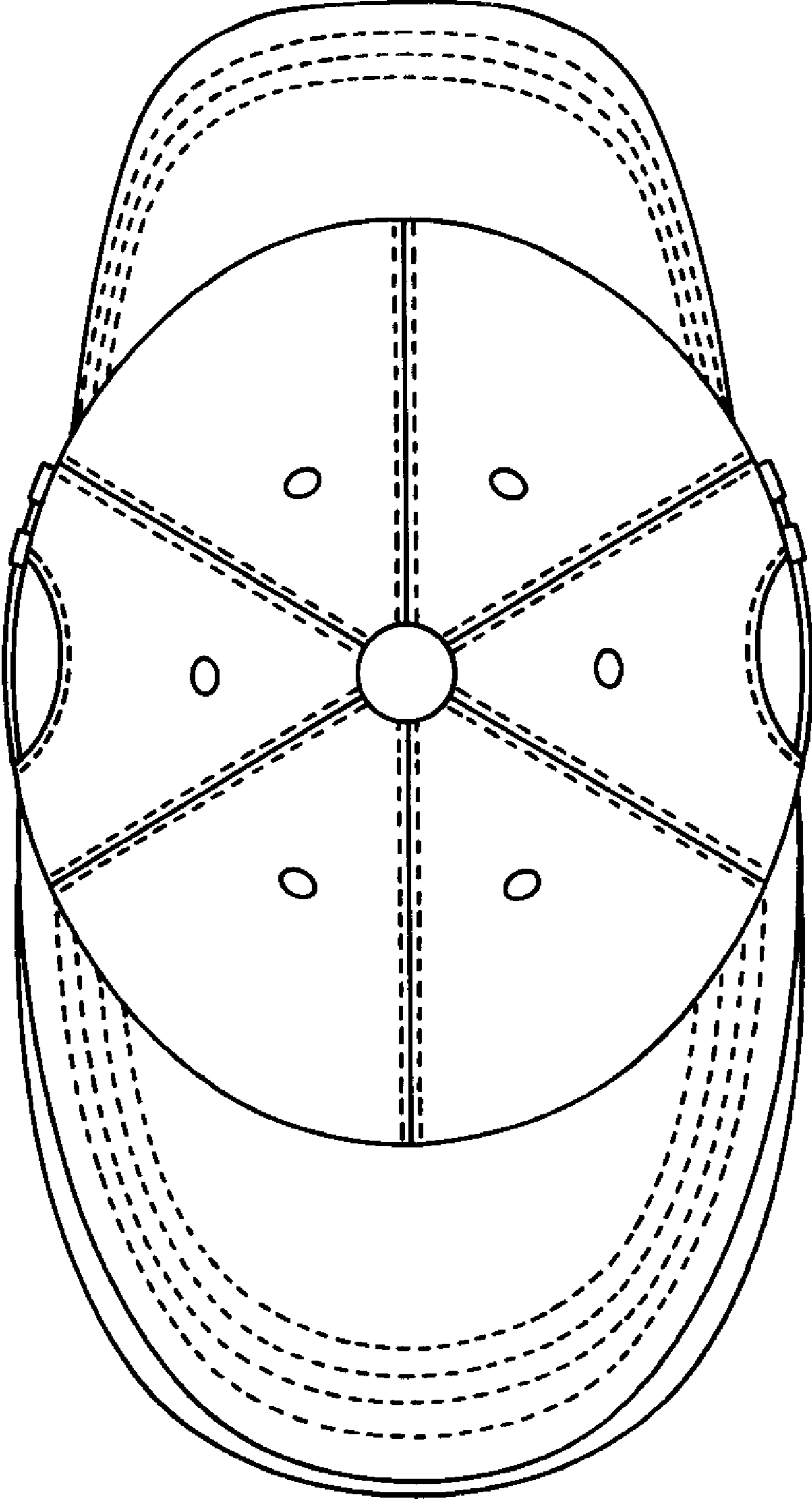

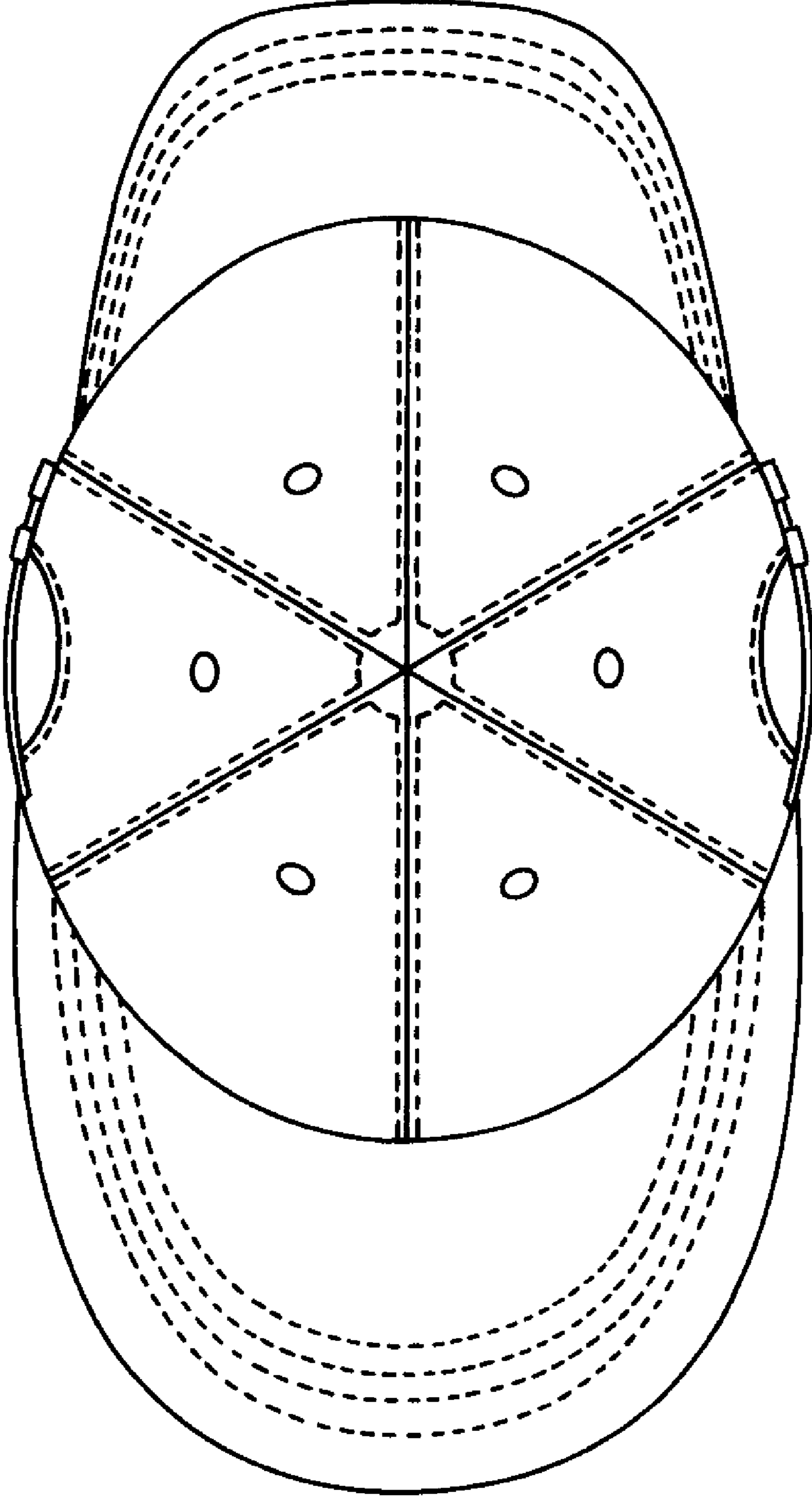
