DESCRIPTION

8;

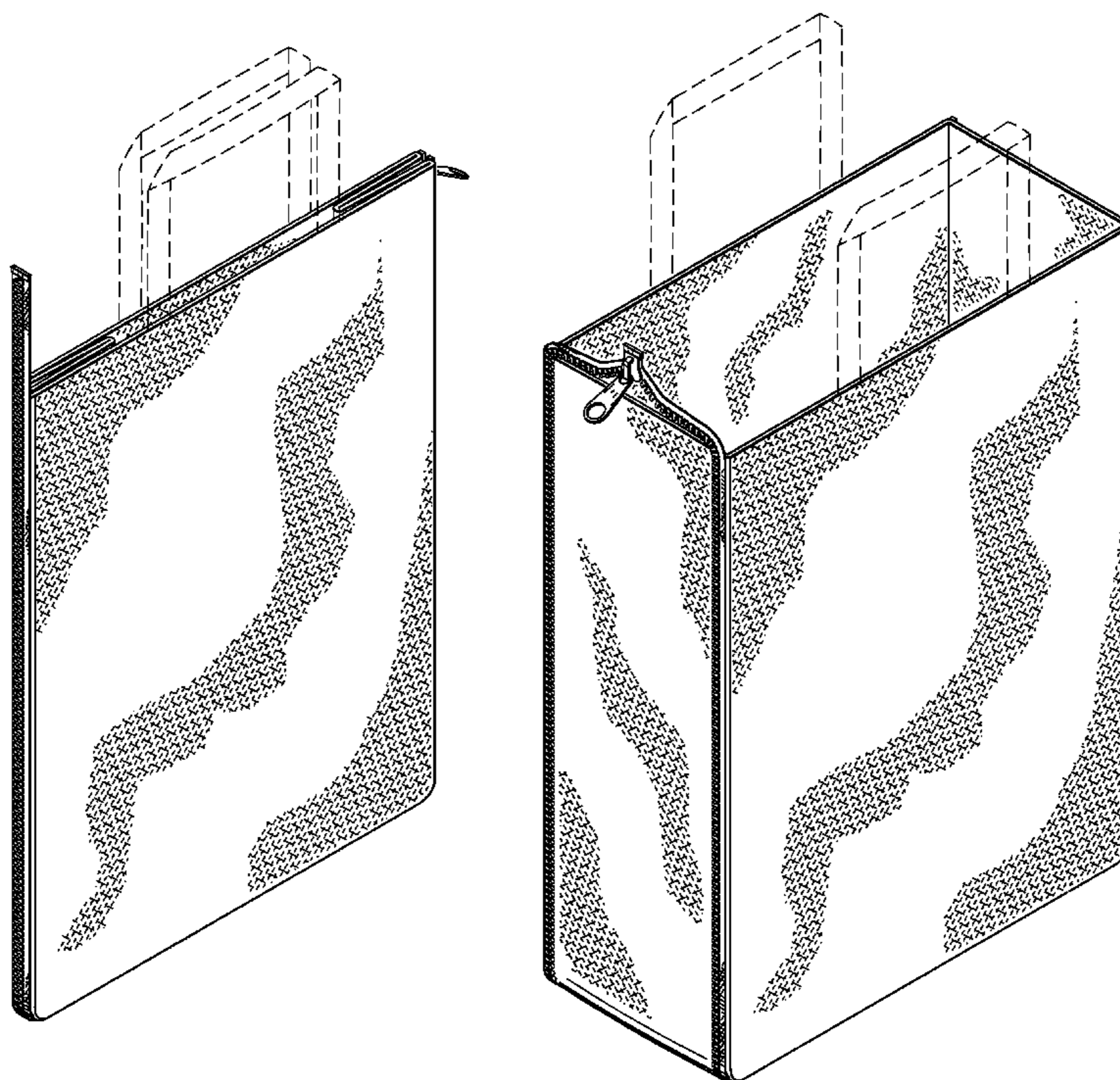
FIG. 12 is an elevational left side view of the handbag of FIG.

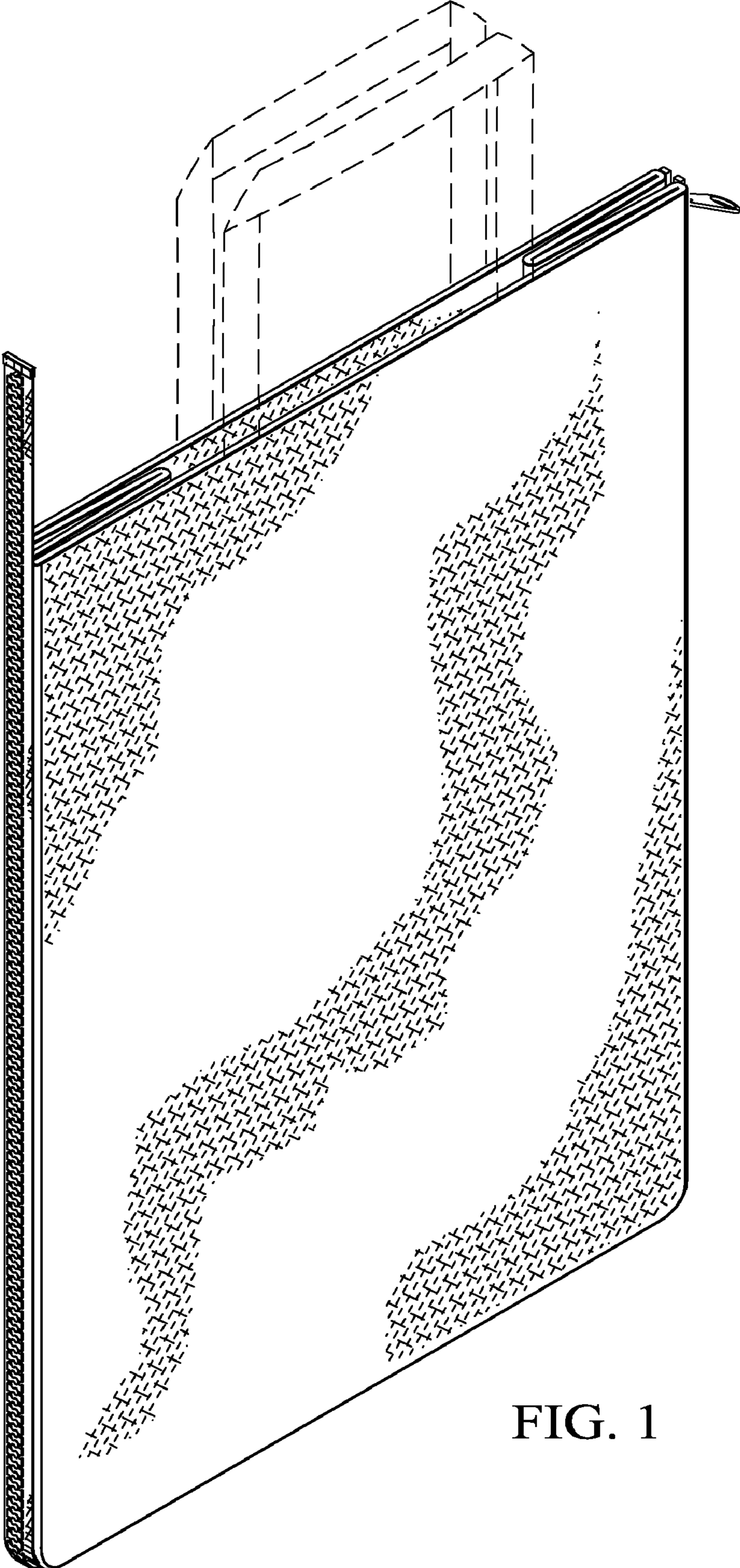

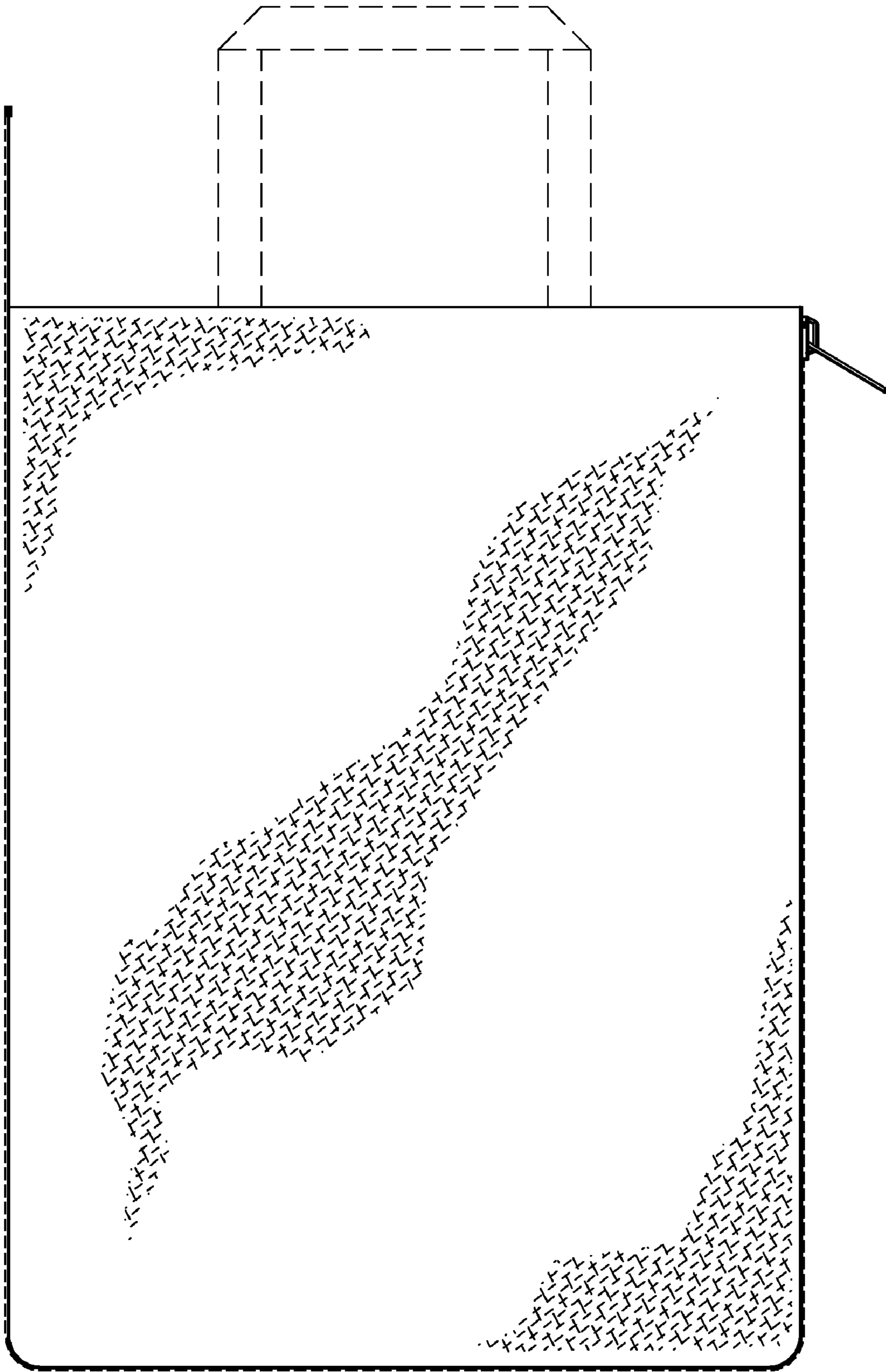

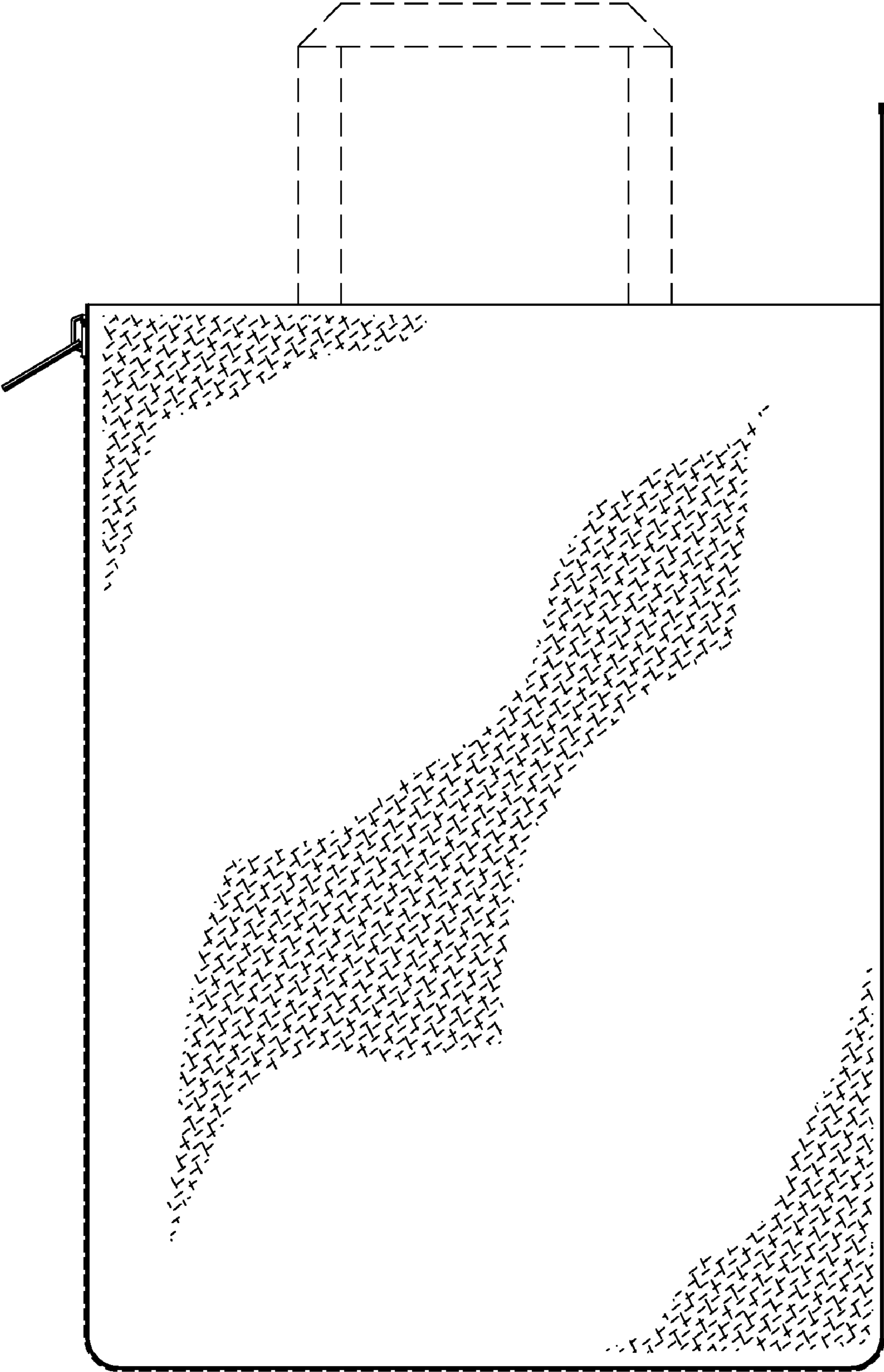

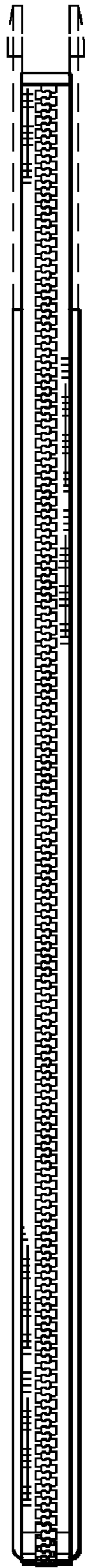

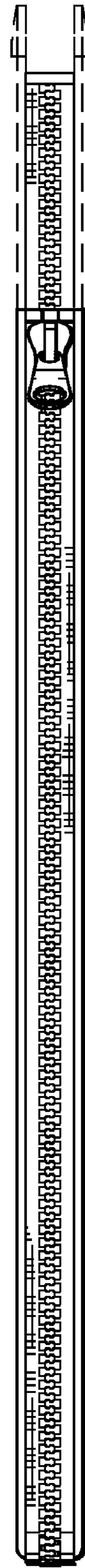

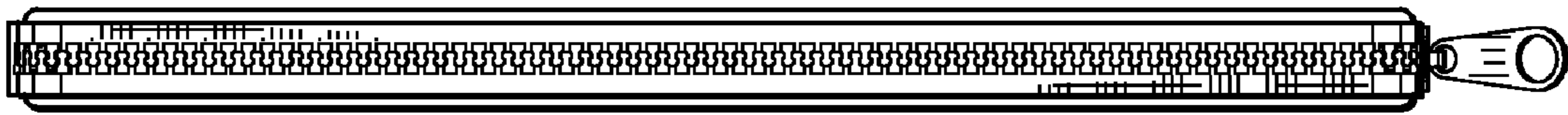

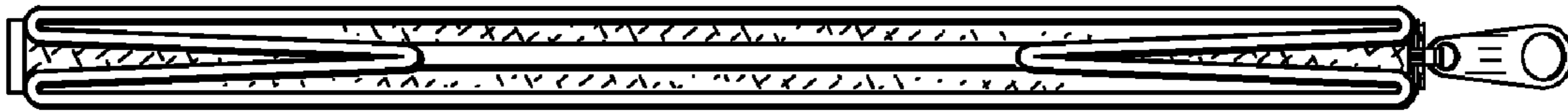

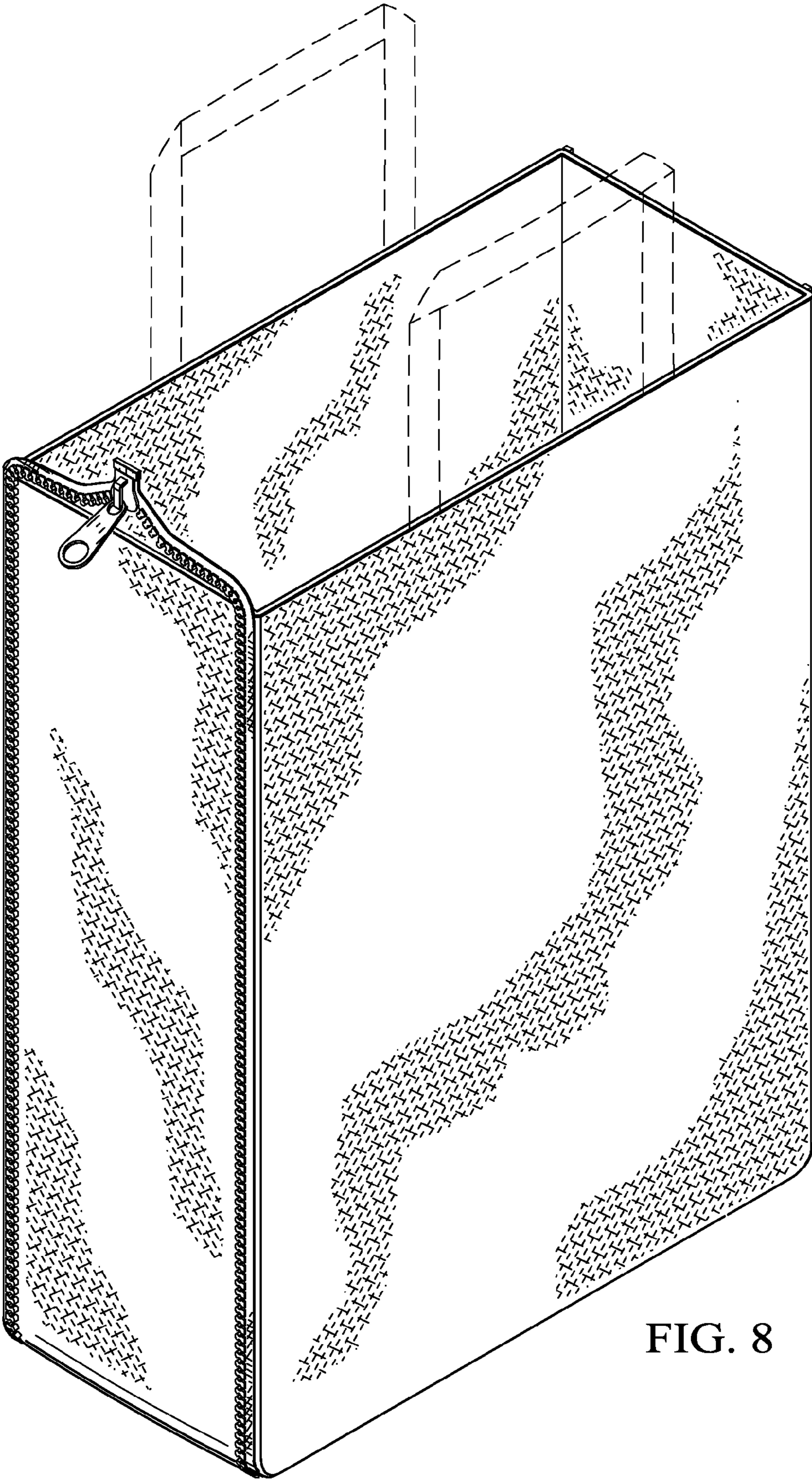

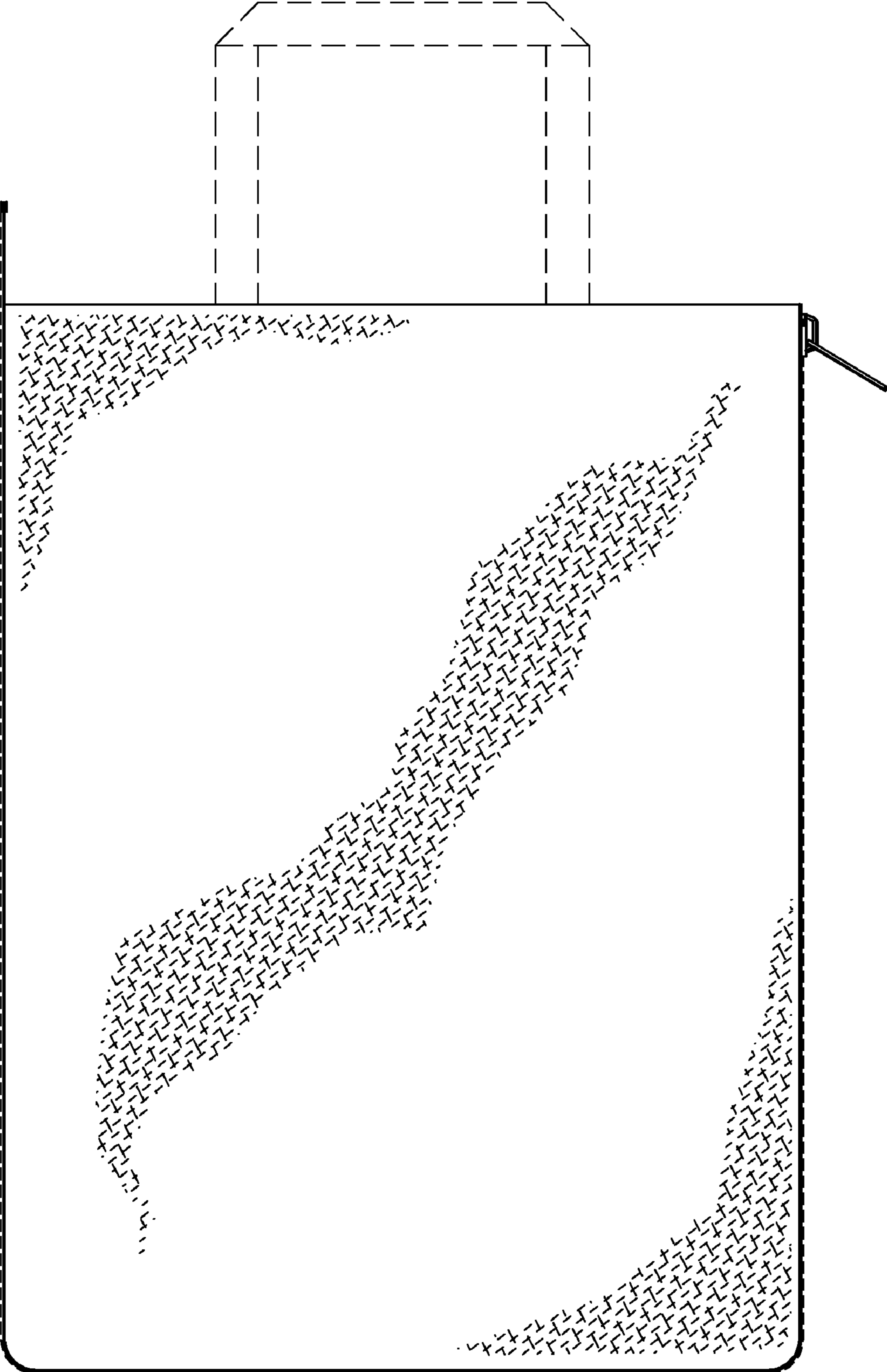

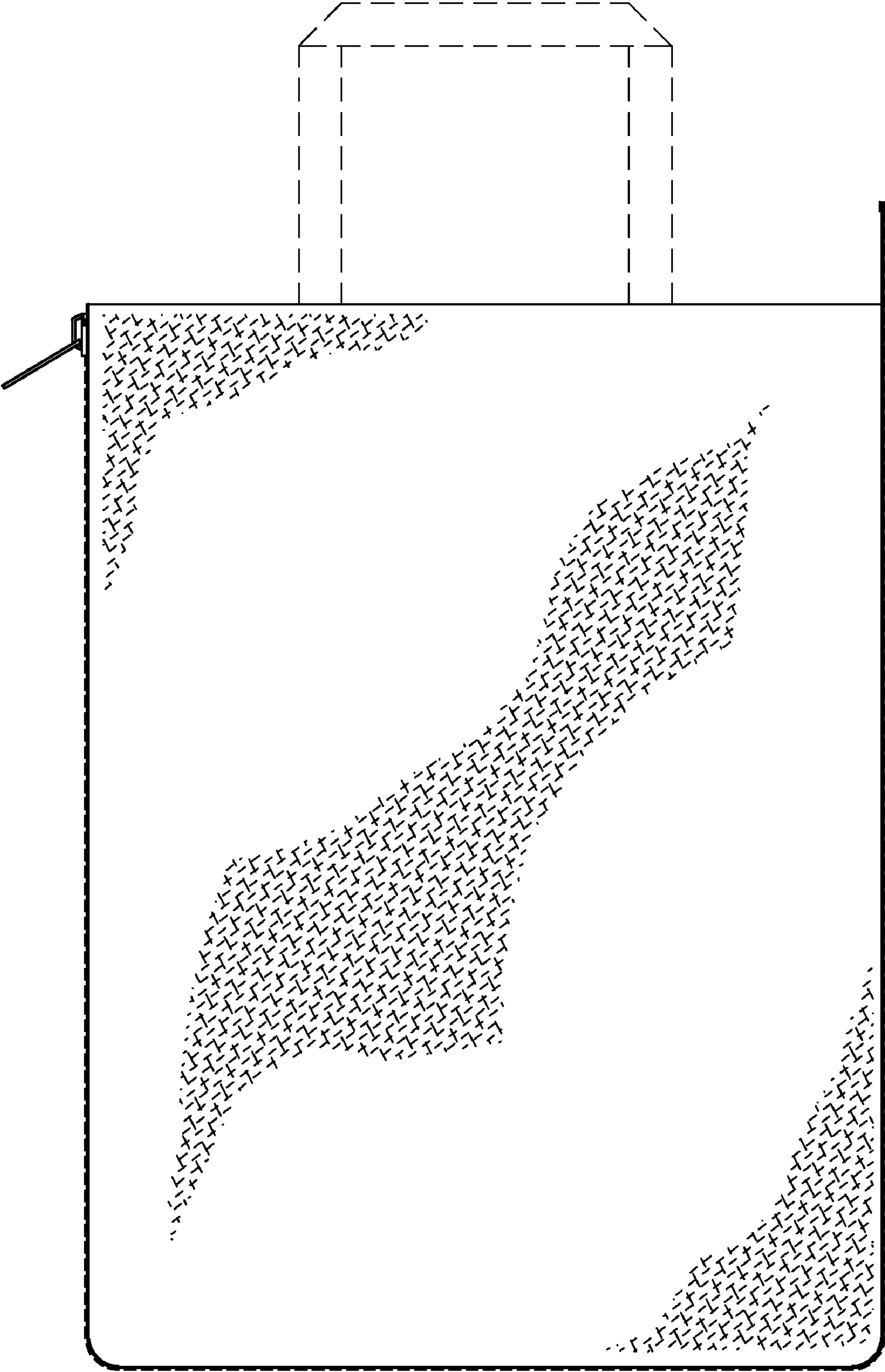

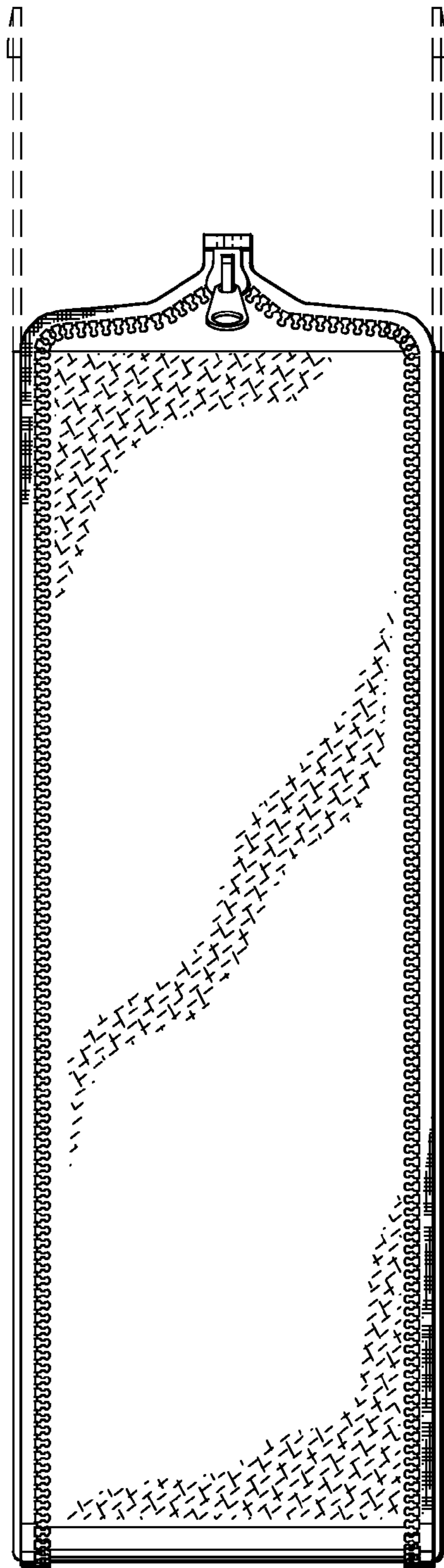

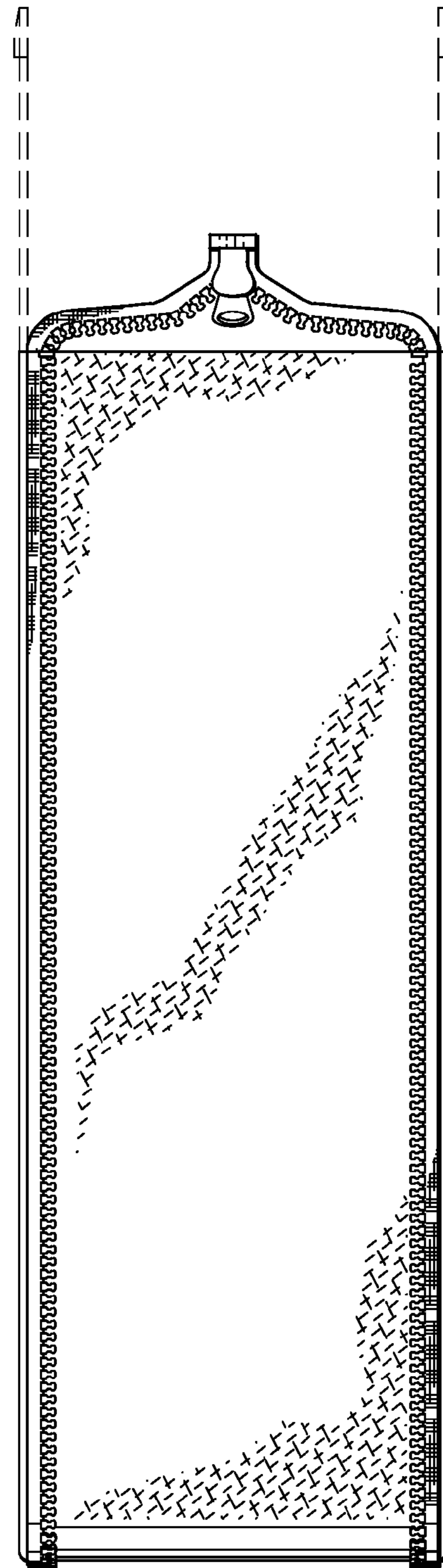

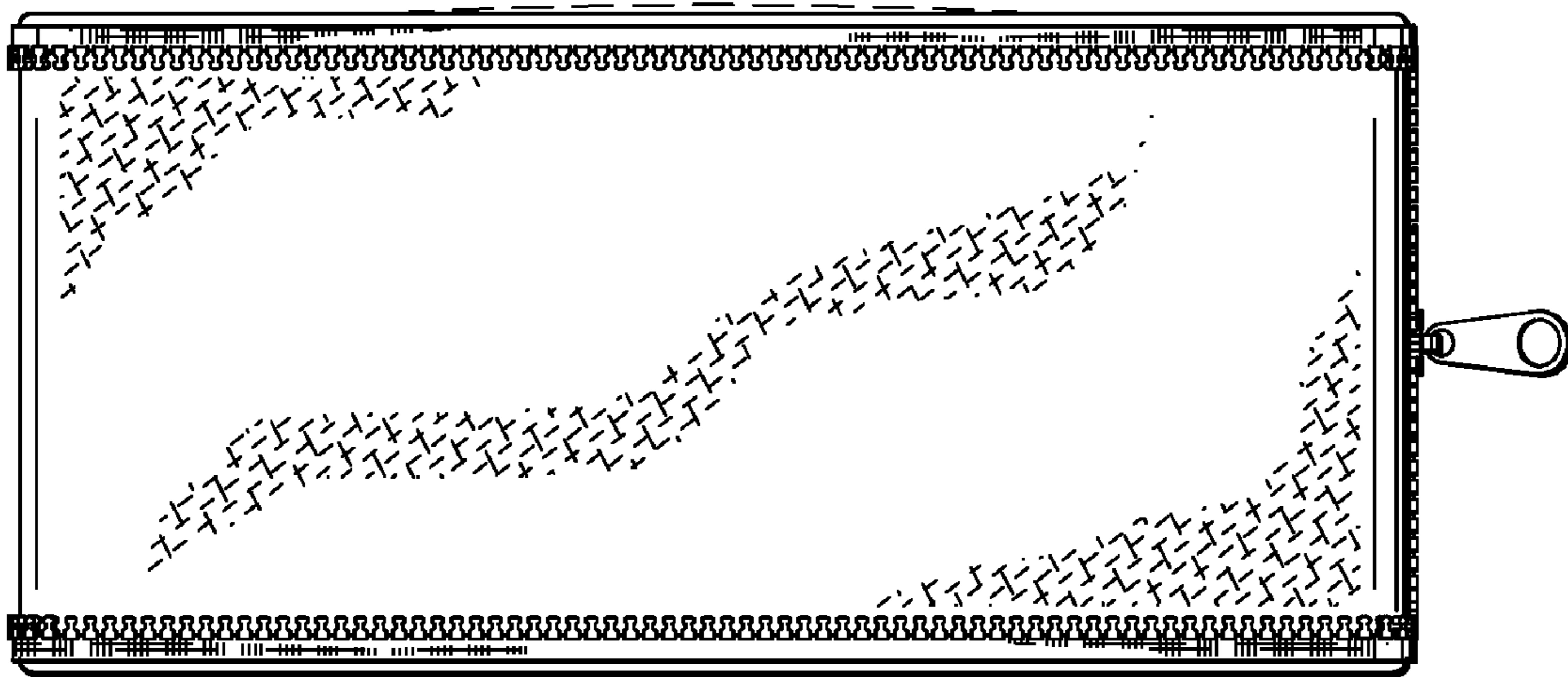

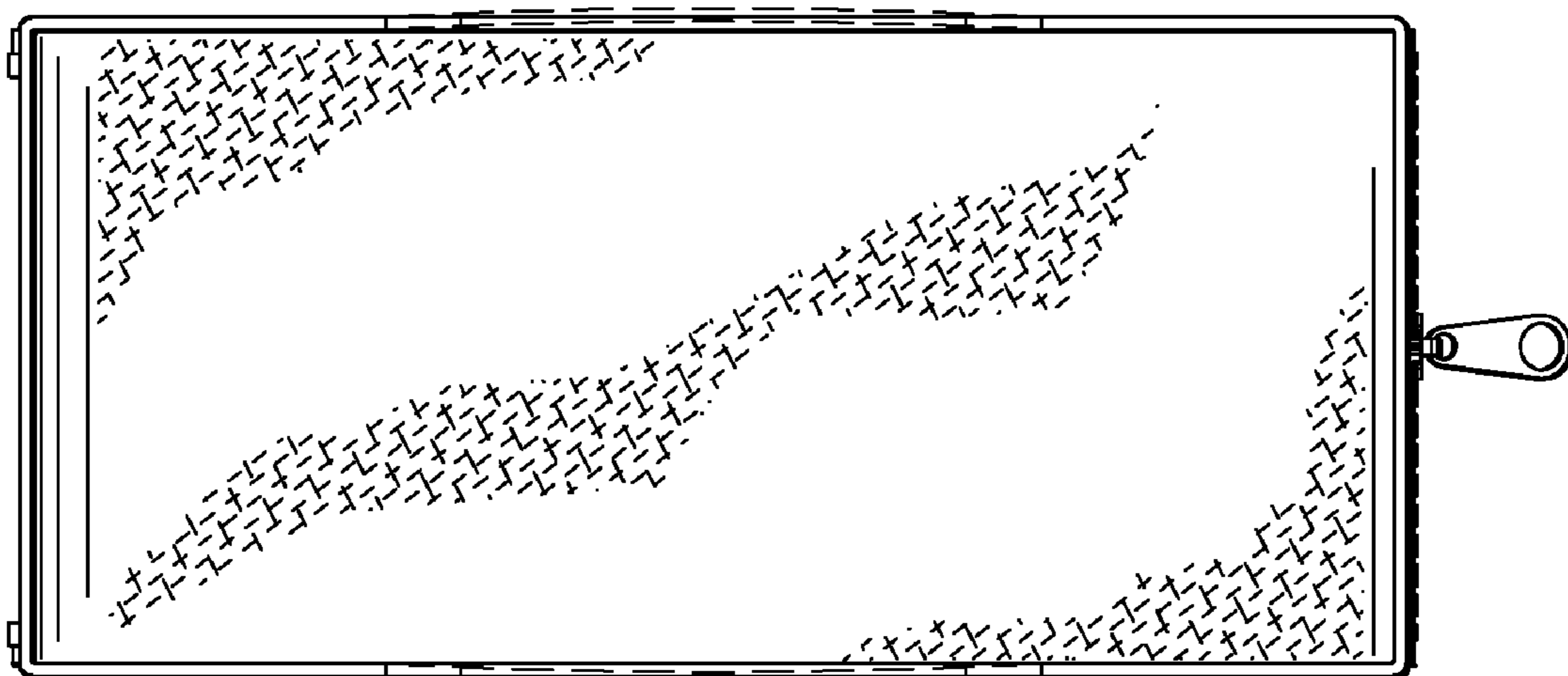
