(57) **CLAIM**

The ornamental design for a golf bag bottom, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a golf bag bottom;

FIG. 2 is a bottom perspective view of the golf bag bottom of FIG. 1;

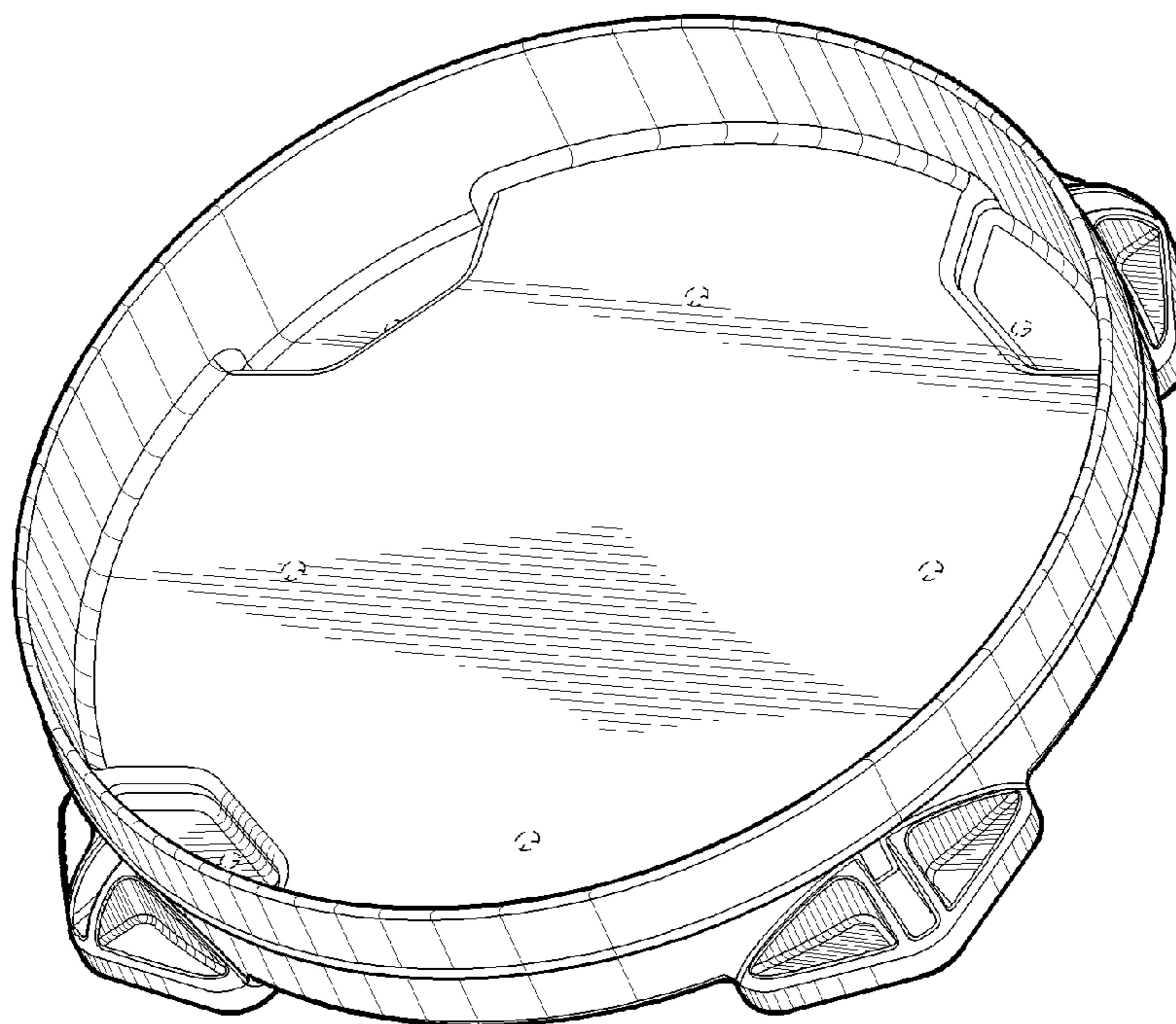
FIG. 3 is a left side view of the golf bag bottom of FIG. 1; the right side view being a mirror image thereof;

FIG. 4 is a top view of the golf bag bottom of FIG. 1; and,

FIG. 5 is a bottom view of the golf bag bottom of FIG. 1.

The broken line showing of the holes in the bottom of the golf bag is included for the purpose of illustrating boundaries and forms no part of the claimed design.

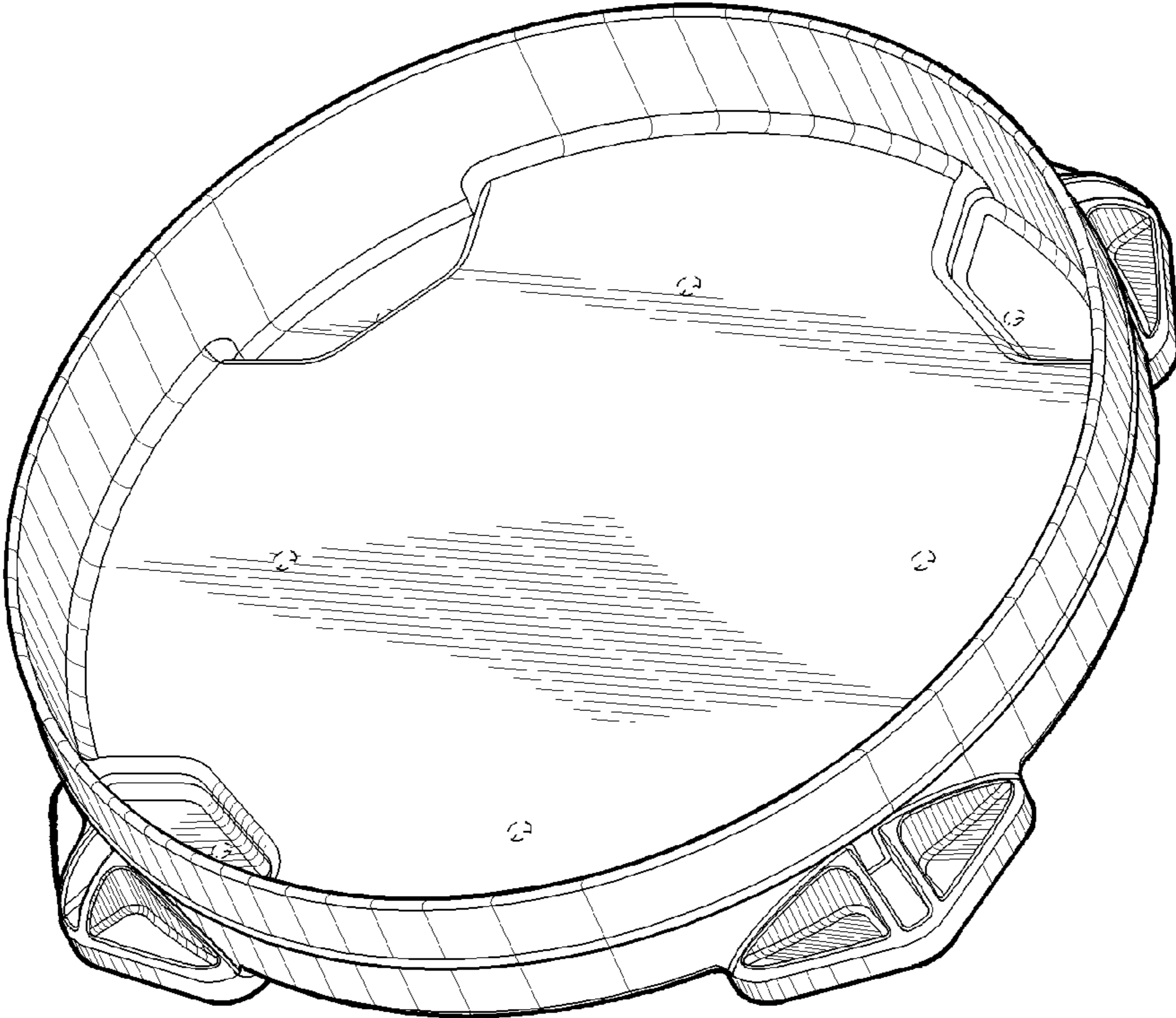

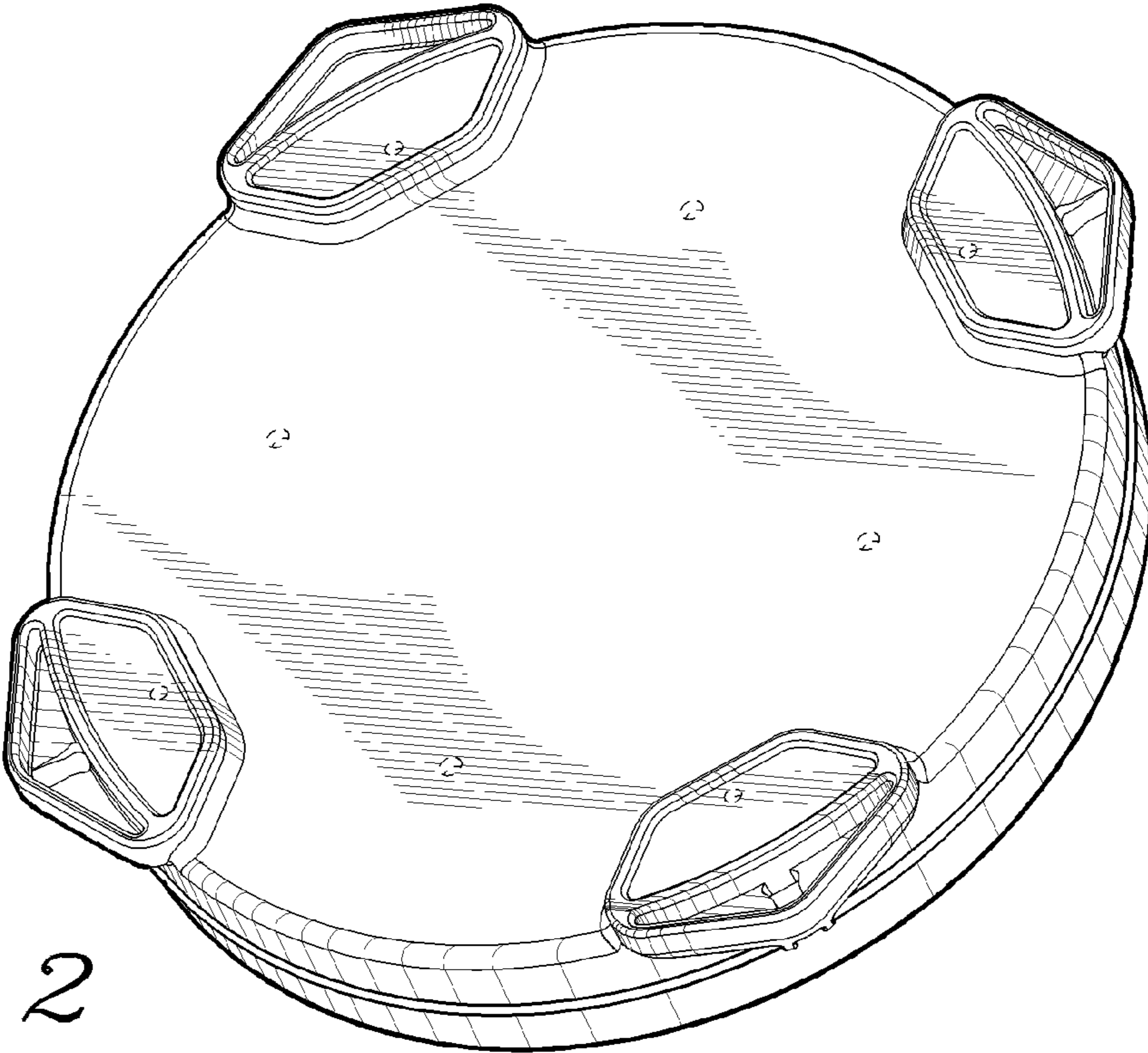

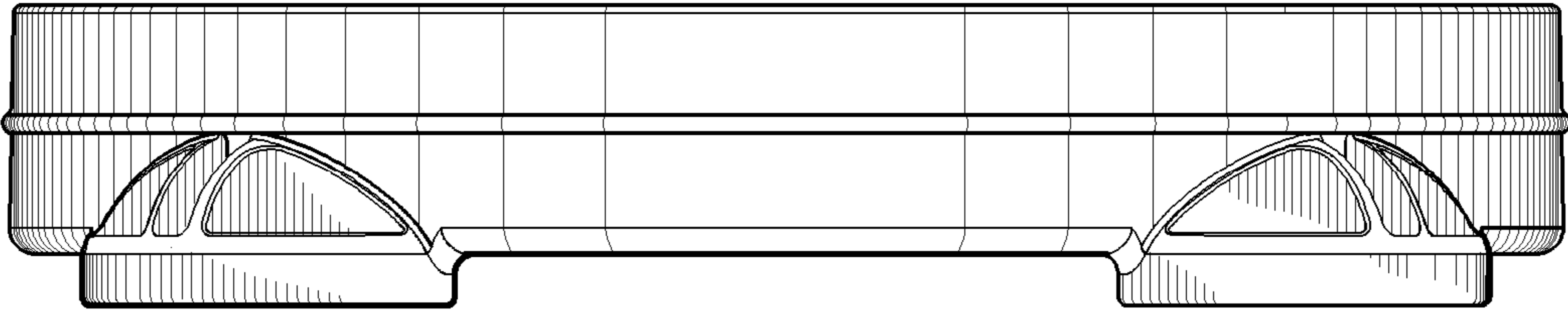

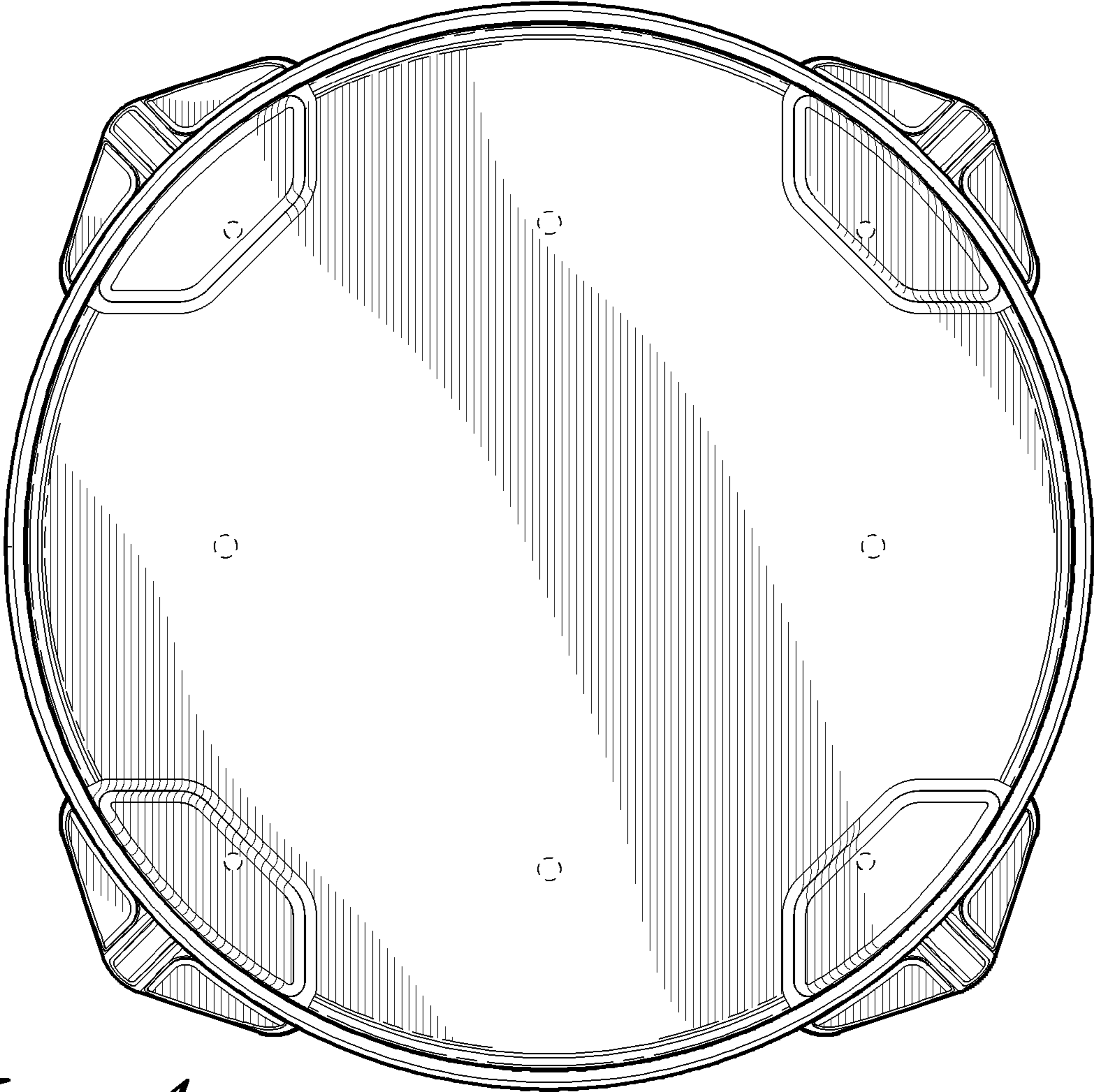

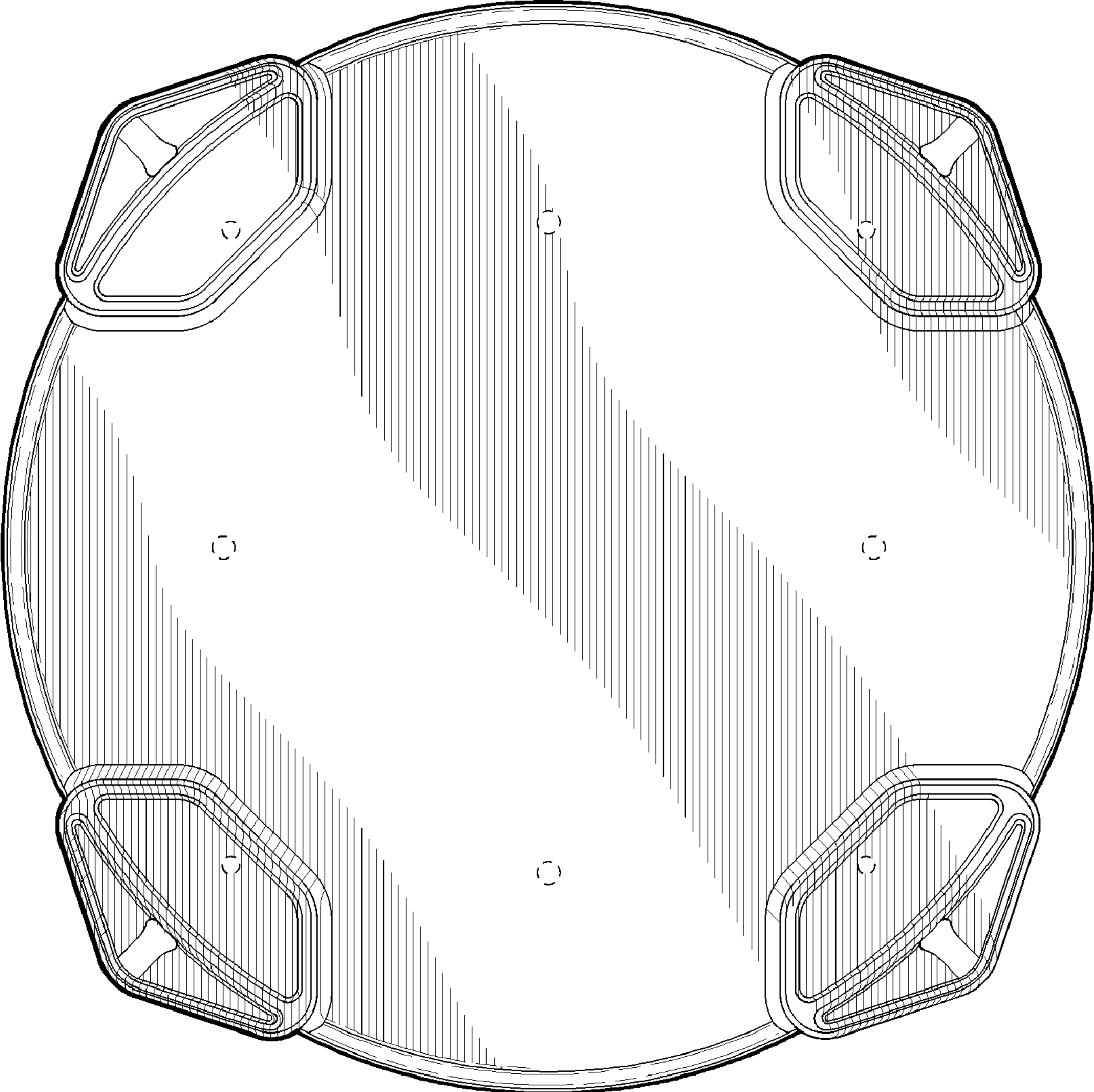
