FIG. 3 is a side elevational view thereof of the side opposite that of FIG. 2;

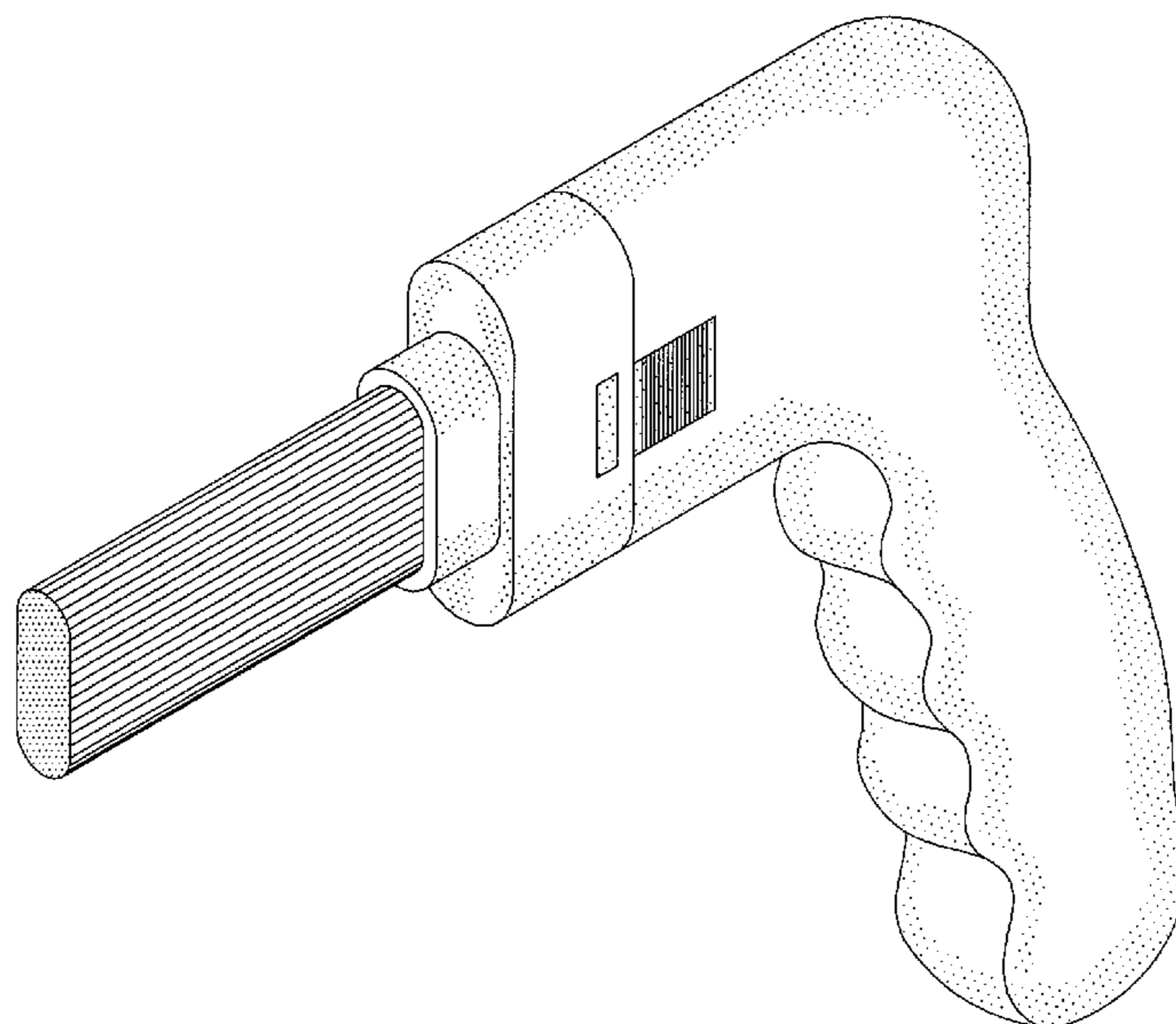
FIG. 4 is a front elevational view thereof;

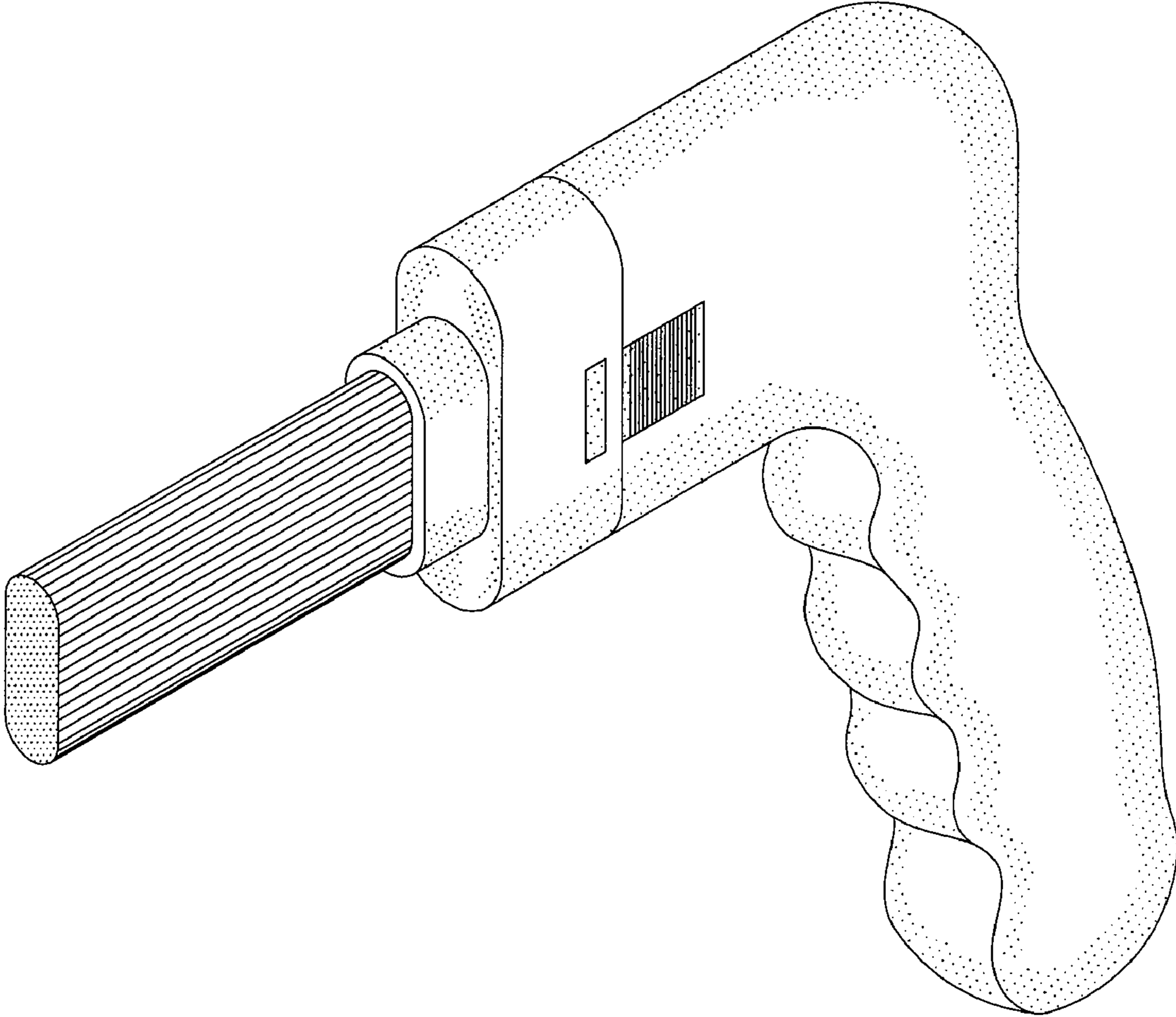

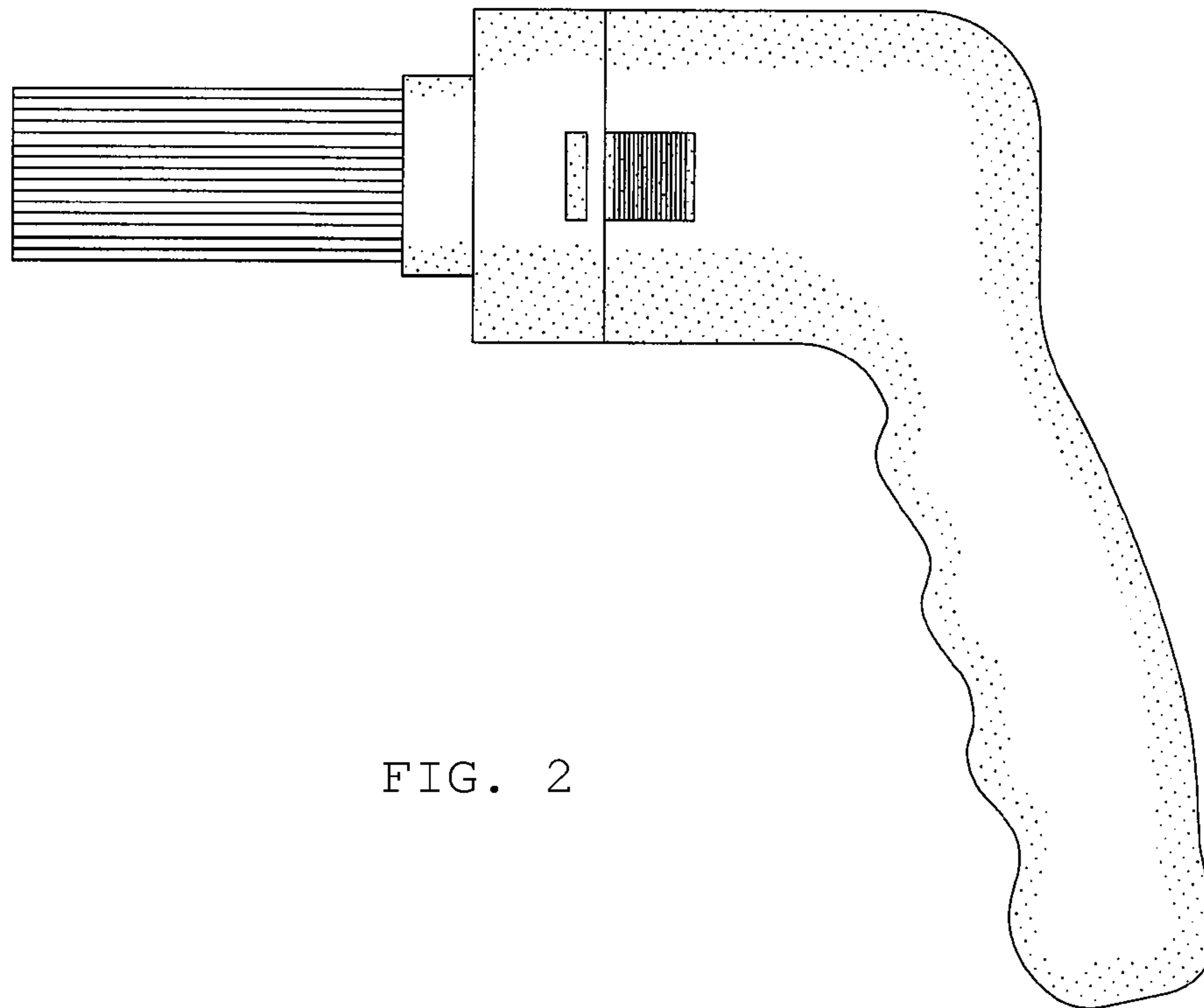

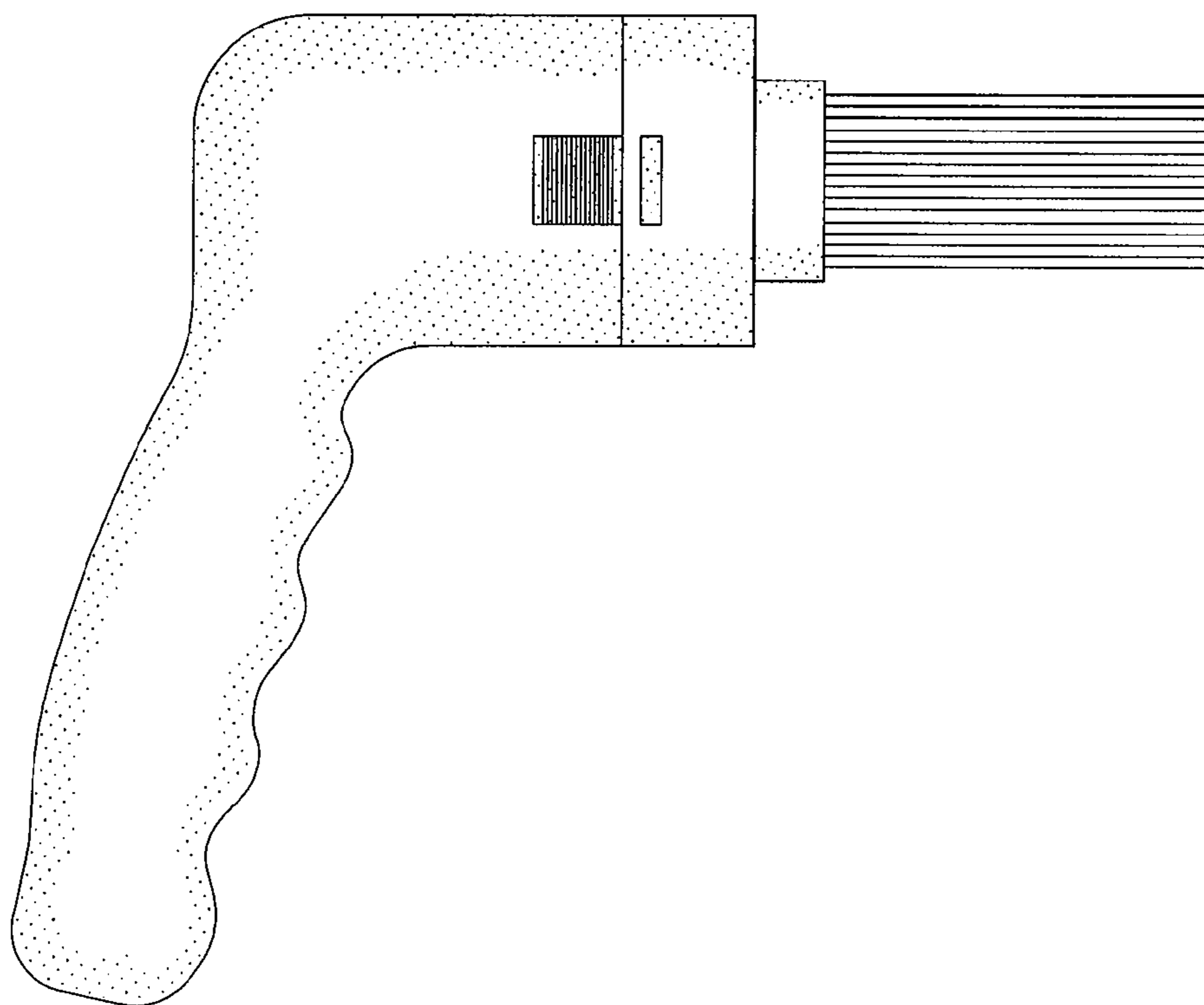

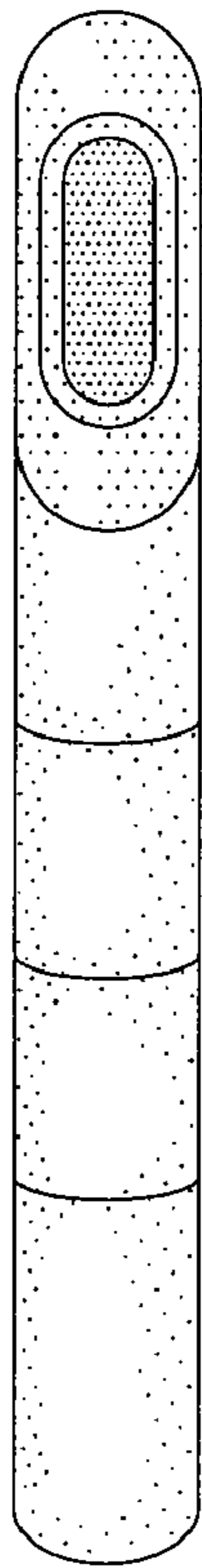

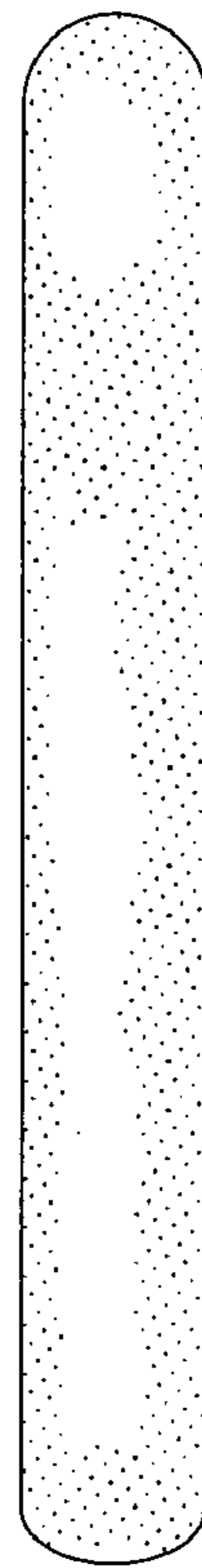

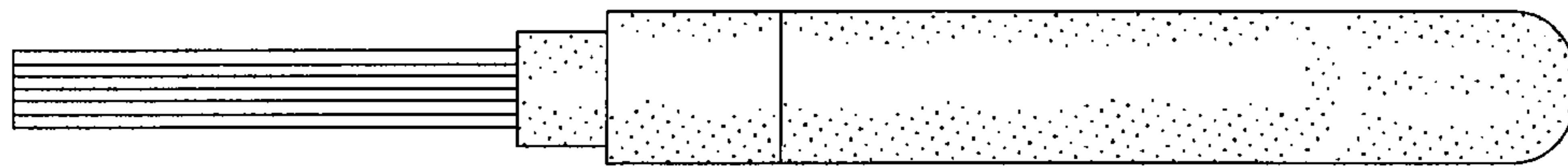

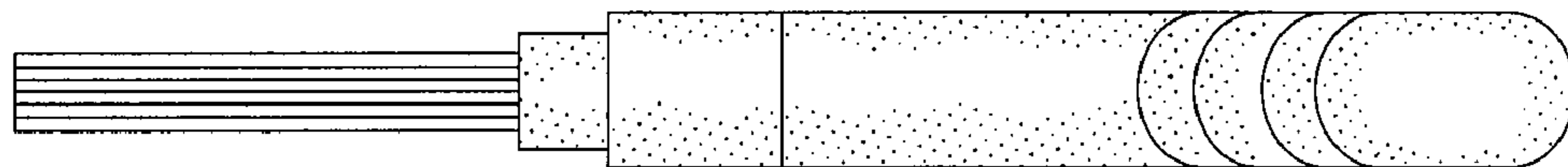
