DESCRIPTION

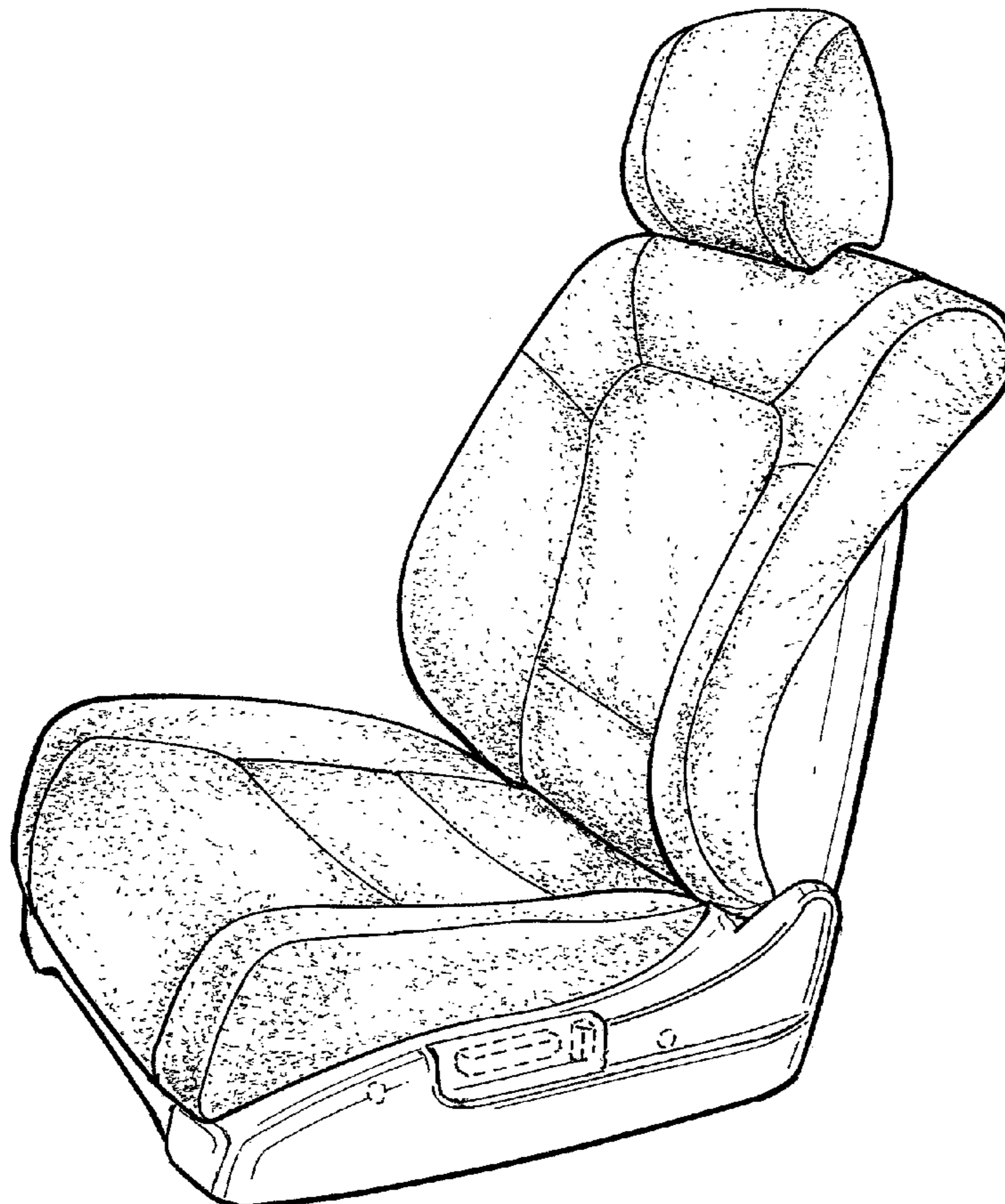
FIG. 1 is a perspective view of a vehicle seat showing my new design;

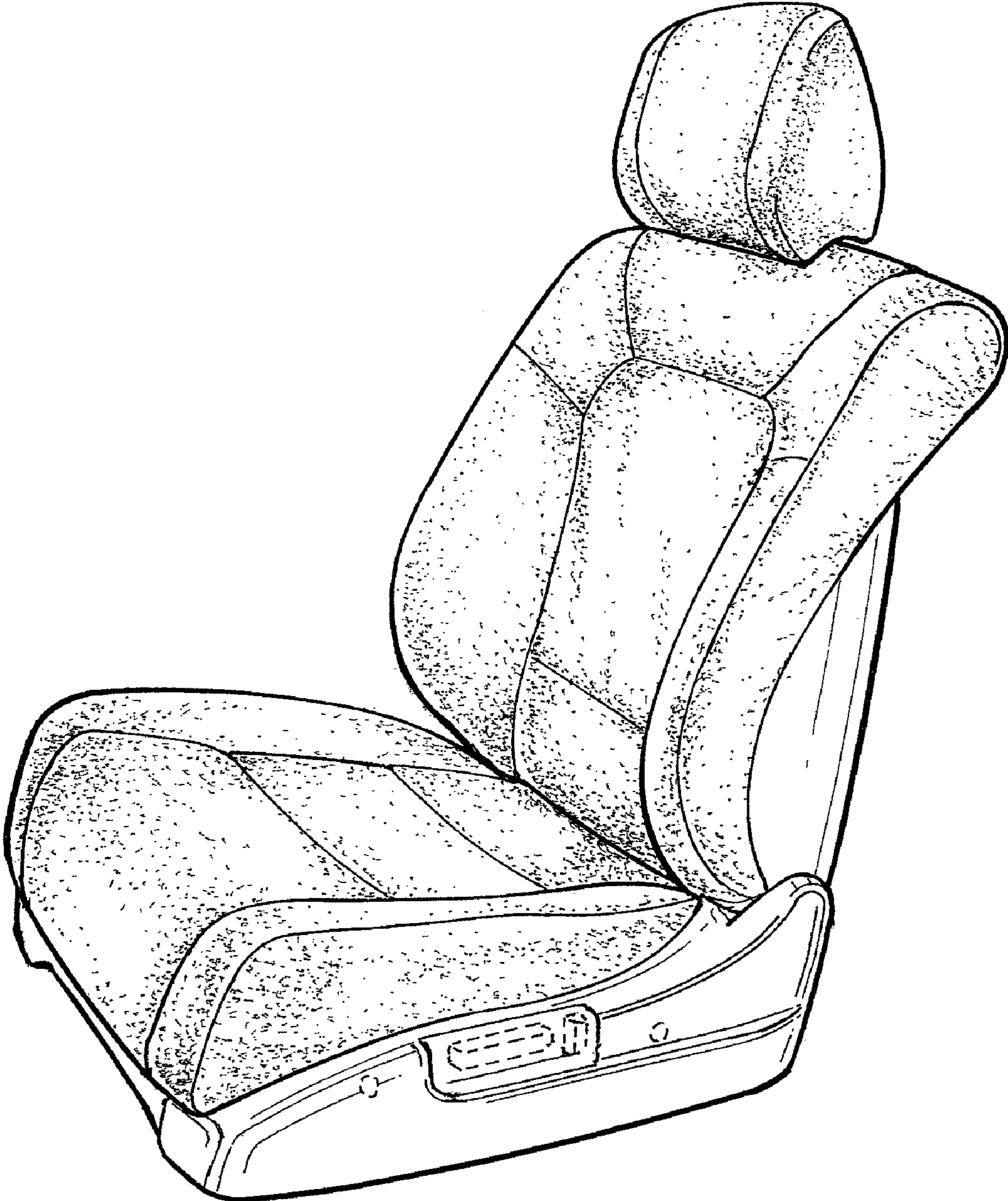

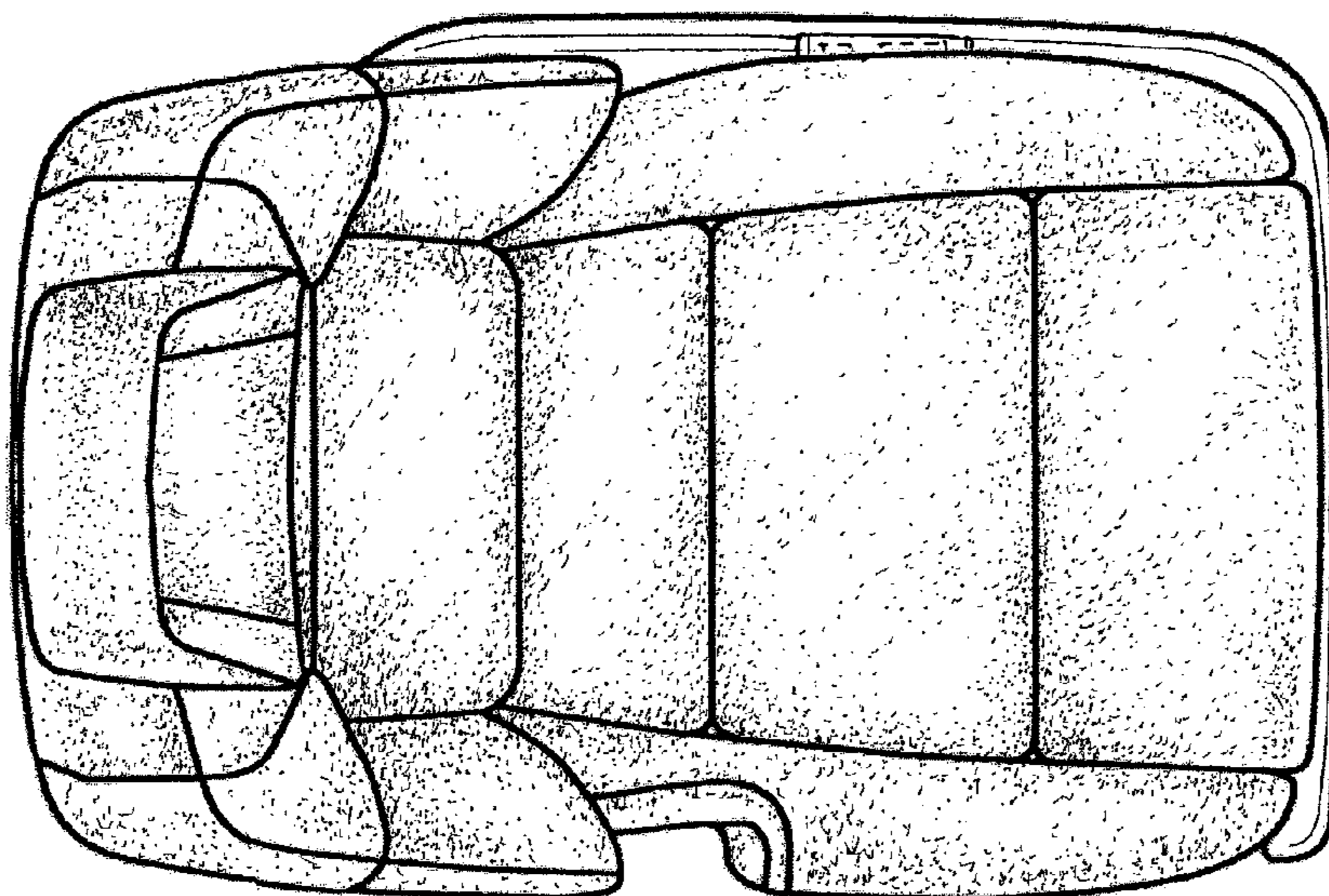

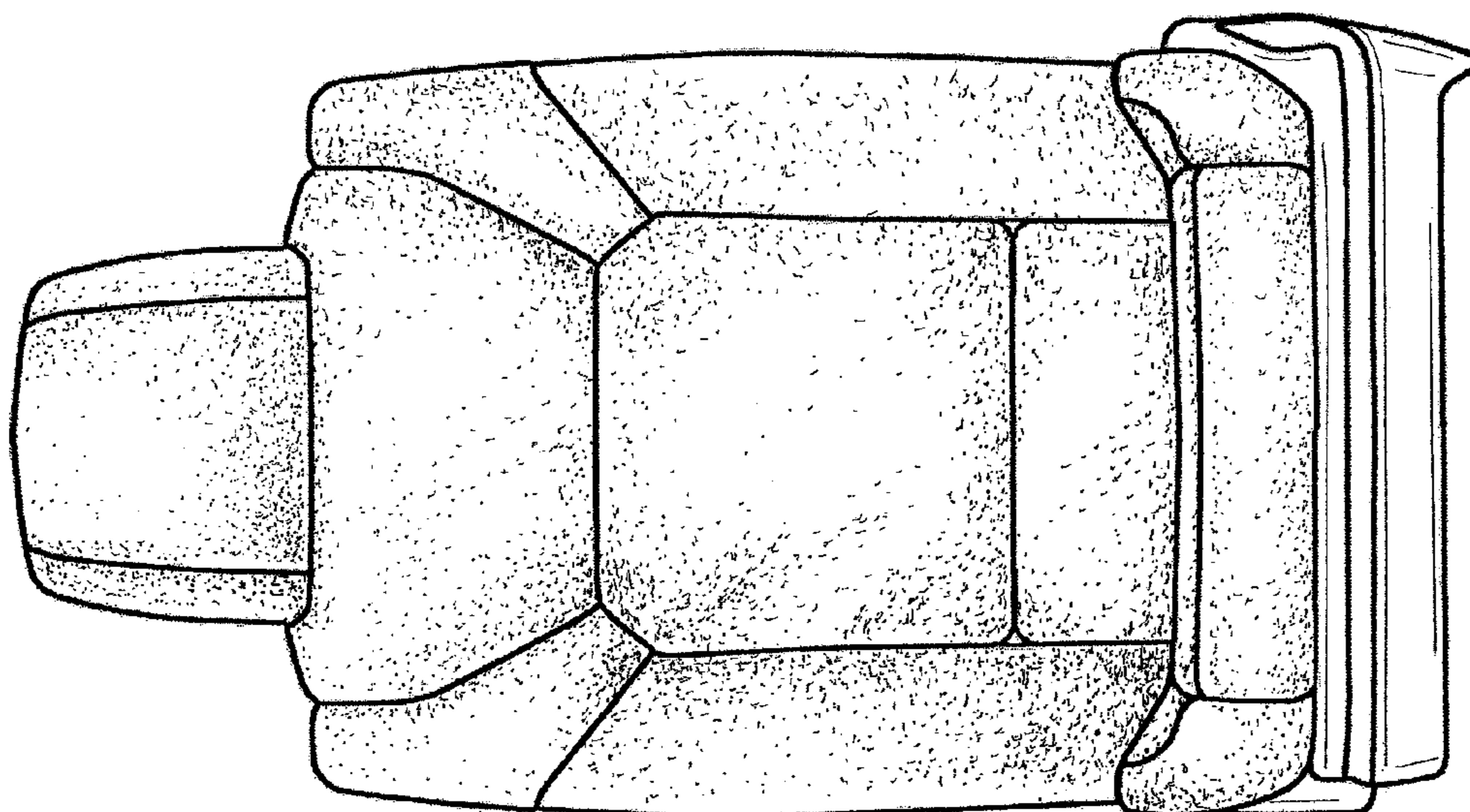
