**DESCRIPTION**

FIG. 1 is a rear elevational view of an armchair, showing my new design;

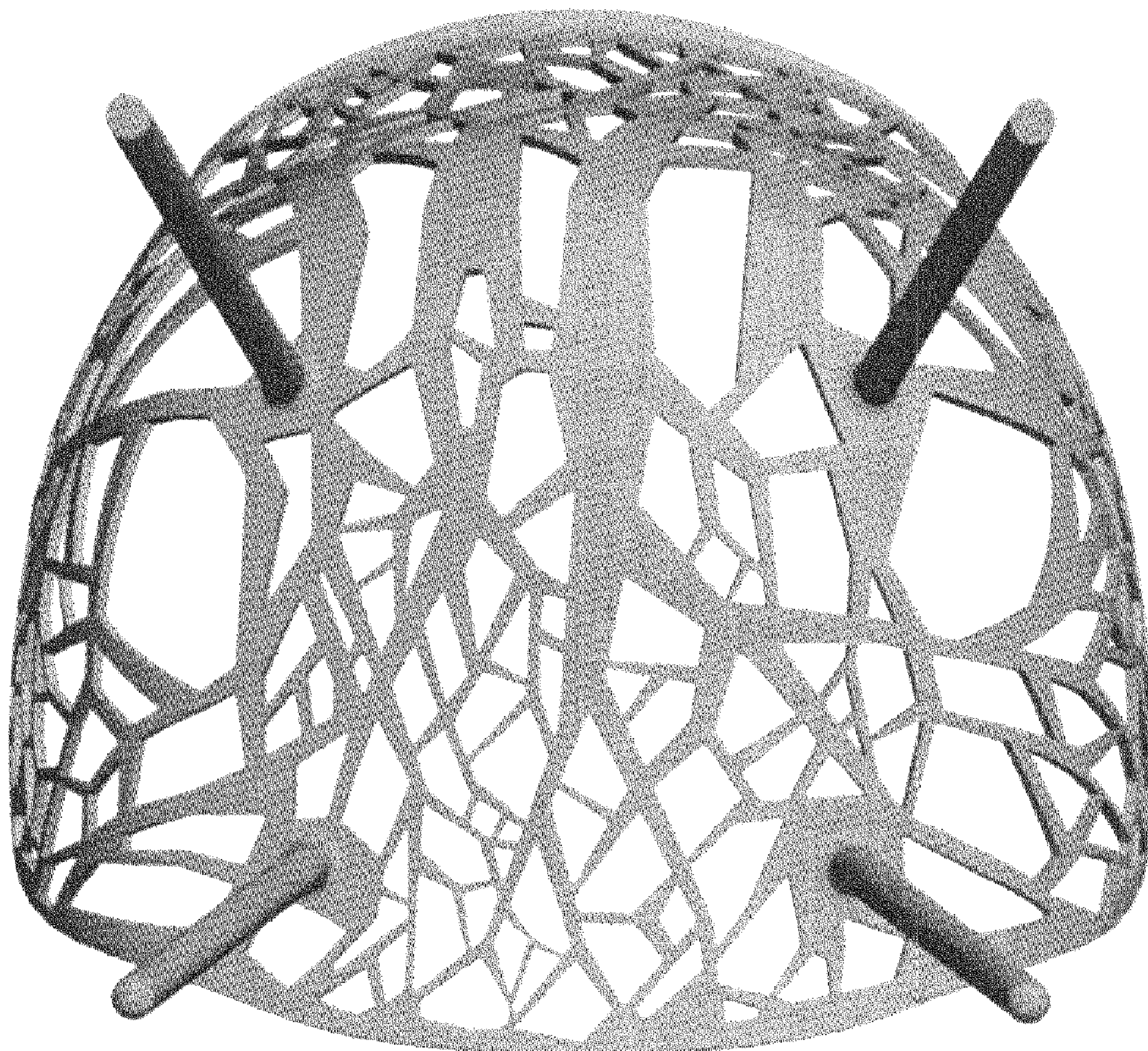
