**DESCRIPTION**

a table embodying my new design;

elevational view being a mirror image thereof;

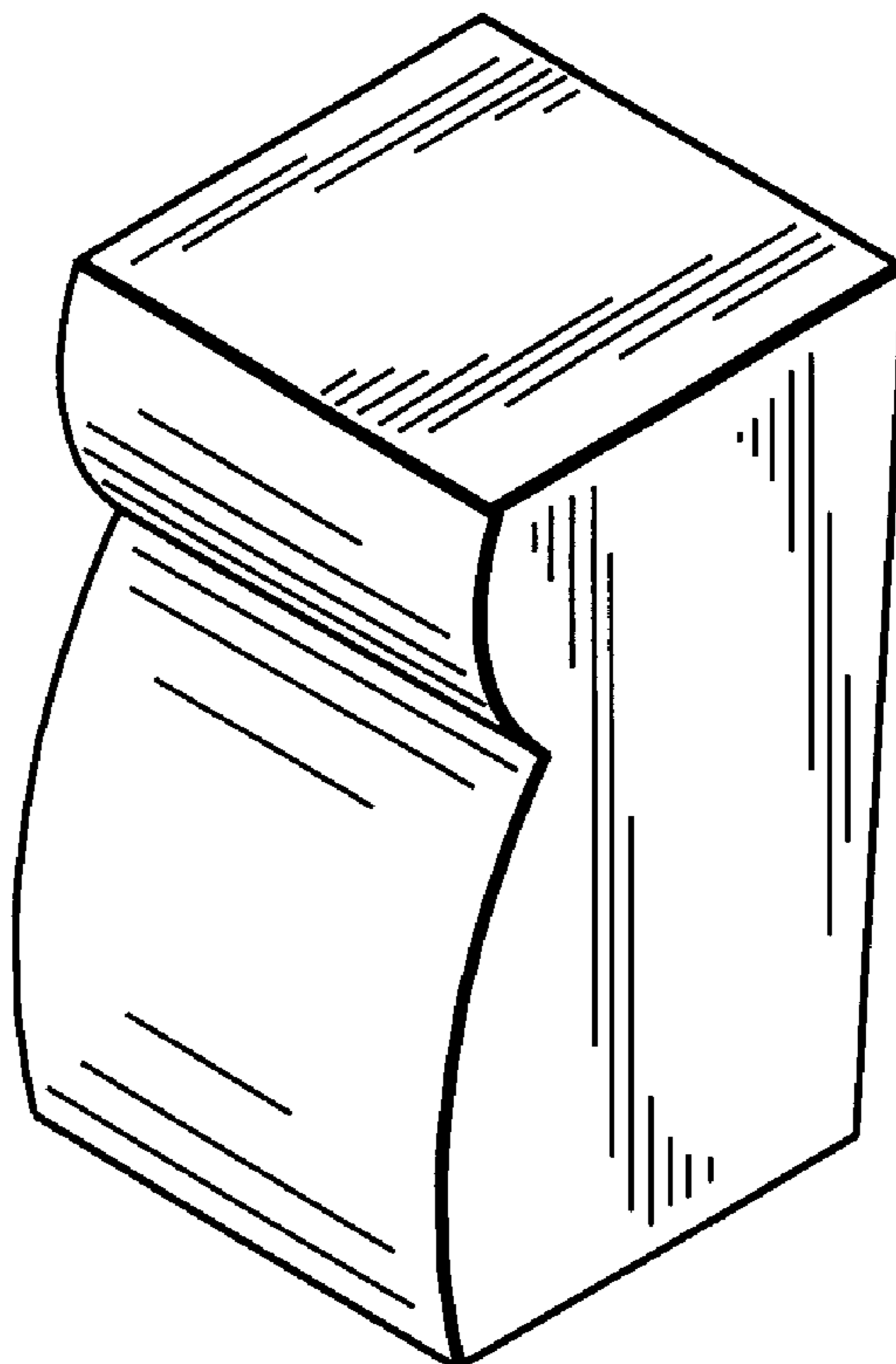
FIG. 3 is a front elevational view thereof;

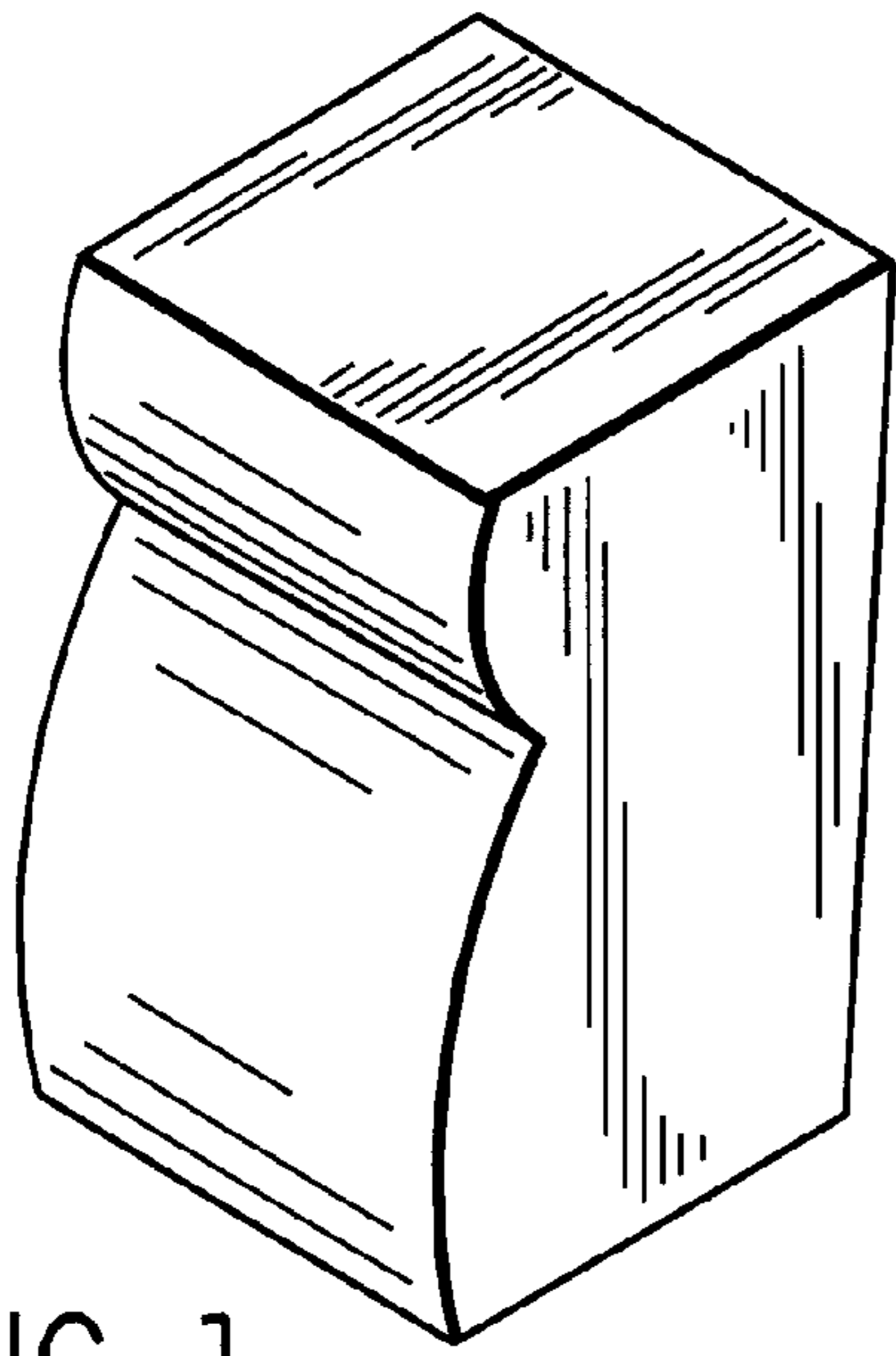

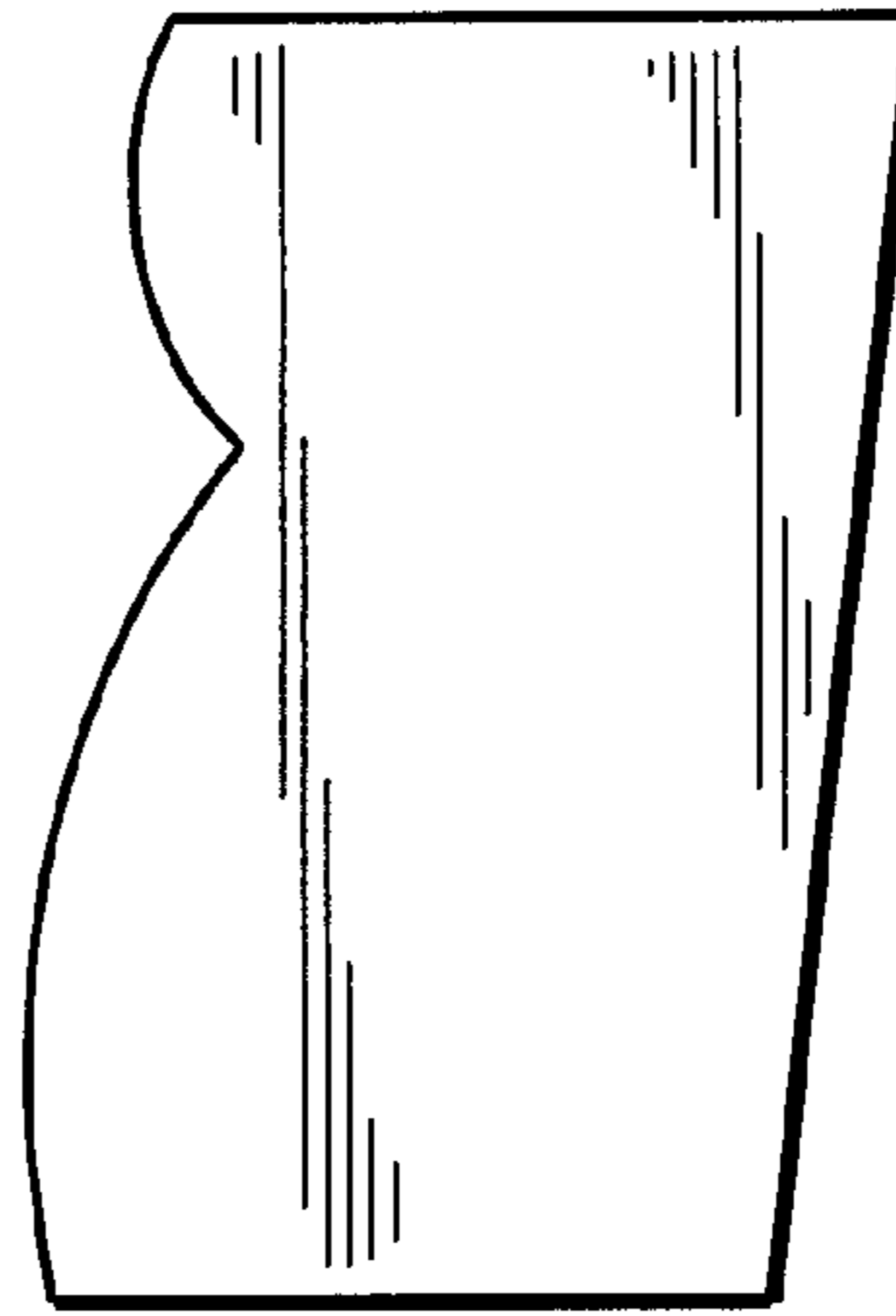

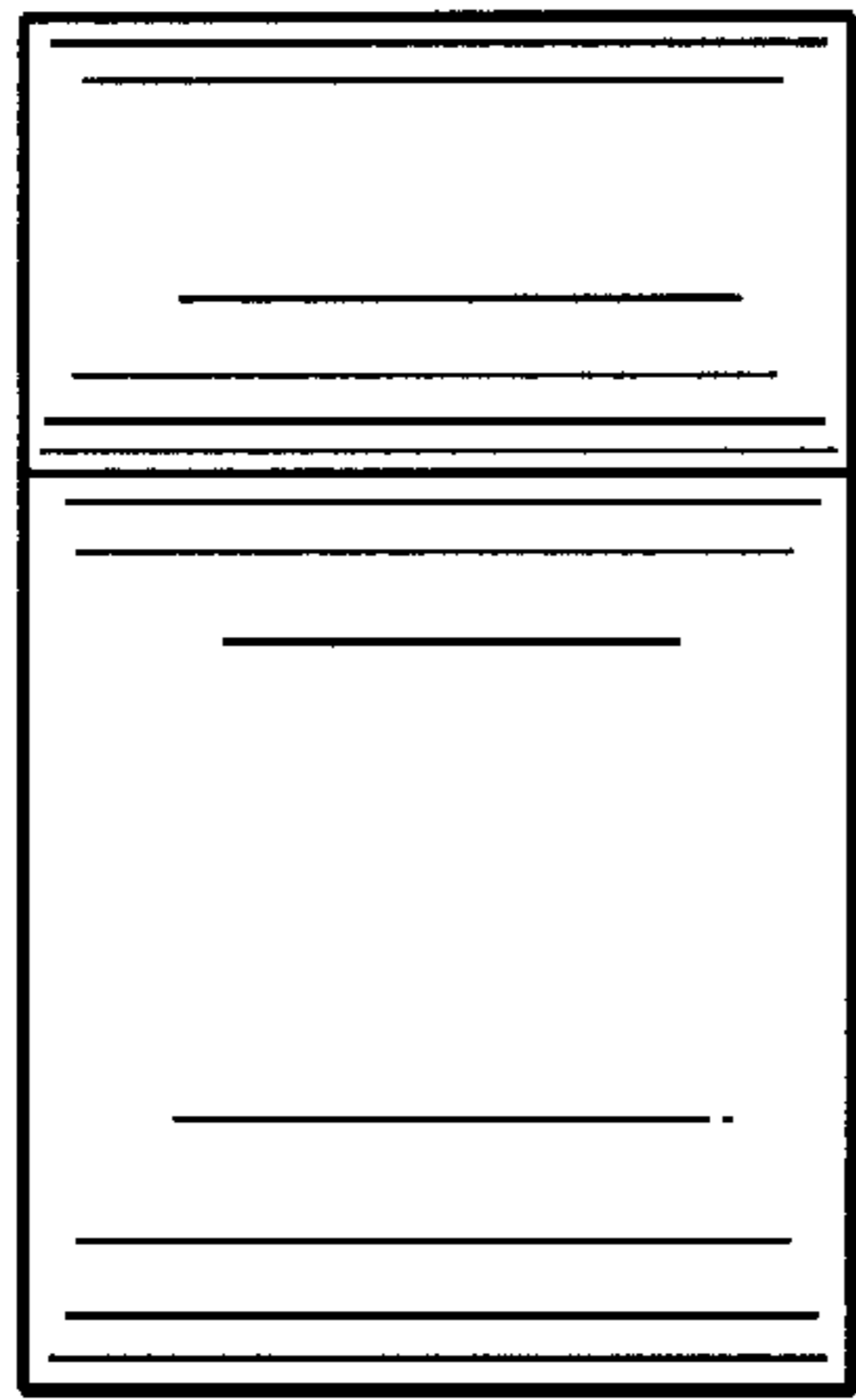

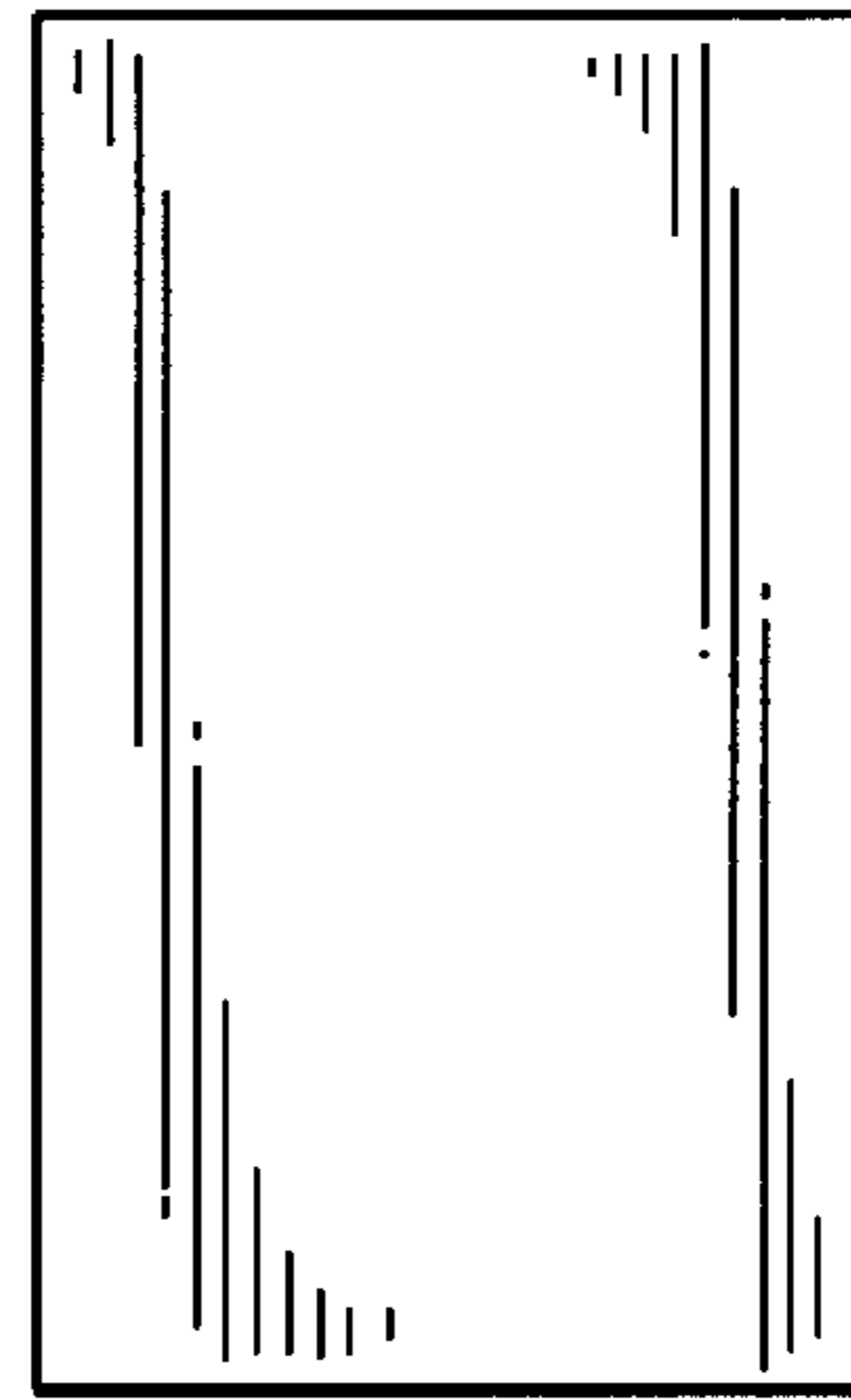

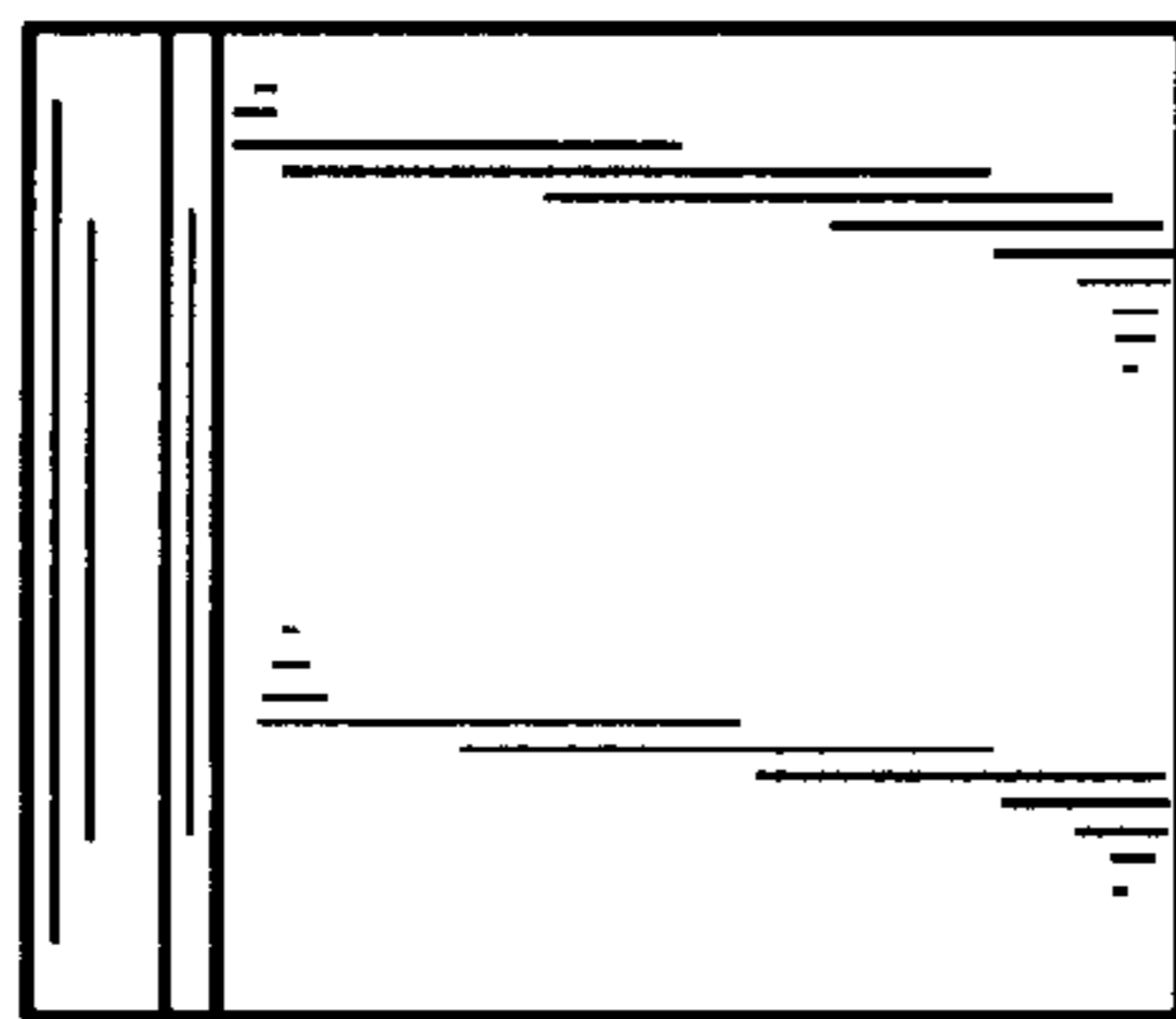

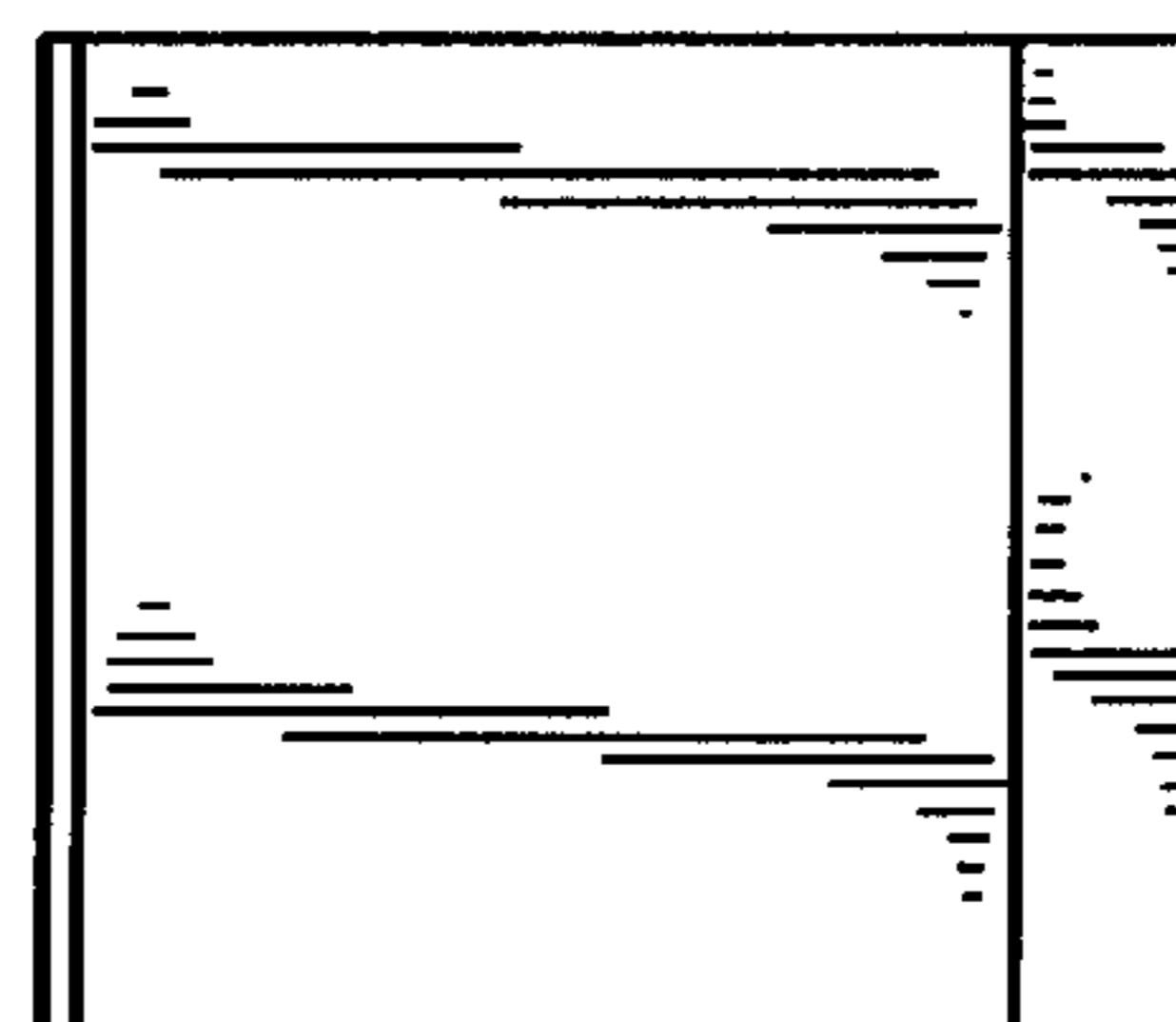
