(57) **CLAIM**

The design for a wine bottle stand, substantially as shown and
described.

DESCRIPTION

FIG. 1 is a front perspective view of the wine bottle stand
according to the invention.

FIG. 2 is a right elevation view of the wine bottle stand of FIG.
1.

FIG. 3 is a left elevation view of the wine bottle stand of FIG.
1.

FIG. 4 is a front elevation view of the wine bottle stand of FIG.
1.

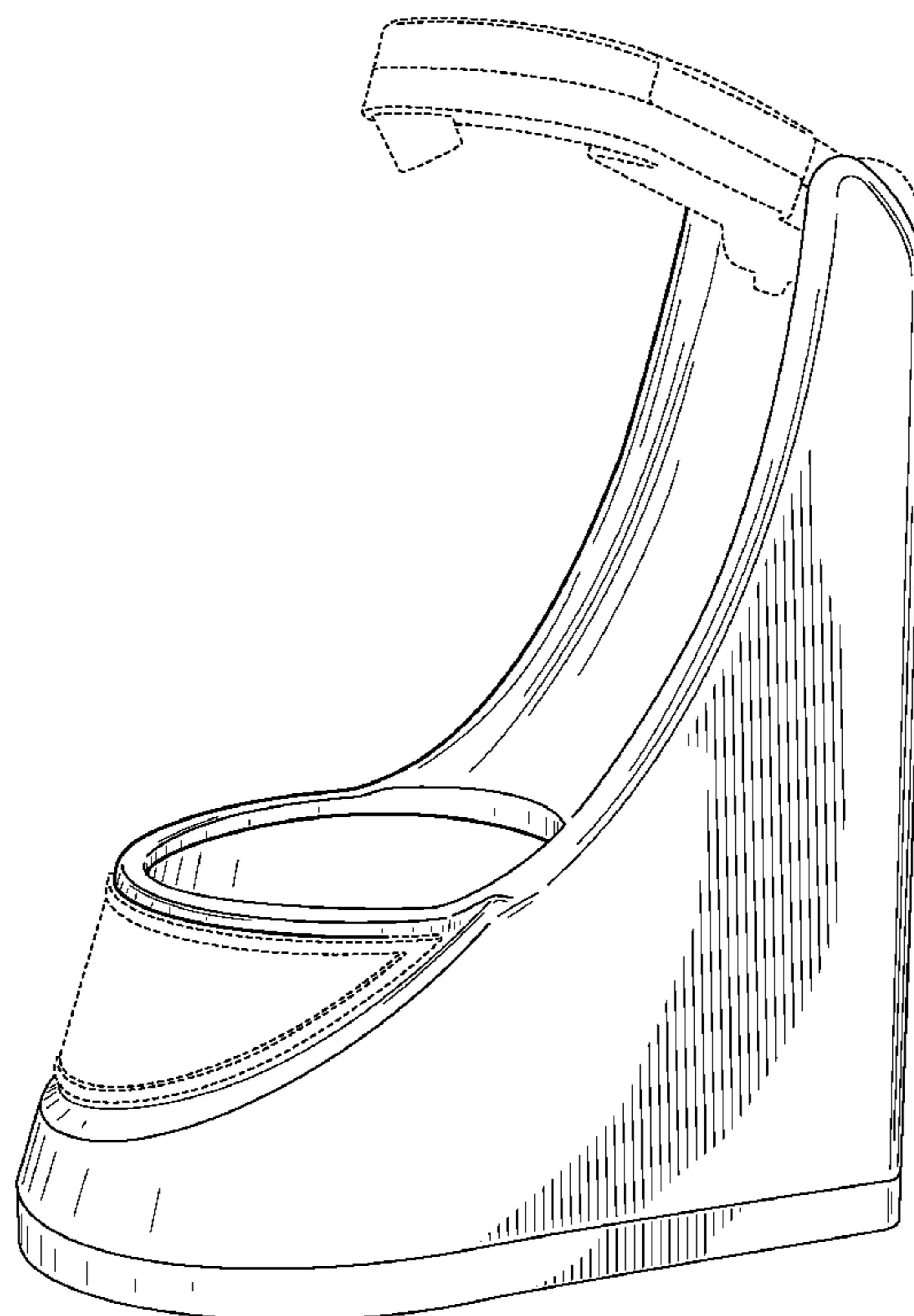
FIG. 5 is a rear elevation view of a wine bottle stand of FIG.

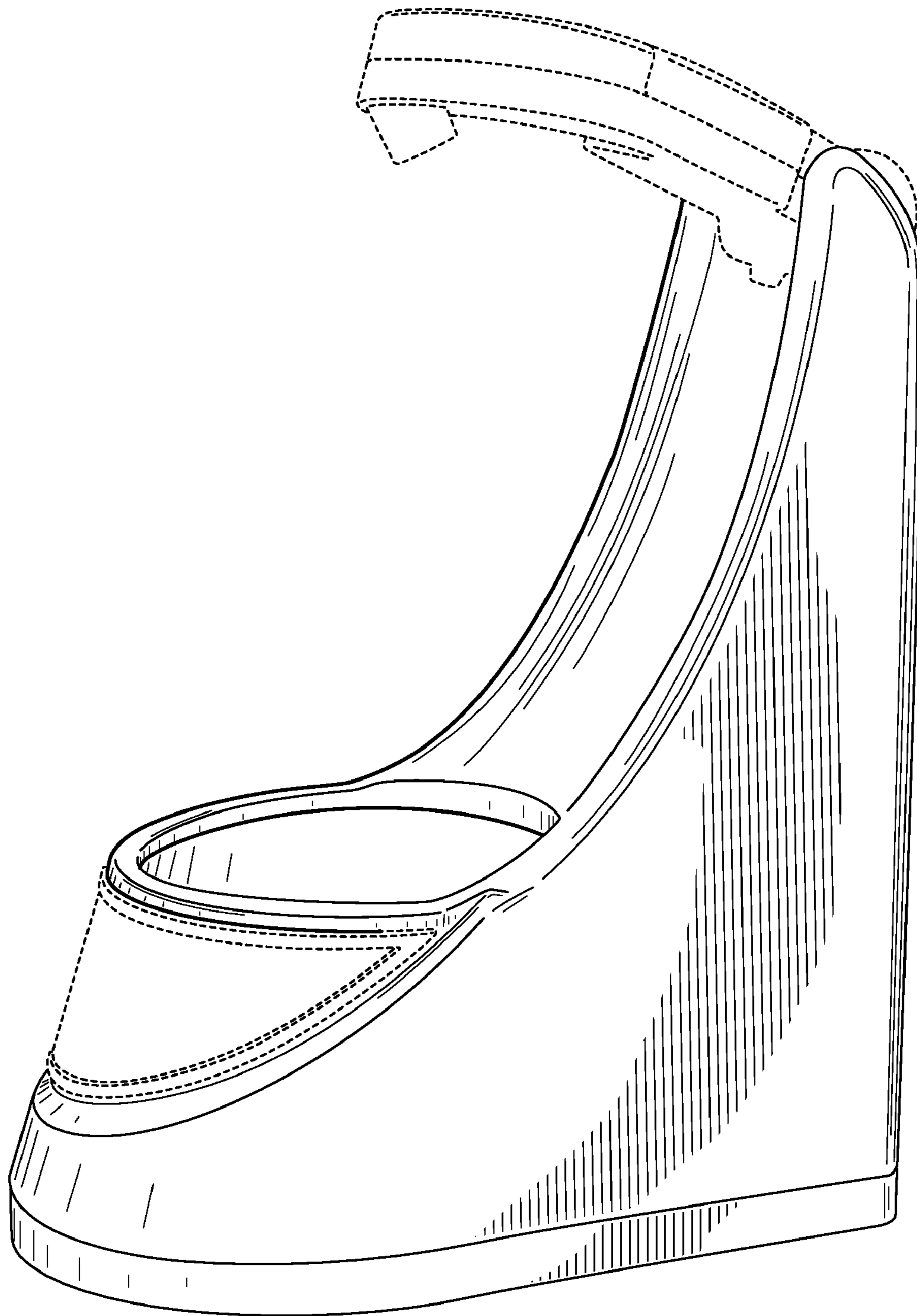

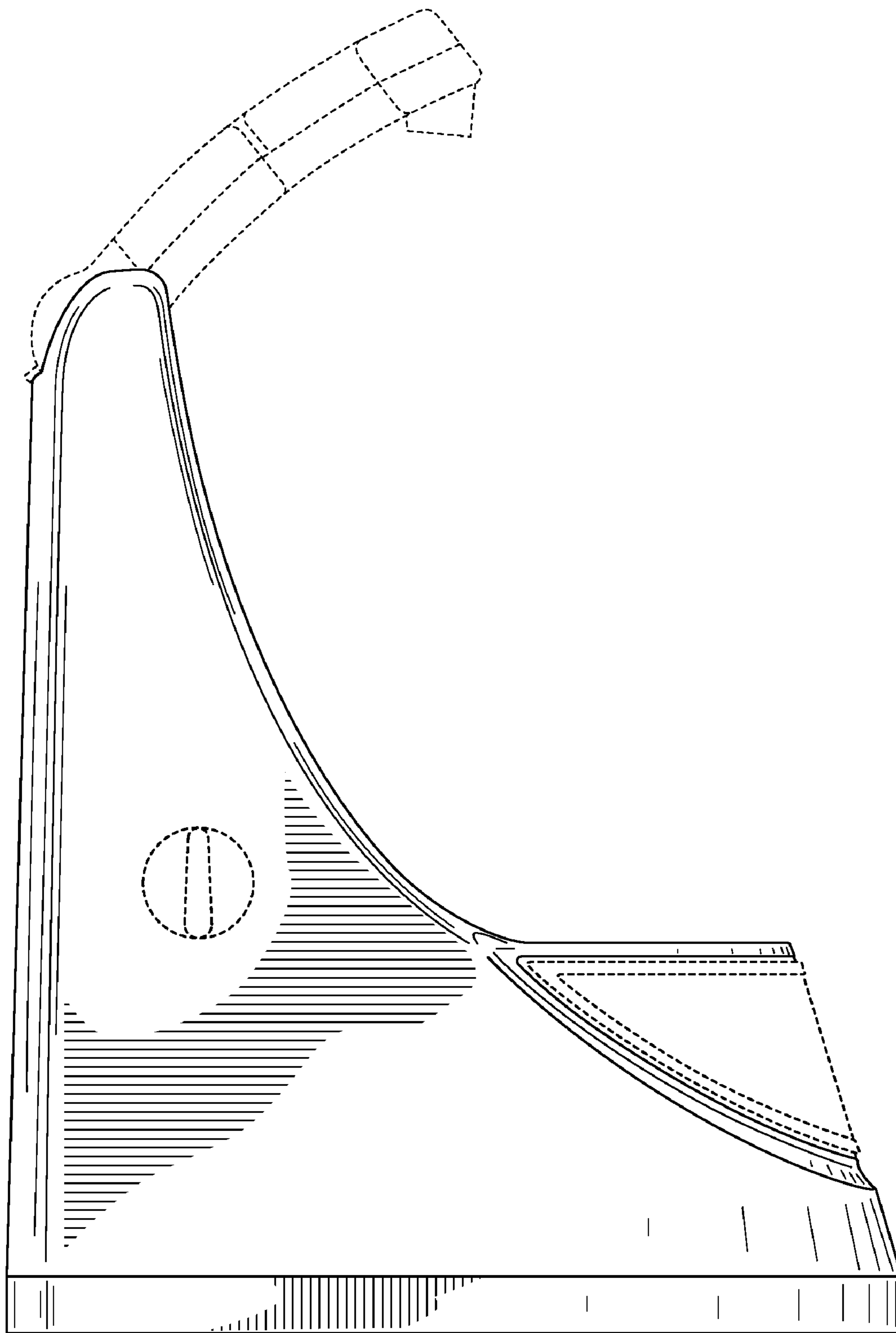

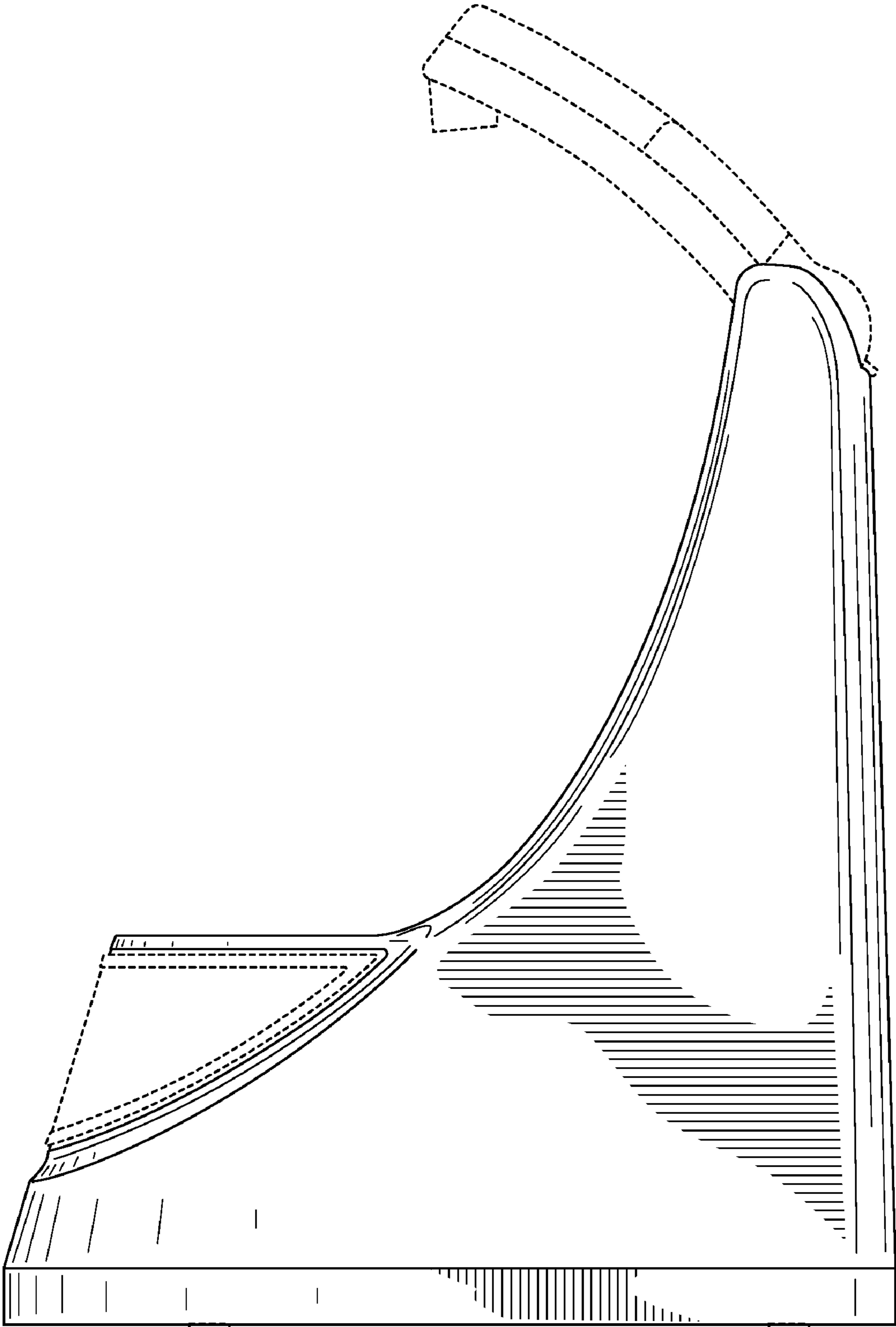

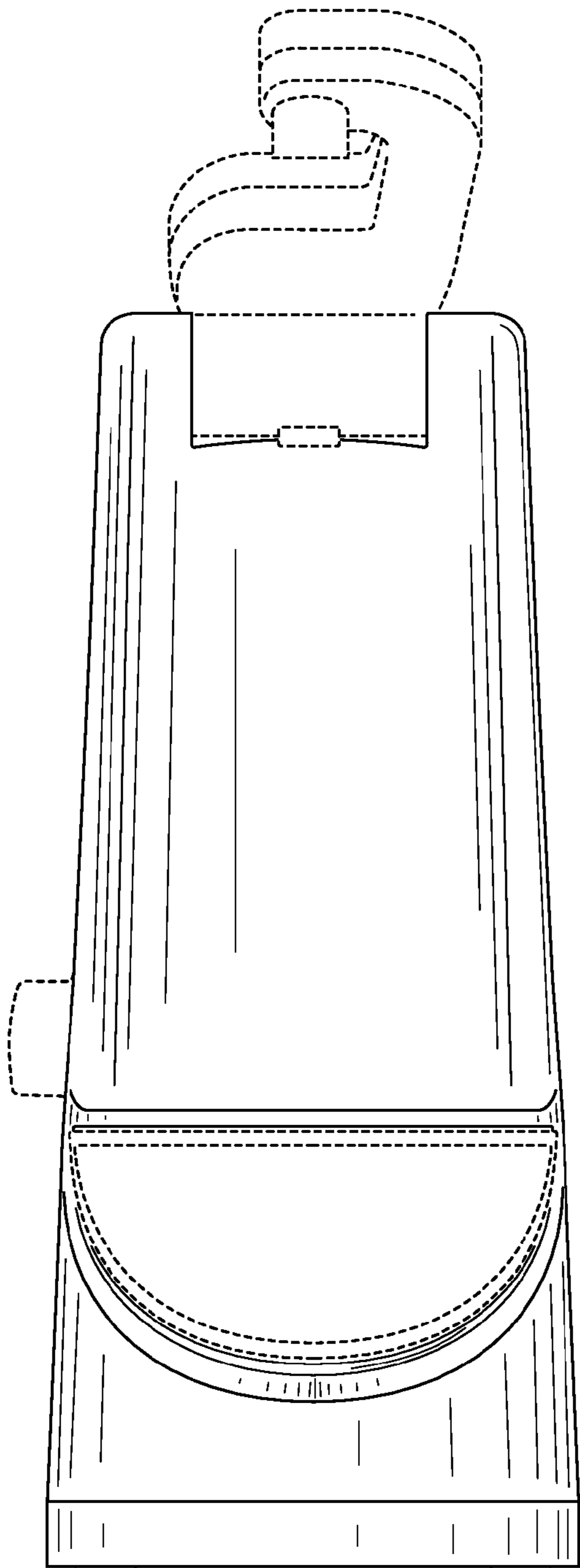

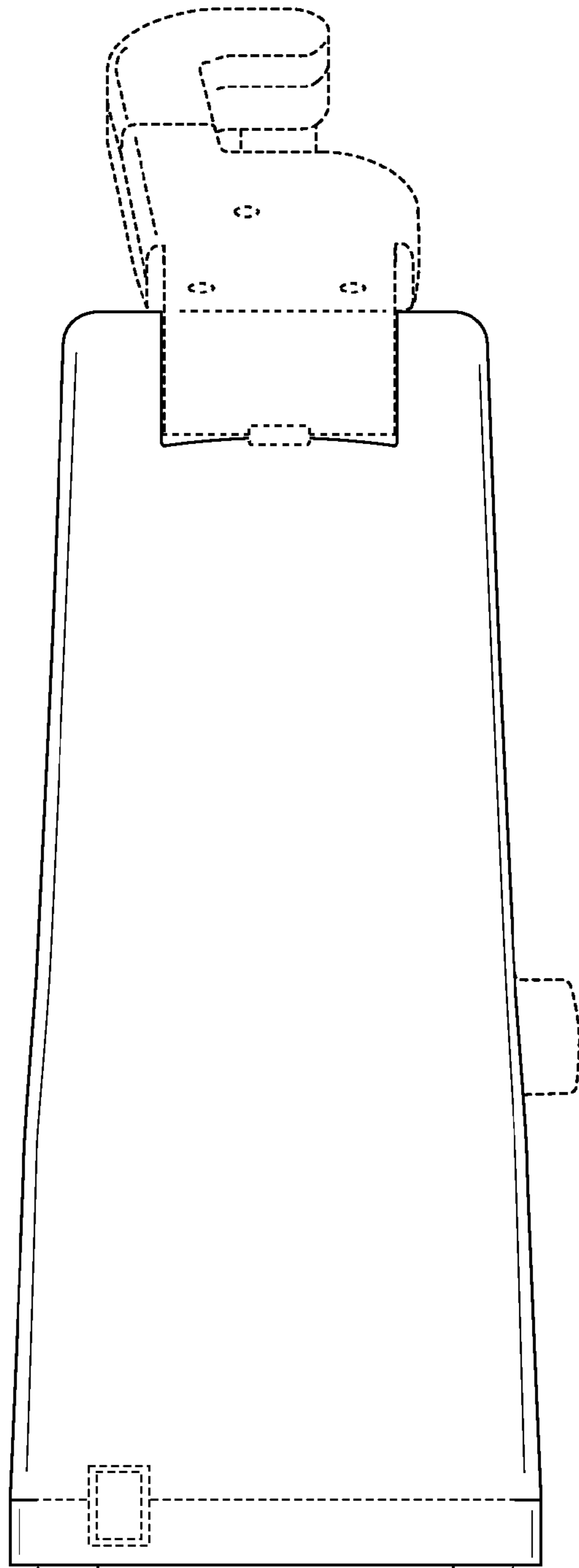

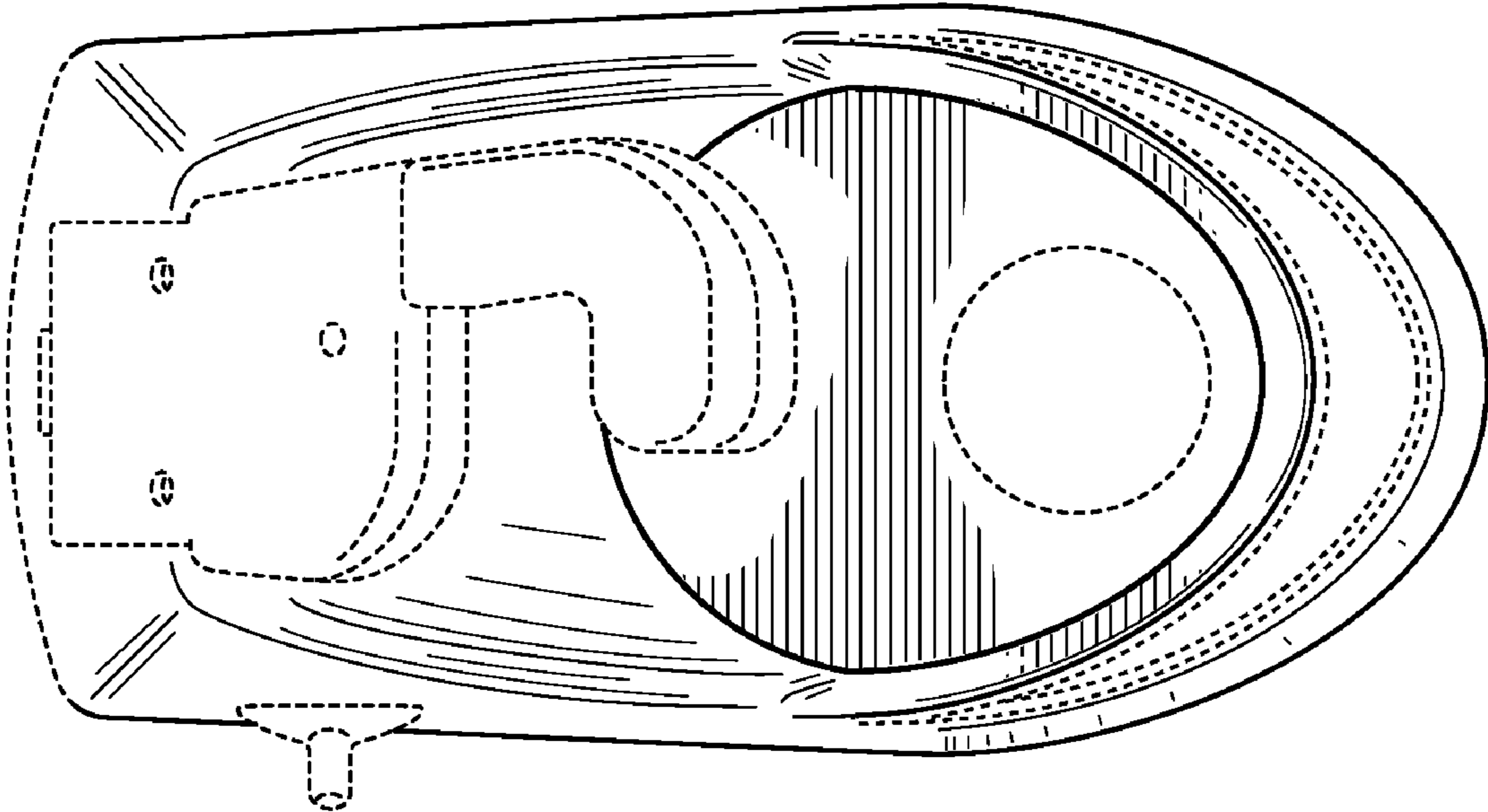

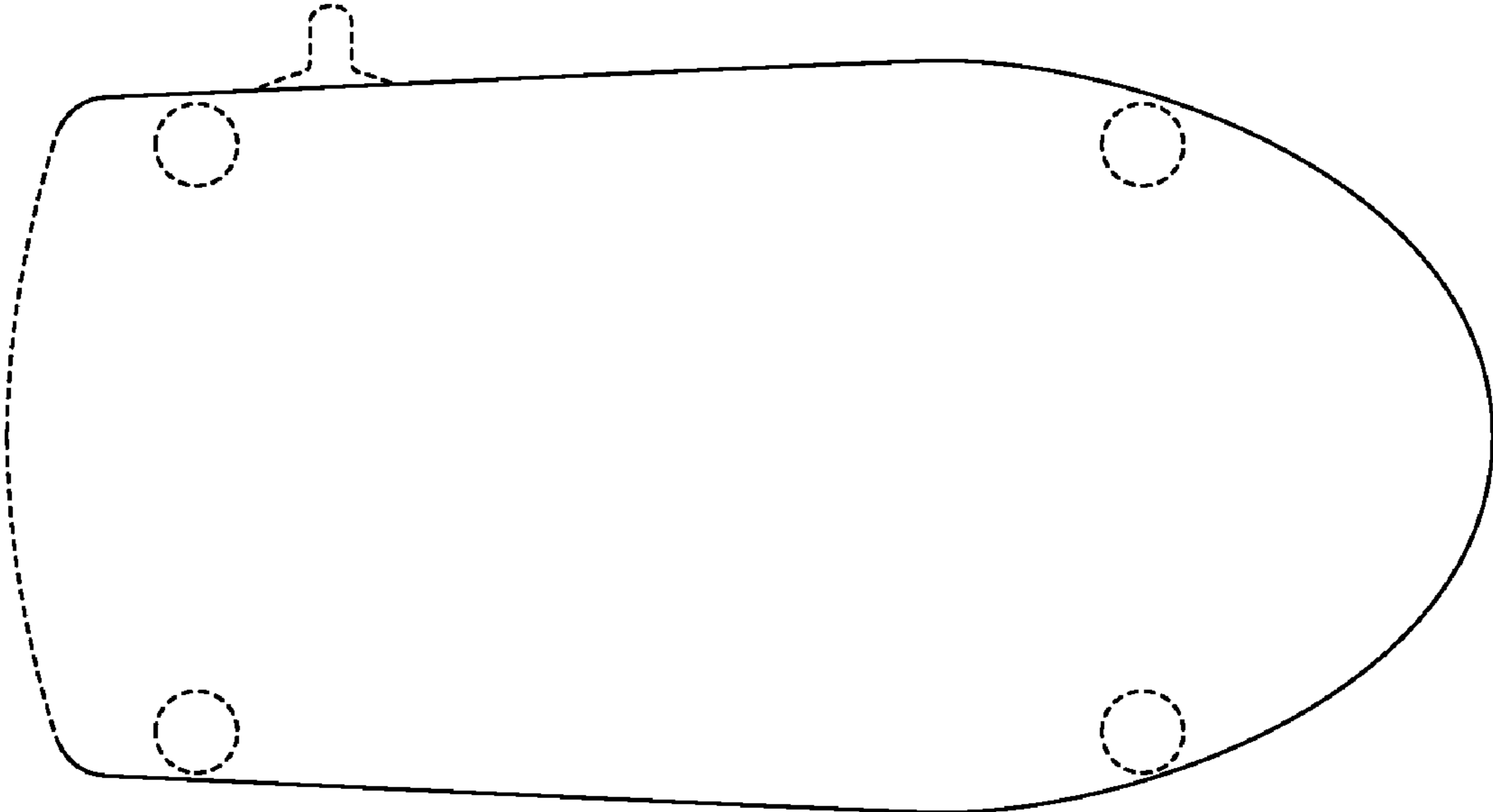
