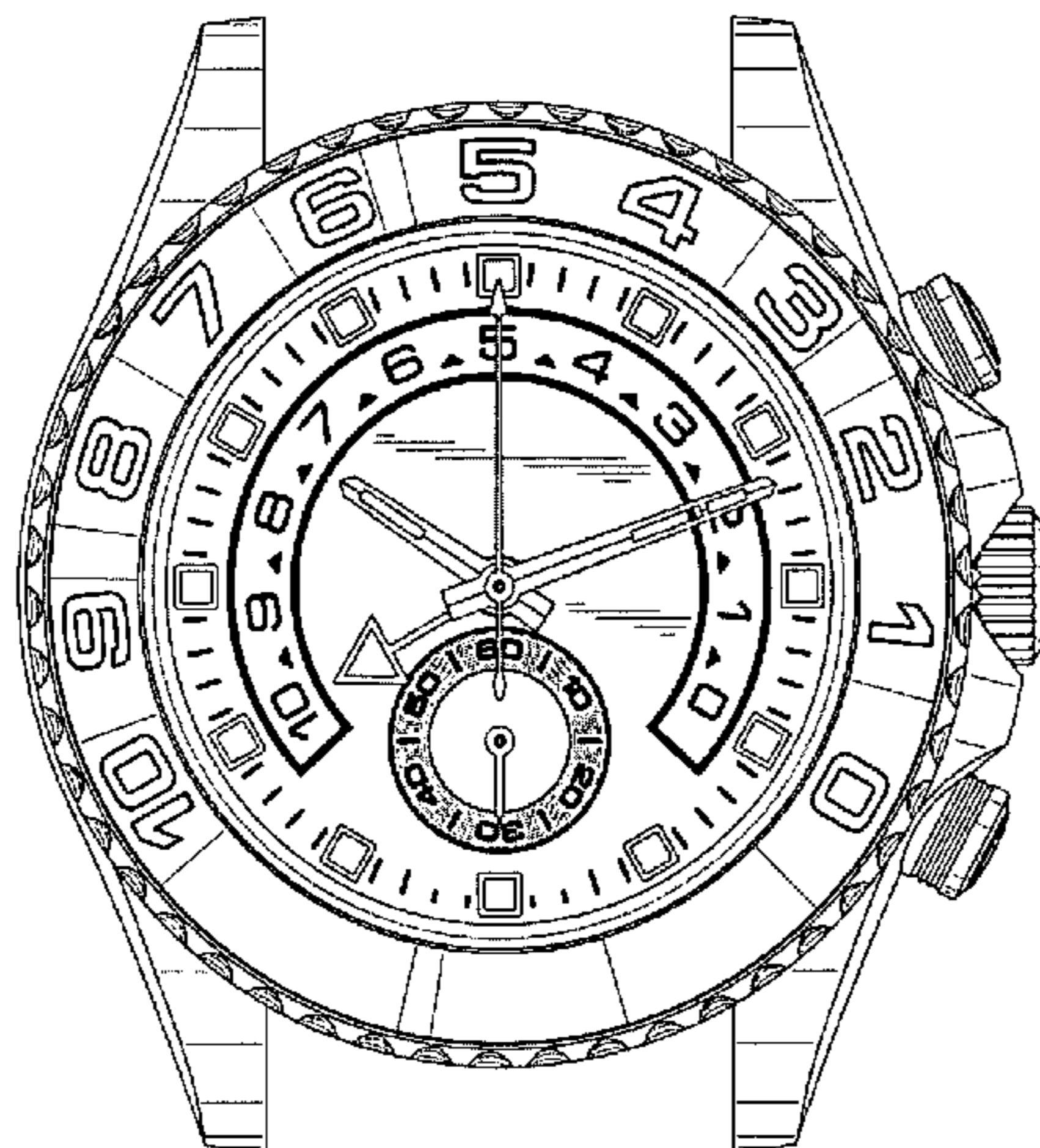
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a watch showing my new design;

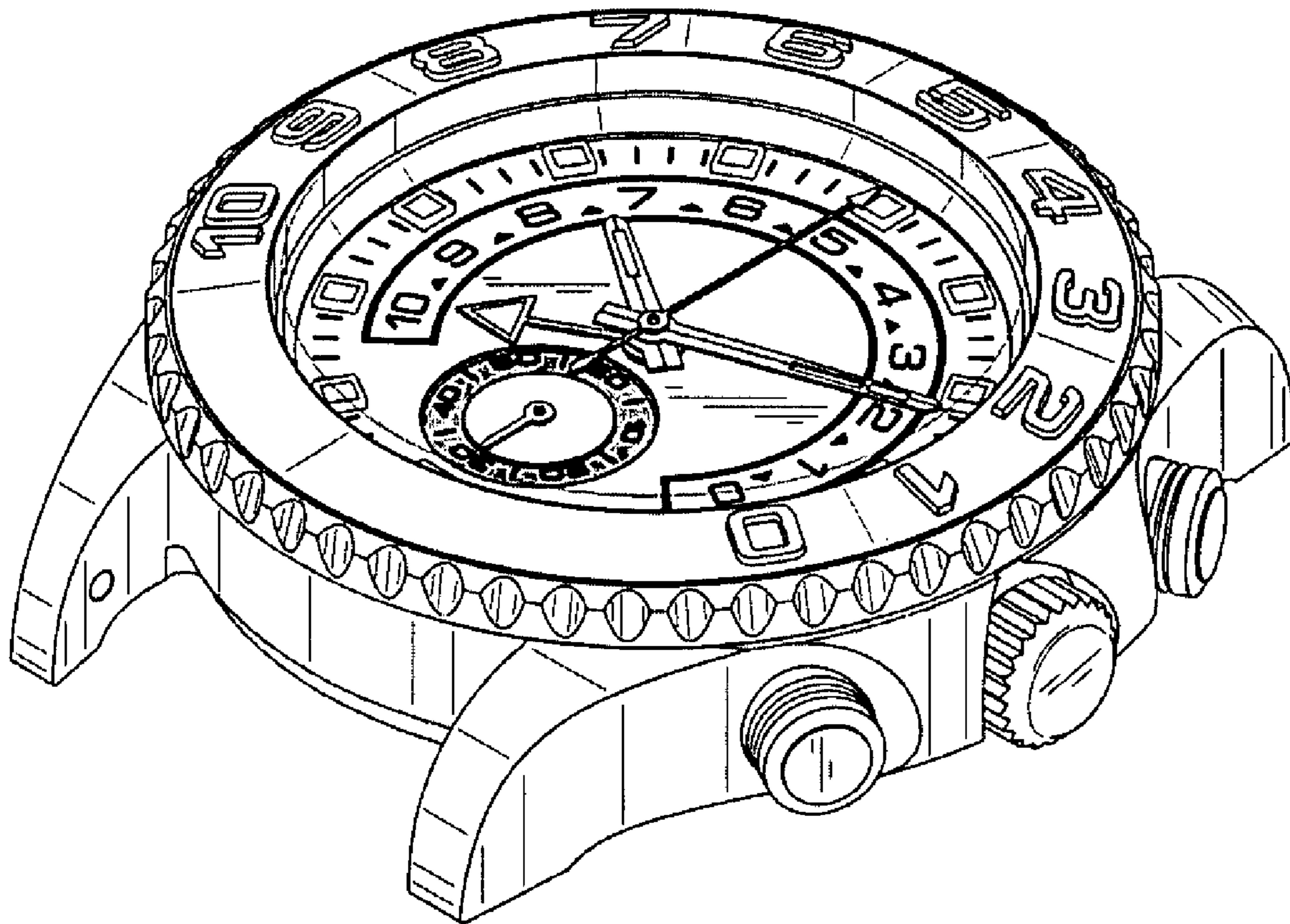

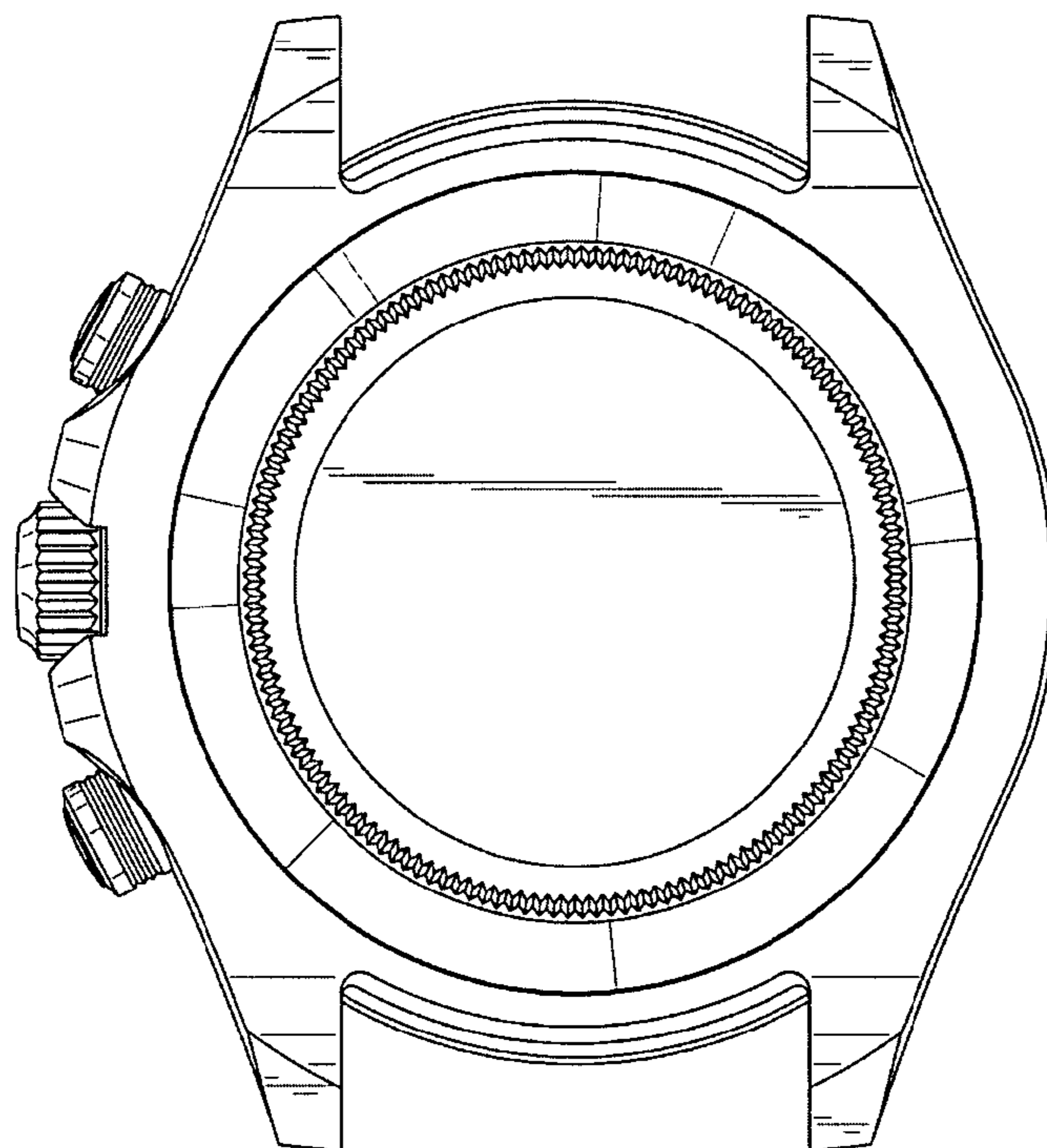

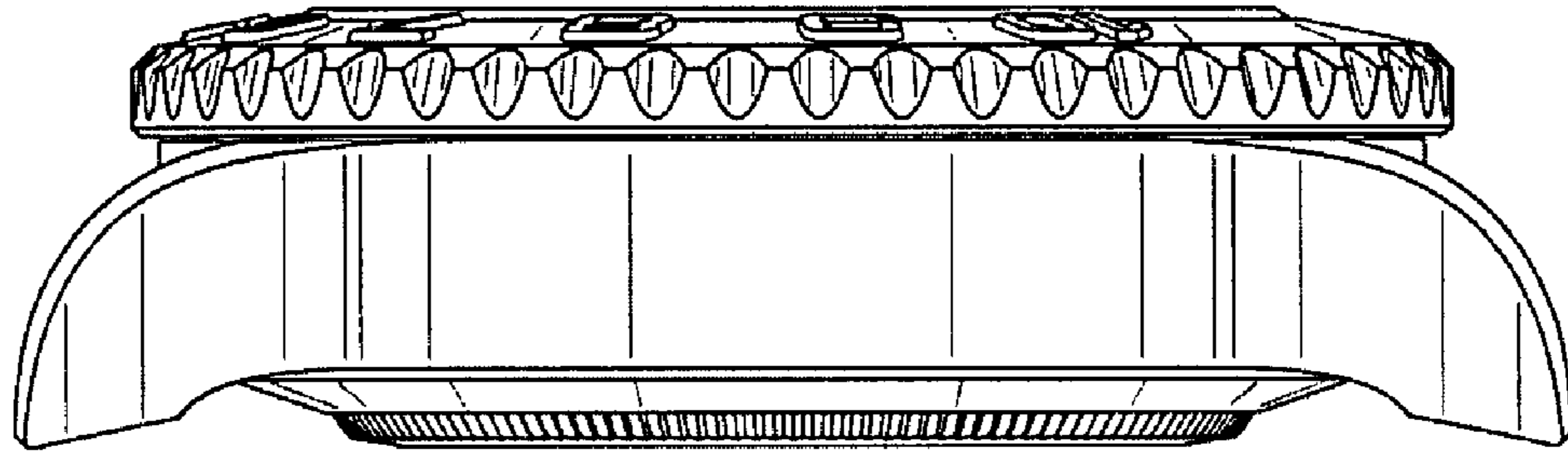

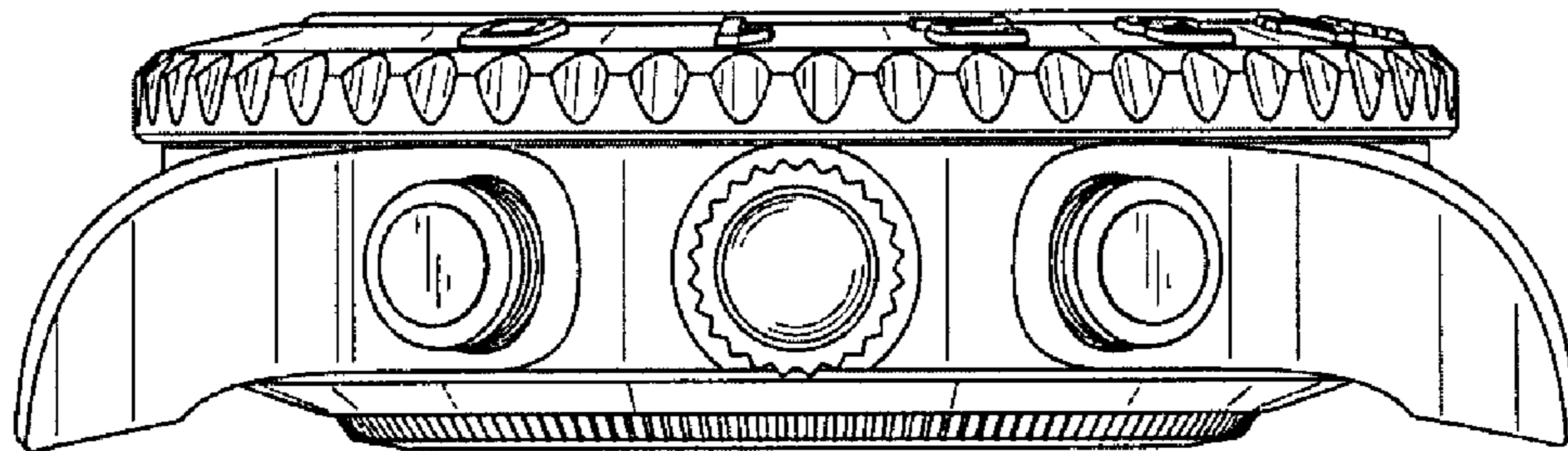

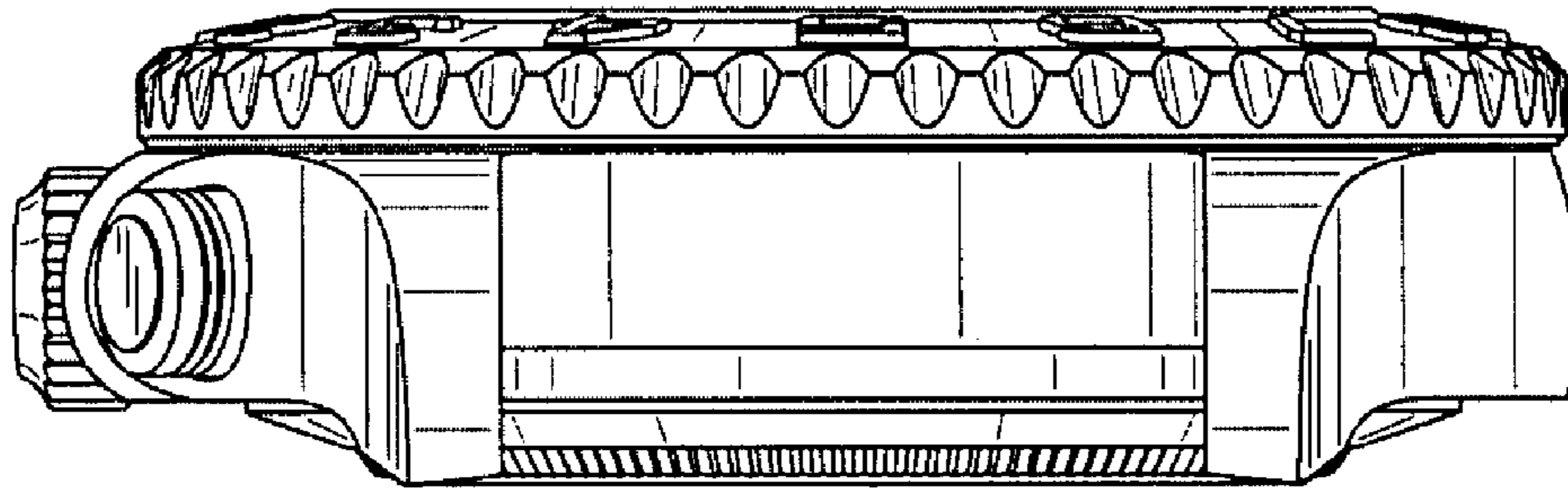

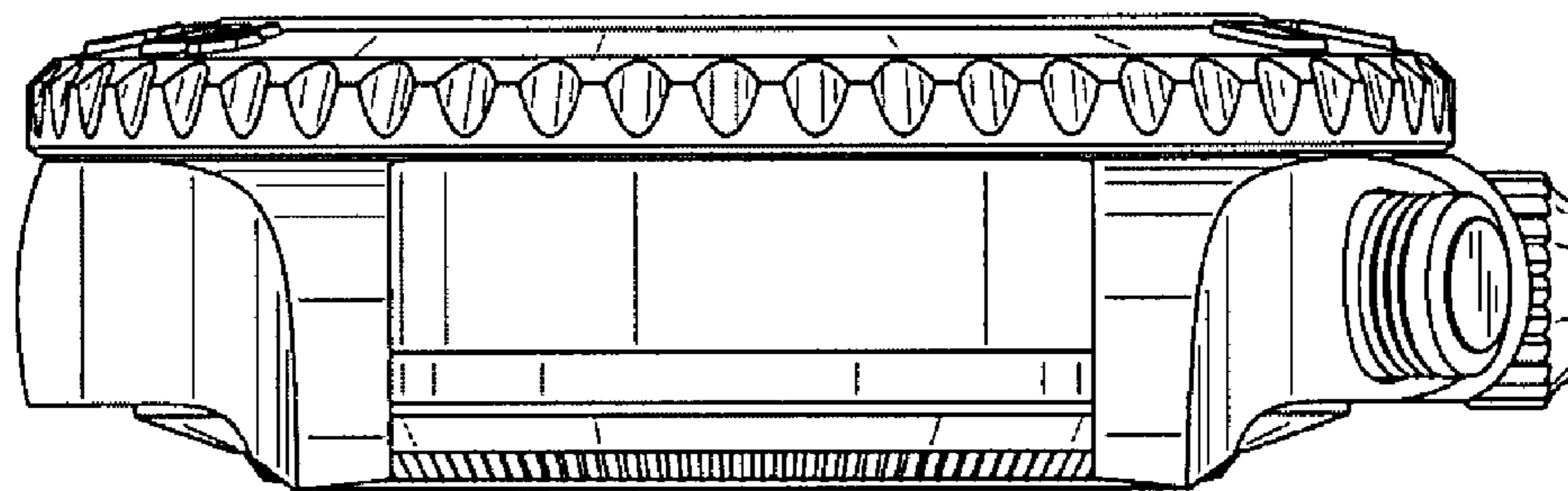
