We claim the ornamental design for a battery for personal computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a battery for personal computer of the present invention;

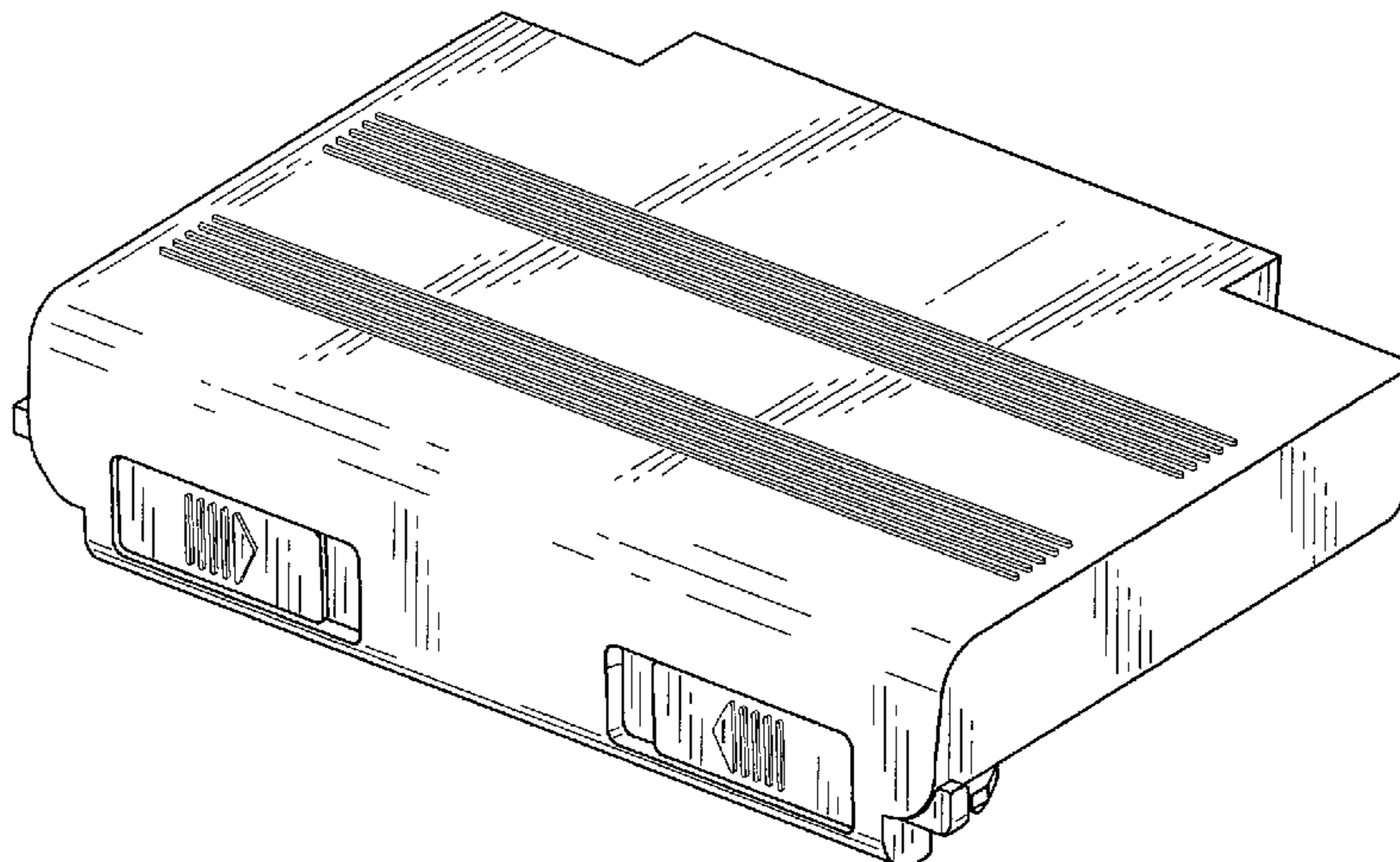

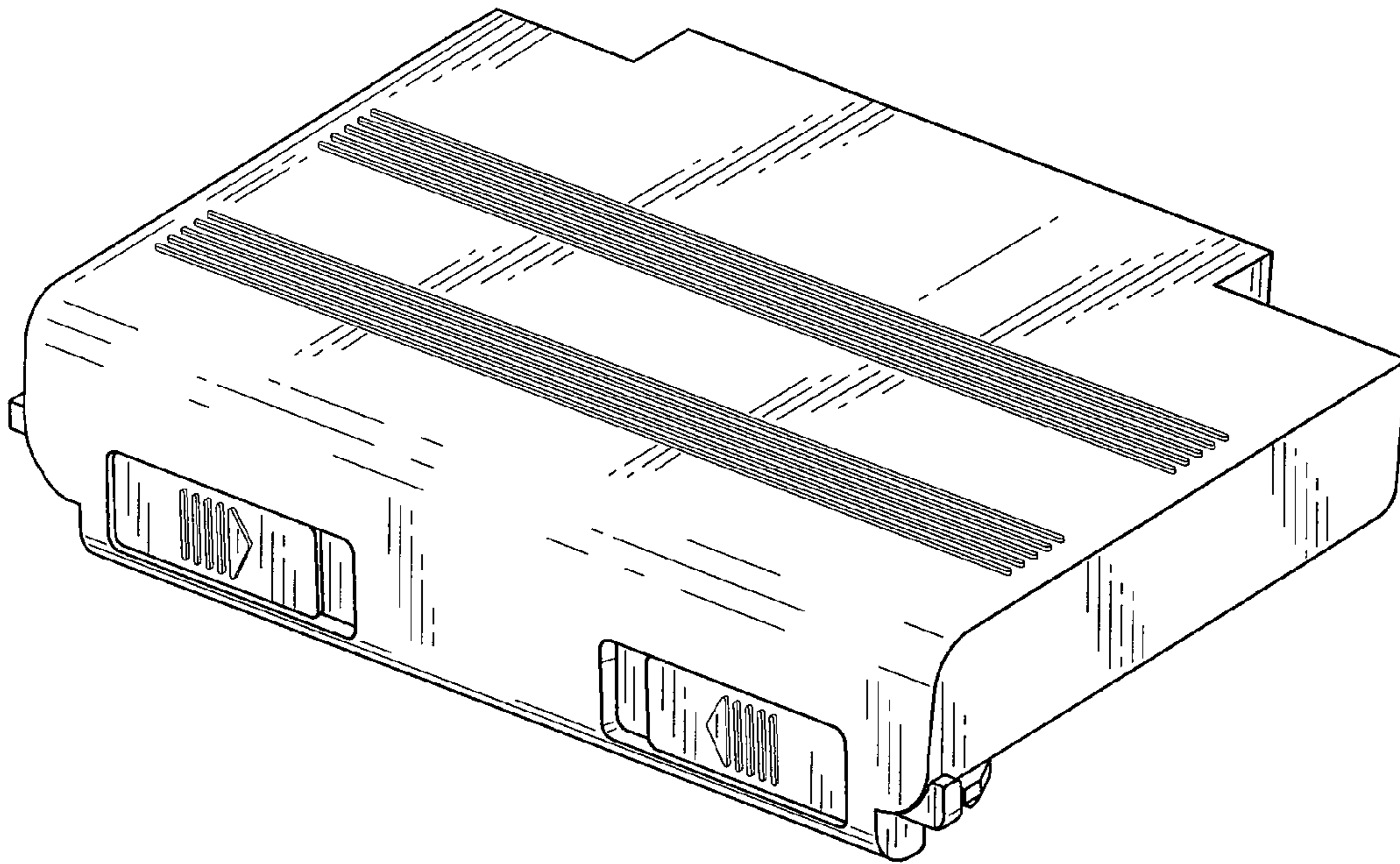

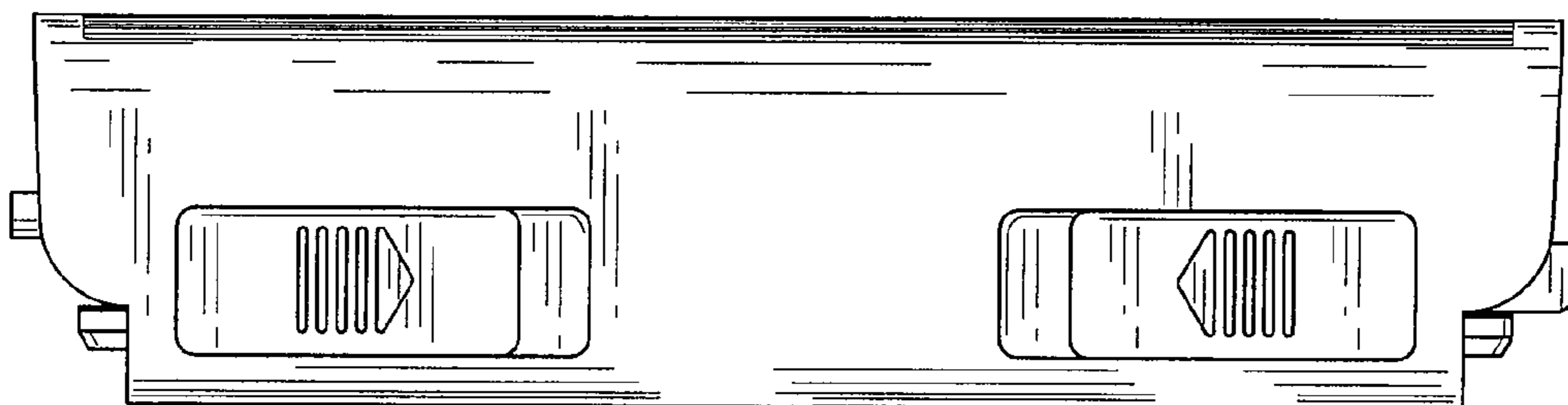

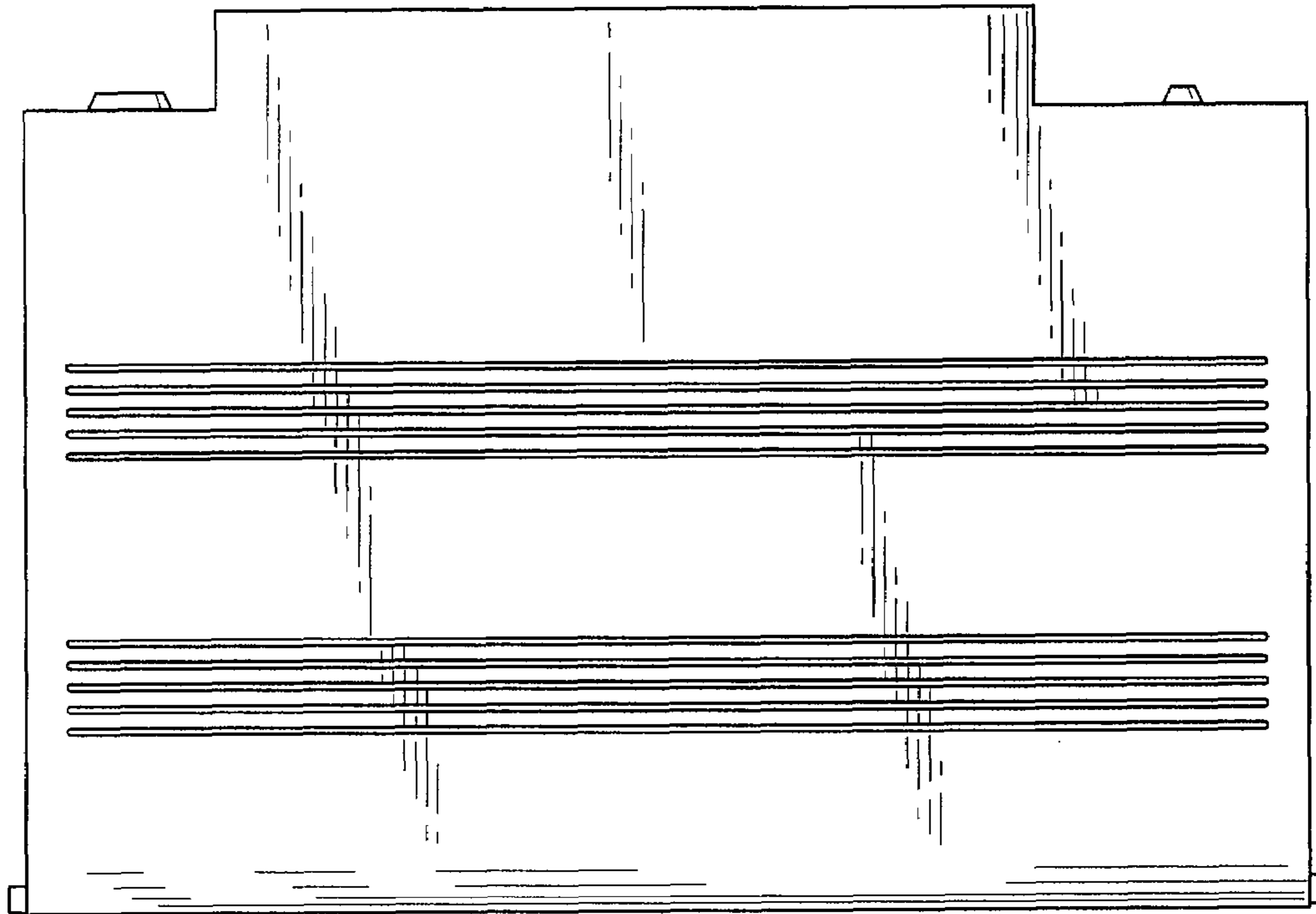

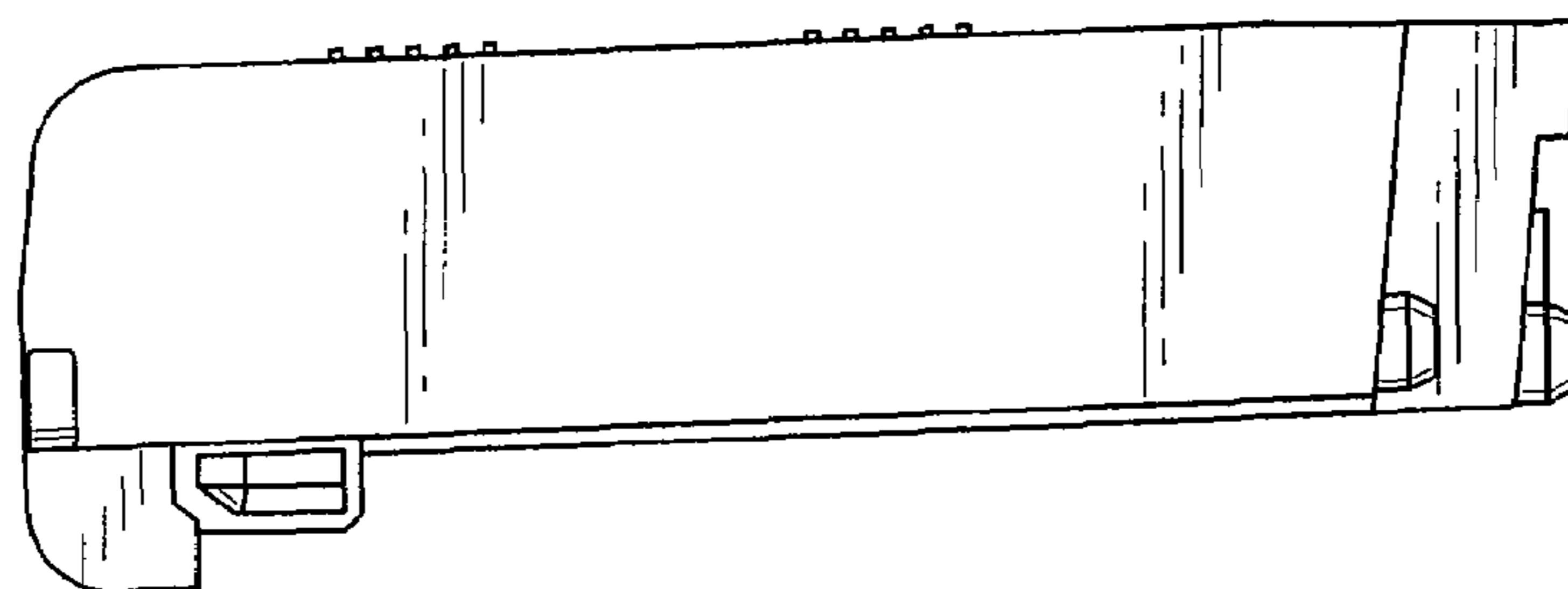

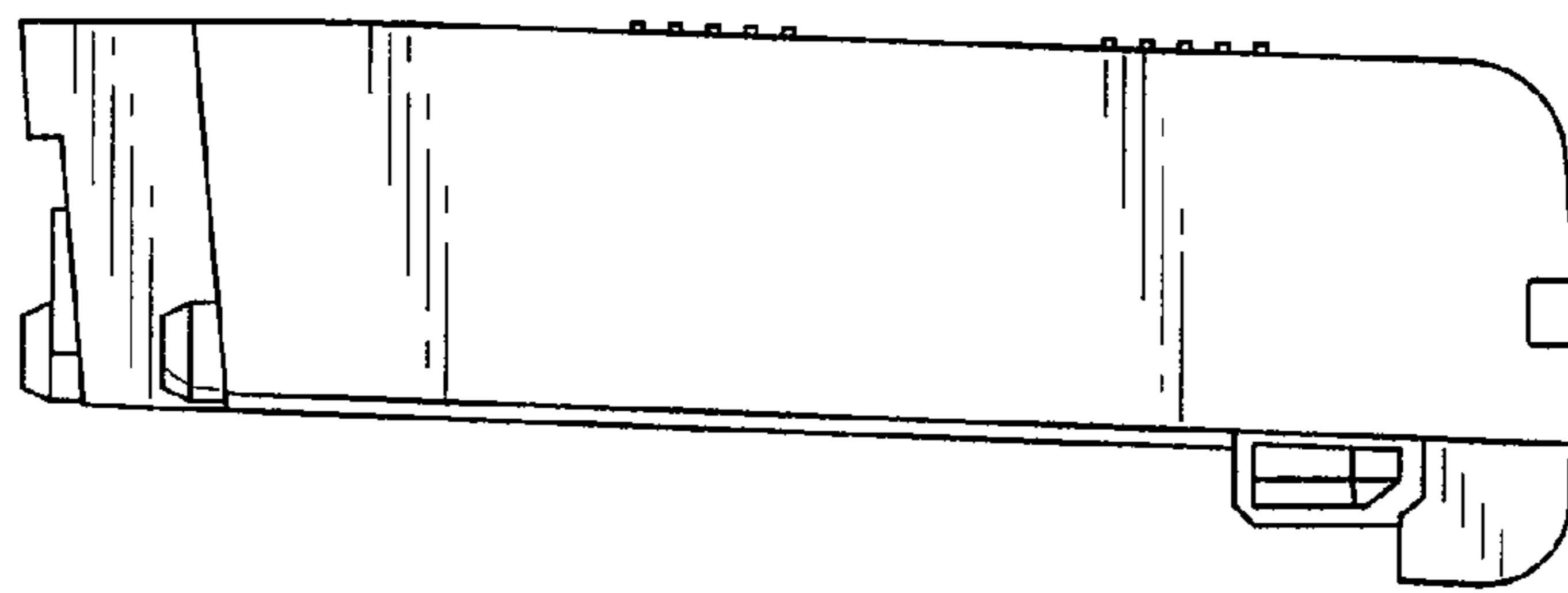

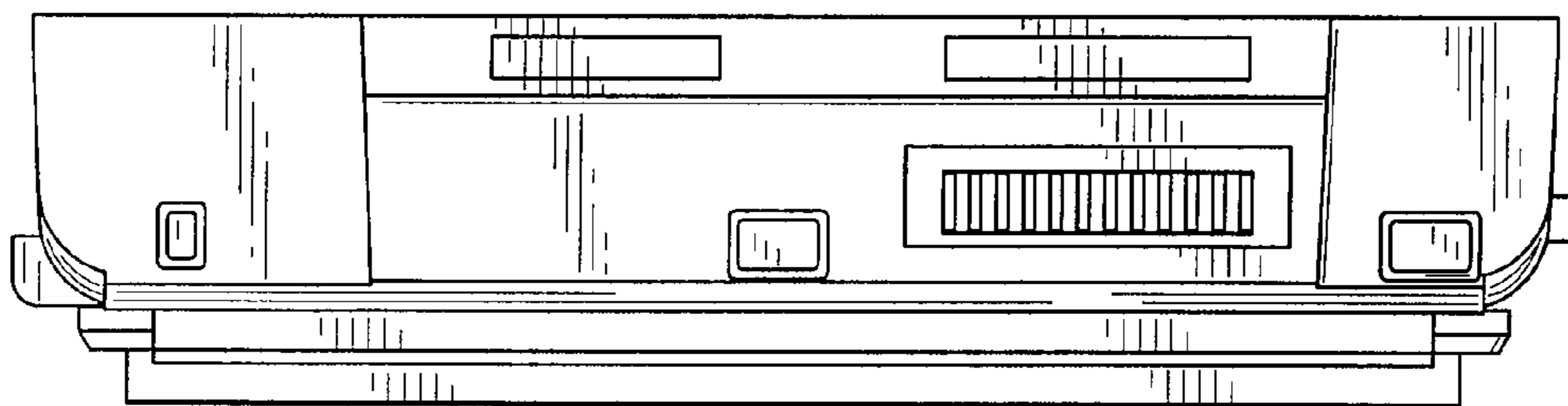

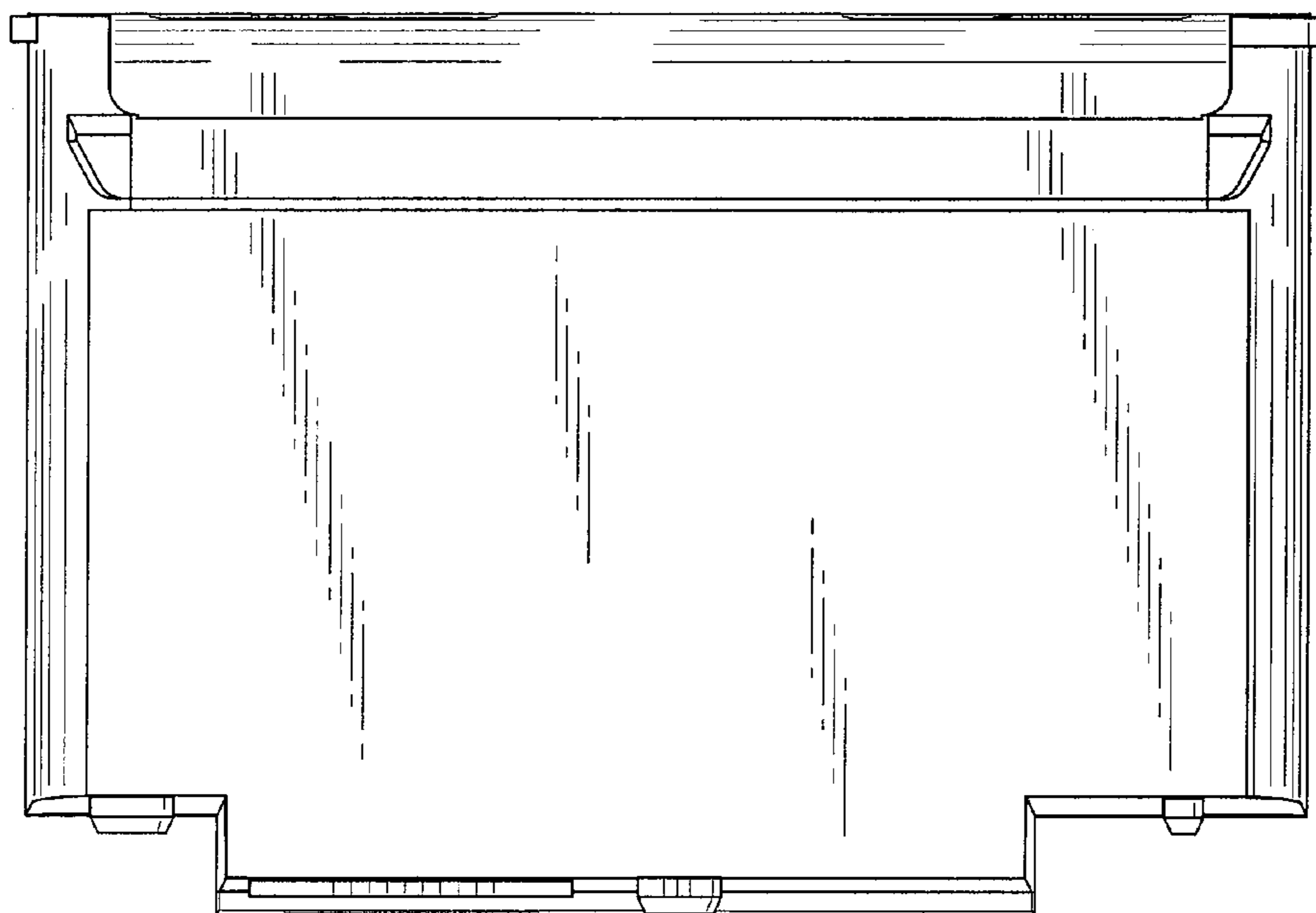
