FIG. 4 is a left side view;

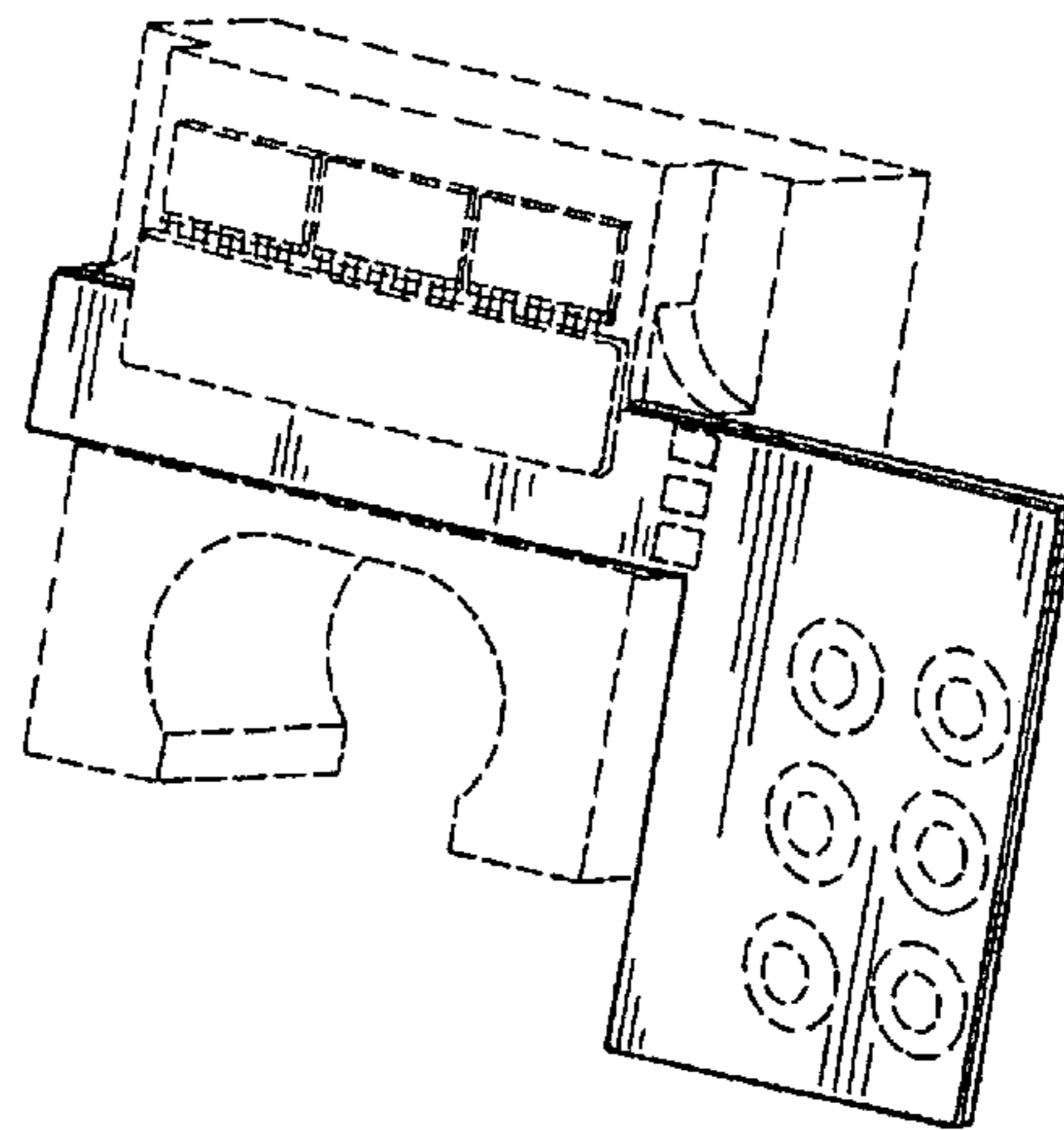
FIG. 5 is a front view;

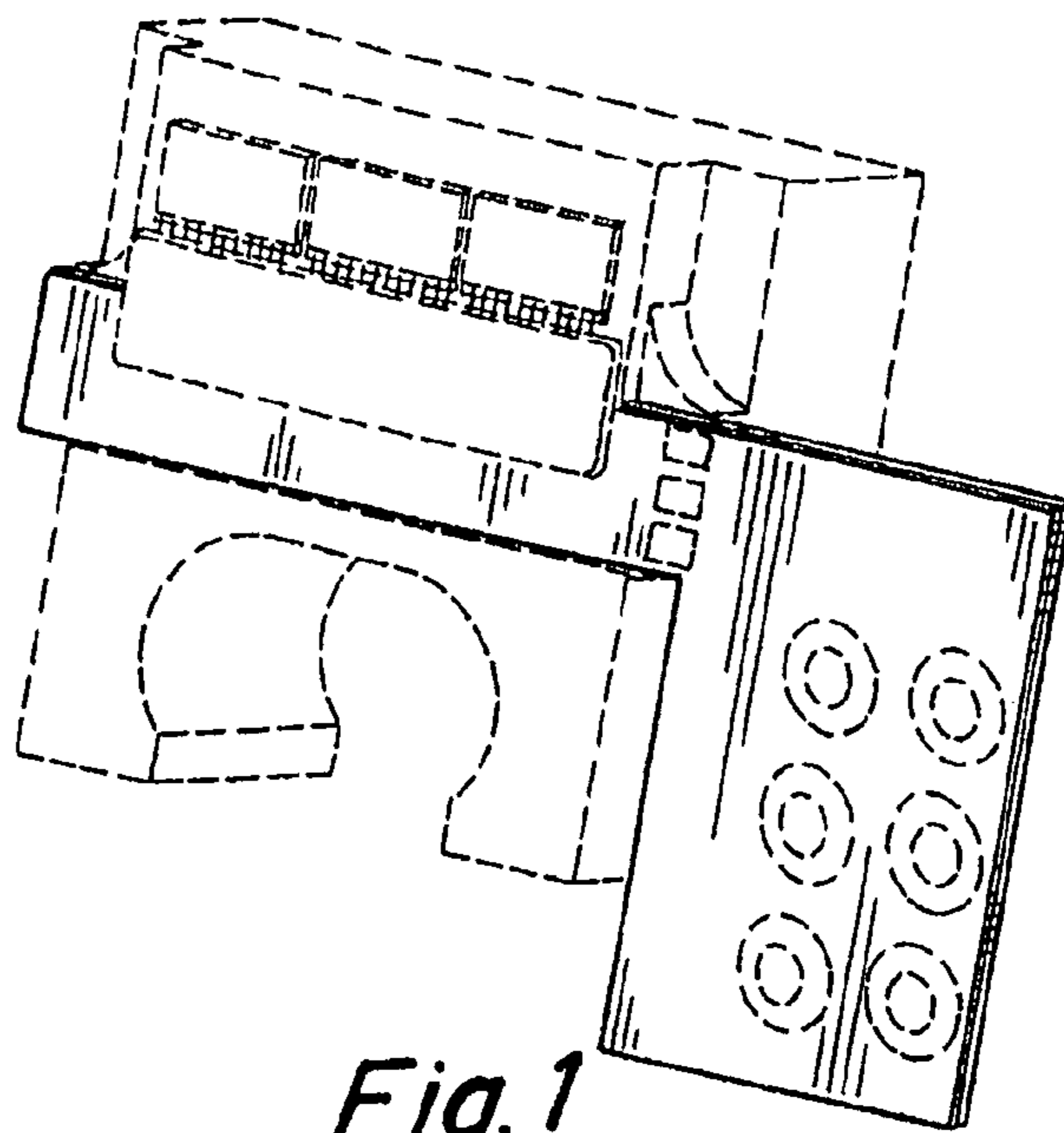

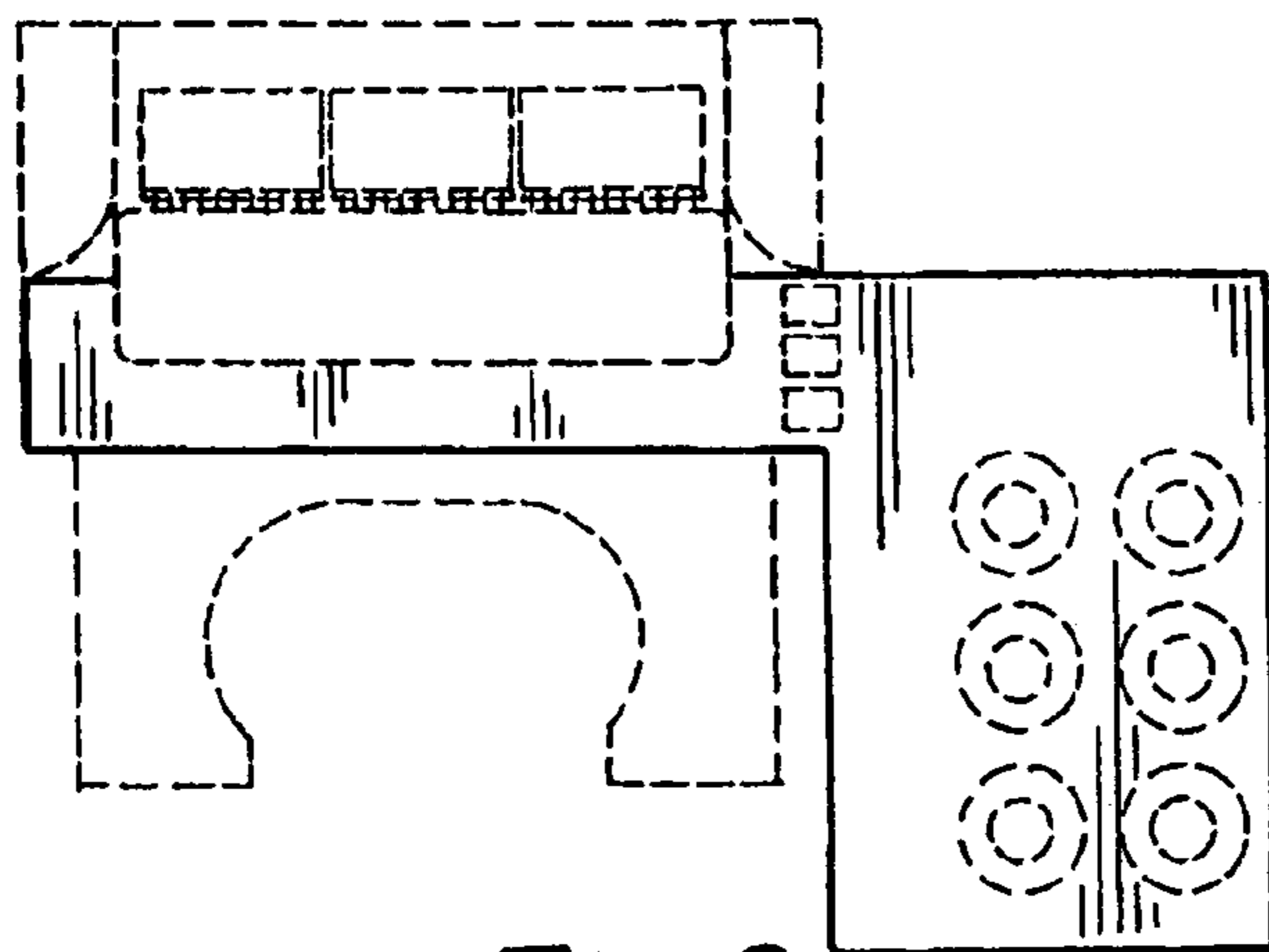

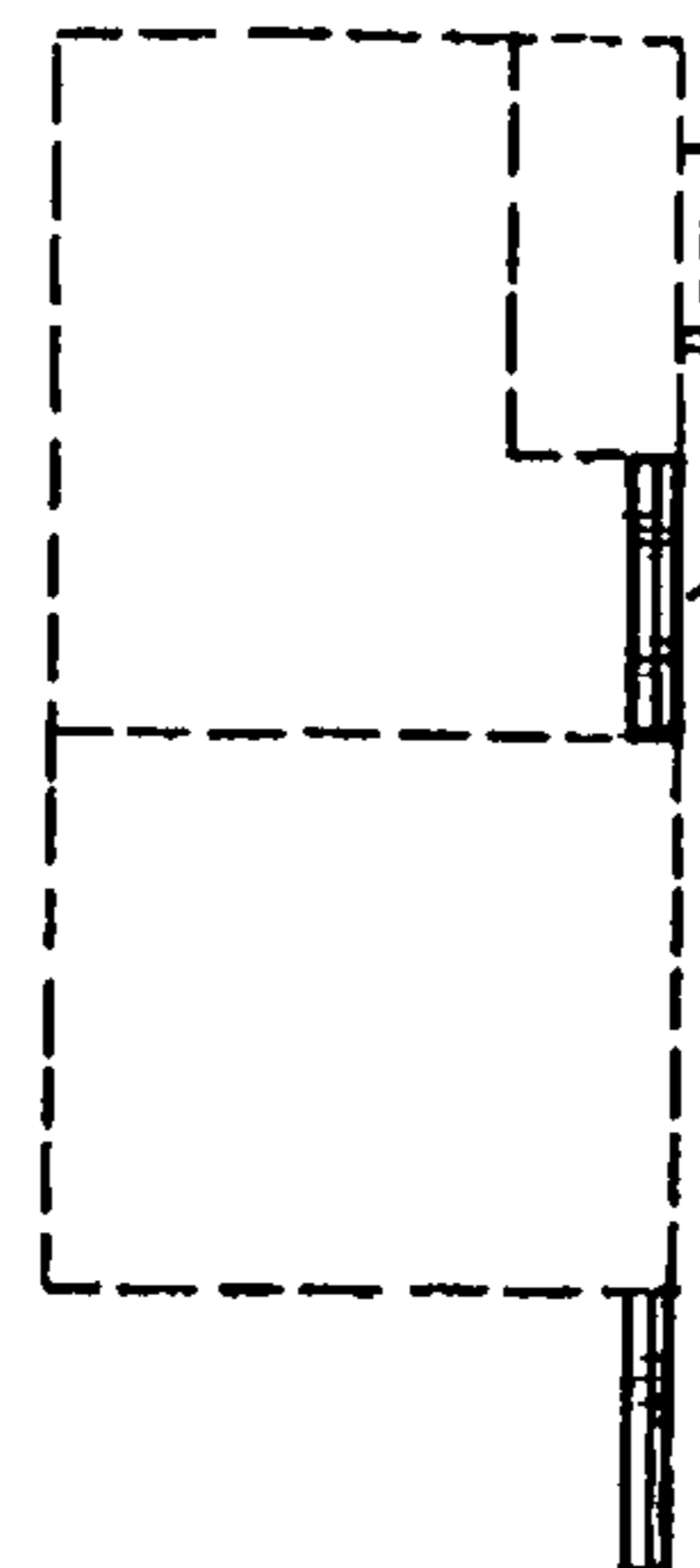

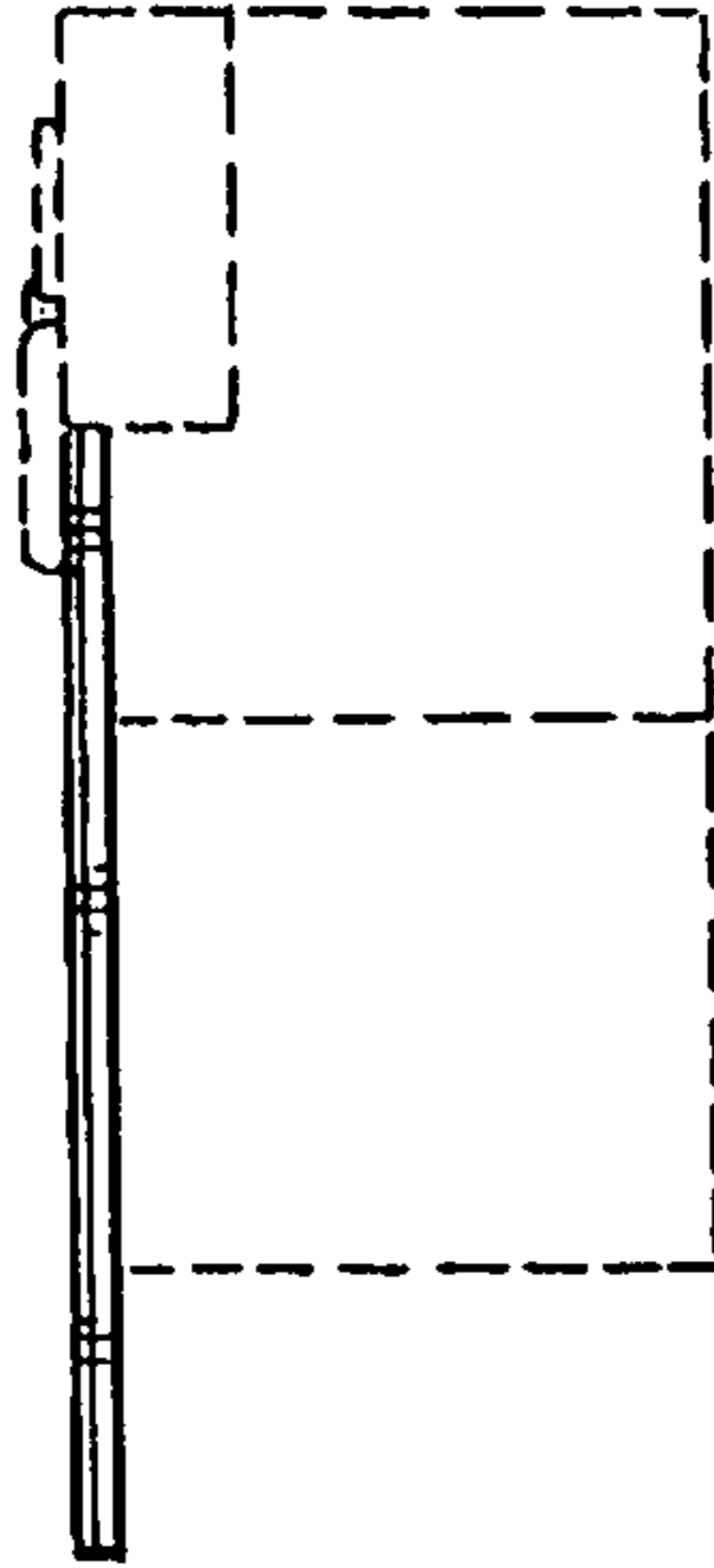

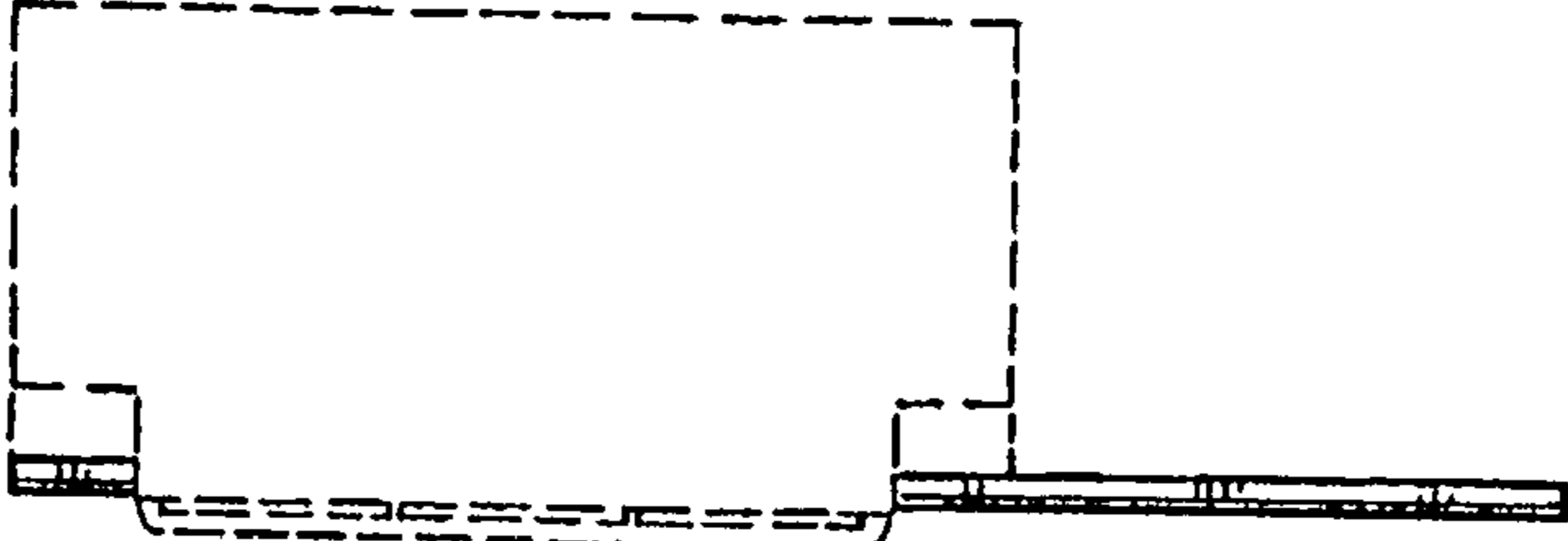

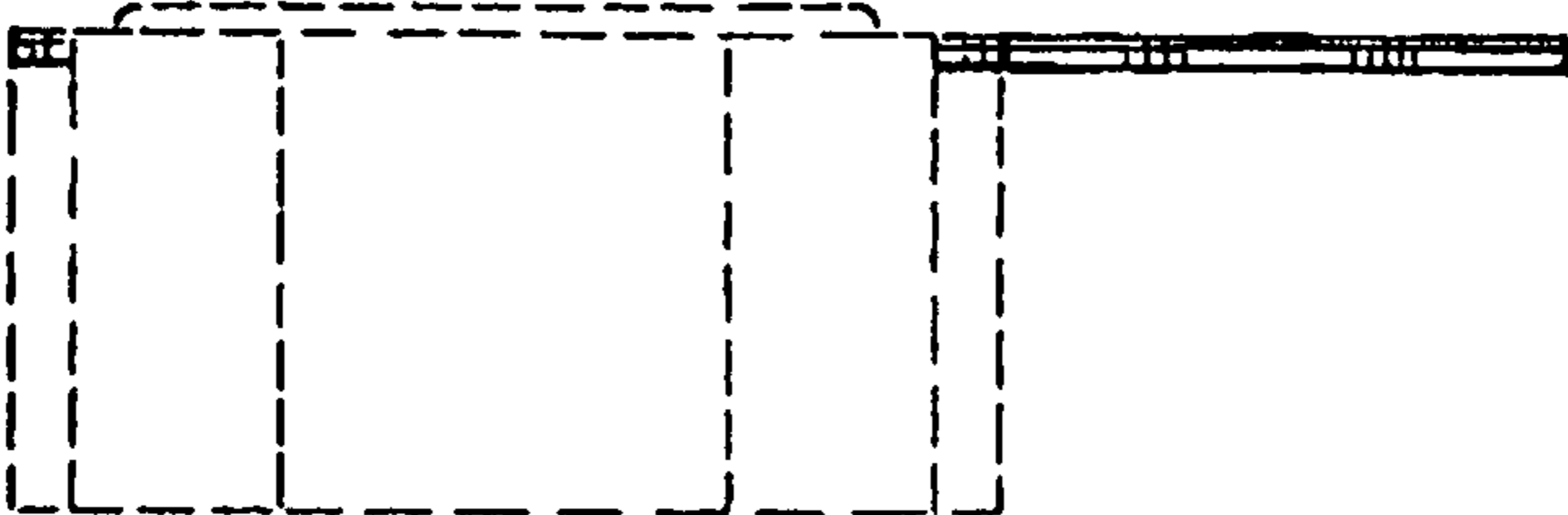

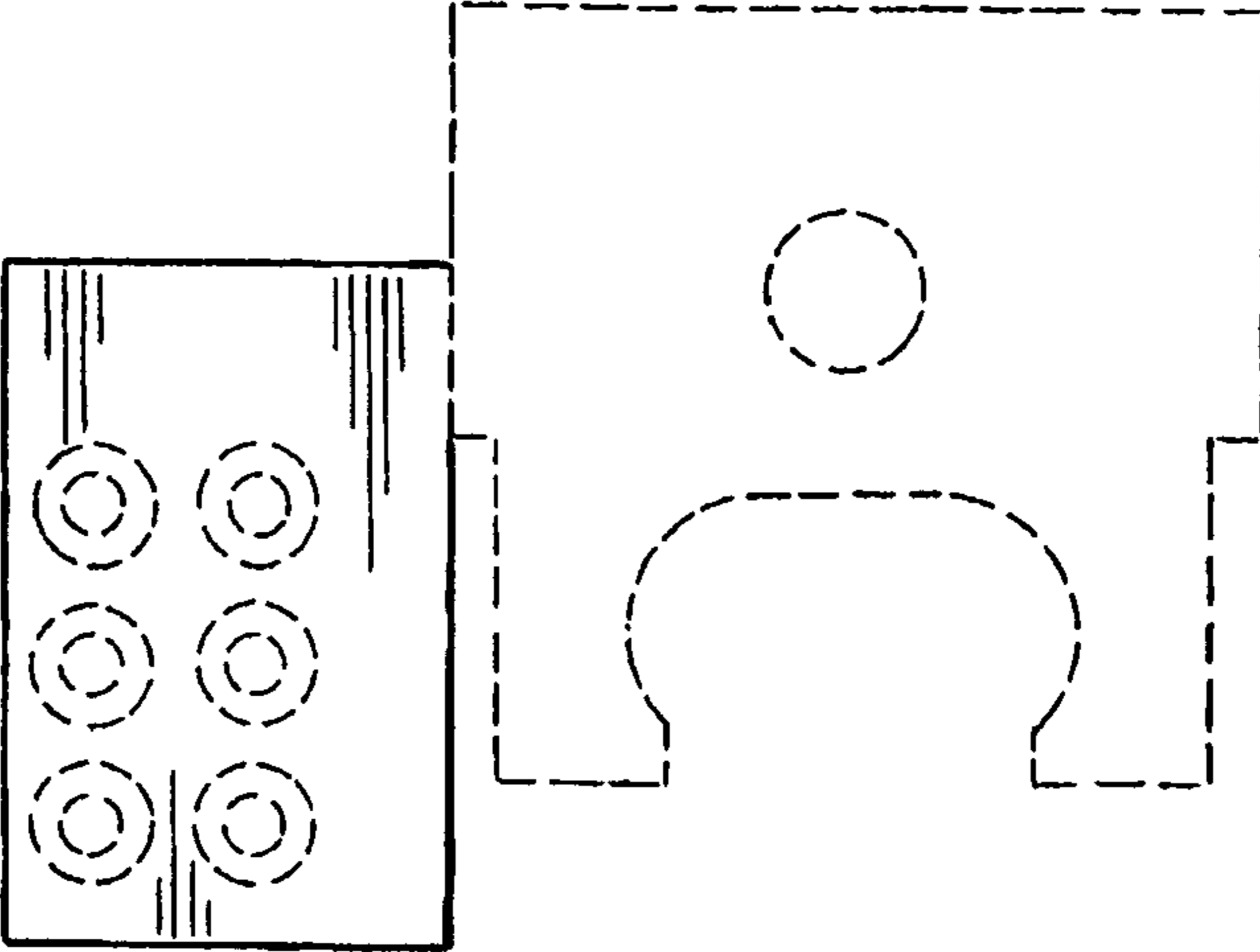
