DESCRIPTION

FIG. 1 is a perspective view of a mobile phone;
FIG. 2 is a front view of the mobile phone of FIG. 1;
FIG. 3 is a rear view of the mobile phone of FIG. 1;
FIG. 4 is left-side of the mobile phone of FIG. 1;
FIG. 5 is right-side of the mobile phone of FIG. 1;

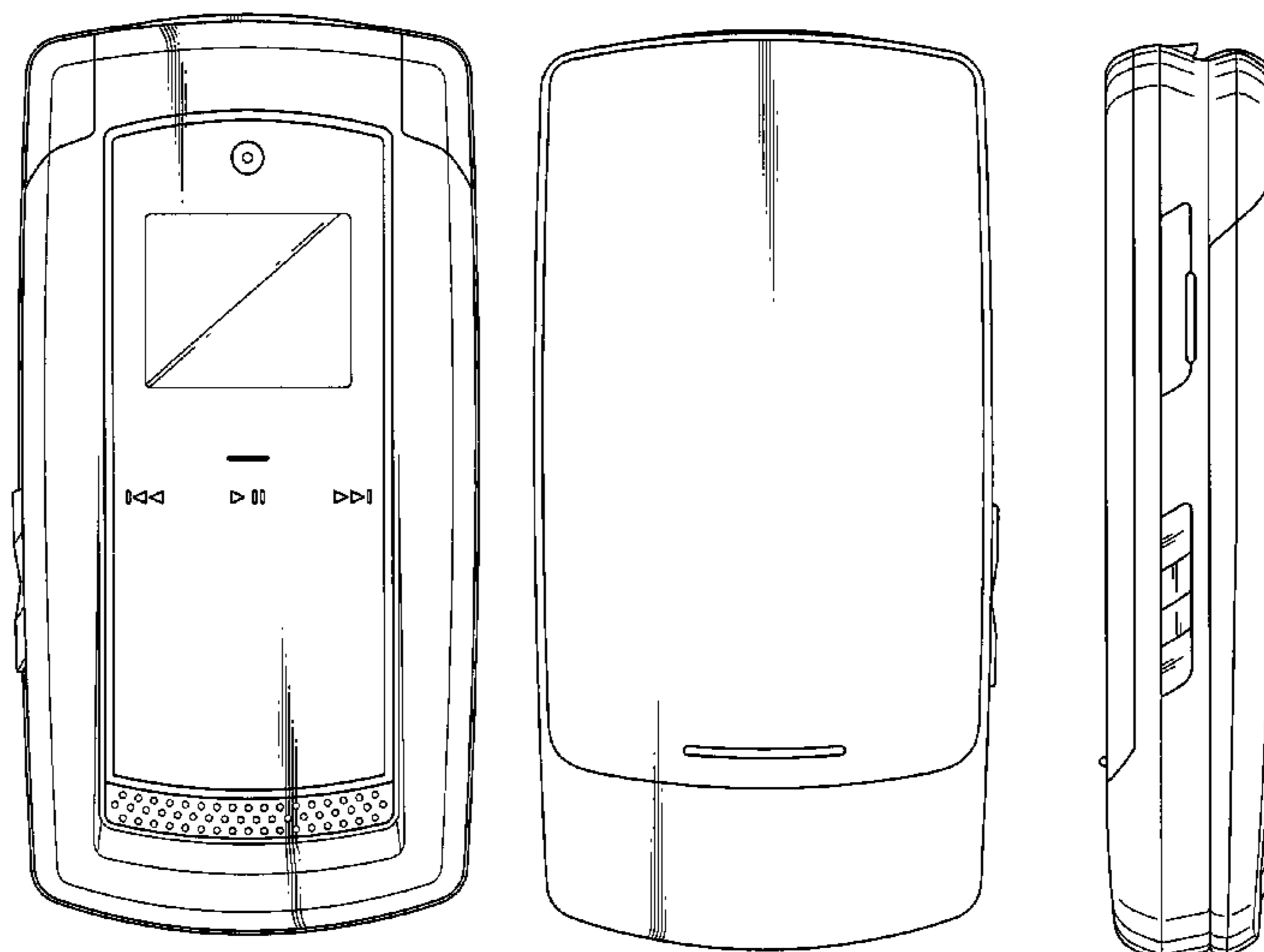

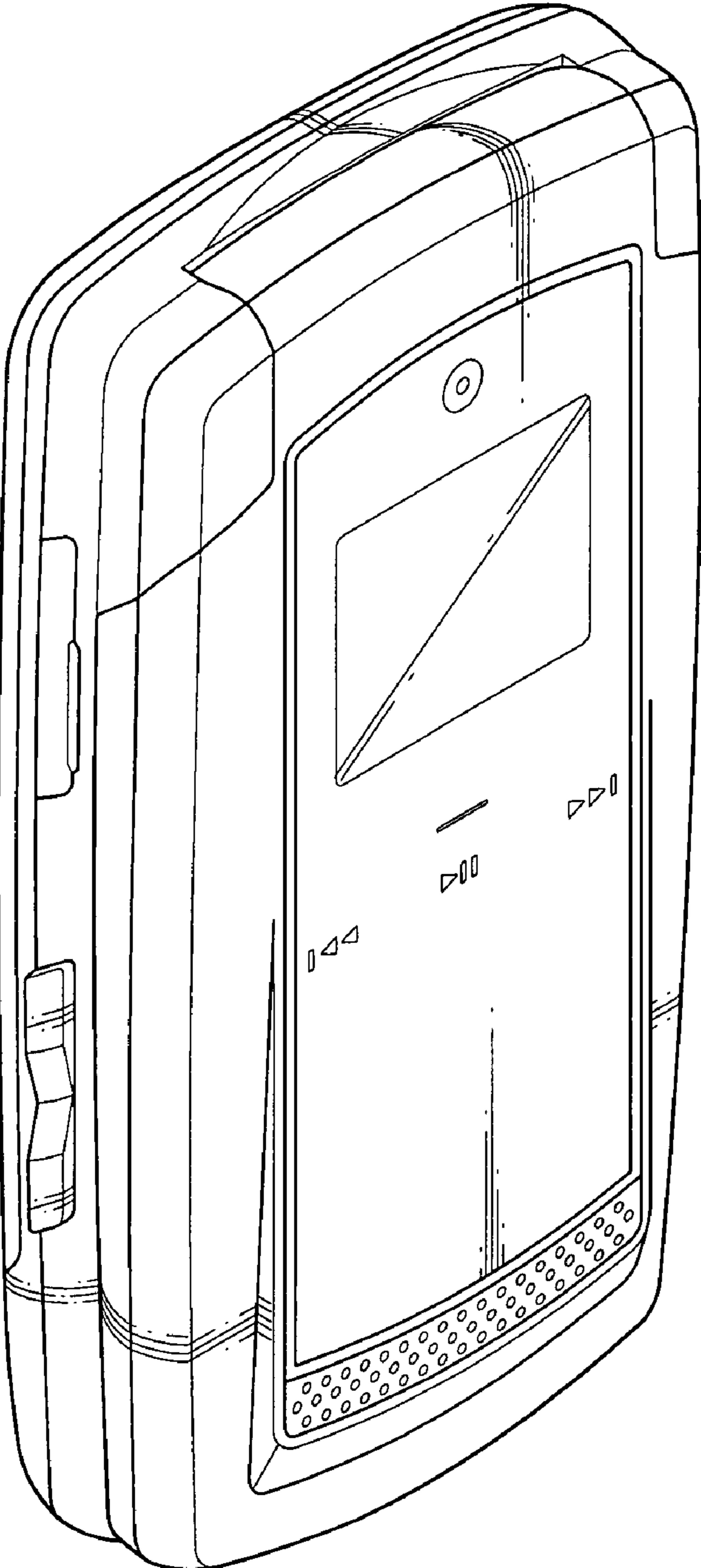

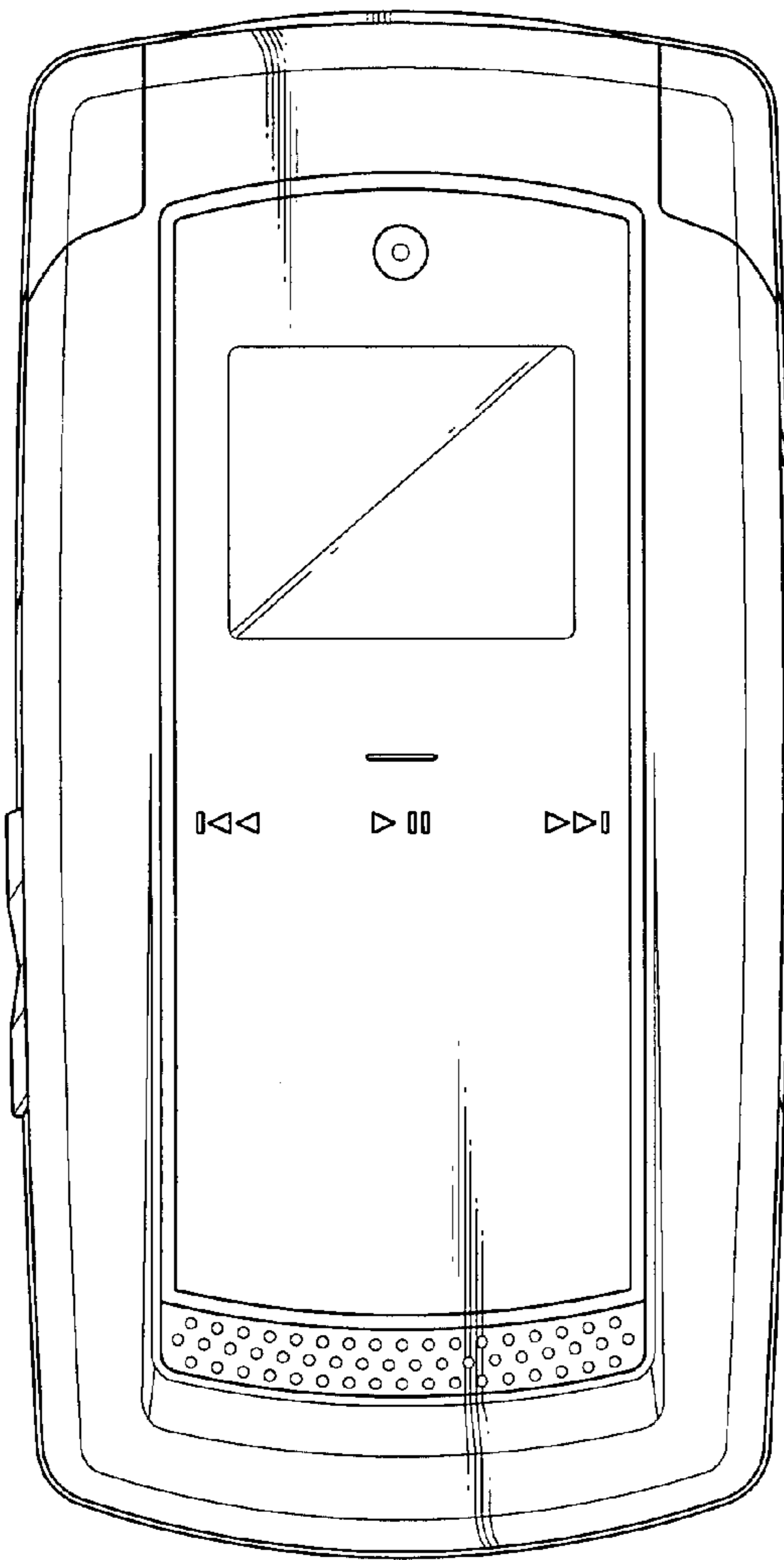

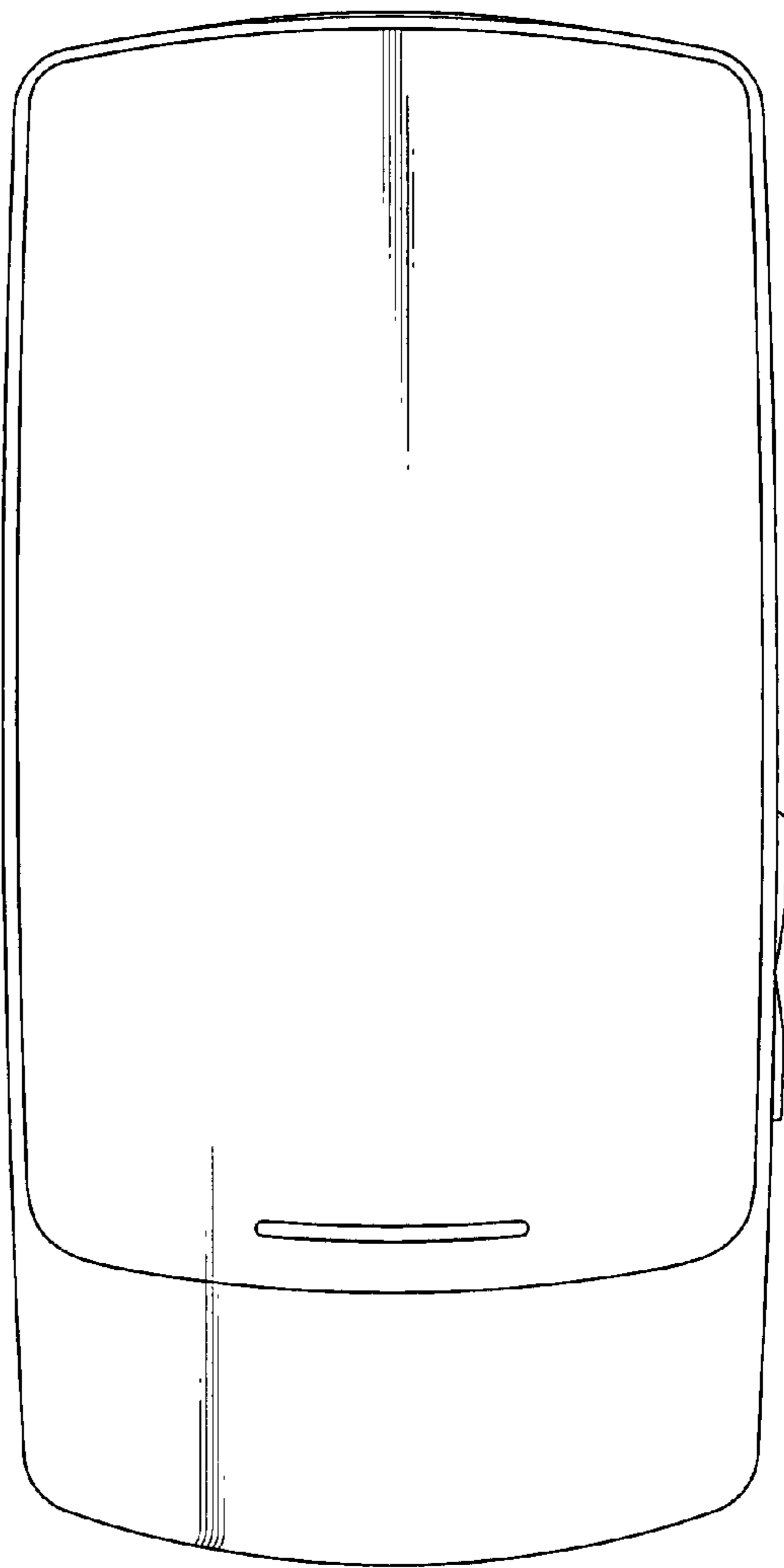

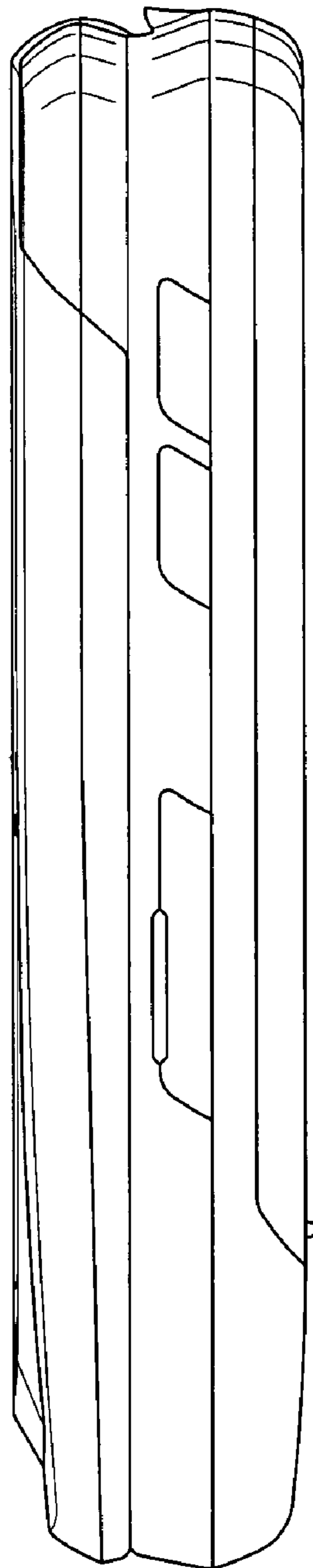
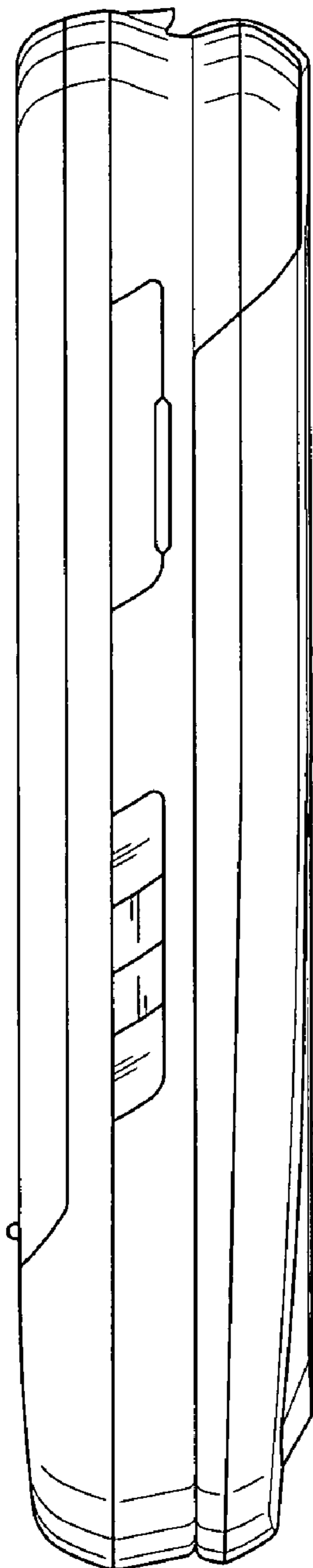

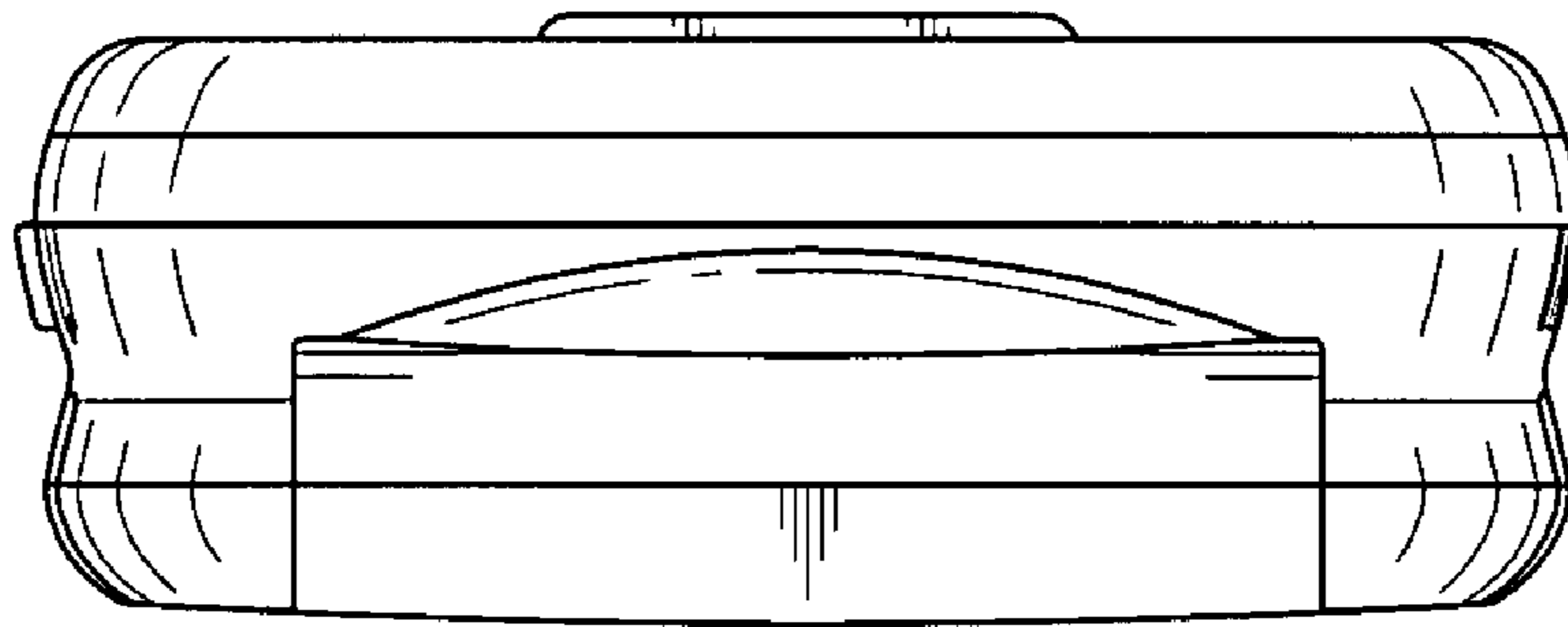
