DESCRIPTION

FIG. 3 is a side view of a breathable gas dispenser according to an embodiment of the invention.

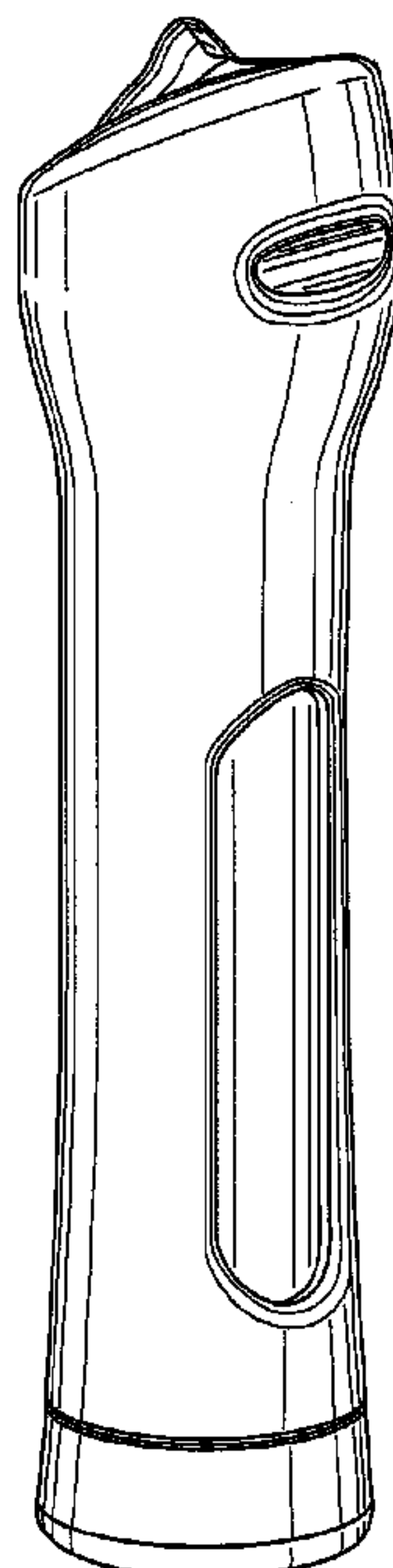

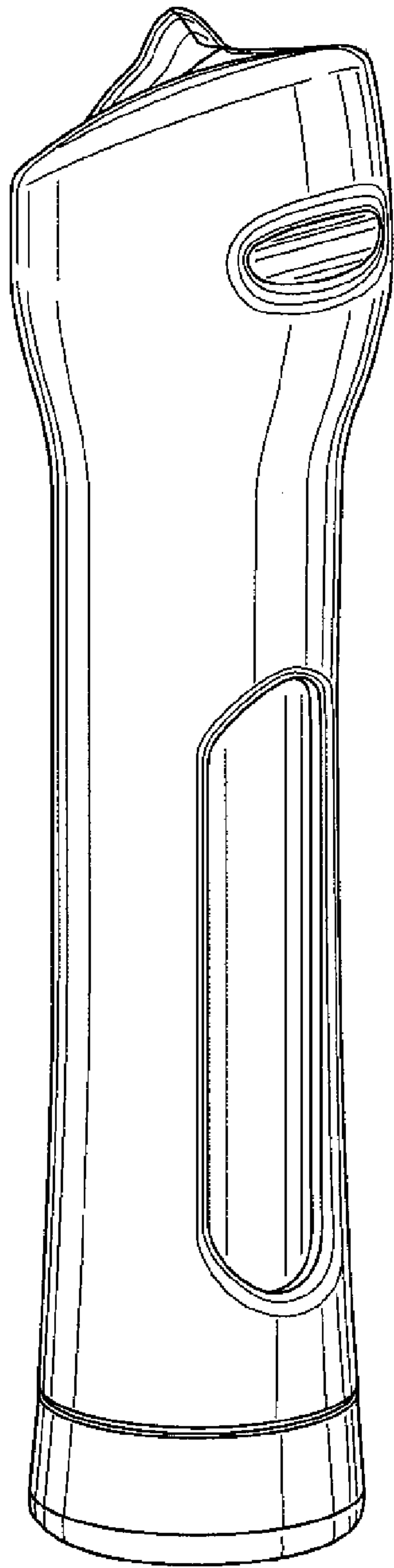

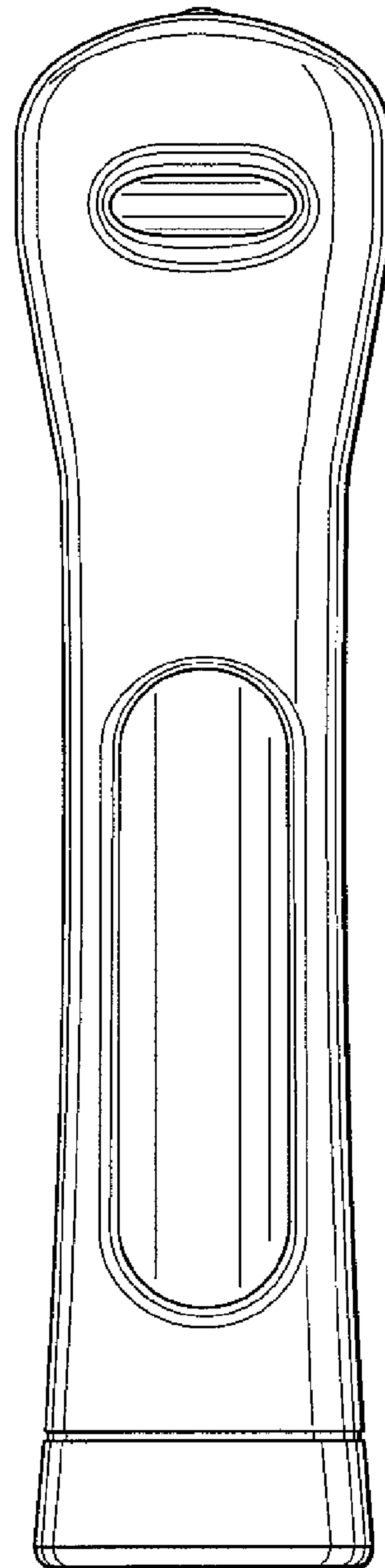

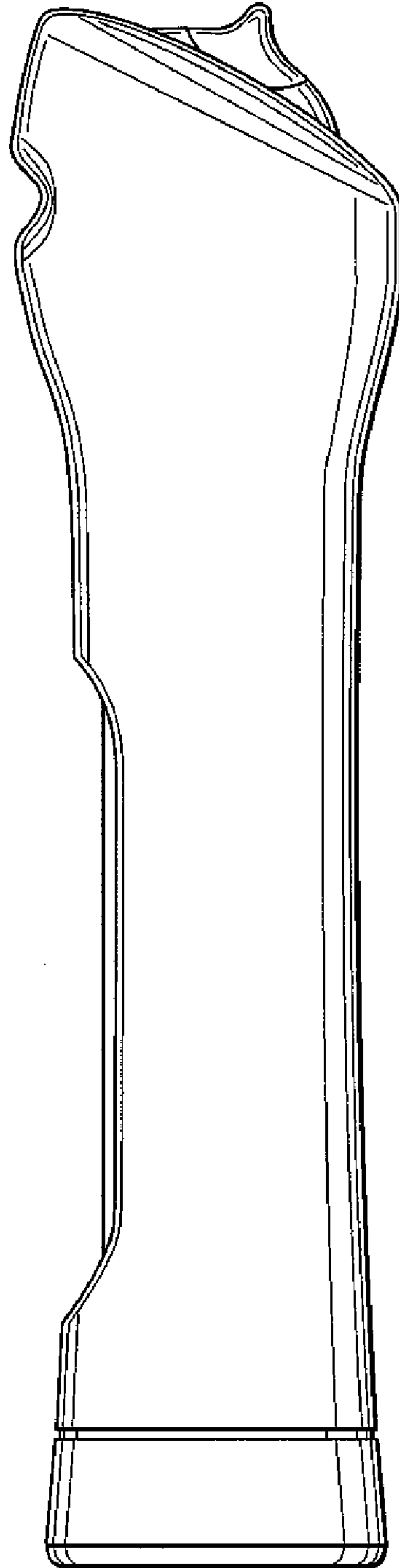

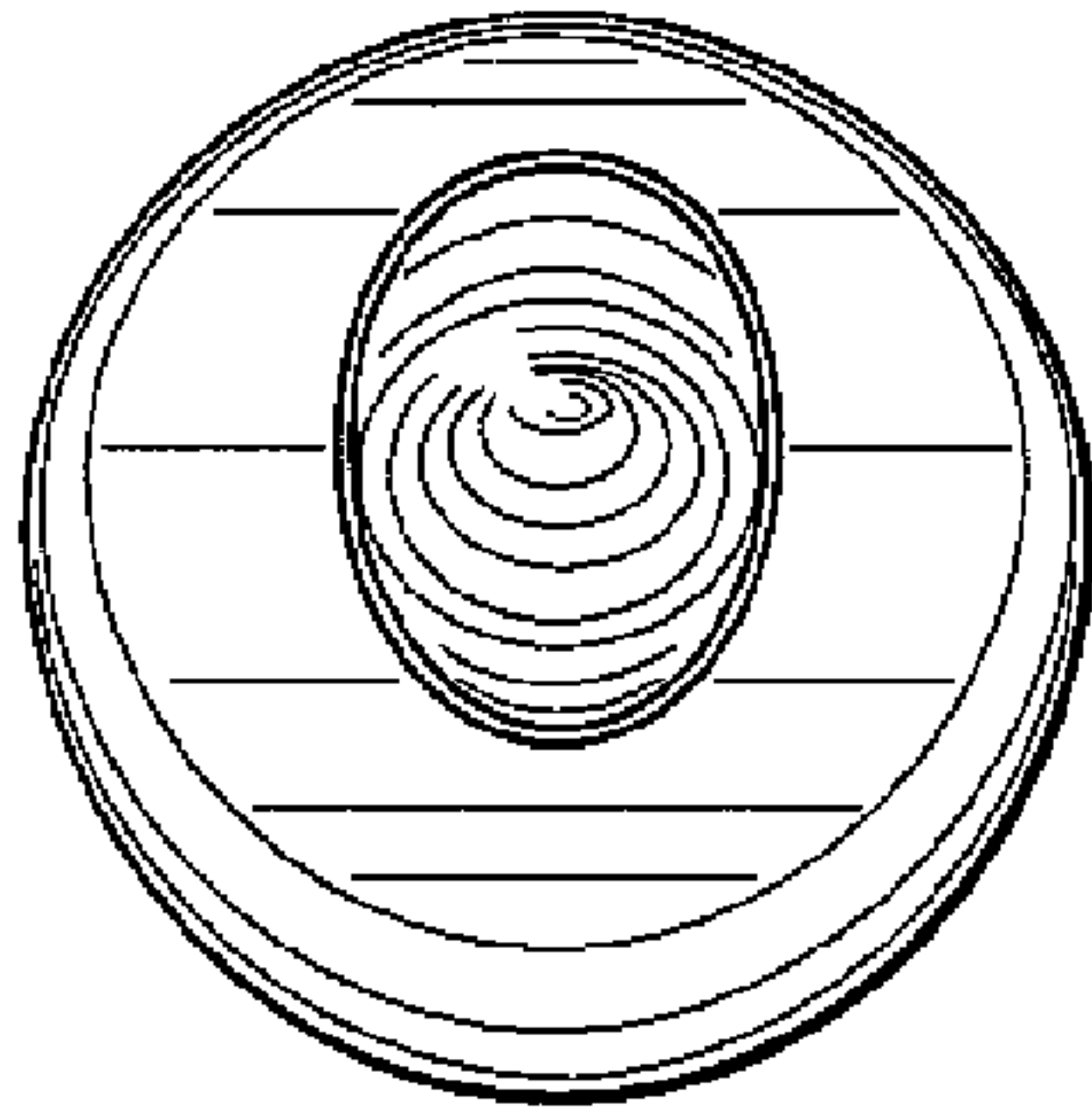

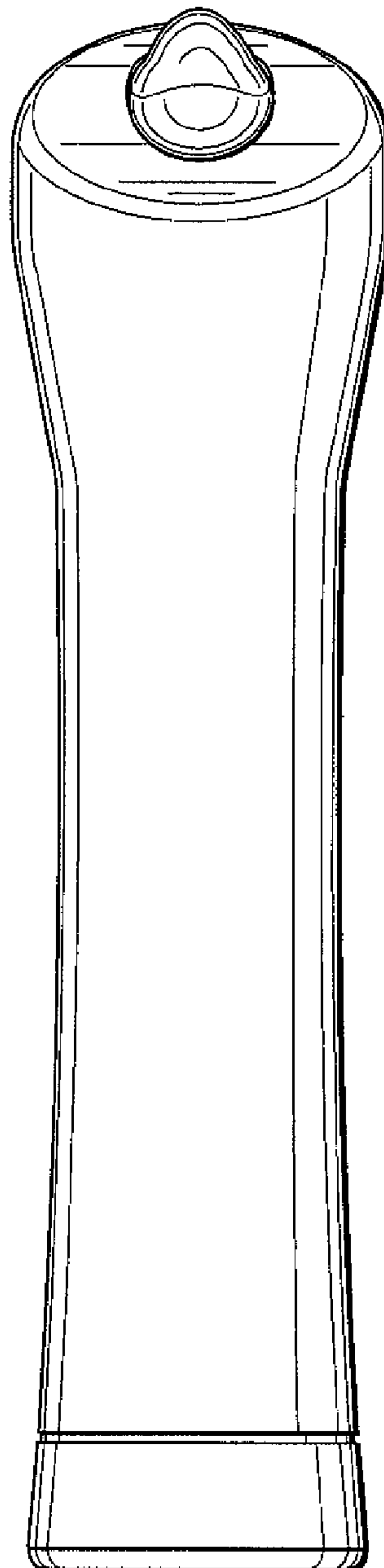
