FIG. 3 is a front elevation thereof;

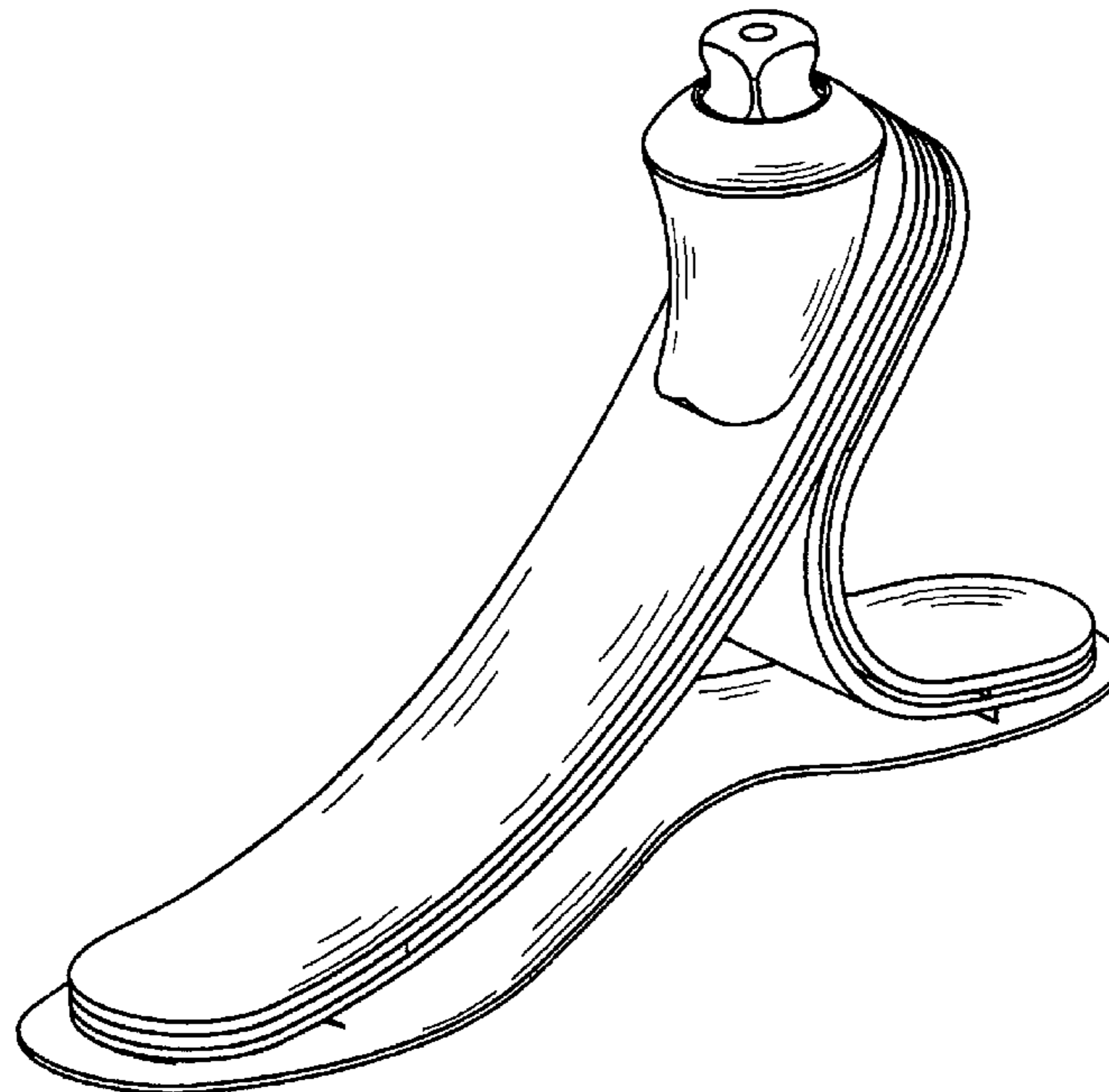
FIG. 4 is a side elevation of the side opposite that shown in FIG. 2;

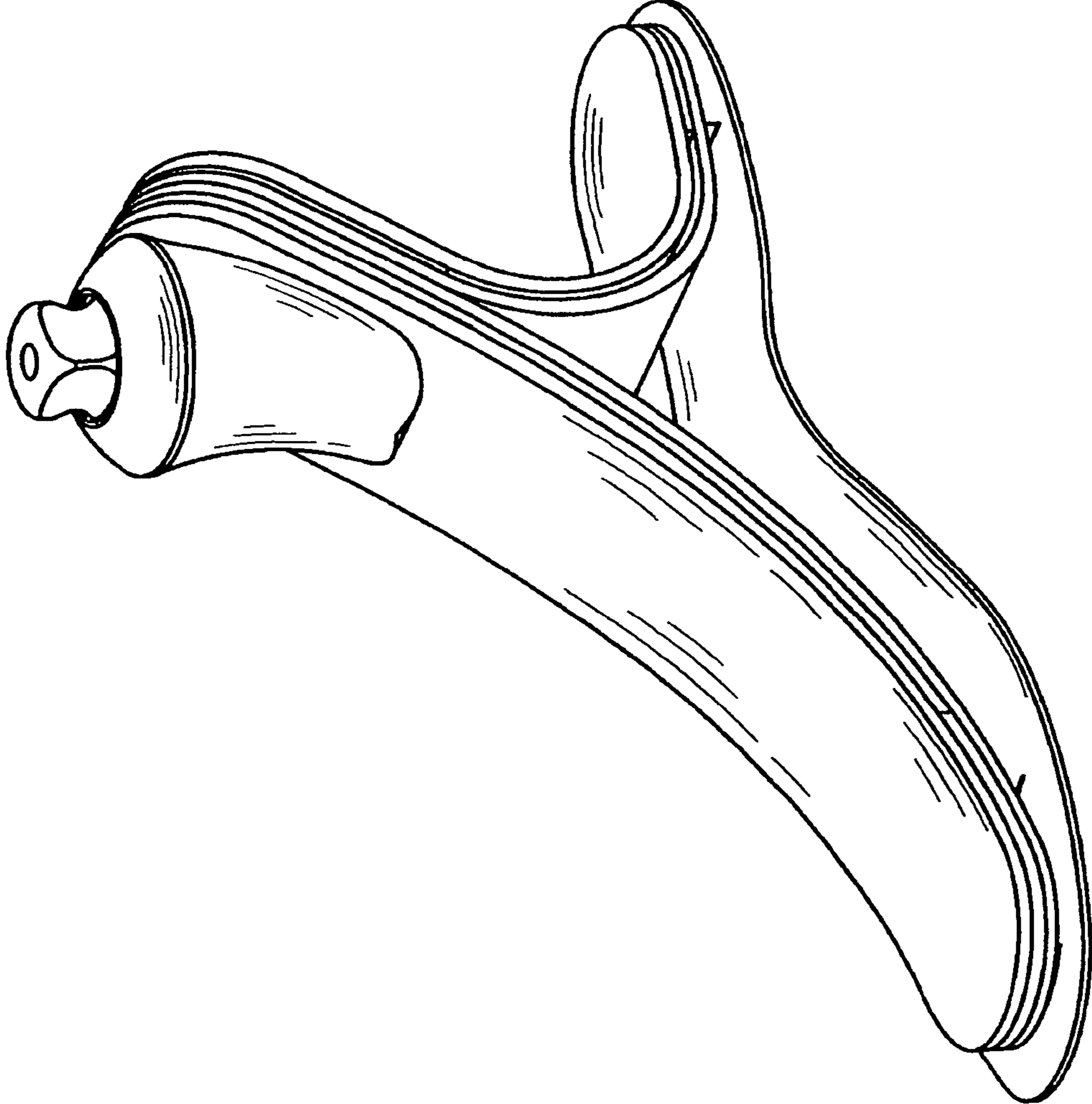

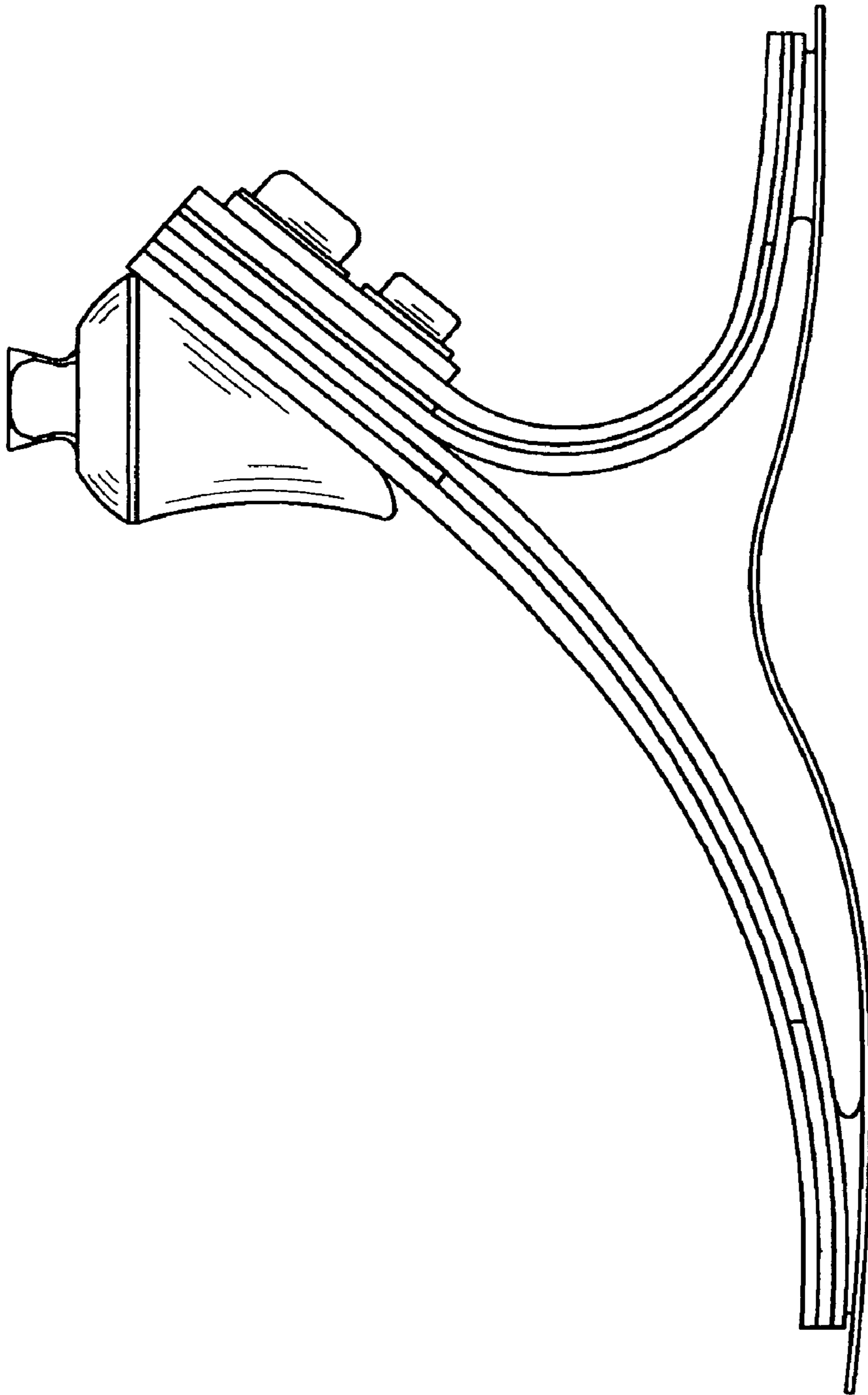

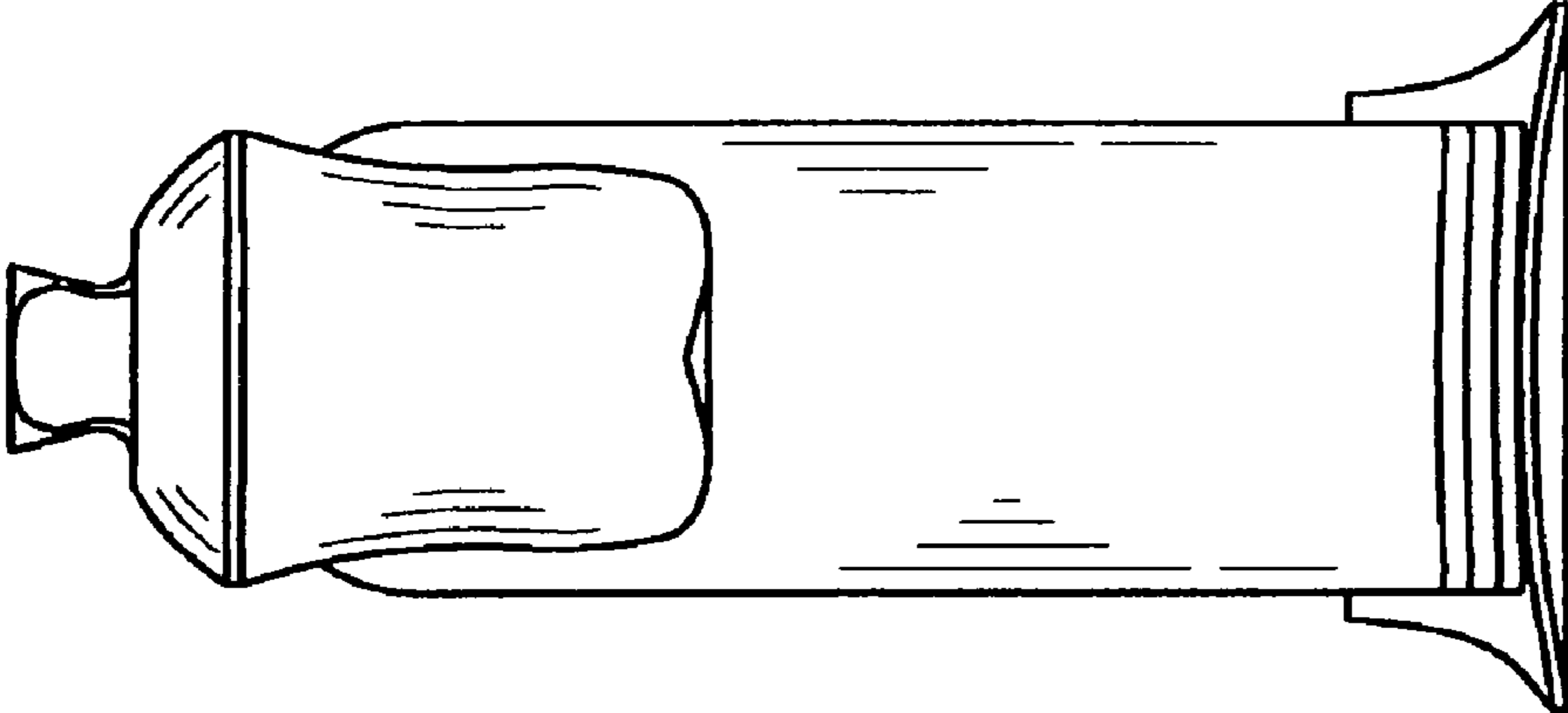

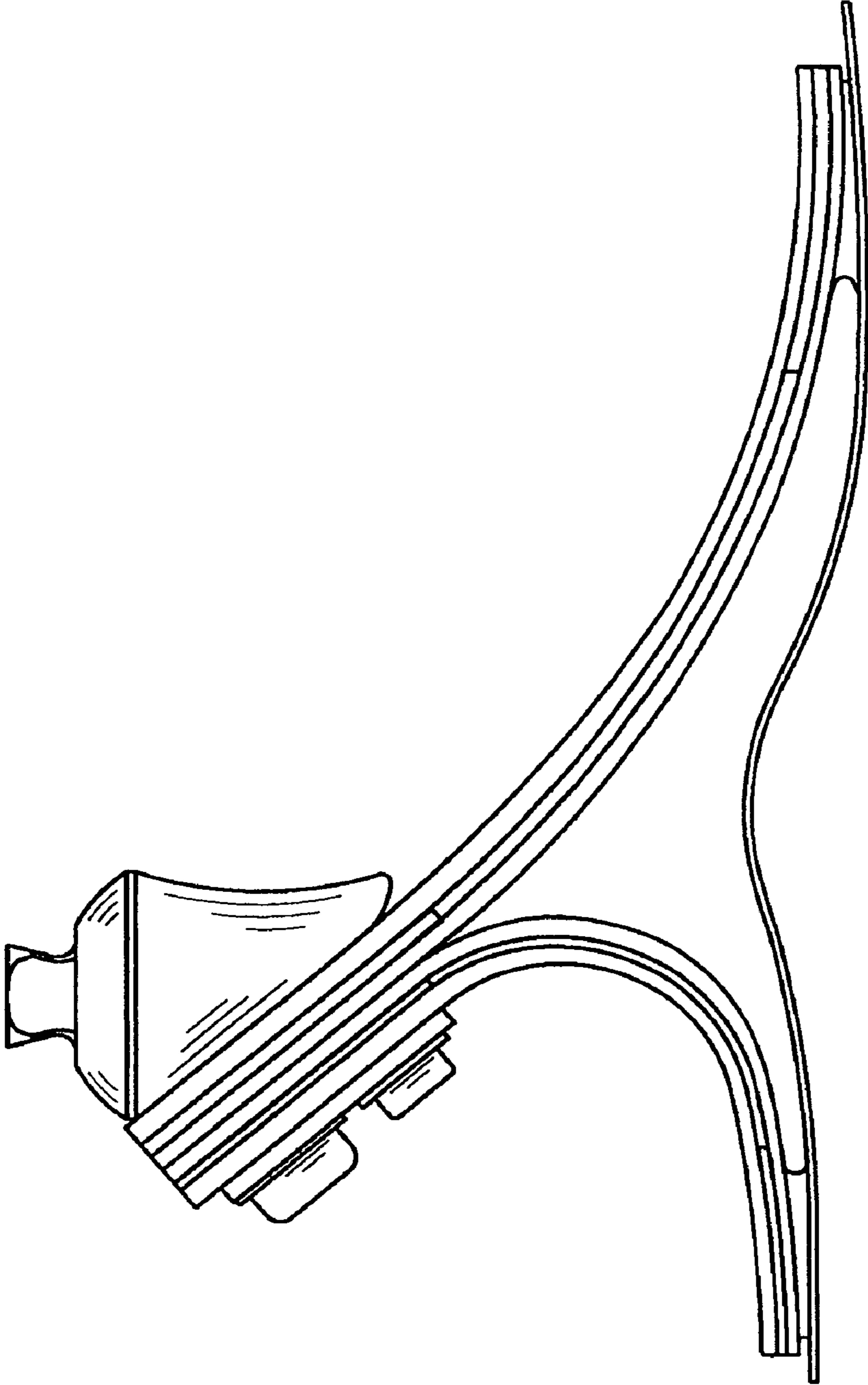

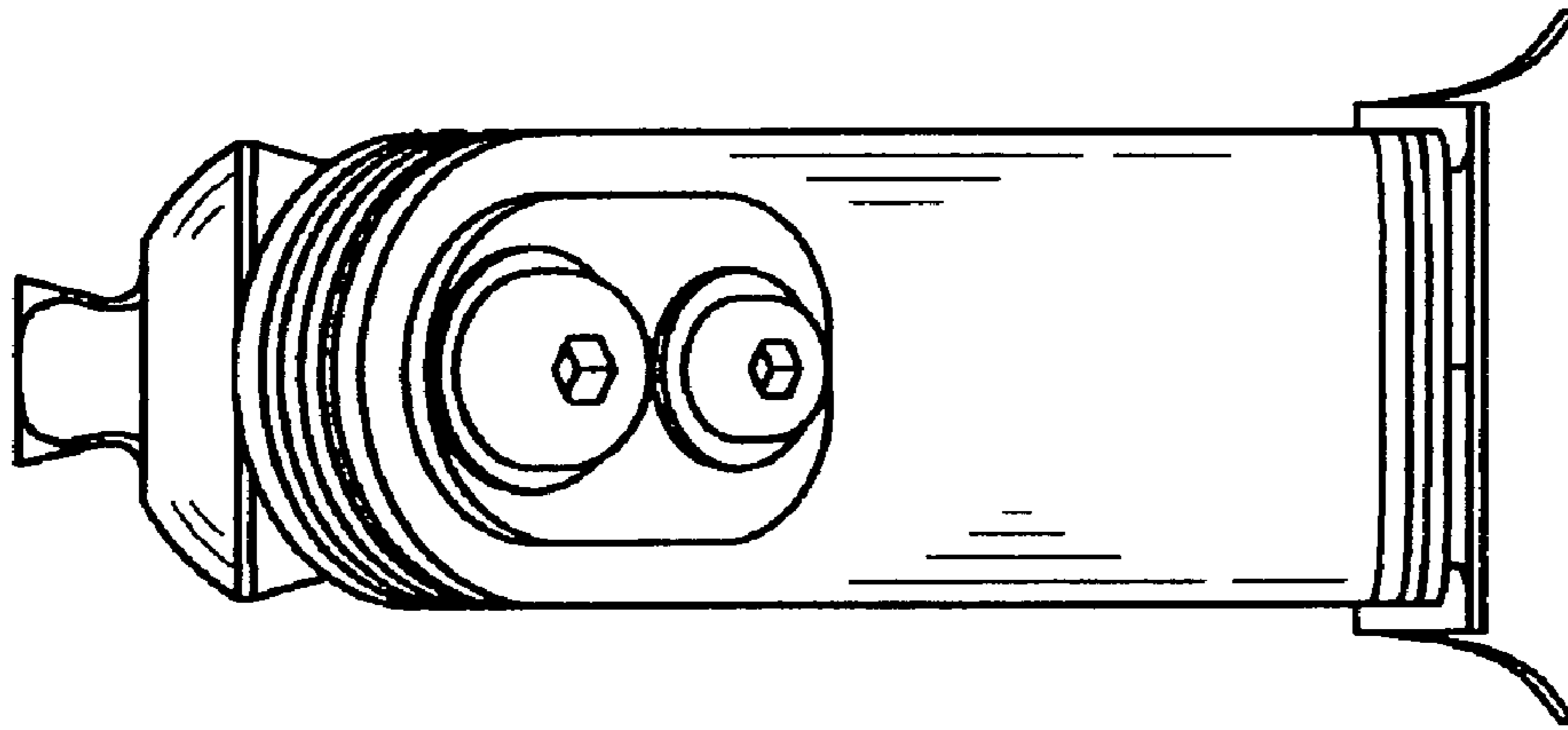

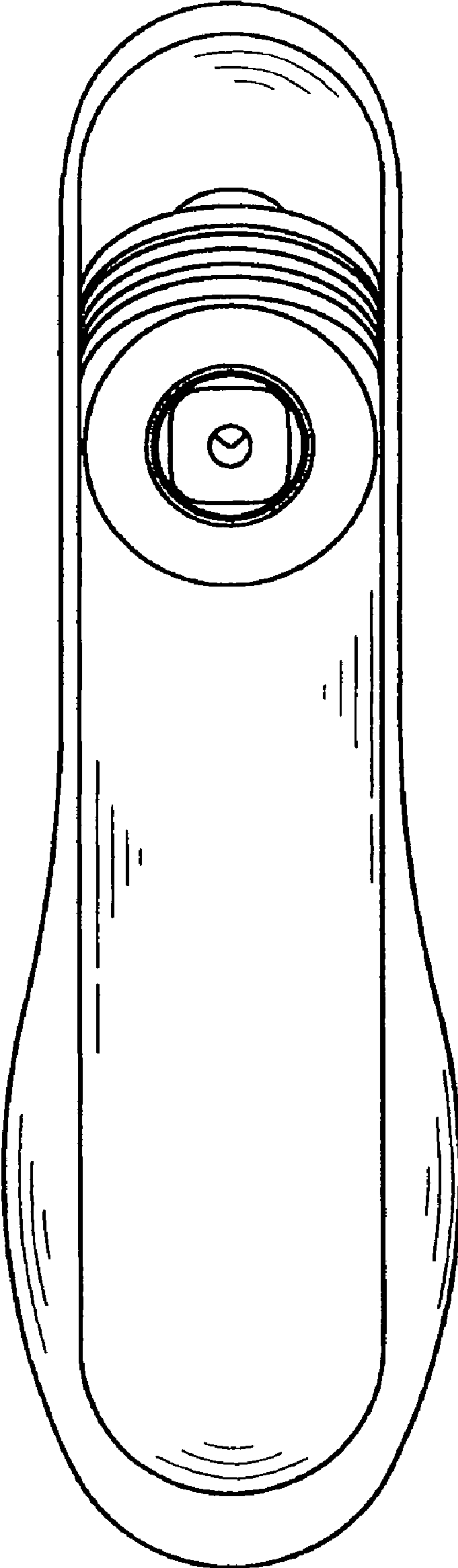

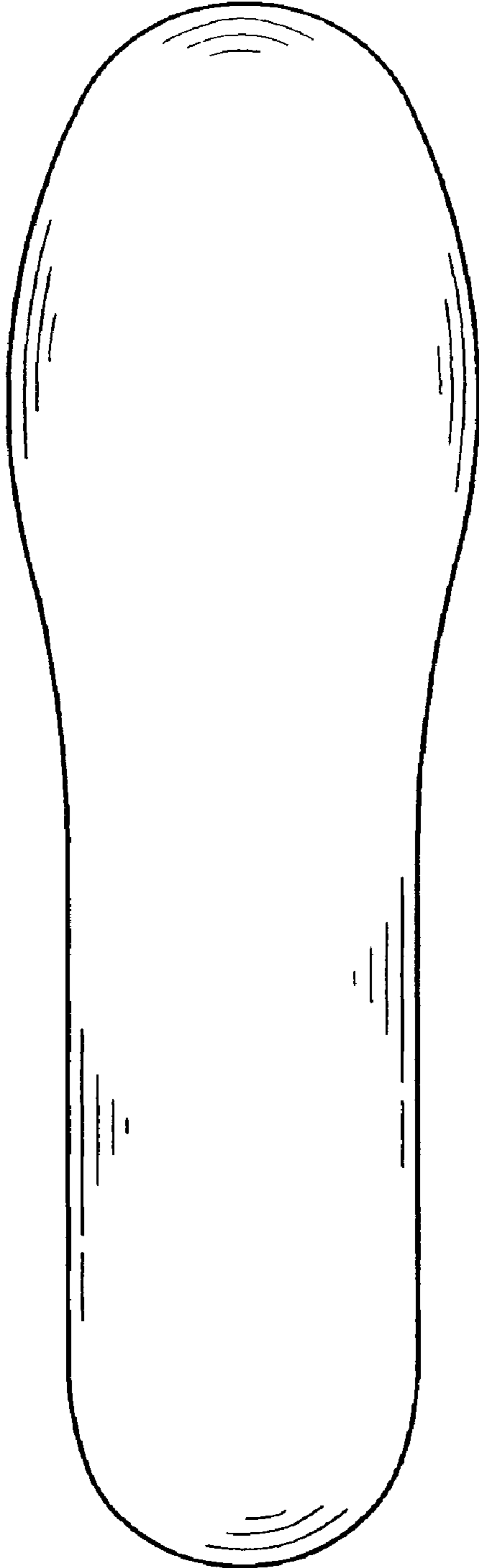
