The broken line showing is for illustrative purposes only and forms no part of the claimed design.

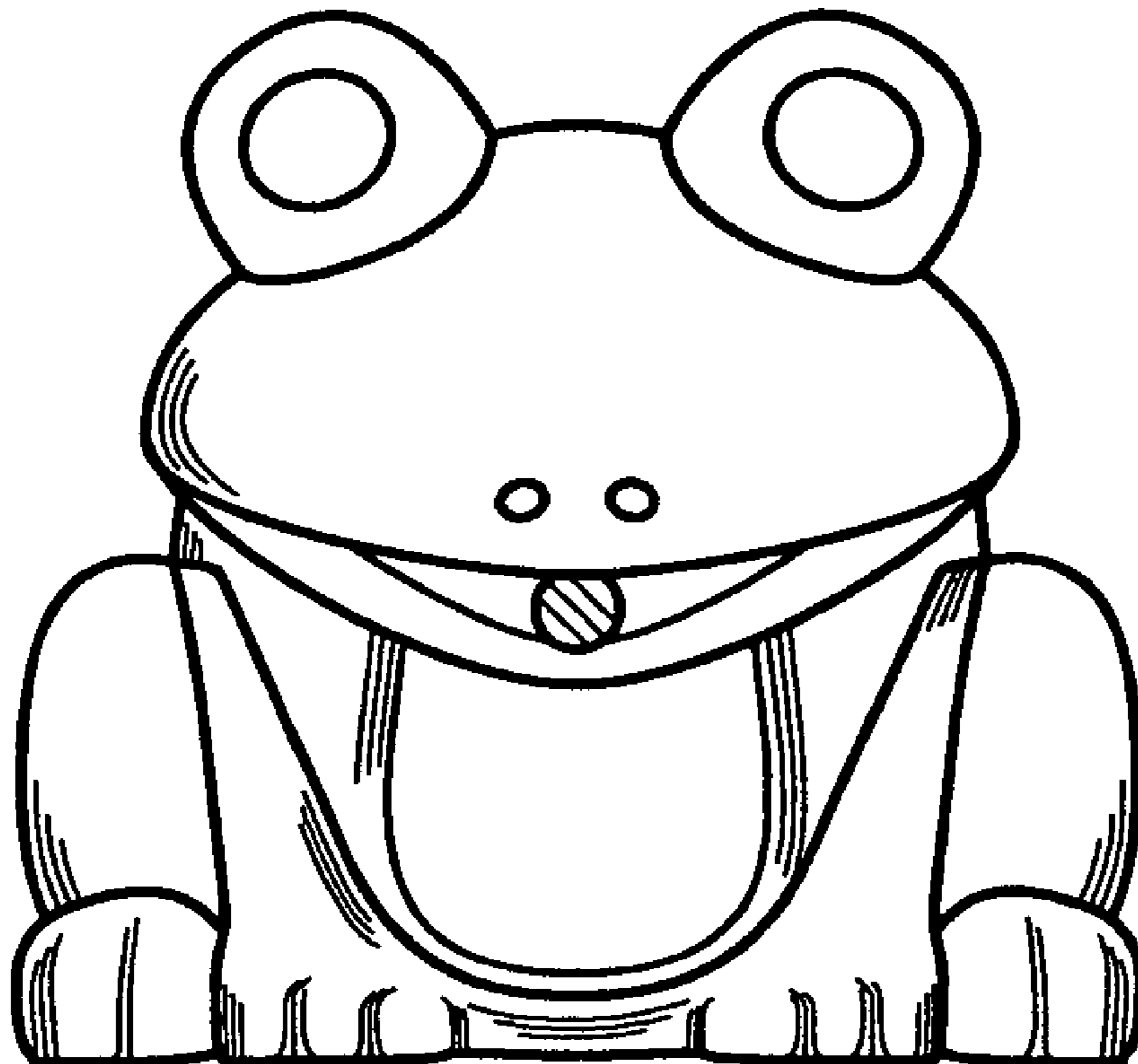
The diagonal lines applied to the circular mouth detail are shown to represent a transparent surface.

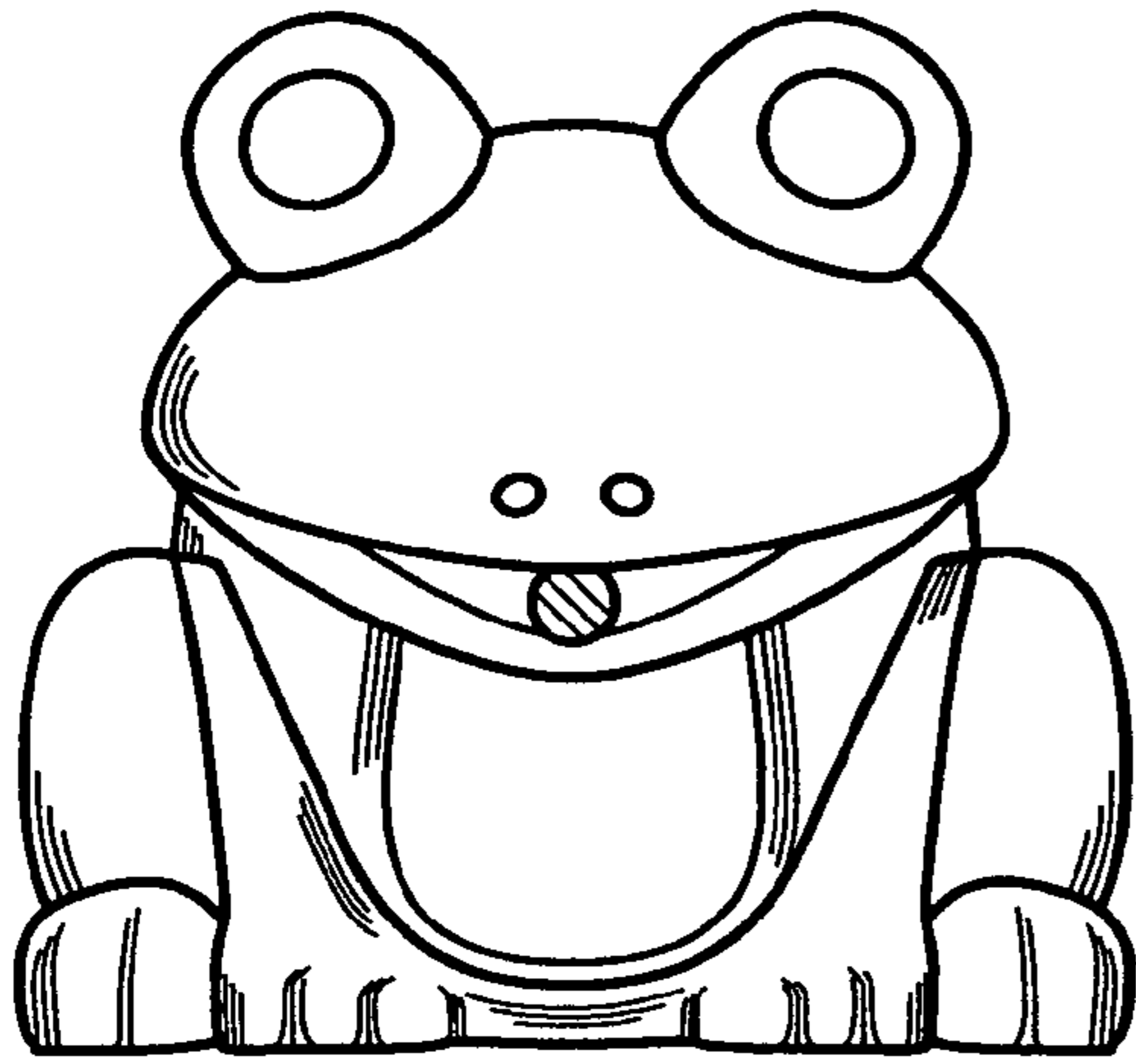

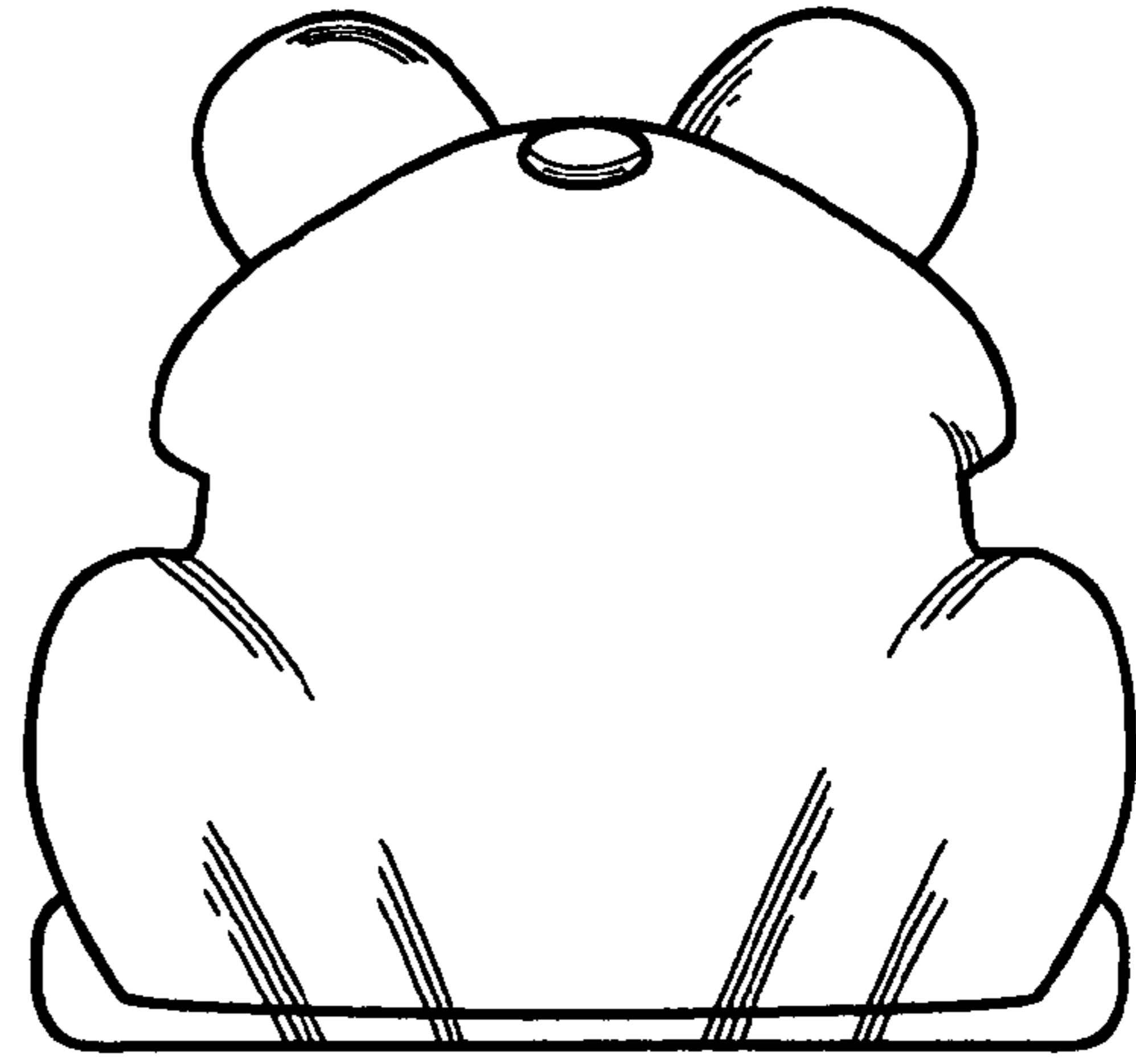

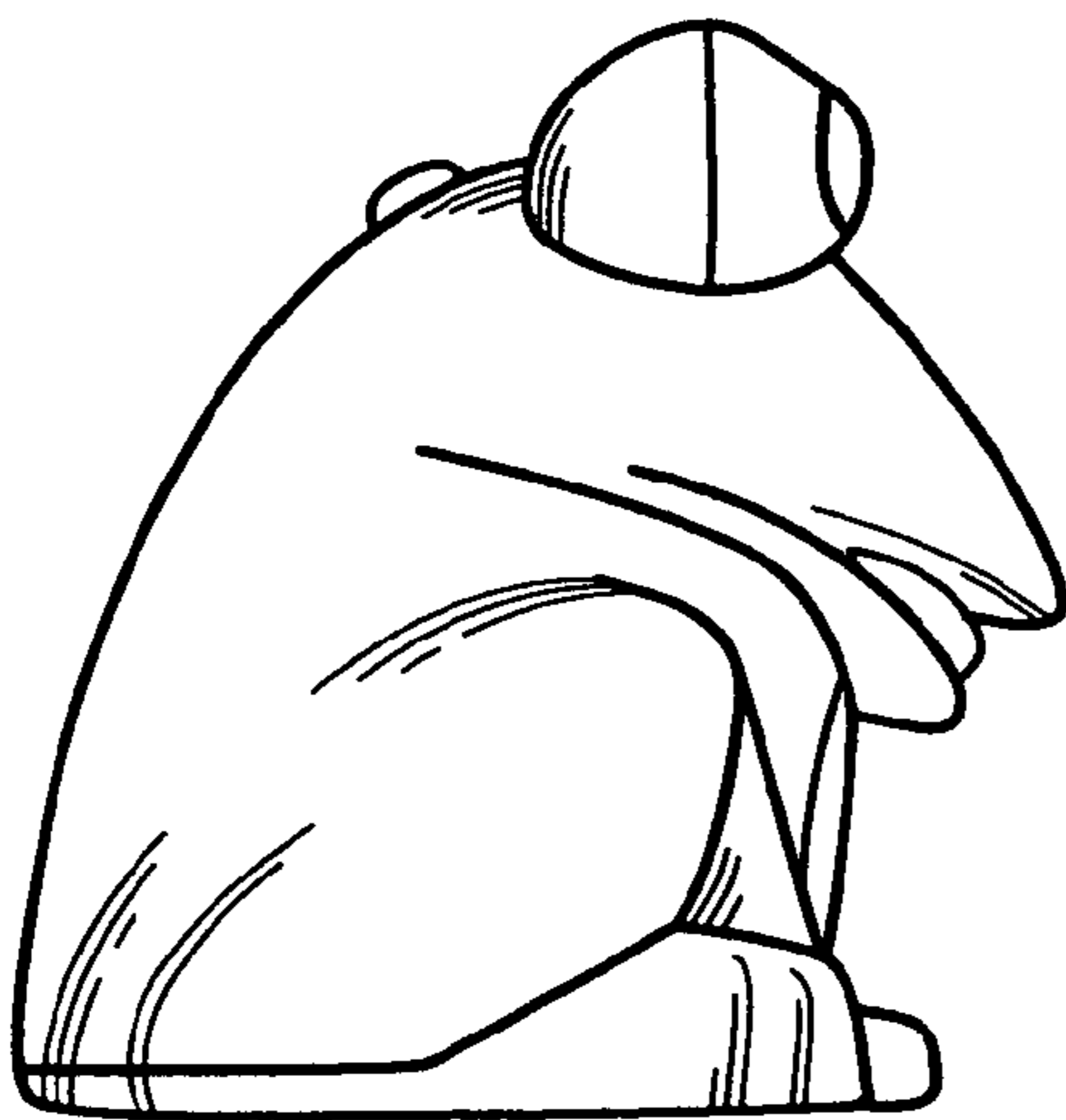

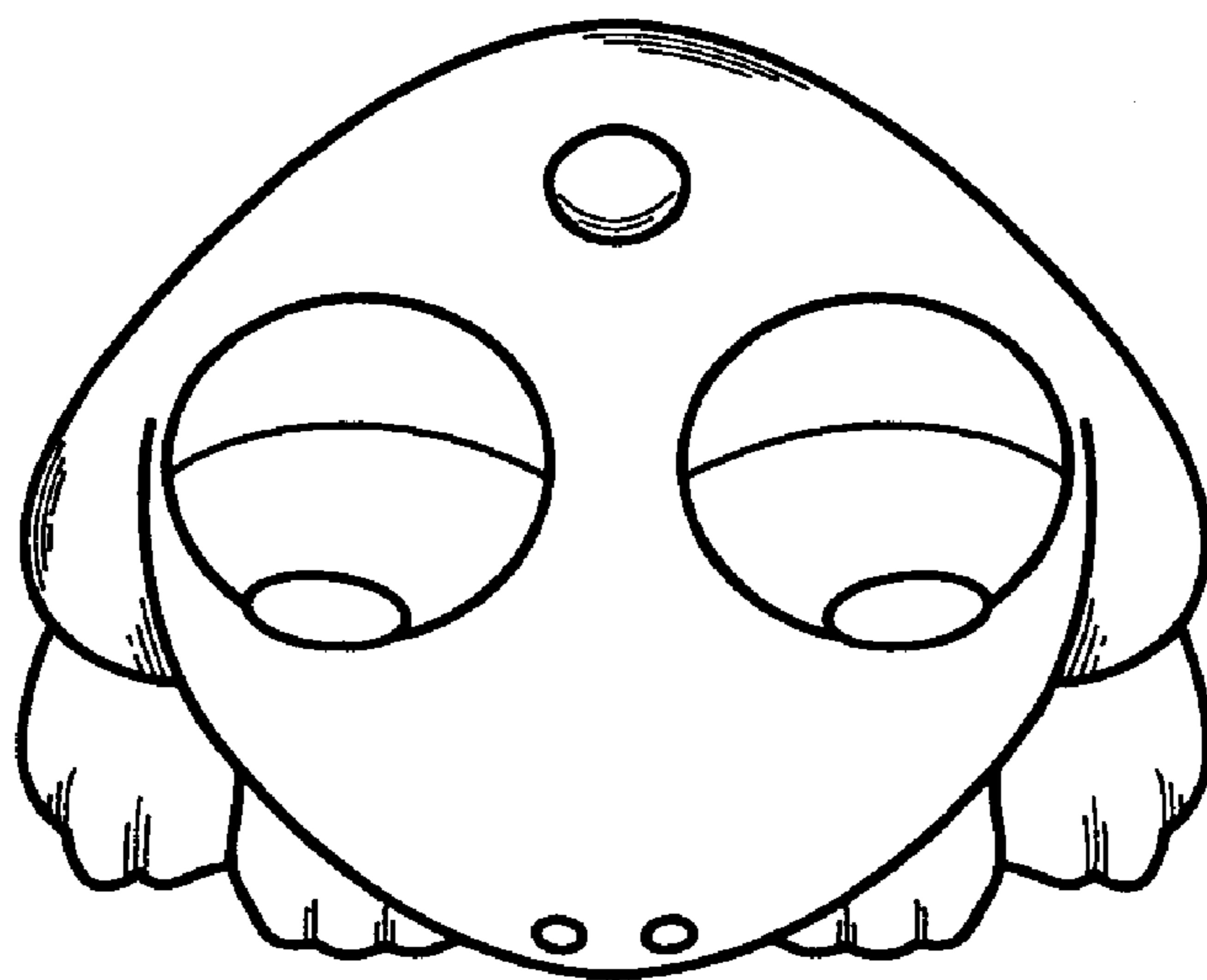

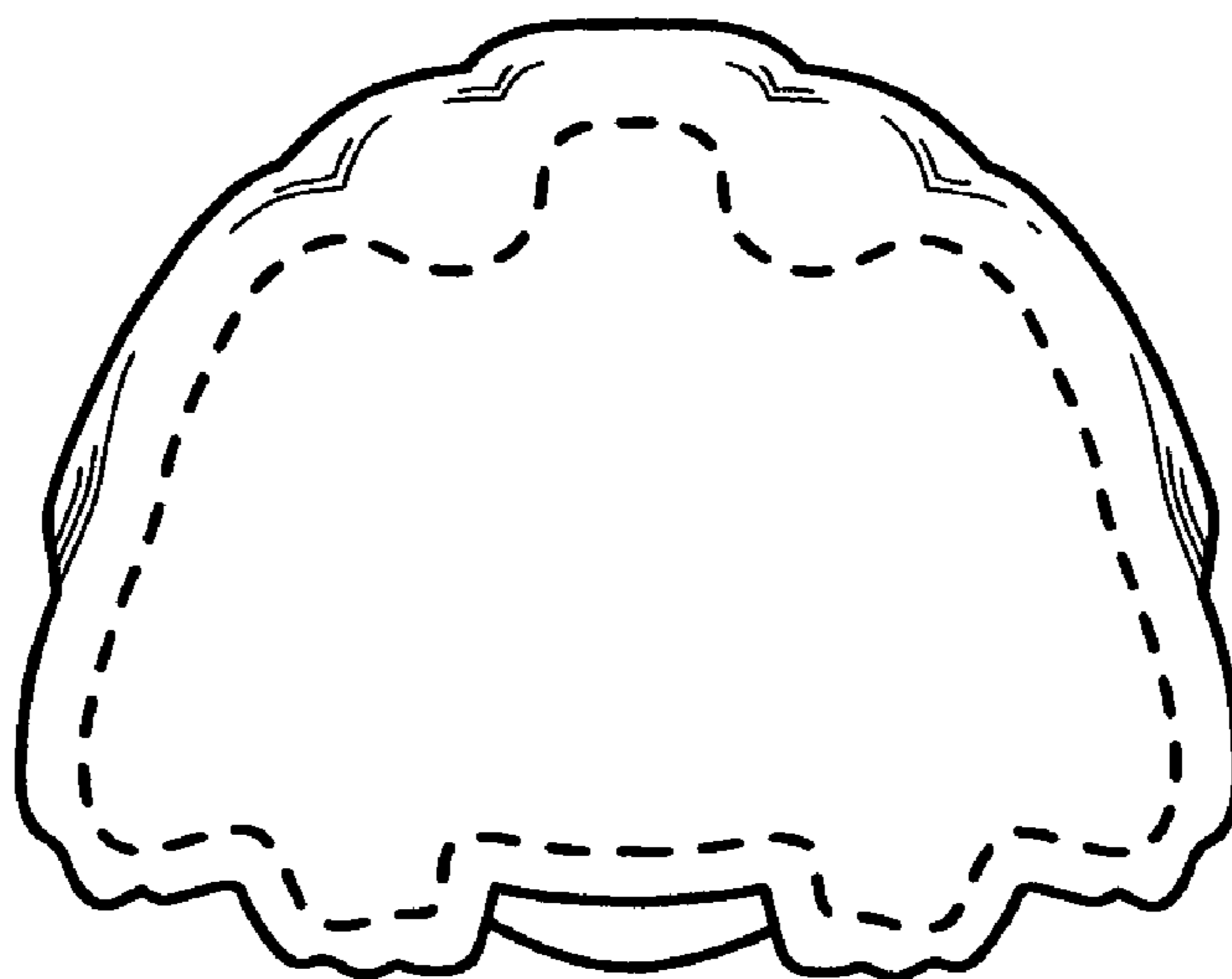
