DESCRIPTION

FIG. 9 is a right side view thereof;

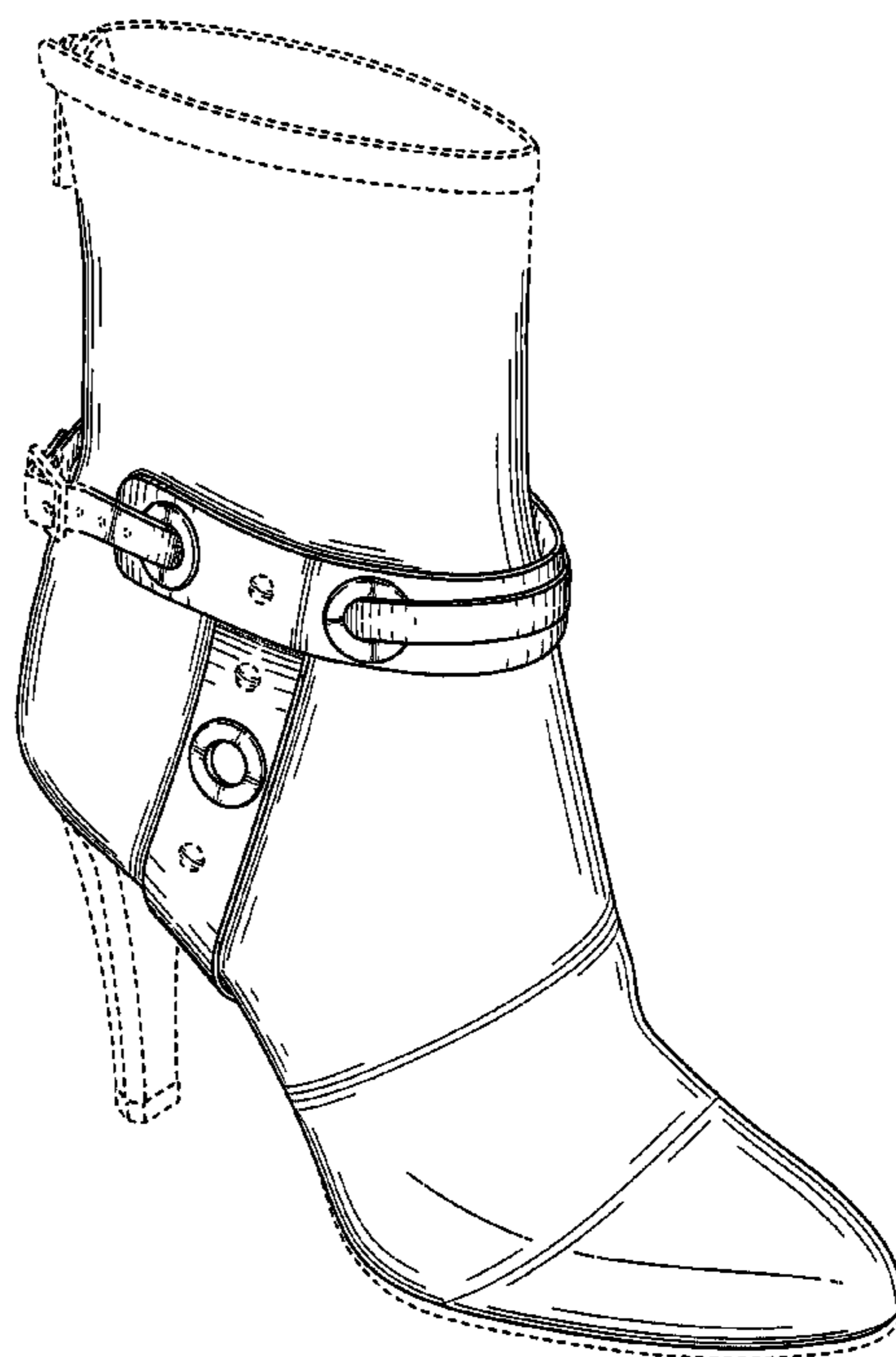
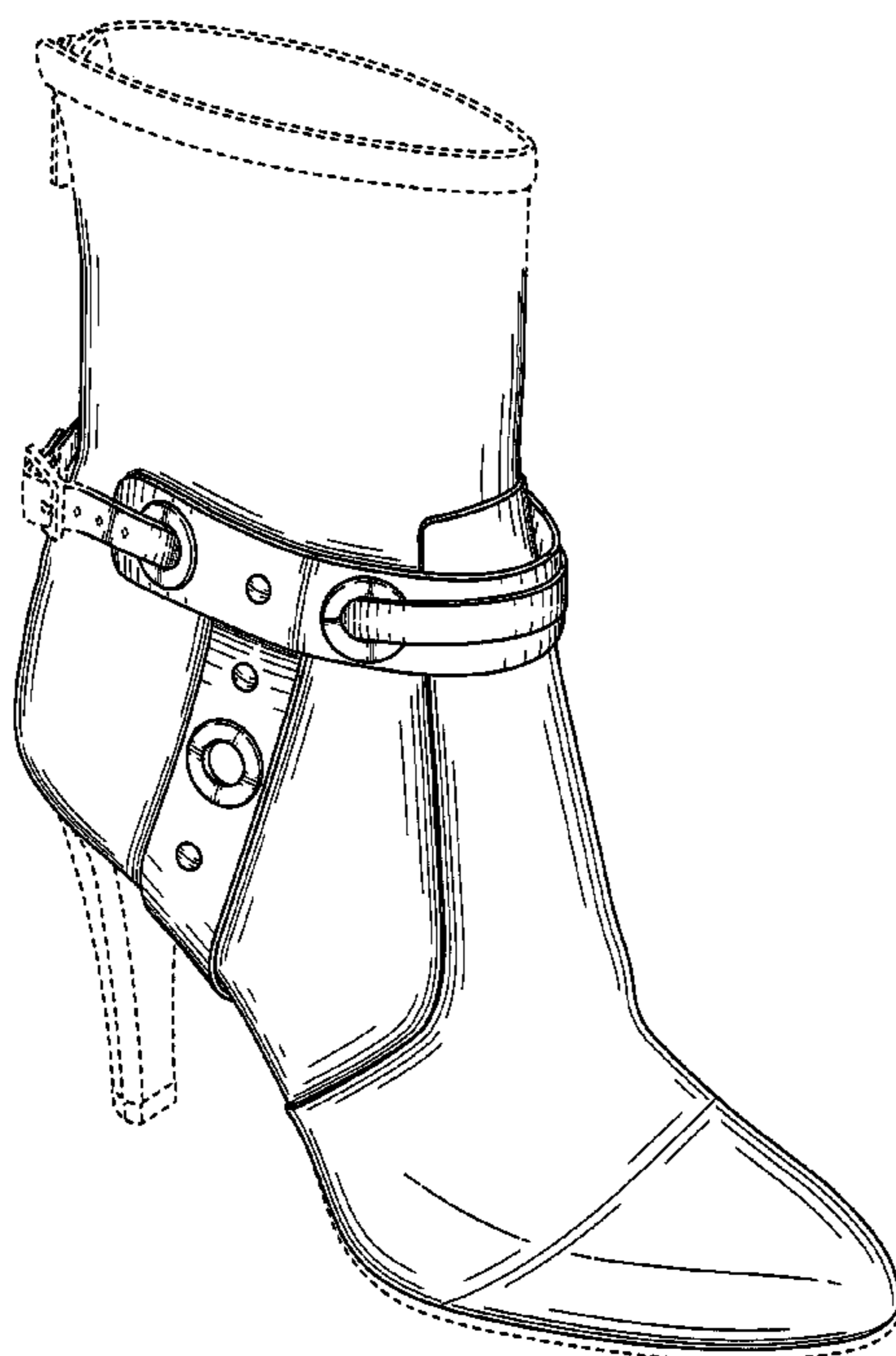
FIG. 10 is a front view thereof;

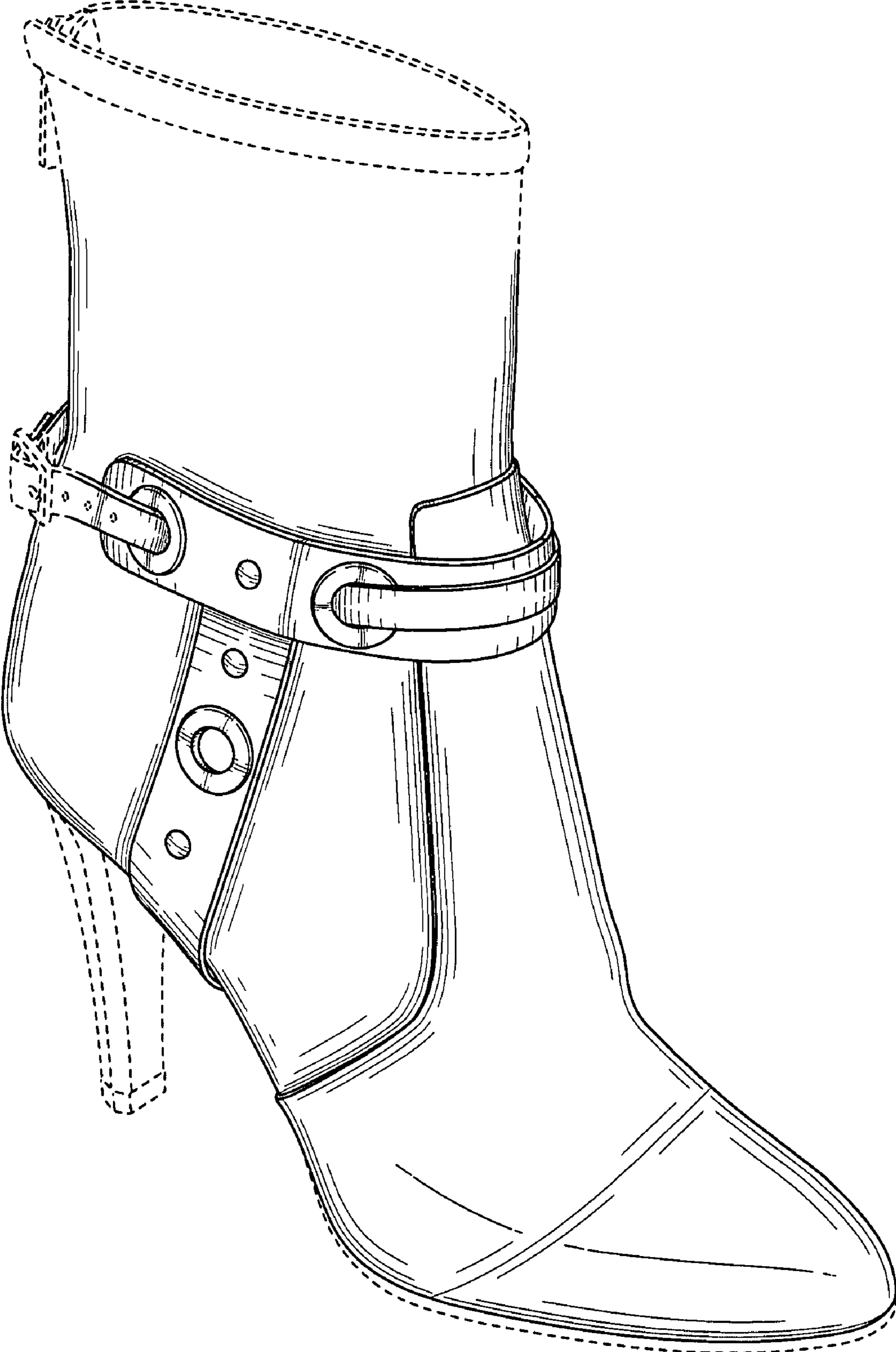

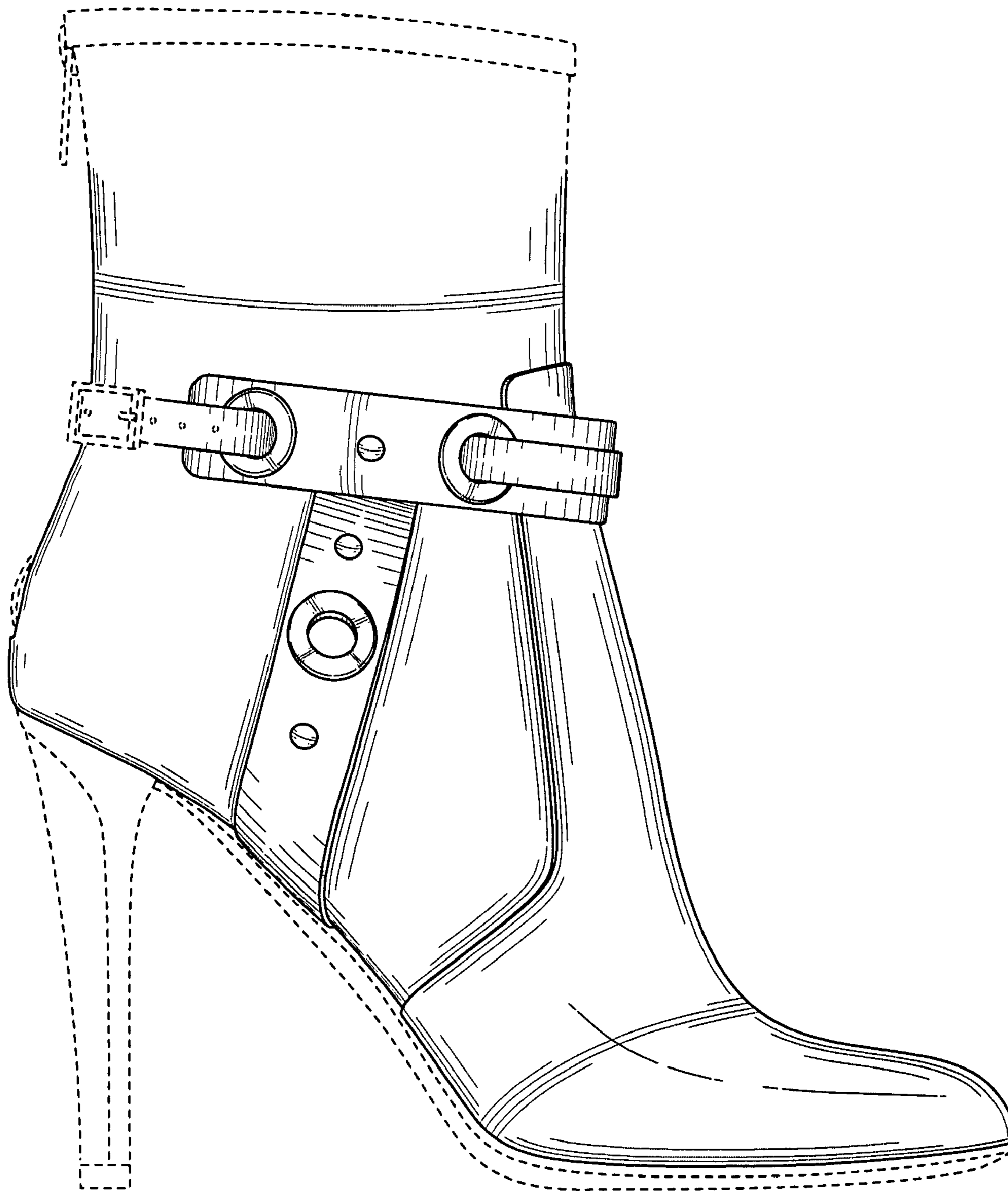

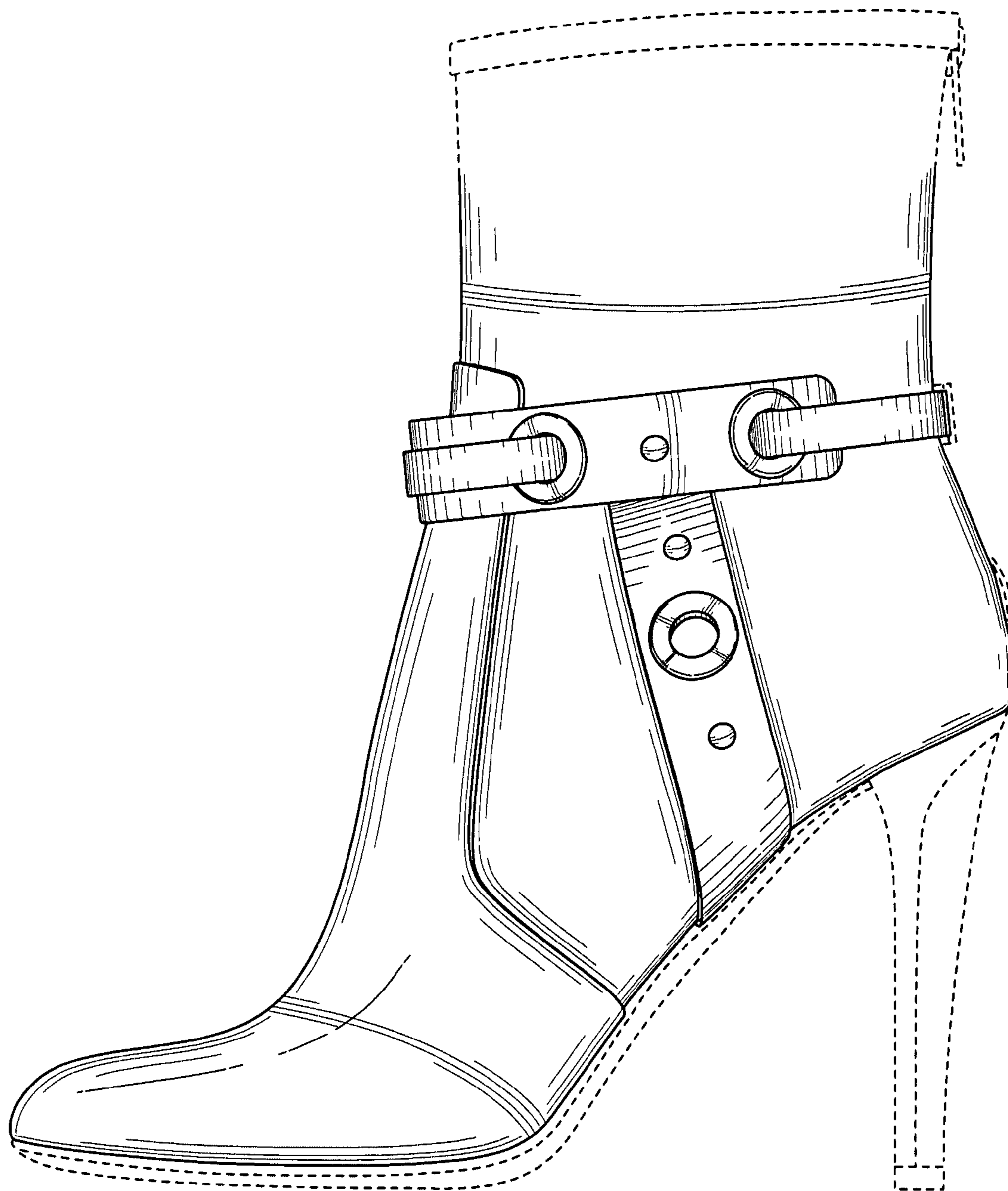

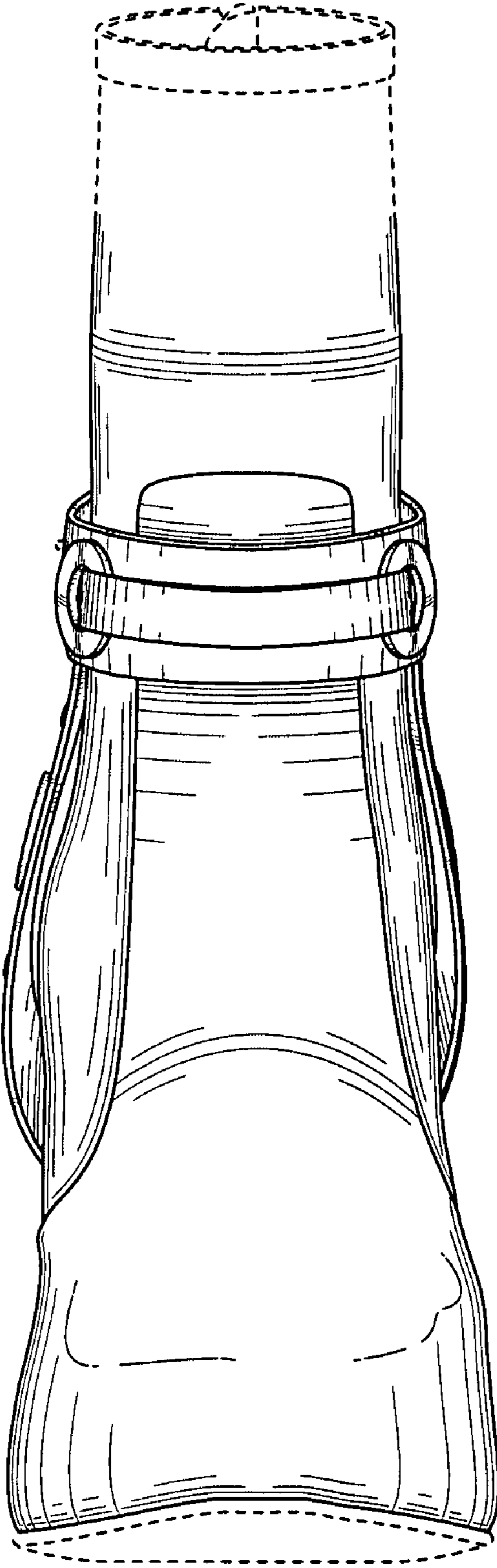

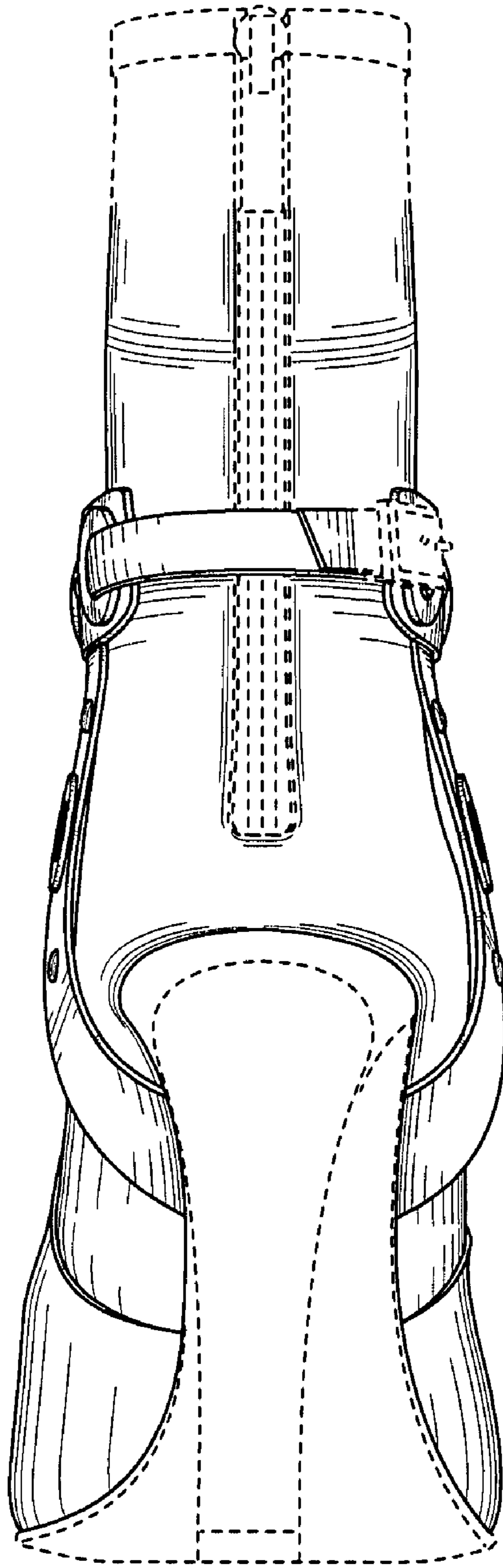

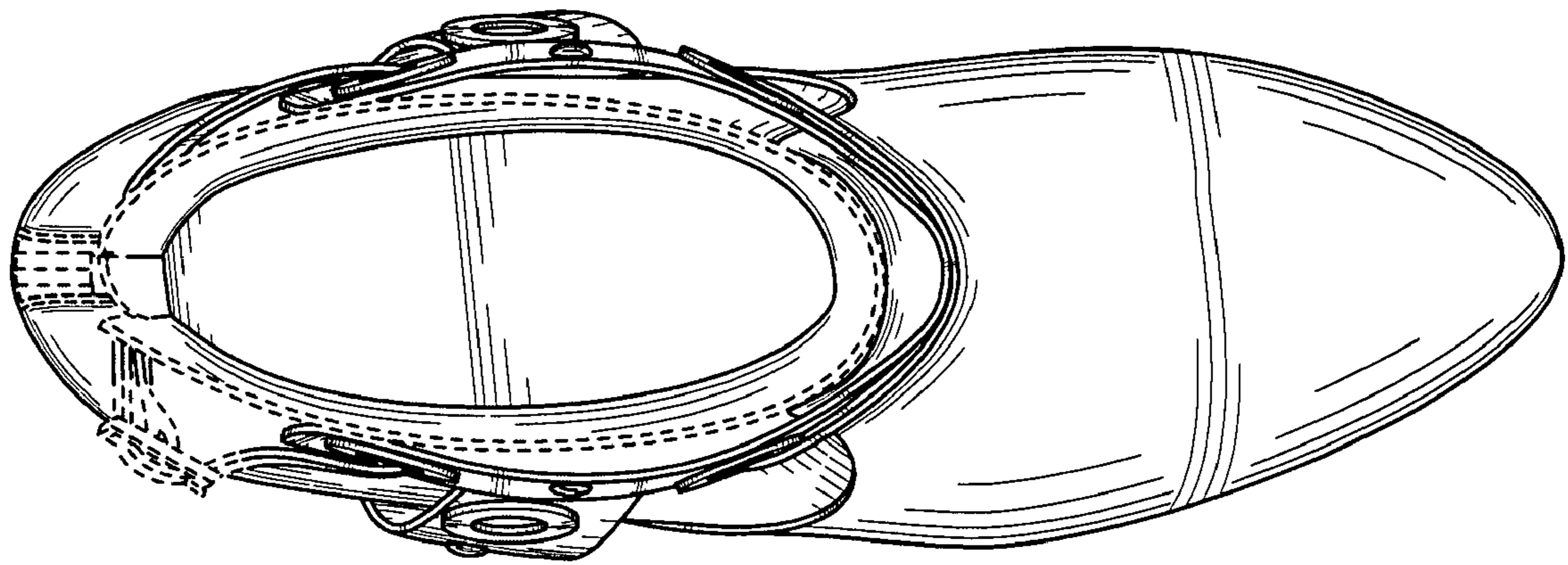

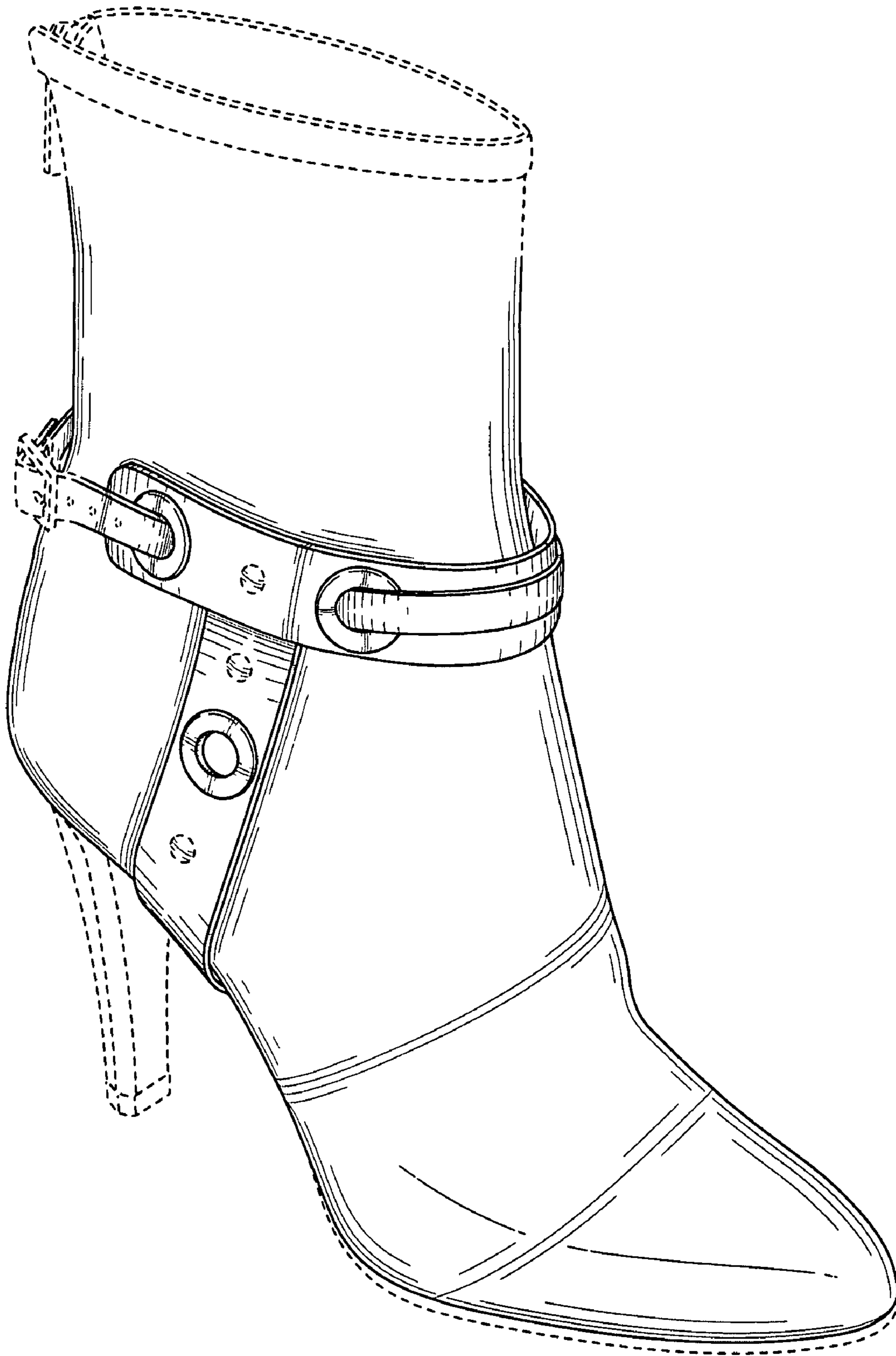

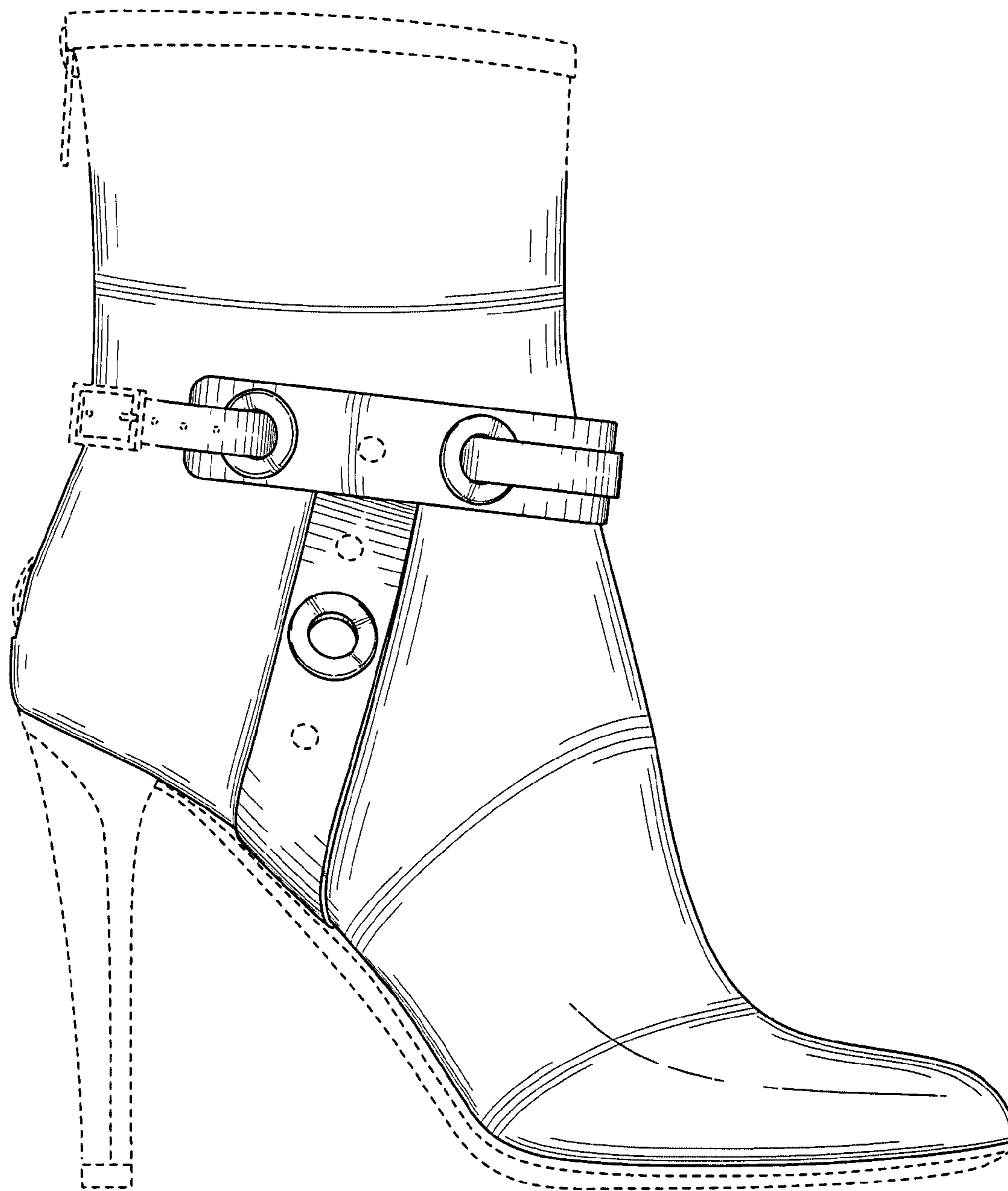

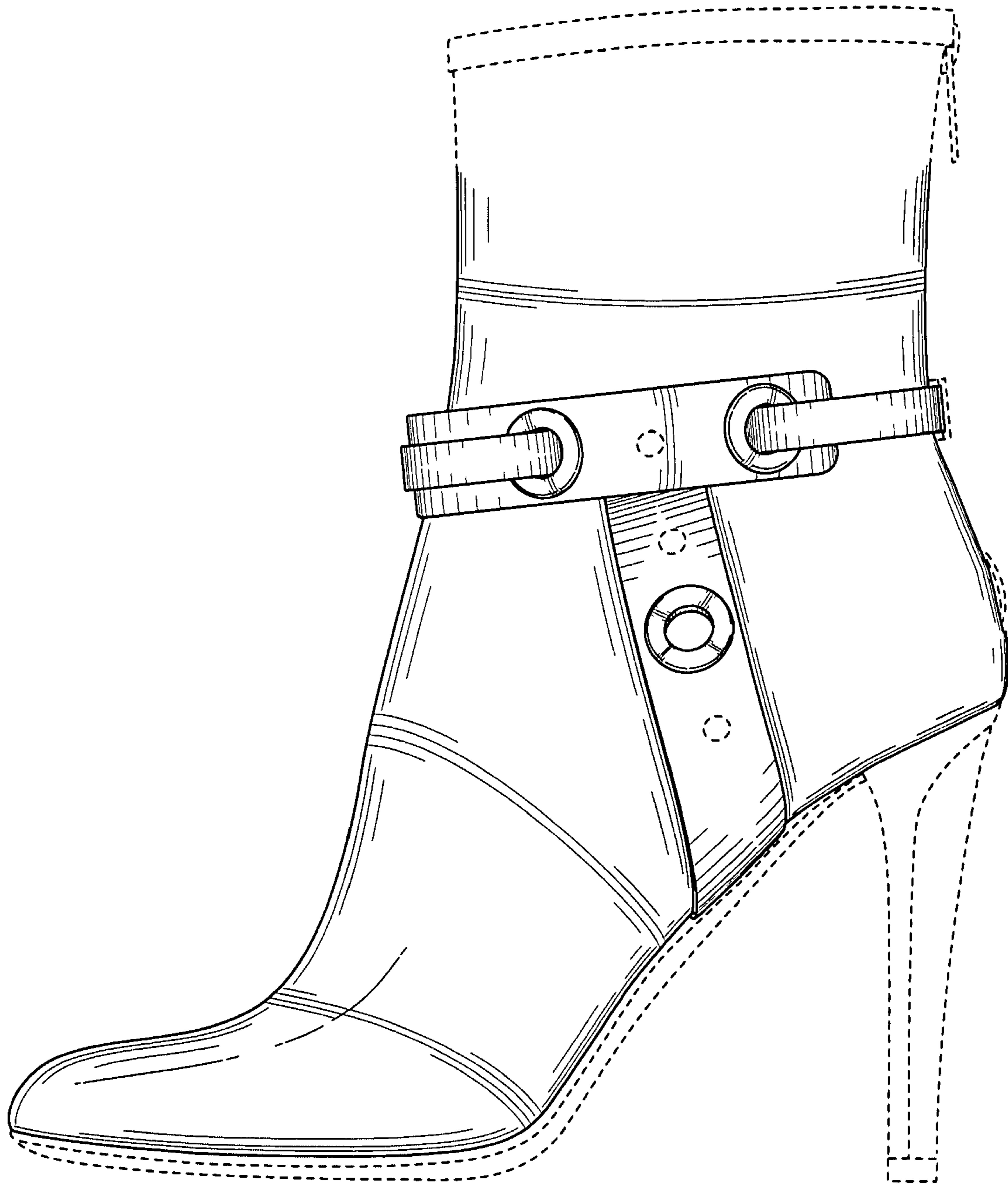

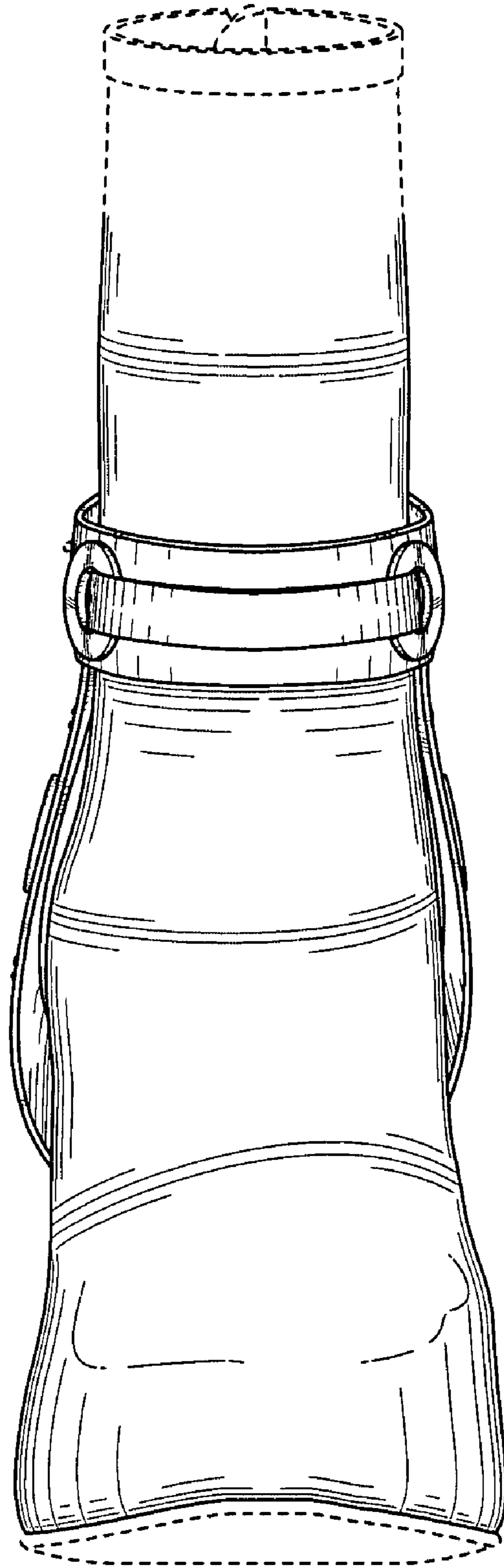

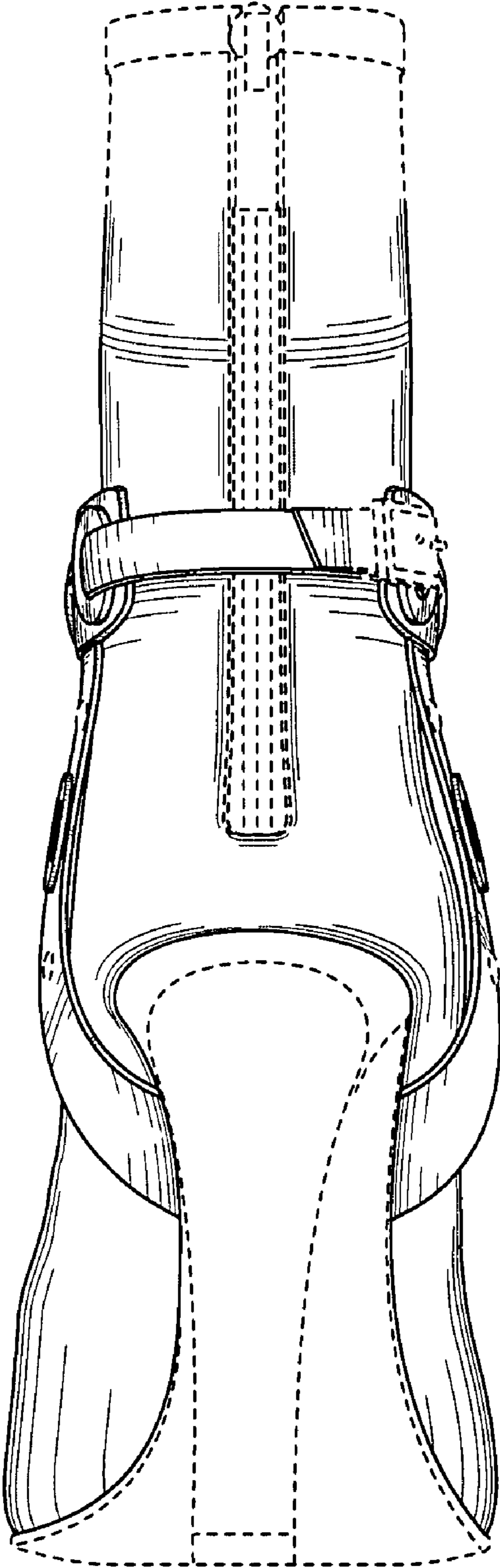

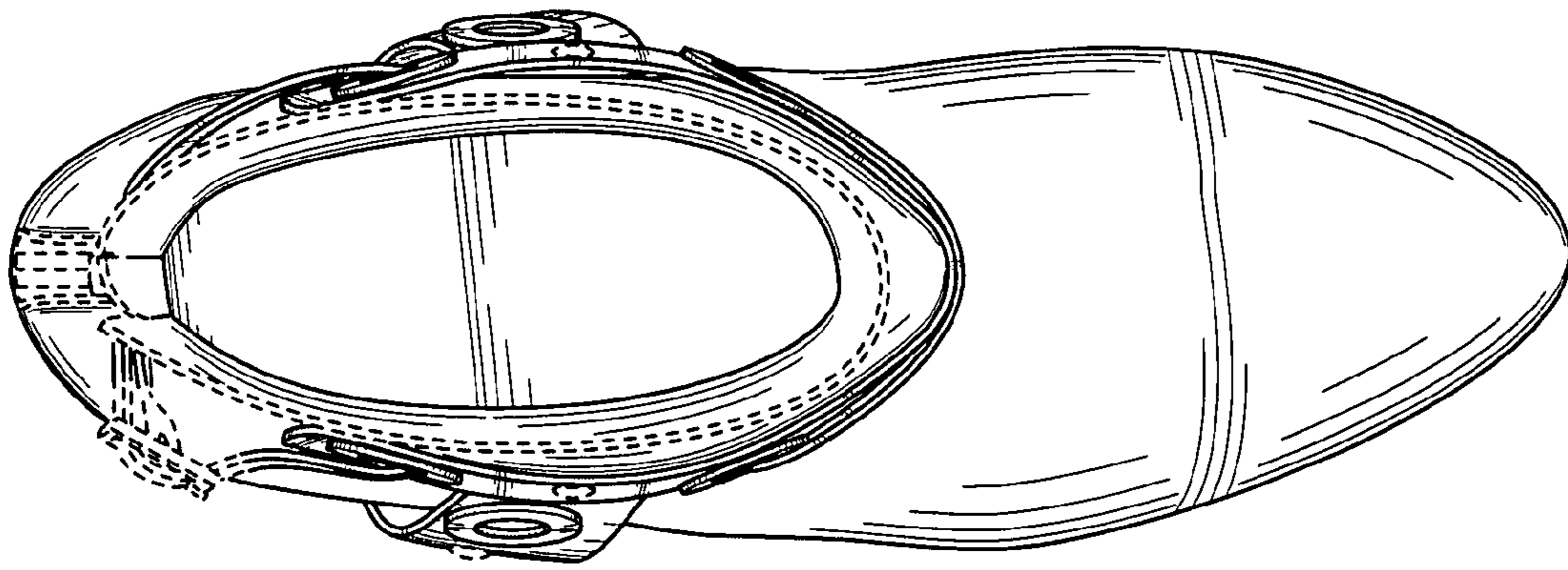
